Explosive fragm entation of thin ceram ic tube using pulsed power

This study experimentally examined the explosive fragmentation of thin ceramic tubes using pulsed power. A thin ceramic tube was threaded on a thin copper wire, and high voltage was applied to the wire using a pulsed power generator. This melted the wire and the resulting vapor put pressure on the ceramic tube, causing it to fragment. We examined the statistical properties of the fragment mass distribution. The cumulative fragment mass distribution obeyed the double exponential or power-law with exponential decay. B oth distributions agreed well with the experimental data. We also found that the weighted mean fragment mass was scaled by the multiplicity. This result was similar to impact fragmentation, except for the crossover point. Finally, we obtained universal scaling for fragmentation, which is applicable to both impact and explosive fragmentation.

Fragm entation is one of the most ubiquitous phenom ena in nature [1]. W ell known exam ples include nuclear collision, the impact of brittle materials, and meteorites form ed from asteroids. Fragm entation phenom ena occur at all scales, from m icro to m acro, and m ost occur very rapidly. Consequently, it is di cult to observe fragm entation phenom ena directly. The statistical properties of the fragm ent m ass (or size) distribution have been investigated frequently, and a scaling m ethod is very useful for the analysis. This method is also used to study earthquakes, turbulence, and m any other non-equilibrium phenomena. Since the scaling laws are universal in many cases, we expect analogies across such phenomena. In particular, brittle fragm entation is a very simple exam ple. Therefore, we believe that investigation of brittle fragmentation is indispensable for understanding nonequilibrium phenomena.

Fragm eat m ass distribution obeys the power-law form N (m) = $\frac{N_1}{m}$ n (m⁰)dm⁰ m¹, that is, n (m) m, where m, n (m), and are the fragm ent mass, fragm ent num ber of m ass m, and characteristic exponent, respectively. Simple experiments exam ining brittle fragm entation have indicated the universality of fragm entation phenom ena with this type of distribution [2, 3, 4]. Subsequently, numerical simulations have been performed [5, 6, 7, 8, 9, 10, 11]. Recently, A strom et al. proposed a generic scaling form, which consists of a combination of the power-law together with exponential decay and exponential functions [9]. This ts m any classes of experiments and simulations, because it contains several typical function form s as limiting cases.

K un and H errm ann studied the transition between the dam aged and fragm ented states [6]. This problem is the key to understanding the universality of fragm entation. They proposed that the transition involves the universality of percolation. By contrast, A strom et al. considered another critical behavior in the fragm entation transition [7]. K atsuragi et al. carried out experiments to check these predictions [12, 13]. They also revealed the role of the log-norm ald istribution. A binom ialmultiplicative model was able to explain the log-norm ald istribution and multi-scaling nature of in pact fragm entation.

Through these simulations and experiments, the outline of brittle fragm entation has been clari ed system atically; however, many unsolved problems remain. One that has received recent attention is the fragm entation of shells [14]. W ittel et al. exam ined im pact and explosive fragm entation of eggshells in both simulations and experiments. They reported that explosive fragmentation exhibits an abrupt transition, whereas impact fragm entation shows a continuous transition. These results suggest that there is a new kind of universality that reveals the explosive fragm entation of shells. In addition, a double exponential (not the power-law) fragm ent mass distribution has been observed in explosive fragm entation experiments [15] and simulations [16]. These results indicate the unresolved features of explosive fragm entation. Therefore, more investigations of explosive fragm entation are needed to consider fragm entation universality.

In general, explosive fragmentation experiments are di cult to conduct because of the danger of the explosion. We performed relatively safe explosive fragmentation using a pulsed power generator. In this Letter, we report the results of our experiments. Moreover, we compare the results with previous impact fragmentation experiments. Finally, we discuss the universal scaling of impact and explosive fragmentation.

W e used a pulsed power generator consisting of four




FIG.1: Schem atic illustration of the experim ental apparatus. A ceram ic tube was threaded on a copper wire, and a pulsed high voltage was applied by the pulsed power generator.

capacitors with a capacitance of 0:1 F each, i.e., 0:4 F in total [17]. Figure 1 shows a schematic in age of the experim ental apparatus. The capacitors were charged to a high negative voltage (around ()20 kV), and triggered by an external signal to a gap switch. We fragm ented thin 99:6% A 1203 ceram ic tubes (SSA-S: Nikkato Corporation) that m easured 1.2 mm in outside diam eter, 0.2mm thick, and 200, 150, or 100 mm long, with a density of 3:9 g/cm³. They were su ciently long that one m ight regard them as one-dimensional objects. In fact, a few (low discharge energy) cases produced one-dim ensionallike fragments that retained the long tube geometry. However, we con med that most of the fragments had two-dim ensional geom etry, i.e., after fragm entation, very few fragm ents retained the original tube geom etry, particularly not those in the sm allm ass range. Therefore, we considered this experim ent a two-dim ensional one. Owing to the discharge voltage lim it of the generator, we could not break larger sam ples than those used.

A thin ceram ic tube was threaded on a copper wire (0:05 mm diameter) and the wire was xed to copper electrodes in a vessel. W hen a pulsed electric discharge passed through the wire, the copper vaporized and the resulting pressure inside the ceram ic tube increased dram atically, causing fragm entation of the ceram ic tube. During the experiments, the current and voltage between the electrodes were measured using a current probe (M odel 110A : Pearson E lectronics) and a high-voltage probe (EP-50K: Pulse Electric Engineering), respectively. A fler each fragm entation, all of the fragm ents were collected and their masses were measured using an electronic balance (ER-60A:A&D). We fragmented 47 ceramic tubes (21: 200 mm-long, 18: 150 mm-long, and 8: 100 mm-long). The input parameter of this experim ent was the discharge voltage, which ranged from 18 23 kV.W hen we analyzed the fragm ent statistics, we used the m in im um lim it of fragm ent mass $m_{min} = 0.001$ g. This roughly corresponds to the reliable lim it of our m easurem ents. M oreover, this value is su ciently larger than the smallest lim it mass of two-dimensionality 0.2^3 (mm³) 3:9 10^3 (g/mm³)




FIG.2: Typical pro les of the current I, voltage V, power P, and discharge energy E as functions of time. A sharp power pulse can be con med on an approximately stime scale.

 $= 3:1 \quad 10^{5} \text{ g.}$

First, we show typical pro les of the current, voltage, power, and released energy during a discharge in Fig. 2. O ther experiments showed similar pro les qualitatively. A very sharp power pulse was con med. The electrical discharge happened on a stime scale, which resulted from the electrical properties of the circuit. This resulted in e cient melting of the copper wire.




FIG.3: Typical cum ulative fragm ent m ass distributions. The distribution curves were obtained from a m ean of 4, 5, 3, and 6 fragm entation events for 20 kV (150 m m), 21 kV (150 m m), 20 kV (200 m m), and 23 kV (200 m m), respectively. The inset shows the relation between the estimated discharge energy and average total fragm ent num ber.

Next, we show merged cum ulative fragment mass distributions in Fig. 3. In Fig. 3, the N (m) curves are dened as N (m) = $_{i=1}^{L} N_{i}$ (m)=r, where r and N_i (m) are the num ber of sum -ups and the ith cum ulative distribution, respectively, i.e., the N (m) curves are averaged. W e averaged the results under the sam e conditions (discharge voltage and sample size). The mass m was normalized to the average totalm assm tot. For the cases with a high voltage discharge, the N (m) curves show a power-law-like portion. This regime corresponds to the fully fragmented state. By contrast, with low voltage discharge, the N (m) curves appear alm ost at in the sm allm ass region. They clearly di er from the fully fragm ented regim e distributions, and are similar to an integrated log-norm aldistribution. These features resemble those of im pact fragmentation [12, 13]. We also show the relation between the estimated discharge energy per unit mass $(E_d = m_{tot})$ and the average total fragm ent num ber per unit m ass $(N = m_{tot})$ in the inset of Fig. 3. Roughly speaking, the estim ated discharge energy shows the extent of the inner pressure produced, and the average total fragm ent num ber indicates the degree of fragm entation.

We tried to t the data in the fully fragmented regime using two traditional forms: the double exponential form N (m) = $A_1 \exp(m = m_1) + A_2 \exp(m = m_2)$, and the power-law with exponential decay form N (m) = $A_0m^{(1)} \exp(m = m_0)$. Where m_0, m_1, m_2, A_0 , A_1 , and A_2 are thing parameters. The results of thing for the 150-m m-long and 21-kV-discharge case are shown




FIG. 4: Fitting results using the double exponential and power-law with exponential decay form s. C incles indicate the result for 150-m m -long tubes with a 21 kV discharge. Both ttings m ake good agreem ent.

in Fig.4. Both function form sagree with the experim ental results very well. O ther N (m) curves for the fully fragmented regime were also tted using both form s. We cannot conclude which form is more appropriate to explain the experiment.

The generic scaling form proposed by Astrom et al. (Eq. (3) in Ref. [9]) is close to the double exponential form when the penetration depth in the scaling form is small. The penetration depth indicates the strength of crack progression whose dynamics result in a powerlaw fragm ent m ass distribution [9]. In our experim ent, a small penetration depth is reasonable because the pressure loads were applied uniform ly to the two-dimensional (2D) space of the sam ples. Fragm entation occurred simultaneously throughout 2D space due to this loading condition symmetry. Then, crack nucleation determines the fragment mass distribution rather than the deep crack dynam ics. C onsequently, the fragm ent m ass distribution approxim ates the double exponential form due to the Poisson random nucleation of a crack and the dynam ics of neighboring cracks that lack a su cient power-law (i.e., a sm all penetration depth). In fact, the horizontal sandwich experimental results in Ref. [12] can be tted using A strom et al.'s scaling form when that is close to the double exponential form [18]. The horizontal sandwich experim ent has sim ilar loading condition symmetry to the present explosive experim ent.

C onversely, an empirical form of the power-law with exponential decay also results in good agreement. This form has fewer thing parameters than the double exponential form and is consistent with other experiments, analyses, and simulations performed to date. A weakness of this thing is the narrow region of the power-law regime in our data. Since the linear part of the log-log plot covers less than one order of magnitude, it m ight not

be su cient to conclude that the power-law form is valid. Note that the double exponential function can produce a sim ilar portion, as seen in Fig. 4. W e found 1 values in the range 0:66 0:76 for the fully fragm ented regime. These values dier from the results of W ittel et al. [14]. There are two free boundaries in the geom etry of a tube, whereas an eggshell has only one. To check the boundary e ect, we also experim ented with two-tone colored tubes. However, we found no signi cant di erence between the regions near the ends and that in the middle of the tubes. W hile W ittel et al.'s explosion arose from a point source and expanded spherically, we used a linear source and the explosion expanded cylindrically. The curvature of the samples might also have a ected the results. These reasons might explain the di erences in the results, although we think that the problem remains unresolved.




FIG.5: Log-log plot of the weighted m ean fragm ent m ass M vs. the multiplicity . The crossover point $_{\rm c}$ is not universal for in pact and explosive fragm entation. H owever, the slopes (exponent) appear to be universal.

W e also exam ined the behavior of the kth order m om m kn (m) in order to elucidate the criti $m ent M_k =$ cal scaling in the explosive fragm entation. Note that this sum m ation involves the largest fragm ent m ass. Sim ilar to the previous analyses [12, 13], we show the log-log plot of $M = M_2 = (M_1 m_{min})$ vs. $= M_0 m_{min} = M_1$ in Fig. 5. Figure 5 also shows previous results for in pact fragm entation [12, 13], where M and are the weighted mean fragm ent m ass and m ultiplicity, respectively [12, 13, 19]. W hen we assume the scaling M ,we can con m the crossover of the scaling exponent at a certain $_{\rm c}$ [13]. As Fig. 5 shows, a crossover from a small value to a large one can also occur in explosive fragm entation. Nevertheless, the crossover point c does not seem to be universal for impact and explosive fragmentation. Although we have conjectured on the universality of $_{\rm c}$ in Ref. [13], it shows non-universal behavior. However, this is not surprising. The slopes (exponent) appear to be universal in the two. We think that this is reasonable in terms of critical universality. In general, the critical




FIG.6:Universal scaling plots of the weighted m ean fragment mass. We use the values = 0:4 and = 0:7. We show (a) M =L vs. =L, and (b) M =L $^+$ as a function of .

point is not universal despite the universality of critical exponents. Moreover, this di erence in $_{\rm c}$ might arise from di erences in the materials, i.e., glass or ceramic.

W e would like to determ ine a more universal law for fragmentation criticality. In order to in prove the scaling, we use the norm alized largest fragment mass L = $m_L = m_m$ in, where m_L is the largest fragment mass. In the nite size system, L plays an important role for scaling analyses. Finally, we assume the universal scaling of the weighted mean fragment mass, as shown in Figs. 6, which include both impact and explosive results. The scaling

form should be written as M = L = f(=L). In Fig. 6(a), we use the values = 0.4 and = 0.7. From Fig. 6(a), we deduce the scaling function f(x) = 0.7. From Fig. 6(a), we deduce the scaling function f(x) = 0.424 0.006 from the tring the data in Fig. 6(a). Furtherm ore, this in plies $M = L^{+}$. We show the log-log plot of $M = L^{+}$ as a function of in Fig. 6(b). The value from Fig. 6(b) is = 0.42 0.01. In either case, the scaling appears convincing globally. We believe that must be a crucial scaling for critical fragm entation. Speci cally, the weighted mean fragm ent mass M can be scaled as $L^{0.69} = 0.42$ independent of the fragm ent m ass distribution type: log-norm al, power-law, or double exponential. The scaling is very robust for sm all to large in parted energies.

If we assume the binom ial multiplicative model with parameter a = 2=3 [12] for the small regime, we can calculate _{bin} as

$$b = \frac{\log a \log [a^2 + (1 - a)^2]}{\log 2 \log a};$$

Substituting = 0.4, = 0:7, and a = 2=3 into Eq. (1), we obtain $_{\text{bin}}$ = 0:44. This value is close to = 0:42. By contrast, if we assume the power-law form (with 1 < < 2) for the large regime, M $_{k}$ can be expressed as M $_{k}$ $_{1}$ m k m dm. From this notation, we can approximate M =L (=L) $^{\text{pow}}$ as [L $^{(3)}$ =L $^{(2)}$]=[L] ([L $^{(2)}$]=[L]) $^{\text{pow}}$; therefore,

W hen we substitute = 0:4, = 0:7, and = 1:7into Eq. (2), we are led to $_{pow}$ = 0:6. This value is slightly di erent from = 0:42. This suggests the lim it of the power-law approximation, or the importance of the exponential form. Determining the origin of the values , , and remains a future problem. A theoretical study of this scaling would clarify the fragmentation criticality well.

In conclusion, we carried out a two-dimensional explosive fragmentation experiment using pulsed power. The N (m) curves for the fully fragmented regime could be t-ted using the double exponential form or the power-law with exponential decay. Each form has merits and demerits. The weighted mean fragment mass M was scaled using the multiplicity and its scaling showed crossover, just as in impact fragmentation. While the scaling exponent was the same as for in pact fragmentation, the crossover point $_c$ di ered. Using the normalized largest fragment mass L, we obtained universal scaling between the impact (both vertically and horizontally) and explosive fragmentation data. This scaling also appears independent of the material broken.
