A nalytic theory of DNA condensation

We introduce a novelm odel for DNA condensation (whip-toroid transition) using the path integral method in the fram ework of the non-linear sigm a model on a line segment. We show that some of its classical congurations exhibit toroidal forms, and the system has phase transitions from a whip to toroidal phases with a parameter $c = \frac{W}{21} \left(\frac{L}{2}\right)^2$. We also discuss stability and nite size election these states.

Since in living cells DNA is often packaged tightly, for instance, inside phage capsids, DNA condensation has drawn much attention [1, 2, 3, 4, 5, 6] as well as its biochem ical/medical importance in the emerging eld of gene therapy. In fact, when we put condensing agents as multivalent cations into DNA solution, it can cause DNA to undergo the condensation from a worm—like chain (whip) to toroidal states [1, 2, 3, 4].

A double stranded DNA chain can be modelled, for example, by a semi exible hom opolymer chain [7, 8, 9]. To increase our understanding of \whip-toroid transition", sem i exible hom opolym ers in a poor solvent condition (i.e e ective interactions between polymer segments are attractive) have been investigated as simple models [10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24]. Simulations using Monte Carlo, Langevin approaches or Gaussian variational method, calculated phase diagram for the semi exible chain in a poor solvent [10, 11, 12, 13, 14, 15, 16]. In theoretical works, existing phenom enological models balance the bending and surface free energies to estimate toroidal properties [17, 18, 19, 20, 21, 22, 23, 24]. It becomes increasingly probable that toroid is the stable lowest energy state the ground state. We note, however, that the theoretical aspects of the works assume a prioritoroidal geometry as the stable lowest energy state with no theoretical proof [21]. Moreover, compared to the theory of coil-globule transition of exible chains 7, 25, 26, 27, 28], which are well described by eld theoretical form alism 25, 26], there is no sim ple m icroscopic theory, which contains the salient physics to dem on strate the whip-toroid transition of the semi exible polymer. Di culties in formulating theory results speci cally from the local inextensibility constraint of the semi exible chain 8, 9], which makes the theory non-Gaussian, and also from the non-local nature of the attractive interaction along the polymer chain, which makes the theory analytically intractable.

In this letter, we investigate the whip-toroid transition of a single sem i exible hom opolym er chain with attraction, using path integralm ethod and the nonlinear sigm a model on the line segment.

In the continuum limit, the Green function (end-to-end distribution) of a sti polymer chain with attractive

interactions can be given by the path integral

with a constraint jaf = 1 [8, 9]. s is the proper time along the sti polymer chain of total contour length L. r(s) denotes the pointing vector at the time's in our three dimensional space while u(s) $\frac{\theta \, r(s)}{\theta \, s}$ corresponds to the unit orientation vector at s. N is the normalisation constant. Following Freed et al. [8, 26], the dimensionless Ham iltonian can be written by H [r;u;W] = $R_{\rm L}$ of [s] (s) + $V_{\rm A\,T}$ (s)]where H (s) and $V_{\rm A\,T}$ (s) are the local free Ham iltonian and the attractive interaction term , respectively:

l is the persistence length and W is a positive coupling constant of the attractive interaction between polymer segments. Thermodynam ic = 1=(k_B T) is implicitly included in l and W . This will be revived when we consider the thermodynam ic behaviours of the system . In what follows, we express r by the unit tangent vector u and therefore the H am iltonian H (u) in terms of u. Hence, the G reen function G 0; R; u_i ; u_f ; L; W becomes a path integral over u with a positive coupling constant W , regardless of r,

where we used $r(L) = \frac{R_L}{_0} \, ds\, u\, (s)$ and the Jacobian is absorbed by N which is neglected here. The delta function selects out the end-to-end vector. When W = 0, our free dimensionless Hamiltonian with the constraint $ju\, (s)\, j^2\, =\, 1\, can\, be\, interpreted\, as\, the\, low\, energy\, limit of a linear sigma model on a line segment, or quantum equivalently a nonlinear sigma model on a line segment, rather than some constrained Hamiltonian system.$

We begin with O (3) nonlinear sigm a model on a line segment which is nothing but a quantum mechanics of a limited times 2 [0;L] with a constraint. The constraint juj = 1 restricts the value of u on a unit sphere S². Its polar coordinate decomposition in the free Hamiltonian H (u) = $\frac{1}{2} \, ^{\rm RL}_{\rm O}$ ds ju (s) j gives the action:

This is called the nonlinear sigm a model since the action is 0 (3) sym metric but some of its transform ations are realised nonlinearly. Minimizing the action (5) in terms of μ and μ yields the classical equations of motion:

Our aim is now to explore classical solutions of eq.(6) and to study the whip-toroid phase transition in the presence of attractive interactions. Consider classical solutions of eq.(6) with a trial solution $_{\pi}=0$. The sequation of (6) leads to $\sin 2_u ('_{-u})^2=0$. Thus the solution is either $_{u}=0;_{\overline{2}};$ or $'_{-u}=0$. The solutions $_{u}=0;$ or $'_{-u}=0$ with $_{\overline{u}}=0$ are equivalent to having a constant $_{\overline{u}}$. A coordingly, classical solutions reduce to $_{u}=\frac{1}{2}$ or $_{\overline{u}}=0$ onstant $_{\overline{u}}=0$ onstant $_{\overline{u}}=0$ onstant $_{\overline{u}}=0$. Therefore, we have two types of classical solutions:

where a;b are constants. By symmetry argument, we state that the solutions (7) represent the general solutions [29]. That is either a constant u(s) (rod solution) or a rotation at a constant speed along a great circle (toroid solution).

Now we consider the attractive interaction term (3). It is discult to interpret it in the context of quantum theory due to its non-local nature along the polymer chain. However, we can solve them with our classical solutions (7). W ithout any loss of generality, we assume a > 0 and n 2 Z_+. Introducing N (s) [as $_R^2$] by G auss' symbol [31], we obtain $_{s=2}^{s}$ a dtu (t) = $_{s=4}^{s}$ a dtu (t) = $_{s=2}^{s}$ N (s)=a dtu (t) = 0. Therefore, the attractive potential is given by V_{AT} (s) = W N (s). Note that N (L) represents the winding number of the classical solution (7) along a great circle of S 2 . Finally, an integration over s yields the dimensionless H am iltonian with our classical solutions:

The rst term denotes the bending energy, and the second and the third terms are thought of as 'topological' terms from the winding number.

The non-zero winding number of the classical solution in the α space means that the polymer chain winds in the respace as well. That is, when a > $\frac{2}{L}$, congurations around the second classical solution (7) start forming a toroidal shape since

and stabilise itself by attracting neighbouring segments. We call such classical solutions the \toroid states." Whenever a increases and passes through the point $\frac{2-n}{r}$ for n 2 Z+, another toroid state appears with the increased winding number n. Note that the radius of the toroid state is given by $\frac{1}{a}$. When the chain of contour length L winds N (L) times we have the N (L) circles of each length $\frac{2}{a}$ and the rest L $\frac{2}{a}$ N (L) . The second and third terms in the second line of eq.(8) result from the form er and the latter respectively. When $0 < a = \frac{2}{\tau}$, the chain cannot wind like the toroid states. Both ends of the chain are not connected to each other, thus can move freely as well as any other parts of the chain uctuate. As long as the total energy of the chain does not exceed the bending energy of $\frac{2^{-2}1}{L}$ at $a = \frac{2}{L}$, they can whip with zero winding number. We call such low-energy states the \whip states." Although the de nition includes uctuations around the classical solutions, unless otherwise stated, we prim arily refer to the classical solutions of such states, which are rather bow strings than whips.

We now explore the exact energy levels of the whip and toroid states, and discuss the phase transitions between these states. The dimensionless Hamiltonian of the second classical solution (7) is a function of l;L;W and a:

This matches with the rst classical solution when $\frac{N(L)}{a}=0$ for a=0 is de ned. A coordingly, the above expression is valid for all classical solutions.




FIG. 1: The dependence of the energy $\frac{H}{W}$ (a) on x = aL=2 and c. H (a) is scaled by the factor of $\frac{W}{W}$ 1 for convenience. The de nition of c will appear shortly.

Consider rst a case with L,W, and l xed. By denition, H (a) H_{cl}(a;l;L;W) is continuous in the entire region of a 0 and is a sm ooth function in each segment: a 2 $\frac{2 \text{ N}}{\text{L}}$; $\frac{2 \text{ (N+1)}}{\text{L}}$ for N 2 Z 0. However, it is not sm ooth at each joint of the segments: $\frac{\text{aL}}{2}$ 2 Z₊. We plot, in Fig.1, the energy level as a function of a for dierent values of c, showing qualitative agreement with Conwell et al. [5]. Given N (L) = N is xed, the Hamiltonian 10)

takes a m inim um at a = a_c (N) $\frac{w}{L1}$ N (N + 1) $^{1=3}$. A coordingly, each segment falls into one of three cases:

- (i) W hen a_c (N) $-\frac{2~N}{L}$, H (a) is a monotonic function in the segment and takes its m in im um at a = $\frac{2~N}{L}$.
- (ii) W hen $\frac{2\ N}{L}$ < a_c (N) < $\frac{2\ (N+1)}{L}$, H (a) behaves quadratic in a and takes its m in im um at a = a_c (N).
- (iii) W hen $\frac{2-(N+1)}{L}$ < $a_c(N)$, H (a) is monotonic in the segment and takes its minimum at a = $\frac{2-(N+1)}{L}$.

The rst and third cases are physically less relevant since they mean no (meta—) stable point in the segment. So, we focus on the second case. Introducing a new parameter c $\frac{L}{2}^{2}\frac{W}{21}$, the condition for N or a to be in the second case turns out to be

where N = [aL=2], N $_L$ (c) $\frac{c}{2}$ 1 $\frac{2}{c}$ + $\frac{q}{1}$ $\frac{4}{c}$, and N $_U$ (c) $\frac{c}{2}$ 1+ $\frac{4}{c}$.

When N_U (c) 1 (i.e. c $\frac{1}{2}$), the above second condition vanishes and thus the whip states only survive at low energy. Therefore, at the critical value of c = $\frac{1}{2}$,

the whip phase to whip-toroid co-existence phase transition m ay occur. On the other hand, when $c > \frac{1}{2}$, there always exists at least one (meta-) stable state for some non-zero value of a with positive winding number N (L). The number of minima are roughly given by the width of the region for N , i.e., N U (c) N L (c). For example, 4, N $_{\rm U}$ (c) N $_{\rm L}$ (c) > 3, and therefore there are at least three m in in a with positive winding numbers greater than 1. When 0 < c < 4, the condition of having three m in im a is $c > \frac{9}{4}$. To sum m arise, when $c > \frac{9}{4}$ there exist at least three minima with dierent winding num bers. This occurence of the multiple local minima is because the energy is given by the balance between the bending energy and the attractive potential energy. The form er is a monotonically increasing function of a while the latter is monotonically decreasing but not smooth function of a. This non-smoothness is a source of multiple stable states. Note that our precise analysis shows that the number of minima could be reduced in some cases, for example, one can con m it shortly by plotting the Hamiltonian (12) with some nite size e ect on. The existence of multiple minima indicates the storderphase transitions between these stable states. In fact, when the energy of the N = 1 stable toroid state becomes zero, the whip dom inant to toroid dom inant phase transition occurs. Such a value of c is 27=16. When c > 27=16, the toroid states will dominate the action. Further discussions on the phase transitions can be seen by changing the value of c [30].

O ne can plot the critical value of c where the m in in um of the N -th segment emerges and vanishes. The lower bound of the N -th segment is $c_L^{(N)} = \frac{N^2}{N+1}$, while the upper bound is $c_U^{(N)} = \frac{(N+1)^2}{N}$. So, when $c_L^{(N)} < c < c_U^{(N)}$, the N-th segment has a m inim aland (m eta-) stable point. For example, when $\frac{1}{2} < c < 4$, the rst segment a 2 $\frac{2}{L}$; $\frac{4}{L}$] (i.e. N = 1) has a m inim al point at a = a_c (1).

So far we have dealt with the classical solutions, which are derived from the rst derivative of the action. Thus, they may correspond to the global/local minima of the action in the conguration space. However, the solutions are not necessarily stable unless we take into account the attraction, since the second derivative of the action is zero or even negative in many cases. When we take the attraction into account, we observe the followings. When captured the the toroid states become stable under the quantum uctuations, since deviations from such toroid states will cost a large penalty in energy. When c is small, a number of the whip states become equally or more probable to any toroid state.

For large c, the ground state | the dom inant toroid state of the w inding number N $_{\rm C}$ can be estimated by the inequality relation of c: $c_{\rm L}^{\rm (N)}$ < c < $c_{\rm U}^{\rm (N)}$. It reads N $_{\rm C}$ ' c. U sing this, we can estimate that the radius of our ideal toroid behaves $r_{\rm C}=\frac{L}{2~\rm N_{\, C}}=\frac{4~\rm l}{\rm W~L}$. Our ideal toroids have zero thickness, but the nite size e ect of their cross sections can be approximated by the hexagonally arranged DNA chains with a van der W aals type interaction, i.e., with the elective nearest neighbour interactions. In the

case of N (L) 4, it leads to the modi ed H am iltonian:

Following the same procedure for $c_L^{(N)} < c < c_U^{(N)}$, one can not N_c ' $2^p \frac{-2}{3} c^{\frac{2}{5}}$ for large c. By $r_c = \frac{L}{2 N_c}$, we now estimate the mean radius of the toroid (i.e. the average of inner and outer radii) in a physical system in more detail. A coupling constant can be given by W = $\frac{1}{l_m} \frac{k}{k_B T}$ where k is the number of the electric dipoles in a monomer segment, which create van derW aals interactions of the magnitude . $\frac{1}{l_m}$ denotes the length of the monomer along the chain contour, taken to be l_m ' 5 tp = 1:66 nm in the end. Substituting N $_c$ and the above, we obtain

This L $\frac{1}{5}$ dependence agrees with the proposed exponent in the asymptotic lim it [18, 22, 23, 24].

W e estim ate the m ean toroidal radius of T 4 D N A in low ionic conditions reported in ref.[4]. Using L = 57 m , l'50 60 nm , and l_m , the m ean radius of the toroid is r_c = 29.09B $^{\frac{2}{5}}$ 31.29B $^{\frac{2}{5}}$ [nm], where B $\frac{k}{k_B\,T}$. This result is in good agreement with the experiment r_c '

28.5 nm for B $\,$ 1.15. The same argument for Sperm DNA packaged by protamines (L = 20.4 m) gives the analytic value r_c = 23.69B $^{\frac{2}{5}}$ $\,$ 25.48B $^{\frac{2}{5}}$ [nm], which is comparable to an experimental result r_c ' 26.25 nm . Note that the latter has a larger diameter of the segment and is expected to have the weaker interaction with smaller B .

The exponents predicted in the literature for r_c L are $=\frac{1}{5}$ in most cases [18, 22, 23, 24]. However, they are inconsistent with the experimentally well-known observation that the radius is independent of the chain length [2, 3, 4]. This might suggest that the real interaction is not van der W aals like, or at least is not a single van der W aals type interaction. It should be noted here that combinations of our ideal toroid and its nite size e ect can give a range of =1 $\frac{1}{5}$ in some region. Another important and interesting remark is that, in fact, when we apply C oulomb like interactions to our approximation, we observe some asymptotic behaviour that the radius remains constant as L changes. The precise analysis is to be studied and given in the near future.
