## Irreversible dynam ics of the phase boundary in U (R u<sub>0:96</sub>R h<sub>0:04</sub>)<sub>2</sub>S i<sub>2</sub> and im plications for ordering

We report measurements and analysis of the speci c heat and magnetocaloric e ect at the phase boundary into the single magnetic eld-induced phase (phase II) of U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub>, which yield striking similarities to the valence transition of Yb<sub>1</sub>  $_{\rm X}$ Y  $_{\rm X}$  InCu<sub>4</sub>. To explain these similarities, we propose a bootstrap mechanism by which a structural distortion causes an electric quadrupolar order parameter within phase II to become e coupled to the 5f-electron hybridization, giving rise to a valence change at the transition.

The broken symmetry order parameter responsible for the large speci cheat anom aly at To 17 K in URu<sub>2</sub>Si<sub>2</sub> continues to be of interest owing to its elusive hidden' nature [1, 2]. W hile there has been no clear consensus on the appropriate theoretical description of the hidden order' (HO) phase [3, 4, 5, 6, 7, 8, 9, 10, 11, 12], the key properties of the Ferm i liquid state, upon which the HO param eter m anifests itself, can be understood. C om prehensive de Haas-van Alphen (dHvA) measurements [13] reveal the quasiparticles to have heavy e ective masses and Ising spin degrees of freedom [14], indicating that nearly-localized 5f-electron degrees of freedom contribute to the Ferm i liquid. W ithin an Anderson lattice scheme, hybridization causes the itinerant quasiparticles to acquire the spin and orbital degrees of freedom of a lowest lying crystal electric eld 5f-multiplet [15]. In this case, it is a 5 non-K ram ers doublet [6], m aking the quasiparticles in URu2Si2 unique among heavy ferm ion m aterials, possessing electric quadrupole as well as Ising spin degrees of freedom [14].

On the basis of the dH vA experiments, one can further assert that the HO phase I (that exists at magnetic elds  $_0\mathrm{H}$  . 35 T and temperatures T . 17 K [16]) must be explained within the context of an itinerant 5 quasiparticle model. This is required to account for the survival of  $_5$  quasiparticles deep within the HO phase [13, 14, 17]. It inerancy of the f-electrons could also be an important factor in making an itinerant electric-quadrupolar order param eterdi cult to detect, as proposed for som e of the m ore exotic itinerant m odels [7, 8, 11, 12]. G iven that the HO param eter has defeated attempts at a direct observation, the existence of ` 5 quasiparticles' necessitates an alternative question: can the electric quadrupolar degrees of freedom order within an itinerant 5f-electron model, and, if so, how might such ordering di er from the established local m om ent quadrupolar system s such as  $UPd_3$  [18]? Until such questions are addressed by

a m icriscopic theory, an alternative approach to exploring the question of electric quadrupolar order is to tip the balance of the interactions in favor of local m om ent quadrupolar order of the type seen in  $UPd_3$  [6, 18]. In URu<sub>2</sub>Si<sub>2</sub> this might be achieved in two ways. The rst is by Rh-doping, which shifts the spectral weight of the 5f-electrons away from the Fermi energy [19], weakening the extent to which they hybridize. Rh-doping also inhibits q-dependent it inerant mechanisms by smearing the states at the Ferm i surface. The second is by applying strong magnetic elds, which enhance the e ect of local correlations in the vicinity of the m etam agnetic transition, causing the quasiparticle bandwidth to collapse [21]. The large magnetic susceptibility associated with m etam agnetism also strongly favors XY order [20] (in which electric quadrupole 'pseudospins' lie orthogonalto the tetragonal c-axis) over Ising antiferrom agnetic order [6].




FIG.1: (a) Phase diagram of U (R  $u_{0:96}$  R  $h_{0:04}$ )<sub>2</sub>Si<sub>2</sub> determ ined by M CE (circles) and C<sub>p</sub> (T) (star symbols). Solid (open) circles indicate the phase boundary exiting (entering) the ordered phase II. The dashed lines represent the approxim ate Ferm ienergy scale, as modi ed by correlations due to m etam – agnetism [21]. (b) M CE of U (R  $u_{0:96}$  R  $h_{0:04}$ )<sub>2</sub>Si<sub>2</sub>, with arrows indicating the direction of H sweep. (c) M CE of Y bInC  $u_4$ , with the changes T in T rescaled 2.

In this paper, we propose that the interplay between an electric quadrupolar order parameter and the extent  $V_{fc}$  to which 5f-electrons hybridize causes the transition into phase II in U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> [22] (shown in Fig. 1) to acquire therm odynamic similarities to the valence transition of Y bInCu<sub>4</sub> [23, 24]. These similarities are evident both in magnetocalorice ect (M CE) and speci c heat  $G_p$  (T) data. When a more conventional (i.e. non-itinerant) type of electric quadrupolar order [6, 18] occurs, the associated structural distortion can alter  $V_{fc}$ , which determ ines both the electric K ondo temperature' and the valence state of the system [23, 24, 25].

The MCE is a convenient tool for studying phase boundaries in a magnetic eld [16]. Here, the sample temperature T is recorded while the magnetic eld H is swept rapidly under quasi-adiabatic conditions. W hen an order-disorder transition is crossed, an abrupt change in T re ects the fact that entropy cannot change. A typical MCE measurement for U ( $Ru_{0:96}Rh_{0:04}$ )<sub>2</sub>Si<sub>2</sub> is

shown in Fig. 1b. The T(H) curve obtained during the H up-sweep (red line) shows a sudden increase when 27 T, indicating that the system enters an or-<sub>0</sub>H dered phase: i.e. T must increase in order to conserve entropy. The system then relaxes to equilibrium with the bath until the next phase boundary, exiting phase  $\Pi_{i}$  is encountered at 0H 38 T. Now T swings the opposite direction as the ordered phase is abandoned. The observed M C E anom alies are hysteretic, as evident from their dependence on the direction of H sweep, which is a direct consequence of the transition being of st order. A nother system atic feature of the data is that the change in T is larger at the high H phase boundary, being consistent with a larger jum p in the magnetization [22]. Furtherm ore, the net m agnitude of the swing in T is larger when entering phase II than exiting it. A similar asymmetry is observed in  $Yb_1 \times Y_x InCu_4$  (with x = 0), see Fig. 1c.




FIG. 2: Interversible  $T_{\rm irr}$  (circles) and reversible  $T_{\rm rev}$  (stars) components of the MCE as a function of T for U (Ru\_{0:96}Rh\_{0:04})\_2Si\_2 (solid symbols) and YbInCu4 (open symbols). The data corresponding to U (Ru\_{0:96}Rh\_{0:04})\_2Si\_2 (YbInCu4) are linked to the right (left) and upper (lower) axes. The thin lines are ts of E $_{\rm p}$  (T) to the  $T_{\rm irr}$  data while the thick lines are merely guides to the eye.

The total swing T in T in the MCE curve (for a given direction of H sweep) is the sum of reversible  $T_{rev}$  and irreversible  $T_{irr}$  contributions.  $T_{rev}$  always changes sign when the direction of sweep of the magnetic eld is changed, while  $T_{irr}$  does not, since is entirely due to irreversible (or dissipative) processes. The latter can be associated with the pinning of domain bound-

aries to the crystalline lattice [26], causing the system to become metastable with its actual state depending on its history. Pinning forces become especially relevant if the order parameter involves charge degrees of freedom, as is known to be the case for valence transitions and electric quadrupolar phases [6, 24]. Figure 2 shows the extracted  $T_{rev}$  and  $T_{irr}$  for both U ( $Ru_{0:96}Rh_{0:04}$ )<sub>2</sub>Si<sub>2</sub> and Yb<sub>1 x</sub>Y<sub>x</sub>InCu<sub>4</sub> (with x = 0). In the case of U ( $Ru_{0:96}Rh_{0:04}$ )<sub>2</sub>Si<sub>2</sub>, data is shown only for the upper critical eld and the axes have been rescaled to compare the two system s. At higher T,  $T_{rev}$  dom inates the M CE in both materials, but the entropy vanishes as T ! 0,

 $T_{rev}$  must also vanish, causing  $T_{irr}$  to dom inate in that lim it. The latter grows rapidly as T ! 0: this is especially clear in the case of YbInCu<sub>4</sub> for which a greater range in T can be accessed owing to its high transition tem perature.




FIG. 3:  $C_p(T)$  at di erent values of H measured on (a) U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> for <sub>0</sub>H < 34 T, (b) U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> for <sub>0</sub>H 34 T, and (c) Yb<sub>1 x</sub>Y<sub>x</sub>InCu<sub>4</sub> (with x = 0.1) using a superconducting magnet. Solid symbols represent  $C_p$ measured with the rst heat pulse on warming-up while open symbols represent the average of subsequent heat pulses.

The similarities between  $U(Ru_{0:96}Rh_{0:04})_2Si_2$  and  $Yb_{1 x}Y_{x}InCu_{4}$  also extend to measurements of the  $C_p$  (T). Figure 3 shows  $C_p$  (T) for U ( $Ru_{0.96}Rh_{0.04}$ )<sub>2</sub>Si<sub>2</sub> and  $Yb_{1} X_{x}$  InCu<sub>4</sub> (with x = 0 and 0.1) measured at constant H at many di erent tem peratures using the therm al relaxation time m ethod [16] (both during a warm up and cooling down of the sample using a sm all 1-3% T increment). The  $\mbox{ rst } C_p \mbox{ (T ) point } m \mbox{ easured at each }$ T during the warm up yields a larger value (solid sym bols) than subsequent points (open symbols), which is consistent with the irreversibilities observed using the  $M \; C \; E$  . However, neither the  $\;$  rst  $C_{\!p} \; (\! T \; \!)$  point (as explained above) nor the subsequent points can be used to extract the precise entropy change at the transition. The form er includes the energy absorbed by irreversible processes (depinning dom ain boundaries etc.) in addition to

the equilibrium  $C_p(T)$ . Once the sample has settled into a new metastable state at each T, subsequent measurements have a much reduced e ect on its state, leading to a smaller estimate for  $C_p(T)$ . Type-II superconductors are well known to give rise to a similar irreversible behaviour [27], with the pinned current prole relaxing considerably after the initial thermal cycle.

It is, nevertheless, worth emphasizing the pridi erence betw een m ary  $U(Ru_{1.96}Rh_{0.04})_2Si_2$ The valence instability in and  $Yb_{1 x}Y_{x}InCu_{4}$ .  $Yb_{1 x}Y_{x}InCu_{4}$  is the consequence of a situation whereby the total free energy of the solid develops multiple m in in a as a function of the volum e along with  $V_{fc}$  [23, 24]. One can consider the mean value of the hybridization operator as the e ective order parameter, although the f-electron density is the most natural order parameter to describe a valence transition. Such an order parameter is non symmetry-breaking, making it directly analogous to boiling point of a liquid. The fact that phase II in U (Ru,Rh)2Si2 occurs only under nite magnetic elds in the vicinity of a metamagnetic

crossover [21], around which the correlations are strongly enhanced, indicates that this phase has a di erent origin to the valence transition in  $Yb_1 _x Y_x InCu_4$  or  $Ce_{0:8}Th_{0:1}La_{0:1}$  [23, 24, 25].

Phase II in U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> can condense at tem peratures that exceed the characteristic Ferm i liquid tem perature (extrapolated from outside the ordered phase) [21]. This together with the roughly symmetric shape of the phase boundary around the m etam agnetic transition is strongly suggestive of local m om ent ordering. A broken symmetry order parameter involving a structural distortion of the lattice, so as to change  $V_{fc}$ within phase II, would provide a very e ective bootstrap mechanism for both ensuring its stability and causing the transition to become storder like that in Y InCu. The large changes in sound velocity observed by Suslov et al. [28] in pure UR u2 Si2 indicate a pronounced m agnetoelastic coupling consistent with a lattice distortion. Furtherm ore, the large redistribution of entropy involved in the form ation of phase II indicates that the 5f-electrons are involved [21], which strongly favors a lattice distortion caused by a electric quadrupolar order param eter as opposed to a charge-density wave.

The possibility of a broken symmetry order parameter being coupled to  $V_{\rm fc}$  may have wider appeal than U ( $Ru_{0:96}Rh_{0:04}$ )<sub>2</sub>Si<sub>2</sub>. For example, an equivalent coupling in Y bRh<sub>2</sub>Si<sub>2</sub> would provide a rather natural explanation as for why the critical eld of its unidenti ed low T ordered phase acquires the physical characteristics of a Valence uctuator' quantum critical point [29].

H aving established that the f-electron valence plays an equally in portant role in dom inating the therm odynam – ics of both U (R  $u_{0:96}$ R  $h_{0:04}$ )<sub>2</sub>Si<sub>2</sub> and Y  $b_{1-x}$  Y<sub>x</sub> InC  $u_4$ , further analysis of the irreversible processes are required in order to understand F ig.2. The increase in T<sub>irr</sub> as T ! 0 is consistent with the loss of therm al uctuations, which enable the dom ain boundaries to overcom e pinning forces and undergo creep at nite T. Type II superconductors provide a good analogue for understanding creep [30], with the supercurrents sustained by pinned vortices being replaced in the present valence system s by the magnetic currents associated with the di erence in magnetization




FIG. 4: (a) magnetization as a function of eld at several temperatures for the U ( $Ru_{0:96}Rh_{0:04}$ )<sub>2</sub>Si<sub>2</sub> sam ple. (b) R elaxation of the magnetization for the Y b<sub>0:9</sub>Y<sub>0:1</sub>InC u<sub>4</sub> sam ple at  $_{0}H = 5 T$  and T = 18 K plotted as an stretched exponential.

M between dom ains. To model the present experimental data, we introduce a phenom enological model for the energy  $E_p / \exp(U_0=k_BT) \exp(U_0=k_BT_o)$  stored due to pinning. Here,  $U_0$  is the typical energy of a pinning site [30], while  $T_o$  is the characteristic ordering tem perature introduced to constrain the model so that  $E_p$  vanishes when M vanishes. In both systems, the transition tem perature  $T_o$  is optimal (maximum) when M = 0, occurring at 34 T in U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> (see Fig. 4a) and at H = 0 in Yb<sub>1 x</sub>Y<sub>x</sub>InCu<sub>4</sub>.

On sweeping the magnetic eld,  $E_p$  manifests itself as an irreversible (hysteretic) contribution to the magnetization M<sub>irr</sub> [31]. This energy must be released as heat as soon as the phase boundary is crossed, giving rise to the irreversible contribution T<sub>irr</sub> to the MCE.Upon making a rather simple assumption that  $T_{irr} / E_p$ , ts of  $E_p$  (T)

in Fig. 2 reproduce the experimental data rather well for both U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> and Yb<sub>1 x</sub>Y<sub>x</sub>InCu<sub>4</sub>, yielding U<sub>0</sub> = 1 0.3 K for both systems. Time-dependent magnetization measurements of Yb<sub>1 x</sub>Y<sub>x</sub>InCu<sub>4</sub> (with x = 0.1) in Fig. 4b provide rather direct evidence for metastability and creep, revealing that, after cooling the sample part way through the transition, the magnetization changes slow by under a constant H and T, having an approximate logarithm ic time dependence. The large critical elds prevent an equivalent study from being made on U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub>.

In sum m ary, we have shown that the irreversible properties of the rst order phase transition into the eldinduced phase (phase II) of U (Ru<sub>0:96</sub>Rh<sub>0:04</sub>)<sub>2</sub>Si<sub>2</sub> are very sim ilar to that associated with the valence transition of Y b<sub>1 x</sub>Y x InC u<sub>4</sub>. This suggests that the broken sym m etry order parameter responsible for phase II is coupled to a change in valence, or equivalently V<sub>fc</sub>. G iven that the low H Fermiliquid of URu<sub>2</sub>Si<sub>2</sub> (in which eld-induced phase II also occurs [22]) is consistent with a lowest energy 5 doublet [14], it is reasonable to expect some form of antiferroquadrupolar order. We propose that the collapse of the quasiparticle bandwidth associated with metam agnetism [21] favors eld-induced local moment electric quadrupolar ordering in  $URu_2Si_2$  [6] over the itinerant phases, which is further favored in U  $(Ru_{0:96}Rh_{0:04})_2Si_2$ by Rh-doping. A local moment ordering within phase II lends itself m ore easily to the established local spectroscopic probes such as NQR and resonant x-ray scattering [18], as well as magnetoelastic techniques such as m agnetostriction and therm alexpansion which have yet to be perform ed at the high m agnetic elds necessary to access phase II.

The itinerant order parameter responsible for the low H HO phase in pure  $URu_2Si_2$ , in contrast, may lend itself more accessible to probes that are more suitable for studying itinerant quasiparticles, such as the dHvA

e ect. Such probes have already revealed the Zeem an splitting of quasiparticle with Ising spin degrees of freedom [14], but could in principle be extended to studying the equivalent splitting of electric quadrupolar degrees of freedom by applying uniaxial strain in the appropriate X or Y direction.
