Two and Three D im ensional Incommensurate M odulation in Optimally-D oped B i_2 Sr₂C aC u₂O ₈₊

X-ray scattering measurements on optim ally-doped single crystal samples of the high temperature superconductor $B_{12}Sr_2CaCu_2O_{8+}$ reveal the presence of three distinct incommensurate charge modulations, each involving a roughly vefold increase in the unit cell dimension along the b-direction. The strongest scattering comes from the well known (H, K 0.21, L) modulation and its harm onics. However, we also observe broad di raction which peak up at the L values complementary to those which characterize the known modulated structure. These di raction features correspond to correlation lengths of roughly a unit cell dimension, $_{\rm C}$ 20 A in the c direction, and of $_{\rm b}$ 185 A parallel to the incommensurate domains and the interfaces between them, respectively. In addition we investigate the recently discovered incommensurate modulations which peak up at (1/2, K 0.21, L) and related wavevectors. Here we explicitly study the L-dependence of this scattering and see that these charge modulations are two dimensional in nature with weak correlations on the scale of a bilayer thickness, and that they correspond to short range, isotropic correlation lengths within the basal plane. We relate these new incommensurate modulations to the electronic nanostructure observed in $B_{12}Sr_2CaCu_2O_{8+}$ using STM topography.

I. IN TRODUCTION




FIG.1: A schematic diagram depicting one and a half unit cells of $B_{12}S_{12}CaCu_2O_{8+}$ is shown. The light (orange) pyramids represent CuO_2 plus apical oxygen complexes, while the dark (blue) octahedra represent BiO_2 plus apical oxygen atom complexes. The Cu ions reside at the center of the base of the light pyramids, while the Bi ions reside at the center of the octahedra. The CuO_2 and BiO_2 bilayer thicknesses are indicated as 3.3 A and 3.2 A, respectively, while the bilayer-bilayer separation of c/2 15.4 is also shown.

H igh tem perature superconductivity is observed and has been extensively studied across several fam ilies of layered copper oxides¹. W hile the structure of fam ilies of these m aterials di er in detail, they are all com prised of stackings of CuO₂ rectangular layers, with so-called charge resevoir layers in between. The CuO₂ layers can occur in isolation, or appear in bi- or trilayer assemblies. O ne of the m ost extensively studied of these m aterials is $B \frac{1}{2}Sr_2CaCu_2O_{8+}$, which is known to display an optimal superconducting T_C of 93 K¹. As shown in Fig. 1, it is a bilayer superconductor with orthorhom bic symmmetry and lattice parameters of a b 5.4 A, and c= 30.8 A². As such two CuO₂ bilayers appear within the unit cell separated by 15.4 A along c.

B i_2 Sr₂C aC u_2O_{8+} has been the high tem perature superconducting sam ple of choice for studies using surfacesensitive techiques such as photoem m ission³ and scanning tunneling m icroscopy (STM)⁴. This is due to the relative ease of producing clean, cleaved surfaces of B i_2 Sr₂C aC u_2O_{8+} at low tem perature, a consequence of its extrem e quasi-two dim ensionality, even com pared with other families of layered high tem perature superconductors, such as Y Ba₂C u_3O_7 and La₂ x Sr_xC uO_4 . T hese techniques and the inform ation they provide on electronic structure have been very important to the general eld of high tem perature superconductivity, and B i_2 Sr₂C aC u_2O_{8+} has been crucial to these studies. Unfortunately, the two dimensional nature of the material has also resulted in relatively thin single crystals being grown (with thicknesses in the c direction of as much as, but typically smaller than, a few m illimeters). This has precluded, or made very di cult, the study of the B i_2 Sr₂C aC u_2O_{8+} fam ily by experimental techniques which require a large volume of material, such as single crystal neutron scattering⁵.

The structural detail for which $B_{i_2}Sr_2CaCu_2O_{8+}$ is perhaps best appreciated is the incommensurate modulation it possesses within its basal plane. This incommensurate modulation has been observed by di erent techniques including, x-ray⁶, neutron⁷ and electron di raction⁸; scanning tunneling microscopy⁹, and electron microscopy¹⁰. This com plex crystal structure has been described in terms of two interpenerating periodic crystals, each of which modulate the other¹¹.

The modulation is one-dimensional, running along the b-direction in the basal plane, and it is the modulation (as opposed to a di erence between a and b lattice parameters) that is responsible for the lower-thantetragonal symmetry of the structure. The incommensurate modulation is characterized by multiple harmonics, and the rst order harmonic corresponds to a periodicity of roughly 5 unit cells along b. Interestingly, it appears that $B_{12}Sr_2CaCu_2O_{8+}$ crystals typically grow untwinned, likely a consequence of strains which would

develop between orthogonalm odulations. This is in contrast to other families of high tem perature superconductors which can be produced in an untwinned state, but only with considerable e ort in preparation.

II. MATERIALS AND EXPERIMENTAL METHODS

The $B_{12}Sr_2CaCu_2O_{8+}$ single crystal samples were grown by the travelling solvent oating zone techniques using a Crystal System's Inc. in age fumace. The growth was performed from premelted polycrystalline rods in 2 atmospheres of owing O_2 . The rods were counter-rotated at 30 pm and the growth speed was 0.2mm/hour. The resulting single crystals were carefully extracted from a large boule, and had approximate dimensions of 10 mm 5 mm 0.1 mm, where the thin dimension was parallel to the caxis. A lthough thin, the single crystals were of excellent quality with m osaic spreads less than 0.07 degrees, and a superconducting transition temperature, determ ined by SQUID m agnetom ery, of T_{\rm C} 92 K with a width of 2 K.

Two sets of x-ray scattering measurements were performed on these samples. Measurements were made using a Cu-rotating anode source and a triple axis spectrometer at M cM aster University. These measurements employed Cu-K radiation and utilized a pyrolitic graphite monochromator. The sample was mounted in a closed cycle refrigerator and placed in a four-circle goiniometer. Four sets of slits were employed to de ne the incident and scattered beam s.

A high resolution di raction setup at the Advanced Photon Source synchrotron radiation facility was used to study a subset of the modulations with greater precision. These measurements were performed on the 4-ID -D beam line at an x-ray energy of 16 keV. This beam line is equipped with a double-crystalSi(111) monochrom ator. A Pd-coated bent mirror was used to focus the beam to a spot size of 180 220 m at the sample. A at Pd mirror was used to further suppress higher order harmonics. The thin single crystal sample was placed in a closed cycle refridgerator. A Ge(111) analyser was used to reduce background and to improve resolution.

III. EXPERIMENTAL RESULTS

A. Three D im ensional M odulated Structure




FIG.2: Synchrotron X -ray scattering scans on a logarithm ic intensity scale along [0,K,0] (top panel) and [0,K,1] (lower panel) in Bi₂Sr₂C aC u₂O₈₊. A total of four harm onics of the modulated structure with the form (0, 4-n, L) are observed at both L=0 and L=1, and they clearly alternate between resolution-limited and broad along both K and L (see Fig. 3). The broad component to the scattering is well described by a Lorentzian-squared lineshape (see Fig. 4).

Synchrotron x-ray scattering scans of the form (0, K, 0)and (0, K, 1) are shown in Fig. 2. This data is plotted on a logarithm ic intensity scale, and was taken at T = 10 K, although no signi cant tem perature dependence was observed to this scattering to tem peratures as high as 300 K.A clear pattern of di raction peaks is observable at incommensurate wavevectors of the form (0, 4-n, L) for = 0.21, corresponding to a roughly 5 unit cellm odulation, and at all harm onics (n= 1,2,3,4) which we studied. Two distinct lineshapes are clearly present. One is very sharp, resolution limited, and these peaks alternate in harm onic for a particular L. This is to say that the even harm onic, n= 2 (K = 3.58), is clearly sharp in K for L= 0, while it is the odd harm onics, n= 1 (K = 3.79) and n= 3 (3.37), which are sharp for L= 1.




FIG. 3: Rotating anode x-ray scattering measurements on a logarithm ic intensity scale show the L-dependence of the principalB ragg peaks, such as [0,4,L] (top panel); the rst order harm onic of the modulated structure [0, 3.79, L] (middle panel); and the second order harm onic of the prim ary modulated structure [0, 3.58, L] (bottom panel). The harm onics alternate with L between resolution-limited B ragg scattering and broad scattering which is well described by a Lorentziansquared lineshape (see Fig. 4).

Figure 3 shows x-ray scattering data, plotted on a logarithm ic intensity axis, taken with the rotating anode source. This data exam ines the system atic L dependence of the scattering shown in Fig. 2. Once again this data is taken at 10 K and scans of the form (0, 4, L), (0, 3.79, L), and (0, 3.58, L) are shown in the top, m iddle and bottom panels of Fig. 3, respectively. Consistent with the data shown in Fig. 2, two sets of incommensurate di raction peaks are seen in the bottom two panels, which alternate with L, between a sharp, resolution-limited lineshape,

and a broad di raction feature.




FIG.4: X-ray scattering scans along K (top) and L (bottom) taken from Figs. 2 and 3 and plotted on a linear intensity scale. Both plots show the second order harmonics of the prim ary modulation [0, 3.58, 1] and [0, 3.58, 5]. These positions correspond to wavevectors with broad (as opposed to resolution-lim ited) lineshapes. A los shown is the t to each lineshape using a Lorentzian-squared form, Eq. 1, which is clearly excellent. As described in the text, this lineshape is typically used to describe the three dimensional random eld dom ain state in disordered magnets.

C learly, at alternate harm onics one observes a much broader lineshape. This is considered quantitatively in Fig. 4, where broad di raction features at (0, 3.58, 1) and (0, 3.58, 5) are plotted as a function of K and L on a linear intensity scale. This data was t to a Lorentzian-squared form along both b and c :

yielding correlation lengths of $_{\rm b} = \frac{1}{_{\rm b}}$ 185 A and $_{\rm c} = 20$ A.

Together these data illustrate two co-existing incom m ensurate structures one of which displays resolutionlim ited long range order in three dimensions, while the other displays three dimensional, albeit highly anisotropic, short range order. We interpret the anisotropic, short-range order di raction peaks as arising from stacking faults in the incom mensurate modulation.

For simplicity, we discuss this three dimensional scattering as if a single harm onic characterized the incom -

m ensurate structure. D om ains of well ordered m odulated regions give rise to the resolution limited peaks at say (0, 3.79, L) with L= odd. The L= odd requirement in plies a phase shift of of , 3 , 5 , between either CuO₂ bilayers (or equivalently BiO₂ bilayers) which are separated from each other by half a unit cellalong c (see Fig. 1). That is, the modulated structure within a particular bilayer is out of phase with that imm mediately above and below it.

In contrast the L-dependence of the broad di raction peaks, such as (0, 3.79, L) with L= even, in plies that this incom m ensurate m odulation is in phase with that in the bilayer im mediately above and below it. A lso, as the

correlation length along c is roughly a unit cell dimension, we have a very natural interpretation that these di raction features arise from the interface between two bulk domains, but which are out of phase with respect to each other. While the domain interfaces, attributed to the broad di raction peaks, are anisotropic with $_{\rm c}$ 20 A and $_{\rm a}$ 185 A, we classify all of the (0, 4 n , L) superlattice di raction peaks as being three dimensional in nature, as all of the superlattice peaks are localized around a particular point in reciprocal space, as opposed to being organized into rods or sheets of scattering, as is known to be relevant to two and one dimensional structures, respectively.

B. TwoDim ensionalM odulated Structure

X -ray scattering m easurem ents using the rotating anode source were also extended to look for additional




FIG. 5: X -ray scattering scans of the form [H, 3.58, 5] which show the new modulated structure corresponding to a doubling of the unit cell along a is shown. The dashed line in the upper panel shows where the scans reside in reciprocal space, passing through the second order harm onic of the primary modulation. The middle and lower panels show these scans on logarithm ic (middle) and linear (bottom) intensity scales, with Lorentzian lineshapes (Eq. 2) to the data. The bottom panel also dem onstrates the lack of tem perature dependence to this scattering below room tem perature.

charge modulation. Additional modulation, distinct from that at (0, 4-n , L) and discussed above, involving a doubling of the periodicity along a have recently been reported in Bi2 Sr2C aC u2O 8+ by M egtert and coworkers¹², and also by ourselves¹³. Scans performed along H, going through the second order harm onic of the three dimensional modulation, (0, 4-2, 0.21, 5), are shown in the bottom two panels of Fig. 5. The (0, 3.58, 5) second order harm onic of the three dim ensionalm odulation is easily observable at the 10 counts/second level. However, we also observe peaks at (1/2, 3.58, 5)at the 0.4 counts/second level on a 0.2 counts/second background. W hile weak, this H = 1/2 modulation is clearly resolved in the middle panel of Fig. 5. The




FIG. 6: X -ray scattering scans of the form [1/2, K, 5] which display the new modulated structure corresponding to a doubling of the unit cellalong a is shown. The upper panel show s where the scans reside in resiprocal space, passing through the rst four harm onics of this new modulated structure. The data in the bottom panel is t to Lorentzian lineshapes (Eq. 2) centered at each of the four harm onic positions along K. A lso shown for comparison in the same panel are K scans of the rst and second harm onics of the prim ary modulated structure, whose linewidth de nes the instrum ental resolution.

bottom panel of Fig. 5 shows three data sets at T = 10 K, 100 K, and 250 K, at the (-1/2, 3.58, 5) wavevector and demonstrates that, like the H = 0 modulations discussed above, the new H = 1/2 modulations have little or no temperature dependence to temperatures as high as room temperature. The peaks shown in Fig. 5 were t to a resolution-convoluted Lorentzian form :

and the (1/2, 3.58, 5) peaks were found to be characterized by a correlation length of $_a$ 27 A along a.

Figure 6 show sx-ray scattering scans of the form (1/2, K, 5) passing between K = 3 and 4, and showing (1/2, 4-n, 5) for = 0.21 and n = 1,2,3, and 4. The top panel of Fig. 6 locates these scans in reciprocal space as the dashed lines. A los shown in the bottom panel of Fig. 6, are scans of the form (0, K, 0) and (0, K, 1) taken under precisely the same experimental conditions as the (1/2, K, 5) scan. This data show sK scans through (0, 3.58, 0) and (0, 3.79, 1) which are both resolution-limited B ragg peaks (see Fig. 2). We therefore conclude that the peaks shown in the (1/2, K, 5) scans of Fig. 6 are not resolution limited. We can provide an excellent t to this data, shown as the solid line in Fig. 6, with a resolution-convoluted Lorentzian lineshape, Eq. 2. We




FIG.7: X -ray scattering scans of the form [1/2, K, L] which observe the new m odulated structure corresponding to a doubling of the unit cell along a are shown. The top panel shows s L-scans of the second order (K = 3.58) harm onic of this scattering, at di erent tem peratures below 250 K, as well as a background scan of the form [3, 3.45, L]. The lower panel shows the L dependence of each of the st four harm onics of this structure at 10 K. R em arkably over the 10 B rillouin zones from L=10 to L=-10, a near com plete rod of scattering is observed for the st order harm onic (K = 3.79), while higher order harm onics peak up weakly at L= 5.

then extract a relatively short correlation length along b for this H = 1/2 m odulation of $_{\rm b}$ 27 A, very sim ilar to the correlation length $_{\rm a}$, extracted from the (H, 3.58, 5) scans of Fig. 5.

Figure 7 shows L-scans of the form (1/2, 4-n, L)for n=2 in the top panel, that is (1/2, 3.58, L), and for n=1,2,3, and 4 in the bottom panel. A lso shown in the top panel is a background scan taken at (0.3, 3.45, L). Remarkably these scans, from L = -10 to 10, show almost no L-dependence at all; that is rods of scattering characteristic of two dimensional structures. The scattering is weakly peaked at L 5, but extends over all L values m easured. These scans were also carried out as a function of tem perature, and again, as seen in the top panel of Fig. 7, one sees little or no tem perature dependence to temperatures as high as room temperature. These results on the new (1/2, 4-n , L) modulations extend those reported earlier^{12,13} by explicitly determ ining L dependencies. W e also see that our results give approxim ately isotropic correlation lengths within the a-b plane a factor of two sm aller than those reported by M eqtert and collaborators¹². However, the Meqtert et al. work

does not discuss the form to which the scattering was t to extract their correlation length, and hence a quantitative com parison is not possible at present.

The extrem e extended nature of this scattering in L helps us understand why the scattering is so weak at any one position, and therefore why it is di cult to observe, and has escaped observation until recently. As the scattering is broad in both H and K (with correlation lengths $_{\rm ab}$ 27 A and rod-like in L, the integrated intensity of these H = 1/2 incom m ensurate m odulations is in fact quite appreciable. However the scattering is su ciently di use so a to make its peak intensity very weak, down by a factor of 10^6 com pared with principal B ragg peaks of the three dimenensional structure, such as (0, 4, 0).

IV. DISCUSSION AND RELATION TO STM IM AG ING

O ur results show three distinct sets of incommensurate m odulation in optim ally-doped B i_2 Sr₂C aC u_2O_{8+} , which co-exist at all temperatures below room temperature. Two of these are three dimensional in nature, with scattering centered on de nite B ragg points in reciprocal space. This scattering is peaked up at (H, 4-n , L) and alternates as a function of harm onic at a particular L, and as a function of L at a particular harm onic, between resolution-limited peaks and those characterized by nite and anisotropic correlation lengths in all three directions.

The broad, (H, 4-n, L), incommensurate peaks are extrem ely well described by a Lorentzian-squared lineshape (Fig. 4). This is an interesting result in itself, as a sum of Lorentzian plus Lorentzian-squared terms is typically used to model di use magnetic scattering in random eld Ising model (RFIM) magnets, which display random local symmetry breaking¹⁴. Three dimensional RFIM systems, such as $Co_x Zn_{1 x} F_2^{15}$ and $Fe_x Zn_{1 x} F_2^{16}$ in the presence of an applied magnetic eld, show magnetic di raction features with negligible Lorentzian weight, and thus their di use scattering is also very well described by a Lorentzian-squared form. Such a scattering form in plies a pair-correlation function in three dimensions which falls o with distance as exp(-r), and is characteristic of a domain wall state 14 . Our results for $_{ab}$ imply these domains are hundreds of angstrom s across, with dom ain walls which are a single unit cell in extent in the c direction. This small spatial extent, _c 20 A in the c direction is consistent with local stacking defects. As $B_{12}Sr_2CaCu_2O_{8+}$ is more generally the m = 2 m ember of the $B_{2}Sr_{2}Ca_{m-1}Cu_{m}O_{4+2m+}$ fam ily, the nature of the stacking fault is likely a missing Ca-layer. As such the dom ain wall itself is expected to locally be the m = 1member of the family: $B_{i_2}Sr_2CuO_{6+}$. This is a relatively low $T_{\rm C}$ superconductor ($T_{\rm C}$ $10\,K$) with a smaller c-axis, c= 24.6 A^{17} than $B\,i_2\,Sr_2C\,aC\,u_2O_{\,8+}$. Such a scenario has recently been proposed from high resolution electron m icroscopy m easurem entsperform ed on the sam e crystals as those studied here^{18}.

The most remarkable result we report is the con mation and characterization of the incommensurate modulation corresponding to a doubling of the periodicity along H and giving rise to rods of scattering of the form (1/2, 4-n, L) at all L. The scattering tends to be weakly peaked near L= 5. This indicates out-of-phase, or , correlations within a bilayer. As shown schem atically in Fig. 1, the CuO_2 and BiO_2 bilayer thicknesses are alm ost identical, at 3.3 A. Such correlations give rise to weak peaks at wavevectors of / (bi-layer thick- $/3.3 \text{ A} = 0.95 \text{ A}^{-1}$ L= 5 2 /c. As can be ness) seen in Fig. 7, this tendency for the two dimensional rods of scattering to peak up near L 5 seems to be strongest for the second and third order harm onics of this incommensurate structure (1/2, 3.58, L) and (1/2, 1.58, L)3.375, L), and is not seen at all for the 1st order harmonic (1/2, 3.79, L) which appears to be truly rod-like in nature.

Several interesting questions arise from the observation of this two dimensional incommensurate structure. First, from what does it arise? For example, is it a surface e ect, or can it arise from an intrinsically two dimensional charge inhom ogeniety which exists throughout the full volume of the crystal?

The scattering geometry employed in all of the measurements presented in this paper is transmission geometry, and hence it is very unlikely that the rod-like incommensurate scattering we observe in Figs. 5, 6, and 7 is due to surface structure of any kind, even though it is two dimensional in nature. We are then left with the intriguing conclusion that the scattering originates from the bulk of the crystal, but is nonetheless two dimensional in nature.




FIG.8: The correlation areas of the new modulated structure corresponding to a doubling of the unit cell along a extracted from our x-ray scattering analysis are superposed on STM topographs⁹ of the surface of B₁₂Sr₂C aC u₂O₈₊. Our measurements indicate isotropic short range correlations with a correlation length of 27 A, and these correspond very well to the extent of the \S" microstructure which appears to be imprinted on the primary modulated structure of B₁₂Sr₂C aC u₂O₈₊, as observed in real space with the STM measurements.

A second question which arises is, given that the $B_{2}Sr_{2}CaCu_{2}O_{8+}$ fam ily of superconductors have been studied for more than 15 years, has this type of structure been observed in previous experim ents? W e believe the answer to this question is yes, and reconsider STM im ages of the surface structure of B i2 Sr2 C aC u2 O 8+ discussed several years ago by Pan and co-workers⁹. Figure 8 shows an STM im age of the [001] cleaved surface of near-optim ally doped $B_{1/2}Sr_2CaCu_2O_{8+}$ from Pan et al². The well known (0, 0.21, L) modulation is seen as the periodic lighter stripes which run along the verticaldirection in the STM im age and which have an approxim ate periodicity of 5 unit cells dim ensions along b. However, superposed on the light stripes is an \S-like" dark modulation, which has a periodicity of 2 unit cells along the stripe; that is along the a-direction. This additionalm odulation in the structure appears superposed on every light stripe within the eld of view. As such one expects its manifestation in reciprocal space to appear at wavevectors of the form (1/2, 0.21, L), exactly where we observe the two dimensional rods of scattering.

Further, careful exam ination of the STM im age shows that the S-modulation along a is not a perfect pattem, but is characterized by phase slips both along a and between S-modulations imposed on adjacent light stripes. Consequently, such substructure would not give rise to resolution-lim ited B ragg peaks, but rather to diffuse peaks characterized by relatively short correlation lengths. Again, this is fully consistent with the two dim ensional rods of scattering which we have observed at (1/2, 4-n , L), wherein the correlation length measured in the ab-plane was found to be approximately isotropic, ab 27 A. We have superposed correlationareas within the ab plane using the correlation lengths extracted from our x-ray scattering m easurem ents, onto the STM images⁹ of the structure of the cleaved [001] plane of optim ally-doped $B_{i_2}Sr_2CaCu_2O_{8+}$, and the agreem ent between the two is rem arkably good. The Smodulation within the STM image was not commented on by Pan et al⁹. How ever, as STM is a very surface sensitive probe, it provides little inform ation as to the behaviour of this substructure into the bulk of them aterial.

It would therefore be possible to associate such structure in an STM experiment with a surface elect. However, we reiterate that our x-ray scattering measurements, performed in transmission geometry, are very insensitive to the surface. We conclude that the two dimensional modulated structure we observe in x-ray scattering is the same as the electronic inhom ogneiety observed with STM, and that it originates from charge inhom ogeniety within the bulk of the Bi2Sr₂CaCu₂O₈₊ superconductor.

F inally, one can ask how general is the phenom enon of charge inhom ogeniety in di erent fam ilies of high tem – perature superconductors? Of course, electronic phase separation is im plied within a variety of models for high tem perature superconductivity, most prominently those involving \stripes"¹⁹. However, is there related di use scattering evidence in other high tem perature superconductors?

The answer again appears to be yes, with the recent reports of a four unit cell superstructure with correlation lengths of 20 A within the ab plane and very short range correlations along c in optim ally doped $YBa_2Cu_3O_7$ ²⁰, and related superstructure in underdoped YBa₂Cu₃O₇ 21 . In these cases, the short range ordered superstructure is periodic along the shorter Cu-Cu bond, whereas the two unit cell superstructure we report here for $B_{12}Sr_2CaCu_2O_{8+}$ is periodic along a diagonal of the CuO_2 basal plane cell, and thus at 45 degrees to either Cu-Cu bond. This difference, however, may simply be a consequence of the electronic inhom ogeniety following the appropriate tem plate for $B_{i_2}Sr_2CaCu_2O_{8+}$ or $YBa_2Cu_3O_7$. That tem plate would be set by the three dim ensional modulation in $B_{1_2}Sr_2CaCu_2O_{8+}$ and by the short range oxygen-vacancy ordered superstructures in the case of $YBa_2Cu_3O_7$ ²¹, which are present throughout the superconducting region of its phase diagram²². It may therefore be the case that such quasi-two dimensional, short range charge inhom ogeneity is a general property of cuprate high tem perature superconductors.

V. CONCLUSIONS

We report the observations of three sets of incom – m ensurate m odulation to the structure of the high tem – perature superconductor $Bi_2Sr_2CaCu_2O_{8+}$. Two of these are the well known m odulation characterized by wavevectors (0, 4-n , L). These Bragg features alternate in both harm onic, n, for the sam e L, and in L for the sam e harm onic, between resolution-lim ited B ragg peaks and di use scattering lineshapes which are very well described by a Lorentzian-squared pro le. We also con m and extend the characterization of the recently discovered (1/2, 4-n , L) m odulations. These charge correlations are quasi-two dimensional. ter of this scattering along c is weakly peaked at L= 5, and this scattering is characterized by nite and relatively short correlation lengths of 27 A within the ab plane. We contend that the charge inhom ogeniety underlying this di use scattering is that previously observed in STM measurements⁹. These new x-ray scattering measurements, in transmission geometry, establish that this charge inhom ogeniety is a bulk property of the system, and is not due to any reconstruction or related surface e ect. We have also thoroughly investigated any possible temperature dependence to all three of these structural modulations below room temperature and nd no such e ect.
