Response of thin-lm SQUIDs to applied elds and vortex elds: Linear SQUIDs

In this paper we analyze the properties of a dc SQUID when the London penetration depth is larger than the superconducting Im thickness d. We present equations that govern the static behavior for arbitrary values of $= 2^{-2}$ relative to the linear dimensions of the SQUID. The SQUID's critical current I_c depends upon the elective ux, the magnetic ux through a contour surrounding the central hole plus a term proportional to the line integral of the current density around this contour. While it is well known that the SQUID inductance depends upon , we show here that the focusing of magnetic ux from applied elds and vortex-generated elds into the central hole of the SQUID also depends upon . We apply this form alism to the simplest case of a linear SQUID of width 2w, consisting of a coplanar pair of long superconducting strips of separation 2a, connected by two sm all Josephson junctions to a superconducting current-input lead at one end and by a superconducting coplanar stripline. We calculate magnetic – eld and current-density pro les, the inductance (including both geom etric and kinetic inductances), magnetic moments, and the e ective area as a function of =w and a=w.

I. IN TRODUCTION

The research in this paper has been motivated by several in portant recent developments in superconductivity: (a) the fabrication of thin- In SQUIDs (superconducting quantum interference devices) made of high- T_c superconductors,¹ (b) the study of noise generated by vortices in active and passive superconducting devices,^{1,2,3,4,5,6,7,8,9,10} and (c) line-width reduction in superconducting devices to eliminate noise due to vortices trapped during cooldown in the earth's magnetic eld.^{11,12,13,14,15,16}

The fact that the London penetration depth in– creases as T increases and diverges at Tc is an important consideration for high-T_c SQUIDs operated at liquidnitrogen tem perature. W hen is larger than the lm thickness d, the physical length that enters the equations governing the spatial variation of currents and elds is the Pearl length¹⁷ = 2 =d. A coordingly, the equations governing the behavior of active or passive thin- Im superconducting devices depend upon the ratio of to the linear dimensions of the device. In particular, the equations governing SQUDs involve not just the magnetic ux up through a contour within the SQUD, but the effective ux, which is the sum of the magnetic ux and a term proportional to the line integral of the current density around the same contour. W hile the e ective is similar to London's uxoid, 18 which is quanııx tized in multiples of the superconducting ux quantum $_0$ = h=2e, we show in the next section that is not quantized. W e also give in Sec. II the basic equations, valid for any value of , that govern the behavior of a dc SQUD.

A vortex trapped in the body of the SQUD during cooldown through the superconducting transition tem perature T_c in an am bient m agnetic eld generates a m agnetic eld and a screening current that together make a sizable vortex-position-dependent contribution v to the e ective ux . If such a vortex remains xed in position and the tem perature rem ains constant, this sim ply produces a harm less bias in . On the other hand, both vortex m otion due to therm alagitation and tem perature uctuations generate corresponding uctuations in $_{v}$ and noise in the SQUID output. In Sec. II we show that to calculate v, it is not necessary to calculate the spatial dependence of the vortex-generated elds and currents. Instead, one may determ ine v with the help of the sheet-current distribution of a circulating current in the absence of the vortex.

In Sec. III we apply the basic equations of Sec. II to calculate the properties of a model linear SQUD, which has the basic topology of a SQUD but is greatly stretched along one axis, such that the central portion resembles a coplanar stripline. The advantage of using such a model is that simple analytical results can be derived that closely approximate the exact num erically calculated quantities in the appropriate limits. In addition to calculating the eld and current distributions for several values of , we calculate the total inductance, geom etric inductance, kinetic inductance, and m agnetic moment when the SQUID carries a circulating current. W e calculate the eld and current distributions, m agnetic m om ent, and e ective area $A_e = f^{B_a}$ when a perpendicularm agnetic induction B_a is applied and the e ective ux f is focused into the SQUD. Finally, we calculate the eld and current distributions and the magnetic moment for the zero-uxoid state when the junctions are

short-circuited and the sample remains in the state with

= 0 when a perpendicular magnetic induction B $_{\rm a}$ is applied.

In Sec. IV, we present a brief sum m ary of our results.

II. BASIC EQUATIONS




FIG.1: I enters the main body of the SQUID from the counterelectrode below through two Josephson junctions (sm all black squares, labeled a and b) and divides into the currents $I_1 = I = 2$ I_1 and $I_2 = I = 2 + I_d$ as shown.

Our purpose in this section is to derive general equations that govern the behavior of a dc SQ U ID consisting of thin superconducting Im s of thickness d less than the weak-eld London penetration depth , such that the elds and currents are governed by the two-dim ensional screening length or Pearl length¹⁷ = 2 =d. W e calculate both the current $I = I_1 + I_2$ through the SQU \mathbb{D} [see Fig.1] and the circulating current¹⁹ $I_d = (I_2 I_1)=2$ and describe how to calculate the critical current I_c of the SQUD for arbitrary values of the SQUD's inductance L. For this case, the contributions from line integrals of the current density to the e ective ux in the hole cannot be neglected, and the kinetic inductance makes a signi cant contribution to L.W hen a perpendicular magnetic induction B_a is applied, we calculate how much m agnetic ux is focused into the SQUD's hole; this ux also can be expressed in terms of the e ective area²⁰ of the hole. We also show how to calculate how much magnetic ux generated by a vortex in the main body of the SQUD is focused into the hole.

Consider a dc SQUD in the xy plane, as sketched in Fig. 1. We suppose that the SQUID is symmetric about the y axis, which lies along the centerline. The maximum Josephson critical current is I₀ for each of the Josephson junctions, shown as small black squares. The currents up through the left and right sides of the SQU D can be written as $I_1 = I=2$ I_d and $I_2 = I=2 + I_d$. W hen the magnitude of I, the total current through the $SQ \cup \mathbb{D}$, is less than the critical current I_c , the equations that determ ine I = $I_1 + I_2$ and the circulating current $I_d = (I_2)$ 1)=2 can be derived using a method similar to that used in Ref. 21. We begin by writing the local current density j in the superconductors (i.e., the main body of the SQUD and the counterelectrode) as^{18}

where A is the vector potential, $_0 = h=2e$ is the superconducting ux quantum, and is the phase of the order parameter. The quantity inside the brackets, which is gauge-invariant, can be thought of as the super uid velocity expressed in units of vector potential. From the point of view of the G inzburg-Landau theory, in plicit in the use of this London-equation approach is the assum ption that the applied elds and currents are so low that the m agnitude of the order parameter is not signi cantly reduced from its equilibrium value in the absence of elds and currents.

To obtain the SQUID equations, we integrate the vector potential around a contour C that passes in a counterclockw ise direction through both junctions, the main

body of the SQUID, and the counterelectrode as shown in Fig.1 and write the result in two ways. Since B = r = A, this integral yields, on the one hand, the magnetic ux in the z direction

where S is the area surrounded by the contour C and $B_z(x;y)$ is the z component of the net magnetic induction in the plane of the SQUID produced by the sum of a perpendicular applied eld B_a and the self-eld $B_{sz}(x;y)$ generated via the B iot-Savart law by the supercurrent density j(x;y). On the other hand, for those portions of the contour lying in the superconductors, we eliminate the line integrals of A in favor of line integrals of j using Eq. (1). We then express the line integrals of r in terms of the values of at the junctions. Equating the two expressions for the line integral of A, we nd that the elective ux in the z direction through the SQUID is given by

with the integration contour C now passing through both superconductors but excluding the junction barriers. These equations are equivalent to Eq. (8.67) in

R ef. 21. The gauge-invariant phase di erences across the junctions b and a are, respectively,²²

where bc labels a point on the counterelectrode side of the junction b and bs labels the point directly across the insulator in the SQUID washer, and ac and as label corresponding points for junction a. A coording to the Josephson equations,²² the junction supercurrents are $I_1 = I_0 \sin_1$ and $I_2 = I_0 \sin_2$. In the above derivation we have assumed that the linear dimensions of the Josephson junctions are much less than the Josephson penetration depth $_J$,²² and that the applied elds are su ciently small that the Josephson current densities and gauge-invariant phase di erences are very nearly constant across the junction areas.

The magnetic moment m = m 2 generated by the currents in the SQUID is 23

It can be shown with the help of the London uxoid quantization condition, 18

where n is an integer and C⁰ is a closed contour that surrounds an area S⁰ within the body of the SQUID, that if there are no vortices present (i.e., when n = 0), the expression for in Eq. (4) is independent of the choice of contour C. Any convenient path can be chosen for C, provided only that the path remains in the superconducting material in the body of the SQUID and the counterelectrode. On the other hand, when there are vortices in the main body of the SQUID, the quantity

increases by $_0$ each time the contour C is moved from a path inside the vortex axis to one enclosing the vortex axis. Thus, without specifying the precise contour C, is determined only modulo $_0$. However, this is of no physical consequence, because the gauge-invariant phases $_1$ and $_2$, which also enter Eq. (3), are also determined only modulo 2. The nalequations determining the currents I and I_d are independent of the choice of contour C and remain valid even when vortices are present in the main body of the SQUID .

W hen the thickness d of the SQUID is much larger than , the contours C and C⁰ can be chosen to be at the m idpoint of the thickness, where j is exponentially sm all, such that the line integrals of j can be neglected. The resulting equations are then the fam iliar ones found in m any reference books, such as Refs. 21,24,25,26,27,28,29. However, we are interested here in the case for which d <, such that the elds and currents are governed by

the two-dimensional screening length or Pearl length¹⁷ = 2 =d. The term in Eq. (4) involving j then must be carefully accounted for. For this case, j is very nearly constant over the thickness and it is more convenient to deal with the sheet-current density J (x;y) = jd, such that Eqs. (4) and (8) take the form ³⁰

For the general case when the SQUID is subject to a perpendicular applied magnetic induction B_a, carries a current I unequally divided between the two arm s, I₁ = I=2 I₁ and I₂ = I=2+ I_d, where the circulating current¹⁹ is I_d = (I₂ I₁)=2, and contains a vortex at the position r_v in the body of the SQUID, the elective ux in the z direction can be written as the sum of four independent contributions:

The rst term on the right-hand side of Eq. (11) is that which would be produced by equal currents I=2 in the y direction on the left and right sides of the SQUID shown in Fig. 1:

where $B_{T}(x;y)$ is the z component of the self-eld generated via the B iot-Savart law by the sheet-current density $J_{I}(x;y)$, subject to the condition that the same current I=2 ows through the two contacts a and b. For a symmetric SQUD, $J_{I}(x;y)$, the y component of $J_{I}(x;y)$, is then an even function of x, and $J_{I}(x;y)$ and $B_{I}(x;y)$ are odd functions of x. As a result, both term s on the righthand side of Eq. (12) vanish by symmetry, and I = 0. Sincer J = 0 except at the contacts a and b, we may write $J_T = (I=2)r$ G_{I} , where $G_{I} = 2G_{I}$; such that $J_{I}(x;y) = (I=2)\hat{z}$ r $G_{I}(x;y)$. The contours of the scalar stream function $G_{I}(x;y) = \text{const correspond to stream}$ lines of $J_{I}(x;y)$, and we may choose $G_{I} = 0$ for points $r_i = (x_i; y_i)$ all along the inner edges of the superconductors and $G_{I} = 1$ for points $r_{o} = (x_{o}; y_{o})$ all along the outer right edges and $G_{I} = 1$ for points $r_{o} = (x_{o}; y_{o})$ all along the outer left edges.

The second term on the right-hand side of Eq. (11) is due to the circulating current¹⁹ $I_d = (I_2 \quad I_1)=2$ in the counterclockw ise direction when unequal currents ow in the two sides of the SQUID shown in Fig.1:

where $B_d(x;y)$ is the z component of the self-eld generated via the B iot-Savart law by the circulating sheetcurrent density $J_d(x;y)$ when a current I_d ow s through

contact a from the counterelectrode into the body of the SQUID, passes around the central hole, and ows through contact b back into the counterelectrode. The m agnetic m om ent m d generated by the circulating current is proportional to I_d , as can be seen from Eq. (7). Since r $J^{=} 0$ except at the contacts a and b, we may write $J_d = I_d r = G_d$, where $G_d = 2G_d$, such that $J_d(x;y) = I_d \hat{z}$ r $G_d(x;y)$. The contours of the scalar stream function $G_d(x;y) = const correspond to stream$ lines of $J_d(x;y)$, and we may choose $G_d = 0$ for points $r_i = (x_i; y_i)$ all along the inner edges of the superconductors and $G_d = 1$ for points $r_o = (x_o; y_o)$ all along the outer edges. Once a num erical result for d is found, the result can be used to determ ine the inductance L of the SQUID via $L = d = I_d$, as was done for a circular ring in Ref. 31. The resulting expression for L is the sum of the geom etric and kinetic inductances.

The third term on the right-hand side is a ux-focusing term due to the applied eld:

where B_f(x;y) is the z component of the net m agnetic induction in the plane of the SQUD produced by the sum of a perpendicular applied eld B_a and the z component of the self-eld $B_{sf}(x;y)$ generated via the Biot-Savart law by the sheet-current density Jf(x;y) induced in response to B_a, subject to the condition that no current ow s through the junctions a and b. In other words, the desired elds are those that would appear in response to B_a if the junctions a and bwere open-circuited. Since $_{f}J=0$, we may write $J_{f}=r$ G_{f} , where $G_{f}=2G_{f}$, r such that $J_f(x;y) = \hat{z}$ r $G_f(x;y)$. The contours of the scalar stream function $G_f(x;y) = \text{const correspond to}$ stream lines of $J_f(x;y)$, and we may chose $G_f = 0$ for all points (x;y) along the inner and outer edges of the superconductor. Once a num erical result for f is found, the result can be used to determ ine the e ective area²⁰ of the SQU \mathbb{D} 's central hole, $A_e = f^{=B_a}$, as was done for a circular ring in Ref. 31.

To prove that the e ective area is also given by A $_{\rm e}~$ = $m_d = I_d$,³² we_R consider the electrom agnetic energy cross term $E_{fd} = (B_f \quad B_{fd} = 0 + 0^2 j_f \quad d) d^3r$, where the integral extends over all space. Here, $B_f(r) = B_a(r) +$ $B_{sf}(r) = r$ $A_{f}(r);$ where $j_{a}(r) = r$ $B_a(r) = 0$ is the current density in the distant coil that produces a nearly uniform eld B $_a$ in the vicinity of the SQUID, $B_{sf}=_0$ is the induced current density in the j_f = r ${\rm SQ} ~{\rm U} ~{\rm I\!D}$, and B $_{\rm sf}$ is the corresponding self- eld under the conditions of ux focusing, i.e., when $j_f = 0$ through the junctions. A lso, $B_d = r$ A_d is the dipole-like eld distribution generated by the circulating current I_d with density j_d in the SQUID; at large distances from the SQU $\mathbb{D}^{23} A_d = _0 m_d$ r=4 r³. We evaluate E_{fd} in two ways, making use of the vector identities r (A B)= В (rA)A (rB) and r and applying the divergence theorem , rst with $A = A_d$, $B = B_{f}$, = d, and $j = j_{f}$, from which we obtain

 $E_{fd} = B_a m_d$, and then with $A = A_f$, $B = B_d$, = f, and $j = j_d$, from which we obtain $E_{fd} = fI_d$ with the help of Eq. (3). Since $f = B_a A_e$, the elective area obeys $A_e = m_d = I_d$.

The fourth term on the right-hand side of Eq. (11) is due to a vortex at position $r_v = \hat{x}x_v + \hat{y}y_v$ in the body of the SQUID:

where $B_v(x;y)$ is the z component of the self-eld generated by the vortex's sheet-current density $J_v(x;y)$ via the Biot-Savart law when no current ows through the junctions a and b. The desired elds are those that would appear in response to the vortex if the junctions a and b were open-circuited. Since $r = \sqrt{J} = 0$, it is possible to express $J_v(x;y)$ in terms of a scalar stream function, as we did for $J_f(x;y)$ and $J_d(x;y)$. However, as shown below, it is possible to use energy arguments to express v(x;y) in terms of the stream function $G_d(x;y)$.³³

To obtain $v_v(\mathbf{r})$ when a vortex is at the position $r = \hat{x}x + \hat{y}y$, in agine disconnecting the counterelectrode in Fig. 1 and attaching leads from a power supply to the contacts a and b. The power supply provides a constant current Id in the counterclockwise direction, and the sheet-current distribution through the body of the SQUD is given by $J_d(x;y) = I_d \hat{z}$ r $G_d(x;y)$, as discussed above. We also imagine attaching leads from a high-im pedance voltmeter to the contacts ${\tt a}$ and ${\tt b}.$ If the vortex moves, the elective ux v changes with time, and the voltage read by the voltmeter will be³⁴ $V_{ab} = d_v = dt$. The power delivered by the power supply can be expressed in terms of the Lorentz force on the vortex, J_d $\hat{Z}_0 = I_d \circ r G_d$; i.e., the rate at which work is done on the moving vortex is $I_d \circ r G_d$ dr=dt. Equating this to the power P = $I_d d_v = dt = I_d r_v$ dr=dt delivered by the power supply to maintain constant current, we obtain the equation $r_v(r) = _0 r G_d(r)$. Thus $v_{\rm v}({\rm r}) = {}_0 {\rm G}_{\rm d}({\rm r}) + {\rm const}$, where the constant can have one of two possible values depending upon whether the integration contour C is chosen to run inside or outside the vortex axis at r = x + y. Choosing C to run around the outer boundary of the SQUD, we obtain

Since $G_d(\mathbf{r}_o) = 1$ for points $\mathbf{r} = \mathbf{r}_o$ on the outer edges of the SQUID and $G_d(\mathbf{r}_i) = 0$ for points $\mathbf{r} = \mathbf{r}_i$ on the inner edges (at the perimeter of the central hole or along the edges of the slit), we have $v_v(\mathbf{r}_o) = 0$ and $v_v(\mathbf{r}_i) = 0$. The derivation of Eq. (16) im plicitly assumes that the vortex-core radius is much smaller than the linear dimensions of the SQUID.

valuate E_{fi} in two We now return to the problem of how to nd the curies r (A B) = rents I and I_d in the SQUD, as well as the critical (j) = r j + r current I_c . As discussed above, we have I = 0 for a rst with $A = A_d$, symmetric SQUD. For simplicity, we assume rst that which we obtain there are no vortices in the body of the SQUD, such that




FIG.2: $I_c=2I_0$ vs f=0, calculated from Eqs. (17) and (18), for $LI_0=0=0, 1, 2, 3, 4$, and 5 (bottom to top).

v = 0 and = f + d in Eq. (3), where $d = L I_d$. From the sum and the di erence of I_1 and I_2 we obtain

where = $(_1 + _2)=2$ is determ ined experimentally by how much current is applied to the SQUID. When = 0, the current I is zero. As increases, the magnitude of I increases and reaches its maximum value I_c at a value of that must be determined by numerically solving Eqs. (17) and (18). A simple solution is obtained for arbitrary f only in the limit $LI_0 = _0 ! 0$, for which $I = I_c = 2I_0 j cos(_f = _0) j and I_d = 0$ at the critical current. For values of $LI_0 = _0$ of order unity, as is the case for practical SQUID s, one may obtain I_c for any value of

 $_{\rm f}$ by solving Eq. (18) self-consistently for $\rm I_d$ for a series of values of and by substituting the results into Eq. (17) to determ ine which value of maxim izes I. Equations (17) and (18) have been solved num erically by de B ruyn O uboter and de W aele,²⁴ (som e of their results are also shown by O rlando and D elin²¹), who showed that at $\rm I_c$

where n is an integer. Hence all the physics is revealed by displaying $I_c(f)$ over the interval 0 $f_0=2$, as shown in Fig.2.

W hen a vortex is present, Eqs. (17) and (18) stillhold, except that $_{\rm f}$ in these equations is replaced by the sum $_{\rm f}$ + $_{\rm v}$. Thermally agitated motion of vortices in the body of the SQUID can produce ux noise via the term $_{\rm v}$ ($r_{\rm v}$) and the time dependence of the vortex position




FIG.3: Sketch of central portion of the long SQUID considered in Sec.III.

 r_v : From Eq. (16) we see that the sensitivity of I_c to vortex-position noise is proportional to the magnitude of $r_v(r) = {}_0 r G_d = J_d \quad 2 {}_0=I_d$: Thus I_c is most sensitive to vortex-position noise when the vortices are close to the inner or outer edges of the SQUID, where the magnitude of J_d is largest. These equations provide m ore accurate results for the vortex-position sensitivity than the approximations given in Refs. 2 and 35.

So far, we have investigated how the general equations governing the behavior of a dc SQUID are altered when the contributions arising from line integrals of the current density are included. As we have shown in Ref. 31, these additional contributions are important when the Pearl length is an appreciable fraction of the linear dim ensions of the SQUD.We have found that the basic SQUD equations, Eqs. (17) and (18), are unaltered, except that the magnetic ux (sometimes called ext^{21}) generated in the SQUID's central hole by the externally applied eld in the absence of a vortex is replaced by the e ective ux f, given in Eq. (14). Sim ilarly, we have shown that the total inductance L of the SQUID has contributions both from them agnetic induction (geom etric inductance) and the associated supercurrent (kinetic inductance). We also have shown in principle how to calculate the e ect of the return ux from a vortex at position r_v in the body of the SQU \mathbb{D} , and we have found that the elective ux arising from the vortex is $v_{\rm v}(r_{\rm v})$, given in Eqs. (15) and (16). To dem onstrate that all the above quantities can be calculated num erically for arbitrary values of , we next exam ine the behavior of a model SQUD as decribed in Sec. III.

III. LONG SQUID IN A PERPENDICULAR MAGNETIC FIELD

Here we consider a long SQUID whose thickness d is less than the London penetration depth and whose topology is like that of Fig. 1 but which is stretched to a large length 1 in the y direction, as sketched in Fig. 3. SQUIDs of similar geometry have been investigated experimentally in Refs. 14,36,37,38,39. We treat here the case for which the length 1 is much larger than the width 2w of the body of the SQUID, and we focus on the current and eld distributions in and near the left (w < x < a) and right (a < x < w) arm s and near the center of the SQUID, where to a good approximation the current density j_y is uniform across the thickness and depends only upon x, and the magnetic induction B = r A depends only upon x and z. In the equations that follow, we deal with the sheet-current density, whose component in the y direction is $J_y(x) = j_y(x)d$.

The self-eld magnetic induction generated by $J_y(x)$ is $B_J(x;z) = r \quad A_J(x;z)$, where $A_J(x;z)$, the y component of the vector potential obtained from Ampere's law, is

A. Form al solutions

W e now use the approach of R ef. 40 to calculate the inplane m agnetic-induction and sheet-current distributions appearing in Eqs. (11)-(14) in Sec. II. For all of these contributions we shall take into account the in-plane (z = 0) self- eld contribution A_J (x) = A_J (x;0) to the y com ponent of the vector potential, where

W e next exam ine the circulating-current case and consider the contributions $B_d(x)$, the z component of $B_d(x)$, and $J_d(x)$, the y component of $J_d(x)$, due to a circulating current I_d ; the current in the y direction on the right side of the SQUID is $I_2 = I_d$ and that on the left side I. The vector potential is still given by Eq. is $I_1 =$ (24), except that we add subscripts d. However, since $J_d(x) =$ J(x), the vector potential is now an antisymmetric function of x; A_d (x) = A_d (x). The circulating current is generated by the uxoid d [see Eq. (13)] associated with a nonvanishing gradient of the phase around the loop. The second term inside the bracket on the right-hand side of Eq. at the ends (U-turn) give exactly the same contribution to m_d, even in the limit 1! 1 . To next higher order in w=lone has to replace lin Eq. (39) by 1 (w a)q, where (w a)q=2 is the distance of the center of gravity of the x-com ponent of the currents near each end from this end. For a single strip of width w a, one has, e.g., q = 1=3 for the Bean critical state (with rectangular current stream lines) and q = 0.47 for ideal screening (w).⁴²

We next examine ux focusing. As discussed in Sec. II, to calculate the e ective area of the slot, we need to calculate the elds produced in response to a perpendicular applied m agnetic induction B_a, subject to the condition that no current ows through either junction. Since this is equivalent to having both junctions open-circuited, the problem reduces to nding the elds produced in the vicinity of a pair of long superconducting strips connected by a superconducting link at only one end, i.e., when the slot of width 2a between the two strips is open at one end. However, the desired elds may be regarded as the superposition of the solutions of two separate problems when the slot has closed ends: (a) the elds generated in response to B_a , when = 0 (the zero-uxoid case) and a clockwise screening current ows around the slot [second term on the right-hand side of Eq. (41) below], and (b) the elds generated in the absence of B_a, when ux quanta in the amount of f_{f} are in the slot and a counterclockwise screening current ows around the slot [rst term on the right-hand side of Eq. (41)]. The desired ux-focusing solution is obtained by setting the net circulating current equal to zero.

The equations describing the elds in the ux-focusing case are derived as follows. The z component of the net magnetic induction $B_f(x)$ is the sum of B_a and the self-eld $B_{sf}(x)$ generated by $J_{f}(x)$. The vector potential $A_v(x)$ is the sum of $B_a x$, which describes the applied magnetic induction, and the self-eld contribution given by Eq. (24) but with subscripts f. Since $J_f(x) =$ $\mathcal{J}(\mathbf{x})$, the vector potential is again an antisymmetric function of x; $A_f(x) = A_f(x)$. The uxoid f [see Eq. (14)] contributes a nonvanishing gradient of the phase around the loop, such that the second term inside the brackets on the right-hand side of Eq. In the next section we also present numerical results for eld and current distributions in the zero- uxoid case, in which I = 0, v = 0, and the elective ux is zero: $= _{d} + _{f} = 0$. Such a case could be achieved by shortcircuiting the Josephson junctions in Fig. 1, cooling the device in zero eld such that initially = 0, and then applying a small perpendicular magnetic induction B_{a} . A circulating current J (x), given by the second term on the right-hand side of Eq. (41), would spontaneously arise in order to keep = 0; as in the M eissner state.

B. Num erical solutions

In the previous section we have presented form al solutions for the sheet-current density $J_v(x)$ in Eqs. (29), (33), and (41), which are expressed as integrals involving the geometry-dependent inverse kernels $K^{sy}(x;x^0)$ and $K^{as}(x;x^0)$. As in Ref. 31 for thin rings, these integrals are evaluated on a grid x_i (i = 1;2;:::;N) spanning only the strip (but avoiding the edges, where the integrand may have in nities), $a < jx_i j < w$, such that for any function f(x) one has $a = f(x) dx = P^{N} \sum_{i=1}^{N} w_i f(x_i)$. Here w_i are the weights, approxim ately equal to the local spacing of the x_i ; the weights obey $\sum_{i=1}^{P} w_i = w$ a.W e have chosen the grid such that the weights ${\tt w}_{\,i}$ are narrower and the grid points $x_{\rm i}\,\text{m}$ ore closely spaced near the edges a and w , where $J_{y}(x)$ varies m ore rapidly. We have accomplished this by choosing some appropriate continuous function x (u) and an auxiliary discrete variable $u_i / i = \frac{1}{2}$, such that $w_i = x^0 (u_i) (u_2 - u_i)$. We can choose x (u) such that its derivative x⁰(u) vanishes (or is reduced) at the strip edges to give a denser grid there. By choosing an appropriate substitution function x (u) one can make the num erical error of this integration m ethod arbitrarily sm all,




FIG.4: Pro les of the sheet current $J_1(x)$, Eq. (49), stream function $G_1(x)$, Eq. (50), and m agnetic induction $B_1(x)$ for the equal-current case ($B_a = 0$, $I_1 = I_2 = I=2 > 0$). Show n are the examples a=w = 0.3 with =w = 0 (solid lines with dots), 0.03 (dot-dashed lines), 0.1 (dashed lines), 0.3 (dotted lines), 0.1 (solid lines), 0.3 (dotted lines), and 1 (solid lines). Here $B = _0$ and J are in units $I_2=w$ and G in units I_2 .




FIG. 5: Magnetic eld lines in the equal-current case for a=w = 0.1 and =w = 0, 0.01, 0.1, and 50 (or 1).

Shown in Fig. 4 are plots of $J_{I}(x)$, $G_{I}(x)$, and the corresponding magnetic induction $B_{I}(x)$ vs x for a=w = 0.3 and various values of =w = 0, 0.03, 0.1, 0.3, 1. The curves for = 0 exactly coincide with the analytic expressions of Appendix A. The magnetic eld lines for this case are depicted in Fig. 5.




FIG.6: Pro les of $J_d(x)$, Eq. (54), $G_d(x)$, Eq. (57), and m agnetic induction $B_d(x)$ for the circulating-current case ($B_a = 0$, $I_i = I_2 > 0$). Shown are the examples a=w = 0.3 with =w = 0 (solid lines with dots), 0.03 (dot-dashed lines), 0.1 (dashed lines), 0.3 (dotted lines), and 1 (solid lines). $B = _0$ and J are in units $I_2=w$ and G in units I_2 .




FIG.7: M agnetic eld lines in the circulating-current case for a=w = 0.1 and =w = 0, 0.01, 0.1, and 50 (or 1).

Shown in Fig. 6 are plots of $J_d(x)$, $G_d(x)$, and $B_d(x)$ vs x for a=w = 0:3 and various values of =w. Note that these curves look sim ilar to those in Fig. 4, but they all have opposite parity, as can be seen from the di erent pro les B (x) near x = 0. The magnetic eld lines for this case are shown in Fig. 7.

As discussed in Sec. II, when a vortex is present in the region a < jxj < w, the sensitivity of the SQUID's critical current I_c is proportional to the magnitude of d $_v=dx = _0 dG_d=dx = _0 J_d(x)=I_d$. From Fig. 6 we see that when w, this sensitivity is greatly enhanced when the vortex is close to the edges a and w but that when w, the sensitivity is nearly independent of position.




FIG. 8: (a) Solid curves show the inductance $L = L_m + L_k$ [Eq. (55)] vs a=w calculated for =w = 0, 0.03, 0.1, 0.3, and 1. See the text for descriptions of analytic approximations shown by the open circles, open squares, dots, and dashes. (b) Solid curves show the geom etric inductance L_m [Eq. (58)] vs a=w for =w = 0, 0.1, and 1 and the kinetic inductance L_k [Eq. (59)] vs a=w for =w = 0.03, 0.1, 0.3, and 1. See the text for descriptions of analytic approximations shown by the dotted and dashed curves.




FIG.9: (a) Solid curves show the inductance $L = L_m + L_k$ [Eq. (55)] vs =w for a=w = 0.01, 0.1, 0.4, 0.8, 0.95, and 0.99. See the text for descriptions of analytic approximations shown by the dotted and dashed curves. (b) Solid curves show both the geometric inductance L_m [Eq. (58)] and the kinetic inductance L_k [Eq. (59)] vs =w for a=w = 0.01, 0.1, 0.4, 0.8, 0.95, and 0.99. See the text for descriptions of analytic approximations shown by the dotted, dashed, and dot-dashed curves.

Show n as the solid curves in Fig. 8(a) are plots of the inductance L vs a=w for various values of =w = 0,0.03, 0.1, 0.3, and 1. The solid curves in Fig. 9(a) show the same L vs =w (range 0.0045 to 2.2) for several values of a=w = 0.01, 0.1, 0.4, 0.8, 0.95, and 0.99.

Shown as solid curves in Fig. 8(b) are L_m and L_k vs a=w. For = 0, when $L_k = 0$, $L = L_m$ exactly coincides with Eq. (A 10), which may be approximated by Eq. (A 11) for a=w < 0.7 [open circles in Fig. 8(a)] and by Eq. (A12) for a=w > 0:7 [open squares in Fig. 8(a)]. The dotted curves in Fig.8(b) for L_{m} and L_{k} are those of Eqs. (C3) and (C6) in the $\lim it = w ! 1$, when the circulating current density is uniform . The dotted curves in Fig. 8(a) are obtained from $L = L_m + L_k$ using the approxim ations of Eqs. (C3) and (C6); they are an excellent approximation to L for =w 0:03 except for sm all values of a=w. Im proved agreem ent for sm all values of =w and a=w is shown by the dashed curves in Fig. 8 (a), which show the approximation of Eq. (B7) for L, and in Fig.8(b), which show the approximation of Eq. (B12) for

 ${\rm L}_k$.

The solid curves in Fig. 9(b) show L_m and L_k vs =w. The geometric inductance Lm depends upon but only weakly, varying slowly between its = 0 asymptote [Eq. (A10), horizontal dot-dashed line] and its = 1 asymptote Eq. (C3), horizontal dotted line]. For larger values of of a=w, L_m is nearly independent of . On the other hand, the kinetic inductance ${\tt L}_{\tt m}$, is approximately proportional to =w. The straight dotted lines in Fig. 9(b), calculated from the large- approximation given in Eq. (C 6), are a good approximation to L_m except for sm all values of =w and a=w. The dotted curves in Fig. 9(a) are obtained from $L = L_m + L_k$ using the approximations of Eqs. (C3) and (C6). Improved agreement for small values of =w and a=w is shown by the dashed curves in Fig. 9(a), which show the approxim ation of Eq. (B7) for L, and in Fig. 9(b), which show the approximation of Eq. (B12) for L_k .

In Eq. (3) of Ref. 44, Yoshida et al. derived an approximate expression for the kinetic inductance when =w 1. We have found that their expression for L_k is not an accurate approximation to our exact num erical results. To elim inate the logarithm ic divergences due to the inverse square-root dependence of the current density near the edges, Yoshida et al. followed an approach used by M eservey and Tedrow, 45 and chose a cuto length of the order of d, the lm thickness. W hen d < , however, this approach cannot be correct, because the equations describing the elds and currents in superconducting strips contain only the two-dimensional screening length = 2 =d. The cuto length therefore must instead be chosen to be of the order of , as we have done in Appendix B.




FIG.10: The magnetic m om ent m $_{\rm d}$ for the circulating current case (B $_{\rm a}$ = 0, I = I $_{\rm 2}$ = I $_{\rm d}$ > 0) plotted versus a=w for various values of =w in units 2w II $_{\rm d}$. These curves coincide with those in Fig.13 below.

As shown in Fig.10, thism agneticm on ent vanishes very slow ly when the gap width and go to zero, a=w ! 0 and =w ! 0. This can be explained by the fact that for = 0 and a < x w one has $J_d(x) / 1=x$, Eq. (A5). The contribution of these sm all x to m_d , Eq. (60), stays nite due to the factor x, but the total current I_d to which m_d is norm alized, diverges when a=w ! 0, thus suppressing the plotted ratio $m_d=I_d$. Interestingly, the curves in Fig.10 coincide with those in Fig.13; see below. Expressions form $_d$ in the lim its =w ! 0 and =w ! 1 are given in Eqs. (A13) and (C7).




FIG.11: Pro les $J_f(x)$, Eq. (62), $G_f(x)$, Eq. (64), and m agnetic induction $B_f(x)$ for the ux-focusing case ($B_a > 0$, $I_1 = I_2 = 0$). Shown are the examples a=w = 0.3 with =w = 0 (solid lines with dots), 0.03 (dot-dashed lines), 0.1 (dashed lines), 0.3 (dotted lines), and 1 (solid lines). B and $_0J$ are in units B_a , and G in units $wB_a = _0$.




FIG.12: Magnetic eld lines in the ux-focusing case for a=w = 0.1 and =w = 0, 0.01, 0.1, and 0.5.




FIG.13: The e ective area A_e , Eq. (63), plotted versus the gap halfwidth a=w for several values of =w = 0,0.001,0.003, 0.01, 0.03, 0.1, 0.3, and 10. The low er-right curves show the same data shifted and stretched along a=w. The dots show the exact result (A19) in the lim it =w ! 0. For =a 10 one has $A_e = 2wl$ (1 + a=w)=2, A ppendix C. These curves coincide with Fig.10 since $A_e = m_d = I_d$.




FIG.14: The e ective area A_e , Eq. (63), plotted versus =w (range 7 10^6 to 14) for several values of a=w = 0, 0.001, 0.003, 0.01, 0.03, 0.1, and 0.2. Same data as in Fig.13.

0.1, 0.3, and 1. The rst term in Eq. (62) equals the circulating-current sheet-current density, Eq. (54), with appropriate weight factor such that the total circulating current vanishes, $I_1 = I_2 = 0$. The corresponding m agnetic eld lines are depicted in Fig.12. Shown in Figs.13 and 14 are plots of the elective area A_e (a=w; =w) versus a=w and =w, respectively, in units of the maximum possible area 2wl. In the limit =w ! 0, A_e is given by Eq. (A19), and when =w ! 1, $A_e = 1(w + a)$: Note in Fig.14 that A_e increases with increasing , particularly for sm all gap widths 2a. Flux focusing is re-ected by the fact that for sm all a=w ! 0 the elective

area A_e of the gap tends to a constant, except in the lim it ! 0, where it vanishes very slow ly, $A_e = 2wl$ (=2)= ln (4w=a) [Eq. (A19)]. When a=w ! 0, the enhancement factor $A_e = 2al!$ 1 and thus diverges even for = 0. In the lim it a=w 1, A_e (0; =w) tends to a universal function [see Fig. 14]. Interestingly, Figs. 13 and 10 show identical curves; this is because the identity $A_e = m_d = I_d$ holds for all values of a=w and =w, as proved in general in Sec. II.




FIG.15: Them inimum of the magnetic induction in the uxfocusing case, $B_f(0) = B_f(x = 0)$, referred to the applied eld B_a and plotted versus the half gap width a=w. Top: The ratio $B_f(x = 0)=B_a$, tending to unity for a=w ! 1 and for =w 1, and diverging for a=w ! 0 when = 0. Bottom: The same ratio multiplied by a=w to avoid this divergence and t all data into one plot. The lower right plot depicts the small-gap data two times enlarged along the ordinate, and shifted and ve times stretched along the abscissa. The circles show the approximation $B_f(0)=B_a$ (w=a)=ln (4w=a) good for a=w 0:3⁴⁶




FIG.16: The minimum eld $B_f(0) = B_f(x = 0)$ for the uxfocusing case as in Fig.15 but plotted versus =w (range 7 10⁶ to 14) for several values of a=w = 0, 0.001, 0.003, 0.01, 0.03, 0.1, and 0.2.




FIG.17: The magnetic moment m $_{\rm f}$ for the ux-focusing case plotted versus a=w for various values of =w in units w $^2\,{\rm IB}_{a}=~_0$.

Figures 15 and 16 show the minimum of the magnetic induction in the ux-focusing case, $B_f(0) = B_f(x = 0)$ [see Fig. 11], plotted versus a=w and =w, respectively. The ratio $B_f(0)=B_a$ 1 tends to unity for a=w ! 1 and for =w 1, and it diverges for a=w ! 0 when = 0. The curve for = 0 exactly coincides with the analytic expression $B_f(0)=B_a = w E(k^0)=aK(k^0)$ obtained from Eq. (A17). For a=w 1 this yields B_f (0)=B_a $(w=a)=\ln (4w=a)$, which is a good approxin ation for 0 < a = w $0:3^{46}$ The magnetic moment m_f for the ux-focusing case, calculated from Eq. (60) but with $J_d(x_i)$ replaced by $J_f(x_i)$, is shown in Fig. 17. Expressions for m_f in the limits = w ! 0 and = w ! 1 are given in Eqs. (A 20) and (C 9)




FIG. 18: Pro les of the sheet-current density J(x) [second term in Eq. (62)] and magnetic induction B (x) generated when a perpendicular magnetic induction B_a is applied in the zero-uxoid case when = 0, $I_1 = I_2 > 0$, and I = 0. Shown are the examples a=w = 0:3 with =w = 0 (solid lines with dots), 0.03 (dot-dashed lines), 0.1 (dashed lines), 0.3 (dotted lines), B and $_0J$ are in units B_a .

Shown in Fig. 18 are profes for the zero-uxoid case with plots of J(x) and the corresponding B(x) generated by an applied magnetic induction $B_a > 0$ when the junctions are short-circuited such that = 0 and $I_1 = I_2 > 0$; for comparison see analogous profes in Sec. 2.5 of Ref. 47 for two parallel strips and in Sec.




FIG.19: M agnetic eld lines in the zero-uxoid case = 0, $B_a > 0$, and I = 0 for a=w = 0:1 and =w = 0, 0.01, 0.1, and 0.5.




FIG.20: The magnetic moment m for the zero-uxoid case = 0, B_a > 0, and I = 0 plotted versus a=w for various values of =w in units w² $IB_a = 0$. At a = = 0 one has m = w² $IB_a = 0$.

IV of Ref. 48 and Sec. 4 of Ref. 31 for rings. That the current density J(x) in the zero- uxoid case is given by the second term on the right-hand sides of Eqs. (41) and (62), can be seen by setting $_{\rm f} = B_{\rm a}A_{\rm e} = 0$ in Eqs. (40), (41), (61), and (62). Depicted in Fig. 18 are the examples a=w = 0.3 with =w = 0, 0.03, 0.1, 0.3, and 1. Figure 19 shows the magnetic eld lines for this case and Fig. 20 the magnetic moment m. Expressions for J, B, and m for the zero- uxoid case in the lim its =w ! 0 and =w ! 1 are given in Appendixes A and C.

IV. SUMMARY

In Sec. II of this paper we have presented general equations governing the static behavior of a thin- lm dc SQUID for all values of the Pearl length = 2 =d, where the London penetration depth is larger than d, the lm thickness. The SQUID's critical current I_c depends upon the elective ux , which is the sum of the magnetic ux up through a contour surrounding the central hole and a term proportional to the line integral of the current density around this contour. For a symmetric SQUID there are three in portant contributions to : a circulating-current term d, a vortex-eld term v, and a ux-focusing term f, all of which depend upon . Since

is a function oftem perature, an important consequence is that all of the contributions to are tem peraturedependent.

The circulating-current term $_{\rm d}$ can be expressed in terms of the SQUID inductance L and the circulating current $I_{\rm d}$ via $_{\rm d}$ = LId. The SQUID inductance has two contributions, L = $L_{\rm m}$ + $L_{\rm k}$, where the rst term is the geometric inductance (associated with the energy stored in the magnetic eld) and the second is the kinetic inductance (associated with the kinetic energy of the circulating supercurrent). B oth contributions are functions of , since they both depend on the spatial distribution of the current density. However, $L_{\rm m}$ depends only weakly upon , because for the same circulating current I_d, the energy stored in the magnetic eld does not vary greatly as ranges from zero to in nity. On the other hand, because the kinetic energy density is proportional to , $L_{\rm k}$ is also nearly proportional to , with deviations from

linearity occurring only for small values of =w.

The vortex-eld term can be written as $v = {}_{0}G_{d}$, where G_d is a dimensionless stream function describing the circulating sheet-current density Jd. Roughly speaking, when is small, I c is most strongly dependent upon the vortex position when the vortex is close to the edges of the lm, but when is large, I c is equally sensitive to the vortex position wherever the vortex is. Recent experiments⁴⁹ have used the relationship $v = {}_0G_d$ to determ ine the vortex-free sheet-current density $J_d(x;y)$ from vortex in ages obtained via low-tem perature scanning electron m icroscopy.^{6,9} The experimental data obtained in magnetic elds up to 40 T are in excellent agreem ent with num erical calculations of $J_d(x;y)$, conm ing the validity of the above relationship, even in the presence of m any (up to 200) vortices in the SQU ID washer.

The ux-focusing term can be expressed as $_{\rm f}$ = $B_{\rm a}A_{\rm e}$, where $B_{\rm a}$ is the applied magnetic induction and $A_{\rm e}$ is the elective area of the central hole of the SQUD. Although $A_{\rm e}$ is primarily determ ined by the dimensions of the SQUD, it also depends upon the value of :

To illustrate the dependence of the above quantities, in Sec. III of this paper we analyzed in detail the behavior of a long SQUID whose central region resembles a coplanar stripline. We numerically calculated the probes of the sheet-current density, stream function, and magnetic induction in the equal-current, circulating-current, ux-focusing, and zero-uxoid cases for various representative values of . We presented plots of the inductances L; Lm, and Lk, the elective area Ae , and the magnetic moments for these cases. Useful analytic approximations are provided for the =w ! 0 limit in Appendix A, for
