A general interpolation scheme for thermal uctuations in superconductors

We present a general interpolation theory for the phenomenologicale ects of them all uctuations in superconductors. Fluctuations are described by a simple gauge invariant extension of the gaussian elective potential for the Ginzburg-Landau static model. The approach is shown to be a genuine variational method, and to be stationary for in nitesimal gauge variations around the Landau gauge. Correlation and penetration lengths are shown to depart from the meaneld behaviour in a more or less wide range of temperature below the critical regime, depending on the class of material considered. The method is quite general and yields a very good interpolation of the experimental data for very different materials.

## I. INTRODUCTION

In a recent paper[1] we have shown that the Gaussian E ective Potential (GEP) can describe the behaviour of superconductors, thus allowing for a comparison with the experimental data. The GEP has a long history [2, 3, 4, 5, 6, 7, 8, 9, 10, 11] and has been discussed by several authors as a tool for describing the breaking of symmetry in the standard model of electroweak interactions[11, 12], but in that context no real comparison with experimental data will be achievable until the detection of the Higgs boson. Thus High  $T_c$  superconductors represent the best way to test the reliability of the method. While the comparison with experimental data is of special importance as a test for the GEP variational method itself, the method can be regarded as a general interpolation scheme for the pre-critical region of superconductors: too close to the critical point for thermal uctuations being negligible, but not yet in the critical range where universality sets in. In this pre-critical range, the GEP provides an interpolation between the mean-eld behaviour and the critical limit. Besides standard phenomenological parameters the method relies on one free parameter which characterizes the width of the pre-critical range and allows for a very good to fithe experimental data for very different materials ranging from cuprates like YBa2Cu2O7 to the double band superconductor MgB2. The free parameter turns out to be a characteristic energy scale of the material.

The general phenomenology of superconductivity can be described by the standard Anderson-Higgsmechanism: the supercurrent is carried by pairs of charged ferm ions whose non-vanishing expectation value breaks the gauge symmetry, and endows the gauge bosons with a non-zero mass. Thus, the standard Ginzburg-Landau (GL) e ective Lagrangian provides the best fram ework for a general description of the phenom enology. Moreover, as the GL action can be seen as a power expansion of the exact action around the critical point, the GL action must be recovered by any microscopic theory at least around the transition. Therefore, whatever the origin of the microscopic pairing mechanism, the GL action is a sound starting point for a general interpolation scheme of superconductivity. Of course we cannot trust the m ean-eld approach to the GL elective theory, and we expect that in high T $_{\rm c}$  superconductors m any unconventional properties should have to do with the breaking down of the simple mean-eld picture. Actually, unconventional superconductors are characterized by a very small correlation length, which allows the experimentalists to get closer to the critical point where the thermal uctuations cannot be neglected and the mean-eld approximation is doomed to fail. As far as we know there is no clear evidence that the critical universal behaviour can always be reached in the cuprate superconductors: a weakly charged super uid regim e has been predicted and observed [13, 14, 15, 16] in nearly optimally doped samples, while a charged critical behaviour has been reported for the underdoped samples [17]. Recently the superconducting pyrochlores have been shown to open up a window onto the charged critical regim e[18]. However it is out of doubt that an intermediate range of temperature is now accessible, where thermal uctuations are not negligible even when the sample is still out of the truly critical regime. Thus, in order to describe some unconventional properties of high Tc superconductors, we need to incorporate the role of them al uctuations, but unfortunately we cannot rely on the standard renormalization group methods [19] which would only describe the lim iting universal behaviour. We need an approximate approach to the GL action for the non-universal regime where the behaviour depends on the physical parameters of the sample, and we would prefer a non-perturbative approximation in order to deal with any coupling, whatever its strengthness.

As a toy model for electroweak interactions, the scalar electrodynamics in four dimensions has been studied by

Ibanez-M eier et al.[12] who computed the GEP by use of Cartesian coordinates for the eld components. This choice breaks the U (1) sym metry of the eld and gives rise to an unphysical, and undesirable, massive degree of freedom. However, in three space dimensions, the U (1) scalar electrodynamics is equivalent to the standard static GLe ective model of superconductivity, and the GEP becomes a variational tool for superconductivity. In this paper, we show that the unphysical degree of freedom can be avoided by use of polar coordinates for the eld components. Moreover, the choice of a U (1) sym metric Gaussian functional restores the gauge sym metry and makes the theory gauge invariant for in nitesimal gauge changes around the Landau gauge. In a previous work we discussed the same approximation in unitarity gauge [1]. The method has been extended to two-dimensional systems by Abreu et al [20] in order to study In superconductors. Unfortunately, we found out that the claimed exact [21] integration of the longitudinal component of the electromagnetic vector eld A is only approximatively exact. A ctually, as we show in the present paper, that approximation is a variational one and its accuracy can be checked by standard variational arguments. Indeed, by a direct comparison of the energies, we show that the present method yields a better result compared with the Cartesian coordinate GEP of Ibanez-Meier et al [12].

The variational method provides a way to evaluate important phenomenological quantities like the correlation length and the penetration depth that emerge as the solution of a set of coupled equations. The GL parameter  $_{\rm GL} = {}$ , whose critical behaviour has been addressed by Herbut and Tesanovic[9], is here shown to be described by a very simple relation in the pre-critical regime where it is found to be temperature-dependent, in contrast to the mean-eld result. Thus, the GL parameter has been chosen as a useful measure of thermal uctuations: its dependence on temperature is a sign of the breaking down of the mean-eld approximation which predicts a constant  $_{\rm GL}$ . Unfortunately, experimental data on the temperature dependence of the GL parameter are quite fragmentary in the literature. The behaviour of and can be extracted by the knowledge of the critical magnetic elds, but experimental limits on these data have narrowed our chances of a wide comparison with experiments. Up to now, our GEP has shown the capability of thing the GL parameter for all the materials that we have been able to test.

The paper is organized as follows: in section II the GL action and partition function are reported and the symmetry of the model is discussed together with the conditions for the gauge invariance of the variational functional; in section III the integration of the longitudinal vector eld is shown to be a variational approximation; in section IV the GEP is evaluated in polar coordinates and the result is compared with the Cartesian coordinate method of Ref.[12]; in section V the variational equations are solved for some set of phenomenological parameters and the GL parameter is compared with the available experimental data; some comments and nal remarks on the interpolation method are reported.

#### II. THE GLACTION AND GAUGE INVARIANCE

where (x) is an arbitrary function. The integration over A is then redundant in Eq.(4) and a gauge xing term must be inserted in order to make the partition function nite. A coording to the standard DeW itt-Faddeev-Popov method [23] the partition function can be written as

The GEP is a sort of optim ized  $\,$  rst order approximation: in Cartesian coordinates [12] the action is split according to

where  $_1$  + i  $_2$  = and  $S_1$  =  $S_0$ . Here  $_i$ , and  $'_i$  are arbitrary variational parameters, and the free energy is evaluated up to rst order in the expansion of  $S_1$ . The result is then optimized by variation of the free parameters. When the shifts  $'_i$  are non vanishing the action  $S_0$  is not U (1) invariant, and the approximate partition function fails to be gauge invariant. The lack of symmetry is evident from the appearance of an unphysical massive Goldstone boson (in fact, there are two different mass parmeters  $_1$  and  $_2$ ). In the next section we show by a variational argument that in polar coordinates the action  $S_0$  can be taken as

so that for  $\,!\,$  0 the constraint f=0 restores gauge invariance up to  $\,$  rst order in the gauge change around the Landau gauge (A=0). This discussion motivates in part the choice of polar coordinates that gives rise to an explicitly rotational invariant variational functional and no unphysical massive G oldstone boson. A nother motivation arises from the more pragmatic observation that the free energy is lower with the choice of this polar coordinate variational functional, and since we show that both methods are genuine variational methods a lower free energy means an higher accuracy of the results.

In the previous section we have given some motivations for the choice of polar coordinates in Landau gauge. In three space dimensions that gauge is the transverse gauge f = r A. A simple coordinate change ! exp(i) in the partition function Eq.(7) yields

If the last term of L were neglected, the phase could be integrated exactly (the integral is G aussian). It has been claim ed [1, 20, 21] that in transverse gauge that term should vanish exactly: the argument was that in transverse gauge there is no longitudinal component of the vector eld. In fact, the Fourier transform of the gradient @ is proportional to the wave vector k and this is orthogonal to the Fourier transform of A for the gauge constraint f(k) = k A (k) = 0. However, this holds only for Fourier transforms. The last term of L contains a  $^2$  factor which is not constant, and thus, in this case, the space integral of this term in the action cannot be replaced by the simple inverse-space integral of the product of the Fourier transforms (we could do that if the factor were constant). Thus we cannot neglect that term and the exact integration over the phase would depend on the eld A. We stress that any gauge change does not solve the problem either, as an undesirable longitudinal component of the eld A would take the place of the phase . This bound ensures that, even neglecting the last term of the phase dependent lagrangian L in Eq.(16), the resulting approxim at partition function  $Z_p$  still gives a genuine variational approximation.

## IV. THE GEP METHOD IN POLAR COORD IN ATES

In this section we study the GEP m ethod for the polar coordinate partition function Eq.(23) with the lagrangian L de ned according to Eq.(15). The GEP m ay be evaluated by the same expansion m ethod discussed in Ref.[2] and [25] and also reported by C am arda et al.[1]. Here the GEP represents a variational estimate of the free energy  $F_p$ . Inserting a source term for the real eld the partition function  $Z_p$  reads

The free energy (40) now depends on the mass parameters , and on the eld shift'. These are the variational parameters that must be determined by the minimization of the energy density  $V_{\rm eff}$ . At the stationary point  $V_{\rm eff}$  is the GEP and the mass parameters give the inverse correlation lengths for the elds, the so called coherence length = 1= and penetration depth = 1= . The eld shift' is the order parameter of the phase transition: when ' 60 at the minimum of  $V_{\rm eff}$  the U (1) symmetry is broken in the ground state and the system is in the superconducting phase.

For any 'value the equations must be solved numerically, and the minimum point values and must be inserted back into Eq.(40) in order to get the Gaussian free energy  $V_{\rm eff}$  (') as a function of the order parameter '. For a negative and small enough m  $_{\rm B}^{\,2}$ , we note that  $V_{\rm eff}$  has a minimum at a nonzero value of ' = ' $_{\rm min}$  > 0, thus indicating

that the system is in the broken-sym m etry superconducting phase. O fcourse the m asses , only take their physical value at the m in im um point of the free energy '<sub>m in</sub>. This point is found by requiring that

However, we notice that here the mass must be found by solution of the coupled gap equations. Thus Eqs.(48), (45) and (46) are a set of coupled equations and must be solved together in order to nd the physical values for the correlation lengths and the order parameter.

Insertion of Eq.(48) into Eq.(46) yields the  $\sin$  ple relation for the GL parameter  $_{\rm GL}$

where  $_0$  =  $e_B^2$  = (8  $_B$ ) is the mean-eld GL parameter which does not depend on temperature. As discussed by C am arda et al.[1], Eq.(49) shows that the GL parameter is predicted to be temperature dependent through the non trivial dependence of and '  $_{m \ in}$ . At low temperature, where the order parameter '  $_{m \ in}$  is large, the deviation from the mean-eld value  $_0$  is negligible. Conversely, close to the critical point, where the order parameter is vanishing, the correction factor in Eq.(49) becomes very important. The deviation from the mean-eld prediction  $_{GL}$  =  $_0$  also depends on the cut-o parameter as for ! 0 all the elects of uctuations vanish together with the integrals I  $_n$ . This parameter defines another length scale '= 1= , which is a characteristic of the material.




FIG.1: Comparison between the polar GEP (solid line) and the Cartesian GEP dashed line. The value of the parameters are:  $m_B^2 = \frac{2}{B} = 80$ ,  $m_B^2 = \frac{2}{B} = 80$ ,  $m_B^2 = \frac{2}{B} = 80$ . Note that the origin of the 'axis coincides with the minimum of the Cartesian GEP to emphasize that our polar decomposition of the eld leads to a lower excitive potential.

A test of the present method comes from the direct comparison with the cartesian coordinate GEP discussed by Ibanez-Meier et al.[12]. Both methods are genuine variational methods and a direct comparison of the free energy density gives information on the accuracy. In Fig.1 we report our polar coordinate GEP together with the three-dimensional version of the cartesian coordinate GEP. The polar coordinate GEP yields a lower free energy density thus indicating that, besides being more symmetric and appealing (there are no unphysical degree of freedom and no massive gauge bosons), the method is also more elective.

# V. INTERPOLATION OF THE EXPERIMENTAL DATA

As we mentioned earlier, another appealing aspect of the GEP approximation in three space-timed in ensions resides in the chance to compare its results with the phenomenology of high  $T_c$  superconductors. For this comparison to be consistent we need to x the bare parameters of the GL action; following [1], we can use the standard derivation of the GL action (1) (see [22]) to not a connection between microscopic rst-principle quantities and phenomenologic bare parameters. Thus, we have:

where 2e represents the charge of a Cooper pair,  $T_c$  is the critical tem perature and  $_0$  the zero tem perature coherence length.

The know ledge of the zero tem perature coherence length and penetration depth enables us to x the other parameters; regarding the bare mass parameter m $_{\rm B}^2$  as a linear function of tem perature, we obtain:

where m  $_0^2$  is the value which is required in order to nd = 1=  $_0$  from the gap equation (45) at ' = '  $_{\rm m\ in}$ , and m  $_{\rm c}^2$  is the value of m  $_{\rm B}^2$  at the transition point. The mean-eld approximation predicts that m  $_{\rm c}^2$  = 0, but the elect of the uctuations is to shift the transition point to a negative non-vanishing m  $_{\rm B}^2$  value.

Finally, the bare coupling  $_{\rm B}$  is xed through Eq.(46) by requiring that at zero temperature (i.e. for  ${\rm m}_{\rm B}^2 = {\rm m}_0^2$ ) the penetration depth  $_0 = 1 = 1$ .

The cuto still remains to be xed; thus, the interpolation scheme for the superconducting properties we have to deal with contains one free parameter (i.e. ), which is a characteristic energy scale of the sample, and will be determined by a direct to fithe experimental data.

(where H  $_{c1}$  and H  $_{c2}$  represent the lower and upper critical elds,respectively), and extrapolated the zero temperature phenomenological values needed to x the bare parameters by a linear t.

The smallnum ber of available experimental data is due to the diculty of performing measurements of the coherence length and penetration depth (or, alternatively, of the two critical elds) up to the pre-critical region.




FIG. 2: The GL param eter according to Eq.(49) for  $_0$  = 100,  $_0$  = 136 nm,  $T_c$  = 1215 K and  $_0$  = 20 (full line). The circles are the experim ental data of Ref.[26] for  $T \downarrow C a_2 B a_2 C u_3 O_{10}$ .




FIG. 3: The GL parameter according to Eq.(49) for  $_0$  = 187,  $_0$  = 1:65 nm,  $T_c$  = 62 K and  $_0$  = 5 (full line). The circles are the experimental data of Ref.[27] for YBa<sub>2</sub>Cu<sub>2</sub>O<sub>7</sub> .




FIG. 4: The GL param eter according to Eq.(49) for  $_0$  = 31:66,  $_0$  = 3:9 nm ,  $T_c$  = 38:6 K and  $_0$  = 900 (full line). The circles are the experim ental data of Ref.[28] for M gB $_2$ .

In Fig 2, Fig 3 and Fig 4 the comparisons between our interpolation curves, as obtained by Eq.(49), and the data relative to the three materials mentioned above, are shown.

It can be noted that the experimental GL parameter is almost constant at low temperatures, according to the mean-eld description, while it shows a sharp temperature-dependence (at  $T=T_c$  0.8 for  $T \lg C a_2 B a_2 C u_3 O_{10}$ , at  $T=T_c$  0.6 for M  $gB_2$ ) in the pre-critical region: it is in this region that the mean-eld approximation breaks down, while our model shows its electiveness. We would like to emphasize that the GEP approximation is able to reproduce the GL parameter behaviour for classes of compounds (cuprates and diborides) with very dierent microscopic structures and, probably, dierent pairing mechanism. These dierences are relected in the cuto values we used to the data: they have the same order of magnitude ( $_0 = 20$  for  $T \lg C a_2 B a_2 C u_3 O_{10}$ ,  $_0 = 5$  for  $YBa_2Cu_2O_7$ ) for the two cuprates, while the cuto used for the diboride ( $_0 = 900$  for M  $gB_2$ ) is about two order of magnitude greater. In this sense, the parameter seems to be a characteristic energy scale of the sample, related to its microscopic structure, and, as a consequence, to the size of the region where uctuations cannot be neglected.

Finally, we want to remark that, very close to the critical point, some universal behaviour should be expected and the role of them all uctuations becomes too important to be dealt with by the present method. In fact the GEP always predicts a weak instrumentation at the critical point even for the neutral super uid (real scalar theory) [30]. This is not a problem for the interpolation of the experimatal data as the difference only arises in a very narrow range of temperature at the transition point. Thus the method seems to be suitable for interpolating the pre-critical region where the order of the transition does not make any difference. Any extension to the critical range would require the proper inclusion of vortex uctuations which are expected to play a major role at criticality [31], and have been recently shown to change the order of the transition in the GL model [24]. We also mention that a variational perturbative extension of the gaussian approximation has been shown to be able to reach the critical regime [32]

In sum m ary we have shown that a polar decom position of the complex eld in the action has the merit of allowing the integration of the longitudinal vector eld (by a further variational approximation), is better than the Cartesian decomposition in [12] and, at variance with the mean-eld approximation, yields a one-parameter interpolation scheme which to very well all the available data, in the whole range of the accessible temperatures. Moreover, the variational character of the model, allowing the study of any kind of coupling, makes the GEP a suitable tool for the inspection of other physical systems, such as super uids.

As the GEP provides a nice way to interpolate the experim ental data beyond the mean-eld regime, we expect the method to be reliable for the description of sym metry breaking in 3 + 1 dimensions where the scalar electrodynamics may be regarded as a toy model for the standard electro-weak theory.
