Quasiclassical frustration

W e study the dissipative properties of a harm onic oscillator subject to two independent heat baths, one of which couples to its position and the other one to its momentum. This model describes a large spin in purity in a ferrom agnet. We nd that some e ects of the two heat baths partially canceleach other. Most notably, oscillations may remain underdam ped for arbitrarily strong coupling. This e ect is a direct consequence of the mutually conjugate character of position and momentum. For a single dissipative bath coupled linearly to both position and momentum, no underdam ped regim e is possible for strong coupling. The dynamics of purity loss for one and two wave packets is also investigated.

The harm onic oscillator provides a scenario where the physics of a quantum particle coupled to a heat bath can be investigated analytically [1, 2, 3]. Thus its study m ay shed light on physical e ects that have been found in less tractable models. Recently, Castro Neto et al. [4] have investigated, by m eans of perturbative renom alization group methods, the equilibrium dynamics of a quantum magnetic impurity in a ferrom agnet and have found that the sym m etric coupling of the m agnon bath to the x and y spin components (z being the m agnetization direction) e ectively decreases the strength of the coupling. They have coined this term quantum frustration, since it may be interpreted as the inability of the spin bath to simultaneously measure two non-commuting observables such as the x and y components of the impurity spin. An important consequence is that spin coherence m ay be longer lived than it would if only one of the spin components were coupled to the dissipative bath. This e ect could be relevant for quantum information, as it would provide a mechanism for quantum spins to remain coherent for long tim es.

Here we investigate the e ect of quantum frustration in a dierent but exactly tractable physical system, namely, a harm onically oscillator coupled separately, through its position and momentum, to two independent oscillator heat baths [5]. In the symmetric limit, this model describes the behavior of a large spin magnetic impurity in a ferrom agnet. A nother instance of a physical system which interacts, through position and momentum, with two dierent baths is a Josephson junction, where the relative particle number (proportional to the electric dipole) couples to the radiation eld while the relative phase interacts with the quasiparticle eld [6]. Those two environments have dierent spectral properties. To investigate a more symmetric coupling, we consider a harm onic oscillator whose position and m om entum interact linearly with two independent 0 hm ic baths [7]. We nd that the two baths do cancel in some but no all respects. A degree of cancellation is revealed by the persistence of underdam ped oscillations for arbitrarily strong dissipation provided that the two baths couple with com parable strength. Quantum purity is weakened by the presence of a symmetric second bath although its decay is slowed down. Since a symmetrically dam ped harm onic oscillator behaves like a large spin in a ferrom agnet, we refer to such a mixed situation as quasiclassical frustration.

W e investigate the following model H am iltonian [6]:

where [q;p] = i and $g_q;g_p$ are su ciently well behaved functions. For general $g_q;g_p$ the two equations in Eq. (2) cannot be decoupled without generating interactions between the two baths. However, if one of the coupling functions, say g_p , equals 1, then [p; q] = 0 and it becomes possible to remove both uctuating contributions from the potential terms through the unitary transformations $U_p = \exp(ip q)$ and $U_q = \exp(i^{-q} p(q^0)dq^0)$. One arrives at the Ham iltonian

where the short-hand notation $j_a \hat{f} = a^{\dagger} a$ has been used.

At this point it is important to specify what we mean by coupling to position or momentum. Those are the particle variables to which the environm ent couples as a set of otherwise independent harm onic oscillators. This is the case e.g. in (3), where the bath oscillators would remain independent if q and p were c-num bers. On the contrary, this is not the case in (1), where, due to the nonlinear character of V_{α} and V_{p} , the bath oscillators do interact with each other [8]. A popular example is that of a charged particle interacting with the photon eld [6]. W hen the velocity-coupling model is adopted, it must be accompanied by a diamagnetic term that contains an interaction between photons. By contrast, through a canonical transform ation, the photon eld interacts with the particle position without an explicit interphoton interaction. Thus, within the precise convention we propose here, the electrom agnetic eld couples to the position of a charged particle.

W e focus on the case of a harm onic oscillator [V_q (q) = $!_q q^2 = 2$, V_p (p) = $!_p p^2 = 2$] with $g_q = g_p = 1$:

This is the model of dissipative coupling that displays the highest degree of sym metry between q and p. Hence it is interesting to study frustration in a physical system other than a quantum spin in a ferrom agnet. The two baths of independent harm onic oscillators are described by the spectral densities

We assume a power law behavior at ! = 0 and write $J_n (!) = 2_n ! {}^n = (! {}_{ph} {}^n {}^1)$, where the introduction of the frequency $!_{ph}$ renders the coupling constants ${}_n$ dimensionless. Moreover, large cuto frequencies ${}_n$ are assumed to exist for both environments.

E lim inating the bath variables, the Heisenberg equations of m otion for q and p are obtained,

where \mathfrak{F}_n (!) is the symmetrized R iem ann transform [9]:

where (!) is the generalized susceptibility.

W e further assume that the two heat baths are 0 hm ic: $J_n(!) = 2_n! = .$ For $_n ! 1$, this implies $\mathfrak{F}_n(!) !$ $i_n! .$ Then the eigenfrequencies are given by

The transition from < 1 to > 1 m arks the crossover from underdam ped to overdam ped oscillations. The condition < 1 requires (criterion A)




FIG.1: Stripes of underdam ped oscillations in the (q; p) plane for three dierent values of the parameter = $(!_q=!_p)^{1=2}$, for q and p coupled to dierent baths. Inset: Shaded region denotes underdam ping for a single bath coupled to q and p.

The underdam ped region satisfying (14) lies in a stripe of width = 4 1 + 4 ¹⁼² with = $(!_q=!_p)^{1=2}$, limited by the graphs of the functions f ($_q$) = ($_q$ 2) ². The stripes of underdam ped oscillations in the ($_q$; $_p$) plane are plotted in Fig.1 for = 1=3;1;3. A rem arkable consequence is that, given a value of e.g. $_q$, one m ay drive the system from the overdam ped to the underdam ped regime by increasing $_p$. For = 1, the oscillator is underdam ped if $_q$ ' $_p$, i.e., if the couplings to the two baths are of com parable strength. When $_q = _p$ the dimensionless parameter becomes,

Thus, in the fully symmetric case, the oscillator remains underdam ped for all values of the coupling strength. This is in contrast with the case of one noise ($_p = 0$),

which requires $_q < 2$ to be underdam ped. Conversely, if $_q = 0$, the condition is $_p < 2^{-1}$. The inset of Fig. 1 shows the underdam ped region for an oscillator coupling through q and p to a single heat bath [10]. Surprisingly, the behavior is qualitatively di erent in that underdam ping is always lost for su ciently large coupling.

A nother interesting quantity is $D_q(!)$ Im $_{qq}(!)=!$, where $_{qq}(!)$ is the Fourier transform of h[q(t);q(0)]i. For 0 hm ic environments,

Following Ref. [4], we may view the presence of a peak in D $_q$ (!) as a signature for the existence of coherent dynamics (criterion B). This occurs for

In the symmetric case, this translates into $< \frac{p}{3}$. For an oscillator coupled to a single bath through its position ($_{p} = 0$), the requirement is $_{q} < \frac{p}{2}$. Finally, if $_{q} = 0$, D $_{q}(!)$ always displays a peak [11].

A third possible condition for the existence of coherent dynam ics is that, in Eq. (12),

In the sym m etric case, the condition (19) becomes <1. For $_p$ = 0, it becomes $_q<\overline{2}$, while for $_q$ = 0, it reads $_p<\overline{2}$ 1 .

In table I, the coherence signatures for the main three particular cases are summarized. Criteria A and C are symmetric in q and p, but not criterion B. The general trend (particularly clear if one considers A and B) is that, starting from a single dissipative bath coupled to e.g. q, the introduction of a second bath that couples to p with the same spectrum and comparable strength favors coherent and underdam ped dynamics. For example, an oscillator with = 1 that is driven from p = 0 to p = q =, with q xed at a value 2 < q < 3, will cross over from incoherent to coherent behavior under both criteria A and B.

We have noted the striking result that, in the symmetric case, the oscillator is underdam ped for all values of . However, criteria B and C indicate that the oscillator lies deep in the underdam ped region only if is small. Such a limitation is also patent in the (possible) maximum of D_q (!)=D_q (0) as well as in the ratio jRe! j=jIm ! j= ¹. Both quantities stay well above unity only if is small. A related point is that, as ! 1, the ratio D_q (!)=D_q (0) does not saturate but rather decays as $!_0^2 = {}^2!^2$ for nonzero !.

A n oscillator initially prepared in a pure coherent state that at t = 0 begins to interact linearly with an oscillator bath is described by a reduced density which remains G aussian at all times. Then the purity P (t) Tr(²) is given by

At long times, hq^2i and hp^2i reach their equilibrium values, which contain contributions from both baths as well as hybrid term swhich vanish if any of the two baths disappears [6]. For simplicity, we focus on the zero tem – perature, weak coupling case. Then,

and similarly for $hp^2 i$. The two baths have opposite effects on $hq^2 i$, but for $_n$!₀ the logarithm is divergence from the p-coupled bath overwhelms the squeezing of q favored by the q-coupled environment. An impure mix-

The dynam ical evolution of the purity P (t) is cum bersom e in the general case, but it becomes tractable in the symmetric problem . We nd ($_q = _p =$)

with $1 = !_0 = (1 + 2) = jm!$ j. The fast decay on the scale of $1 \mod s$ from the choice of decoupled initial conditions [12] and from the concurrence of two baths [13]. For t 1, the system evolves slow by towards equilibrium. The divergence of for $! 1 \mod s$ interpreted as robustness against purity loss. How ever, it should be noted that such a slow ing down merely relects a dilation of all time scales with increased friction. For instance, $Re! j = !_0 = (1 + 2)$ vanishes even faster.

We have also investigated the purity decay when at t = 0 the system is prepared in a linear superposition of two coherent states centered at q = a=2 with zero average momentum [14]. For the symmetric case, we nd [10]

where (t) is a complicated function that evolves from (0) = 1 to $\lim_{t! \ 1}$ (t) = 0, and the single wave packet purity P (t) is given in (23). As expected, P (t)=P (t) ! 1 as a ! 0, and P (t)=P (t) ! 1=2 as a ! 1.

Interestingly, the structure of (24) is such that, as time passes and (t)P (t) evolves from 1 to 0, the ratio P (t)=P (t) starts at unity, as corresponds to a pure state, then decreases and nally, at long times, goes back to unity. W hen a is large P (t)=P (t) decays rapidly on a tim escale $1=4a^2$ to 1=2. There it stays for a time which increases with distance as ¹ In a. A fterwards it returns to one. The ratio 1/2 can be rightly interpreted as resulting from the incoherent mixture of the two wave packets. Thus it com es as a relative surprise that P(t)=P(t) becomes unity again at long times, as if coherence am ong the two wave packets were eventually recovered. The physical explanation lies in the ergodic character of the long time evolution, with both wave packets evolving towards the equilibrium con guration described in Eqs. 20-22. Once the two initially separate wave packets begin to overlap, they regain mutual coherence. Due to the sym metry of the problem, a

sim ilar result would have been obtained if the oscillator had started from a superposition of two coherent states located in the same region of real space but with di erent average values of the momentum.

In summary, we have found features that are rem iniscent of an e ective particle-bath decoupling, such as the persistence of underdam ped oscillations for arbitrarily large values of in the case of a symmetric oscillator and the slowing down of purity decay for a Gaussian wavepacket. Another feature is that two initially separate wave packets regain relative coherence at long times because they recombine. The situation is rem iniscent of the quantum frustration exhibited by a magnetic quantum impurity albeit in a more limited form [4]. The main di erence between the two problem s is the dim ensionality of the particle Hilbert space. Evolving in the continuum, the quantum oscillator can be considerably degraded by the e ect of the environment, as shown in (23). It is only when the two wave packets recom bine because of ergodicity that relative purity is recovered. By contrast, the spin-1/2 magnetic impurity lives in a two-dimensional space. The only possible e ect of the environment is to ip the spin. Thus, in any representation, two initially orthogonal states quickly overlap and tend to preserve mutual coherence. The net result is an increased decoupling from a sym m etrically dissipative environm ent. The requirem ent of low dimensionality suggests that strong frustration is a genuinely quantum e ect.
