Point-Contact Spectroscopy on RuSr₂G dCu₂O₈

A bstract

We present Point-Contact experiments on polycrystalline $RuSr_2GdCu_2O_8$ samples. The majority of tunneling curves shows a zero-bias conductance peak, which is modeled by assuming a d-wave pairing symmetry of the superconducting order parameter. The magnetic eld dependence of the conductance spectra has been measured in very stable junctions. In some cases, due to the granularity of the samples, clusters of grains in series introduce peculiar features in the conductance spectra.

1. Introduction

The sym metry of the order parameter gives important information to understand the mechanism of the superconductivity in high- T_c superconductors. A standard technique to investigate the pairing sym metry and the presence of nodes in the superconducting energy gap is the Point-Contact Andreev Re ection Spectroscopy (PCAR), which consists in establishing a contact between a tip of a normal metal and a superconducting sample (N {S junction}).

Recently a new compound of the cuprate family, the $RuSr_2GdCu_2O_8$ (Ru-1212) [1], has drawn great attention among theorists and experimentalists in the eld of solid state physics. Indeed, the Ru-1212 compound presents a similar structure to YBa₂Cu₃O₇, with the substitution of Cu-O chains by magnetic Ru-O₂ planes, so that coexistence of superconductivity and magnetic ordering

Our Ru-1212 sam ples were directionally solidied pellets, prepared starting from a Ru-1212 and Ru-1210 (RuSr₂GdO₆) powders mixture (in a Ru-1212/Ru-1210 = 0.2) by means of Top-Seeded Melt-Textured. The details of the preparation pro-




Fig.1.X-Ray D i raction spectrum on Ru-1212.In the inset the resistivity measurement as a function of the temperature is shown ($T_c^{on}=43~{\rm K}$, $T_{c0}=24~{\rm K}$).

cedure are reported in Ref. [6]. X-Ray di raction patterns were recorded at room tem perature using a Philips PW -1700 di ractom eter equipped with a Ni-lter for CuK radiation. The diraction patterns were collected over 2 range 5 -100 with a step of 0.05 and a time per step of 20s. A typical di raction pattern for a Ru-1212 sample is shown in Fig. 1. The only phase detectable is Ru-1212 (the main re ections are indexed) and the sample is polycrystalline. Zero-eld resistivity is shown in the inset of Fig. 1. The sample is metallic down to 90 K where a saturation in the resistivity starts to appear. This persists down to 49 K where a weak increase of the resistivity is present at temperatures just above the onset of the superconducting transition ($T_c^{on} = 43 \text{ K}$). The sample exhibits zero resistivity at a tem perature $T_{c0} = 24 \ \text{K}$.




Fig. 2. Conductance curve measured on Ru-1212/Pt-Ir point-contact junction at $T=4\,2K$ (points). This spectrum is tted by BTK model with d-wave symmetry of the order parameter (solid line). The tting parameters are: the superconducting gap, , the barrier strength Z , the angle of the order parameter and the smearing factor .

To realize our experiments we used a Pt-Irtip, chemically etched in a 37% solution of HCland in an ultrasound bath. Current-voltage (I V) characteristics were obtained and a standard lock-in technique was used to measure the dierential conductance (dI=dV V) spectra. Dierent kinds of conductance curves have been observed, majority of which exhibiting a triangular Zero Bias Conductance Peak (ZBCP) [7] with an energy width of about 10m V, as reported in Fig. 2.

The triangular structure of the ZBCP can be explored in term of PCAR Spectroscopy, however there is no possibility to model this peculiar shape by assuming an s-wave symmetry of the supercon-

ducting order param eter. Indeed we have assum ed a d-wave sym metry of the superconducting gap in a B T K modi ed model [8,9]. In a d-wave superconductor, the electron-like and hole-like quasiparticles, incident at a N {S interface, experience a different sign of the order parameter, with the consequent form ation of bound states at the Ferm ienergy. These states, named Andreev Bound States, are responsible for an increase of the tunneling conductance at zero-bias, in some case higher than 2, the theoretical limit for conventional superconductors [10].

The BTK modeldescribes the I V characteristics of a N (S junction separated by a barrier of arbitrary strength, which is modeled by a dimensionless param eter Z: varying Z one ranges from Andreev Re ection regime (small Z) to the tunneling lim it (Z 1). For an anisotropic d-wave superconductor, at the given energy the tunnel current depends both on the incident angle ' of the electrons at the N {S interface as well as on the angle of the ∞ s[2(')].It order param eter, nam ely is well known that in PCAR experiments there is no preferential direction of the quasiparticle in jection into the superconductor, so the tunneling current results by an integration over all directions inside a sem isphere weighted by the scattering probability term . M oreover since our experim ents deal

with polycrystalline sam ples, more than one grain can be touched by the tip, consequently the angle is a pure average thing parameter, which depends on the experimental conguration.

Fig. 2 shows an experimental conductance curve at $T=42\,\mathrm{K}$, with a satisfactory best ting curve. The used ting parameters are: the superconducting energy gap = 2:6 meV, the barrier strength Z=0.94, the angle = 0:45 and the smearing factor = 0:27 meV. The factor is a phenomenological parameter introduced to take into account pair breaking elects, possibly due to magnetic ordering [11]. We notice that the d-wave BTK theoretical theoretical that the change of slope occurring in the ZBCP at about $2\,\mathrm{Lm}$ meV.




Fig. 3.M agnetic eld dependence of the dI=dV V characteristics at T=42K from 0 T to 2 T. The height and the width of the conductance peak decrease for increasing magnetic eld. In the inset the zero eld conductance spectrum is reported with the best theoretical thing obtained by modi ed BTK model. The thing parameters are: = 3:0 m eV, Z = 0:9, = 0:51 and = 0:7 m eV

In the case of very highly stable junctions we studied thee ect of them agnetic eld from zero up to 2 Tesla (Fig. 3). We observed a reduction of the height of the ZBCP, but a complete suppression of the peak and/or any splitting of this feature were not observed. This behavior is a signi cant evidence that the critical eld of this sample is greater than 2 Tesla.

In the inset of Fig.3 we show the zero-eld experim ental data, norm alized by using a parabolic background, together with the d-wave best tting curve. Values of the tting param eters are: = 3:0 m eV, Z = 0:9, = 0:5 and = 0:6 m eV.W e notice that both the shape of the ZBCP the dips 5m V are correctly modeled. Moreover, around from the tem perature dependence of the conductance curves [10], we observed that the ZBCP disappears at T_c ' 30 K so excluding that the form ation of the ZBCP is due to the presence of magnetic m om ents at the barriers [12,13]. Our ndings about the use of the d-wave sym m etry in modeling the Ru-1212 are in agreement with the work by G.A.Ummarino et al. [16], however we infer a sm aller value for the energy gap.

Som e com m ents are needed about the relatively low value of the energy gap, = $(2.8 \quad 0.2)\,\text{m}$ eV and the BCS ratio 2 =K $_B\,T_C$ 2.2, signi cantly depressed in comparison with that of conventional BCS and high T_C superconductors. Moreover, the simultaneous presence, at low temperatures, of both ferrom agnetic and superconducting orders has to be taken into account. The Ru-1212 systems can be thought as a S/F multilayered

compound with alternating S/F layers along the c-axis. The two competing orders tend to mutually exclude each other, and proximity e ect in this case dram atically reduces the amplitude of the order parameter, inducing a change of sign for critical thickness of the magnetic layer [14,15]. In addition to this, by means of dierent experimental techniques, it has been proved that in the Ru-1212 system a large fraction of the charge carriers is not condensed in the superconducting state at low temperatures.




Fig. 4. Conductance curve measured on Ru-1212/Pt-Ir point-contact junction at T=4.2K. This spectrum is tted according to our model of Josephson junction in series with the point contact, with a gap amplitude = 3m eV.

In some cases, in our experiments, we have found ZBCPs with a wider energy amplitude, as reported in Fig.4. We speculate that the intergrain weak-coupling e ect in polycrystalline samples plays a fundamental role in the tunneling process. Indeed a S{N {S or S{I{S Josephson junction can be formed in series with the N {S point contact one. The measured voltage is expressed as the sum of two contributions [17], one coming from the N {S point contact (V_{PC}) and the other from the intergrain S{N {S (S{I{S}) Josephson junction (V_{J}):

The I (V) characteristics are obtained by inverting Eq. (1). We assume that the Josephson capacitance is small and write the Josephson voltage as follows:

where I_c and R_J are the critical current and the resistance of the Josephson junction, respectively.

The point-contact contribution to the total conductance is again expressed in term softhe d-wave BTK model, because an s-wave symmetry, even in presence of a Josephson junction in series, would never yield a triangular structure of the conductance curves. In Fig. 4 we present an example of experimental conductance with a wider ZBCP, with the corresponding theoretical thing according to our model of two junction in series. We observe that, the best thing parameters, shown in gure, are compatible with those used for other measured junctions, and in particular the amplitude of the superconducting energy gap (= 3.0 meV) is consistent with the estimated value by our previous d-wave things.

3. Concluding Remarks

We have performed Point-Contact spectroscopy experiments on Ru-1212 synthesized pellets and we have obtained dierent conductance curves, all characterized by a Zero Bias Conductance Peak. The conductance curves with a narrow peak were selected to estimate the magnitude of order pa-

ram eter. By thing these spectra we have inferred a d-wave symmetry of the superconducting order parameter with a maximum value of the gap am plitude = (2:8 0:2) m eV . For the spectra with wider zero bias structures we hypothesized that the granularity of the sam ples causes the form ation of a Josephson junction in series with the PC one. In this case, by using simplied model of a Josephson junction in series with the N (S point contact, wewere able to tour spectra, with a value of the order parameter in agreement with the previous results. To investigate the interplay between superconducting and magnetic orders, we followed the dependence of the conductance curves from an applied magnetic eld, concluding that the critical eld of these sam ples is greater than 2 Tesla.
