# Path Integral of the Holstein Model with a <sup>4</sup> on site potential

We derive the path integral of the sem iclassical, one dimensional anham onic Holstein model assuming that the electron motion takes place in a bath of non linear oscillators with quartic on site hard (and soft) potentials. The interplay between e-ph coupling and anham onic force constant is analysed both in the adiabatic and antiadiabatic regime. In the latter we nd much larger anham onic features on the therm odynam ic properties of low energy oscillators. Soft on site potentials generate attractive centres at large am plitude oscillator paths and contribute to the anom abus shape of the heat capacity over temperature ratio in the intermediate to low T range. This anharm onic lattice e ect is superim posed to the purely electronic contribution associated to a temperature dependent hopping with variable range inducing local disorder in the system.

#### I. IN TRODUCTION

There is at present a large interest on the e ects of a strong electron-phonon coupling in a number of systems ranging from dimermolecular junctions [1] to carbon nanotubes [2], from organicmolecular crystals [3], to DNA [4] and cuprate superconductors [5,6]. Several theoretical studies have focussed on the interplay between e-ph coupling and non linearities in the framework of the Holstein model [7,8] investigating the phase diagram both in the adiabatic [9] and the antiadiabatic regime. Mainly in the latter anhamonic e ects are believed to be large [10] thus o ering a picture to explain the high  $T_c$  of binary alloys such as superconducting M gB<sub>2</sub> with a sm all Ferm i energy and sizeable e-ph coupling [11].

The path integral form alism provides a powerful method to study quantum systems in which a particle is non linearly coupled to the environment [12{14]. A previous path integral analysis [15] has pointed out how the phonon dispersion, that has to be taken into account in the computation of the ground state properties of the H olstein H am iltonian [16{18], induces non locale-ph correlations which renormalize downwards the elective coupling and ultimately broaden the size of the polaronic quasiparticle. This explains why the polaron mass in a dispersive H olstein model [19] is lighter than in a dispersionless model [20]. A lso the therm odynam ics of the H olstein H am iltonian can be computed within a dispersive model which accounts for the lattice structure [15].

The Holstein diatom ic molecular model was originally cast [21] in the form of a discrete non linear Schrodinger equation for electrons whose probability amplitude at a molecular site depends on the interatom ic vibration coordinates. The non linearities are tuned by the e-ph coupling [22] whose strength drives the crossover between a large and a small polaron state according to the degree of adiabaticity and the dimensionality of the system [23].

In the Holstein model, the phonon therm odynam ics is not a ected by e-ph induced anharm onicities [24]. This follows from the fact that the Holstein perturbing source current is local in time and it does not depend on the electron path coordinate. As a consequence, in the total partition function, electron and lattice degrees of freedom are disentangled and the latter can be integrated out analytically as far as a harm onic lattice model is assumed. Howevernon linearities may arise in Holstein like system s also by virtue of on site potentials dependent on the lattice structure and, in principle, independent of the e-ph coupling. We are thus led to investigate the therm odynam ics of the anharm on ic Holstein model with a quartic on site potential which may be repulsive or partly attractive according to the sign of the force constant and the am plitude of the lattice displacem ent paths. The path integral approach permits to monitor the physical properties for any value of the coupling strengths [25]. The presence of a <sup>4</sup> potential may in turn a ect also the e-ph interactions and sinergically interfere on the equilibrium properties of the system. This is the focus of the present paper. Section II presents the Ham iltonian model while the path integral method is brie y described in Section III. The derivation of the total partition function of the system is presented in Section IV and Section V contains the discussion of the physical results. The conclusions are drawn in Section VI.

## II. THE ANHARM ON IC HOLSTEIN MODEL

W e consider the one dimensional anharm onic Holstein H am iltonian consisting of: i) one electron hopping term, ii) an interaction which couples the electronic density  $(f_1^y f_1)$  to the lattice displacement  $u_1$  at the l-site, iii) a bath of N identical dispersionless anharm onic oscillators with mass M and frequency !:

the sum <;> is over z nearest neighbors and t is the tight binding overlap integral. g is the e-ph coupling in units of h!. Choosing the atom ic mass M of order  $10^4$  times the electron mass, we get g ' 1:1456 g 2h! meVA <sup>1</sup> where h! is given in meV. , in units meVA <sup>4</sup>, controls the strength of the non linearities and determines whether the on site potential V (u<sub>1</sub>) = M  $!^2u_1^2=2+u_1^4=4$  is hard ( > 0) or soft

( < 0). In the latter case, V ( $u_1$ ) attains the maximum at  $u_1^2 = M !^2 = j$  j and the in ection point occurs at  $u_1^2 = M !^2 = 3j$  j. The condition j  $j_1^2 > 2M !^2$  yields an attractive on site potential. Then, the range of the atom ic path am plitudes generating attractive scattering centres depends on the value of the anharm onic force constant. For j j> 2M !<sup>2</sup> the potential becomes attractive for a portion of large am plitude atom ic paths while sm all am plitude paths weigh the repulsive range.

In the following computation of the electron path integral coupled to the anham onic oscillator, after setting the potential parameters, we select at any temperature the class of atom ic paths which mainly contribute to the euclidean action. As the distribution of the path am plitudes has a cuto on the scale of the lattice constant, say i.e.  $u_1^2 < 1A^2$ , the on site potentials are always bound from below also in the attractive cases.

# III. THE PATH IN TEGRAL METHOD

The Holstein Ham iltonian in (1) can be mapped onto the time scale according to space-time mapping techniques extensively described in previous works [15,26,27]and hereafter outlined.

Dening x ( ) and y (  $^0)$  as the electron coordinates at the land m lattice sites respectively, H  $^{\rm e}$  in (1) transform s into

where and <sup>0</sup> are continuous variables 2 [0; ], with being the inverse temperature. A fler setting <sup>0</sup> = 0, y(0) 0 and taking the therm allaverages for the electron operators over the ground state of the H am iltonian one gets the average electron hopping energy per lattice site:

where, G [x(); ] is the electron propagator at nite tem perature.

By treating the lattice displacements in (1) as dependent classical variables,  $u_1 \, ! \, u()$ , we obtain from H  $^{e \ ph}$  in (1) the averaged e-ph energy per lattice site which is identified as the perturbing source current j() in the path integralmethod:

As the Ham iltonian model assumes a set of identical oscillators we study the path integral for the electron coupled to a single anharmonic oscillator of the bath. The path integral reads:

where the kinetic term (m  $_{\rm e}$  is the electron m ass) is norm alized by the functional measure of integration over the electron paths.

Since the electron hopping does not induce a shift of the oscillator coordinate the Holstein e-ph interactions are local in time and, in the sem iclassical treatment, the source current j() is independent of the electron path. As a consequence oscillator and electron coordinates appear disentangled in (5) while the coupling occurs through the parameter g.

## IV.THE PARTITION FUNCTION

The quantum statistical partition function  $Z_T$  is derived by integrating (5) after in posing periodicity conditions, is the period, both on the electron and oscillator paths:

The cuto s over the Fourier coe cient integrations have to ensure proper norm alization of the kinetic term in absence of hopping processes. Thus  $\rm Z_{el}$  transforms into

with  $/ m_{e}$  [27] indicating that large amplitude electron paths have to be selected at low tem peratures where the quantum e ects are larger. Two Fourier components,  $M_{F} = 2$ , su de to attain stable results as  $h^{e}(x())$  depends sm oothly on the electron path. The hopping temm accounts for the deviation from the G aussian behavior. Numerical analysis shows that, for any choice of path parameters,  $h^{e}(x())$  decreases by decreasing the temperature but its overall contribution to the electron action is substantial also at low T.

Let's focus now on the anharm onic oscillator term Z  $_{\rm osc}$  . The oscillator path is expanded in N  $_{\rm F}\,$  Fourier components

with M atsubara frequencies  $!_n = 2n =$  and coe cients  $a_n < u_h$ ,  $b_h = u_i$  satisfying the conditions  $a_n = a_n$  and  $b_h = b_n$ . The latter are consistent with the choice of real paths and simplify the following integration of the on site potential.

Note that the periodicity property, u() = u(+), would be fulled also taking the very  $a_n$  coe cients in (10) [28]. However such a choice would not permit to t with accuracy the harmonic oscillator partition function which is known exactly:  $Z_h = 2 \sinh(!=2)^{-1}$ . Infact, in the path integralm ethod, the harmonic partition function  $Z_h^{PI}$  reads

Instead, dropping the  $b_{\rm h}$  term s in (10) and (12), one would get the square root of the product series in (13) which does not yield a reliable tof  $Z_{\rm h}$  even for large  $N_{\rm F}$ . Note that at high T, the condition 2n  $\,$ ! is fullled for small integers n, hence the main contribution to  $Z_{\rm h}^{\rm P~I}$  is given by the 1= ! factor which stem s from the duo in (12). This is consistent with the expectation that high T paths are well approximated by their -averaged value  $u_{\rm o}$  whereas uctuation e ects become e increasingly relevant towards the low T regime in which  $N_{\rm F}$  rapidly grows. N  $_{\rm F}$  clearly varies also with the oscillator energy while the shape of N  $_{\rm F}$  (!;T) may di er according to the harm onic function ( $Z_{\rm h}$ , harm onic free energy or speci c heat) one chooses to t.

The anham onic partition function  $Z_{osc}$  in (6) can be worked out analytically using (10),(12) and performing the time integration of the oscillator functional O (u ( )). This permits to get an insight into the role of the non linear terms. The lenghty calculation yields:

Note that the elective e-ph coupling g is associated only to the  $-independent \mod ponent u_0$ , that is to the -averaged displacement path [15]. This follows from the fact that the perturbing source current is non retarded in the Holstein model as a consequence of the local nature of the e-ph interaction.

The quartic potential induces a strong m ixing of the Fourier components of the path that highly complicates the num erical problem . Thus the value of N  $_{\rm F}$  appears to be crucial in the computation. We determ ine N  $_{\rm F}$  (!;T) by tting (with an accuracy of 2  $10^2$ ) the exact harmonic free energy (F  $_{\rm h}$  =  $\ln$  (Z\_h) = ), through the path integral harmonic free energy F  $_{\rm h}^{\rm P~I}$  obtained from (13). As an example, for the oscillator with ! = 20m eV, N  $_{\rm F}$  (T = 10K ) = 59 and N  $_{\rm F}$  (T = 200K ) = 8.

Inspection of (14) o ers the key to perform reliable path integrations according to the sign of the <sup>4</sup> potential. At high tem perature, a large contribution to Z<sub>osc</sub> is expected to come from the paths having  $u_o$  which maximizes exp  $f(u_o)$  with  $f(u_o) =$  $(au_0 + u_0^2 + bu_0^4); a$ q= ; b =4. In general, we nd that for a hard (soft) potential, the duo-integration has to be carried out along the  $u_{\circ}$  < 0 ( $u_{\circ}$  > 0) axis, with cuto  $0:6^{\frac{p}{2}}$ . This perm its to include the set of ju<sub>o</sub> j<sub>nax</sub> paths which mainly contribute to the euclidean oscillator action. On the Fourier coe cients integrals,  $da_n db_n$ , we set the cuto s  $ja_n j_{nax}; j_n j_{nax} 0:6 = \frac{1}{n}$  both for hard and soft potentials thus achieving num erical convergence and correct computation of the Gaussian integrals once the non linearities are switched o . It turns out, see the de nitions in (14), that the cuto s on the oscillator path integration are increasing functions of tem perature T) consistently with the physical expectations of large am plitude displacem ents at high T. As the path displacements encounter an upper lim it due to the cut $j_{a}j_{ax} + 2 \sum_{n=1}^{P} j_{an} j_{ax}$ , the distribution o s, u( ) of on site potentials has a lower lim it also in the case of soft and attractive non linearities. This avoids num erical divergences and makes the problem physically meaningful.

### V.RESULTS

W e test the relevance of the non linearities on the equilibrium therm odynam ics of the system and present the calculation for the heat capacity in the interm ediate to low tem perature range.

Figures 1 show the behavior of a low energy (! = 20 meV) oscillator without (g = 0) and with (g =

2;4) coupling to the electronic subsystem in the adiabatic regime: t=! = 5. Figs.1(a),(b) assume an anham onic potential with positive quartic force constant

=  $10^3$ ;  $10^4$  m eV A <sup>4</sup> respectively. A lso the harm onic heat capacity is reported on for comparison. The hard potential lifts the free energy over the harm onic values with a more pronounced enhancement at increasing T and for larger . The e ect on the free energy second derivative is how ever scarce and essentially consists, see Fig.1(a), in a slight increase (decrease) of the heat capacity at low (high) tem peratures. The reduction of the heat capacity (with respect to the harm onic plot) at interm ediate and high T is more evident in Fig.1 (b) where the quartic force constant is larger. This result is in accordance with diagram matic perturbative treatments of the anham onic crystals which predict negative contributions to the constant volum e speci c heat arising from positive force constants in the quartic potential [29,30]. The e-ph coupling strength also tends to decrease the oscillator heat capacity but the overall e ect is sm all as the insets in the gures show : infact the electronic term dom inates the total heat capacity C and the oscillator contribution is not distinguishable in the plots of the C over tem perature ratios versus T. The low tem perature uptum is due to the large electron energy term in (9) and precisely ascribable to the feature of the variable range (on the scale) of the electron hopping, captured by the path integral form alism [27].

The cases of a soft on site potential are reported on in Fig.1(c) with =  $1 \text{dm} \text{ eVA}^4$  and Fig.1(d) with =  $1 \text{d}^4 \text{ m} \text{ eVA}^4$ . The characteristic potential parameter is M  $!^2 = j j'$  0.5 and 0.05A<sup>2</sup>, respectively. The potential V (u()) = M  $!^2$ u( $j^2 = 2 + u(j^4 = 4)$  is attractive for those paths such that u( $j^2 > 2M !^2 = j j$ .

At any T, we integrate over a distribution of time dependent potentials. Thus, at a given lattice site, the electron may experience an attractive or repulsive scattering centre according to the size of the atom ic path. As an example, at T = 200K, we get a maximum path  $u_{max}$  such that  $u_{max}^2$   $0.15A^2$ . This guarantees that V (u()) is generally repulsive in Fig.1 (c) and attractive for a broad class of paths in Fig.1 (d).

The e ects on the oscillator heat capacity are twofold: i) the soft potential enhances the heat capacity mainly in the low T range with respect to the hard potential and this feature is much more pronounced in Fig.1 (d); ii) the trend of the e-ph coupling is opposite to that observed in Figs.1 (a), (b): now by increasing the g values one gets higher heat capacities although the size of this e ect is sm allon the scale of the electronic terms in the adiabatic regim e as revealed by the C =T plots in the insets.

Let's come to the antiadiabatic regime (t=! = 0:5) discussed in Figures 2, where a low harmonic energy (! = 10m eV) is assumed to emphasize the size of the anharmonicity together with a very narrow electron band. A hard on site potential with =  $10^3 \text{m eV A}^4$  is taken in Fig.2 (a): the shape of the oscillator heat capacity signals the elects of the non linearities which atten the curve at

interm ediate T and enhance the heat capacity also at low T with respect to the corresponding case of Fig.1 (a). As the D ebye tem perature is now smaller (than in Fig.1 (a)) the hard anharm onicity decreases the constant volume heat capacity with respect to the harm onic plot over a broader tem perature range.

The e-ph coupling plays a m inor role also in antiadiabatic conditions. The anham onic contribution is visible in the total heat capacity as the inset m akes evident although the dom inant electronic feature persists in the low T uptum of C=T. In Fig.2 (b), we assume g = 2and consider two cases of soft potential: the oscillator anham onicity becomes relevant and such to m odify the shape of the anom alous uptum in the total heat capacity. An enhancement of the C=T values is observed at intermediate and low T and, in the case of the largest j j generating a soft attractive potential, the oscillator heat capacity C<sub>osc</sub> yields an uptum in C<sub>osc</sub>=T independently of the electronic term.

### VI.CONCLUSIONS

W e have studied the path integral of the one dim ensionalnon linear Holstein model in which a set of dispersion less oscillators provides the environm ent for the electron. The model is sem iclassical as the lattice displacem ents are treated classically while the electron operators are therm ally averaged over the ground state Ham iltonian. The e-ph coupling of the model is local and generates a perturbing current which linearly depends on the oscillator path am plitude u() where is the time (or inverse tem perature) of the M atsubara G reen functions form alism. The anharm on icity on the lattice site is modelled through a <sup>4</sup> potential that may result attractive for a set of displacem ent paths in the case of a negative quartic force constant (soft potential). We have derived the path integral of the interacting system and computed the total partition function selecting, as a function of the tem perature (T 200K), both the electron and oscillator paths which yield the largest contribution to the action. W hile quantum electron paths have increasing am plitudes at decreasing tem peratures, the atom ic displacem ents are growing functions of T. This relevant physical feature is accounted for in our model as the cuto s on the electron path integration are proportional to the electron therm alwavelength whereas, on the atom ic path integration, we nd cuto sproportional to T.

The oscillator partition function includes the e ect of the coupling to the electron subsystem but the on site anharm onicities play a major role mainly when the potential is soft and the harm onic energy is low. A mong the therm odynam ic properties we have chosen to present the heat capacity C in view of the uptum in the C=T behavior due to the low T electron hopping tuned by the value of the overlap integral in the Ham iltonian model. The com putation is highly tim e consum ing especially because of the strong m ixing of the path Fourier com ponents generated by the non linear potential.

In general we nd that: i) in the case of a hard quartic potential, sw itching on the e-ph coupling leads to lower the free energy and its second derivative, ii) when the quartic potential is soft, e-ph coupling and anharm onicity act sinergically enhancing the therm odynam ic functions.

These results can be understood on general physical grounds. Infact, a hard quartic potential shifts the characteristic phonon frequency upwards thus hardening the spectrum and broadening the size of the quasiparticle. If the e-ph coupling is enhanced (independently of the on site anham onicity) the magnitude of the source which causes the lattice distortion becomes larger. This further hardens the vibrations and leads to decrease the anharm onic heat capacity over the whole temperature range. Instead, when the quartic potential is soft the phonon frequency is lowered and the oscillator potential well is m ore exible. In this case, larger e-ph coupling strengths favour the self-trapping of quasiparticles with heavier effective m asses. This is physically equivalent to soften the phonon spectrum and enhance the heat capacity.

The electron contribution to the heat capacity is dom inant in the adiabatic regim e whereas antiadiabatic systems are expected to present signi cant anharm onic corrections. Infact, in the antiadiabatic regime the quasiparticle is a small size object on the lattice scale and the electron energy associated with the overlap integral is small. Thus, this regime proposes a physical picture in which the electron hardly hops from site to site and its e ective mass becomes heavier on the scale of the atom ic mass. But a potential well generated by "lighter oscillators" is more sensitive to on site anharm onic e ects.

In particular, soft potentials increase the heat capacities over the harm onic values and reinforce the uptum in the C=T versus T plots when the on site anharm onicity is such to produce attractive potentials for a set of lattice displacement paths. Since the path amplitudes are larger at high T, soft attractive potentials induce rapidly increasing phonon heat capacities at growing T as shown in Fig.2 (b).

Thus our path integral investigation and the therm odynam ical results point to a complex role of the lattice anharm onicities in the one dimensional Holstein model and suggest that on site potentials may be experienced as attractive or repulsive according to the temperature and the amplitude of the atom ic path. Such potentials may provide scattering centres generating local disorder whose e ect on the system therm odynam ics is superim posed to the disorder induced by the hopping of electrons with variable range.
