Relativity, nonextensivity, and extended power law distributions

A proof of the relativistic H -theorem by including nonextensive e ects is given. As it happens in the nonrelativistic limit, the molecular chaos hypothesis advanced by Boltzmann does not remain valid, and the second law of them odynamics combined with a duality transformation implies that the q-parameter lies on the interval [0,2]. It is also proved that the collisional equilibrium states (nullentropy source term) are described by the relativistic q-power law extension of the exponential Juttner distribution which reduces, in the nonrelativistic domain, to the T sallis power law function. As a simple illustration of the basic approach, we derive the relativistic nonextensive equilibrium distribution for a dilute charged gas under the action of an electrom agnetic eld F. Such results reduce to the standard ones in the extensive limit, thereby showing that the nonextensive entropic fram ework can be harm onized with the space-time ideas contained in the special relativity theory.

In the last few years, a great dealof attention has been paid to the nonextensive T sallis entropy both from theoretical and observational view points [1, 2, 3, 4]. Recent applications of the nonextensive entropy to an increasing number of physical problem s is beginning to provide a m ore de nite picture on the kind of scenarios where the new form alism proves to be extrem ely useful [3-13].

At present, self-gravitating systems and plasma physics o er the best fram ework for searching to nonextensive e ects. The rst one is characterized by very strange kinetic and therm al properties (see [5] for recent publications on this topic). A ctually, collisionless stellar systems like galaxies are endowed with negative specic heat, and the simplest density pro les based on the Maxwellian distribution lead to in nite mass (the so-called singular isotherm al sphere). In the case of plasm as, Boghosian's treatm ent for a two dim ensional pure electron plasm a yielded the rst experimental con rm ation of T sallis theory [6], whereas experiments related to dispersion relations for electrostatic plane-wave propagation also points to a class of power law T sallis velocity distributions [7]. In reality, it is now widely believed that the nonequilibrium properties of such system s away from Boltzmann-Gibbs state are not completely understood [8]. This nonextensive statistical form alism also proved to be an useful construct for the analysis of many interesting properties of linear and nonlinear Fokker-Planck equations [9].

On the other hand, most of the observational or experimental evidence supporting T sallis proposal are related to the power-law velocity distribution associated with T sallis therm ostatistical description of the classical N-body problem [10]. For a dilute gas of massive point particles, the nonextensive e ects are simply parameterized by the local entropy density form ula

where k_B is the Boltzmann constant, f is the distribu-

tion function, ${\bf q}$ is the nonextensive parameter and the ${\bf q}\mbox{-logarithm}$ ic function is de ned by

$$\ln_q f = (1 \ q)^{\perp} (f^{\perp q} \ 1); \quad (f > 0)$$

which recovers the standard Boltzm ann-G ibbs entropy $S = k_B f \ln f d^3p$ in the lim it q ! 1. In the nonrelativistic lim it, the time evolution of S_q was analyzed with basis on the Liouville and Fokker-P lanck equations [11], as well as through a nonextensive generalization of the nonrelativistic Boltzm ann H -theorem [12, 13].

As rst recognized by Lin a et al. [12] (hereafter paper I), the attem pts for extending Boltzm ann kinetic theory by including nonextensive e ects, which basically m eans a q-transport equation and the associated H -theorem, required a departure from the celebrated m olecular chaos hypothesis rst advanced by Boltzm ann. In this connection, it is worth notice that the q-Boltzm ann equation of paper I di ers from the one proposed by K aniadakis [14], an approach based on the kinetic interaction principle, only by the assumed form of the collision integral.

Theoretically, beyond the applications closely related to the nontrivial solutions of the nonrelativistic qtransport equation and the associated transport coe cients [7], it is clearly necessary to go one step further, by extending the proof of H -theorem to the relativistic and quantum domains. The basic reasons are very wellknown, and have partially guided the developm ent of m odem physics [15]. A ctually, in the case of the M axwell-Boltzm ann distribution, this basic program has already been performed in detail to special relativity [16], quantum theory [17], as well as, by including the gravitational interaction, to the context of general relativity theory [18]. In particular, the collisional equilibrium of a relativistic gas of massive point particles is described by the Juttner distribution function which contains the number density, the tem perature, and the local 4-m om entum as free param eters [15, 16].

In this letter, the nonrelativistic q-B oltzm ann equation

and the H -theorem discussed in paper I are extended to the special relativistic domain through a manifestly covariant approach. As we shall see, the whole argument follows from a direct generalization of the molecular chaos hypothesis and the expression of the 4-entropy ux in the spirit of the nonextensive T sallis prescription. The leitmotiv of this article is to shown that the kinetic nonextensive approach can also be harm onized with the space-time ideas contained in the special relativity theory.

To begin with, we recall that the proof of the standard relativistic H -theorem is also based on the molecular chaos hypothesis (Stosszahlansatz), i.e., the assum ption that any two colliding particles are uncorrelated. This means that the two point correlation function of the colliding particles can be factorized

or, equivalently,

$$\ln f(x;p;p_1) = \ln f(x;p) + \ln f(x;p_1);$$

where the particles have 4-m om entum p = (E = c; p) $x = (ct; r)_p of the space-time,$ in each point x with their energy satisfying $E = c = \frac{1}{p^2 + m^2 c^2}$ (in the above expressions, p and p_1 , are the 4-m om enta just before collision). In what follows, we shown that the relativistic nonextensive entropic measure is consistent with a slight departing from \Stosszahlansatz" (m olecular chaos) when exact correlations are introduced. Operationally, this means that one must replace the logarithm functions appearing in (4) by their nonextensive counterpart which are represented by the q-logarithm ic (power laws) de ned by (2). It should be recalled that the validity of the chaos molecular hypothesis still remains as a very controversial issue [19]. Probably, the unique consensus is that it is by no means a consequence of the laws of mechanics, and, as shown in paper I, the \Stosszahlansatz" is not responsible by the irreversible content of the Boltzm ann approach.

Let us now consider a relativistic rari ed gas containing N point particles of mass m enclosed in a volum e V, and under the action of an external 4-force eld F. From a kinetic viewpoint, the states of the gas must be characterized by a Lorentz invariant one-particle distribution function f(x;p). By de nition, the quantity $f(x;p)d^3xd^3p$ gives, at each time t, the number of particles in the volume element d^3xd^3p around the particles space-time position x and m om entum p. By taking into account the nonrelativistic treatment (see [12]), one m ay assume that the tem poral evolution of the relativistic distribution function f(x;p) is driven by the following q-transport equation

where the index take the four values 0,1,2,3, while $0 = (c^1 \theta_t; r)$ indicates di erentiation with respect to

tim e and space coordinates, respectively, and C $_{\rm q}$ denotes the relativistic q-collisional term . Note that the lefthand-side of (5) is just the total derivative of the distribution function or the \stream ing term ". This means that the nonextensive e ects can be manifested only through the collisional term which is a local slow ly varying function of f(x;p). The collision integral, $C_q(f)$, must be consistent with the energy, m om entum, and the particle number conservation laws, and its speci c structure must be such that the standard result is recovered in the lim it q! 1. At this point, it is interesting to compare the approach developed here which is based on equation (5) with the one proposed by Lavagno [26]. In the latter work, all the nonextensive e ects are quantied by assum ing a modi ed Boltzm ann equation to the quantity f^q (see Eq. (13) of the quoted paper). In particular, this means that such theories must lead to di erent predictions of the physical quantities, as for instance, the expressions for the transport coe cients.

Now, since $C_q(f)$ leads to a nonnegative local qentropy source, that is, $_q(x)$ @ S_q , where S is the 4-entropy ux (an identically vanishing quantity for equilibrium states), its general form reads

where d is an element of the collision solid angle, the $\frac{\text{scalar F}}{(p \ p_1)^2 \ m^4 c^4}$, and is the di erential cross section of the collision $p + p_1 \ p^0 + p_1^0$ (see R ef [15] for m ore details). All quantities are de ned in the centre-ofm ass system of the colliding particles. In a point of fact, relativity enters only in the de nition of F, and in plicitly through the di erential cross-section . The quantity $R_q (f; f^0)$ is a di erence of two correlation functions which are assumed to satisfy a q-generalized form of the molecular chaos hypothesis expressed as [12]

$$R_{q}(f;f^{0}) = e_{q}(f^{0q^{1}} \ln_{q} f^{0} + f^{0q^{1}}_{1} \ln_{q} f^{0}_{1})$$
$$e_{q}(f^{q^{1}} \ln_{q} f + f^{q^{1}}_{1} \ln_{q} f_{1});$$

where primes refer to the distribution function after collision. Note that in the lim it q! 1 the above expression reduces to $R_1 = f^0 f_1^0 \quad ff_1$, thereby showing that the molecular chaos hypothesis is readily recovered. Sim ilarly, the nonextensive 4-entropy ux reads

$$S_{q} = k_{B} c^{2} p f^{q} \ln_{q} f \frac{d^{3}p}{E};$$

and as should be expected, $c^{1} S_{q}^{0}$ is just the local T sallis' entropy density as given by (1). Now, in order to obtain the source term, we rst take the 4-divergence of S_{a}

$$S_q = k_B c^2 (qf^{q-1} \ln_q f + 1)p \ 0 \ f \frac{d^3 p}{E};$$

and combining with the nonextensive relativistic Boltzm ann equation (5), one m ay rew rite the above expression in the following form

$$_{q} = \frac{k_{B}c^{3}}{2} F (qf^{q-1} \ln_{q} f + 1)R_{q}\frac{d^{3}p}{E}\frac{d^{3}p_{1}}{E_{1}}d : (10)$$

At this point, it is convenient to rewrite q in a more symmetrical form by using some elementary symmetry operations which also take into account the inverse collisions. First we notice that by interchanging p and p_1 the value of the integral is preserved. This happens because the scattering cross section and the magnitude of the ux are invariants [15]. In addition, the value of $_{\rm q}$ is not altered if we integrate with respect to the variables p⁰ and $p_1^0\,\text{.}$ Actually, although changing the sign of $R_{\,\rm q}$ in this step (inverse collision), the quantity $d^3pd^3p_1=p^0p_1^0$ is also a collisional invariant [15]. Finally, as we have done in paper I, we apply a \duality" transform ation (see discussion below and Ref. [21]) of the form $f^{q 1} \ln_q f = \ln_q f$, where the new nonextensive parameter is related to the old one by q = 2 q. As one may check, such considerations imply that the q-entropy source term can be written as

$$_{q}(x) = \frac{qk_{B}c^{3}}{8}^{L} F (\ln_{q} f^{0} + \ln_{q} f_{1}^{0} \ln_{q} f \ln_{q} f_{1})$$

This is our main result, and the reader should compare it with the nonrelativistic expression deduced in paper I.As widely known, the irreversible nature of therm odynamics emerging from molecular collisions is recovered if the above quantity is positive de nite. In the present case, such a condition can be guaranteed in two steps. First, we notice that the integrand of

is always positive for any pair of distributions $(f; f_1)$ and $(f^0; f_1^0)$. This means that the sign of the 4-entropy source is now completely determined by the sign of the nonextensive parameter. Therefore, if the second law is to be obeyed [15, 20], the values of this parameter must be restricted to q 0. In other words, when q < 0, the relativistic q-entropy source of a given volume element decreases in the course of time. Note that the boarder case (q = 0) seem sto be physically meaningless, since the entropy is constant regardless of the solution obtained from the transport equation with a non-null collision integral. In this concern, one may ask if the q parameter is limited from above. As one may check, repeating all the

calculations present until now with a duality transform ation, i.e., by taking q = 2 q in T sallis entropy, Eq. (1), it is easy to conclude that q > 0. Therefore, the duality transform ation together with the relativistic H – theorem in ply that q is constrained on the interval [0,2] (as rst pointed out by K arlin et al. [21], such a result is also valid in nonrelativistic theory [12]). In particular, this means that the upper bound of q, i.e. q < 2 is not a purely quantum mechanics restriction, as recently claim ed in the literature [22].

In order to complete the proof of the theorem, let us now derive the nonextensive Juttner distribution. Such a function is the relativistic version of the q-power T sallis distribution [10, 12], and must be obtained as a natural consequence of the relativistic H -theorem. As happens in the classical case, $_q = 0$ is a necessary and su cient condition for local and global equilibrium. Since the integrand appearing on the expression of $_q$ must be positive de nite, this occurs if and only if

$$\ln_{q} f^{0} + \ln_{q} f_{1}^{0} = \ln_{q} f + \ln_{q} f_{1}; \qquad (13)$$

where the 4-m om enta are connected through a conservation law ($p + p_1 = p^0 + p_1^0$) which is valid for any binary collision. Therefore, the above sum of q-logarithm s remains constant during a collision. It is a sum mational invariant. In the relativistic case, the most general collision invariant is a linear combination of a constant plus the four-momentum p [15]. Consequently, we must have

$$\ln_q f^0(x;p) = (x) + p;$$
 (14)

where (x) is a scalar, a 4-vector, and p is the fourm om entum. A fler simple algebra, we may rewrite (14) as a relativistic nonextensive distribution

$$f^{0}(x;p) = [1 (1 q)((x) + p)]^{1-1}q; \quad (15)$$

with arbitrary space and time-dependent parameters (x) and (x). The above expression is the relativistic version of the q-T sallis distribution [12]. The function $f^0(x;p)$ is the most general expression which leads to a vanishing collision term and entropy production, and reduces to Juttner distribution in the lim it q ! 1. How-ever, it is not true in general that $f^0(x;p)$ is a solution of the transport equation. This happens only if f^0 also m akes the left-hand-side of the transport equation (5) to be identically null. Nevertheless, since (15) is a power law, the transport equation implies that the parameters (x) and (x) m ust only satisfy the constraint equation

The nonextensive distribution of the form (15), with the speci c parameters obeying the above equation, describes the relativistic (nonextensive) local equilibrium states.

For illustration purposes, let us now consider a relativistic gas under the action of the Lorentz 4-force F(x;p) = (Q = mc)F(x)p; where Q is the charge of the particles and F is the M axwell electrom agnetic tensor. Following standard lines, it is easy to show that the local equilibrium function in the presence of an external electrom agnetic eld reads

$$f(x;p) = 1 (1 q) - \frac{[p + c^{1}QA(x)]U}{k_{B}T} ;$$

where U is the mean four-velocity of the gas, T (x) is the temperature eld, is the G ibbs function per particles, and A (x) the four potential. Note that the above expression in the lim it q ! 1 reduces to the well known expression [15, 24]

$$f(x;p) = \exp \frac{[p + c^{1}QA(x)]U}{k_{B}T}$$

Sum m arizing, we have proposed a q-generalization of the relativistic Boltzm ann's equation and the associated H -theorem along the lines of T sallis' nonextensive kinetic theory. We have found that the nonextensive ideas can be consistently extended in order to incorporate the spacetime concepts of the special relativity. In addition, since the basic results were derived in a manifestly covariant way, their generalization to the general relativistic fram ework can be readily accom plished.

It is worth notice that the relativistic counterpart of the H -theorem constrains the physically allowed values for the q-parameter (as it occurs in the Newtonian regime), and its proof also does not require the \Stosszahlansatz" (m olecular chaos) Boltzm ann assum ption. By the reasons discussed before, the q-nonextensive contributions must appear explicitly only in the collisional term of the q-transport equation, and, as such, the approach followed here di ers profoundly from another attempts to generalize the Boltzmann equation within the spirit of T sallis' fram ework [25, 26]. A s should be expected, the relativistic class of q-distributions reduce to the standard Juttner result in the extensive lim it q = 1. However, di erent from the extensive M axwell-Boltzmann-Juttner approach, correlations are extremely relevant in the nonextensive context (see also paper I), and, more important, the corresponding modications in the collisional term are consistent with the standard law s of microscopic dynamics. A s we have shown, such correlations are exactly described and form the physical basis of the nonextensive H -theorem either for the relativistic and nonrelativistic regimes.

It should be stressed that the combination of the relativistic H -theorem and duality transformation [21] restricted the q-parameter on the range, [0,2], which is exactly the same result of the nonrelativistic quantum dom ain [22] and of the consistent fram ew ork for generalized satistical mechanics [23]. It should be noticed, however, that the allowed range of q m ay be even sm aller if one takes into account the nite norm alization condition and the negativeness of heat capacity. In the nonrelativistic regime, for instance, it has been shown that q must be smaller than 5/3 [5, 27, 28]. Finally, two points to be noted here and explored in the near future are the possible connection between the relativistic nonextensive function and the kappa-distributions [29], and the search to the expressions of the q-relativistic transport coe cients [30].
