A daptive R esolution M olecular D ynam ics S im ulation: Changing the D egrees of Freedom on the F ly

W e present a new adaptive resolution technique for e cient particle-based multiscale molecular dynamics (MD) simulations. The presented approach is tailor-made for molecular systems where atom istic resolution is required only in spatially localized domains whereas a lower mesoscopic level of detail is su cient for the rest of the system. Our method allows an on-the-y interchange between a given molecule's atom ic and coarse-grained level of description, enabling us to reach large length and time scales while spatially retaining atom istic details of the system. The new approach is tested on a model system of a liquid of tetrahedral molecules. The simulation box is divided into two regions: one containing only atom istically resolved tetrahedral molecules, the other containing only one particle coarse-grained spherical molecules. The molecules can freely move between the two regions while changing their level of resolution accordingly. The coarse-grained and the atom istically resolved system s have the same statistical properties at the same e physical conditions.

I. IN TRODUCTION

M any problem s in com plex soft m atter system s are inherently multiscale in nature, i.e., microscopic interactions are coupled strongly to mesoand m acroscopic properties. Despite the increasing computational power and ongoing e orts to enhance the e ciency of molecular dynamics (MD) integration algorithm s[1, 2, 3, 4, 5, 6], all-atom MD simulations are often incapable to cover the tim e and length scales needed in order to reach relaxation in a typical molecular system, such as a polymer solution or melt. In many cases it is also questionable, whether the huge am ount of detail information might not even obscure the relevant structural inform ation. On the other hand, details of the chem istry do not a ect universal power laws but the prefactors of these power laws, which can vary by several orders of m agnitude them selves. Thus even on the more coarse-grained level it is advisable to keep a link to the speci c chem istry under investigation [7, 8]. In addition typical soft matter systems can be quite inhom ogeneous in a way, that di erent regions within one system are su ciently described by more or less detail. A consistent and at the same time highly e cient ansatz to understand m odern soft m atter system s (both of synthetic as well as biological origin) has to take such considerations into account. One st way to tackle this, was to reduce the num ber of degrees of freedom by a system atic coarse-graining, which retains only those degrees of freedom that are relevant for the particular property of interest. E xam ples of m olecular system s where the coarsegraining approach has been used with much success are uids[9], lipid bilayers [10, 11, 12, 13, 14], and polym er system s[15, 16, 17, 18].

Since som e speci c chem ical details are usually lost in the coarse-graining procedure, much e ort has been devoted recently to the developm ent of multiscale modeling approaches, where di erent parts of the system are modeled at di erent levels of detail to account for the local resolution requirem ent[19, 20, 21, 22, 23, 24]. In the dualresolution m odeling approach for studying the behavior of polymers near metal surfaces [22, 23, 24], for example, polymer chain ends that interact with the m etal surface are represented partially atom istically while the remaining parts of the polymers, where low er resolution is adequate, are represented as bead-spring chains. However, the switching between di erent levels of resolution, ie, the atom ic and m esoscopic, is not allow ed during the course of that MD simulation, and therefore the initial level of detail and thereby the num ber of degrees of freedom in the system remain unchanged. Since the chain ends that interact with the metal typically remain close to the surface and they only contain a sm all fraction of the whole system, an adaptive on-the- y change of the molecules' resolution is not strictly required for this class of system s. Another approach reported in the literature concerns the link between quantum mechanical and classical M D simulations. In this Q M /M M approach a small subset of the system is de ned and considered as quantum mechanical, while the rest is

treated by a classical force eld simulation. Here the atom s as well as the regions of the dierent regimes are xed from the very beginning [25], restricting the application to rather species.

In contrast, M D simulations, in which the spatially localized atom istic dom ains frequently exchange particles with the remaining mesoscopic part of the system, would allow for much wider applications. Then it would be possible to de ne certain areas or develop criteria for certain situations, which ask for a more detailed view, while the rest of the system can be treated on the more coarse-grained level. It is the purpose of this paper to present a rst attempt of an MD simulation of that kind. Because of that we here at st restrict ourselves to a most elementary model system. Of course one also could resort to M onte Carlo simulations, where di erent levels of detail are combined. This actually would be somewhat simpler because of the purely stochastic nature of this simulation method. Since we are eventually aiming at molecular systems, where collective motions are crucial, we decided to stick to the MD approach. Existing hybrid MD methods that concurrently couple di erent length scales have been developed to study solid state system s, where atom istic MD was either combined with the nite elements method [26, 27, 28] or it was linked to a quantum mechanicalm odel[29]. To our know ledge, how ever, in pursuit of this objective no adaptive hybrid atom istic/m esoscale particlebased M D m ethod, which would allow to dynam ically adjust the level of detail, which means the adjustment of the degrees of freedom in the system, has been developed so far.

In this paper we present a novel adaptive resolution M D scheme that com bines a full atom istic description of a desired region of the system with a mesoscale treatment of the remaining part. The key feature of the new method is that it allows to dynamically adapt the level of a given molecule's resolution according to its position in the system. Hence, the number of degrees of freedom is not a conserved quantity in our M D simulations. Furthermore, the presented method is not restricted to couple only the atom istic and mesoscopic levels of detail but can also be applied to system swith mesoscopic domains that are described at di erent levels of coarse-graining. Here we present a

rst test case, showing that such an approach is feasible. Therefore the new approach is tested for a simple model liquid consisting of tetrahedral molecules. The simulation box is divided into two regions: one containing "atom istically" resolved tetrahedralm olecules, the other containing coarse-grained sphericalm olecules. M olecules are allowed to freely m ove between the two regions while changing their level of resolution accordingly. The results show that the statistical properties of the corresponding fully atom istic system are accurately reproduced by using the proposed hybrid scheme. In particular, gradients in the chem ical potential across the articial interface where the resolution changes and corresponding spurious uxes can be avoided. A lthough we applied the new m ethod here to a generic test system it should

nd application in more realistic physical system s. There has been an initial attempt reported in R ef. [30], where M D simulation of an inhom ogeneously coarse-grained system of liquid methane has been described. There the starting point were two established models for methane, a ve site atom istic and a one site spherical where the interaction between molecules of di erent species was derived by standard Lennard-Jonesm ixing rules with the hydrogens of the atom istic invisible to the spherical molecules. In this case it turned out that an effective ux between the two di erent regimes occurred. This e ect is partially due to the di erent equilibrium state points described by the two models, but in any case in that approach no effective potential between coarse-grained m olecules was derived. Our approach di ers from that since here we derive such potentials in such a way that the two regimes are in true therm odynam ic equilibrium .

The organization of the article is as follows. In section 2 the methodology is presented, whereby in the rst step a coarse-grained model is derived and parameterized from a fully atom istic system and then, in the second step, the atom ic and mesoscopic length scales are system atically coupled in a hybrid atom istic/mesoscopic model. The computational details are given in section 3. The results and discussion are presented in section 4, followed by conclusions in section 5.

II. M ETHODOLOGY

In this section, the model system s are described and the methodology for the adaptive multiscale M D simulations is presented.

M odels

All-Atom Model

First, we introduce our reference explicit allatom (ex) model. Consider a system of n tetrahedralm olecules consisting of N = 4 atom s of the sam e m ass m₀ connected by anharm onic bonds as presented in gure 1 (a) (consider only the right red molecule).

All atoms in the system interact according to a purely repulsive shifted 12-6 Lennard-Jones potential with a cuto at 2^{-6} :

where $r_{i\ j}$ is the distance between the atom i of the molecule and the atom j of the molecule . We use " as a unit of energy. All atoms have the same excluded volume diameter, where is the unit of length. The neighboring atoms in a given molecule are linked via an attractive FENE potential

with divergence length $R_0 = 1.5$ and sti ness k = 30"=², so that the average bond length is approximately 1:0 for $k_B T =$ ", where T is the temperature of the system and k_B is Boltzmann's constant. The functional form of these potentials and their parameters are the same as usually em – ployed in polymer MD simulations[15].

Coarse-Grained Model

Next, we map the atom istic model to a coarsegrained (cg) mesoscopic model. For the latter we have chosen a system composed of none-particle molecules schematically depicted in gure 1 (a) (consider only the left blue molecule). A given coarse-grained molecule in the system has a mass $M = 4m_0$ equal to the total mass of the explicit tetrahedral molecule. All rotational and vibrational degrees of freedom of atom istically resolved tetrahedral molecules are thus removed, and the num ber of nonbonded interactions is strongly decreased as well.

We shall now nd an e ective pair potential between coarse-grained molecules such that the structural properties of the underlying atom istic model are reproduced. There is usually no unique way to coarse-grain to an e ective pair potential, which is in general temperature and density dependent [31, 32, 33], just as in statistical mechanics there are di erent ways to perform a renormalization group step. Here, we extract the e ective pair potential from a center-of-m ass radial distribution function (RDF $_{cm}$) of the reference atom istic model using the potential of m ean force PMF (r) as

where g_{ex}^{cm} (r) is the RDF $_{cm}$ of the all-atom system and U^{cm} (r) is the derived e ective pair potential[34]. The e ective potential obtained in this way is correct only in the lim it of zero density, where the many-body contributions vanish. For systems with nonzero densities in principle many-body interactions would be needed just as for the classical renorm alization group theory in statistical mechanics. In a similar spirit we here resort to the (expected) relevant part in order to gain a signi cant speed up in our simulations. Because of that we use the PM F as the initial guess for the e ective pair potential in systems with nonzero density. Then this is further ne-tuned until the RDF $_{\rm cm}$ s and pressures of the reference atom istic and coarse-grained systems match [34]. As it turns out (see the Results and Discussion section) the e ective pair potential acting between our coarse-grained molecules is signi cantly softer than the pair potential between atom s of the resolved molecules in accordance with the results previously found in the literature [33, 35].

Transition Regime: Hybrid Atom istic/Mesoscopic Model

Let us now introduce a hybrid explicit/coarsegrained (ex-cg) model. Consider a box of n m olecules where one half of the box is occupied by atom istically resolved four-atom tetrahedral molecules while the other half is led up with the sam e num ber of corresponding coarse-grained oneparticle molecules as schematically presented in gure 1 (b). The two dom ains exchange m olecules which adapt their level of resolution accordingly. To ensure that the transition between the two different levels of description is smooth, i.e., the rotational and vibrational degrees of freedom of a given molecule are gradually 'switched on/o ' as it crosses the boundary between the atom istic and coarse-grained dom ains, we also introduce an interface layer for handshaking between atom istic and mesoscale regions. In this regime also the rotational and vibrational velocities have to be reintroduced in a consistent way. Due to the periodic boundary conditions employed in our simulations there are in fact two such layers as depicted in gure 1 (b).

Since the totalnum berofm olecules n in the system is a conserved quantity in our constant tem – perature simulations, we sample the phase space from the nVT ensemble. However, the total num – ber of degrees of freedom is not constant in this m odel.

An alternative way compared to the similarities with renorm alization group methods, which probably describes the situation even better, is the comparison to a rst order phase transition. The rotational and vibrational part of the free energy then can be viewed as the latent heat at this transition. At equilibrium, conditions analogous to two phase coexistence,

must be automatically satis ed, where ex, pex, T_{ex} and $_{cg}$, p_{cg} , T_{cg} are the chemical potentials, pressures, and tem peratures of the liquid in the atom istic and coarse-grained dom ains, respectively. These conditions (4) assure that there is no net ux of molecules between the atom istic and coarse-grained regions. To keep this absolute requirem ent also then de nes a central task. This guarantees that the liquid is hom ogeneous across the box as it is in the reference fully atom istic system. From a molecular point of view, the arti cial resolution boundary must be essentially invisible, ie., the molecules have to cross the border without experiencing any barrier'. Our approach to reach this objective is presented in the proceeding subsection.

A daptive R esolution Schem e

To allow a coarse-grained molecule to nd an energetically permissible orientation with respect to its neighboring molecules (when it leaves the coarse-grained dom ain and is remapped into the atom istically resolved four-atom tetrahedral molecule) we introduce an interface layer between the atom istic and coarse-grained regions, which contains 'hybrid' molecules as presented in gure 1. Each hybrid molecule schematically shown in

gure 1 (a) (consider the middle molecule) is composed of a tetrahedralmolecule with an additional massless center-ofmass particle serving as an interaction site. This is similar to the exible T IP 4P water model[36] where apart from the interaction sites on the three atoms of a water molecule an additional interaction site is introduced along the symmetry axis between the hydrogen and oxygen atom s.

Thus, each time a coarse-grained molecule leaves that dom ain and enters the interface layer, it is remapped st into a hybrid molecule with the same center-of-m ass position and a random orientation in space, where the relative positions of the tetrahedral atom s are taken from a m olecular con guration corresponding to a random ly chosen molecule from the atom istic regime. Each of the four explicit tetrahedral atom s in the hybrid m olecule gains at this rem apping a velocity equal to the velocity of the corresponding coarse-grained molecule to maintain the linearmomentum of the molecule. In addition, the tetrahedral atom s are also assigned rotational/vibrational velocities corresponding to atom s of a random molecule from the atom istic region, where we subtract the total linear momentum of the latter molecule. In this way we ensure that the kinetic energy is distributed among all degrees of freedom according to the equipartition principle as $k_{\rm B}$ T=2 of average kinetic energy per quadratic degree of freedom while retaining the linearm om entum of the coarsegrained m olecule. The center-of-m ass interaction site m oves obeying the constraints:

where R is a center of mass of the molecule , ri is the position vector of the explicit tetrahedralatom i in the molecule , V is the centerof mass velocity of the molecule , v $_{\rm i}$ $\,$ is the velocity of the explicit tetrahedral atom i, and $M = \prod_{i} m_{i}$ is the total mass of the molecule . In our case, $m_i = m_0$ and $M = 4m_0$ for all $i = 1; \dots; 4$ and $i = 1; \dots; n$. Each time a hybrid molecule crosses the boundary into atom istic regime it is remapped into a four-particle tetrahedral molecule with the four tetrahedral atom s retaining their current velocities and positions. In this model also the explicit tetrahedralm olecules have the center-of-m ass interaction sites, but only for the interactions with the hybrid and coarse-grained molecules. Of course, deep in the atom istic region, where the atom istically resolved m olecules do not interact anym ore with the hybrid and coarse-grained m olecules the center-ofm ass interaction site can be om itted. Every tim e a four-particle tetrahedralm olecule leaves the atom istic region and enters into the transition regime it is mapped into a hybrid molecule with the four tetrahedral atom s retaining instantaneous velocities and positions with the center-of-m ass interaction site moving according to Eqs. (5) and (6). Similarly, as a hybrid molecule crosses a boundary to the coarse-grained region it is mapped into a coarse-grained molecule with a velocity equal to the center-of-mass velocity of the hybrid molecule given by Eq. (6).

To couple the atom ic and mesoscopic length scales we de ne in the spirit of therm odynam ic perturbation approach [37, 38] the total intermolecular force acting between centers of mass of molecules and as

is the sum of all pair atom interactions between explicit tetrahedral atoms of the molecule and explicit tetrahedral atoms of the molecule and

The vector $r_{i \ j} = r_i$ r_j is the relative position vector of atom si and j, R = R R is the relative position vector of the centers of mass of the molecules and , X and X are the x center-ofm ass coordinates of the molecules and

, respectively, and w is the weighting function that determ ines the 'identity' of a given m olecule. The weighting function w 2 [0;1] is dened in such a way that values 0 < w < 1 correspond to a hybrid m olecule with extreme cases w = 1 and w = 0 corresponding to a four-atom tetrahedralm olecule and one-particle coarse-grained m olecule, respectively. Hence, as soon as one of the two interacting m olecules and is a coarse-grained m olecule with no explicit tetrahedralatom sw (X)w (X) = 0 and F = F^{cm}.

W e propose the following functional form of the weighting function w:

where a is the box length and d the half-width of the interface layer. The weighting function w is shown in gure 2. Our choice, which takes into account the periodic boundary conditions, is a particularly simple way to ensure an interpolation between w = 0 and w = 1 that is monotonic, continuous, di erentiable and has zero slope at the boundaries to the atom istic and coarse-grained regions. A part from these requirem ents we consider the precise functional form as immaterial.



FIG.2: The weighting function $w(x) \ge [0;1]$ de ned by Eq. (11). The values w = 1 and w = 0 correspond to the atom istic and coarse-grained regions of the hybrid atom istic/m esoscopic system with the box length a, respectively, while the values 0 < w < 1 correspond to the interface layer. Exploiting the analogy with the quantum mechanicalm ixed state description [39], one can consider a hybrid molecule in the interface layer as a normalized linear combination of a fouratom tetrahedral molecule and a corresponding one-particle coarse-grained molecule. As a given m olecule m oves from the coarse-grained boundary of the interface layer to the atom istic boundary, w is gradually changed from 0 to 1 and a coarsegrained m olecule with only 3 translational degrees of freedom gradually turns into an atom istically resolved m olecule with additional 3N 3 = 9 rotational and vibrational degrees of freedom and a de ned spatial orientation. The continuous, i.e., not instantaneous, 'identity' transition is required since a hybrid molecule is given a random orientation at the coarse-grained boundary, and there can consequently be overlaps of its tetrahedral atom s with the atom s of the neighboring molecules. Since at this boundary w = 0 and

the repulsive potential U^{atom} given in Eq. (1) is capped (see the C om putational D etails section), the forces acting on these atoms cannot diverge, how ever. W hile moving towards the atom istic region the hybrid molecule slow ly adapts its orientation via the gradually increasing atom istic interactions with the neighboring molecules. Likew ise, as presented in gure 1 (a), as a given molecule moves from the atom istic boundary of the interface layer to the coarse-grained boundary, w is continously changing from 1 to 0, the fully atom istically resolved molecule gradually turns into the one particle coarse-grained molecule while om itting all rotational and vibrational degrees of freedom and orientation.

To elucidate the de nition of the force calculation in our model we rewrite Eq. (7) as

From Eqs. (8) and (12) one can then deduce that the pair force in Eq. (7) is de ned in such a way that two given atoms i and j in given explicit (w(X)) = 1 and w(X) = 1)molecules and interact via the atom istic potential de ned by Eqs. (1) and (2) while two coarse-grained molecules (w (X) = 0 and w (X) = 0) interact via the corresponding e ective pair potential U^{cm} . Furtherm ore, the coarse-grained m olecules 'see' the fully atom istically resolved molecules as coarse-grained m olecules. Hence, their interm olecular interaction is de ned by the e ective pair potential Um. To ensure that the center-of-m ass dynam ics governed by Eqs. (5) and (6) of a given explicit or hybrid molecule is correct, the total intermolecular force F^{cm} between the atom istically resolved molecule

and a coarse-grained molecule is distributed among the explicit atom s of the molecule as

where F_i is the force imposed on the explicit tetrahedral atom i by the coarse-grained molecule . The explicit tetrahedral atoms in a given hybrid molecule interact with other explicit atoms in neighboring explicit and hybrid molecules through atom istic forces, while the then massless center-of-massparticle serves as an elective potential interaction site. The total force on a hybrid molecule is then according to Eq. (7) a normalized

The force de nition in Eq. (7) hence satis es N ew - ton's Third Law.

R ecall that the e ective interm olecular potential is determ ined in such a way that the equations of state for the ex and og models match around the state point considered. Therefore, following the scheme, as given by Eq. (7), Eq. (4) is im plicitly satis ed, due to which spurious uxes are avoided at the boundary between the atom istic and coarsegrained regimes.

To summarize, the new adaptive resolution scheme for the hybrid atom istic/mesoscale MD simulations is a two-stage procedure:

- 1. Derive the e ective pair potential U^{cm} between coarse-grained m olecules on the basis of the reference all-atom system.
- Introduce the interface layer containing the hybrid m olecules that have additional interaction sites positioned at their centers of mass. De nea weighting function w by Eq. (11) and use Eq. (7) for the de nition of the interm olecular pair forces. A llow molecules to adapt their level of resolution according to their position in the system as explained in the second paragraph of this subsection.

F inally, since the switching of the resolution can be considered as a rst order phase transition, the adaptive resolution scheme must necessarily be employed in combination with a therm ostat. Because the latent heat is generated in the transition regime it is important to use a therm ostat, which couples locally to the particle motion, e.g., Langevin or D issipative Particle D ynam ics (DPD) therm ostats[40].

III. COMPUTATIONALDETAILS

Tem perature Calculation

In order to treat all n m olecules equally regardless of the level of detail, we de ne, using the equipartition principle, the tem perature of a system only from translational degrees of freedom. The 'translational' tem perature

when averaged gives the tem perature of the system [41]. Here E_k^{cm} is the total translational kinetic energy of the system . We also checked the \particle" tem perature in the explicit atom istic region. As to be expected we does not the same tem perature.

P ressure C alculation

For the same reason also the pressure calculation is based on the molecular instead of atom ic interactions:

where F is given by Eqs. (7) [41, 42]. Moreover, using Eq. (18) for pressure evaluation has two additional advantages compared to the pressure calculation based on atom ic interactions: rst, Eq. (18) is also valid in the case that forces on atom s involve internal non-pairwise-additive contributions, and second, even if all interactions are pairwise additive (as in our case), the pressure calculation based on atom ic interactions introduces additional uctuations in the pressure [42].

M ultiscale Sim ulation D etails

For computational convenience during the proof of principle stage we replace our ex-cg m odel with a m odel in which the whole box contains exclusively hybrid m olecules with four explicit atom s and a center-ofm ass interaction site. This has some technical advantages during the tests of the m ethod. The true level of detail of the m olecules is then determ ined from the value of w (X). For later large scale, how ever, of course the original ex-cg m odel com posed of the explicit, coarse-grained, and hybrid m olecules will be employed. U sing Eq. (11) in the replacement m odel for distinguishing between explicit, coarse-grained, and hybrid m olecules of our original ex-cg m odel we can capture all de nitions of pair forces for all classes of

particles in our system in a single expression as

we regain the total force between molecules and given in Eq. (7). From Eqs. (5), (6), and (19) follows that in the replacement model with only hybrid molecules a hybrid molecule experiences only translational kicks from otherm olecules in the coarse-grained region (w = 0) and hence its center ofm assm oves exactly as the respective oneparticle coarse-grained m olecule in the original excg m odel. Similarly, in the explicit region (w = 1) a hybrid molecule experiences only atom istic forces and hence its explicit atom s m ove exactly as the explicit atoms in the respective tetrahedralm olecule in the originalm odel. Therefore, the m odel containing only hybrid m olecules interacting via the pair force de ned by Eq. (19) together with the applied Langevin therm ostat [15] acting on each particle in the system (to assure that the atom velocities are therm alized in accordance with the equipartition principle) exactly minics the original ex-cg m odel in which the tem perature would also be held constant by the Langevin thermostat. From them ethodology developm entpoint of view, these two models are therefore identical.

This yields the Langevin equation of motion

where m_i is the mass of particle i, F_i is the total force acting on the respective particle equal to the sum of pair interactions given by Eq. (19), is the friction constant, and W is the random force of a heat bath [43]. We sample the random force from a uniform distribution, since it has been shown that there is no advantage of using G aussian noise for the Langevin therm ostat [44].

The value of the friction constant used in our simulations is = 0.5¹ where = ("=m₀²)¹⁼². The equations of motion are integrated for each particle of the system using

the velocity Verlet algorithm with a 0:005 time step. Here, again only for the purpose of testing the method, we use only one time step in the whole system. In the coarse-grained regime actually a signi cantly larger time step could be used. Therefore ultimately one would like to introduce a multiple time step algorithm. Simulations are performed at temperature $T = "=k_B$ and number density = n=V = 0: $1=^{3}$. Here n = 5001 is the number of molecules in the system, which can be either the explicit, coarsegrained or hybrid. If we roughly estimate the excluded volume diameter of the coarse-grained molecule CG as the distance, where the repulsive e ective pair potential between the coarsegrained m olecules in our simulations equals $k_B T$, 1:7, then the number density ie., _{cg} $0:1=^{3}=0:1(_{CG}=)^{3}=^{3}_{CG}$ $0:5=\frac{3}{CG}$ corresponds to a medium dense liquid, which is due to the soft e ective repulsive interactions rather weakly correlated [45]. Periodic boundary conditions and the minimum image convention [41] are employed. The interaction range in the system is given by the range of the e ective pair potential between molecules and the geometry of tetrahedralm olecules, i.e., the most outer atom s of two tetrahedralm olecules with centers of mass slightly less than 2:31 apart still experience the e ective potential contribution in Eq. (19). Hence, the actual interaction range in the system is approximately 3:5 .

All molecules are initially random by placed in a cubic box of size a = 36:845. To remove the overlaps between them, a 50 long warm -up run is performed during which the repulsive interparticle potential is capped (see capped interactions in Ref. [46]). Thus, at all interparticle distances, which would lead to larger forces between particles than a prescribed maximal force, the forces de ned by the original repulsive pair potential are replaced by repulsive central forces of the maxim al force m agnitude. The latter is gradually increased from 20"= to 110"= during this warm -up phase. A fterwards an additional 250 equilibration run is carried out where we set the maxim alforce magnitude to 10^9 "= , which corresponds to interparticle distance of 0:27. The chosen maxim alforce magnitude value is so high that it has no e ect on the dynamics of molecules in the atom istic region because there atom s never com e this close together. Therefore, by this force capping we only prevent possible force singularities that could emerge due to overlaps with the neighboring molecules when a given molecule enters the interface layer from

the coarse-grained side as explained in the previous section. Production runs with the 10^9 "= force capping are then perform ed for 7500, storing congurations at each 5 time interval for analysis. We perform ed all our MD simulations using the ESPR esso package[46], developed at our institute. The following reduced Lennard-Jones units[41] are used throughout: $m = m = m_0$, r = r =, $V = V = {}^3$, $T = k_B T = ", U = U = {}^m_0 = ", p = p {}^3 = ", = n = V$, $t = t = , D = D {}^m_0 = " =$, where

D is the self-di usion constant. Note that in our simulations all atom s have a mass m = 1 while all molecules have a mass M = 4.

IV. RESULTS AND DISCUSSION

Determ ination of the E ective Potential

We have determined the elective nonbonded pair potential U^{cm} between coarse-grained molecules illustrated in gure 3 by using the potential of mean force (PM F_{ex}) of the exsystem, Eq. (3), at very low number density = 0:0025 as the initial guess. Then we further adjusted it to obtain the adequate agreement between RDF_{cm} s of the ex and cg systems at the = 0:1. We have

param eterized the e ective potential ${\tt U}^{\tt cm}$ with the M orse potential

with parameters = ="= 0:105, = = 2:4, and $r_0 = r_0 = = 2:31$. As one can see from

gure 3, the obtained e ective potential is soften than the underlying repulsive interatom ic interaction potential given by Eqs. (1) and (2) since it varies m ore slow ly with the interparticle distance. This is a general feature of e ective potentials for polyatom ic m olecular system s[33].

The obtained RDF_{cm} s of the ex and cg system s at the temperature T = 1 and number density 0:025 0:175 using for all number densities the same e ective potential given by Eq. (22) for the pair interactions between the coarsegrained m olecules are depicted in gure 4. The

RDF_{cm} s are calculated in the range r 2 [0;5] with r = 0.05. From results presented in gure 4 it can be observed that although the e ective potential given by Eq. (22) was parameterized at the number density = 0:1 the agreem ent of RDF_{cm} s of the cg system with the corresponding reference RDF_{cm} softhe ex system is good also for the low er num ber densities. In fact, due to weaker m any-body interactions the agreem ent is even better for the system s with lower density. Since the e ective potentials are density dependent [31], to obtain a better agreem ent for higher densities the e ective potential should be reparam eterized [34]. Probably the functional form of the e ective potential will also change due to increased contribution from m any-body interactions.

As a quantitative measure of accuracy of the evaluated RDF $_{\rm cm}$ swede neapenality function $f_{\!p}$ as

where g_{ex}^{cm} , which is taken as a reference, is the RDF_{cm} of the ex system. The function exp(r) is employed to penalize m ore strongly deviations at sm all distances [34]. The values of f_p for cg system s with the number density 0.025 0.175 are reported in table I. A sexpected the f_p grows with

the growing density of the system .

From the RDF_{cm} we can evaluate the average number of neighbors of a given molecule within a sphere with the radius r as

The n_n (r) for the ex and cg systems at the tem – perature T = 1 and number density 0.025

0:175 are shown in gure 5. Despite the deviations between the RDF_{cm} s of the ex and cg system s the corresponding average num bers of neighbors exactly m atch, indicating, together with the RDF_{cm} s presented in gure 4, that the cg m odel with the m olecules interacting via the e ective potential given by Eq. (22) reproduces well the structure of the underlying ex system.

To show that the cg system with the e ective potential from Eq. (22) is at the same state point

as the original ex system at the same tem perature and density we also evaluated the pressure in the system. The equations of state for the ex and og models are shown in gure 6. The resulting

equations of state are sim ilar to the case of colloidal sphere system s[35]. This similarity is to be expected since the tetrahedralm olecule as well as the spherical coarse-grained molecule can be considered as spherical colloidal particles with a hard core and a soft coating layer. From gure 6 we can conclude that the cg m odel with the particles interacting via the e ective potential from Eq. (22) reproduces the equation of state of the underlying ex system up to = 0:125, at which the two pressure curves start deviating from each other, re ecting the fact that the e ective potential is density dependent. In order to m in im ize the artifacts originating from our param eterization of the e ective potential while still simulating the liquid state we have decided to perform allour M D sim ulations of the hybrid atom istic/m esoscopic (ex-cg) m odel at the state point with T = 1 and density = 0:1.

Statistical P roperties

The new adaptive resolution scheme is tested by comparing the computed statistical properties of the ex-cg model with the corresponding properties of the reference fully atom istic ex system.

Figure 7 (a) displays the RDF_{cm} s calculated from center-of-m ass positions of all molecules in the box of the ex and ex-cq systems at = 0:1 and T = 1. Shown is the case with the width of the interface layer 2d = 2.5. Depicted are also the corresponding local RDF $_{\rm cm}$ s for the explicit (ex-cg/ex) and coarse-grained regions (ex-cg/cg) of the ex-cg model. As in all simple liquids, e.g., m ethane, the RDF cm s are zero at short distances between molecules' centers of mass because repulsive forces prevent overlapping of m olecules. Then the functions increase rapidly to the st peak. W ith increasing distance ${\tt RDF}_{\tt cm}$ s reach the lim – iting value 1 after few oscillations, indicating that there is no order at long distances. The average num bers of neighbors n_n (r) of a given molecule as functions of distance are illustrated in gure 7 (b). The number of nearest neighbors in the st layer corresponding to the rst m in im um in the RDF_{cm} is about 11. For comparison, the corresponding experimental value from X-ray di raction for liquid methane at T = 92 K is approximately 12 [47].

All calculated RDF_{cm} s of the ex-cg m odel and n_n (r) are in good agreement with the reference RDF_{cm} and n_n (r) of the ex m odel indicating that the structure of the underlying all-atom system is well reproduced using the adaptive resolution

scheme. This is further con med by the values of the penalty function f_p reported in table II, evaluated for dierent interface layer widths. From the results given in table II we can see that the local structure in the explicit region of the ex-cg model is exactly reproduced independently of the interface layer width. In contrast, the accuracy of the

local structure reproduction in the coarse-grained region of the ex-cg m odel depends on the accuracy of the e ective potential parameterization in the cg m odel (see the value of $f_{\rm p}$ given in table I for

= 0.1). The computed $f_p s$ for the totalRDF_{cm} of the ex-cg m odel lie up to 2d = 8.0 in between the values for the local explicit and coarse-grained RDF_{cm} s.

For narrow interface layers with 2d < 2.5 the adaptive resolution scheme fails to work. The m olecules are not given enough space and time to adapt their orientation to their environment and the system is not properly equilibrated in this case. The value 2d = 2.5, for which the adaptive resolution scheme gives the acceptable results, can be rationalized by the fact that the interface layer width should at least exceed the maximal range of interaction, which is the range of the elective potential, namely 2:31.

To dem onstrate that the therm odynam ic properties are correctly reproduced by the adaptive resolution scheme the tem perature and pressure of the system as a functions of the interface layer width are given in tables III and IV, respectively. The calculated tem perature pro le reported in table III shows that the system is at the right tem perature and that all degrees of freedom are properly equilibrated in accordance with the equipartition principle regardless of the interface layer width. The results given in table IV also show that the adaptive resolution scheme succeeds in reproducing the pressure of the underlying fully atom istic system .

In order to check that the chem icalpotentials in the atom istic and coarse-grained regions are equal as required by the condition (4) we report in table V the average number of molecules in di erent regions of the system . In table V we also give the number of degrees of freedom $n_{D \ O \ F}$ in the system de ned as

where N = 4 is the number of explicit tetrahedral atoms in a molecule and w is the value of the weighting function de ned by Eq. (11) for the molecule . The summation in Eq. (25) goes over all n molecules of the system . The results show that there is no molecule number bias in the system and that the ex-cg system is hom ogeneous. Note that $n_{D \ O \ F}$ is greatly reduced employing the adaptive resolution scheme on the ex-cg model in comparison with the fully atom istic model. The time evolution of the number of molecules in different regions of the system together with the $n_{D \ O \ F}$ is illustrated in gure 8. The results clearly

dem onstrate that the system is in therm odynam ical equilibrium, indicating that the conditions (4) are satis ed by our adaptive resolution scheme.

A lthough we have parameterized the e ective potential to reproduce the structural properties of the ex system we can also compare the dynamical properties of the ex-cg with the ex model. For

that purpose we have computed the self-di usion coe cient, which is evaluated from the center-ofm ass displacements using the Einstein relation

where R (t) is the center-ofm ass position of the molecule at time t and averaging is performed over all molecules and all choices of time origin. The self-di usion coe cient of the ex and cg models calculated in the microcanonical ensem ble, where the Langevin them ostat is switched o after the initial warm -up run, are 0.24 and 0.30, respectively. The corresponding values of the selfdi usion coe cient for the ex, cg, and ex-cg models with the Langevin therm ostat switched on are 0.12, 0.14, and 0.13, respectively. Since we use the

same time and length scales in all our three mod-

els di erent values of the self-di usion coe cient in the ex and cg models (with no Langevin thermostat applied) indicate that the coarse-grained molecules experience a slightly smaller intermolecular frictional hindrance in their motion com pared to the explicit molecules. This indicates that the e ective pair potential given in Eq. (22) introduces an e ective time scale shift in the coarsegrained regime. This is known from other studies [16,17], where one actually takes advantage of that in order to reach very long simulation times[48]. The apparent self-di usion coe cient values of the ex and cg m odels are lower and m uch closer together when the Langevin them ostat is applied due to the frictional forces arising from the coupling to the therm ostat unlike to the case of polym ers. There typically the friction of the therm ostat is negligible com pared to the friction between m onom ers. Since the self-di usion coe cient of the ex-cg m odel is close to the corresponding values for the ex and cg m odels we can conclude that the center-of-m ass dynam ics of the m olecules is sim ilar in all three m odels.

As the naltest to dem onstrate the reliability of the adaptive resolution scheme we have computed the number density pro le of the ex-og model. The results for the system with 2d = 2:5 and 2d = 10:0 are presented in gures 9 (a) and (b), respectively. The results in gure 9 (a) for the case of 2d = 2:5 show that the explicit and coarsegrained regions have the sam e hom ogeneous density as the reference system while the density in the transition regime undergoes an oscillation around the reference value $_0 = 0:1$ with a magnitude of approximately 0.05_{0} . In the case of 2d = 10.0 (qure 9 (b)) a 5% drop in the density occurs in the transition regime, which is compensated by the slight increase of the density in the explicit and coarse-grained regions.

This artifact can be explained by considering the results displayed in gure 10 (a), where the pressure of the system containing only hybrid molecules as a function of the constant value of the weighting function w (corresponding to the situation in the interface layer) is illustrated. The pressure is increased in comparison to the pressure in the reference system . C learly the increase ism ost prominent for them ost 'arti cial' case with w = 1=2, indicating that there still is a sm all 'pressure barrier' in the interface region causing the density dip. This is also evident from results in gure 10 (b), where the RDF_{cm} and the potential of m ean force of the system with w = 1=2 are shown. The e ective potential in a system containing only hybrid molecules with constant value of the weighting function changes in comparison to the all-atom system . This means that the hybrid molecules in the interface layers of the ex-cq model experience too strong e ective interaction leading to the pressure variations in the interface layer. Since the artifact occurs at constant values of wit is an artifact of the linear combination of forces in Eq. (7) and not of the functional form of the weighting function w. It must be emphasized, how ever, that this artifact of the proposed adaptive resolution scheme is within a 5% error and

that sim ilar artifacts, occurring at the boundary of two domains with di erent level of detail, are also characteristic for other hybrid schemes[49].

The pressure variations in the interface layer could cause a spurious re ection of molecules from the boundary. However, the results presented in

gure 11, where the time evolution of two di usion pro less is monitored form olecules that are initially localized at the two slabs with a =10 width neighboring the interface layer, show that this is not the case. The molecules initially localized at the two slabs spread out symmetrically with time. This is because the self-di usion coeccients of all

m odels are approxim ately the same in the case of the applied Langevin therm ostat. Thus, the two distributions occupy at time t regions with mean square radius

where x (0) is the center of the distribution at time t = 0, which is equal to d = 20 for the left slab (gure 11 (a)) and d + a = 20 for

the right slab (gure 11 (b)). Since the di usion pro les are symmetrical at any given time we can conclude that the artifact at the interface layer is too small to have any severe e ect on the di usion of molecules across the interface layer.

V. CONCLUSIONS

A novel approach for e cient hybrid atom istic/m esoscale m olecular dynam ics (M D) sim ulations has been presented in this paper. The new adaptive resolution M D simulation schemedynam ically couples the atom ic and mesoscale length scales of the studied system by allowing an onthe- y dynam ical interchange between m olecules' atom ic and m esoscopic levels of description. In our approach the number of degrees of freedom is allowed to uctuate during the course of simulation while the statistical properties of the underlying all-atom model are properly reproduced for both levels of detail. Since the purpose of this paperwas to develop the method, we restricted ourselves to amost simple model system of a molecular liquid with short-range repulsive interactions. Even on this level a number of questions still have to be tackled, as there is the application to higher liquid densities for complex molecular liquids or the proper analysis and understanding of the time scale problem, when the di usion on the coarsegrained level is faster than on the all-atom level. For separate runs at the two levels of detail this is understood, while the occurrence within one sim ulation box still poses som e conceptual problem s. On the other hand the current density is in between a typical small molecule liquid and a polymeric uid. Thus we expect that already this approach can be generalized and applied to di erent realistic soft condensed matter system s where both atom ic and m esoscopic length scales have to be considered. This can be either polymer solutions and melts, such as a synthetic or biological m acrom olecule embedded in a solvent. Sim ilarly ourmethod should also nd application for other polymer systems (same force eld), molecular liquids such as methane (sam e geometry) or water (tetrahedral clusters), etc., enabling to reach much larger length and time scales than for all-atom MD simulations. In all cases the aim is to treat in a simulation only as many degrees of freedom as absolutely necessary for the question considered. In this sense the region of higher detail can be either given by a geometrical constraint, e.g., close to a surface, or even be chosen on dem and due to speci clocal conformations of a (macro-)molecular system . W ork along these lines is underway.
