## A haronov-Bohm E ect for Parallel and T-shaped Double Quantum Dots

We investigate the Aharonov-Bohm (AB) e ect for the double quantum dots in the Kondo regime using the slave-boson mean—eld approximation. In contrast to the non-interacting case, where the AB oscillation generally has the period of 4—when the two-subring structure is formed via the interdot tunneling  $t_c$ , we not that the AB oscillation has the period of 2—in the Kondo regime. Such e ects appear for the double quantum dots close to the T-shaped geometry even in the charge—uctuation regime. These results follow from the fact that the Kondo resonance is always—xed to the Fermi level irrespective of the detailed structure of the bare dot-levels.

KEYW ORDS: Aharonov-Bohm e ect, Kondo e ect, Double Quantum Dots

Recent rapid progress in the nanotechnology makes it possible to fabricate double quantum dot (DQD) system s.1) One of the remarkable features in the DQD system s is the interference e ect induced via multiple paths of electron propagation, which is very sensitive to the external magnetic ux, giving rise to the Aharonov-Bohm (AB) e ect<sup>2,3)</sup> The AB e ect has been theoretically studied for the DQD with $^{4\{8\}}$  or without $^{9\{13\}}$  the intradot Coulomb interaction. As noted in the literature recently, 10(13) the interdot tunneling between two dots, which forms two-subring structure, generates a new AB oscillation period of 4 instead of the normal period of 2 . However, the argum ents are based on the noninteracting electron model, and the in uence of electron correlations on this new AB oscillation has not been discussed yet.




Fig. 1. DQD system with the magnetic ux .

In this note, we address this question about the AB e ect by explicitly taking into account the K ondo e ect in the DQD shown in Fig. 1. We will show that if the

K ondo e ect is taken into account in the parallelDQD, the AB period should be practically regarded as 2 instead of 4. This tendency becomes more remarkable in the DQD close to the T-shaped geometry, which is another typicalDQD system sensitive to the interference e ect.

In the following discussions, the intradot C oulom b interaction is assumed to be sulciently large, so that double occupancy at each QD is forbidden. This assumption which allows us to use a slave-boson representation of correlated electrons in the dots. In this representation, the DQD system in Fig. 1 is modeled with the N (= 2)

fold degenerate Anderson Hamiltonian

is the annihilation operator of an electron where o with spin in the lead ( = L;R), and the annihilation operator of an electron in the dot m (m = 1;2) with the energy "d is represented as  $b_{m}^{y} \ f_{m} - w \ \text{ith}$ the constraint,  $f_m^y f_m + b_m^y b_m = 1$ , where  $b_m (f_m)$ is the slave-boson (pseudo-ferm ion) annihilation operator for an empty state (singly occupied state). We use the mean-eld approximation at zero temperature (see ref.14). The e ect of the magnetic ux rically incorporated in the tunneling between the dot m and the lead in eq. (1),  $V_{L1(R2)} = W_{L1(R2)}e^{i=4}$ ,  $V_{L2(R1)} = W_{L2(R1)}e^{i} = 4$ , where = 2 = 0 ( 0 = h=e). This means that the magnetic ux equally pierces the two subrings formed by the interdot tunneling to. We system atically change the arrangem ent of the DQD by m odifying the resonance width  $_{1;1(2;2)} = y_{1(2)}y$  ( is the density of states for leads at the Ferm ienergy): the 2;2, and the T-shaped parallelDQD is given by 1;1 DQD by  $_{2;2}$  0 with xed  $_{1;1}$ . 15)




Fig. 2. Conductance as a function of the magnetic ux : (a) K ondo regime, (b) charge-uctuation regime. We choose the interdot coupling  $t_{\rm c}=1.5$  in the unit of  $_{1,1}$  (=1).

Figure 2 shows the conductance as a function of the magnetic ux for several values of  $_{2,2}$ . We have studied two typical cases in the K ondo regime and the charge-uctuation regime. There are several remarkable properties in the conductance. (i) As seen in Fig. 2 (a), the AB period of the conductance seems to be always 2 in the K ondo regime (" $_{\rm d}=3.5$ ) even if we change the arrangement of the DQD from the parallel to T-shaped geometry. This is in contrast to the conclusion for the non-interacting case: the period should be 4 generally,  $^{10\{13\}}$  which follows from the two-subring structure formed via the interdot tunneling  $t_{\rm c}$ . (ii) On the other hand, in the charge-uctuation regime (" $_{\rm d}=2.4$ ) in Fig. 2 (b), the AB oscillation for the parallel DQD ( $_{2.2}=0.9$ ) indeed

has the period of 4 . Even in this case, however, as the DQD system is changed from the parallel to T-shaped geom etry, the period again approaches 2 (see  $_{2,2}$  = 0.3 in Fig. 2 (b)). These results in ply that electron correlations play a crucial role for the AB oscillation in the DQD.




Fig. 3. Transm ission probability T (") around the Ferm i energy (" = 0) in the K ondo regime (" $_{\rm d}$  = 3:5). We set  $t_{\rm c}$  = 1:5 and  $_{2,2}$  = 0:9.

The above characteristic properties result from the K ondo resonances a ected by the interference e ect. In Fig. 3 the transmission probability T (") is shown around the Fermi energy (" = 0) in the case close to the parallel geom etry ( $_{2;2} = 0:9$ ). At = 0, the K ondo resonance splits into two distinct resonances due to the interdot coupling tc: they consist of a sharp bonding K ondo resonance at the Fermi energy and a broad anti-bonding K ondo resonance. $^{14)}$  The interference between these two resonances produces a dip in T (") around " = 0, as seen in Fig. 3(a). As the magnetic ux increases, the interference e ect is smeared (Fig. 3(c)), and the Kondo resonances in T (") become almost symmetric at = At = 2, the shape of T (") is inverted with respect to the Fermi energy as shown in Fig. 3(e), and then T (") returns to the original shape with another increase by 2 . We thus see that T (") changes with the period of 4 , as should be expected. However, it should be noted that the value of T(" = 0) oscillates with the period very close to 2 , which characterizes the linear conductance shown in Fig. 2(a) for  $_{2;2} = 0.9$ . This new periodicity is due to the constraint in posed on the K ondo resonances:

the self-energy shift inherent in the K ondo e ect properly tunes the position of the resonances so as to keep the electron number in the dots constant. This many-body e ect gives rise to the e ective period of 2 , in contrast to the non-interacting case.  $^{10\{13\}}$ 




Fig. 4. Transm ission Probability T (") for  $_{2;2}=0:3$  in the charge-uctuation regime (" $_{\rm d}=2:4$ ).

In the charge- uctuation regime ( $\frac{1}{d} = 2:4$ ), the resonances are both lifted slightly above the Ferm i energy. The resulting asymmetric nature in T (") naturally gives the AB e ect with the period of 4, as seen for  $_{2:2} = 0:9$ in Fig. 2(b). However, even in this charge-uctuation regime, we encounter a remarkable fact that when the system approaches the T-shaped DQD ( $_{2;2}$  = 0:3 in Fig. 2(b)), the e ective period becomes 2 again. To understand this tendency, we should recall that while the whole DQD system is in the charge- uctuation regime, the dot-2 itself falls into the K ondo regim e because it is almost decoupled from the leads in the T-shaped geometry. We can see that the broad resonance of the dot-1 develops a dip structure at the Ferm i energy, which is caused by the sharp K ondo resonance form ed in the dot-2. In this case, the DOS of the dot-1 mainly controls the transmission probability T (") shown in Fig. 4. When the magnetic

ux is turned on, the dip in T (") is slightly modi ed with the resonance-width almost unchanged. Therefore, although the current ows mainly through the dot-1 in the T-shaped geometry, the sharp dip structure caused by the K ondo e ect in the dot-2 essentially controls the linear conductance in the system. This gives rise to 2 for the e ective AB period even in the charge—uctuation regime, as observed in Fig. 2 (b).

Finally, we would like to comment on the AB period in more general cases for which the magnetic ux piercing the two subrings is not equal; the ratio of ux is assumed to be an irreducible fraction m=n. In the non-interacting case, the AB period of the conductance is 2 (m+n). In the K ondo regime, however, the AB period becomes half, (m+n), provided that both m and n are odd, while it remains 2 (m+n) if either m or n is even.

In sum mary, we have shown that in spite of the two-subring structure in our DQD system, the AB oscillation practically has the period of 2 in the K ondo regime. Such e ects appear for the DQD close to the T-shaped geometry even in the charge—uctuation regime. This conclusion, which is contrasted to the noninteracting case,  $^{10\{13\}}$  arises from the self-energy shift inherent in the K ondo e ect: the K ondo resonance is always xed to the Ferm i level irrespective of the detailed structure of the bare dot-levels.
