Simultaneous Onset of Condensation of Molecules and Atoms in an Attractive Ferm iG as of Atoms

The self-consistent equations for the order parameters of Bose-Einstein condensation (BEC) of m olecules and Bardeen-Cooper-Schrie er (BCS) condensation of atoms in a Fermigas of atoms with an attractive two-body interaction between atoms have been derived within the Hartree-Fock-Bogoliubov approximation from the path integral representation of the grand partition function. We have found that the order parameters for BEC and BCS are proportional to each other, which im plies that BEC and BCS onsets simultaneously. We have also found that the common critical tem perature of BEC and BCS increases as the average number of molecules increases and that the atom -m olecule coupling enhances the common critical tem perature.

The crossover regime [1, 2, 3, 4, 5, 6, 7, 8] of Bose-Einstein condensation (BEC) of molecules and Bardeen-Cooper-Schrie er (BCS) condensation of atoms in a Fermigas of atoms has recently been an active research

eld since it contains abundant inform ation on the interplay of two kinds of quantum uids (the Bose and Ferm i quantum liquids) that exist in the nature. Progress in understanding of this crossover regime will certainly furnish signi cant im plications and shed much light on our understanding of a plethora of macroscopic quantum phenom ena including high temperature superconductivity. How ever, despite that great e orts have been put into it, the nature of condensation on either side of the crossover regime still remains an open question.

In this Letter, we report our results obtained in our study of Bose-Einstein condensation of molecules and BCS condensation of atom s on the BCS side in a Ferm i gas of atom swith an attractive two-body interaction between atoms (an attractive Fermigas of atoms). We will rst derive a set of self-consistent equations for the order param eters of BEC and BCS in the Hartree-Fock-Bogoliubov approximation from the path integral representation of the grand partition function. Then, from the self-consistent equations we will draw the central conclusion in this Letter that BEC of molecules and BCS of atom s onset simultaneously in an attractive Fermi gas of atom s. We also calculate the common critical tem perature of BEC and BCS and discuss its dependence on the fraction of atom s bound into molecules, on the two-body interaction between atom s, and on the atom molecule coupling.

In the literature, the prime examples of Ferm i gases of atom s are the gases of 40 K and 6 Li atom s, with the gas of 40 K atom s m ost intensively studied so far. The m agnetic- eld Feshbach resonance [9, 10] is used to vary the sign and strength of the two-body interaction between atom s so that the BEC-BCS regime is conveniently accessed. In our present work, we are concerned with the BCS side in which the two-body interaction between

atom s is attractive. On the BCS side, there exist an open channel and a closed channel, with bound states only in the closed channel. The bound-states in this case are referred to as unstable (unphysical) bound states. A resonance molecule refers to the entity form ed by two atom s in such a bound state in real space. If the size of a bound state is sm all in real space, the bound state is then a conventional molecule. The size of a bound state can be varied by varying the strength of the two-body interaction between atom s through the Feshbach resonance. A s its size increases, the bound state becom es better localized in momentum space and it can then be referred to as a preform ed C ooper pair.

A Fermigas of atom swith an attractive two-body interaction is described by the Hamiltonian [11]

where 2 = 2 () is the o set energy of a molecule relative to the chemical potential , a_p^y and a_p are creation and annihilation operators of a molecule of momentum p and energy 2 , c_k^y and c_k are creation and annihilation opperators of a fermionic atom of momentum k, spin , and energy $_k = -k^2 = 2m$, U (< 0) is the two-body interaction between atom s, g is the elective atom -molecule coupling constant, and N is the average num ber of single atom s.

Our starting point is the path integral representation [12, 13] of the grand partition function Z = Tre $^{\rm H}$ with H given in Eq. (1). To obtain the path integral representation of the grand partition function, we introduce the com plex variables $\prime_{\rm p}$ () and $\prime_{\rm p}$ () for the creation and annihilation operators $a_{\rm p}^{\rm y}$ () and $a_{\rm p}$ () ofm olecules, and the G rassman variables $_{\rm k}$ () and $_{\rm k}$ () for the

creation and annihilation operators c_k^y () and c_k () of atom s. Replacing a_p^y (), a_p () by '_p (), '_p () and c_k^y (), c_k () by _k (), _k () in the Ham iltonian in Eq. (1) so that the Ham iltonian becomes a function of the above-introduced com plex and G rassm an variables and is denoted by H (';), and then substituting H (';) into

we obtain the integral representation of the grand partition function. The integration measure in Eq. (2) is given by

The com plex variable $'_{p}()$ introduced above acts as the order parameter of Bose-Einstein condensation of molecules. To proceed further, we use Fourier transformations of $'_{p}()$ and $_{k}(_{p})$ given by $'_{p}() =$ $\lim_{\substack{i!_{m} \\ m \ = \ i!_{m} \ = \ and \ i!_{n} = i(2n + 1) = , with m and$ n being integers, are M atsubara in aginary frequencies $for bosons and fermions, respectively, and <math>p = (p; i!_{m}),$ $k = (k; i!_{n})$ to rewrite the path integral representation in in aginary frequency space. For the purpose of decoupling the two-body interaction between atom s through the Hubbard-Stratonovich transformation [14, 15], we rewrite it as

The eld introduced in implementing the Hubbard-Stratonovich transform ation is denoted by $_{\rm p}$ and it corresponds to the order parameter of BCS condensation of atom s [12]. For discussion of Bose-E instein condensation of m olecules and BCS condensation of atom s, we need retain only zero bosonic momentum -frequency terms in the atom -m olecule coupling and in the decoupled terms. Then all nonzero momentum -frequency order parameters of zero momentum and frequency [they are now sim ply denoted by ' and , respectively] remaining in the path integral representation of the grand partition function.

The next algebraic manipulation to perform is the integration over the G rassman variables. To integrate out

the Grassm an variables, we rst bring the term s containing the Grassm an variables as a whole into a diagonal form. This manipulation is similar to the diagonalization of the Ham iltonian of a system of ferm ions [16]. We found that it is convenient to introduce a colum n m atrix of two G rassm an variables and to write the concerned term s in a m atrix form . Then we diagonalize the m atrix appearing in the matrix form of the concerned terms. The transform ation matrix that transforms the to-bediagonalized m atrix into a diagonal m atrix is com posed of the orthonorm aleigenvectors of the to-be-diagonalized matrix. The new Grassman variables in terms of which the concerned term s are expressed in a diagonal form can be easily obtained by using the transform ation m atrix. It can be directly veri ed that the Jacobian of the change of variables from the old G rassm an variables to the new G rassm an variables is unity.

The nalsimpli cation we can do to the path integral representation of the grand partition function is to perform the summations over the imaginary frequencies $i!_m$ and $i!_n$. These summations can be easily performed by considering proper contour integrals [17, 18]. With the summations over $i!_m$ and $i!_n$ done, we obtain

Notice that the prefactor N $p^2 \underbrace{j}_p j$ in Eq. (6) arises from the change of variables ' ! N ' and ! N j j j before performing the summations over i!_m and i!_n. The purpose of this change of variables is to make the order parameters ' and intensive.

An approximate explicit expression of Z can be obtained by making use of the steepest-descent method [19] in which S is expanded as a Taylor series in ' and about the stationary point of S. As an approximation, this series is term inated at the second order. The integration over ' and can then be performed and an approximate explicit expression of Z is obtained. The stationary value of S is obtained by evaluating its value at the stationary point determ ined by the conditions that @S=@' = 0 and @S=@ = 0 and their com plex conjugates. From the stationary conditions, we obtain the self-consistent equations for ' and

The self-consistent equations for the complex conjugates of ' and can be obtained simply by taking the complex conjugation of the above two equations.

From Eqs. (8), we immediately see that ' and are proportional to each other

The proportionality between ' and in plies that they become nonzero at the same temperature as the temperature is lowered from a value higher than the critical tem – perature. In other words, Bose-E instein condensation of m olecules and BCS condensation of atom s occur sim ultaneously. This result is of great signi cance in that it reveals to us that both m olecules and atom s condense in an attractive Ferm igas of atom s and furtherm ore that their condensation onsets at a common temperature. Physically, the sim ultaneity of condensation of m olecules and atom s is due to the presence of the atom -m olecule coupling.

We now turn to the evaluation of the common critical temperature of condensation of m olecules and atoms. The common critical temperature T_c can be determined from any one of the two self-consistent equations in Eqs. (8) in conjunction with the relation in Eq. (9). Explicitly, we have

Notice that, since the chemical potential appears in , the chemical potential has to be determ ined self-consistently. To determ ine , we set up a self-consistent equation for it by using the relation 2M + N = @F = @ in which F is the Helmholz freeenergy and M is the average number of m olecules. This relation can be easily veried by using F = ¹ ln Z and Z = Tre ^H with H qiven in Eq. (1). With Z expressed as $Z = e^{S}$, the above relation can be written as ¹ @S=@ . In the Hartree-Fock-Bogoliubov 2M + N = approximation, it is satisfactory to approximate S with its stationary value. W ith the utilization of such an approximation to S, we obtain the following self-consistent equation for the chem ical potential $_{\rm c}$ at T = T_c

where $_{\rm c} = 1 = k_{\rm B} T_{\rm c}$, $_{\rm m}$ is the ratio of the number of atom sbound into m olecules to the total number of atom s, $_{\rm m} = 2M = (2M + N)$, and $_{\rm a}$ is the ratio of the number of single atom s to the total number of atom s, $_{\rm a} = N = (2M + N)$. Notice that, in deriving the self-consistent equation for $_{\rm c}$, the zero-point contributions must be om itted [20].

Before we proceed to solve for the com m on critical tem perature T_c from Eqs. (10) and (11), we rst specify values for several param eters. Firstly, an energy cuto is required in Eq. (10). This cuto indicates the energy range of atom s that participate in pairing. We take this energy cuto to be the Fermi energy E_F since all atom s are allowed to participate in pairing . For a typical density of $n = 10^{20} \text{ m}^{-3} [1, 11], E_F$ 1:25 K for ⁴⁰K atom s. Secondly, the range of the atom -m olecule coupling g w e w ill consider is between $0.1E_F$ and E_F . Thirdly, for the twobody interaction between atom s, we use U = $0.2 E_F$. Lastly, for the molecular o set energy, we use $= E_F$. The above-quoted values of parameters are in consistency with the experim ent [1] and with the previous theoretical analysis [11].




FIG.1: The dependence of the common critical temperature T_c [(a)] and the chemical potential $_c$ at T_c [(b)] on the fraction of atoms bound into molecules for $g = 0.1E_F$, $U = 0.2E_F$, and $= E_F$. The dashed lines are power-law ts discussed in the text.

Shown in Fig. 1 (a) [the solid line] is the dependence of the common critical temperature T_c on the fraction m of atom s bound into m olecules, with the dependence on $_{\rm m}$ of the chem ical potential $_{\rm c}$ at $T_{\rm c}$ shown in Fig.1(b). It is seen that, as m increases, T_c increases alm ost linearly, with T_c 0:12E_F at m = 0 and T_c 0:63E_F at m = 0.25. We thus conclude that the presence of more m olecules e ectively raises the common critical temperature of condensation. The dependence of T_c on m can be well tted with the power law $k_B T_c = E_F = a + b_m$ [shown in Fig. 1(a) as a dashed-line] with a 0:120. b 1:569, and 0:815. From Fig. 1(b), we can see that, as m increases, the value of the chem ical potential $_{\rm c}$ at $T_{\rm c}$ also increases, with the increase slowing down at large values of $\ _{\rm m}$. The dashed-line in Fig.1(b) is the t to the power law $k_B T_c = E_F = c + d_m$ with c = 0.984, $d = 1.824 \quad 10^2$, and = 0.233.




FIG.2: The e ects of the two-body interaction [(a)] and the atom -m olecule coupling [(b)] on the common critical tem perature T_c . The dashed lines are the power-law ts discussed in the text.

Both the two-body interaction between atom s and the atom -m olecule coupling have signi cant in uences on the common critical temperature T_c as shown in Fig. 2 for

 $_{m} = 0.15$ and $= E_{F}$. At these values of $_{m}$ and , the values of $T_c = E_F$ fall in the vicinity of $0.5E_F$ for values of $J_{j} = E_F$ and $g = E_F$ within the range of 0:1 1:0, which is in consistency with the experiment [1]. As jujor q increases, T_c increases monotonically. It has been found that both the T_c -versus-jU j and T_c -versus-g curves can be well tted with a power law $k_B T_c = E_F = + x$. For the T_c -versus-jU j curve, $x = jU = E_F$, = 0.452, = 7:85 10³, and = 2:410; for the T_c -versus-g curve, $x = g = E_F$, = 0:435, = 0:257, and = 1:327. These ts are shown in Figs. 2(a) and 2(b) as dashedlines. From Fig. 2, it can be seen that the in uence on T_c of the atom -m olecule coupling is stronger than that of the two-body interaction between atom s. The reason for this behavior is the fact that g appears in the quadratic form in the e ective coupling constant $(g^2=2)$ + 1U1) [the rst factor on the right hand side of Eq. (10)], while ju jappears only in the linear form .

In encapsulation, in terms of the self-consistent equations for the order parameters derived from the path integral representation of the grand partition function, we have studied Bose-E instein condensation of molecules and BCS condensation of atoms in an attractive Ferm i gas of atom s as realized in experiments [1, 7, 21] by making use of the magnetic- eld resonance. We have found that molecules and atoms start to condense at the same critical temperature, that the common critical temperature increases as the number of molecules increases, and that the atom-molecule coupling raises the common critical temperature.

Our ndings have a number of important implications both to the BEC-BCS crossover in particular and to super uidity (superconductivity) in general. The fact that both molecules and atom s condense and that they have the very same critical temperature resolves the controversy over the nature of condensation on the BCS side of the BEC-BCS crossover regime and manifests that the condensate in an attractive Ferm i gas of atom s is actually composed of a Bose-E instein condensate and a BCS condensate. The increase of the com m on critical tem perature with the fraction of atom s bound into m olecules indicates that high tem perature (possibly room tem perature) super uidity (superconductivity) is likely to be achieved in a system in which Bose-E instein condensation of bosons and BCS condensation of ferm ions can occur simultaneously. The enhancement of the common criticaltem perature by the atom -m olecule coupling suggests that high tem perature super uidity (superconductivity) is likely to be discovered in a system with a strong bosonferm ion interaction in addition to that both bosons and ferm ions in the system can undergo, respectively, Bose-Einstein and BCS condensations.
