Current distribution and ac loss for a superconducting rectangular strip with in phase alternating current and applied eld

The case of ac transport at in-phase alternating applied m agnetic elds for a superconducting rectangular strip with nite thickness has been investigated. The applied m agnetic eld is considered perpendicular to the current ow . W e present num erical calculations assuming the critical state m odel of the current distribution and ac loss for various values of aspect ratio, transport current and applied eld am plitude. A rich phenom enology is obtained due to the m etastable nature of the critical state. W e perform a detailed com parison with the analytical limits and we discuss their applicability for the actual geom etry of superconducting conductors. W e also de ne a loss factor which allow a more detailed analysis of the ac behavior than the ac loss. Finally, we com pare the calculations with experiments, showing a signi cant qualitative and quantitative agreement without any tting parameter.

I. IN TRODUCTION

The behavior of a superconductor transporting an alternating current or exposed to a m agnetic eld varying in time have been a wide subject of study from the early 1960's [1, 2, 3, 4]. However, the case of a simultaneous alternating transport current and applied m agnetic eld remains unclear. This situation is found in superconductor windings where each turn feels the m agnetic eld of all the other. W indings are present in m any applications, like ac m agnets, transformers and m otors [5, 6, 7, 8]. From the practical point of view, it is of fundamental in portance to understand, predict and, eventually, reduce the energy loss (or ac loss) in the superconductor. A ctually, the reduction of the ac loss is vital for the applicability of superconductor electrical technology [7, 8]. The study of the ac loss is also interesting for m aterial science, since in can be used for characterizing superconducting sam ples [9, 10, 11, 12].

The superconductors suitable for electrical applications are hard type II ones [13]. Now adays there is a great scientic c e ort in the development of silver sheathed $Bi_2Sr_2Ca_2Cu_3O_{10}$ (Ag/Bi-

2223) tapes and $YBa_2Cu_3O_7$ (YBCO) coated conductors, which are high-temperature superconductors, and MgB_2 wires [5, 8]. These superconducting tapes and wires have a cross-section roughly rectangular or elliptical. In this work we will consider wires with rectangular cross-section (or rectangular bars), leaving those with elliptical cross-section for further studies. We also restrict to the situation when the ac applied eld is uniform and in phase with the transport current.

H and type II superconductors can be well described by the critical-state m odel (C SM) proposed by Bean and London [1, 2], which assumes that the magnitude of the local current density cannot be higher than a certain critical value J_c .

For the situation of only transport current, the C SM was rst applied by London and Hancox in the early 1960's in order to analytically describe simple geometries, like in nite cylinders and slabs, [2, 14]. Later, an important step forward was done by Norris, who analytically deduced the current distribution and the ac loss for an in nitely thin strip by means of conform alm apping transformations [15]. The case of a strip with nite thickness can only be solved numerically, as done by Norris [16], Fukunaga et al [17], D aum ling [18] and Pardo et al [19].

The rst analysis about the CSM with only ac applied eld was done by Bean for an slab with applied eld parallel to the surface [13]. The case of a thin strip with perpendicular applied eld was analytically solved by B randt et al [20] following the Norris' technique [15]. The current distribution for a strip with nite thickness were num erically calculated by B randt [21] and P rigozhin [22], and the ac loss by P ardo et al [23].

C oncerning the case of sinultaneous alternating transport current and applied eld, the most signi cant published calculations within the C SM are the following. In late 1970's C arr analytically derived the acloss for an in nite slab in parallel applied eld [24]. In the 1990's B randt and Zeldov et al analytically calculated the current distribution in a thin strip using conform altransform ations for the situation that the transport current and the applied eld increase monotonically [25, 26]. A lthough these works provide di erent form ulae, they are actually equivalent [55]. Moreover, B randt studies the values of transport current and applied eld for which these form ulae are valid, obtaining that they are not applicable for high elds and low currents [25]. From that current distribution, Schonborg analytically calculated the ac loss for a thin strip [27].

For strips with nite thickness, there are no published works dealing with the simultaneous application of alternating currents and magnetic elds in a superconductor in the CSM, according to our know ledge. However, there are several theoretical works assuming a relation between the electrical eld E and the current density J as E (J) = $E_c(jJ \neq J_c)^n J = jJj$ where E_c is an arbitrary value and n is a positive exponent. The current distribution and the ac loss are calculated in R efs.

[28, 29, 30, 31, 32] and Refs. [28, 29, 31, 33], respectively, for several values of the alternating transport current and applied eld. These published results are incomplete, not covering the whole range of combinations of ac current and ac eld. This contrasts with the extensive experimental study that has been done for Ag/B i-2223 tapes [31, 34, 35, 36, 37, 38] and YBCO coated conductors [39, 40].

The objective of this paper is to provide a system atic study of the current distribution and ac loss for a superconducting strip of nite thickness assuming the CSM under simultaneous application of an alternating transport current and eld. The elect of mainly three factors are considered: the aspect ratio of the cross-section and the aplitudes of the transport current the applied magnetic eld. We also study the applicability of the CSM to actual superconducting tapes and wires of such shape.

This paper is structured as follows. In Sec. II we present the numerical method used for the calculations and we discuss some general features, mainly about the energy of the system. The results and their discussion are presented in Sec. III. In Sec. IV the comparison with data measured in a high-temperature superconducting tape is reported. Finally, in Sec. V we present our conclusions.

II. NUMERICAL METHOD AND GENERAL CONSIDERATIONS

Let us consider an in nitely long superconductor along the z axis with rectangular cross-section with dimensions 2a 2b in the x and y directions, respectively, Fig. 1. The origin of coordinates is taken in the center of the strip. We study here the situation that the superconductor carries a sinusoidal time-varying current I (t) = $I_m \cos t \sin u$ hancously immersed in a uniform in-phase ac applied eld H_a(t) = H_m cost toriented in the y direction. It is shown below (Secs. IID and IIE) that our results are not only independent on the superconductor carries of I and H_a, similarly to the case of only transport current or magnetic eld [2, 13].

In our calculations we will consider that rst I and H $_a$ are increased from zero to their maximum, starting from the zero-eld cooled state of the superconductor. We call this process the initial stage. Following this stage, we regard the reversal one for which the current and applied eld are decreased from H $_m$ and I $_m$, respectively, to H $_m$ and I $_m$. Next, the applied eld and current are increased back to their maximum, closing the ac cycle. We refer to this latter stage as the returning one.

A. The critical-state model in strips

We assume that the superconductor obeys the CSM with constant critical-current density J_c [1]. The CSM corresponds to supposing a multivalued relation of electrical eld E against current density J such that E = E (jJjJ=jJjw ith an E (jJj) that only takes nite values for $jJj=J_c$, being zero for $jJj < J_c$ and in nity for $jJj > J_c$ [41]. For an in nitely long strip along the z direction, the current density and the electrical eld inside the superconductor are also in the z direction and they can be considered as the scalar quantities J and E, respectively. A though in principle jJj in the CSM can be lower than J_c , in a superconducting strip J only takes the values 0 or J_c [42].

Let us start with the introduction of the main features of the current distribution in the initial stage for the case of transport current only (i.e. $H_a = 0$) or when solely the magnetic eld is applied (I = 0).

The behavior of a superconducting strip in the critical state model with $H_a = 0$ and uniform J_c is detailed in [15, 19, 43]. In the initial stage, for any I > 0 lower than the critical current, $I_c = 4abJ_c$, there exist a zone with J = 0 surrounded by another one with $J = J_c$. The region with J = 0 is usually called the current-free core. In this zone the electrical eld is zero because in the C SM E(J = 0) = 0. W ith increasing I, the region with $J = J_c$ monotonically penetrates from the whole surface inwards and the current-free core shrinks, until it disappears when I reaches I_c . In the C SM, I cannot overcom e I_c since it is assumed that $jJj = J_c$.

The situation when a magnetic eld is applied to a superconducting strip that is not transporting any net current is described in [21, 22]. For this case, the current distribution is antisym metric to the yz plane. In the initial stage with $H_a > 0$, there are a zone with $J = J_c$ in the right half and another one with $J = -J_c$ in the left half expanding from the surface to a current-free core between them. Throughout this paper, we call the border between regions with di erent J as a current front. It is important to notice that in the current fronts J vanishes and, then, so does E. W ith increasing H_a , the cross-section of the current-free core shrinks until it becomes a point at (x;y) = (0;0) at the characteristic eld H_p , that is called the penetration eld. At elds higher than H_p , the current distribution is the same as for $H_a = H_p$.

W hen we now consider the simultaneous action of an applied magnetic eld on a conductor transporting a nonzero current, one can expect that the qualitative behavior of the current distribution is similar to that one for only transport current or applied eld. How ever, for some situations of I and H_a the current distribution presents a di erent behavior. We discuss this aspect in more detail below (Sec. IIIA).

B. M in im ization principle for the critical state m odel

A s discussed by several authors, such as P rigozhin [22, 41], B adia and Lopez [42, 44], B hagwat et al [45], and Sanchez et al [46, 47, 48], the distribution of current density for a superconductor assuming the critical state model is such that it minimizes a certain functional. The functionals introduced in [22, 41, 44, 45] are equivalent, while in [46] it is proposed the magnetic energy as the quantity to be minimized. As shown in [22, 41], the principle of minimization of the functional, F, can be derived from fundamental considerations. In Sec. IIC we demonstrate that them inimization of F is equivalent to minimizing the magnetic energy provided that in the initial stage the current front penetrates monotonically from the surface inwards. Some of the situations presented in this paper do not satisfy this condition; therefore we use the minimization of F as follows.

Let consider the case of an in nitely long superconductor extended along the z direction carrying a transport current I and immersed in a uniform applied eld in the y direction H_a, Fig. 1. W ith this geometry, the current density is in the z direction and, therefore, so is the vector potential A if we assume the gauge r A = 0. Then, we can regard these quantities as scalar. Following the notation of Prigozhin [41], the current at a certain time distributes in such a way that it m inimizes the functional

where S is the superconductor cross-section, A_J is the vector potential created by J, A_a is the vector potential from the external eld, and the quantities with hat correspond to those at the previous time layer. For in nitely long geometry, A_J can be calculated from

Dening the current density variation J J \hat{J} , we obtain from Eqs. (1) and (4) that the current density which m in in izes the functional F also m in in izes the functional F⁰, dened as

where A_J is the vector potential created by J and A_a A_a , $\hat{A_a}$.

In this section we demonstrate that, for the initial stage, the principle of m inim ization of F is equivalent to the magnetic energy m inim ization (MEM) provided that current density penetrates monotonically from the surface inwards and the rate of increasing the transport current is proportional to the rate of increasing the applied eld.

For calculating the magnetic energy, we assume that the transport current in the strip of Fig. 1 returns through another identical one at a large distance D (D a;b). In the following, we consider that the returning strip is centered at (x;y) = (D;0) [48]. Using the general form ula for the magnetic energy in an in nitely long circuit $W = (1=2) \frac{R}{S_{xy}} J(r)A_J(r) + \frac{R}{S_{xy}} J(r)A_a(r)$, where S_{xy} refers to the whole xy plane area, we obtain that the magnetic energy per strip, W^{-0} , is

ignoring constant terms that are irrelevant for $M \in M \cdot W^{-0}$ of Eq. (6) is independent of the position of the returning strip, as long as it is placed at a enough large distance from the other strip.

In order to compare the minimization of F⁰ at every time layer with the magnetic energy minimization for a J in the initial stage, we do the following [48]. Given a physical J, we divide it into n terms J_i , so that $J(r) = \prod_{i=1}^{P} J_i(r)$, being n a large number. We choose these terms as the actual current density increments in the initial stage corresponding to the time layer at $t = t_i$, $J_i = J(t = t_i)$ with $t_i > t_{i-1}$. If the current front penetrates monotonically from the surface inwards with increasing I, each J_i encloses a current-free core. Furthermore, if n is very high, J_i is nonzero in a thin layer only, so that the vector potential variation at time t_i , $A_i = A_{J_i} + A_{a_i}$, is alm ost uniform in the layer and

where A_i^c is the variation of the vector potential in the current-free core and I_i is the transport current at time t_i with $I_{i=0} = 0$.

From Eqs. (6), (4) and (7), we can separate W 0 as

where the label 1' corresponds to the st increment of current density set in the superconductor,

and $J^0 ext{ J}$, $A^0 ext{ A}_J^0 ext{ A}_{J;1}$ and $A_a^0 ext{ A}_a ext{ A}_{a;1}$. To obtain Eq. (8) we used that all the current density created after $ext{ J}_1$ lies inside the current-free core of $ext{ J}_1$.

Following the same steps for all J_i , we not that

If the nalcurrent density J is reached by increasing I and A_a m onotonically from zero and the increase rates of I and A_a are proportional to each other, then $2A_a \quad A_{a,i} \quad A_{a,i-1} = A_{a,i}$ (2I $I_i \quad I_{i-1} = (I_i \quad I_{i-1})$. Inserting this into Eq. (9) and using Eq. (7), we obtain

From Eq. (10) we directly deduce that when m inim izing $F^{0}[J_{i}]$ for each time layer, W⁰ is also m inim ized, since I and I_i are xed external parameters. If the J_i which m inim izes $F^{0}[J_{i}]$ is unique, the J = $P^{n}_{i=1}$ J_i m inim izing W⁰ is also unique.

D. Calculation of current distribution

W e calculate the current distribution by m in in ization of F 0 [J] of Eq. (5) for each time layer as follows.

As done in [19, 23, 48], each superconducting strip is divided into $N = 2n_x - 2n_y$ elements with dimensions $a=n_x - b=n_y$; current density is assumed to be uniform in each element. In order to obtain a smoother current front, we allow the current density to have discrete values below J_c , that is, $J = kJ_c=m$ with k being an integer number from 1 to a maximum value m. As discussed in Refs. [19, 48], this reduces the discretization error in our ac loss calculations. In this paper we use between N = 12000 and 16000 elements and m = 20 current steps.

G iven a current \hat{I} , applied vector potential \hat{A}_a and a current density \hat{J} , we calculate the current density variation J if the current is changed into I and the applied vector potential into A_a , as follow s.

First, we nd the element with $sJ < J_c$, being $s = sign (I \quad \hat{I})$, where increasing the current by $I = sJ_cab=n_xn_ym$ produces the minimum increase of F⁰ and we repeat the procedure until the current reaches I. Then, we nd the elements where changing the current by I and I, respectively, reduces the most F⁰ and jJ jdoes not exceed J_c ; we repeat this procedure until varying the current in any pair of elements will increase F⁰ instead of lowering it. This allows the creation of regions with current density opposite to I. Setting the current in this way, we ensure that the constrains of Eqs. (2) and (3) are fulled. In this procedure the time do not play any role, so that the resulting current distribution is independent on the specie current (and eld) waveform.

The variation of F^0 , F^0 , due to a variation of current I in the element j can be calculated from Eq. (5) and $A_a = {}_{0}H_ax$ taking into account the division into elements of the tape, with the result

where I_k is the current owing through the element k induced after the change of I and H $_a$, x_j is the x coordinate of the center of element i, and C $_{jk}$ are geometrical parameters calculated in the appendix of [48].

For simplicity, we consider a constant variation of I (and H_a) between di erent time layers inside each half cycle. In this paper we use between 80 and 320 time layers.

It can be demonstrated that the current distribution in the reverse and returning stages can be obtained from that one in the initial stage as long as in that stage the current front penetrates monotonically from the surface inwards with increasing I (and H_a) Ref. [48]. Speci cally, the current distribution in the reverse and returning stages, J_{rev} and J_{ret} , are, respectively,

where J_{in} is the current distribution in the initial stage [56].

E. Calculation of ac loss

The power loss per unit volume in a conductor is $J = E \cdot Then$, the acloss per unit length and cycle Q in the superconducting strip is

where the time integral is over one period.

Since the electrical eld inside the superconductor is in the z direction, we obtain that

where is the electrical scalar potential, $Q_z = Q = Qz$ and A. QA = Qt. The electrical eld and the vector potential have zero components in the x and y directions, so that Q = Qx = Q = Qy = 0. Then, since for in nitely long conductors E do not depend on z, Q_z is uniform in the whole cross-section. The quantity Q_z can be calculated taking one point where E = 0 and using Eq. (15), obtaining that

where x_0 and y_0 are the x and y coordinates at some point where E = 0. For the critical-state model, E always vanishes in the positions where J = 0. Such position can be either in the current-free core or on the ux fronts (Sec. IIA).

Inserting Eqs. (15) and (16) into Eq. (14) and using $A_{-} = I \Theta_I A$ and dI = I dt, we obtain

where the current integration is performed in the returning stage. From Eq. (17), we see that Q is independent on the speci c I (t) waveform, as long as I increases or decreases m onotonically with time in a half cycle. From this feature it is directly deduced that the ac loss due to a sinusoidal current and applied eld is independent on their frequency.

The vector potential can be easily calculated from J, obtained by means of the numerical procedure described in Secs. IIB and IID. Then, we calculate $@_{I}A$ at a certain time layer k from the numerically obtained A as

where I_k is the current in the time layer k. Equation (18) yield much more accurate results of $@_IA$ than using nite di erences between consecutive time layers. Indeed, according to the mean value theorem, there must exist some current between I_{k-1} and I_{k+1} where the derivative is exactly the right-side part of Eq. (18). Equation (18) cannot be used at the boundaries of a half cycle, $I = I_m$, since there $@_IA$ is not continuous. Therefore, we use nite di erences between k and k + 1 or k and $k = I_m$, respectively.

If in the initial stage the current front m onotonically penetrates with increasing I_m (or H_m), it is possible to obtain a formula for the ac loss without derivatives in the vector potential. This is the case, e.g. of the pure ac transport or the magnetization by an ac external eld. For this situation, J_{rev} and J_{ret} obey Eqs. (12) and (13). Thanks to this feature and following the same deduction as Carr for the pure transport situation [43], the ac loss from Eq. (17) becomes

where A_m^k and $A_m(x;y)$ are those corresponding to the peak values of I and H_a and s(x;y) is a function giving the sign of J_{rev} . Equation (19) with s = 1 corresponds to that obtained by N orris for the transport case [15] and with s = x=jxj it corresponds to the magnetic one given by R hyner [49].

Since the condition of monotonic current front movement is not always valid, it is saver use Eq. (17) for a general treatment of simultaneous ac magnetic eld and alternating transport current.

III. RESULTS AND DISCUSSION

In this section we present our results for the current distribution and the ac loss and we discuss the existing analytical approximations for low and high b=a aspect ratios. We also introduce the dissipation factor = 2 Q=($_0 I_m^2$), characterizing the loss behavior better than the ac loss itself.

A. Current distribution

In the following we present the current distribution for a rectangular strip with aspect ratio b=a = 0.2, although the num erical procedure gives accurate results for b=a between 0.001 and 100. We consider several situations of eld and current.

First, we study the case of low applied elds. As an example, we plot the current distribution for $I_m = I_c = 0.8$ and $H_m = H_p = 0.08$ in Fig. 2. These procless are qualitatively similar to those for transport current [19] with the difference that the current-free core is shifted to the left. In this situation, the current fronts monotonically penetrate from the surface inwards. Thus, the current distribution can be calculated using MEM (Sec. IIC) and the current distribution for the whole cycle can be constructed from that one in the initial stage using Eqs. (12) and (13). For this case, the ac bas can be calculated using Eq. (19), so that the evaluation of E can be skipped.

The most representative situation of combined action of ac eld and ac current is that of higher applied elds, such as $I_m = I_c = 0$:6 and $H_m = H_p = 0$:72, presented in Fig. 3. The most signi cant issue is that the current distribution in the reverse stage is not always a superposition of that for the initial stage. Not even the returning stage is related to the reverse one. How ever, as can be seen in the gure, the current distribution for $I = I_m = 1$ (and $H_a = H_m = 1$) in the reverse stage corresponds

to that for $I=I_m = 1$ (and $H_a=H_m = 1$) for the returning one, except som e num erical deviation. Then, the current distribution for the follow ing reverse stage for a certain transport current I (and applied eld H_a) is the same but with opposite sign with respect to those for the returning stage for transport current I (and applied eld H_a), being current distribution periodic in time after the rst cycle.

The above specic case (Fig. 3) presents a current-free core, but it is not always the case for higher H_m or I_m. For example, the current-free core is not present for I_m = I_c = 0.6 and H_m = H_a = 1.2 (Fig. 4), as well as for any case with I_m = I_c, as shown in Fig. 5 for I_m = I_c and H_m = H_p = 2. In addition, for all the cases with I_m = I_c the electrom agnetic history is erased at the end of one half cycle (Fig. 5). Thus, for this current amplitude, the returning proles correspond to the reverse ones with inverted sign of the current density, so that the electrom agnetic behavior is simplified. A nother issue is that the current distribution for I_m = I_c have only one boundary between the zone of positive and negative current, while they can have two or more for lower I_m (Figs. 3 and 4).

For other aspect ratios we found the sam e qualitative behavior as for b=a = 0.2 described above. As an example, in Fig. 6 we present the current distribution in the returning curve for b=a = 5. This corresponds to the situation of the sam e strip as for Figs. 2 to 5 but with applied eld parallel to the wide direction.

1. Comparison with analytical limits

It is interesting to compare the sheet current density K in a thin lm from Refs. [25, 26], where it is assumed that current fronts penetrate monotonically, with our results for nite thickness. We calculated K by integrating the current distribution over the thickness. For this situation, in Refs. [25, 26] it is distinguished between the low – eld high-current regime, for which all current has the same sign, and the high-eld low-current one, when current density with both signs exist. These regimes appear for I=I_c tanh (H_a=H_c) and I=I_c tanh (H_a=H_c), respectively, being H_c 2J b= .

In Fig. 7 we present our numerical calculations of K for the initial stage together with the analytical results for a thin lm for b=a = 0:01, H_m =H_p = 0:1 and I_m =I_c = 1 (a), belonging to the low - eld high-current regime, and H_m =H_p = 1 and I_m =I_c = 1 (b), as an example for the high - eld low -current case. As can be seen in Fig. 7 (a), for low applied elds all numerical results fall on the analytical curve within the numerical accuracy, while for higher elds, Fig. 7 (b), there is only coincidence for the pro-les corresponding to low current penetration. The discrepancy for higher

penetration appears since the assumption of monotonic penetration of current fronts is no longer valid for the analytical solution. As can be seen in Fig. 4 (a,b,c), for high $I=I_c$ there is a recession of the zone with negative current density in favor of that one with positive current density, being this e ect more in portant for higher I. The validity of the analytical solution for thin strips was already discussed in Refs. [25, 26].

We can also compare the numerically obtained current distribution to the analytical solution for a slab in parallel eld, for which the current fronts are planar [24, 26]. For strips with high b=a in the high-eld low-current regime, the calculated current fronts approach to planar ones (Fig. 6), the approximation being better for higher b=a. This behavior is in agreement to the pure magnetic case [21]. However, for the low-eld high-current regime current fronts are similar to that ones for a thin strip with only transport current, which are nonplanar [15, 19] and, thus, the slab approximation is no longer valid.

We have performed numerical simulations for very high applied elds, $H_m > 5H_p$, and have shown that the current fronts approach to vertical planes for any aspect ratio, in accordance to the slab approximation. This is because when the applied eld variation is much higher than the eld created by the variation of J, the rst term of F⁰ in Eq. (5) can be neglected. Since A_a is proportional to x, F⁰ of the new induced current density is independent of its y location, and the current density pro les must be planar.

B. Totalac loss

First, we study the ac boss for several b=a aspect ratios and their possible analytical approximations. For this purpose, we present our results of the normalized ac boss q $2 \text{ Q} = (_0 \text{ I}_c^2)$ as a function of I_m and constant H_m and as a function of H_m and constant I_m in Figs. 8 (a),9 (a),10 (a) and Figs. 8 (b),9 (b),10 (b), respectively. Figures 8, 9 and 10 are for aspect ratios b=a = 0:001, 100 and 0.1, respectively. The aspect ratios of b=a = 0:001 and 0.1 can be used to describe qualitatively YBCO coated conductors and A g/B i-2223 tapes, respectively, in perpendicular eld. A spect ratio b=a = 100 is representative for parallel applied eld. For all gures, we consider I_m normalized to the full penetration eld H_p, which for a rectangular strip is [21, 50]

The num erical error in the ac loss have been analyzed by using several num bers of elements, current steps and time layers, showing a variation that cannot be appreciated for the axis scale of

all gures below.

From Figs. 8, 9 and 10 we see that the ac loss monotonically increases with increasing either the current or the applied eld amplitudes. For high applied eld, Q increases linearly with H m for constant I_m [Figs. 8(b),9(b) and 10(b)]. The ac loss for the low-current limit in gures (a) and the low-applied-eld limit in gures (b) is constant, corresponding to the pure transport and pure m agnetic case, respectively. This qualitative behavior is consistent with experiments for YBCO coated conductors [39, 40] and Ag/Bi-2223 tapes [31, 34, 35, 36, 37, 38].

As expected, the loss results for zero applied eld and zero transport current are the same to the results for pure transport and pure magnetic situations calculated using MEM in Refs. [19] and [23], respectively.

1. Analytical limits for the acloss

In the following we study st the validity of the analytical limits for this strips and slabs in parallel applied eld.

In Fig. 8 we can pare our num erical results of 2 $Q = (_0 I_c^2)$ for b-a = 0.001 (line plus symbols) with the ac bass for an in nitely thin strip calculated by Schonborg [27] (dash line) from the sheet current distribution obtained in [25] and [26]. Schonborg expression for $I_m = 0$ corresponds to the Norris formula for a thin strip with pure transport current [15]. The thick continuous line plotted in Fig. 8 separates the low - eld high-current regime from the high-current low - eld one, Sec. IIIA 1. As can be seen in Fig. 8 (a,b) the ac loss for the low - eld high-current regime is well described by the analytical expressions for a thin strip. However, there is a signi cant deviation for the high- eld regime, increasing with increasing eld or current. This is so because, as discussed in [25, 26], the current density formulae for thin strips are only valid for monotonic penetration of current fronts, which appears only for the low - eld high-current regime, Fig. 2. The current front penetration deviates more from the monotonic case for higher eld and current, so that the formulae for thin strips are less applicable.

In Fig. 10 we plot our num erically calculated 2 $Q = (_0 I_c^2)$ for b=a = 0:1 (line with symbols) together with that for a thin strip (dash line). In this gure we can see that the thin-lm approxim ation is not valid for b=a for any case except $I_m = I_c$ and low applied eld.

It is also interesting to compare our num erical results to the form ulae for the ac loss obtained

by Carr for a slab in parallel applied eld assum ing planar current fronts [24], which in SI are

In Fig. 9 we plot our num erical results of 2 $Q = (_0 I_c^2)$ for b=a = 100 (line with symbols) together with those for a slab calculated from Eqs. (21)-(23) (dash line). We see that the above form ulae for slabs agree well with the num erical results for high elds and low currents, although they do not for low elds and high currents. In Fig. 9 we also see that for H_m much above H_p, the Carr's results approach to the actual loss for any current. These features can be explained from the current distribution, discussed in Sec. IIIA 1.

The C arr form ula can be also compared to num erical results for any b=a. In Figs. 8 (a) and 10 (a) we include the high- eld lim it of the ac loss in a slab, Eq. (24), for the highest values of $H_m = H_p$ in those graphs (dotted lines). It can be seen that the analytical lim it of Eq. (24) approaches to the num erical results for high H_m for $H_m = H_p$ 1 and $H_m = H_p$ 5 for b=a = 0.001 and b=a = 0.1, respectively. Num erical calculations for other b=a, like b=a = 1, also agree with Eq. (24) for high applied eld am plitudes. This feature can be explained as follows. For high H_m , the current fronts are planar, like those for a slab, Sec. IIIA 1. Moreover, if H_m is high enough, the only relevant contribution to the electrical eld, Eqs. (15) and (16), is from the applied vector potential for any aspect ratio. Then, the high- eld lim it for a slab must be valid for any aspect ratio. A ctually, Eq. (24) can be easily deduced from Eqs. (14)-(16) assuming that A- $A_a = 0 x H_a$.

C. D issipation factor

U sually ac loss under alternating eld and current have been studied as a function of I_m and xing H_m or vice versa, [27, 31, 33, 34, 35, 36, 37, 38, 39, 40]. Here we underline the signi cance

of the ac-loss dependence when increasing simultaneously I_m and H_m with both parameters proportional to each other along the curve. This situation is found in actual ac devices, such as an alternating magnet.

As explained below, for I_m / H_m we can see more details of the acloss behavior if we plot Q normalized to I_m^2 instead to I_c^2 . Actually, the quantity 2 Q = ($_0 I_m^2$) is proportional to the acloss of a winding per the stored magnetic energy averaged during the cycle duration. Thus, can be regarded as a dissipation factor. Moreover, for only transport current is proportional to the imaginary part of the self-inductance, de ned in [51], and for only applied magnetic eld is proportional to the imaginary part of the ac susceptibility [9, 52].

In Fig. 11 we present our num erical results of for b=a = 0:1 as a function of I_m when H_m is varied proportionally to I_m as $H_m = H_p = I_m = I_c$, where is a constant (line with symbols). This gure shows that for the low I_m (and H_m) limit, increases proportionally to I_m (or H_m), which corresponds to a dependence proportional to I_m^3 for the ac loss. Moreover, for high , decreases with increasing I_m with a slope in log-log scale slightly higher than 1 (and a slope around 1 for the ac loss), presenting a peak at a certain value of I_m (or H_m). We notice that in a log-log plot of q against I_m , the ac loss always increase with I_m , appearing curves very similar to straight lines with a slight change in the slope. However, for the qualitative behavior of the loss with varying I_m and is more evident.

The linear dependence of the dissipation factor with I_m (and H_m) for the low-eld limit is characteristic of the critical-state model, also found for the pure transport and pure magnetic situations [19, 23]. This is so since for low enough I_m the current distribution is approximately parallel to the surface, as well as the magnetic eld in the region with nonzero current density [23]. This means that the loss factor will increase as I_m (and Q as I_m^3) at low levels of excitation in a superconductor winding of any shape or num ber of turns. How ever, for strips with very small b=a, such as b=a = 0.001, the linear dependence of with I_m appears only for very small I_m , presenting for higher I_m the I_m^2 dependence typical for thin I_m s [23].

For comparison, in Fig. 11 we also include the loss factor for only transport current (dashdot line) and that for only applied eld (dash lines), extracted from the tables in [19] and [23], respectively, and interpolating for intermediate values of I_m or H_m when needed. In a $(I_m = I_c)$ representation, the curve for the pure magnetic ac loss is different for each . We see that for low

, approaches to that one for only transport for any I_m and for high , approaches to that one for only magnetic eld for not very high I_m .

For a ner approximation for high , we can consider the following loss factor

The rst term of Eq. (26) is the ac loss with only applied magnetic eld, while the second one is the high-eld limit for an slab, Eq. (24), subtracting the ac loss for $I_m = 0$. In Fig. 11 we plot the loss factor of Eq. (25) for = 2 and 5, calculated from the tables of numerically calculated ac susceptibility in [23] and Eq. (25). We see that the approximation of Eq. (25) in proves with increasing , being almost overlapped with our numerical results for 5.

For low b=a, such as b=a = 0:001 or lower, the ac loss for = 0 approaches to the N orris form ula for thin strips [15], if I_m is not very low [19]. For the high- lim it we can obtain an analytical solution of by inserting the form ula for the ac loss in a thin strip with $I_m = 0$, Ref. [25], into Eq. (25), obtaining

where $H_c = 2bJ_c = .$ Equation (27) is not valid for very low $H_m = H_c$, since the thin strip approxim ation for only applied eld is not valid for this range [23]. For intermediate , can be approximated from the Schonborg's formula for the acloss in thin strips [27], as long as I_m tanh [$H_m = (2aJ_c)$], Sec. IIIB 1.

IV. COMPARISON W ITH EXPERIMENTS

The results of our ac loss calculations presented in Figs. 8, 9, and 10 qualitatively agree with published measurements for Ag/Bi-2223 tapes [31, 33, 34, 35, 36, 37, 38] and YBCO coated conductors [39, 40]. It is interesting to analyze in detail Fig. 10 of Ref. [39]. There, it is shown a comparison between the measured ac loss in a YBCO coated conductor and the theoretical one for a thin strip in the critical state model, evaluated from the current distribution in [25, 26]. It can be seen that the measured ac loss lay below the thin strip approximation, in agreement with our numerical results of Fig. 8. A s discussed in Sec. IIIB 1, this is so because the thin strip calculations in Refs. [27, 39] are not valid for high applied elds. This shows that our numerical calculations can be used to simulate the ac loss in YBCO coated conductors.

In order to perform a more detailed comparison, we measured the loss factor for a commercial Ag/Bi-2223 tape with 37 km ents manufactured by Australian Superconductor. The sample was of 8cm length and 3.2 0.31mm cross-section with a critical current of 38A in self eld at 77K. The superconducting core cross-section was roughly elliptical with dimensions 2a 2b = 3.0 0.13mm. The measurements were performed at a 72H z frequency and 77K temperature; the details of the experimental technique will be presented elsewhere. We present the measured results in Fig. 12 (dot line with symbols) together with numerical calculations for a rectangular strip with the same e thickness, width and critical current (solid lines). We notice that for the theoretical curves we do not t any parameter to the measured ones. In Fig. 12 we label the curves with the parameter 2aH_m =I_m instead of in order to avoid supposing any model for performing the measurements. For comparison, we also include the loss factor assuming elliptical cross section for only transport current [15] (lower dash curve) and only applied eld for the highest 2aH_m =I_m [53] (upper dash curve).

From Fig. 12 we see that the main qualitative features of the measurements correspond to the behavior of a strip assuming the critical state model, except close to I_c for high 2aH $_m = I_m$. This can be explained from the magnetic eld B dependence of J_c , for which J_c decreases with increasing β j. Then, for higher H_m , I_c is lower and a normal resistive current appears in the silver for $I_m < I_c$, adding a certain contribution to . Figure 12 shows that there is a better agreement between the measured and that for an elliptical bar in the critical state model approximation than for the rectangular one, explained by the overall shape of the tape superconducting core. Moreover, the fact that the multi lamentary superconducting core behaves as a single solid wire for any H_m suggests that the inter lamentary currents in the tape are saturated due to the high length of the sample [54].

V. CONCLUSIONS

In this paper we have presented a system atic theoretical study of the current distribution and ac loss in a rectangular strip transporting an alternating transport current I in phase with an applied eld H_a perpendicular to the current ow . We assumed that the superconductor follows the critical state model with a constant J_c . With this assumption, we have developed a numerical procedure which takes into account the nite thickness of the strip. General features of the critical state model in such circum stances have been discussed. In order to do a system atic study, we have perform ed extensive numerical calculations for several aspect ratios and current and applied eld am plitudes, H_m and I_m respectively. Finally, we have performed measurements on Ag/Bi-2223 tapes to be confronted with calculations. Good qualitative and quantitative agreement without thing parameters have been found.

The results for the current distribution have shown a rich phenom enology due to the m etastable nature of the electrical currents owing in the superconductor. For low H_a and high I, the current distribution is qualitatively similar to the pure transport situation. Then, J at the reverse and returning stages are a superposition of J in the initial one \mathbb{E} qs. (12) and (13)]. However, it is not the same for high H_a or low I due to the nonmonotonic penetration of current fronts. In general, the returning stage can be deduced from that one in the rst reverse stage. Only after the rst cycle, the behavior becomes periodic.

The ac boss Q has been accurately calculated for the thickness-to-w idth aspect ratios, b=a= 0.001, 0.1 and 100, in order to qualitatively describe YBCO coated conductors and A g/B i-2223 tapes with applied elds in the transverse direction (b=a = 0.001 and 0.1, respectively) and in the parallel one (b=a = 100). Their current and applied eld dependence is in accordance with published m easured data for YBCO coated conductors [39, 40] and A g/B i-2223 tapes [31, 34, 35, 36, 37, 38]. We have shown that the ac loss behavior can be better characterized by m eans of the loss factor = 2 Q = ($_0 I_m^2$) studied as a function of I_m with H_m proportional to I_m . We have m easured the loss factor in actual A g/B i-2223 tapes, obtaining a good agreem ent with the calculations.

We have also presented a detailed study of the analytical limits for Q and and their applicability. For this samples like YBCO coated conductors, b=a 0.001, the current proles and the ac loss only approach to those for the analytical limit for this strips [27] for the low - eld high-current regime only. The thin lm approximation is never valid for b=a 10, such as for Ag/Bi-2223 tapes. We have also studied the slab limit, obtaining that for the situation of parallel eld, b=a = 100, the slab approximation is not valid for the transport-like regime (low H_m and high- I_m). However, the high-eld limit for the slab approximation can be used for any aspect ratio provided that H_m is high enough.
