Inhom ogeneous sandpile model: C rossover from multifractal scaling to nite size scaling

Abstract

We study an inhom ogeneous sandpile model in which two dierent toppling rules are dened. For any site only one rule is applied corresponding to either the Bak, Tang and Wiesenfeld model [PBak, C. Tang, and K. Wiesenfeld, Phys. Rev. Lett. 59, 381 (1987)] or the Manna two-state sandpile model [S. S. Manna, J. Phys. A 24, L363 (1991)]. A parameter c is introduced which describes a density of sites which are random ly deployed and where the stochastic Manna rules are applied. The results show that the avalanche area exponent a, avalanche size exponent s, and capacity fractal dimension D_s depend on the density c. A crossover from multifractal scaling of the Bak, Tang, and Wiesenfeld model (c = 0) to nite size scaling was found. The critical density c is found to be in the interval 0 < c < 0.01. These results demonstrate that local dynamical rules are important and can change the global properties of the model.

I. IN TRODUCTION

Bak, Tang, and W iesenfeld (BTW) [1] introduced a concept of self-organized criticality (SOC) as a common feature of di erent dynam ical systems where the power-law temporal or spatial correlations are extended over several decades. Dynam ical systems with m any interacting degrees of freedom and with short range couplings naturally evolve into a critical state through a self-organized process. They proposed a simple cellular autom aton with determ inistic rules, which is known as a sandpile model, to demonstrate this new phenom enon. In this model the relaxation rules are conservative, no dissipation takes place during relaxation, and correspond to a nonlinear di usion equation [1]. G enerally, the sandpile model is represented by a d-dimensional hypercube of the nite linear size L. Its boundaries are open and allow an energy dissipation, which takes place only at the boundaries.

M anna proposed a two-state version of the sandpile m odel [2] where no m one than one particle is allowed to be at a site in the stationary state. If one particle is added to a random ly chosen site, then relaxation starts depending on the occupancy of the site. If the site is empty, a particle is launched. In the case when the site is not empty, a hard core interaction throws the particles out from the site and the particles are redistributed in a random m anner among its neighbours. All sites a ected by this redistribution create an avalanche. An avalanche is stopped if any site reached the stationary state, i.e. no m ore than one particle occupies a site.

The rst system atic study of scaling properties, universality and classi cation of determ inistic sandpile models was carried out by K adano et al. [3]. U sing num erical simulations and by varying the underlying microscopic rules which describe how an avalanche is generated they investigated whether di erent models have the same universal properties. Applying nite-size scaling (FSS) and multifractal scaling techniques they studied how a nite-size of the system a ects scaling properties.

The real-space renorm alization group calculations [4] suggested that determ inistic [1] and stochastic [2] sandpile models belong to the same universality class. On the other hand, many numerical results [5, 6, 7, 8, 9] show clearly two dimensions in the dynamical rules of the models do not con m the hypothesis that small modi cations in the dynamical rules of the models do not change the universality class, presented by Chessa at al. [10].

This study was motivated by the results published by Tebaldi et al. [11], and Stella

and M enech [12], where a multifractal scaling of an avalanche size distribution of the BTW m odel was dem onstrated. They assume that a multifractal character for SOC m odels like the BTW m odel is a crucial step towards the solution of universality issues. By applying the m on ent analysis they found FSS for the two-state M anna m odel [12]. Based on these results they conclude that the 2D BTW m odel and the M anna m odel belong to qualitatively di erent universality classes. This assumption was con med recently [13, 14], where a precise toppling balance has been investigated in more detail.

In this paper we report the results of disturbing the dynam ics of the BTW model using stochastic M anna sites which are random ly deployed. They can introduce stochastic events during an avalanche propagation. Our model was derived from the inhomogeneous sandpile model [15] in witch two di erent determ inistic toppling rules were de ned. In the proposed model the rst toppling rule corresponds to the BTW model [1] and the second rule is now stochastic and corresponds to the two-state M anna model [2]. The model is similar to that in Ref. [14], however we applied the original toppling rules of the listed sandpile models.

The paper is organized as follows. The inhomogeneous sandpile model is introduced in Sec. II. The avalanche scaling exponents, capacity fractal dimensions and crossover from multifractal to FSS are investigated with numerical simulations and the results are presented in Sec. III. The Sec. IV is devoted to a discussion which is followed by conclusions in Sec. V.

II. MATHEMATICALMODEL

We consider a d-dimensional hyper-cubic lattice of linear size L, and a notation presented by Ben-Hur et al. [7] is followed to de ne a sandpile model. Each site i has assigned a dynamical variable E (i) that generally represents a physical quantity such as energy, grain density, stress, etc. A con guration fE (i)g is classified as stable if for all sites E (i) < E _c, where E _c is a threshold value. We note that the two-state M anna model [2] has no threshold E _c. The M anna model has de ned a hard core repulsion interaction among different particles at the same position. This hard core repulsion interaction can be described by a threshold where the threshold value E _c = 2 is assigned to any site. In our inhom ogeneous sandpile model, the threshold values E _c depend on the site position i, E _c (i) [15]. The conditions for a stationary state, a stable con guration fE (i)g (no avalanche), are now E (i) < E _c (i), where the threshold $E_c(i)$ at the site i was random by chosen from two allowed values

For any site i the threshold $E_c(i)$ [Eq. (1)] is defined in such a manner that n random by chosen sites have the value E_c^{II} and the remaining L^d n sites have the value E_c^{I} . The density of sites with the threshold value E_c^{II} is denoted c, and $c = n = L^d$.

Let us assume that a stable con guration fE (j)g is given, and then we select a site i at random and increase E (i) by some amount E. We now consider E = 1 for any site. When an unstable con guration is reached, E (i) $E_c(i)$, a relaxation takes place. An unstable site i lowers its energy, that is distributed among the neighbor sites. The directions to the neighbor sites are de ned by the vectors $e_1 = (0;1)$, $e_2 = (0; 1)$, $e_3 = (1;0)$, and $e_4 = (1;0)$. The relaxation is de ned by the following rules

where e is a set of vectors from the site i to its neighbors. The indexes and are integers 1;2;3, and 4 random ly chosen at any relaxation. The neighbors that receive the energy can became unstable and topple, thus generating an avalanche. The distribution of energy is described by Eqs. (2) and (3), we added additional rules Eqs. (4) and (5) which specify the manner how the energy is distributed depending on the position i, threshold E_c (i) Eq. (4)], and corresponding sandpile model [Eq. (5)]. The relaxation rules Eqs. (2)–(5) are applied until that moment when a new stable con guration is reached again, for all sites E (i) < E_c (i). O by builty, during one avalanche an arbitrary unstable site i can transfer the energy E_c (i) a few times to became stable, E (i) < E_c (i). A d-dimensional lattice has open

boundaries so added energy can ow outside the system, and an energy dissipation takes place only at the boundaries.

This model has been designed to enable a well de ned change between two well known nondirected sandpile models: determ inistic [1] and stochastic [2] (nondirected only on average) similarly as in Ref. [13]. The model belongs to the critical height models with conservative relaxation rules and with undirected energy transfer where the two thresholds are random ly frozen. It can be characterized as a sandpile with a possibility to modify its scaling behaviors.

III. RESULTS

We shall report the results obtained using numerical simulation of the conservative, undirected, critical height sandpile model de ned by Eqs. (2)–(5). The simulations were carried out for the following parameters: d = 2, two-dimensional lattice of linear sizes L = 256; 512 and 1024, random ly added energy E = 1, two thresholds either $E_c^{I} = 4$ or $E_c^{II} = 2$, and with density of sites with threshold E_c^{II} in the interval 0 c 1. In our simulations we have used the density c as a model parameter. For densities of stochastic sites c = 0 and 1 the model behaves as the BTW model [1] and M anna model [2], respectively, which are both considered to be Abelian [16].

A valanches can be characterized by such properties as their size, area, lifetime, linear size, and perimeter. We concentrate only on a minimal number of parameters which are necessary to demonstrate the investigated phenomena: the avalanche area a and avalanche size s. Here the avalanche area a is the number of lattice sites that have relaxed at least once during the avalanche. The avalanche size s is the total number of relaxations that occurred during the avalanche. The probability distributions of these variables are usually described as power-laws with cuto

where x = a;s:W hen the system size L goes to in nity, the cuto x_c diverges as $x_c = L^{D_x}$. If we assume FSS, then the set of exponents $(x;D_x)$ from Eq. (6) de nes the universality class of the model [10].

The avalanche area probability distribution P (a) and avalanche size probability distribu-

tions P (s) have been analyzed at nite lattice sizes L = 256;512, and 1024. It is expected that these distributions follow a power-law P (x) $x \times Eq$. (6)]. For any lattice size L and density c the corresponding scaling exponents $_{x,L}$ (c) were determ ined. The scaling exponents found in the num erical simulations for the largest lattice size L = 1024 and for selected densities c are presented in Table I. It is evident that the exponents are increasing with c in the interval 0 < c < 0:1 and then for densities c > 0:1 they are alm ost constant.

The scaling exponents $_{x,L}$ show a nite size e ect when the lattice size L is changed. Their dependences on lattice sizes L are approximated by a formula proposed by M anna [17]

This approximation was used to extrapolate the scaling exponents $_{\rm x;L\,!\,\,1}$ for the in nite lattice L ! 1 .




FIG.1: (Color online) The avalanche area and size scaling exponents $_{a;L!\ 1}$ and $_{s;L!\ 1}$ are approximated for the in nite lattice size L ! 1. The exponents depend on the density c of M anna sites.

The avalanche size probability distributions P (s) obey the power-law dependence for any density c. The corresponding scaling exponents $_{s;L!\ 1}$ (c) are shown in the Fig. 1. In the range of densities 0:01 c 0:1 these scaling exponents decrease from $_{s;L!\ 1}$ (0:01) = 1:37 0:025 to $_{s;L!\ 1}$ (0:1) = 1:29 0:025 and then, for higher densities c > 0:1, are alm ost constant.




FIG. 2: (Color online) The avalanche area distribution P (a) does not follow exactly a power-law function. The parameters used in the num erical simulation were: density c = 0.01 and linear lattice size L = 1024.

The avalanche area scaling exponents $_{a,L!\ 1}$ show a more complex dependence on the density c. For densities 0:09 c 0.5 they decrease from $_{a,L!\ 1}$ (0:09) = 1:49 0:025 to $_{a,L!\ 1}$ (0:5) = 1:38 0:025, then for higher densities c > 0:5 the exponents $_{a,L!\ 1}$ (c) are almost constant. It was observed that for densities 0:01 c 0:09 the avalanche area distributions P (a) do not follow exactly a power-law dependence as it is expected from Eq. (6). Therefore the exponents $_{a,L!\ 1}$ (c) from this density interval are not included in Fig. 1. O ne typical example is shown in Fig. 2 where the density of random toppling sites is

c = 0.01 and the lattice size is L = 1024. The double-log plot of area distribution function P (a) clearly shows that a possible approximation function is not a straight line which must correspond to the simple power-law dependence.

For the two well known sandpile models, BTW (c = 0) and M anna (c = 1) the scaling




FIG. 3: (C obr online) The extrapolated spectra of the avalanche area a and avalanche size s for various densities of M anna toppling sites: (a) c = 0 BTW m odel, which show smultifractal scaling, (b) c = 0.01 at which the multifractal scaling of BTW m odel is destroyed, and (c) c = 0.95 where the m odel show s the FSS near the two-state M anna m odel (c = 1). The m axim al error bars of f (;c) are for q = 0, and are approximately = 0.05, but for a higher q they are smaller. The values are determined within errors = 0.025.

exponents $_{a;L!\ 1}$ (0) = 1.26, $_{s;L!\ 1}$ (0) = 1.23, $_{a;L!\ 1}$ (1) = 1.36, and $_{s;L!\ 1}$ (1) = 1.27 were found. In addition, for all densities c (see Fig. 1) the relation $_{a;L!\ 1}$ (c) > $_{s;L!\ 1}$ (c) is valid.

The scaling exponents $_{x;L}$ as functions of the lattice size L show a nite-size scaling e ect [Eq. (7)]. An exact determ ination of scaling exponents $_{x;L! 1}$ from num erical experiments

is therefore a di cult task. A new method was introduced [6] to increase the numerical accuracy of the exponents based on their direct determ ination. We found that the method gives slightly larger exponents than a simple extrapolation of Eq. (7). However, the exponents $_{\rm s}$ do not uctuate around their mean values as it was observed in the paper [6]. Our error bars were larger, therefore we have to repeat this analysis again in more details.

Tebaldi et al. [11] found that in the BTW model the avalanche area distributions P (a) show FSS and avalanche size distribution P (s) scale as a multifractal. To describe these scaling properties rather a multifractal spectrum f() versus than the single scaling exponent $_{s}$ [Eq. (6)] is necessary. Thus, the scaling exponent $_{s}$ bees the importance and is replaced by a spectrum of exponents. Despite this fact, the avalanche size scaling exponents $_{sil,l}$ (0) are determined. They enable a comparison with the previous results, since the whole point is that the exponent $_{s;L! 1}$ (0) does not exist. The recent studies [11, 12] led us to analyze the multifractal properties of the model given by Eqs. (2)-(5) for various densities c. To determ ine the multifractal spectra a method presented in the paper [12] was useful. There, for any nite-size lattices L, the quantities $x(q;L) = hlog(x)x^{q}i = [log(L)hx^{q}i]$ and log ($hx^{q}i$) = log (L) were computed. It was observed that $_{x}$ (q; L) and $_{x}$ (q; L) show _х (q;L) a nite-size dependence on the system size L, which is well approximated by Eq. (7) and this relation was used to extrapolate L ! 1 quantities. Based on the Legendre structure relating f_x to x, a parametric representation of f_x (x) by plotting $f_x(q) = x(q)$ y(p) x versus $_{x}$ (q) can be obtained [12].

Some signi cant spectra of $f_x(x;c)$ extrapolated for an in nite lattice size L ! 1 are shown for illustration in Fig. 3. The $f_x(x;c)$ values were determined for the parameter q in the range 3.5 < q < 3.5 and they are limited by errors about 0.08, similarly as in Ref. [12]. We have observed that if $f_x(x;c)$ spectra are computed for all avalanches where a > 50 then the errors of $f_x(x;c)$ are 0.05. The multifractal scaling of the avalanche size probability distribution P (s) and FSS of avalanche area probability distribution P (a) were found at density c = 0 (see Fig. 3 (a)). The avalanche probability distributions P (x) show FSS for densities c = 0.01 Fig. 3 (b), and for c = 0.95 Fig. 3 (c) which is close to the M anna m odel (c = 1). The spectra for c = 0 and 1 agree well with the previous results [12]. It was found that the multifractal scaling of P (s) was destroyed (Fig. 3 (b)) at a relatively sm all density of M anna sites 0 < c < 0.01.

Stella et al. [12] claim that if probability distributions P (x) satis ed FSS the large q data




FIG. 4: (C olor online) A crossover from multifractal scaling to nite size scaling takes place at 0 < c < 0.01. The hatched area border an interval of f (c) in which f (c) = 0 and probability distributions P (x) show nite size scaling. We note that f (c) = f_a^{m in} (_a;c) f_s^{m in} (_s;c).

accumulate in the same value $f_x(x)$ where $\int_x^{max} = D_x$ and $f_x = (x - 1)D_x$. However, for probability distribution showing the multifractal scaling there is no accumulation point and $f_x(x)$ points shift progressively down as the parameter q is increasing and the parameter q approaches D_x . This fact is utilized as a simple criterion to recognize which probability distributions show eithermultifractal scaling or FSS [12]. The equality $f_a^{min}(a;c) \doteq f_s^{min}(s;c)$ is considered to be an attribute that probability distributions P (x) show FSS. To test this equality the differences f(c) defined as $f(c) = f_a^{min}(a;c) = f_s^{min}(s;c)$ were determined. The equality f(c) = 0 is considered for true if jf(c)j = 0.10 which refers numerical errors. The differences f(c) are shown in Fig. 4 where the hatched area limits the region where the equality is true and thus the avalanche probability distributions P (x) show FSS behavior. It is clearly evident that only one value of f(c) at the density c = 0, is outside the region jf(0)j > 0.10, and it corresponds to multifractal scaling of the BTW model [11, 12]. We have no data from the interval of densities 0 < c < 0.01 and thus we may only expect that a crossover from multifractal to FSS takes place in this interval.




FIG.5: (C olor online) The capacity fractal dimensions D $_{x=a;s}$ (c) as functions of the density c. The error bars are 0:025.

The $f_x(x;c)$ spectra enable us to determ ine the capacity fractal dimensions $D_x(c)$ as $D_x(c) = \frac{m \, ax}{x}(c)$. The results $D_x(c)$ for densities 0 c 1 are shown in the Fig. 5. For the BTW model $D_x(0) = 2:88$ 0:025 and $D_a(0) = 2:02$ 0:025, and for the M anna model $D_s(1) = 2.77$ 0.025 and $D_a(1) = 2.03$ 0.025 were found. The avalanche area capacity fractal dimensions $D_a(c)$ are almost constant $D_a(c) = 2$, for any density c, and $D_a(0) = D_a(1)$. In the interval of densities 0.01 < c < 0.15 the avalanche size dimension $D_s(c)$ is decreasing from $D_s(0.01) = 2.90$ to the value $D_s(0.15) = 2.78$ and is then almost constant for c > 0.15, nally $D_s(0) > D_s(1)$.




FIG. 6: (C olor online) The scaling exponents were determ ined using $_{x}(c) = 1$ $f_{x}^{m \text{ in}}(c)=D_{x}(c)$, for the moment analysis all avalanches where a > 50 were taken into account.

The m one ent analysis m ethod [12] was used to clarify interesting properties of the scaling exponents $_{x,L! \ 1}$ (c) which are shown in Fig. 1. The values of the functions $f_x^{m in}$ (c) and D $_x$ (c) (Fig. 5) are determined from the f_x ($_x$; c) plots. For specific densities c = 0 (the BTW model) and c = 1 (the M anna model) $f_a^{m in}$ (0) = 0.43 0.05 and $f_s^{m in}$ (1) = 0.784 0.05 were found. Then the scaling exponents are given $_x$ (c) = 1 $f_x^{m in}$ (c)=D $_x$ (c) and are shown in the Fig. 6. For the density c = 0, it was found $_a$ (0) = 1.213 0.0125. For the densities 0.01 c 0.15, the exponents decrease from $_a$ (0.01) = 1.441 0.0125 and $_s$ (0.01) = 1.329 0.0125 to the values $_a$ (0.15) = 1.394 0.0125 and $_s$ (0.15) = 1.299 0.0125, which are subsequently constant for c > 0.15. For the density c = 1, they are $_a$ (1) = 1.386 0.0125 and $_s$ (1) = 1.297 0.0125. These results are similar to those determined directly from the distribution functions P (x) x x (Fig. 1).

IV. DISCUSSION

The plots of x_{L} vs. $1=\ln L$ and an approximation given by Eq. (7) were used to extrapolate scaling exponents $x_{x,L! 1}$ [6, 17]. Lubeck and U sadel [6] have analyzed an in uence of an uncertainty in the determ ination of the exponents x,L on the precision of the extrapolated exponents $x_{j,L+1}$. Their results show that this method is not very accurate. However, this approximation enables us to make a comparison of our results with previous ones. The scaling exponents of the BTW model $_{a;L!1}$ (0) = 126 and $_{s;L!1}$ (0) = 123 (Fig. 1) are approximately the same as those found in Ref. [6] ($_a = 1.258$ and $_s = 1.247$) using the same method. The exponents of the M anna model $_{a;L!1}$ (1) = 1:36, and $_{s;L!1}$ (1) = 127 are comparable with the previous results, $s_{L=1024} = 128$ 0.02 [2] and with a = 1.373and s = 1275, which were found by direct determ ination of exponents [6] or calculated from the moment analysis a = 136 and s = 128 [18]. The results obtained by the moment analysis [12], $f_a^{m \text{ in}}(0) = 0.43 \quad 0.05 \text{ and } f_s^{m \text{ in}}(1) = 0.784 \quad 0.05$, agree well with the previous results, a = 0.391 0.011 and s = 0.7900 0.002 [18]. We may conclude that the experimental data for two known densities, c = 0 and 1, and data analysis methods give approximately the same exponents as were found in previous num erical experiments [2, 6, 18].

The scaling exponents de ned by Eq. (6) [3] and the conditional exponents $_{xy}$ [7, 19] can

characterize the sandpile models. The theory predicts $_{s} = 1.253$ [4] and a few numerical experiments show D_s ' 2:7 and D_a ' 2 [4, 10]. The conditional exponents $_{sa}$ determined directly from the numerical experiments are $_{sa}(0) = 1.06$ and $_{sa}(1) = 1.23$ [7].

Let us assume that the BTW and M anna m odels belong to the same universality class. Then the scaling exponents $_{x}(c);D_{x}(c) \mathbb{E}q$. (6] of the model (Eqs. (2)-(5)) must be independent on the density c, i.e. $_{x}(c) = \text{const:}$ and $D_{x}(c) = \text{const:}$ This means that knowing only the scaling exponents ($_{x}(c);D_{x}(c)$), we could not distinguish how m any sites are toppling by determ inistic or stochastic m anner $\mathbb{E}q$. (5)].

We observed that the capacity fractal dimensions $D_a(c)$ is constant for any density c, $D_a(c) \stackrel{!}{=} 2$. The capacity fractal dimension $D_s(0) = 2.88$ is the same as was found in the Ref. [12], $D_s \stackrel{!}{=} 2.86$ (determ ined from the Fig. 1 (a) in [12]). Our capacity fractal dimension $D_s(1) = 2.77$ is higher than the value D' 2.7 [2, 10], however it is closer to the D' 2.75[13]. In addition, for densities 0.01 c 0.1, the scaling exponents $_{x,L! \ 1}$ (c), $_x$ (c) (Figs. 1 and 6) and $D_s(c)$ (Fig. 5) depend on the density c. These scaling exponents and capacity fractal dimension are not constant. They demonstrate that the assumption about a single universality class is wrong and thus con rm the existence of dimension dimension and classes.

The conditional scaling exponents $_{xy}$ [19] can be determined as $_{xy}(c) = (_{y}(c) = (_{x}(c) = (_{x}(c) = (_{x}(c) = (_{y}(c) = (_{x}(c) = (_{x}(c$

To determ ine the exact scaling exponents of the probability distribution functions P (x), the experimental data must show a power-law dependence given by Eq. (6). However, the avalanche area size distributions P (a) do not follow exactly power-law distributions for densities 0 < c 0:1 in the whole range of avalanche area sizes, a typical example is shown in the Fig. 2. Chessa et al. [10] found that the area size distribution P (a) of the BTW model (c = 0) is not compatible with the FSS hypothesis in the whole range of avalanches. However, for large size of avalanches the FSS form must be approached. They assume that the scaling in the BTW model needs sub-dom inant corrections of the form P (x) = ($C_1x^{-1} + C_2x^{-2} + \cdots$)F (x=x_c) where C_1 are nonuniversal constants and that these corrections do not determ ine universality class. The asymptotic scaling behavior is determined by the leading power law. We assume that the deviation from a simple power-law for densities 0 < c 0:1 (Sec. III) could be explained by this correction. We

observed that the exponents for large avalanches a are larger than the approximate exponents $(_{a,L=1024} = 1.23 \text{ in the Fig. 2})$ which cover the whole range. As a consequence, the leading exponents $_{a,L}$ (c) for densities 0 < c < 0.1 are higher than the approximate exponents which we found (they are not shown in the Fig.2 for 0 < c = 0.09). It is evident that the leading scaling exponents $_{a,L}$ are dimensional are not constant (Fig. 1) as in the case of the BTW model or the M anna model and thus the model for these densities belongs to a dimensional class than the BTW model or the M anna model.

D ivergences from the expected power-law behaviour of the BTW model and a need of sub-dom inant correction were observed in another inhom ogeneous sandpile model [15]. Here the avalanche dynam ic was disturbed by sites which had the second higher threshold. The e ect was signi cant for thresholds E $_{\rm C}$ 32 and low concentration of such sites [15].

The multifractal properties (Fig. 3) of the model given by Eqs. (1)–(5) for the density c = 0 (the BTW model), and FSS for the density c = 1 (the M anna mode) agree well with the recent results [12]. In addition, the crossover from multifractal to FSS was observed in the Fig. 4. Our results can only predict that a critical density is expected to be found in the interval of densities 0 < c < 0.01 (Figs. 3 and 4). This interval is ve times smaller than what was found in R ef. [13] where the results are based on the autocorrelation function of the avalanche wave time series [20].

W e assume that divergences from power-law dependences in inhomogeneous conservative models, [15] and Eqs. (1)-(5), have a common reason which is connected to the crossover from multifractal scaling to FSS [13]. In both models a disorder is induced by deployment of disturbing sites. These disturbing sites either increase the short range coupling during relaxations in deterministic model [15] or introduce the random toppling Eq. (5)]. In these models toppling in balance [13, 14] only for a few such sites can change character of waves in the models from coherent to more fragmented waves [7, 8, 9, 12].

In this study, the multifractal properties of the BTW model which is initially hom ogeneous, are destroyed at very low concentrations of such disturbing sites. In the opposite case, the M anna model shows the FSS and resistance to disturbance caused by presence of BTW sites because all signi cant exponents from Eq. (6) are approximately constant in a broad range of densities 0:15 c 1. One possible explanation for this is that the nature of the small perturbation of the model is not the same when we perform changes around the densities at c = 0 and c = 1. A small perturbation of the dynamical rules of the BTW

m odel (c = 0) breaks the toppling symmetry [13] and this may explain why the changes in the scaling exponents $_{x}$ (c) and capacity fractal dimension D $_{s}$ (c) are so unexpected. On the other hand, for the M anna m odel (c = 1), decreasing of the density c cannot in unce the unbalanced toppling symmetry of the M anna m odel [13]. For sandpile m odels which show FSS this is an expected result and agrees well with the theory [4, 10], where a sm all m odi cation of toppling rules cannot change the scaling exponents.

We can clearly identify two universality classes which correspond to the classes proposed in papers [7] or [13]: (a) nondirected models, for density c = 0 (BTW model, them ultifractal scaling [5, 11, 12]), and they show a precise toppling balance [13] and they are sensitive on disturbance of avalanche dynamics, (b) random relaxation models, for densities 0.1 < c < 1where FSS of P (x) is verified, they are nondirected only on average (M anna two-statemodel c = 1 [7]). In these models breaking of the precise toppling balance [13] is observed, the scaling exponents are resistant to disturbance of avalanches. The classic cation for densities 0 < c < 0.1 is not so clear. If we follow the proposed classic cations then the model is a random relaxation model [7] with broken precise toppling balance [13] and it belongs in the same class as the M anna model. On the other hand, the scaling exponents differ from the M anna model and they are not universal ($_x(c) \in const., D_s(c) \in const.$), and the reasons of the sub-dom inant approximation of area probability distribution functions [10] can play an important role. We assume that a new universality class between the BTW (c = 0, multifractal scaling) and the M anna (c > 0.5, FSS) classes [13, 14] could be identi ed for densities 0 < c < 0.1. However, a more detailed study is necessary to verify this classic cation.

O ur additional arguments to the previous results [5, 6, 7, 8, 9, 13, 15] show that small modi cations of the dynamical rules of the model can lead to dierent universality classes what is considered to be unusual from a theoretical standpoint [10].

V. CONCLUSION

In these computer simulations multifractal scaling of the BTW model [11] and FSS of the M anna model [12] were con med. In addition, a crossover from multifractal scaling to FSS [13] was observed when avalanche dynamics of the BTW model was disturbed by M anna sites which were random ly deployed in the lattice, as their density was increased. This crossover takes place for a certain density c in the interval 0 < c < 0.01. This interval is ve times smaller than what was found recently [13]. The scaling exponents $_{x}$ (c) and the capacity fractal dimension D $_{s}$ (c) are not constant for all densities c which is necessary if the models [1, 2] belong to the same universality class. These result agree well with the previous conclusions that multifractal properties of the BTW model [5, 11, 12], toppling wave character [7, 8, 9] and precise toppling balance [13, 14] are in portant properties for solving the universality issues.

An open question remains about how to characterize the universality class for densities 0.01 < c < 0.1, where the scaling exponents are not universal ($_x$ (c) \in const. and D $_s$ (c) \in const.) and in addition, the avalanche probability distributions P (a) do not show exact power-law behavior since the sub-dom inant corrections of P (a) [10] are important. In this interval of densities c, our m odel belongs to the random relaxation m odels [7] and to the m odels with unbalanced toppling sites [13, 14], how ever, its scaling exponents are not equal to the exponents of the M anna m odel.

Based on the previous ndings [13, 14] and our results we assume that the avalanche dynam ics of undirected conservative models, in which some of the probability distribution functions show a multifractal scaling (the BTW model), is disturbed by suitable toppling nules which are dimensioned from the two-state M anna model (for example a stochastic four-state M anna model [7, 9]), then a local manner for the energy distribution during the relaxation can be important and can change the scaling exponents. However, the models which show the FSS for all probability distribution functions (the M anna model) are not sensitive to the details of the toppling nules and are consistent with theoretical predictions [4, 10].
