# Crossover between Local-M om ent M agnetism and Itinerant-Electron M agnetism in the t-J M odel

# Abstract

A Kondo-lattice theory is applied to the t-J model on a quasi-two dimensional lattice. The K ondo tem perature  $T_K$  or  $k_B T_K$  is de ned as an energy scale of local quantum spin uctuations, with k<sub>B</sub> the Boltzm ann constant. The bandwidth W of quasiparticles, which is approxim ately given by W ' 4k<sub>B</sub>T<sub>K</sub>, is renorm alized by the Fock-type term of the superexchange interaction. When the lifetime width of quasiparticles is so small and temperature T is so low that = W  $^{<}$  1 and  $k_B T = W^{-1}$ , the renormalization is large. Even in the limit of the half lling, for example, the bandwidth W is nonzero and of the order of i J i with J the superexchange interaction constant between nearest neighbors. The K ondo tem perature  $k_B T_K$  , which also gives a measure of the strength of the quenching of magnetic moments by local quantum spin uctuations, increases away from the half ling; it is smaller for larger . Therefore, local-moment magnetism, which is  $T_{K}$  , with  $T_{N}\,$  the Neel tem perature, appears for almost half  $\,$  llings, and characterized by T<sub>N</sub> it in erant-electron m agnetism , which is characterized by  $T_{\rm N}$   $^{<}$   $T_{\rm K}$  , appears for llings away from the half lling;  $T_N$  is higher for larger . The antiferrom agnetic region as a function of electron llings is wider for larger; this result in plies that it is wider in more disordered systems than it is in less disordered ones. The di erence or asymmetry of disorder between electron-doped and hole-doped cuprate oxide superconductors must be, at least partly, responsible for that of antiferrom agnetic phases between them .

# I. IN TRODUCTION

The discovery<sup>1</sup> in 1986 of high critical-tem perature (high-T<sub>c</sub>) superconductivity in cuprate oxides has revived intensive and extensive studies on strong electron correlations because it occurs in the vicinity of the M ott-H ubbard m etal-insulator (M -I) transition or crossover. W hen no electrons or holes are doped, cuprates are insulators; they exhibit antiferrom agnetism at low tem peratures. W hen enough electrons or holes are doped, they becom em etals; they exhibit superconductivity at low tem peratures. The M -I transition or crossover and the transition between antiferrom agnetic and param agnetic phases as a function of doping concentrations are asymmetric between electron-doped and hole-doped cuprates<sup>2</sup>; the insulating phase is much wider in electron-doped ones than it is in hole-doped ones. It is plausible that a relevant theory can explain not only high-T<sub>c</sub> superconductivity but also the asymmetry of the M -I transition or crossover and that of the N well tem perature.

In 1963, three distinguished theories on electron correlations in a single-band model, which is now called the Hubbard model, were published by Kanamori,<sup>3</sup> Hubbard,<sup>4</sup> and Gutzwiller.<sup>5</sup> Two theories among them are related with the M-I transition or crossover. A coording to Hubbard's theory,<sup>4</sup> the band splits into two subbands called the lower and upper Hubbard bands. A coording to Gutzwiller's theory,<sup>5</sup> with the help of the Ferm i-liquid theory,<sup>6,7</sup> a narrow band of quasiparticle appears on the chemical potential; we call them Gutzwiller's band and Gutzwiller's quasiparticles. The combination of the two theories in plies that the density of states must be of a three-peak structure, Gutzwiller's band between the lower and upper Hubbard splitting occurs in both m etallic and insulating phases as long as the onsite repulsion U is large enough, and Gutzwiller's band or that it can behave as a bad m etal or an insulator when lifetim e widths of Gutzwiller's quasiparticles are larger than their bandwidth.

N ot only Hubbard's<sup>4</sup> and Gutzwiller's<sup>5</sup> theories but also the previous theory<sup>8</sup> are within the single-site approximation (SSA). This fact in plies that local electron correlations must be responsible for the three-peak structure. Local electron correlations are rigorously considered

in SSA that includes all the single-site term s; such an SSA is rigorous for paramagnetic phases with no order parameter in in nite dimensions.<sup>9</sup> It is reduced to solving the Anderson model,<sup>10,11,12</sup> which is one of the simplest elective H am iltonians for the K ondo problem. This approximation is often called the dynamical mean-eld theory (DMFT).<sup>13</sup> The K ondo problem has been almost settled or almost completely clari ed<sup>14,15,16,17,18,19</sup>. The K ondo temperature  $T_K$  or  $k_B T_K$  is dened as an energy scale of local quantum spin uctuations, with  $k_B$  the Boltzm ann constant. Gutzwiller's band between the lower and upper H ubbard bands corresponds to the so called K ondo peak between two sub-peaks; its bandwidth W is about W '  $4k_B T_K$ .

O ne of the m ost essential physics involved in the K ondo problem is that a m agnetic m om ent is quenched by local quantum spin uctuations so that the ground state is a singlet<sup>14</sup> or a norm alferm i liquid.<sup>16,17</sup> A strongly correlated electron liquid on a lattice is a norm alferm i liquid at T <sup><</sup> T<sub>K</sub>, where m agnetic m om ents are quantum -m echanically quenched, while it is a nondegenerate Ferm i liquid at T T<sub>K</sub>, where m agnetic m om ents are therm ally quenched. Local-m om ent m agnetism occurs at T T<sub>K</sub>, and it inerant-electron one occurs at T <sup><</sup> T<sub>K</sub>; superconductivity can only occur at T T<sub>K</sub>. The M -I transition or crossover is related with the crossover between local-m om ent m agnetism and it inerant-electron m agnetism.

The coherence of quasiparticles is destroyed by not only thermal uctuations but also disorder. When  $k_B T = W$  or W, with the quasiparticle lifetime width, quasiparticles are never well-de ned; the liquid behaves as a bad metal or an insulator. When  $k_B T \leq W$  and  $\leq W$ , on the other hand, they are well-de ned; the liquid behaves as a metal. D isorder can also play a signi cant role in the M-I transition or crossover.

K ondo-lattice theories<sup>20,21,22</sup> have been developed so far mainly in order to elucidate strong electron correlations in typical or canonical K ondo lattices of lanthanide and actinide alloys, which are also called dense K ondo system s or heavy-ferm ion system s. In these canonical K ondo lattices, alm ost localized 4f or 5f electrons and itinerant conduction electrons coexist and conduction electrons can play an in portant role not only in the quenching of m agneticm on ents of alm ost localized electrons but also in the appearance of an intersite exchange interaction m ediated by conduction electrons such as the R uderm an-K ittel-K asuya-Y osida (R K K Y) exchange interaction<sup>23</sup> and the opening of the so called hybridization gaps or pseudogaps. In this paper, we are interested in electron correlations in non-canonical K ondo lattices such as transition-m etal alloys in the vicinity of the M –I transition or crossover,

where the coexistence of alm ost localized electrons and conduction electrons is absent or it plays no essential role even if it is present.

A K ondo-lattice theory developed in this paper is a perturbation theory starting from a starting or an unperturbed state constructed in a non-perturbative method, that is, SSA or DMFT; intersite terms are perturbatively considered in terms of intersite exchange interactions. This perturbation is nothing but 1-d expansion, with d being spatial dimensionality.<sup>9,10,11</sup> It has already been applied to typical issues on electron correlations in non-canonical K ondo lattices such as the M ott-H ubbard M -I transition,  $^{13}$  the Curie-W eiss law of itinerant-electron m agnets,  $^{24,25}$  it inerant-electron antiferrom agnetism  $^{26}$ and ferrom agnetism  $r_{1}^{27}$  and related issues to high-T<sub>c</sub> superconductivity  $r_{1}^{28,29}$  and so on. Early papers<sup>30,31</sup> on a mechanism of d-wave high-T<sub>c</sub> superconductivity can also be regarded within the fram ework of the K ondo-lattice theory. The interplay between correlations and disorder in a param agnetic phase is investigated for the Hubbard model with the just half lling.<sup>32</sup> One of the purposes of this paper is to study the interplay between correlations and disorder in the crossover between local-m om ent m agnetism and itinerant-electron m agnetism as a function of electron llings in the t-J m odel. This paper is organized as follows: The K ondo-lattice theory is reviewed in x II. A param agnetic unperturbed state is constructed in x III. A ntiferrom agnetic instability of the unperturbed state is studied in x IV . D iscussion is given in x V. Conclusion is given in x V I. The selfenergy of quasiparticles in disordered K ondo lattices is studied in Appendix.

# II. KONDO-LATTICE THEORY

# A. Renorm alized SSA

We consider the t-J m odel<sup>33,34</sup> or the t-t<sup>0</sup>-J-U<sub>1</sub> m odel with U<sub>1</sub> = tj! + 1 on a quasi-two dimensional lattice composed of simple square lattices:

with the transfer integral between nearest neighbors hiji,  $t^0$  between next-nearest neighbors hiji<sup>0</sup>,  $S_i = \frac{P}{2} + \frac{1}{2} + \frac{1$ 

sites. The t-J m odel (2.1) itself can only treat less than half llings. W hen the hole picture is taken, it can also treat m ore-than half llings. W e consider two m odels: a sym m etric one with  $t^0 = 0$ , where physical properties are sym m etric between less than half and m ore-thanhalf llings, and an asym m etric one with  $t^0 \in 0$ , whose precise de nition is m ade in x III. E ects of disorder and weak three dimensionality are phenom enologically considered in this paper. W e assum e J= $t_j$  = 0:3; t = (0:3-0:5) eV and J = (0:10-0:15) eV for cuprate oxide superconductors.

We follow the previous paper<sup>28</sup> to treat  $U_1$ . The selfenergy is divided into the single-site one ~ (i"<sub>n</sub>) and the multisite one (i"<sub>n</sub>;k). The single-site one ~ (i"<sub>n</sub>) is given by that of the Anderson model with the same  $U_1$  as that of the t-J model (2.1); other parameters should be selfconsistently determined to satisfy<sup>10,11</sup>

with N the number of sites, and  $\mathbb{G}$  (it  $_n$  ) and

the G reen functions of the Anderson and t-J m odels, respectively. Here, is the chem ical potential and E  $(k) = 2t_{1s}(k) - 2t_{2s}(k)$ , with

with a the lattice constant of the simple square lattices.

Note that the mapping condition (2.2) with eq. (2.3) depends on the multisite selfenergy, which should be perturbatively and selfconsistently calculated. There can be various approximations of singles-site selfenergies or dynamical mean elds depending on it. As is shown in x III, the multisite selfenergy includes an energy independent part, which is denoted by (k), because the superexchange interaction constant does not depend on energies in the t-J model. In this paper, we include only (k) in eq. (2.3); the G reen function that includes (k) instead of (i"\_n;k) is denoted by G<sup>(0)</sup> (i"\_n;k).

The K ondo tem perature  $T_K$  is de ned by

where  $\sim_{s}$  (i!<sub>1</sub>) is the spin susceptibility of the Anderson model, which does not include the conventional factor  $(1=4)g^{2} {}_{B}^{2}$ , with g and  ${}_{B}$  being the g factor and the Bohr magneton, respectively. The single-site selfenergy  $\sim$  (i"<sub>n</sub>) is expanded for j"<sub>n</sub> j  $\leq 2k_{B}T_{K}$  as  $\sim$  (i"<sub>n</sub>) =  $\sim$ (0) + (1  $\sim$ )i"<sub>n</sub> +  $\stackrel{P}{}_{0}$  (1  $\sim$  0)  $\circ$  + , with=  $\sim$  and in nitesimally small spin-dependent chem ical potential shifts. with  $= ( ~_{0})=$  and  $(k) = \mathbb{E}(k) + (k) =$ . We introduce a phenom enological lifetime width . A lithough depends on energies even if it is due to disorder, as is discussed in Appendix A, its energy dependence is ignored.<sup>35</sup>

A coording to the Ferm i-surface sum rule,<sup>6,7</sup> the number of electrons per site for  $T = T_K$  ! + 0 and  $=k_B T_K$  ! + 0 is given by

with (z) the di-gamma function. Note that  $f_{=0}$  (") = 1= [exp("=k\_BT) + 1]. We assume eq. (2.8) even for nonzero T and . The parameter  $\sim_0$  or can be determined from eq. (2.8) as a function of n.

# B. Intersite exchange interaction

In K ondo lattices, local spin uctuations at di erent sites interact with each other by an exchange interaction. Following this physical picture, we de ne an intersite exchange interaction  $I_s$  (i! 1;q) by

where  $_{s}(i!_{1};q)$  is the spin susceptibility of the t-J model to be studied. Following the previous paper,<sup>28</sup> we obtain

The single-site term is subtracted in  $F_s(i!_1;q)$  because it is considered in SSA. The expansion coe cient  $\sim_s$  appears as an elective or reducible single-site vertex function in eq. (2.14). Because the spin space is isotropic, the interaction in the transversal channels is also given by these equations. In the K ondo-lattice theory, intersite elects are perturbatively considered in term s of  $I_s(i!_1;q)$ ,  $I_s(i!_1;q)$ , or  $F_s(i!_1;q)$  depending on each situation.

# III. RENORMALIZATION OF GUTZW ILLER'S QUASIPARTICLES

In this section, we restrict the H ilbert space within param agnetic states. There are two types of selfenergies linear in the exchange interaction: Hartree-type and Fock-type term s. The Hartree-type term vanishes in param agnetic states. We consider the Fock-type term of the superexchange interaction:




FIG. 1: Renormalized transfer integrals t of the symmetric model: (a)  $k_B T=jj=0.02$ , (b)  $k_B T=jj=0.1$ , (c)  $k_B T=jj=0.2$ , and (d)  $k_B T=jj=0.4$ . In each gure, topmost solid, dashed, broken, chain, and chain double-dashed lines show results for =jj=0.01, 0.1, 0.2, 0.4, and 1, respectively. For comparison,  $1=^{-1}$  is also shown by a bottom solid line.

The factor 3 appears because of three spin channels. When only the coherent part is considered,

For the symmetric model,  $t^0 = 0$  so that  $t_2 = 0$ . In order to examine how crucial role the shape of the Ferm i surface plays in the asymmetry, we consider a phenomenological asymmetric model with  $t_2 = t = 0.3$ .

Expansion parameters  $\sim$  and  $\sim_s$  are given by those of the mapped Anderson model. However, we approximately use those for the Anderson model with a constant hybridization energy. A coording to Appendix of the previous paper<sup>27</sup>,




FIG.2: t of the asymmetric model for  $k_B T = tj = 0.02$ . See also the caption of Fig.1.




FIG. 3: Single-particle properties of the unperturbed state of the sym metric model. (a) Density of states for quasiparticles ("), (b) elective chemical potentials, , as functions of carrier concentrations n, and (c) n as functions of . In these three gures, solid, dashed, broken, chain, and chain double-dashed lines show results for  $=jt j = 10^{-3}$ , 0.1, 0.3, 1, and 3, respectively. Note that the solid and dashed lines are the alm ost same as each other. (d) Ferm i surfaces for  $k_B T = jt = 0$ , = 0, and 19 electron concentrations such as n = 0.1 i, with 1 i 19 being an integer. D ashed lines show Ferm i surfaces for n = 0.5, 1.0, and 1.5. Single-particle properties of the asym metric model can be found in Fig. 2 of ref. 28.

where = 1 n is the concentration of dopants, holes ( > 0) or electrons ( < 0). These are consistent with Gutzwiller's theory.<sup>5</sup> Figures 1 and 2 show t of the symmetric and asymmetric models as a function of for various . It is interesting that t is nonzero even for ! 0 if and k T are smallenough. For the symmetric model ( $t_2 = 0$ ), eq. (3.3) can be analytically calculated for T = 0 K, = 0 and = 0 ( = 0) in such a way that = 4= <sup>2</sup>. It follows that  $[t=t]_{!0}$  !  $3W_s^2 J=2^2 t = 0.18$  for J=t = 0.3. If or k T is large enough, on the other hand, and t vanish for ! 0.

Figure 3 shows physical properties of the unperturbed state of the symmetric model. Those of the unperturbed state of the asymmetric model can be found in Fig. 2 of ref. 28. In x IV, we study antiferrom agnetic instabilities of these paramagnetic unperturbed states.

#### IV. ANTIFERROMAGNETIC INSTABILITY

## A. Reduction of $T_{\rm N}$ by local spin uctuations

A coording to eq. (2.11), the N eel tem perature  $T_N$  is determined by the competition between the K ondo e ect and the intersite exchange interaction:

where Q is an ordering wave number to be determined. E ects of local spin uctuations in SSA or those of dynamical mean elds in DMFT are included in the local term of  $1=\sim_s (0)$ ;  $I_s(0;Q)$  corresponds to the conventional W eiss's mean eld, which is an intersite e ect and can only be included beyond SSA.

The local susceptibility  $\sim_s (0)$  is alm ost constant at T  $T_K$ , while it obeys the Curie law at T  $T_K$ . We use an interpolation between the two lim its:

Here,  $T_K$  is an averaged one over  $T_K$ 's at di erent sites. In disordered systems, the mapping conditions are di erent from site to site so that  $T_K$ 's are also di erent from site to site. Such disorder in  $T_K$  causes energy-dependent lifetime widths, as is studied in Appendix. However, lifetime widths due to the disorder in  $T_K$  are small on the chemical potential in case of non-magnetic impurities. According to eqs. (2.2) and (2.6) together with the Ferm i-liquid relation,<sup>18,19</sup> it follows that

in the absence of disorder. Then, a mean value of  $T_K$  in disordered system s is approximately given by eq. (4.3) with nonzero but small . It follows from eq. (4.3) that

with  $c_{T_{K}}$  a numerical constant depending on n. As is shown in Fig. 3(a), () '0.15 for 0.1 < =jtj < 1 and 0.05 < j j < 0.25. We assume that  $c_{T_{K}}$  is independent of n for the sake of simplicity:  $c_{T_{K}} = 0.15$ . We are only interested in physical properties that never drastically change when  $c_{T_{K}}$  slightly changes.

The magnitude of  $J_{\rm Q}$  (0;q) is proportional to  $k_{\rm B}\,T_{\rm K}$  or the quasiparticle bandwidth.




FIG. 4: Static polarization function  $\mathbb{P}(0;q)$   $P_0(0)$ ]t jof the symmetric model: (a)  $k_B T = t j = t j = 0:1$ , (b)  $k_B T = t j = t j = 0:3$ , and (c)  $k_B T = t j = t j = 1$ . Solid, dashed, broken, chain, and chain double-dashed lines show results for n = 1, n = 0:9, 0.8, 0.7, and 0.6, respectively. Here, , X and M stand for (0;0), (=a;0) and (=a; =a), respectively.




FIG.5:  $\mathbb{P}(0;q) = P_0(0)$  ]t jof the asymmetric model:  $k_B T = t j = -t j = 0:1$ . A solid line shows a result for n ! 1, dashed lines results of electron doping cases such as n = 1:1, 12 and 1.3, and broken lines results for hole doping cases such as n = 0:9, 0.8, and 0.7.

Figures 4 and 5 show  $\mathbb{P}(0;q)$   $P_0(0)$ ] of the symmetric and asymmetric models. The polarization function at q = (=a; =a) is relatively larger in electron-doping cases than it is in hole-doping cases.

# C . Reduction of $T_{\rm N}$ by the mode-mode coupling term

Following previous papers,<sup>37,38,39,40</sup> we consider m ode mode coupling terms linear in intersite spin uctuations  $F_s$  (i! 1;q) given by eq. (2.15):

The rst term  $_{L}$  (i!  $_{1}$ ) is a boal mode-mode coupling term, which includes a single boal four-point vertex function, as is shown in Fig. 4 of ref. 40. Both of  $_{s}$  (i!  $_{1}$ ;q) and  $_{v}$  (i!  $_{1}$ ;q) are intersite mode-mode coupling terms, which include a single intersite four-point vertex function; a single  $F_{s}$  (i!  $_{1}$ q) appears as the selfenergy correction to the single-particle G reen function in  $_{s}$  (i!  $_{1}$ ;q) while it appears as a vertex correction to the polarization function in  $_{v}$  (i!  $_{1}$ ;q), as are shown in Figs. 3(a) and 3(b), respectively, of ref. 40. In this paper, weak three dimensionality in spin uctuations is phenomenologically included. Because J (q) has its maximum value at q = (=a; =a) and the nesting vector of the Ferm i surface in two dimensions is close to q = (=a; =a) for almost half lling, we assume that the ordering wave number in three dimensions is Q = (=a; =a; Q), with  $Q_z$  depending on interlayer exchange interactions. On the phase boundary between paramagnetic and antiferrom agnetic phases, where eq. (4.1) is satisfied, the inverse of the susceptibility is expanded around Q and for small j! j in such a way that

A swas shown in the previous paper,<sup>28</sup>  $\cdot$  ' 1 for  $T=T_K < 1$  and  $=k_B T_K < 1$ . Physical properties for  $T=T_K$  1 or  $=k_B T_K$  1 scarcely depends on  $\cdot$ . Then, we assume  $\cdot = 1$  for any T and in this paper.




FIG. 6:  $T_N$  determ ined by eq. (4.23) for J=jj = 0.3 and = 0 as a function of the exponent x of the anisotropy factor de ned by  $A_z = A_k j = 10^{-x}$ .

When we ignore  $_{L}(0) = 5 = 2 \sim _{s}(0)$  and we assume  $T_{K} = 0$ , eq. (4.23) gives  $T_{N} = (1=4)J(Q)=k_{B} = jJ \neq k_{B}$ . This  $T_{N}$  is nothing but  $T_{N}$  in the mean-eld approximation for the H eisenberg model, to which the t-J model with the half lling is reduced. On the other hand, diverges at non zero temperatures for  $A_{z} = 0$ ; no magnetic instability occurs at nonzero temperature in complete two dimensions.<sup>41</sup> The reduction of  $T_{N}$  by  $_{L}(0)$  or by quasi-two dimensional therm also pin uctuations depends on the anisotropy of  $A_{z}=A_{k}$ . When only the superexchange interaction is considered,  $A_{k} = jJj$ . Although  $(1=4)J_{Q}(0;Q+q)$  also contribute to the q-quadratic term, we assume  $A_{k} = jJj$  for the sake of sim plicity. Figure 6 show  $T_{N}$  as a function of the exponent x of  $A_{z}=A_{k}j=10^{-x}$  for the half lling ( = 0). When we take x = 10, for example, we obtain  $T_{N} ' 0.06 \ddagger = 10^{-x}$  for the sake of sim plicity  $x = 10^{-x}$  in the following part of this paper.




FIG.7:  $T_N$  of the symmetric model as a function of = 1 n. From the bottom, solid, dashed, broken, chain, and chain double-dashed lines show  $T_N$  for  $=j_j=0.2, 0.3, 0.4, 1$ , and 2, respectively. The topm ost solid line shows  $T_N$  determined from eq. (4.23) for comparison. The solid line with a positive slope shows  $1=^{\sim}$ . Antiferrom agnetic states whose  $T_N$  are much above and below this line are characterized as local-moment ones and itinerant-electron ones, respectively, according to discussion in x V.




FIG.8:  $T_N$  of the asymmetric model as a function of . See also the caption of Fig.7. Note that  $T_N$  is almost symmetric between < 0 and > 0.

Figures 7 and 8 show  $T_N$  of the symmetric and asymmetric models as a function of = 1 n for various . The antiferrom agnetic phase becomes narrower as decrease. As long as is almost symmetric between > 0 and < 0, T is also almost symmetric between them.

When W or  $k_B T$  W,  $T_N$  is determined by the competition between the superexchange interaction J and two quenching e ects,  $1 = \sim_s (0)$  and  $_L (0)$ . The reduction of  $T_N$  for small j j is mainly due to  $_L (0)$ . On the other hand, the critical concentration  $j_c$  j below which antiferrom agnetic ordering appears at T = 0 K is determined by the competition between J and  $k_B T_K$ , because thermal spin uctuations vanish at T = 0 K. Because the K ondo e ect is rather weak,  $j_c$  j is as large as  $j_c$  j' 0:14, as is shown in Figs. 7 and 8.

When  $\langle W \rangle$  and  $k_B T \langle W \rangle$ , well-de ned quasiparticles can play roles in both of the enhancement and suppression of  $T_N$ . Antiferrom agnetism is enhanced by  $J_Q$  (i"<sub>n</sub>;q), in which the nesting of the Ferm i surface can play a signi cant role. However, the difference of the Ferm i surfaces cannot give any signi cant asymmetry of  $T_N$ . The reduction of  $T_N$  by the K ondo e ect is large. The intersite mode-mode coupling term,  $_{\rm s}(0;Q) + _{\rm v}(0;Q)$ , also suppresses  $T_N$  in addition to the local term s,  $k_B T_K$  and  $_{\rm L}(0)$ . The quenching e ects overcom e the enhancement e ect, and  $T_N$  decrease with decreasing .

#### V. DISCUSSION

One of the most serious assumptions in this paper is that the homogeneous life-time width of quasiparticles, which is phenom enologically introduced in this paper, can be de ned. This is relevant when there are many weak in purities and their distribution is totally random. When disorder is so small that quasiparticles are well de ned, electrons behave as Landau's Ferm i liquid. The assumption is obviously relevant in such a case. On the other hand, when disorder is so large in the vicinity of the M ott transition or crossover that quasiparticles are never well-de ned, electrons behave as localized m agnetic m om ents. plays no role, the theoretical fram ework of this paper must also be relevant in Because such a case. Then, an issues is whether the assumption is relevant or irrelevant in the crossover regime between the two regimes, for example, in the regime where the Anderson localization of quasiparticles occurs. Because the hom ogeneous lifetim e width can be de ned in the so called weakly localized regime of the Anderson localization,  $^{42}$  we expect that the results of this paper apply to such a regime. The assumption is irrelevant when scattering potentials of dopants are strong and the concentration of dopants is rather sm all. The strong Anderson localization, where the localization length is short, is out of scope in this paper. The crossover between the M ott-Hubbard insulator and the Anderson insulator, which is exam ined in ref. 32, is also out of scope in this paper.

O nem ay suspect that the theoretical fram ework of this paper cannot apply to the limit of ! 0 or to vanishingly small j j. A coording to the combination of G utzwiller 's theory and the Ferm i-liquid theory,<sup>6,7</sup> the bandwidth of quasiparticles is vanishingly small but is still nonzero such as W ' 8j tj. The Ferm i liquid state is formed, at least, at T 8j tj=k<sub>B</sub>; the spectral weight of quasiparticles is vanishingly small. It is obvious that when the renormalization of quasiparticles due to the Fock-type term of the superexchange interaction is taken into account the bandwidth becomes as large as jJ j, at least, at T 8j tj=k<sub>B</sub>. We show in this paper that these quasiparticles are stable not only for k<sub>B</sub> T 8j tj and

8j tj but also for  $k_B T$  jJ j and jJ j. The existence of elementary excitations or quasiparticles whose bandwidth is of the order of jJ j are in plied by several studies on the t-J m odel on sm all lattices.<sup>43,44,45</sup> Then, we can argue that when the H ilbert space is restricted within param agnetic phases no divergence of the elective m ass of quasiparticles or no M –I transition can occur except for J ! 0, ! 0, and T ! 0 K.W hat can occur for

nonzero J is a M -I crossover rather than a M -I transition, as is shown in Figs. 1 and 2.

The coexistence phase of a metal and a Mott-Hubbard insulator is obtained for the Hubbard model with the just half lling and nite onsite U.<sup>32</sup> It is interesting to exam ine whether or not the coexistence phase remains when the renormalization of quasiparticles by an intersite exchange interaction such as the superexchange interaction is included. It is also interesting to exam ine whether or not the coexistence phase remains for non-half llings.

Quasiparticles are well-de ned for T  $\leq$  T<sub>K</sub> and  $\leq$  k<sub>B</sub>T<sub>K</sub>. According to refs. 24 and 25, the exchange interaction J<sub>Q</sub> (+ i0;q), which arises from the virtual exchange of pair excitations of quasiparticles, show s an alm ost T -linear dependence consistent with the C urie-W eiss law at T  $\leq$  T<sub>K</sub> in a small region of q ' Q, with Q being the nesting wavenum ber, for itinerant-electron antiferrom agnets where the nesting of the Ferm isurface is signi cant.<sup>46</sup> O n the other hand, the T -linear dependence of  $1=\sim_{s}(0)$  at T T<sub>K</sub> is responsible for the C urie-W eiss law of local-m om ent m agnets or insulating m agnets. Then, m agnetism with T<sub>N</sub> T<sub>K</sub> is characterized as local-m om ent m agnetism appears for alm ost half llings, and itinerant-electron m agnetism appears for llings substantially away from the half lling.

Because no order is possible at non-zero tem peratures in two dimensions,<sup>41</sup> it is likely that  $T_N$  is substantially reduced by critical therm all uctuations in quasi-two dimensions. As is examined in x IV D, the reduction of  $T_N$  is large;  $T_N$  '  $0.2 j J = k_B$  for the anisotropy of  $A_z = A_k j = 10^{-10}$ . This explains observed  $T_N$  ' 300 K for cuprate oxides, when we take j J j ' 0:15 eV. The exponent 10 seems to be little larger than actual ones. We should consider the reduction of  $T_N$  by therm all critical uctuations more properly than we do in this paper.

The nesting of the Ferm i surface becomes less sharp as becomes larger, as is shown in Figs. 4 and 5. One may argue that antiferrom agnetism is weaken by disorder in the itinerant-electron regime where the nesting of the Ferm i surface plays a crucial role. However, this elect is overcome by the reduction of  $T_K$  by nonzero. The renormalization of the quasiparticle bandwidth by the superexchange interaction becomes small with increasing

so that the K ondo tem perature  $k_B T_K$  becomes small. On the other hand, the superexchange interaction is not reduced by nonzero . Then, antiferrom agnetism is strengthen with increasing even in the itinerant-electron region.

An antiferrom agnetic states appears in a narrow range of 0 j j 0.02{0.05 in hole-

doped cuprates oxides ( > 0), while it appears in a wide range of 0  $j \oint 0.13\{0.15 \text{ in} electron-doped cuprate oxides ( < 0). Tohyam a and M aekawa<sup>47</sup> argued that the asym m etry between hole-doped and electron-doped oxides m ust arises from the di erence of the Ferm i surfaces, and that the t-t<sup>0</sup>-J m odel should be used. They showed that the intensity of spin excitations is relatively stronger in electron doping cases than it is in hole doping cases. A coording to Fig. 5, the polarization function at q = ( =2a; =2a) is relatively larger in electron doping cases than it is in hole doping cases that it is in hole doping cases that it is consistent with that of spin excitations studied by Tohyam a and M aekawa. However, the di erence of the Ferm i surfaces cannot explain the asym m etry of T<sub>N</sub>, as is shown in Fig. 8.$ 

The condensation energy at T = 0 K of the asymmetric model is also quite asymmetric;<sup>48</sup> it is consistent with the asymmetry of spin excitations and the polarization function discussed above. On the other hand,  $T_N$  is significantly reduced by quasi-two dimensional spin uctuations as well as local spin uctuations of the K ondo elect. This large reduction of  $T_N$ arises from the renormalization of normal states; not only the Neel states but also param – agnetic states just above  $T_N$  are largely renormalized. It is plausible that the asymmetry of the condensation energy of paramagnetic states just above  $T_N$  is similar to that of the Neel states at T = 0 K. It is interesting to examine by comparing the condensation energy of the Neel states and that of paramagnetic states just above  $T_N$  whether  $T_N$  is actually alm ost symmetric as is shown in this paper.

E lectrical resistivities of electron-doped cuprates are relatively larger than those of holedoped cuprates are.<sup>49</sup> Then, we can argue that disorder must be relatively larger in electrondoped cuprates than it is in hole-doped cuprates, and that the asymmetry of  $T_N$  can arise, at least partly, from the difference of disorder between them. It is interesting to exam ine whether or not the symmetric behavior of  $T_N$  can be restored by preparing hole-doped and electron-doped cuprates with similar degree of disorder to each other.

W hen nonmagnetic in purities of Zn ions are introduced on  $CuO_2$  planes, antiferrom agnetic m on ents appear in the neighborhood of Zn ions.<sup>50</sup> B ecause the conguration of Cu ions is  $(3d)^9$  and that of Zn ions is  $(3d)^{10}$ , the phase shift at the chemical potential due to scatterings by Zn ions must be about =2 according to the Friedel sum rule. Then, scatterings by Zn ions must be very strong. One of the plausible scenarios is that the renormalization of  $k_B T_K$  by the Fock-type term of the superexchange interaction is small in the neighborhood of Zn ions because of strong scatterings, that is, the quenching of magnetic moments by local




FIG.9: t of the symmetric model as a function of for various and  $k_B T=tj=0.02; W_s' 1$ or r = 0.5 is assumed instead of  $W_s' 2$  or r = 1 (See text). From the top, solid, dashed, broken, and chain line show t for =tj=0.04, 0.1, 0.2, and 0.4, respectively. For the sake of comparison,  $1=^{-1}$  is also shown by a bottom solid line.




FIG.10:  $T_N$  of the symmetric model as a function of for various  $W_s'$  1 or r = 0.5 is assumed instead of  $W_s'$  2 or r = 1 (See text). From the bottom, solid, dashed, broken, and chain lines show  $T_N$  for  $=\pm j = 0.04, 0.1, 0.2$ , and 0.4, respectively. For comparison,  $T_N$  determined from eq. (4.23) is shown by a topm ost solid line.

quantum spin uctuations are weak there so that antiferrom agnetism is enhanced there. It is interesting to develop a microscopic theory that can treat such an inhom ogeneous e ect.

The three-point vertex function  $\tilde{s}$  and the mass-renormalization factor  $\tilde{s}$  are those in SSA;  $W_s = \tilde{s} = 2$  as is discussed in x IIA. When we take  $W_s '$  2, on the other hand, the superexchange interaction constants as small as jJj = 0.02-0.03 eV, which are much smaller than experimental ones jJj = 0.10-0.15 eV, give  $T_c$  as high as  $T_c = 50-150$  K,<sup>30,31</sup> which are as high as observed  $T_c$ . This implies that the renormalization of the vertex

function and the mass renorm alization factor by intersite e ects such as antiferrom agnetic and superconducting uctuations should be included. Taking it into account, we treat  $W_s$  as another phenom enological parameter following the previous paper,<sup>28</sup> where  $W_s = 0.7\{1$ is used instead of  $W_s$  ' 2 in order to explain observed  $T_c$  and observed coe cients of T linear resistivities when jJ j = 0.10-0.15 eV are used. Then, we replace  $W_s$  by  $rW_s$ , with r a num erical constant sm aller than unity; eq. (3.5) is replaced by

and eqs. (4.3) and (4.4) are replaced by those with  $rW_s$  instead of  $W_s$ .<sup>51</sup> Figures 9 and 10 show t and  $T_N$ , respectively, of the symmetric model as a function of for r = 0.5 and various . The antiferrom agnetic region extends with decreasing r.

An antiferrom agnetic state in the range of 0.02 of hole-doped La<sub>2</sub> M CuO<sub>4</sub> M = Sr or Ba) is characterized as a local-m on ent one. The so called spin-glass or Kum agai's phase<sup>52</sup> appears in the range of 0.02 < 0.05. We characterize the tail part of the solid line in Fig.10 as a critical line to the Kum agaiphase;<sup>53</sup> = jj' 0.04 are needed to reproduce Kum agai's phase. A coording to Fig. 9, j = tj' 0.05 for = 0.04. Then, we can argue that  $k_F l' 2k_B T_K = '4j = , with k_F$  the Ferm i wave number and 1 the mean free path, must be 4{8 in Kum agai's phase. A coording to Fig. 4(b), the nesting of the Ferm i surface is substantial at least for =j j < 0.3; the nesting cannot be ignored for =j j < 1. Kum agai's phase must be a spin density wave (SDW) state in a disordered system rather than a spin glass. The divergence<sup>52</sup> of the nuclear quadrupole relaxation (NQR) rate at T<sub>N</sub> supports this characterization.

# VI. CONCLUSION

The t-J m odel with J=j:j= 0:3 on a quasi-two dimensional lattice is studied. First, an unperturbed state is constructed in SSA or DM FT. The K ondo temperature  $T_K$  or  $k_B T_K$  is dened as the energy scale of local quantum spin uctuations. The unperturbed state is a normal degenerate or almost degenerate Ferm i liquid at T  $< T_K$  and is a non-degenerate Ferm i liquid at T  $T_K$ . No m etal-insulator transition is possible within paramagnetic phases; what occurs is a m etal-insulator crossover. The bandwidth W of quasiparticles, which is about W  $' 4k_B T_K$ , is renormalized by the Fock-type selfenergy due to the su-

perexchange interaction J, so that that W is larger for lower T and smaller , with being the phenom enologically introduced lifetime width of quasiparticles. The bandwidth W is approximately given by the sum of term s of O (j t) and O (jJ), with being the concentration of dopants added to the just half-led system; the term of O (j t) is consistent with Gutzwiller's theory, and the coe cient of the term of O (j j) is O (1) for  $k_B T = jW j^{<} 1$  and  $= jW j^{<} 1$  and is vanishingly small for  $k_B T = jW j 1$  or = jW j 1.

Next, antiferrom agnetic instability of the unperturbed state is examined perturbatively in terms of intersite exchange interactions. This perturbation theory can treat both of localm on ent magnetism and itinerant-electron magnetism. When  $T_N = T_K$ , with  $T_N$  the Neel temperature, or local thermal spin uctuations are dominant over local quantum spin uctuations at  $T_N$ , magnetism is characterized as localm on ent magnetism; it appear for alm ost half llings of electrons. In the opposite case where  $T_N \leq T_K$  or local quantum ones are dominant over local thermal ones at  $T_N$ , magnetism is characterized as itinerant-electron magnetism; it appears for llings away from the half lling.

The reduction of  $T_N$  by quasi-two dimensional therm alcritical uctuations is large when the anisotropy of the exchange interaction constants is large. For example,  $k_B T_N = jJj! = 0$ in complete two dimensions, as is expected. The Neel temperature  $T_N ' = 0.10-0.15$  eV and in cuprates with no doping can be explained, when we assume jJj = 0.10-0.15 eV and  $jJ_z=Jj' = 10^{-10}$ , with J and  $J_z$  the exchange interaction constants between nearest neighbors within a CuO<sub>2</sub> plane and between CuO<sub>2</sub> planes, respectively.

When W or  $k_B T$  W, W = O(j t) or  $k_B T_K = O(j t)$  so that the quenching of magnetic moments by local quantum spin uctuations is rather weak. Because them all spin uctuations vanish at T = 0 K, an antiferrom agnetic state is stabilized in a wide range of . When  $^{<}W$  and  $k_B T \stackrel{<}{W}$ , quasiparticles are well-de ned. Because the nesting of the Ferm i surface is substantial, the exchange interaction arising from the virtual exchange of pair excitations of quasiparticles is also responsible for antiferrom agnetic instability in addition to the superexchange interaction. On the other hand, the quenching of magnetic moments by local quantum spin uctuations is strong. Not only quasi-two dimensional thermal critical uctuations but also the quenching of magnetic moments by local quantum uctuations make  $T_N$  substantially reduced or they destroy antiferrom agnetic ordering. A n

antiferrom agnetic state is stabilized only for small j j the critical concentration  $j_c$  j below which antiferrom agnetic ordering appears is smaller for smaller . This result in plies that

 $T_N$  is lower and a magnetic phase is narrower in a cleaner system .

The di erence or asymmetry of disorder between electron-doped and hole-doped cuprates must be, at least partly, responsible for that of  $T_N$  and antiferrom agnetic phases between them . We characterize the so called K um agai's phase as a spin density wave (SDW) state in disordered system rather than a spin glass.

We assume non-magnetic impurities so that  $n_{j''} = n_{j\#}$ .

We denote the average number of electrons and their mean-square deviation by  $n = hn_j i_{dis}$  and  $n^2 = h(n_j n)^2 i_{dis}$ , respectively, where  $h_{dis}$  stands for an ensemble average over disordered systems. We assume that there is no correlation between di erent sites:  $h(n_i n)(n_j n)i_{dis} = 0$  for  $i \neq j$ .

We consider the site-dependent part of  $E_{dj} + \gamma_j$  ("+ i0) as a static but energy-dependent scattering potential; it is approximately given by

The energy-independent term can be ignored because  $\sim$  1 for almost half llings. It is quite likely that  $\sim$  n<sup>2</sup> = 0 (1) and = tj = 0 (1) for almost half llings.

It is straightforward to extend the above argument to a system in the presence of magnetic elds and a system with magnetic in purities. In such cases,  $n_{i''}$   $n_{i\#}$  can be different from site to site; Im  ${}^{(dis)}(" + i0) = \sim$  can be large even for " = 0.
