## Functional Integral for Ultracold Ferm ionic Atom s

We develop a functional integral form alism for ultracold gases of ferm ionic atoms. It describes the BEC -BCS crossover and involves both atom and molecule elds. Beyond mean eld theory we include the uctuations of the molecule eld by the solution of gap equations. In the BEC limit, we nd that the low temperature behavior is described by a Bogoliubov theory for bosons. For a narrow Feshbach resonance these bosons can be associated with microscopic molecules. In contrast, for a broad resonance the interaction between the atoms is approximately pointlike and microscopic molecules are irrelevant. The bosons represent now correlated atom pairs or composite \dressed molecules". The low temperature results agree with quantum M onte C arlo simulations. Our form alism can treat with general inhom ogeneous situations in a trap. For not too strong inhom ogeneities the detailed properties of the trap are not needed for the computation of the uctuation e ects - they enter only in the solutions of the eld equations.

#### I. IN TRODUCTION

U ltracold ferm ionic atom s can exhibit both the phenom ena of a Bose-Einstein condensate (BEC) [1, 2] of m olecules and the condensation of correlated atom pairs sim ilar to BCS-superconductivity [3, 4]. Recent experim entalprogress [5, 6, 7, 8] in the crossover region reveals the universality of the condensation phenom enon, as anticipated theoretically [9, 10, 11, 12, 13, 14].

In this paper we develop a system atic functional integral formulation for the treatment of the equilibrium state<sup>1</sup> of ultracold ferm ionic atom s. W e discuss in detail how to arrive at a form ulation that treats the ferm ionic uctuations of unbound atom s and the bosonic uctuations of the molecule or diatom eld on equal footing. An approach based on a Hubbard-Stratonovich transformation is an ideal starting point for a uni ed inclusion of uctuations of m olecules or \Cooper pairs". We show how this form alism can be implemented in practice in a self-consistent approxim ation scheme. We carefully discuss the renorm alization procedure that is needed to absorb the ultraviolet divergences in this nonrelativistic quantum eld theory. The result is an e ective low energy form ulation which is insensitive to the microphysical cuto scale .

We concentrate on dimensionless quantities by measuring all quantities in units of the Ferm im omentum  $k_{\rm F}$  or the Ferm i energy  $_{\rm F}$  =  $k_{\rm F}^2$ =2M . The inverse Ferm i momentum is the most important length scale in the problem , related to the total number density of atoms by  $k_{\rm F}$  =  $(3~^2n)^{1=3}$ . It measures the typical interparticle spacing. We show that the atom density does not appear as an independent parameter in the computations which

can be perform ed in term s of dimensionless ratios. This renders our form alism highly universal, since the results of experiments with dimension and densities can be related by simple scaling law s.

For this purpose, we introduce three dim ensionless param eters that characterize the crossover problem e ciently: First, the \concentration" c describes the ratio between the in-medium scattering length and the average distance between two unbound atoms or molecules. Its inverse, c<sup>1</sup>, sm oothly connects the weakly coupling BCS regime (c < 0; jcj1) with the BEC regime 1). The perhaps most interesting region is the crossover regime" in between, jc<sup>1</sup> j. 1. Second, a Yukawa or Feshbach coupling h characterizes the interaction between atom s and m olecules. The third param eter is the tem perature in units of the Ferm i energy, T = T = F. No further details of the \m icrophysics" are needed for the macroscopic quantities. In this sense the description becom es universal. In the language of quantum eld theory or critical phenom ena the param eters c and h describe relevant couplings for the long distance physics.

O ur form alism is well suited to describe all regimes of coupling and temperature, including the super uid phase with broken symmetry. As a rst application we compute the phase diagram for the crossover problem as described by the dependence of the critical temperature on c. The function T (c<sup>1</sup>) only depends on the value of  $\tilde{h}$  and shows universal limits for large  $jc^{1}j$  i.e. in the BCS or BEC regime, respectively. In the crossover region the dependence on the Yukawa coupling  $\tilde{h}$  is strongest. N evertheless, we nd that for the two limits  $\tilde{h}$  ! 0 (narrow resonance) and  $\tilde{h}$  ! 1 (broad resonance) the crossover becomes independent of  $\tilde{h}$ . For broad Feshbach resonances the Yukawa coupling becomes an \irrelevant" parameter.

In the narrow resonance  $\lim it$  for  $\hbar$  ! 0 the bosonic degrees of freedom can be associated with m icroscopic molecules. In this  $\lim it$  the molecule uctuations can

be neglected and mean eld theory becomes valid. In contrast, for  $\hbar$  ! 1 the microscopic molecule degrees of freedom play no role and the model is equivalent to a purely ferm ionic model with pointlike interactions. Nevertheless, e ective molecular bound states (\dressed molecules") become a crucial feature of the crossover physics.

For an actual com parison with experimental results one needs to relate the \universal parameters" to experimental observables, in particular the strength of the magnetic eld. This is done in [15], where we connect the scattering properties of atom s with the values of our universal parameters. The present paper may therefore be viewed as the theoretical basis for the more detailed com parison with experiment in [15]. Here we concentrate on the conceptual and form all developments.

A further aspect of universality concerns the geom etry of the trap. We will present a system atic \derivative expansion" which computes the e ects of uctuations and interactions independently of the shape of the trap. The details of the trap only enter at the end through the solution of e ective eld equations in presence of a trap potential. The system atic character of the derivative expansion allows for a quantitative estim ate of the reliability of sim ple approxim ations, like the \bcal density" resp. \Thom as Ferm i approxim ation" or the \bcal condensate approxim ation" frequently used in literature [16, 17, 18, 19, 20]. The e ective eld equation for the condensate has the sam e status as the (tim e independent) G ross-P itaevskii equation [21, 22, 23] for a B ose-E instein condensate.

O ur approach basically relies on two ingredients: The functional integral and the Hubbard-Stratonovich transform ation or partial bosonization. The partial bosonization permits us to formulate the problem microscopically as a Yukawa theory, thereby allowing to deal with nonlocal interactions. This route is also taken in [16, 17, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33]. The power of the functional integral techniques, how ever, is so far only m arginally used. A rst attempt in this direction was made by R anderia [11, 34]. Later, other approaches em – ployed this concept m ore as an argum entative tool than as a method for concrete calculations [25, 30, 31, 35]<sup>2</sup>.

Beyond the system atic functional integral form ulation and the emphasis on the universal aspects of the phase transition our work extends previous results by the system atic inclusion of the molecule uctuations. These uctuations are important for the quantitative understanding of the phase transition for a broad Feshbach resonance with a large dimensionless Yukawa coupling  $\tt M$ , as relevant for the present experiments in  $^6{\rm Li}$  and  $^{40}{\rm K}$ . For zero temperature our calculations agree well

with Q uantum M onte C arlo simulations  $[37]\,at\,the\,resonance.$ 

This paper is organized as follow s:

In sect. II we investigate the Feshbach resonance and introduce the important molecule degrees of freedom in terms of a di-atom or molecule eld (x). This allows us to cover the whole range of temperature and the crossover. The Bose-E instein condensate or the super uid order parameter corresponds to a nonvanishing expectation value  $h^{1}$ . We establish the equivalence of our form ulation with a purely ferm ionic form ulation for which the elective interaction between the atoms contains a nonlocal piece relating the molecule exchange. Only in the broad resonance limit h = 1 this interaction becomes pointlike.

O ur functional integral form ulation in terms of an independent eld (x) is particularly well adapted to the crossover from a BEC to a BCS condensate: M olecules and C ooper pairs are described by the same eld. O f course, the dynam ical properties depend strongly on the BEC or BCS regime. In particular, we compute in sect. III the gradient coe cient A which determ ines the gradient contribution to the free energy for a spatially varying m olecule eld. For the BEC regime, A is dom inated by the \classical value", corresponding to the dom inance of the tightly bound m olecules. In contrast, for the BCS regime the uctuation e ects dom inate A . In this case (x) can be associated to a collective degree of freedom

(C ooper pair). O ne could om it the classical contribution to A such that <sup>^</sup> becomes on the microscopic level an auxiliary eld. Indeed the presence of a molecular bound state is no longer crucial in the BCS regime. O ne may work in a purely ferm ionic setting with a local interaction which depends on a magnetic eld B. For a broad Feshbach resonance this feature holds for the entire crossover region.

W e discuss the derivative expansion of the e ective action in sect. III. In particular, sect. IIIA addresses the issue of additive renorm alization of the detuning and sect. IIIB computes the wave function renorm alization Z which distinguishes the \renorm alized eld" for the dressed molecules and the eld for the microscopic of \bare" molecules. W e turn in sect. IV to the discussion of the relevant parameters that describe the universal aspects of ultracold atom s. In terms of the dimensionless concentration c and Yukawa coupling ñ the system becom es independent of the detailed short distance properties.

Sect. V discusses the fraction of atom s bound in m olecules. It is crucial to distinguish between the \bare" or m icroscopic m olecules and the dressed m olecules [38, 39]. Their numbers are related by the multiplicative wave function renorm alization Z . In order to achieve a complete symmetry between the fermionic uctuations of unbound atom s and the bosonic uctuations of m olecules we adapt our functional integral setting in sect. V I. In sect. V II we turn to the BEC limit. For a broad Feshbach

resonance (large  ${\tt \tilde{h}}$ ) one nds very large Z , such that the condensate fraction (condensed dressed molecules) exceeds by far the number of microscopic molecules. The latter becomes completely negligible for  ${\tt \tilde{h}}$ ! 1. Nevertheless, we nd a Bogoliubov theory for bosons in the low temperature BEC regime for all values of  ${\tt \tilde{h}}$ . Finally, we include the molecule uctuations (or collective uctuations of diatom states) in sect. VIII in the form of new bosonic gap equations. We draw conclusions in sect. IX .

W hile the main part of this paper deals with a hom ogeneous situation our form alism can be extended to cover the inhom ogeneous situation in a trap of atom s if the inhom ogeneity is not too large. Since the main part is independent of the discussion of inhom ogeneities we display the form alism for inhom ogeneous situations in appendix A.

We introduce a general form alism for a functional integral which applies to arbitrary ferm ionic systems and is easily generalized to system s with bosons, far beyond the particular case of a Feshbach resonance (where diatom states play a role). In addition to the (G rassmann) eld variables ^(x) for the ferm ionic atom swe employ a bosonic eld variable (x). It corresponds to a varying e ective chem ical potential which is associated to the density eld n(x). This procedure allows computations for the inhom ogeneous setting of atom s in a trap beyond the sm all density approxim ation or beyond the Thom as-Fermi approximation. The bosonic eld variable is introduced by partial bosonization. We formulate the e ective action [] and establish the exact form al relations between (x), n(x), the chemical potential and the local trap potential  $V_1(x)$ .

# II. D ILUTE GAS OF ULTRACOLD ATOM S

The ultracold gas of ferm ionic atom s in the vicinity of a Feshbach resonance can be treated in the idealization of two stable atom ic states denoted by a two component spinor  $\hat{}$ . (For the example of <sup>6</sup>Li these states may be associated with the two lowest hyper ne states jli, j2i.) The molecular state responsible for the Feshbach resonance can be treated as a bosonic particle. In our idealization it is stable for negative binding energy and can decay into a pair of ferm ionic atom s for positive binding energy.

For a realistic description our form alism has to be capable to describe the following phenomena: (i) Condensates of atom pairs may form at low temperature, similar to the BCS description of superconductivity. (ii) Molecules of two atoms can be exchanged between the single atoms, thus contributing to the interaction. A loo these molecules may form a Bose-E instein condensate at low temperature. In our form alism both e ects nd a uni ed description as will be discussed in detail in this paper.

We work with a microscopic action which explicitly

includes a bosonic eld ^ with atom number two [25],

Here we employ the M atsubara form alism where the Euclidean time is wrapped on a torus with circum ference = 1=T with conventions

(O ur units are  $\sim$  = c =  $k_{\rm B}$  = 1.) W e will shortly see how this m icroscopic m odel relates to a purely ferm ionic setting by the m eans of a partial bosonization or H ubbard-Stratonovich transform ation.

The complex two-component spinors ^(x) are anticom muting G rassm ann variables. W e assum e an equal mixture of the two atom ic states. In this case the chem icalpotential associated to the di erence in the number of atom s in the \up" and \down" states precisely cancels the energy di erence between the two states such that both can be om itted. (For unequalm ixtures the action contains an additional term  $/ \frac{\gamma}{3}$ .) The bosonic molecules are described by a complex bosonic eld ^. The propagator for these \bare m olecules" is obtained from simple symmetry considerations, i.e. we assume a mass 2M, leading to a nonrelativistic kinetic energy ^ ^ involves the \bare"  $q^2 = 4M$ . The quadratic term binding energy or detuning ( ) which typically depends on the magnetic eld. In order to make contact to physical observables, has to be additively renorm alized, which is implemented in sect. IIIA.

We use here two di erent chem ical potentials and for the ferm ionic atom s and barem olecules. This is useful if we want to obtain separately the densities of ferm ionic atom s or bare m olecules by di erentiation of the free energy with respect to or . Since only the total num ber of atom s is conserved, one has to set = at the end of the com putations. The distinction between and is appropriate if one wants to understand explicitly the role of them icroscopic (orbare) m olecules. In sect. V I we will drop this distinction in favor of a m ore uni ed approach. There we will set = from the outset such that will be conjugate to the total density of atom s irrespective of a m icroscopic distinction between unbound atom s and m olecules. In the main part of this paper we will treat

and as constant classical source term s. However, we stress that this source term can be straightforwardly promoted to a uctuating eld,  $! ^{(x)}$ . This issue, and its use for the description of inhom ogeneities beyond the usual Local D ensity A pproximation, will be discussed in the appendix A.

The Yukawa or Feshbach coupling h describes the coupling between the single atom s and m olecules, =

,  $_{12} = 1.$  Forh ! 0 them olecular states decouple. However, in an appropriately performed \narrow resonance limit" h ! 0 which keeps the scattering length xed, an exact solution of the many-body problem becomes feasible above the critical temperature. A detailed analysis of this limit is given in [15]. Broad Feshbach resonances correspond to large h , and we will see that the limit h ! 1 describes a purely fermionic theory with pointlike interactions where microscopicm olecules can be neglected.

The therm odynamic equilibrium situation is described by the partition function. The basic ingredient for our form alism is the representation of this object in terms of a functional integral with weight factor e  $^{\rm S}$   $_{\rm B}$ , with S\_B the Euclidean action (1)

This form ulates the full quantum theory in terms of the sources and j for the ferm ion and the boson elds. All one particle irreducible n-point functions, including the order parameter and the correlation functions, can be directly extracted from the elective action , which obtains by a Legendre transform,

The elective action is a functional of the classical" elds (or eld expectation values) =  $h^{i}$ ; =  $h^{i}$  in the presence of sources. They are de ned as

and analogous for the ferm ion elds. Of course, due to Pauli's principle, the ferm ion eld cannot acquire a non-vanishing expectation value for = y = 0 such that the physical value is simply = 0. It is offen convenient to write as an implicit functional integral over uctuations ; around \background elds";

with j(x) = -(x). This form is particularly useful for the construction of the equation of state, i.e. the explicit expression for the total atom number density.

The total number density of atom s n includes those from unbound or \open channel" atom s and the ones arising from the bare molecules or \closed channel" atom s. It obeys

Indeed, the action is invariant under U (1) phase transform ations of the ferm ions and bosons,

and the corresponding N oether charge is the total atom num ber N =  $d^3xn(x)$ . We emphasize that eq. (7) is no \ad hoc" assumption - it is an exact expression for the particle num ber and directly follows from the m i-croscopic form ulation. M ore technically speaking,  $h^{\gamma}$  i and  $2h^{1}$  i represent the full two-point correlation functions of the \bare elds" which appear in the m icroscopic action (1) and are quantized by m eans of the functional integral. In a hom ogeneous situation, the conserved particle num ber can be replaced by a xed constant particle density, n = N = V.

The bosonic part  $n_B$  counts the total num ber of atom s contained in the microscopic or <code>\bare"</code> m olecules. This num ber receives a contribution from free molecules and from the condensate as discussed in more detail in sect. V. In the language offen used for a Feshbach resonance,  $n_B$  measures the <code>\closed</code> channel" microscopic atom s. U sing the form alism of the present paper we have com – puted  $n_B$  as a function of the magnetic eld B in [15]. We nd very good agreem ent with observation [8] over several orders of magnitude in  $n_B$ .

Since the action (1) contains only terms quadratic or linear in  $\hat{}$  it is straightforward to express the expectation value  $_0$  in terms of a local ferm ion-bilinear. It obeys (for vanishing source for  $\hat{}$ )

This demonstrates directly that our form alism makes no di erence between a \condensate of molecules" and a \condensate of atom pairs"  $h^T$  ^i - they are simply related by a multiplicative constant.

We nally show the equivalence of our form alism with a model containing only ferm ionic atoms and no microscopic molecules. The interaction in this ferm ionic description is, in general, not local. It becomes local, how – ever, in the limit of a broad Feshbach resonance for h ! 1. For this purpose we use again the quadratic form of the bosonic part of the microscopic action (1), which allows us to integrate out the ^ eld. Expressed only in terms of ferm ions our model contains now a momentum dependent four-ferm ion interaction ( $Q_4 = Q_1 + Q_2 - Q_3$ ;  $Q = (!_n; q)$  with discrete bosonic M atsubara frequencies

W e emphasize that there is no di erence between the Yukawa type model described by the action (1) and a purely ferm ionic model with interaction (11). All physicalobservables can be computed in either one or the other of the two form ulations. However, eq. (11) reveals that our model describes a setting beyond pointlike interactions via the classical frequency and momentum dependence of the four-ferm ion interaction. The momentum structure of (11) is compatible with interactions in the ^^ { channel. The action (1) hence models a nonlocal coupling between the ferm ionic constituents. Reversing the logic, eq. (1) could also be obtained by starting from eq. (11) and perform ing a Hubbard-Stratonovich transform or partial bosonization [40, 41]. Finally, we note that we could also choose classical \gradient coe cients"  $A^{(cl)}$  (see below) di erent from 1=(4M) in order to model an experim entally determ ined e ective range.

In the pointlike lim it the momentum dependence and the dependence on can be neglected and the coupling term in eq. (11) is replaced by the \local interaction approximation"

This limit obtains form ally for  $h^2 ! 1$ , ! 1, while keeping xed. It is relevant for broad Feshbach resonances, as discussed in detail in [15].

# III. DERIVATIVE EXPANSION FOR THE EFFECTIVE ACTION

The condensation of atom s pairs or molecules is signalled by a non-vanishing expectation value  $h^{i} = _{0}$ . The associated symmetry breaking of the global continuous symmetry of phase rotations of  $\hat{}$  and  $\hat{}$  (related to the conservation of the number of atom s) induces a massless G oldstone boson. This is the origin of super-uidity. In this section, we show how to describe this phenomenon in the elective action formalism. For this conceptual issue, it is su cient to work in the mean eld approximation or a simple extension thereof (extended MFT). The more sophisticated approximation schemes beyond mean eld are presented in sects. V I, V III.

In this work we will treat the elective action in a derivative expansion, i.e. we write

and compute the  $\w$  ave function renorm alization" Z , the \gradient coe cient" A and the e ective potential U (). In the present paper we do not com pute the corrections to the part of the e ective action involving ferm ions { for this part we have simply taken the classical action. (See [15] for the renorm alization of the Yukawa coupling in presence of a \background" four-ferm ion interaction.) W e therefore om it the ferm ionic part of the e ective action from now on. For the concrete calculation we work in momentum space. We emphasize, however, that the above expression can be used for the investigation of weak inhom ogeneities as encountered in atom traps. The uctuation problem, i.e. the computation of Z ; A ; U in the above truncation, can then be solved in m om entum space, while the e ects of weak inhom ogeneities can be investigated by solving the classical eld equations derived from (13). This reaches substantially beyond the usual local density approximation, which ignores the kinetic terms in eq. (13). We discuss the implementation of an external trapping potential in our functional integral form alism in app. A. Here, however, we focus on the hom ogeneous situation.

In its most general form, the elective action depends on the parameters T; and and on the classical eld. The dependence on the chemical potentials and can already be inferred from the partition function { they are only spectators w.r.t. the Legendre transform. Following the therm odynamic construction, the total particle density in a hom ogeneous setting is obtained as

This prescription precisely reproduces eq. (7). Here U has to be taken at its minimum .

In the absence of sources the eld equation for (x) reads

Here we have introduced the U (1) invariant = { the e ective potential only depends on this combination. This simple equation can be used to classify the therm odynam ic phases of the system,

where  $_0 = _{0 0}$  denotes the minimum of U(). For high temperatures, the minimum of the elective potential occurs at = 0 and we deal with a norm algas phase. For low enough T, on the other hand, we expect the minimum of U(;) to occur for  $_0 \in 0$ . The spontaneous breaking of the U(1) symmetry is signalled by a nonzero eld expectation value and indicates the condensation phenom enon. This has an important aspect of universality: one and the same criterion can be used for the whole

In the remainder of this section, we will evaluate the e ective action in the mean eld approximation (MFT). This scheme is dened by only considering the elects generated by fermion uctuations. We will include bosonic uctuations in later chapters. Beyond MFT, we rst include the contribution to the density from dressed molecules. This is connected to the elective bosonic two-point function (connected part of the bosonic particle density). This elect is included in dilerent current approaches to the crossover problem in the limit of broad Feshbach resonances [19, 29, 38]. We will refer to it as extended M ean Field Theory. Furtherm ore, we include in sect. V III the modi cations of the elective potential due to bosonic uctuations, using suitable Schwinger-Dyson equations.

Cooper pairs and for the BEC of m icroscopic m olecules.

In a realistic physical situation the validity of our model is restricted to momenta smaller than some microphysical \ultraviolet cuto " . In turn, is typically given by the range of the van der W aals interactions. One may use  $a_{\rm B} = 100 \text{ with } a_{\rm B}$  the Bohr radius. For practical com putations it is often convenient to consider the limit ! 1 such that no explicit inform ation about the \cuto physics" is needed. This requires to express the couplings of the theory in terms of suitably de ned \renorm alized couplings" that stay nite for ! 1 . In the next subsection we will discuss the additive renorm alization of the detuning. The functions Z; A, in contrast, are UV nite. We will also subtract eld-independent pieces linear in and that obtain in a naive MFT computation. This additive \density renormalization" will be traced back to the relation between the functional integral and the operator form alism .

A. E ective potential and additive renorm alization

In the mean eld approximation, the elective potential reads, after carrying out the M atsubara sum mation and om itting an irrelevant in nite constant,

Here we have added an index in order to rem ind that this form still depends on an ultraviolet cuto .W e reg-ularize the e ective potential by limiting the integration over spacelike momenta by an upper bound  $, q^2 < ^2$ .

Let us now discuss the additive renorm alization needed to properly describe the physics encoded in this object. It is needed in two instances: The rst one concerns a zeropoint shift of the two-point function and is related to the quantization via the functional integral. Its rem oval does not involve a physical scale and can thus be seen as a norm alization of a certain observable, the particle number. The second one is related to a true ultraviolet divergence which needs to be cured by an appropriate counterterm. For the ultraviolet renorm alization we can restrict to the sim pler situation where there is no spontaneous symmetry breaking, since this e ect occurs only in the low energy sector and cannot a ect the ultraviolet physics. For the physical value of the eld expectation value, this in plies = 0 and =.

The ferm ionic part of the particle num ber is naively obtained from the therm odynam ic relation n = 0U = 0 in a hom ogeneous setting. This yields the explicit expression

and we observe that this number may get negative for large negative =T. In order to clarify the precise relation between n and the particle density, we rst consider the simpler situation of a single ferm ionic degree of freedom. Here the second equality holds since this combination of operators is covariant with respect to permutations of the ordering. For a lattice model (as, for example, the Hubbard model) with f degrees of freedom per site the ferm ion number per site therefore reads  $n = n + \frac{f}{2}$ . For electrons in a solid (f = 2) one can associate n with the di erence of the electron density from half lling (where n = 1), i.e. the average number of electronsminus holes per site as compared to the half-lling density. For relativistic charged ferm ions <sup>^</sup>y <sup>^</sup>m easures the di erence between particle and antiparticle density and the additive constant drops out. For nonrelativistic atoms, how ever,

The volume factor in momentum space, (0), diverges in the limit of in nite momentum cuto . The physical ferm ionic particle density  $n_{\rm F}$  (x) and the relative particle density  $n_{\rm F}$ ; (x) =  $h^{\rm Ay}(x)$   $^{\rm are}(x)$  is are therefore related by an additive shift that depends on the momentum cuto .

In consequence, one nds now a manifestly positive total ferm ionic particle num ber

The momentum integral is now ultraviolet nite for ! 1. It becomes exponentially insensitive to the ultraviolet cuto , such that we dropped the index. We recover the familiar Fermi distribution. An analogous argument holds for the connected part of the bosonic two-point function which will be in plemented below. Formally, this additive renormalization appears in the form of eld independent terms linear in and in the classical potential.

Let us now proceed to the second instance where UV renorm alization is needed. The m icroscopic action (1) depends explicitly on two parameters , h . A third parameter is introduced in plicitly by the ultraviolet cuto for the momentum integration in the uctuation e ects. (Besides this, the results will depend on the therm odynamic variables T and ; .) Contact to experiment is established by relating the m icroscopic parameters to observables of the concrete atom ic system. Here we choose these parameters to be the m agnetic eld dependent physical detuning (B) and the Feshbach coupling h <sup>4</sup>. The parameters (; h) can, how ever, be replaced by an equivalent set (a <sup>1</sup>; h) (a the scattering

length) in a second step as pointed out below. Once the parameters (B) and h are xed by the properties of the molecules or atom scattering in empty space we can proceed to compute the properties of the atom gas at nonzero temperature and density without further free parameters.

In the vicinity of the Feshbach resonance at  $B = B_0$ we may approximate (B) by a linear behavior (linear Zeem an e ect)

In vacuum (n = 0;T = 0) the Feshbach resonance corresponds to a vanishing binding energy  $_{\rm M}$  = 0. This is realized [15] for = 0, m<sup>2</sup> = 0. There is also no condensate in the vacuum, i.e.  $_0$  = 0. We note that there are no boson uctuations contributing to the renorm alization of the mass term in the physical vacuum n = T = 0 as can be seen from a diagram matic argument [42].

The scattering length a can be de ned in terms of the scattering amplitude at zero momentum and zero energy [15]. At the present stage we may consider a \resonant scattering length"  $a_R$  related to by

It accounts for the contribution of the m olecule exchange to the atom scattering. For B  $\notin$  B<sub>0</sub> and low enough m om enta and energies (low enough temperature) the m olecule exchange can be described by an elective point-like interaction. We therefore also de ne the renorm alized resonant four-ferm ion vertex R,

T his demonstrates that the renorm alization of  $\,$  (26) corresponds to the renorm alization of the elective atom interaction strength  $\,$  .

This suggests the de nition of a or density dependent e ective coupling () (cf. eq. (11)) for the atom -m olecule m odel. In the m any-body context and in therm odynam ic equilibrium, where ferm ions and bosons share a com m on chem ical potential = , the latter is determ ined by the density. In the physical vacuum, obtained by sending the density to zero, describes the binding energy of a molecule, M = 2 = 2 and does not vanish on the BEC side of the resonance [15]. We em phasize that the resonant scattering length  $_{\rm R}$  in eq. (31) describes the scattering of ferm ions throughout the crossover and is directly related to the observed scattering length for two atom scattering. On the other hand, () is a universal combination characteristic for the ground state of the system [42]. For broad Feshbach resonances (h ! 1) the two quantities coincide.

Expressing the e ective potential U (19) in terms of the momentum integral becomes ultraviolet nite,

The remaining cuto dependence is  $0 \ ( \ ^1)$ , the precise value of therefore being unin portant. For de niteness, the cuto can be taken  $= (3 \ ^2n_{\rm gs})^{1=3}$  with  $n_{\rm gs}$  the density in the liquid or solid ground state at T=0. This choice will be motivated in app. B.

At this point we have reached a simple but nevertheless rem arkable result. When expressed in terms of measurable quantities, namely scattering length  $a_R$  (or  $_R$ ) and the open channel atom density  $n_F$  the dependence of the electric potential becomes very insensitive to the microscopic physics, i.e. the value of the cuto . W ithout much loss of accuracy we can take the limit ! 1 for the computation of U. The electric chemical potential depends on  $n_F$  and via  $@U(;) = @ = n_F$ .

#### B. W ave function renorm alization

The wave function renorm alization Z is another important ingredient for the description of the crossover physics in the Yukawa model. This can be seen from the fact that rescaling all couplings in the elective action with the appropriate power of Z , we end up with an elective bosonic Bogoliubov theory in the BEC regime, as will be discussed in detail in sect. VII. Here we focus on the explicit computation of the wave function renormalization.

As can be read o from eq. (13), the wave function renorm alization Z is related to the inverse m olecule propagator P. In app. C we compute P in the mean eld approximation,

## IV. RELEVANT PARAM ETERS, MOMENTUM AND ENERGY SCALES

#### A. Concentration

For a mean eld computation with nonzero density the elective renorm alized four-ferm ion coupling is related by an equation similar to eq. (12) to the resonant scattering length in vacuum. We de ne<sup>5</sup>

Therefore the e ective scattering length in an atom gas di ers from the (vacuum) scattering length which is measured by the scattering of individual atom s. This density e ect is re ected by the dependence on the e ective chem icalpotential and we de ne




FIG.1: Crossover phase diagram  $T_{\rm c}~({\rm c}^1)$ . For large  $\tilde{h}~$  we compare a calculation with a gap equation modi ed by boson uctuations (dashed) to the result obtained with the standard BCS gap equation (solid). The universal narrow resonance lim it  $\tilde{h}~!~0$  is indicated by the dashed-dotted line. We further plot the result of the standard BCS approach (BCS gap equation, only ferm ionic contributions in the density equation; long-dashed rising line) and the result for noninteracting bosons (long dashed horizontal line). The solid line at resonance  $T_{\rm c}~({\rm c}^{-1}~=~0)=0.292$  coincides with the result obtained in [47] which om its boson uctuations. The dashed line  $(T_{\rm c}~({\rm c}^{-1}~=~0)=0.259$  is in good agreem ent with the value obtained in [48]  $(T_{\rm c}~=~0.266)$ , who work in the broad resonance lim it from the outset.

On the BCS side is positive and  $a_R$  is negative – the size of  $\dot{a}$  j is therefore larger than  $\dot{a}_{\rm R}$  j. A similar enhancement occurs in the BEC regime where will turn out to be negative and a<sub>R</sub> positive. Roughly speaking, on the BCS side the presence of a nonvanishing atom density favors the form ation of (virtual) molecules by reducing the \cost" of form ing m olecules with positive (or posit ive binding energy) to 2. In the BEC regime the presence of m olecules reduces the absolute size of the effective binding energy. It should, however, be pointed out that the e ect of a density dependence is small in case of broad resonances  $\hbar$  ! 1, as visible from eq. (42).

The atom density n de ness a characteristic m om entum scale by the Ferm im om entum  $k_F$ , i.e.

The inverse of the Ferm i momentum de nes the most important characteristic length scale in our problem. Roughly speaking, it corresponds to the average distance d between two unbound atoms or molecules. We emphasize that our de nition of  $k_{\rm F}\,$  involves the total density n and therefore includes unbound atoms, molecules and condensed atom pairs. In terms of  $k_{\rm F}\,$  we can form a characteristic dimensionless \concentration"

The concentration is a measure for the ratio between the in-medium scattering length a and average distance, c / a=d. As mentioned in the introduction, the concentration is the crucial parameter for the description of the crossoverbetween the BEC and BCS regimes. For a small concentration jrj the gas is dilute in the sense that scattering can be treated as a perturbation. In this range mean eld theory is expected to work reasonably well. On the other hand, for large jrj the scattering length exceeds the average distance between two atoms and uctuation e ects beyond mean eld might play a crucial role.

A n alternative de nition of the concentration could use the measured (vacuum) scattering length, c = a(B) $k_{\rm F}$ . This de nition has the advantage of a simple relation to the magnetic eld. The choice between the two de nitions is a matter of convenience. We adopt here the definition (45) since this rejects universality in an optimal way. For broad Feshbach resonances the two de nitions coincide since a = a(B). In presence of an additional \background scattering length", a(B) =  $a_{\rm bg}$  +  $a_{\rm R}$ (B) we will include  $a_{\rm bg}$  in the de nition of c.

The concentration c is the most important parameter for the description of the crossover (besides T and n). The inverse concentration c  $^1$  corresponds to a \relevant parameter" which vanishes at the location of the resonance. Once described in terms of  $c^1$  the ultracold ferm ionic gases show a large universality. We dem onstrate this universality on the crossover phase diagram in g. 1 which plots the critical tem perature  $T_c = T_c = F_F$  for the transition to super uidity as a function of c $^1$ . The narrow resonance lim it ñ ! O is exact, while our results for broad resonances (ñ ! 1) still have substantial uncertainties, as dem onstrated by two approxim ations that will be explained later. For large  $\tilde{h}$  the actual value of ñ becom es irrelevant and all curves coincide with the broad resonance lim it. Intermediate ñ interpolate between the broad and narrow resonance lim its.

W e have argued in sect. II that in the lim it of a pointlike approximation for the elective fermionic interaction all results should only depend on the e ective scattering length. This only involves the ratio  $=h^2$  such that for xed c the separate value of h should not matter. On the BCS side for sm all jcjwe therefore expect a universal behavior independent of the value of the Yukawa coupling h . This is clearly seen in g. 1 where the critical line approaches the BCS result independently of h . Furtherm ore, all results become independent of the value of h in the broad resonance lim it (h ! 1). The concentration remains then as the only parameter (besides T and n) for the description of the crossover. These new universal aspects, adding to those that will be presented in IVC, are discussed in [15]. In particular, the broad resonance limit ñ ! 1 corresponds to a pointlike microscopic interaction.

For the broad resonance limit the rst approximation (solid line) corresponds to extended MFT and neglects




FIG.2: G radient coe cient  $A^{\sim} = 2M A$  and wave function renormalization Z in dependence on c<sup>1</sup>. We divide by  $\hbar^2$ in order to get numbers O (1) and use  $\hbar^2 = 3.72$  f0 as appropriate for <sup>6</sup>Li [15]. The ratio  $A = A^{\sim} = Z$  is displayed in g. 9.

the modi cations of the elective potential induced by the molecule uctuations. The second approximation (dashed line) includes these uctuation elects via the solution of a gap equation for the molecule propagator (sect. VIII). The fast approach to the BEC value for c<sup>1</sup> ! 0<sub>+</sub> does not reject the expected behavior  $T_c = T_c^{BEC} + c$  with a dimensionless constant . This shortcom ing of our treatment is remedied by a functional renormalization group study [49]. The solid line at resonance  $T_c$  (c<sup>1</sup> = 0) = 0.292 coincides with the result obtained in [47] which om its boson uctuations. The dashed line ( $T_c$  (c<sup>1</sup> = 0) = 0.259 is in good agreement with the value obtained in [48] ( $T_c = 0.266$ ), who work in the broad resonance limit from the outset.

In g. 2 we show the wave function renorm alization Z and the dimensionless gradient coe cient  $A^{\sim} = 2M A$ as a function of  $c^1$  for T = 0. We use the large value for the Feshbach coupling in  ${}^{6}\text{Li}$ ,  $\hbar^{2} = 3.72$  150 for  $k_{\rm F} = 1 \text{eV}$ (cf. eq. (46)). We note that for large  $\tilde{n}$ , as appropriate for the Feshbach resonances in <sup>6</sup>Lior <sup>40</sup>K, the wave function renorm alization Z is large, the ratio  $Z = \tilde{h}^2$  being an 0 (1) quantity. We observe a strong increase of A when evolving to the BCS side of the resonance. This strongly suppresses the propagation of the e ective bosonic degrees of freedom, leading to a situation where they are com pletely irrelevant. This is an aspect of universality, where the system \loosesm em ory" of the bosonic degrees of freedom and a purely ferm ionic BCS-type description becom es appropriate. These curves are essentially identical in the lim it  $\tilde{h}^2$  ! 1 .

Indeed, large values of  $\hbar^2$  exhibit an \enhanced universality" [15]. In this case, all \m icroscopic quantities" depend only on the concentration c. In the limit  $\hbar$  ! 1 at xed scattering length there is a loss of memory concerning the details of the bosonic sector in the microscopic action (1). These aspects are worked out in more detail in [15]. In a renorm alization group treatment this universality will be rejected in strongly attractive partial infrared xed points, similar to the quark meson model in strong interactions [50]. This universality property will be valid beyond mean eld theory.

#### B. D im ension less param eters

The characteristic energy scales for T , and the gap = h are set by the Ferm i energy  $_F = k_F^2 = (2M)$ . It is appropriate to de ne dimensionless quantities

The critical tem perature for the phase transition corresponds to the value  $T_{\rm c}$  where r vanishes. This part of the mean eld computation is independent of the Yukawa coupling h . In sect. V we will determ ine  $n_{\rm F}$  =n as a function of  $\sim$ ;T and c such that eq. (50) can be used to determ ine  $\sim$  as a function of c and T. As an alternative, we will modify in sect. VI the denition of U such that a modi ed equation  $\theta = \theta \sim = 1 = 3^2$  becomes independent of  $n_{\rm F}$  =n. Again,  $\sim$  can now be xed as a function of c and T. We will see that the relation  $\sim$  (c;T) depends on the choice of the Yukawa coupling h . The results will therefore depend on the additional dimensionless parameter  $\tilde{N}$  (46). A way from the narrow and broad resonance limits, the model is therefore characterized by two dimensionless quantities, c and  $\tilde{N}$ .

## C. Universality

All observables can be expressed in term s of c, T and  $\hbar$  . For example, using the de nition

In particular, the phase diagram  $T_c(c)$  depends only on  $\tilde{N}$  as shown in g. 1 for the case of narrow and broad resonances. For  $T = T_c$  we nd that the relation ~ (c) depends only mildly on the value of  $\tilde{N}$  as shown in g. 3 where we compare narrow and broad resonance limits again. Furtherm ore, for sm all jej the universal curves  $T_c(c)$  and ~ (c;T) become independent of  $\tilde{N}$  : Both in the BEC and BCS regime, an enhanced universality sets in, making  $\tilde{N}$  irrelevant for all its possible values! These issues are investigated more system atically in [15].

In sum m ary we have now an elective low energy formulation where neither M nor enter anym ore. Everything is expressed in term  $sofk_F$  and three dimensionless




FIG. 3: C rossover at the critical temperature in the broad resonance limit: E ective dimensionless chemical potential ~ at the critical temperature as a function of the inverse concentration c<sup>1</sup>. We compare the results for two versions of the gap equation as in g. 1 (solid and dashed line). A dditionally, the result for the narrow resonance limit is indicated (dashed-dotted).

param eters, nam ely c;  $\tilde{h}$  and  $\tilde{T}$ . This scaling property is an in portant aspect of universality. In [15] we discuss the relation of the param eters c and  $\tilde{h}$  with the physical observables for an experim ental setting, nam ely the m agnetic eld B and the binding energy in vacuum. In the present paper we treat  $\tilde{h}$  as a free param eter. The values of  $\tilde{h}$  for <sup>6</sup>Li and <sup>40</sup>K turn out to be large such that the broad resonance lim it applies to these system s.

We display in tab. I the values of the dimensionless scale rations  $M=k_{\rm F}$ ,  $=k_{\rm F}$  and  $_{\rm F}=k_{\rm F}$ . The rst two give an idea how well the detailed m icrophysics decouples for realistic ultracold ferm ionic gases. We use a density n = 4:4  $1^{10}$  cm  $^3$ ,  $k_{\rm F}$  = 1eV  $\doteq$  (3:7290  $1^{2} \Omega_{\rm B}$ )  $^1$ .

# V. MOLECULE AND CONDENSATE FRACTION

At this point the functional integral setting for the ultracold ferm ionic atom gases is fully specified. The parameters  $a_R$  and  $h^2$  can be extracted from a computation of two-atom scattering in the vacuum, taking the limit  $T \ ! \ 0, n \ ! \ 0 \ [15]$ . Rescaling with appropriate powers of  $k_F$  yields the parameters c and  $\hbar^2$  for the many body system. The relation between  $\$  and n is determined by




FIG.4: M om entum dependence of the gradient coe cient in the broad resonance regime  $\tilde{M}^2$  1. We plot A = 2M A =Z for T = T<sub>c</sub> in the di erent regimes, BCS (c<sup>1</sup> = 1.5;T<sub>c</sub> = 0.057, topm ost), crossover (c<sup>1</sup> = 0;T<sub>c</sub> = 0.29) and BEC c<sup>1</sup> = 1.5;T<sub>c</sub> = 0.218). The dashed line is the value for elementary pointlike bosons, A = 1=2.

eq. (14) and we identify = at the end of the computation. An approximate solution of the functional integral for the elective action gives access to therm odynamic quantities and correlation functions.

and n seems to be rather The relation (14) between form al at this stage. In this section we will develop the physical interpretation of this formula. In this context the important distinction between m icroscopic and dressed m olecules will appear. In a quantum m echanical computation for the physics of a Feshbach resonance the concept of dressed molecules arises from mixing e ects between the open and closed channels. This is an important ingredient for the understanding of the crossover. Our functional integral form alism has to reproduce this channelm ixing in vacuum and to extend it to the many body situation. In the functional integral form ulation the quantum mechanical \mixing e ects" are closely related to the wave function renorm alization Z . The concept of dressed molecules and their contribution to the density is directly related to the interpretation of eq. (14). We stress how ever, that the functional integral evaluation of n for given = can be done com pletely independently of this interpretation.

#### A. Exact expression for the bare molecule density

The total density of atom s is composed of three components according to eq. (7),

This formula is exact  $^7$ . It involves an additive renormalization  $\hat{n}_B$  of a similar origin as for the fermionic density, cf. sect. IIIA, but with opposite sign due to Bose-statistics. In the hom ogeneous limit we can write eq. (59) as a sum over integer M atsubara frequencies 2 nT

The ratio of bare molecules to open channel atoms,  $n_{\rm M}$  =n\_F, is important for the understanding of the atom gas. Technically, it enters the eld equation for the elder chemical potential (50) which involves  $n_F$  =n. In the regions in parameter space where  $n_{\rm M}$  =n is not very small a reliable computation of  $n_{\rm M}$  is crucial for a quantitative understanding of the phase diagram. Such situations are e.g. realized in the BEC regime for narrow and intermediate resonances. However, for the crossover region for a broad Feshbach resonance (as for  $^6{\rm Li}$  and  $^{40}{\rm K}$ ) it turns out that  $n_{\rm M}$  =n is small such that an approximation  $n_F$  = n yields already a reasonable result.

N evertheless, the mean eld approximation (51) does not remain valid in all regions of the phase diagram. This is due to an additional -dependence of u arising from the boson uctuations which are neglected in MFT.We will argue below that this contribution from the bosonic uctuations can be interpreted as the density of dressed m olecules. Thus, again an estim ate of the m olecule density will be m andatory for the understanding of the crossover physics. A simple estimate of the dressed m olecule density is the m inimal ingredient beyond m ean eld theory needed for a qualitatively correct description. W e will refer to this as \extended m ean eld theory".

As a rst step the evaluation of the molecule density we may evaluate the classical approximation where the Yukawa interaction between open and closed channel atom s is neglected. This corresponds to the limit h ! 0(for xed a). Then G <sup>(cl)</sup> (g;n) is the free propagator <sup>8</sup>

#### B. Fluctuation e ects

The uctuation e ects will change the form of G (q;n). Details of the computation of  $G = P^{-1}$  are presented in app. C. In the symmetric phase we may account for the uctuations by using

We include here the uctuations of the ferm ions (open channel atom s) for the computation of A and Z. The mass term m<sup>2</sup> will be evaluated by a gap equation which also includes the bosonic molecule uctuations. In the super uid phase ( $\frac{6}{100}$ ) the diagonalization of the propagator has to be performed carefully as discussed below in subsects. G ,H .

The gradient coe cient A  $(;T;q^2)$  is defined by eq. (41) and depends on the Yukawa coupling h. For large  $q^2$  it comes close to the classical value 1=4M. We plot the renormalized gradient coe cient A  $(q^2) =$ 2M A  $(q^2)=Z$  for different c corresponding to the BCS,




FIG. 5: Weighted Bose distribution  $N_{M}^{T=T_{c}}(q) = (\exp{(A \ q^{2}=T)} \ 1)^{1}$  as a function of dimensionless momentum  $q = q = k_{F}$ , for  $T = T_{c}$ . We show the three regimes: (a) BEC (c<sup>1</sup> = 15;  $T_{c} = 0.218$ ), (b) Crossover (c<sup>1</sup> = 0;  $T_{c} = 0.292$ ) and (c) BCS (c<sup>1</sup> = 15;  $T_{c} = 0.057$ ). We compare our best estimate using A (q) = A' (q)=Z (solid curve) with the approximation A = A (q=0) (dashed curve) that we employ for the numerical estimates in this paper. Also indicated is the result for the classical gradient coe cient A = 1=2 (dashed-dotted) that strongly overestimates the molecule number in the crossover and BCS regimes.

BEC and crossover regimes in g. 4. It is obvious that this gradient coe cient plays a major role. Large A leads to an additional suppression of the occupation num – ber for modes with high  $q^2$ , as anticipated in sect. IIIC.

In the symmetric phase (  $_0 = 0$ ) the \mass term " is

We use here a language familiar in quantum eld theory since the molecule wave behaves like a massive eld for m<sup>2</sup> > 0. (The propagator G has a \gap".) For a second order phase transition the critical temperature therefore corresponds precisely to a vanishing mass term , m<sup>2</sup> (T = T<sub>c</sub>) = 0. 2 . We note that the ferm ion uctuations  $\rm low\,er\,m^2$  as compared to the microscopic term m<sup>2</sup>; = 2, cf. eq. (19). This e ect enhances the occupation number for molecules – using m<sup>2</sup>; instead of m<sup>2</sup> would yield a much too small density of molecules! At the critical temperature the mass term m<sup>2</sup> vanishes (see below). For T = T\_c the uctuation e ects therefore concern the size and shape of A (q).

A swe have seen in ourm ean eld computation in sect. III the quantities Z ; A and m<sup>2</sup> depend strongly on . We may imagine to integrate rst the ferm ion uctuations in the functional integral (6) (with y = 0). The result is an intermediate \mean eld action" for the remaining functional integral over bosonic uctuations. The quadratic part (Q) (Q) in this action will be of the type of eq. (63). Performing now the boson uctuations will induce an additional contribution to  $QU = Q = n_F$ . This will be interpreted below as the density of dressed molecules.

# C. D ressed M olecules

D ressed m olecules are quasi-particles with atom num - bertwo. They are described by renorm alized scalar elds

with a standard non-relativistic -derivative in the effective action. This allows for a standard association of the number density of quasi-particles with the correlation function for renormalized elds. With the elds for dressed and bare molecules reads

We observe a large uctuation e ect in the BCS regime (beyond the renorm alization of  $m^2$ ). In this regime, how – ever, the overall role of the molecules is subdom inant. On




FIG. 6: Crossover at the critical temperature: Contributions to the total particle number, showing the crossover from ferm ion to boson dominated physics. (a) Fractions of \dressed" densities in the large  $\tilde{h}$  limit. We compare the results for two versions of the gap equation as in g. 1. (b) Fractions of \bare" densities in the exact narrow resonance limit  $\tilde{h}$  ! 0. Though the pictures are similar, the physical interpretation of the two plots di ers as described in the text.

the other hand, in the BEC regime the molecule distribution is rather insensitive to the details of the treatment of the uctuations. The most important uncertainty from the \molecule" uctuations therefore concerns the crossover regime. In the BEC and crossover regime the replacement of A  $(q^2)$  by A  $(q^2 = 0)$  results only in a moderate error. For simplicity we neglect the momentum dependence of A  $(q^2)$  for the numerical results in this work.

# D. Contribution of molecule uctuations to the e ective potential

The computation of  $n_M$  evaluates a one loop integral which involves the molecule uctuations. (G raphically, eqs. (60), (62) correspond to a closed loop for the molecule uctuations with an insertion of a - derivative.) A self-consistent approximation should therefore also include the e ects of the molecule uctuations in the computation of U and therefore  $_0$  or  $T_c$ . Our func-

tional integral approach m akes this necessity particularly apparent: The computation of the partition function Z involves the uctuations of open channel atom s and m olecules in a completely symmetric way (the variables ^ and ^ in eq. (1)). There is no reason why the uctuations of the ferm ionic atom s should be included and not the ones for the bosonic m olecules. In particular, the critical region very close to  $T_c$  will be dom inated by the boson uctuations.

For the e ective potential the incorporation of the molecule uctuations is achieved by adding to U the one loop contribution  $U_1^{(B)}$  from the uctuations of ^

The mean eld e ective potential (19) is obtained from eq. (75) in the classical approximation. The next order contribution takes the Gaussian approximation for the uctuations of the molecule eld into account. In principle, this requires the evaluation of highly nonlocal objects { the one-loop ferm ion uctuations encoded in the Trlnterm in eq. (76) feature a complex frequency and momentum dependence. However, since we are interested in the observable low energy properties of the system, we may apply a derivative expansion which only keeps the leading order term s in the frequency and m om entum dependence. This precisely generates the wave function renorm alization Z (38,39) and the gradient coe cient (41,C13). In this approximation, we nd (up to an irrelevant in nite constant and evaluated in the symmetric phase) the one loop result

and we recall that  $_{\rm F}$  also receives a contribution from U<sub>1</sub><sup>(B)</sup>. We have computed  $_{\rm B}$  in [15] and the results agree wellwith [8] over several orders of magnitude.

In the symmetric phase for T  $_{\rm C}$  one has  $_{\rm F}$  +  $_{\rm M}$  = 1. For small  $\hbar$  . 1 the BEC-BCS crossover is the crossover from small to large  $_{\rm F}$ . In g. 6 (b) we plot  $_{\rm F}$  and  $_{\rm M}$  as a function of the inverse concentration c  $^1$  for T =  $T_{\rm c}$ . The modi cations of Z , A and m  $^2$  in the inverse propagator P (63) depend on the Yukawa coupling  $\hbar$ . How ever, this in uences the precise shape of the crossover between the BEC and BCS regime only for m oderate  $\hbar$  & 1. For smaller  $\hbar$ , the density fractions are insensitive to the uctuation modi cations.

For the large values of  ${\tt \tilde{h}}$  encountered for the broad Feshbach resonances in  $^{6}\text{Li}$  and  $^{40}\text{K}$  the contributions from the closed channelm olecules  $_{\rm M}$ ;  $_{\rm C}$  become very small (cf. g. 7 (b)). The dressed molecules di er substantially from the bare molecules (large Z ) and the crossover physics is better described in terms of dressed molecules. We display in g. 6 (a) the fraction of dressed unbound atom s  $_{\rm F}$  and dressed molecules  $_{\rm M}$  for large values of  ${\tt \tilde{h}}$  and T = T\_c. The fractions are not sensitive to the precise value of  ${\tt \tilde{h}}$  in the broad resonance limit  ${\tt \tilde{h}}$  ! 1 , similar to the behavior found for small  ${\tt \tilde{h}}$ .

#### F. Condensate fraction

In g. 7 (a) we plot the condensate fraction  $_{\rm C}$  as a function of c<sup>1</sup> for T = 0. We also show the fraction of closed channel atom s<sup>9</sup> in the condensate,  $_{\rm C}$ , in g. 7 (b). Both correspond to the broad resonance limit and we choose the Yukawa coupling appropriate for  $^{6}{\rm Li}$ ,  $\hbar$  = 610.

to the condensate fraction as de ned by a given experimental setup. The ambiguity is even larger when we come to the concepts of uncondensed ferm ionic atoms and m olecules. The distinction becomes somewhat arbitrary if we include higher bops for the computation of it, where bosonic and ferm ionic uctuations are mixed. As an example for the ambiguities in the denition one may try to extract the number of open channel atoms in the condensate directly from the -dependence of  $n_{\rm F}$ . 

The equations (113) for the density of dressed molecules involve the renormalized coupling . This describes the full vertex and therefore is a momentum dependent function. This also holds for A . We will neglect the momentum dependence of A , as motivated by g. 5 for  $T = T_c$ . For this issue is more involved since (q) vanishes for q ! 0 (T T\_) due to the molecule uctuations, as shown in app. E. We observe that for small T the momentum integration in eq. (110) is dom instead by the range  $q^2$ <sub>0</sub>=A.The infrared suppression of (q! 0) is therefore not e ective. The inclusion of the molecule density  $n_{\rm M}$  is important for quantitative accuracy even at T=0. This is demonstrated in g. 8 where we show the crossover for the elective chemical potential  $\sim$  and the gap  $\sim$  as a function of c $^1$ . The agreement with quantum M onte C arlo simulations [37] is substantially improved as compared to mean eld theory, and also compares reasonably wellw ith other analytical approaches (Strinatiet al [52],  $\sim$ = 0:53;  $\sim$ = 0:445).




FIG. 8: Solutions of the coupled gap and density equations at T = 0, (a) e ective chem ical potential, (b) gap parameter  $\sim = \frac{p}{r}$ . We also show (dashed)the mean eld result (obtained by setting the bosonic contribution  $n_M = 0$  in the density equation). Our result can be compared to QMC calculations [37] perform ed at c<sup>1</sup> = 0 which nd  $\sim = 0.44$ ;  $\sim = 0.54$ . Our solution yields  $\sim = 0.50$ ;  $\sim = 0.53$ , and in proves as compared to the MFT result  $\sim = 0.63$ ;  $\sim = 0.65$ .

# VI. EFFECTIVE FIELD FOR ATOM DENSITY

Before proceeding in sect. V III to a description of our computation of the e ects from the molecule uctuations on the e ective potential we present in this section an improvement of our form alism which treats the fermionic and bosonic uctuations in an even more symmetric way. Indeed, in the thermodynamic equilibrium the molecule propagator should involve the same e ective chemical potential as the propagator of the unbound atoms. (So far it involves instead of .)

If one is interested in the separate contributions from open and closed channel atom s one may form ally consider di erent chem ical potentials and multiplying ^y ^ and ^ ^ in the action. Then  $n_F$  and  $n_B$  can be associated to the variation of the elective action with respect to and . At the end of the computations one has to identify = ). Form any purposes, how ever, one only needs the total number of atom s n. It seems then advantageous to modify our formulation such that the

eld is associated to n instead of  $n_F$ . In this section, we treat as a classical eld such that its role is reduced to a source term = J. In app. A we will consider the more general case where is treated as a uctuating eld.

In the presence of interactions it is hard to evaluate the full bare correlation functions in the above form explicitly { it premises the solution of the full quantum eld theory. As we have discussed in sects. V D, V E it is more practicable to decom pose n according to

#### VII. BEC LIM IT

In sect. V G we have de ned a multiplicative renorm alization scheme for the bosons by rescaling all couplings




FIG.9: Gradient coe cient A = A = Z for T = 0, as a function of the inverse concentration. In the BEC limit, A takes the classical value 1=2 as appropriate for elementary bosons of m ass 2M.

and elds with an appropriate power of Z such that the tim elike derivative in the e ective action has a unit coefcient. This leads to the notion of dressed m olecules in our form alism. In this section we discuss the im plications of this prescription in the BEC regime. Here we will see that the dressed m olecules behave just as \elementary" bosons.

The propagator for the dressed molecules has still a nontrivial renorm alization factor for its dependence on the spacelike momenta (63). The ratio  $A = A^{-2}$  is shown as a function of c in g. 9. It is instructive to evaluate A in the BEC limit where the propagator should describe the propagation of dressed molecules. The integrals in  $A^{-}$  and Z can be evaluated analytically (cf. app. D, eqs. (D 3, D 4)) irrespective to the therm odynamic phase of the system. The universal result does not depend on h ,

This makes it particularly clear that for both the lim it of small  $\tilde{N}$  ! 0 and the lim it of large  $\tilde{N}$  we recover composite, but pointlike bosons with wave function A = 1=2, corresponding to a kinetic energy  $p^2=4M$ . However, in the rst case of small  $\tilde{N}$  we deal with m icroscopic closed channelm olecules, while in the second case of large  $\tilde{N}$  the emerging bosons are open channel pairs, how ever behaving just as if they were pointlike bosons in the BEC lim it. For large  $\tilde{N}$  we could equally well drop the classical piece in A and Z. This corresponds to a purely pointlike interaction for the ferm ions without any explicit reference to molecules at all, cf. eq. (11), and the discussion in [15]. Nevertheless, bound atom pairs emerge that behave just as pointlike particles.

A similar aspect of universality is found for the fourboson coupling  $= {}^{\sim} = \mathbb{Z}^2$ . In the approximation where we neglect bosonic contributions to the four-boson coupling and to the gap equation for the mass (BCS gap

= (F) = 8 = - such that the equation), we nd bosonic scattering length becomes  $a_M = 2a_R$ . This is the Born approximation for the scattering of the composite bosons. However, more accurate treatments on this issue have shown  $a_M = a_R = 0.6$ . This result is obtained from the solution of the four-body Schodinger equation [53] and form a numerically demanding diagrammatic approach [54], and has also been con rm ed in QMC simulations [55]. A resummation of the e ective boson interaction vertices in vacuum as done in [56] yields  $a_M = a_R = 0.75$  (4). Our present Schwinger-Dyson approach does not correctly account for the real situation since the contribution from molecule uctuations in the vacuum is missing. In the frame of functional renorm alization group equations, this de ciency has been rem edied. Simple truncations yield  $a_M = a_R = 0.71 \quad 0.92$  [49].

It is instructive to investigate eq. (113) in the limit  $c^{1} ! 1$  (BEC limit) where we have A  $! 1=2;a_{M} = 2a_{R}$ . The density in the super uid phase  $n_{M}$  (113) then coincides precisely with the Bogoliubov form ula for bosons of m ass 2M and the above scattering length,

We emphasize again that we can perform rst the lim it  $\hbar$  ! 1 where we recover a purely ferm ionic model with pointlike interaction and no explicit molecule degrees of freedom (cf. [15]). Subsequently we may consider large c<sup>1</sup> where the approximations leading to eq. (119) become valid. This shows that the Bogoliubov form ula for weakly interacting \fundamental" bosons can be recovered from a purely ferm ionic model! In our approach, this result emerges in the simultaneous lim it c<sup>1</sup> ! 1 (BEC regime),  $\hbar$  ! 1 (broad resonance regime). A similar result has been established by Strinatiet al. [18, 19, 20, 56], who work in a purely ferm ionic setting, or, in our language, in the broad resonance lim it  $\hbar$  ! 1 from the outset.

This observation is strengthened by an investigation of the dimensionless density equation (115) at T = 0 in the BEC limit:

Here we have dropped the term  $_{\rm C}$  = 0 (Å<sup>2</sup>) and we may similarly neglect  $_{\rm M}$ . In the rst line of eq. (121)

the nst term is the explicit result for  $_{F;0}$ . The second line uses the explicit result for Z (D 4) and we recover the densition of  $_{C}$  (88). This is precisely the density equation one obtains when assuming fundam ental bosons of m ass 2M . This is an important result: O ur Z - renorm alization procedure generates precisely the m acrophysics we would have obtained when starting m icroscopically with a purely bosonic action. In our approach how ever, the bosons emerge dynam ically.

## VIII. GAP EQUATION FOR THE MOLECULE PROPAGATOR

The form ulation of the problem as an Euclidean functional integral for ferm ionic and bosonic elds perm its the use ofm any of the highly developed m ethods of quantum eld theory and statistical physics. It is an ideal starting point for system atic in provem ents beyond M FT. We have mentioned in the previous sections that one possible alternative to the standard one loop approximation could be to rst integrate out the ferm ions and then perform the remaining ^-integral in one loop order. This procedure has, how ever, som e problem s.

Let us consider the dimensionless renorm alized inverse bosonic propagator (63) (!  $_{\rm B}$  = 0) in the approximation

is diagonal but in general non-degenerate in the  $_1$ ;  $_2$  basis. It vanishes at the critical temperature of a second order phase transition. A lready after the rst step of the  $^-$  integration P di ers from the classical inverse m olecule propagator. The molecule propagator will appear in the molecule uctuations as described by the partition function

where  $S_{M \ F \ T}$  is the interm ediate action resulting from the G aussian integration of the ferm ion elds. It is composed of the classical boson piece and a loop contribution from the ferm ion elds,

At this stage the contribution from the ferm ion loop still depends on the uctuating boson eld. For example, the form ula for the dressed m olecule density in the sym m etric phase




FIG.10: Lowest order Schwinger-Dyson equation for the inverse m olecule propagator (double dashed line) in the symmetric phase. The rst two terms on the rhs denote the \m ean eld inverse propagator" after integrating out the fermionic

involves P (122). It generalizes  $^{13}$  eq. (62) with replaced by . We see that the inverse propagator P appears in the bosonic uctuation contribution  $U_1^{\,\,(B)}$  to the elective potential and in uences the eld equation for .

For a simple one loop evaluation of the functional integral (124) one would have to use a propagator with m  $^{(F)2}$  instead of m<sup>2</sup> in eq. (122). This has an important shortcom ing. Due to the di erence between U  $_{\rm M\ F\ T}$  and U the masslike term m<sup>(F)2</sup> vanishes at some tem perature dierent from T<sub>c</sub>. As a consequence of this m ism atch one observes a rst order phase transition for su ciently large values of ñ . C learly such a rst order phase transition may be suspected to arise from an insu cient approximation. (A similar fake rst order transition has been observed for relativistic scalar theories. There it is well understood [57, 58] that an appropriate resum mation (e.g. by renormalization group methods) cures the disease and the true phase transition is second order. For the crossover problem the second order nature of the phase transition has recently been established by functional renorm alization group m ethods for the whole range of concentrations, cf. [49])

In order to improve this situation we use for the bosonic uctuations Schwinger-Dyson type equations where the inverse propagator P involves the second derivative of the full e ective potential U (rather than  $U_{M \ F \ T}$ ). It is obvious that this is needed for a reliable estimate of  $n_M$  since the exact expression (59) and therefore also (126) involves the full molecule propagator includ-

ing the contribution of the molecule uctuations. Since our functional integral treats the molecule uctuations exactly on the same footing as the ferm ionic atom uctuations we can derive the lowest order Schwinger-Dyson or gap equation for  $m^2$  in the standard way. For the symmetric phase it is graphically represented in g. 10 and involves the full propagator and therefore  $m^2_{;ab}$ .

Here <sup>(F)</sup> is the elective vertex involving four bosonic elds ()<sup>2</sup>, as induced by the ferm ion uctuations. It depends on  $q^2$  and  $\vdots_n$ . Neglecting the  $\vdots_n$  -dependence, i.e. replacing <sup>(F)</sup> ( $q; \vdots_n$ ) ! <sup>(F)</sup> (q) <sup>(F)</sup> ( $q; \vdots_n = 0$ ), one can perform the M atsubara sum

We have not yet computed the momentum dependence of <sup>(F)</sup>(g) but a simple qualitative consideration of the relevant diagram shows that for large  $q^2$  one has a fast decay <sup>(F)</sup>(g) /  $q^4$ . This makes the momentum integral (132) ultraviolet nite. It will be dominated by small values of  $q^2$ . For our purpose we consider a crude approxim ation where we replace <sup>(F)</sup>(g) ! <sup>(F)</sup> <sup>(F)</sup>(q = 0). Of course, we have now to restrict the momentum integration to low momenta. This can be done e ciently by subtracting the leading UV divergence similar as in the computation of  $n_{\mathbb M}$  , i.e. replacing  $\operatorname{coth} x$  by  $\operatorname{coth} x$  1. This procedure yields

where we recall that  $_{\rm M}$  depends on m<sup>2</sup>. Our gap equation has a simple interpretation: The bosonic contribution to m<sup>2</sup> vanishes in the limit where only very few dressed molecules play a role ( $_{\rm M}$  ! 0) or for vanishing coupling. We are aware that our treatment of the suppression of the high m om entum contributions is som ewhat crude. It accounts, how ever, for the relevant physics and a more reliable treatment would require a quite involved computation of (F) (g; +). This complication is an inherent problem of gap equations which often require the know ledge of e ective couplings over a large m om entum range. As an alternative method one may employ functional renorm alization [59] for the crossover problem [49], where only the know ledge of couplings in a narrow m om entum interval is required at every renorm alization step.

The ferm ionic contribution to the mass term m  $^{(F)2}$  (cf. eq. (65)) reads explicitly

The molecule uctuations give a positive contribution to m<sup>2</sup>, opposite to the ferm ionic uctuations. This has a simple interpretation. The ferm ion uctuations induce a self-interaction between the molecules (F). In turn, the uctuations of the molecules behave similarly to interacting fundamental bosons and modify the two point function for the molecules. The quantum corrections to the ferm ionic and bosonic uctuations to the inverse molecule propagator are represented graphically in




FIG.11: Tem perature dependence of the gap  $\sim = \frac{P_{-}}{r}$  at the resonance. The role of molecule uctuations and the uncertainties in their treatment for T !  $T_c$  are demonstrated by four choices of in the gap and density equation. The critical tem peratures are indicated by vertical dashed lines, with values  $T_c = 0.259; 0.292$ .

g. 10. We emphasize that an additional microscopic molecule interaction could now easily be incorporated by adding to the mean eld value for  $^{(F)}$  a \classical part"  $^{(cl)}$ . In this case the renormalization of discussed in sect. IIIA would be modiled. For a constant  $^{(cl)}$  the UV - divergent part would contribute to m<sup>2</sup> (T = 0; n = 0). One would again end up with a contribution of the form (133), now with  $^{(F)}$  replaced by  $^{(cl)}$ +  $^{(F)}$ . Our approximation (133) therefore treats the interactions of dressed molecules similar to fundamental interacting bosons.

A ctually, the Schwinger-Dyson equation for the molecule propagator (g. 10) also describes the contribution of molecule uctuations to the momentum dependent part encoded in A . In the limit of a momentum independent (F) the contribution of the boson loop to A vanishes in the symmetric phase.

## B. Super uid phase

Again we replace  $^{(F)}$  (q) by a constant  $^{(F)}$  evaluated for q = 0 and subtract the leading UV divergence of the momentum integral. This results in

The quantity contains a mass term 2  $_0$  which involves the \full" vertex =  $^{(F)} + ^{(B)}$ . We have computed the Schwinger-Dyson eq. for in app. E. For zero momentum q! 0 we nd that vanishes in the super uid phase. This is, how ever, only part of the story since the gap equation involves a momentum dependent vertex (q). In order to demonstrate the uncertainty arising from our lack of know ledge of (q) we present in g. 11 our results for di erent choices of in the gap eq. (143).

In detail, we show in g. 11 four approximation scenarios: (i) the \standard" BCS gap equation (long dashed) neglects the molecule uctuations, i.e. = (F) = 0in both the gap and the density equation. This yields a second order transition but disagrees with QMC results for T ! 0. (ii) Bogoliubov density (short dashed) with (F) in the density equation, while the molecule uctuations in the gap equation are neglected. This is proves the behavior for T ! 0, but induces a fake rst order phase transition for T ! T<sub>c</sub>. (iii) Neglection of molecule

uctuations in the elective coupling (dashed-dotted), i.e. we use = <sup>(F)</sup> in the density and gap equation. (iv) Our best estimate (solid line) includes also corrections from molecule uctuations for . As described in this section we use in the propagator of the diagram in the gap equation, whereas the coel cient multiplying the diagram is given by <sup>(F)</sup>. (W e use <sup>(F)</sup> in the density equation.) The rst order nature is weaker than in (iii), but still present. In a recent functional renorm alization group treatment we have established the second order nature of the phase transition throughout the crossover, indicating that we now control the universal long range physics governing the phase transition [49].

### C. Phase transition

For  $T = T_c$  the gap equations (134) and (143) m atch since  $_0 = 0$ , =, = 0. A loo the expression for the m olecule density becomes particularly simple

## IX. CONCLUSIONS

Our functional integral investigation of ultracold ferm ionic atoms strengthens the picture of a smooth crossover between Bose-Einstein condensation of molecules and BCS type super uidity. One and the same eld can both describe molecules and collective atom excitations of the type of Cooper pairs. The two di erent pictures correspond to two regions in the space of m icroscopic couplings and external param eters (T;n). In dependence on a concentration parameter c, which is related to the magnetic eld B, one can continuously change from one to the other region. Away from the critical temperature the \m acroscopic observables" are typically analytic in c<sup>1</sup> despite the divergence of the scattering length for two-atom scattering at  $c^{1} = 0.0 n ly for T ! T_{c}$  one expects to encounter the non-analytic critical behavior which is characteristic for a second order phase transition in the universality class of 0 (2) - Heisenberg magnets.

For sm alland m oderate Y ukawa couplings  $\hbar$  the physical picture of the crossover for  $T > T_c$  is rather simple. Far on the BEC side the low tem perature physics is dom - inated by tightly bound m olecules. As the concentration increases, the m olecule waves start to m ix with collective diatom states. M ore precisely, the m olecule state with m om entum p m ixes with pairs of atom s with m om enta  $q_1;q_2$  that are correlated in m om entum space such that  $q_1 + q_2 = p$  (Cooperpairs). On the BCS side the relevant state become es dom inantly a Cooper pair. O ur form alism uses only one eld for both the m olecule and Cooper pair states. Nevertheless, the relative im portance of the m icroscopic m olecule versus the collective C ooper pair is re ected in the propagator of , i.e. the wave function renorm alization Z and the gradient coe cient A .

On the BEC side the propagation of corresponds to free molecules and A takes the classical value A  $^{\rm (cl)}$  = 1=4M , and similarly for the wave function renormaliza-

tion, Z<sup>(c1)</sup> = 1. The increasing mixing in the crossover region results in A and Z growing larger than A<sup>(c1)</sup>; Z<sup>(c1)</sup>. Indeed, the diagram responsible for the increase of A; Z precisely corresponds to a molecule changing to a virtual atom pair and back. Finally, far in the BCS regime one has A A<sup>(c1)</sup>; Z Z<sup>(c1)</sup> such that the classical contribution is negligible. The existence of a microscopic molecule is not crucial anymore. At long distances the physics loosesmem ory of the microscopic details - the approximation of a pointlike e ective interaction between atom s becomes valid.

For a broad Feshbach resonance the situation is, in principle, similar. However, the region where Z and  $A = A^{(cl)}$  are large covers now both sides of the Feshbach resonance. The di erence between the bare (m icroscopic) and dressed m olecules is a crucial feature. For a broad Feshbach resonance the m icroscopic m olecules are irrelevant for the whole crossover region. For this limit we have demonstrated in sect. V II that our form alism is equivalent to a purely ferm ionic m odel with a pointlike interaction. This demonstrates that in the broad resonance limit, the use of the two channelm odel is rather a question of com putational ease than a physical issue { it describes the same physics as a single channelm odel.

On the other hand, the two channel model is more general and also covers the case of narrow resonances. This issue is discussed in more detail in [15]. It remains to be seen if it will be possible to investigate the narrow resonances also experimentally in the future.

The universality of the low temperature physics and the crossover can be traced back to the \renorm alizable couplings" of an electrive non-relativistic quantum eld theory for long distances. More precisely, the long distance physics will only depend on the relevant (or marginal) couplings in the infrared renorm alization ow. These are precisely the dimensionless parameters c and h. Im proved approximations will in uence the relation between microscopic atom ic and molecular physics and (c;h). At this point also \subleading interactions" like the -exchange or other interactions contributing to the background scattering length  $a_{bg}$  will play a role.

However, universality predicts that the relations between long-distance (\m acroscopic") quantities should become computable only in terms of the \renorm alizable couplings" m  $^2$  (or c) and h . In consequence, we nd a universalphase diagram in term s of these param eters, where the \m em ory" of the m icroscopic physics only concerns the values of c and h , providing for a universal phase diagram in term softhese parameters. In addition, the universal critical exponents and am plitude ratios for  $T ! T_c$  will be independent of c and h . Furtherm ore, the BCS lim it is independent of h since only one param eter (c) characterizes the e ective pointlike atom interaction. Also the BEC lim it does not depend on h since the uctuations of unbound atom sbecom e irrelevant. On the other hand, the behavior in the crossover region can depend on h as an important universal parameter. This

demonstrates that a pointlike approximation for the effective atom interaction is not always applicable for small  $jc^{1}j$ .

The couplings h and  $\tilde{h}$  are related by the multiplicative factor Z<sup>1=2</sup>. In the broad resonance limit  $\tilde{h}$  ! 1 one nds that the renorm alized coupling h is given by an infrared xed point. It therefore ceases to be an independent coupling.

For a more general form of the microscopic action we expect that deviations from universality become most visible far in the BCS regime, where further channels may play a role for the e ective interaction, as well as in the far BEC regime, where more details of the microscopic dispersion relation for the molecules and their m icroscopic interactions may become relevant. Going beyond our particular ansatz for the m icroscopic action universality should actually work best in the crossover region of sm all  $jc^{1}$  j. On the other hand, for a given m icroscopic action the results are most accurate in the BEC and BCS regimes where uctuation e ects are most easily controlled. It is precisely the presence of strong uctuation or renorm alization e ects in the crossover regime that is responsible for the \loss of m icroscopic m em ory" and therefore for universality!

The formulation as a Yukawa model solves the problem swith a large e ective scattering length for the atom s in the crossover region in a simple way. The large scattering length is simply due to the small m ass term " m<sup>2</sup> of the molecule eld. It does not require a large atom molecule interaction / h . As long as the dimensionless Yukawa or Feshbach coupling h remains small, the region of sm all and vanishing jc<sup>1</sup> j (large or diverging effective atom interaction) poses no particular problem. In the symmetric phase all quantities can be computed in a perturbative expansion in ñ . For ñ ! 0 a nontrivial exact lim iting solution of the functional integral has been found [15]. Nevertheless, for large h a new strong interaction appears and the bosonic uctuations become important. Indeed, the crossover for a broad Feshbach resonance amounts to a theoretical challenge. One has to deal with a genuinely non-perturbative setting.

In the present paper we have included the molecule uctuations by the solution for Schwinger-Dyson or gap equations. For T = 0 the results are quite satisfactory as shown by the comparison with quantum M onte Carlo simulations [37] in g. 8. However, as T increases towards the critical tem perature  ${\rm T}_{\rm c}$  our m ethod becom es less reliable since the details of the treatment of the molecule uctuations play an increasing role, cf. g. 11. The main problem results from the neglected momentum dependence of the four-boson-vertex . This is related to a generaldiculty for Schwinger-Dyson equations: the m om entum integrals involved require the know ledge of effective couplings in a large m om entum range. A prom ising alternative m ay be the use of functional renorm alization [59]. At every renormalization step only a narrow m om entum range plays a role and the m om entum dependence of suitably chosen e ective vertices is much less

in portant. First results of a functional renorm alization group treatm ent can be found in [49].

In this light the present paper should be viewed as a starting point for more accurate investigations with further functional integral techniques. It is well suited for system atic extensions, among which we would like to stress a more appropriate treatment of the momentum dependence of the couplings, an extended inclusion of the e ect of boson uctuations, and the modi cation of the ferm ion propagator by the renorm alization e ects originating from mixed ferm ion-boson contributions.

It remains to be seen if theoretical improvements, together with a reduction of systematic experimental uncertainties, will nally lead to an understanding of ultracold fermionic atoms with high quantitative precision.

# APPENDIX A : PARTIAL BOSON IZATION AND PARTICLE DENSITY

In this appendix we extend the formulation for the functional integral in such a way that we are able to discuss situations which are (i) inhom ogeneous and (ii) beyond the \sm all density approximation" (SDA). The treatment of inhom ogeneities is particularly desirable in the context of ultracold gases which are prepared in traps of various shapes. In particular, we show how the \b-caldensity approximation" emerges from our formalism. Further we consider situations beyond sm all densities. The price to pay is the inclusion of a further functional integration over a now uctuating eld ^. In the SDA, treating the chemical potential as a source term is appropriate, and we will quantify this statement here.

We will start the discussion for a single ferm ion eld. This describes a situation far o a Feshbach resonance, where molecules of e ective collective states are unim portant. A ctually, the discussion in this appendix covers a very large class of ferm ionic system s with e ective pointlike interactions. Besides ultracold ferm ionic atom s, it may be applied to neutrons (e.g. in neutron stars), dilute gases with short range interactions (e.g. dipole interactions) and also covers certain aspects of electron gases (where the Coulomb interaction is replaced by a pointlike repulsion). We then extend the discussion to the case of ferm ions and bosons in order to account for strong interactions via a Feshbach resonance. The concept presented here will also be technically useful for the analysis of strongly interacting ultracold atoms in the fram e of the functional renorm alization group.

In this section we develop a general functional integral approach for the computation of the density n(x). For this purpose we introduce a eld (x) which is conjugate to J(x). It will play the role of an e ective chem ical potential which diers from eq. (A3) unless the density is small. Our approach can be used for arbitrary n and is not restricted to a small density approximation. The e ects of density uctuations can be incorporated by functional integration over via partial bosonization.

## 2. Partial bosonization

Partial bosonization is achieved by inserting a Gaussian integral which is equivalent to one up to an irrelevant multiplicative constant (Hubbard-Stratonovich transformation [41], [40])

The crucial advantage of our form alism is the possibility to compute the elective action []without any speci cation of the local potential (trapping potential)  $V_1(x)$ . The detailed geometry of the trap only enters at a second step when one solves the eld equation (A13). This o ers the great advantage that the uctuation problem can be solved in a hom ogeneous setting, i.e. one encounters standard momentum integrals in the loop expressions rather than summations over spherical harmonics or other function systems adapted to the geometry of the trap. The results are universal and apply to all geometries, provided the inhom ogeneity is su ciently weak.

In practice, one often does not know in a given experimental situation, but rather has information about the total particle number N =  $d^3xn(x)$ . In this case one may compute N () by integrating the solution of eq. (A 35). Our setting can be reformulated in a more intuitive form in terms of a \density functional<sup>m</sup> ^[n] to which we proceed in the next section.

The error of the LDA can now easily be estimated by an iterative procedure. Inserting the solution of eq. (A 47) into eq. (A 35) allows for a simple direct computation of the subsequent terms. O by iously, the error depends on the size of A which is often a rather small quantity (see below).

If both the density is su ciently small and the trap su ciently hom ogeneous one can work with the small local density approximation (SLDA). This results in the simple form ulae

We will not that for realistic ultracold atom systems like <sup>6</sup>Li the LDA is valid whereas eqs. (A 49), (A 50) are oversim – pli cations (except for the BEC regime far away from the Feshbach resonance).

We emphasize again that our method is valid quite generally and not bound to the case of sm all density. If necessary, mean eld theory can be improved by including the bosonic uctuations in the computation of U and A by performing the functional integral over ^. Our method can also be applied in the presence of additional condensate elds. As a simple application we compute in appendix B the density at low T in the mean eld approximation. In particular, this shows that the dilute gas of ultracold atom s is a metastable state, the ground state being a liquid or solid.

## APPENDIX B:METASTABILITY

At low T the therm al equilibrium state of atom s is a liquid or solid, with density essentially determ ined by the \size" of the atom s (typically set by the van der W aals length). W hen we deal with a dilute gas of atom s at ultracold tem perature we obviously do not consider the stable therm al equilibrium state which m in in izes the free energy. Indeed, we will see in this section that the m etastability can be captured within our form alism if the weak cuto dependence O ( $^{-1}$ ) is not neglected. For this purpose, we consider a hom ogeneous system and neglect the e ects from m olecules.

This has no impact on observables, since the thermal distribution functions are suppressed at lowerm om enta already (see below, also g. 5). It m ight be an artefact of the neglected momentum dependence of Z .

In the present paper we neglect for the num erical results the momentum dependence of A and approximate A (q = 0). Let us discuss here the valid-A (q) = Aity of this approximation in the broad resonance regime at the critical tem perature. The im pact of the mom entum dependence of A (q)=Z is most clearly seen for the Bose distribution in q. 5. There we explicitly com pare the results with a momentum dependent A (q)=Zand an approximation of constant A =Z . In the BEC regime the error is very small with A (q)=Z close to the classical value 1=2 for all q. The main di erence from the classical propagator concerns the renorm alization of the mass term  $m^2$ . In the crossover regime the approxin ation of constant A =Z underestim ates the number of m olecules with large  $q^2$ , but the error rem ains acceptable. In contrast, the deviation from the result with the classical molecule propagator is already substantial. In the BCS regime the underestimate of  $N_{M}$  (q) for the dom inant range in q is quite substantial. Though the overall e ect of the boson uctuations is small in the BEC regime, this may a ect the quantitative results for the num ber density of m olecules and the condensate. In view of g.5 (c) the estimates of  $_{\rm M}$  and  $_{\rm C}$  and  $_{\rm M}$  ;  $_{\rm C}$  in the present paper are most likely too sm all.

The loop correction to the gradient coe cient is strictly positive and m onotonically growing for ~ increasing from negative values (BEC side) to its saturation value ~ = 1 on the BCS side. For the BEC regime it vanishes in the limit ~ ! 1. However, the physical quantity  $A = A^{-} = Z$  approaches the nite value 1=2 in the BEC regime - this is an indicator of the emergence of an elective bosonic theory. The G oldstone boson uctuations renorm alize to zero, as found in [57, 58, 61]. In our approximation vanishes for all T < T<sub>c</sub> in the super uid phase. In consequence, the mass term 2  $_0$  of the radial m ode vanishes for all T < T<sub>c</sub>. However, as we have discussed in the main text, this vanishing of

concerns only the e ective vertex at zero external momentum , whereas the loop integrals often involve vertices at nonzero momentum .

Furtherm ore, the contribution from the uctuations of the radial m ode in eqs. (E 4) and (E 12) are not treated

very accurately. However, this e ect will then become visible as an infrared divergence of the gradient coe cient for the radialm ode, A  $_{,r}$  /  $_0\,jqj^1$  (which di ers from A for the Goldstone m ode). In consequence, one has P (q ! 0) / jqj and the \radialm ode contribution" to the Schwinger-D yson equation is not infrared divergent. We note, how ever, that the radialm ode contribution is subleading as compared to the Goldstone m ode contribution tion such that our approximation catches the dom inant features for the behavior of

Finally, in the super uid phase the potential (E11) also contains a cubic term  $/ {\begin{array}{c} 0 \\ 1 \end{array}}^2_2 / {\begin{array}{c} 1^{=2} \\ 0 \end{array}}$ . This term contributes to the Schwinger-D yson equation form  ${}^{(B)2}$ . The coe cient of this contribution  $/ {\begin{array}{c} (F) \\ 0 \end{array}}$  vanishes for = 0. Nevertheless, for a momentum dependent

one has to take it into account, as well as similar corrections to the Schwinger-D yson equation for which involve quintic couplings.
