# Q uantum Theory of Irreversibility

#### Abstract

A generalization of the $G$ ibbs-von $N$ eum ann relative entropy is proposed based on the quantum BBGKY B ogolyubov-B om-G reen-K inkwood-Y von] hierarchy as the nonequilibrium entropy for an N boody system. By using a generalization of the Liouville-von $N$ eum ann equation describing the evolution of a density superoperator, it is dem onstrated that the entropy production for an isolated system is non-negative, which provides an arrow of tim e. M oreover, follow ing the procedure of non-equilibrium therm odynam ics a $m$ aster m atrix is introduced for which a m icroscopic expression is obtained. T hen, the quantum Boltzm ann equation is derived in term $s$ of a transition superoperator related to that $m$ aster $m$ atrix.

## 1 Introduction

A ccording to the $m$ echanicistic interpretation of the physical w orld, the basic law s of nature are determ inistic and tim e reversible. H ow ever, at the $m$ acroscopic level we observe irreversible processes related to energy degradation which generate entropy. H ow do we reconcile the spontaneous production of entropy' w ith the tim e reversibility of the $m$ icroscopic equations of $m$ otion?. This is a problem not solved in a clear and de nitive way yet, thus it still constitutes an open problem. Attem pts to address this have been $m$ ade based on coarse-graining procedures [1]-[3]. In a previous work [4] we show ed that in the fram ew ork of the classicalB B G K Y -hierarchy which explicitly inconporates the correlation betw een all the particle clusters in the system,m acroscopic irreversibility arises w thout coarse-grainig procedures. A ll that is needed is a coherent de nition of the entropy given through a generalization of the $G$ ibbs

[^0]relative entropy in term $s$ of the distribution vector in addition to the generalized Liouville equation. B ased on the fact that the generalized Liouville equation introduces a trace preserving transform ation in the set of distribution vectors, we obtained a non-negative entropy production for the isolated system which $m$ anifests the existence of a classical tim e arrow by appealing to the underlying $m$ icroscopic dynam ics only.

Here we develop the quantum version of this previous analysis. T he quantum counterpart of the distribution vector is the density superoperator evolving according to the generalized Liouville-von N eum ann equation. M oreover, we propose a generalization of the $G$ ibbs-von $N$ eum ann relative entropy in term $S$ of the density superoperator, in the spirit of the generalized $G$ ibbs relative entropy postulate. A s in the classical approach, here, the generalized Liouvillevon $N$ eum ann equation introduces a trace preserving transform ation asw ell. From this we obtain a non-negative entropy production for the isolated system, providing an arrow oftim e and giving a microscopic basis to the second law of Therm odynam ics. A fter obtaining that, through a therm odynam ic analysis, the quantum Boltzm ann equation follows in a natural way.

W e have structured the paper as follow s. In section 2, we introduce the H am ir tonian dynam ic of the N boody system obtaining the generalized Liouville-von $N$ eum ann equation. In section 3, we com pute the entropy production. Section 4 is devoted to the non Equilibrium Them odynam ic analysis of the system obtaining the quantum Boltzm ann equation. F inally in section 5, we em phasize ourm ain conclusions.

2 H am iltonian D ynam ics

Let's consider a dynam ical system of N identical particles whose H am iltonian is given by the N -particle H am iltonian

where $H^{(j)}$ denotes the individual energy of the $j$-th particle and ( $j ; k$ ) the interaction energy betw een the $j$-th and $k$-th particles. T he state of the system is com pletely speci ed at a given tim e by the N -particle density operator $D^{(N)}(1 ;::: ; N)$ which evolves according to the Liouville-von $N$ eum ann equation [5]

On the other hand, the dynam ics of the $D^{(n)}$ follows after perform ing the operation $\operatorname{Tr}_{(\mathrm{n}+1 ;: \mathrm{i}, \mathrm{N})}$, on both sides of Eq. (2). Thus, we obtain the so-called quantum BBGKY hierarchy of equations which can be written in a com pact way as a generalized Liouville equation

At this point, it is convenient to introduce the projection operators $P$ and $Q$, its com plem ent w ith respect to the identity (i.e., $P L+Q L=L$ ), which give the diagonal and non-diagonal part of the generalized Liouvillian $L$, respectively. This projection operators are de ned according to

W thout the right hand side term in this equation, the evolution ofD ${ }^{(n)}$ w ould be unitary. In the next section we w ill show that irreversibility is m anifested in the dynam ics of the system when the adequate description, i.e. in term sof the set $D$ of all the $n$-particle reduced density operators is used.

3 N on-equilibrium entropy and irreversib ility

A s the expression for the non-equilibrium entropy we propose

a functional of $D{ }^{(n)}$, generalizing the $G$ ibbs-von $N$ eum ann entropy postulate [11], [12], based on the fact that the superoperator $D$ determ ines the state of the system. This entropy is analogue to the relative or K ullback entropy [17], [18]. H ere, $k_{B}$ is the Boltzm ann constant, $S$ o the equilibrium entropy and $D_{0}$ is assum ed to be the equilibrium value of $D$ which corresponds with $S_{o}$, satisfying $L D_{\circ}=0$. It is known that $S$ is a concave functional of $D$, and $w i l l$ never decrease under a linear stochastic transform ation like the one induced by Eq. (11) [14]-[18]

Therefore, the entropy we propose is coherent w th the second law according to which $S$ increases in irreversible processes such as the relaxation to equilibrium from an initially non-equilibrium state. To prove this we com pute the rate of change of S which can be obtained by di erentiating Eq. (22) w th the help of Eq. (11)

Eq. (26) constitutes the entropy production corresponding to the relaxation passing from a non-equilibrium state to equilibrium . By using Eqs. (12)-(19) in addition to the cyclic invariance property of the trace, one has

These are zero at equilibrium when $D{ }^{(n)}=D{ }_{0}^{(n)}$, but in any other case these are not necessarily zero because neither the density $D^{(n+1)}$ com $m$ utes $w$ th $D^{(n)}$ and $D 0_{0}^{(n)}$ nor $D 0_{0}^{(n)}$ commutes with $H^{(n)}$, in general. Hence, according to our previous discussion related to the concave character of the entropy $S$ and its consequences, should be non negative. This provides a tim e arrow inherent to the irreversible $m$ acroscopic $m$ anifestation of the dynam ics of the system.

A sknown due to the unitary character of the tim e-evolution operator related to the Liouville-von $N$ eum ann equation giving the dynam ics of the $N$-particle density operator, the von $N$ eum ann entropy is a constant of m otion. Nevertheless, as we have seen here, this is not the case for the generalized $G$ ibbs-von N eum ann entropy, based on the fact that the dynam ics of the density superoperator given through the genaralized Liouville-von $N$ eum ann equation is not unitary. In addition, as com pared to other de nitions ofentropy, Eq. (22) does not contain any coarse-grainig. In the light of these facts not contained in other de nitions of the entropy in the literature the strength of our de nition (22) resides.

4 N on-equilibrium therm odynam ics analysis

H ere we proceed as in Ref. [20], which constitutes the standard way of N onequilibrium them odynam ics. Thus, for sm all deviations from equilibrium we assum e that $D$ and $D$ 。 are diagonal in a com $m$ on basis. A ccording to this, the entropy (22) becom es up to second order

5 C onclusions

H ere we have show $n$ a representation ofthe statisticaldescription of an $N$-body system in term sof a density superoperator which reveals the irreversibility at the $m$ acroscopic level. In the scenario drawn by the Liouville-von $N$ eum ann equation w ith its associated $G$ ibbs-von $N$ eum ann relative entropy, irreversibility is hidden because of the inherent unitary evolution of the N -particle density operator. N onetheless, in the fram ew ork of the quantum BBGKY hierarchy the density superoperator follow s a non-unitary dynam ics given by the generalized Liouville-von $N$ eum ann equation. T hus, the generalization ofthe $G$ ibbsvon $N$ eum ann entropy in term s of the density supoeroperator we propose is not conserved by this dynam ics. M oreover, this dynam ics is trace preserving which as is know n [14]-[18], ensures the non-negative character of the entropy production which is coherent w ith the second law of T herm odynam ic.

In addition, follow ing the procedure of the non Equilibrium Therm odynam ics we introduce a $m$ aster $m$ atrix which satis es a kind of $G$ reen $K$ ubo relation. $T$ his, allow s us to transform the BBGK Y hierarchy into a hierarchy ofm aster equations which we rew rite in term s of a transition superoperator related to the $m$ aster $m$ atrix. $O$ nce this has been done, by neglecting correlations in the spirit of the Boltzm ann's Stossahlansatz, we derive the quantum Boltzm ann equation.

To sum $m$ arize, ourpoint is that the fram ew ork ofthe B B G K Y hierarchy which explicitly incorporates the correlations betw een all the particle clusters in the system constitutes the $m$ ost appropriate description leading to irreversibility at the $m$ acroscopic level. To manifest this irreversibility all that is needed is
a coherent de nition of the entropy which is our generalaized G ibbs-von N eu$m$ ann relative entropy in addition to the generalized Liouville-von $N$ eum ann equation.

In this way a macroscopic tim e arrow arises in a natural way in the system. Hence, we can say that our analysis constitutes a microsoopic basis of the m acroscopic irreversibility.
