FITTING EFFECTIVE DIFFUSION MODELS TO DATA ASSOCIATED W ITH A \GLASSY POTENTIAL": ESTIMATION, CLASSICAL INFERENCE PROCEDURES AND SOME HEURISTICS

Abstract. A variety of researchers [15, 22, 27, 29, 31, 33] have successfully obtained the param eters of low -dim ensional di usion m odels using the data that com es out of atom istic simulations. This naturally raises a variety of questions about e cient estim ation, goodness-of-t tests, and condence intervalestimation. The rst part of this article uses maximum likelihood estimation (MLE) to obtain the parameters of a di usion model from a scalar time series. I address num erical issues associated with attempting to realize asymptotic statistics results with moderate sample sizes in the presence of exact and approxim ated transition densities. Approxim ate transition densities are used because the analytic solution of a transition density associated with a param etric di usion m odel is often unknown. I am prim arily interested in how well the determ inistic transition density expansions of A t-Sahalia capture the curvature of the transition density in (idealized) situations that occur when one carries out simulations in the presence of a \glassy" interaction potential. A ccurate approximation of the curvature of the transition density is desirable because it can be used to quantify the goodness-of-t of the model and to calculate asymptotic con dence intervals of the estim ated param eters. The second part of this paper contributes a heuristic estimation technique for approxim ating a nonlinear di usion m odel. A \global" nonlinear m odel is obtained by taking a batch of tim e series and applying simple local models to portions of the data. I demonstrate the technique on a di usion m odel with a known transition density and on data generated by the Stochastic Sim ulation Algorithm [21].

1. Introduction. C om plicated systems are often approximated by overly simplied models. A signi cant research e orthas gone into attempting to e ciently summarize the information contained in a complicated atom istic simulation with a low-dimensionale ective model [15, 22, 27, 29, 31, 33]. A tom istic simulations contain many observables, an elective di usion model aim s at representing the salient features of the data in the drift component of a stochastic di erential equation (SDE) and lumping the elects of the neglected details into the noise term. The appeal of elective models stems from the fact that information contained in the elective models can easily and quickly be extracted by analytical methods or well-established numerical procedures. The idea being that the \truth" is contained in the atom istic simulation, but the computational load required to get the information is so large that the researcher has a di cult time exploring all of the process parameters under study.

Before one attempts to wrap e ective models around the output of an atomistic simulation, a variety of assumptions need to be made about the data and the parametric model. In this paper, I obtain parameter estimates from the classical parametric framework via maximum likelihood estimation (MLE). Here the phrase \classical parametric framework" refers to the fact that one uses a single family of functions (of specied functional form) for the drift and di usion coe cient functions

of the di usion SDE that depends only on a nite number of parameters. I make the following assumptions about the atom istic system and the parametric di usion model:

A sm all set of order parameters [46, 25] that accurately sum marize the full atom istic system are identied and easily measurable. The term <code>\order parameter"</code> is used to refer to the observables modeled in the elective di usion SDE.

The parametric model is uniquely identiable.

The exact transition density of the param etric model has all of the regularity properties that make M LE attractive. Namely it is the asymptotically most e cient estimator in the sense that the properly normalized parameter distribution associated with the procedure converges to a normal distribution with the smallest asymptotic variance (in \nonergodic" situations this assumption is relaxed).

The true parameter value admits a contiguous neighborhood and the process allows for a quadratic expansion of the log likelihood ratio 1 .

The dynamics of the order parameters can be adequately described by a diusion $\mbox{SD\,E}$.

The drift and di usion ∞ cient of the elective SDE are suitably smooth (to be more specic assume the functions are in nitely dierentiable with respect to the parameters and state, but this can be relaxed substantially) and the drift ∞ ponent of the SDE comes from the gradient of an elective potential [15, 31]. Even if the order parameter being considered is governed by a glassy potential (this term is described in section 2), a smooth drift coelected to summarize key features of the free energy landscape².

The rst item is extremely in portant and is an active area of research in our group [46], but will not be addressed in this article. The next two assumptions allow one to trust the parameter estimates and allows one hope for checking if some asymptotic results associated with M LE [28, 48, 50] hold for the sample sizes used. The fifth item is brie y addressed in the nal application of the second part of this paper where I estimate the parameters of a di usion approximation of a jump process (the model of the reduction of nitric oxide on a platinum surface given in [41] is revisited). The nal issue is concerned with \m odelm isspeci cation" [50], dealing with this issue is important if the elective model is to be of any practical use. I rst obtain parameter estimates assuming the nal item holds, but in section 4.3 classical techniques for testing this assumption a posteriori are outlined. Some nonparameteric goodness-of-

t tests are better suited for practical im plem entation [12, 26], but classical tests are of interest because the tests used quantify how wella transition density approximation m atches the curvature of the true density.

In order to use M LE one must have an approximation of the transition density of the di usion process. Unfortunately, for many SD E's the transition density is not available in closed-form so one must resort to some approximation of the density. The estimation techniques presented are intended for application to interesting atom istic systems (e.g. a time series that comes from a molecular dynamics simulation), but in

this paper toy models are studied in order to system atically study the consequences of using the transition density expansions of A t-Sahalia [3, 4] in some large sample statistics applications. Our research group has had success in applying some of these ideas to actual atom istic systems, but this paper's main concern is in determining exactly how much information can be extracted from the transition density expansions in controlled examples intended to minic scenarios encountered in some multiscale applications.

The remainder of this paper is organized as follows: Section 2 reviews the multiscale applications that motivated this study. Section 3 lays out the model systems used. Section 4 outlines the techniques and estimation tools used in the presence of \contam inated" ³ data and transition densities. Section 21 outlines a simple estimation procedure that can be used to study multiscale systems that satisfy the assumptions stated above. Section 6 contains the numerical results and discussion and the nal section gives the conclusion and outlook.

2. M otivation. A situation encountered often in spin glasses [34], protein folding [25], and zeolites [10] is that of a harm onic \glassy" potential energy surface ⁴. That is to say, when one boks at a free-energy surface from a distance, the shape of the free energy surface is roughly parabolic. W hen one boks closely at the details of the surface however, one sees many bumps in the surface (see gure 3.1). In many applications, it is believed that the order parameter of the process \funnels" its way down to the global minimum of the free energy surface [25] in the long time lim it. Current computational power does not always allow one to carry out an atom istic simulation long enough to observe such a phenom ena because the order parameter can get trapped in a local minima. Sometimes one can reach the global free energy minima by increasing the temperature parameter of the simulation [18, 13]. W hen this occurs, the force binding the order parameter to the global minimum still has a \bum py" potential associated with it (but the magnitude of the bum ps is smaller because of the new temperature scale). I refer to this hypothetical case as situation I.

A nother commonly encountered scenario is one where the order parameter is trapped in a free energy well which is not the global minimum of the surface. Many applications require system information at low temperatures, ruling out the simple technique mentioned in the previous paragraph. If the temperature of the system is so low that on the timescale of the atom istic simulation that the order parameter appears to be approximately bound by a smooth (but not necessarily harm onic) potential in a neighborhood of the local minima, then I will refer to this case as situation II.

C lassic statistical mechanics models usually assume that the noise around the local minima is state independent. This assumption does not hold in a variety of interesting systems, [31, 15] so in all models I consider there is state dependent noise in the process. The estimation techniques presented in this paper deal with both situations described in the preceding paragraphs.

If the location (s) of the dominant free energy wells are known by theory or simulation methods, then the estimation methods shown here can be used to measure the curvature at the wellminim a which can in turn be useful for getting information about transition pathways [14]. If one also has know ledge of where the saddles are and a protocol for starting meaningful simulations around the saddle point then the methods presented can also be used to determ ine the curvature of the unstable state points.

3. M odel System s. To idealize situation I and II, data is generated from two fam ilies of SDE's. This rst fam ily is meant to m in ic situation I and has the form :

The second family idealizes situation II and takes the form :

The parameters are set to = 20, = = 4, and $! = \frac{1}{3}$ throughout. The parameters and take the values (0,15,60,200) and $(0,\frac{1}{400})$. I refer to these cases as situations IA-D and situations IIA-B respectively. The situation where and are both zero is known as the Cox-Ingersoll-Ross (CIR) model and is one of the rare situations where an SDE with nonlinear coe cients has an explicit solution [3]. I use this example because it illustrates mean reversion, it demonstrates state dependent noise and most importantly has an exact closed-form transition density which can be used to help determ ine why a transition density approximation is failing.




Fig. 3.1. Situation I Potential Potential energy function used to determ ine drift with = (0;15;60;200). The inset shows the empirically measured invariant distribution for the four values of used (with obvious correspondence between the four cases); the distributions are shown only to give one an idea of how the di erent parameter values a ect the long-term dynamics (M LE parameters only depend on the observation frequency).




Fig. 3.2. Situation II Potential Potential energy function used to determ ine drift with $(=0;\frac{1}{400})$ along with inset of corresponding invariants distributions (the narrower distribution corresponds to the nonlinear perturbation case)

Figures 3.1 and 3.2 plot the potential energy surfaces for the cases studied. In all cases, sam ple paths of the above processes are simulated using the explicit Euler scheme [30] with a step size $t = 2^{-9}$ given data starting from the invariant density associated with situation IA. The data is observed every 16^{th} step yielding a constant observation window spaced by $t_{bbs} = 2^{-5}$ time units (in Situation IA-C the data is also sam pled every 64^{th} step giving $t_{bbs} = 2^{-3}$). Each plot and graph that are grouped together in this paper used the same B row nian trajectories in order to sim – ulate paths (the only di erence between the sam ple paths is caused by the di erent drift coe cients) in order to reduce variation due to random number draw s.

For the st part of this paper, the data generated by the SDE's above is modeled by the CIR class:

For the second part of this paper, the following parametric family is used:

W here X $_{\circ}$ is user speci ed; the parameter vectors are estimated by techniques associated with maximum likelihood in all cases.

The second terms in the drift coe cient of the data generating processes are used to determ ine how robust the estim ator is against model misspeci cation [50, 42, 9]. The perturbation terms are not modeled because it assumed that their true (or approximate) functional form are completely unknown and the interest is primarily in the smooth noise and mean reversion parameters (;;). Of course the presence of these extra terms a ect the estimation of the parameters, it is shown in section 6 that the e ects induced by these perturbation parameters a ect things consistently with what a physicist of them ist would intuitively anticipate. The interesting feature demonstrated in the aforementioned section is quantitatively how the MLE procedure carried out with various transition density approximations respond to these perturbation parameters in relation to the exact transition density.

The reason for studying the rst two idealized model systems stems from a desire to carefully numerically quantify how the MLE procedure with approximated

transition density perform s in tasks beyond point parameter estimation. The results obtained are of course specic to the model and parameter values used, how ever one can always obtain the parameters of a parametric di usion model using observations from the particular system being studied and then carry out an idealized set of tests similar to the ones presented here by using established SDE path simulation techniques [30].

The nalm odel presented is one for the reduction of nitric oxide (N O) by hydrogen gas on a platinum (Pt) surface. The mechanism is as follows [47]:

NO^y represents NO absorbed onto the Pt surface; this mechanism is used with G illespie's Stochastic Simulation A lgorithm (SSA) [21] technique in order to construct stochastic evolution rules for the amount of NO in the system at any given time. This model is used because it exhibits nonlinearm ean reversion with state dependent noise. The jump process is known to converge weakly to a di usion with a cubic drift term

as the system size parameter (denoted by N_{m olecules}) increases [21, 1]. This yields another \situation II" type scenario, but now the data generating process is not a genuine di usion ⁵. The parameter k₃ is set to a num erical value of 4, the otherm odel parameters used are given in [41]. In the nalpart of this paper, the parameters of the assumed model are extracted in the \smallm olecule" case (N_{m olecules} = 3600). This value is chosen because simple visual inspection indicates that the process has not yet converged to a di usion ($t_{obs} = 2^{5}$) with this molecular population size, so the exact functional form of the di usion model is unknow n. A \global" ⁶ estim ate of the di usion approximation of the actual process is obtained using techniques presented in the second part of this paper and the invariant density of the obtained nonlinear di usion model is compared to that of the actual SSA process in section 6.

4. Statistical Tools. In the beginning of this section, som e classical statistical tools relevant to this study are outlined. The tools are only brie y de ned, references are given throughout which com prehensively describe the details of the theory applied. The tools below are applied to the estimation of the parameters associated with both stationary and \nonergodic" ⁷ tim e series.

M LE's importance⁸ stems from the fact that one needs some kind of generic metric by which to judge a wide class of parametric models by. In situations where the underlying transition density satis es a set of regularity assumptions [48], it is very appealing because it provides a consistent estimator with the minimum asymptotic variance. If one has a reliable estimate of the underlying transition density, then one can sometimes (in the stationary ergodic distribution case [28]) determine the asymptotic parameter distribution with a simple deterministic integral [24, 38]. One can also generate test statistics based on output of the M LE procedure which can be used to asses the goodness-of-t of the parametric model [50].

Next, an optim al sim ple hypothesis test is introduced. Speci cally, the transition density expansions are used in order to create the Neym an-Pearson test statistic [8]. A sim ple hypothesis test is useful when one wants to test the statistical signi cance of the magnitude of the changes in e ective model parameters when one adds more features to the underlying atom istic simulation (e.g. one would like to determ ine if the changes in the elective model are signi cant when the parameters are estim ated from the output of atom istic simulations that use a potential with and without electrostatic interactions).

It is already known that the simple models that are wrapped around the data do not faithfully represent the exact system dynam ics. In section 4.3, methods that can be used to quantify how closely the proposed parametric models represent the data are reviewed. In section 4.4, a heuristic method that can be used in the nonergodic case for obtaining parameter uncertainty estimates is presented.

4.1. M axim um Likelihood Basics. In order to avoid technical complications, it is assumed throughout that the exact distribution associated with the parametric model admits a density whose logarithm is well de ned almost everywhere and the logarithm of the density is continuously twice di erentiable. The principal of maximum likelihood is based on maximizing the following integral with respect to the parameter :

In the above equation, Q corresponds to the measure of the underlying probability space, f(x;) corresponds to the R adon-N ikodym derivative (consult [32, 50]) of the law of the random variable x with respect to the underlying probability space and x corresponds to a discretely sampled time series (of nite length = M). A ssume that if the measure of a set under Q is zero it im plies that the measure of the set under P is also zero (the phrase \P is absolutely continuous with respect to Q " is used

to describe this situation). Let P = f(x;)dQ. For discrete M arkovian m odels, f(x;) can readily calculated by the following form ula [24]:

In the above equation f (x_n \dot{x}_{n-1} ;) represents the conditional probability (transition density) of observing x_n given the observation x_{n-1} . In practice, one usually takes a nite sample of data and presents this data to a M onte C arlo scheme that is meant to approximate the integral in equation 4.1 and nds the parameter values that yield the maximum value. In what follows, the function below is referred to as the log likelihood function (assume throughout that x_{o} has a D irac distribution) :

Under our assumptions one has ⁹ the following:

W here in the above ^ is the \true" parameter of the model; represents the parameter estimated with a nite time series of length M ; =) denotes convergence in distribution [48, 24] under P_{\wedge} ; N (0;F 1) denotes a normal distribution with mean zero and covariance matrix F 1 . For a correctly specified model, F 10 can be estimated in a variety of ways [50, 38]. Various conditions can be tested to see if asymptotic results are relevant for the nite sample sizes used [48, 38]. In this article sam ple sizes are m oderate, but good agreem ent with som e classical asym ptotic predictions [50] is observed. When a closed-form transition density is in hand one can determ inistically calculate F in the stationary ergodic case 11 .

In practice, maximum likelihood does fail spectacularly for some simple models because of singularities that can be observed with the log likelihood function 12 . The classical example is the following: one assumes that a distribution is a mixture two Gaussians whose variance 2 (0;1). Then the nite sample MLE fails to exist in this simple case (see [8, 48] for a more in depth discussion) ¹³.

tion of the process (which in the scalar case can usually be readily calculated in closed-form from the coe cients of the param etric SDE [26]). The di culties encountered in the nonstationary time series situation is analogous to the situation of using the M etropolis algorithm to sam ple phase space [18]; in principle a determ inistic integral could be evaluated, but with current com putational power quadrature is not possible due to the high dim ensionality of the problem

The aforem entioned point brings us to an important observation contained in this paper. It is well known that the transition density associated with a di usion SDE can be solved through a corresponding PDE (via the Kolm ogorov equations [4]). One can often prove that the density of the process has the regularity properties needed to make exact MLE successful (a priori regularity bounds associated with the log likelihood function is trickier) via techniques of harmonic analysis [43], but many useful properties determ ined by analytic techniques are only applicable to the exact transition density. A pproxim ations to the transition density are needed in cases where the transition density is not available in closed-form . The approximations provided by A t-Sahalia's Herm ite expansion [3, 4] are useful for obtaining point parameter estim ates, can capture the curvature of the transition density enough to approxim ate param eter distributions, and are som etim es accurate enough to create test statistics needed for som e hypothesis tests. How ever, when one uses derivatives of the expansion for creating W ald or R ao 14 test statistics [8] it can introduce spurious singularities which complicates squeezing all of the inform ation that is theoretically possible from MLE. I use the \Euler" estimator as a crude transition density approximation to dem onstrate som e points in this paper 15. It is well known that the Euler estimator is signi cantly biased [40], this fact helped to initiate a ood of transition density approximations in recent years [3, 4, 5, 7, 19, 44] (just to mention a few).

4.2. Optim al B inary A lternative H ypothesis Testing: The N eym an-P earson Lemma. In this section it is assumed that one has a data set and two parameter vectors. A ssume that one parameter vector is the \nullhypothesis" and the other parameter vector is the \alternative". The type I error probability is dened as the probability of rejecting the nullhypothesis when in fact the null is true (classically denoted by). The power of a test against the alternative is the probability of rejecting the null hypothesis when in fact the null strue. An optimal test statistic can be found which for a specified maximizes the power [8]. To create the test statistic denote he likelihood ratio by L = $\frac{f(x_{i, N u II})}{f(x_{i, N u II})}$;

one rejects the null if L > NP where NP is a scalar value that allows the equality f(x; $_{Null}$)dx =

In the context ofmultiscale system s computations, this test is really only practical for stationary ergodic distributions (or for order parameters that are trapped for the duration of a simulation in a local free energy minima), but it provides us with insight as to how well the transition density captures the likelihood ratio of nearby parameter points. Applications shown later require a highly accurate approximation of the likelihood ratio.

4.3. G oodness-of-t and M odel M isspeci cation. It is possible to test if the log likelihood function is consistent with the proposed m odel structure by testing

In the above, the superscript T denotes the transposition operation, F_{OP} is the \outer product" matrix. For correctly specified models, both F_{OP} and $F_{Hessian}$ [24] are valid estimates of F. When a closed-form expansion is in hand, these quantities are easily computable after the optimal parameter is located.

For real data it is overly optim istic to expect to be able to exactly param eterize the density of the process with a Euclidean param eter vector. However, in some situations it is meaningful to attempt to project the data onto the proposed model structure [9, 50] yielding a Quasi-M axim um Likelihood Estimator (QMLE). When the true density does not lie in the proposed param etric model class, one can still maxim ize the integral in equation 4.1 yielding the estimator that minimizes the Kullbeck-Leibler distance [32, 42]. Under assumptions laid out in [50], this QMLE converges to a norm all distribution in the in nite sample limit:

The matrix C (= $F_{Hessian}^{-1} F_{OP} F_{Hessian}^{-1}$) replaces F^{-1} . This fact can be used to test the goodness-of-t given the data and the optim alparameter vector via the Rao or W ald test statistic [50, 8]. Them ethodology laid out in [50] is comprehensive and pow-erful, but in order to develop techniques which can be accessed by the diverse audience involved in multiscale modeling, algorithms available in standard packages/libraries (MATLAB, MSL) are employed.

4.4. Le C am 's M ethod and Likelihood R atio E xpansions (LAQ). Lucien Le C am was a major contributor to a variety of important asymptotic statistics results [35, 36, 38]; one of his major contributions was concerned with Locally A symptotic Quadratic (LAQ) expansions of the log likelihood ratio (llr). D enote the llr symbolically by $_{\rm h,M}$ (). It is given (for discrete M arkovian models) by:

Here M is again the length of the times series; h is a vector perturbation with the same dimensionality as ; M is a matrix that scales the perturbation and L denotes the llrevaluated at ; for later use let $h_M := M$ h. W hen the assumptions behind LAQ hold [28, 38], one can asymptotically approximate the above statistical experiment by a norm all limit experiment ¹⁶. If one is in a neighborhood of the true parameter (^) the LAQ conditions in ply

converges (in P_^ probability) to 0. In the above expressions, when $_{h,M}$ () is twice dimensional with respect to $, S_M$ () and W_M () play the role of the rst and second derivative (respectively) of the llr [28]¹⁷ with respect to the parameter vector.

The contiguity condition is a generalization of the concept of absolute continuity [23]; it allows one to determ ine the asymptotic distribution of \nearby" experiments which is sometimes useful for constructing hypothesis tests. Denote the true parameter by $\hat{}$ and let $\hat{}$ be contained in a M neighborhood of $\hat{}$. If contiguity exists in the experiment, it [48] in plies the following limit distribution:

The llr is of interest to us because it provides a method for taking a classical parametric model and producing a scalar random variable which has the above lim it distribution in the LAQ case (the practical utility of this theory is realized if the above norm aldistribution can be used to reliably approximate the more complicated distribution of the llr associated with the proposed parametric model for moderate sample sizes [36]).

There are many other important implications of LAQ, the method is only used in this paper to quantify the uncertainty associated with a nonergodic time series. In the stationary ergodic case the matrix W_{M} ([^]) coincides with determ inistic quantity F shown earlier, for nonergodic models the matrix is itself a random variable. I repeat the construction in LeC am chapter 6 [38] here in order to show how one uses the llr in order to estimate W_{M} ([^]) (which can be used to roughly approximate the variance of the limit parameter distribution). To simplify the situation, assume that one is already within a $_{M}$ neighborhood of [^] (this neighborhood is centered at [~]) and set the matrix $_{M} = \frac{p_{M}^{1}}{M}$ Id where Id is the identity matrix. Under the LAQ assumptions, one can claim that W_M (~)=) W_M (^) as M tends to in nity. The theory shown here (developed by LeCam) is purely an asymptotic one, how ever if one observes that the relation in equation 4.4 holds, it gives one more con dence when equation 4.5 is employed to approximate the quadratic expansion of the llr. In the situation where W_M (~) is random (as it will be in some of the applications presented), one needs to repeat this procedure for a variety of paths ¹⁸ and then take expectations in order to get a rough estimate of the asymptotic

param eter distribution associated with the collection of sam ple paths. The estimation m ethods that use the LAQ expansions are purely heuristic, the theory developed above is proved in great detail for independent random variables; asymptotic statements about the llr associated with generalM arkov chains are harder to make [36, 45]. The potential applications of these types of ideas in multiscale applications are merely shown via numerical results in this paper.

5. LocalPolynom ialD i usion M odels. Thus far, them ain concern has been approxim ating the transition density and quantifying the goodness-of-t of our simple models to the data. For the remainder of this section assume that the data can adequately be described by some arbitrary nonlinear e ective SDE. Recall, I am working under the assumption that even if the true underlying potential energy surface is rugged, a sm ooth m odel of the drift and di usion coe cients can be used to reliably approximate certain features of the free energy surface. In statistical mechanics, som etim es a lim it theory exists for what the large sam ple system 's e ective dynam ics converge to [20]. Unfortunately, for many interesting systems, the functional form of the drift and di usion coe cients are completely unknown. Our research group has used the label equation free m ethods" [29] to describe a set of num erical procedures that have been designed to dealwith a situation where one has a simulation protocol that is believed to contain useful inform ation and the inform ation in the simulation is believed to be describable by an e ective equation (with sm ooth coe cients), but the equation is unavailable in closed form . The early versions of this procedure used least squares approximation in order to get derivative information. Within the last couple of years, our group has extended the estimation procedure to match local linear SDE models (both vector and scalar) to the output of simulation data. The parametric m odels proposed are of the type given in equation 3.4. M LE and QM LE are greatly facilitated by the determ inistic likelihood expansions developed by A t-Sahalia [2,3,5] 19.

Conceptually, Iam just taking advantage of the fact that the accurate A t-Sahalia Herm ite expansion allows us to generalize the piecew ise-polynom ial (pp) concept to di usion SDE models. Since I posit the existence of a smooth underlying e ective di usion model, the drift and di usion coe cient functions are t locally to linear models. One is free to use a fairly broad class of polynom ials in the scalar case with a variant of A t-Sahalia's expansion [5], but our future work is concerned with applying the techniques in this paper to the vector case. In that situation, a higher order polynom ial of unknown vector functions is not practical from an estimation standpoint. O ur experience has shown that if one wants to accurately capture the mean reversion portion of a nonlinear e ective model that it usually becomes necessary to model the state dependence of the noise (this point is illustrated in section 6.5). In statistical terms, I am simply just noting the QM LE estimate of the param etric model shown in equation 3.4. How ever a variety of practical questions arise:

How does one determ ine if the estim ated m odel is m eaningful? In the case where an approxim ate transition density is used to estim ate pa-

ram eters, how sensitive is the QM LE projection to the quality of the approxim ation?

How does one choose the size of the neighborhood where a local linear model is valid?

How does one piece together the local models in order to create a global nonlinear e ective di usion model?

The rst issue is readily handled by the theory discussed earlier. The second issue is concerned with sem iparam etric estimation and robust statistics. These are important and active area of research in statistics [9, 48] (and in the future could make great contributions to multiscale modeling), but results are currently di cult (for this author) to translate into practical and reliable num ericalm ethods associated with the ideas laid out here. In section 4.1 it is shown that the true model is not too sensitive to \contam inated data" and this quality is retained by the expansions of A t-Sahalia, how ever is not by the overly crude Euler estimator.

A simple estimation procedure is well-equipped to handle the third issue. The m ethod requires the user to obtain a batch of trajectories from a simulation. In order to carry out a classical estim ation procedure, one must create a partition of state space where a local linear di usion model is an accurate representation of the underlying nonlinear di usion (see gure 5.1). O nœ the data set is collected, one is free to m ake as many partitions as desired. The simple idea is to only present observation pairs $(x_n; x_{n+1})$ to the log likelihood function that have x_n " within the selected neighborhood. The neighborhood size must be chosen to be small enough that the QM LE param eters estimates of the pp SDE model are statistically meaningful²⁰ and large enough to contain enough samples to obtain the desired parameter accuracy (and have asymptotic limits remain useful for the sample size). The main di culty that the method faces is determining a neighborhood yielding a satisfactory compromise between the two aforem entioned factors. This procedure is greatly facilitated by the equations of a lim it process if one is known. O there is one must use num erical experin entation to attempt to determ ine how sm ooth the underlying coe cient functions are (recall the assumption that a simple low-dimensionalm odel exists). In multiscale m odeling we have the convenience of controlling the initial conditions of the (assum ed m eaningful) atom istic simulation m aking this type of pp SDE m odeling m ore practical (otherwise one can only estimate parameters around state points visited frequently by the sam ple path). Note that this method makes the time series length itself a random variable. In addition, many applications of this idea lead to estimation of a nonstationary time series. It has already been noted earlier that it is computationally di cult to calculate the Fisher information matrix in these circum stances. These facts indicate that the LAQ likelihood ratio approximation m ight be useful. It should be noted that optim all tests rarely exist in this type of situation, how ever in the estimation literature some heuristic techniques have been recommended [6, 17]. The technical details of these methods require some fairly specialized arguments and due to this author's ignorance of both recent developm ents and the more important aspects of the theory, goodness-of-t tests are avoided in this situation 21 .

In regards to the nalitem, I merely present two simplistic methods of piecing together our local models in section 21. I also demonstrate that the LAQ expansion can give a useful quantication of parameter uncertainty for our toy models. The information contained in an LAQ approximation can be used in more sophisticated \medshing " schemes. Again this area is well outside of this author's research area; if the problem at hand is of any real significance one should consult [11, 16, 49] for modern matching techniques, but at some stage one will almost certainly have to appeal to some form of heuristics (a k a., \the art of numerical computation").

5.1. Relevance to M ultiscale N um erical M ethods. The details of the tools used may obscure their utility in multiscale modeling, so the connection is sum marized here. The computational bad to carry out a full simulation is too great, so a di usion approximation is made which hopes to capture the relevant information in the underlying model. Goodness-of-t tests are needed to quantify the quality of the approximation. If the model is found to be statistically acceptable, then one would be interested in the con dence intervals associated with the estimate. Dierent state points have di erent levels of noise; having a reliable m ethod for theoretically predicting param eter uncertainty as a function of sample size at di erent state points can assist one in designing \e cient experiments" because one can allocate computational resources in an intelligent m anor. QM LE is a nice tool for achieving all these tasks, however it can fail if it is followed \verbatim ", especially when one uses an approxin ation of the transition density. Estimators based on llr methods are appealing in situations where standard QM LE fails because they are applicable to a wider class of problem s and the distribution of the llr asym ptotically converges to a m anageable distribution for certain m odel classes [36].

6. R esults and D iscussion. In order to get M LE (QM LE) parameter estimates in all of the section to follow, the IM SL Neder-M ead search algorithm is employed using the term ination criterion of 5 $\,10^{-8}\,$ with an initial parameter distribution dictated by a uniform distribution around the slightly biased (+ 10%) true parameter values in the cases of known or approximately known models and from an assumed limit process in the nalapplication.

6.1. M axim um Likelihood Estimation Results. Tables 6.1 and 6.2 report the empirically measured mean and standard deviation of the parameter distributions as well as the asymptotic predictions for the standard deviation for situation IA-D and situation IA-C (using data spaced $t = 2^5; 2^3$ units respectively). We see that as increases the estimated mean reversion parameter decreases in magnitude. This makes sense because the parametric model in equation 3.3 assumes a single free energy m inim um ; as the m agnitude of the sine wave added to the drift increases, one experiences a situation where the \well-depths" associated with the local minim a of the glassy potential increase, retarding the rate of mean reversion (centered around the globalm inimum). The exact magnitude of this e ect depends heavily on several factors, some of which are: the magnitude of the noise, the frequency of the sine wave's perturbation, the amplitude of the sine wave, and the sampling frequency. The last two e ects are quantiled in tables 6.1 and 6.2. Inspection of these tables shows that the when the true density is used, the e ective model estimated from the data is relatively independent of the sam pling frequency. Note that as the observation frequency decreases the quality of the expansion (in time) naturally decreases, but




Fig. 5.1. LAQ Screening M ethod Illustration Applied to Situation II B D ata The circle corresponds to a state point where a param etric m odel was obtained using that particular\X $_{\circ}$ " in the param etric m odel given in equation 3.4. For sm ooth m odels the quality of the linear approximation depends on the neighborhood size as well as the curvature of the drift and di usion coe cients (latter not shown). Once the data is collected, one is free to vary X $_{\circ}$ and/or the neighborhood size where the local SD E is assumed to m odel the data.

even for relatively \large" tim es between samples A t-Sahalia's expansion remains accurate. The quality of the Euler expansion is very sensitive to the time between sam ples and it introduces a signi cant bias even when the \perfect data" is presented to the estim ator. I continue to show the results for the Euler estim ator despite these shortcom ings because in section 6.4 the estim ator dem onstrates a redeem ing quality which can be used in conjunction with the transition density estimator of A t-Sahalia in situations where the latter fails. The tables also show that the sample size is large enough to partially realize asymptotic results in most cases. Table 6.3 shows sim ilar results; the cubic perturbation introduced into the drift results in a higher mean reversion rate. In section 6.4 it is demonstrated that if one presents \screened" data (those observation pairs that fall within a small neighborhood centered around the estim ated param eter) that the bias introduced by the nonlinear drift perturbation steadily decreases in m agnitude as the neighborhood size decreases which intuitively makes sense given our assumptions. Unfortunately, this simple procedure creates a m ore complicated statistical problem in regards to theoretical parameter distribution predictions because a determ inistic approximation of the parameter distribution is much harder to get using this technique.

6.2. Optim al B inary A Iternative H ypothesis Testing R esults. In gure 6.1, the top/right axis corresponds to the N eym an-P earson critical value versus the theoretical type I error probability for all three transition density expansions using the null as the true (known) param eters of situation II A and the alternative as the param eters obtained using situation II B data with QM LE (using the exact C IR density). The left/bottom axis shows the analytically calculated cum ulative distribution of rejecting the null under the alternative using the three di erent transition densities (plugging in the same alternative param eters estim ated by QM LE) as well as the empirically m easured distribution of the likelihood ratio (see caption for additional details). We see that the sam ple size is large enough to realize agreem ent between the m easured and lim it distributions. The expansion of A t-Sahalia provides a very good approxim ation of this distribution, whereas the distribution predicted by the Euler approxim ation deviates substantially.

6.3. G oodness-of-t and M odelM isspeci cation R esults. Here it is demonstrated how the various transition densities perform when one tries to use them to evaluate the derivatives needed to estimate some goodness-of-t statistics shown in [50]. Before proceeding, a mildly problem atic aspect of the expansion of A t-Sahalia is pointed out. To illustrate the problem, the histograms of $\frac{\theta^2 L}{\theta^2}$ are plotted for 500

sam ple paths using the three expansions. The particular histogram shown using the A t-Sahalia expansion had 25 observations that were disregarded because of unusually high values in the calculated quantities. The expansion of A t-Sahalia is very accurate, but its functional derivatives can unfortunately introduce spurious singularities into the transition density approximation. To show a speci c exam ple of this, take the logarithm of the order one A t-Sahalia C IR expansion²² and calculate the second derivative with respect to and plug in the observation pair (obtained via an Euler




Fig. 6.1. Neyman-Pearson Results The Neyman-Pearson test carried out on situation II B data using the QM LE parameter estimate as the alternative and the exact (known) parameters associated with situation II A as the null. The curves represent the deterministic calculation of the type I error probability as a function of the critical value (right axis) and the theoretical CDF of the likelihood ratio obtained by using the various transition density expansions assuming ergodic sam pling of the invariant distribution (left axis). The $\times r's'$ correspond to using the actual situation II B data (nonlinear potential) and the $\circ s''$ correspond to the distribution of the likelihood ratio obtained using the QM LE parameters estimated to simulate sam ple paths of the parametric model proposed (plugging in the average of the QM LE parameter distribution) and then using the exact CIR density to evaluate the likelihood ratio.

path simulation) $[x_n; x_{n-1}] = [3:1826960; 3:305275]$ and set $= 4; = 4; t = 2^5$. The bottom panel in gure 6.2 plots the resulting function of . For the particular model and parameter values shown, this type of situation is only encountered when calculating functional derivatives. In the transition density associated with the model given in equation 3.4, sample values where singularities are hit when evaluating the pure log likelihood function are encountered. A standard method for dealing with this is to apply a one-step M LE estimator²³. A minor modi cation of Le C am's method shown in section 4.4 provides one possible construction of a one-step M LE estimator. M any one-step methods require a parameter guess that is within a \reasonable neighborhood" of the true parameter value (the exact size of the neighborhood can be

The major problem with these estimators is that the contiguity condition becomes di cult to verify (a condition that needs to be met before the LAQ expansion can be used with con dence). The last two columns display -2 times the mean and the variance of the llm easured by evaluating it a ^ and ^ + h_M where h_M = (12;0;0:12). In the in nite sample limit these two quantities will be identical (assum ing h_M is continually scaled properly). For the exact and order four A t-Sahalia expansion one observes close results. For the other two expansions this is not the case (see text for further discussion).

chosen using an approxim ation of the Fisher inform ation m atrix). Table 6.4 illustrates that if one starts with a slightly perturbed guess of the true param eter that LeCam 's m ethod can get fairly close to the true param eter vector if the transition density approximation is very accurate (the llr expansion was obtained from situation IIA data and the one-step used is outlined in Le Cam [38] chapter 6). The asymptotic likelihood expansions are valuable in param etric estimation; unfortunately this application requires an extrem ely accurate transition density approxim ation 24 . Throughout this paper the st order (in time) A t-Sahalia expansions have been used; only in table 6.4 do I report results from a higher order expansion (order four). Recall in section 6.1 that the order one A t-Sahalia expansion provided an accurate approximation of the likelihood ratio for a simple hypothesis test. The test statistic generated for the Neyman-Pearson test only required the ratio of one observation pair at two nearby param eter vectors. The transition density expansion does introduce a system atic bias into the approximation, and the nature the bias does exhibit a smooth dependence on the parameter values making the ratio of two nearby probability densities also exhibit a signi cant bias and these small errors accumulate as the time series length grows (see equation 4.3) com plicating matters. Som e techniques and analysis have already been developed for approximating the LAQ expansion of random variables in the case where the density is not known explicitly [28]; most techniques developed require one to empirically measure the transition density. For our applications, the empirical distribution techniques are mildly inconvenient (from a computational standpoint) because one needs to determ ine an empirical density approximation for each observation pair.

Now let us return to the goodness-of-t issue. First, the condition $F_{Hessian} =$

 $^{^{24}}$ Instead of applying one-step m ethods (a full discussion would slightly overload this paper and distract from the simpler points), in the sim ple param etric m odels studied I rem edy the singularity issue by using the Euler approximation to determ ine when a singularity is hit. It is possible to distinguish between spurious singularities from log likelihood function singularities in the CIR case because the true transition density is known. In all of the CIR applications the singularities hit were in fact spurious. I simply threw out sample paths where the absolute value of the logarithm of the transition density of the A t-Sahalia expansion di ered from that of the Euler approximation by a factor of three anywhere along the discretely observed path (this occurred less than 4% in the CIR studies, in the SSA studies this number increased to roughly 25%).




Fig. 6.2. Histogram of D iagonal C om ponent of $F_{\rm H}$ essian C orresponding to for the Three Transition D ensity Expansions The histogram s all have slightly di erent shapes indicating that the curvatures of the three transition densities di er (data taken from situation IC with $t = 2^5$). In the second plot 25 observations were thrown out because there were outliers caused by spurious singularities in the transition density expansion. The bottom panel gives one dem onstration of how the A t-Sahalia expansion can introduce spurious singularities into the log-likelihood function. The data shown is the second derivative of transition density expansion with respect to as a function of for a particular observation (see text for discussion). The fat tails of the log likelihood function m ake a sim ple screening of outliers (caused by spurious singularities) very di cult if one does not have the true transition density to reference.

 F_{OP} it tested. If the condition holds $T := \prod_{i,j=1}^{p_k} F_{Hessian}^{ij} + F_{OP}^{ij}$ should be a mean zero random variable (the superscripts denote matrix components and k is the number of param eters estim ated). If it is assumed that the classical central lim it theorem (CLT) holds and that the sam ple sizes used are large enough to appeal to the CLT and approximate the sample mean by a normal distribution of unknown variance, then the classical t-test can be employed [8] (m ore sophisticated tests are proposed in [50]). Figure 6.3 plots the t-test results for testing if $F_{\rm Hessian} = F_{\rm OP}$ for various sample sizes (the A t-Sahalia data is screened by the technique mentioned in footnote 24). The gure shows that as the number of paths grows (the equality tested is valid in the in nite time series length limit; here the time series length is held xed), that it becomes easier to detect discrepancies between the data and the assumed model. Even when the true transition density is used with the correct model, one observes that as sample size increases (in paths) that it becomes easier to reject the null. This is because the equality $F_{H essian} = F_{OP}$ is an asymptotic result. A nite size time series can never fully realize asymptotic results; as more paths are analyzed the departure from the limit becomes easier to detect. One should also note that as the number of paths increases it also becomes easier to detect the errors in the transition density expansion. Before proceeding to check for model m isspecication in the presence of an approxim ated transition density, one should determ ine if asym ptotic results are valid for \perfect data" using the same time series length, then proceed to check the accuracy of the expansion by som e M C tests (like the ones presented in the previous section).




Fig. 6.4. G codness-ofF it with K olm ogorov-Sm innov Test The 2 (3) probability density is plotted along with the empirical distribution of the test-statistic proposed in [50] for situation IC data. The inset shows a plot of the p-value (m in im um needed to reject the null given the data) obtained using the one-sam ple K olm ogorov-Sm innov test versus the num ber of paths used to create the test statistic. If the full set of sam ples were used, the test would have no problem in rejecting the null. This is due to the fact that asymptotic results are never truly realized with nite sam ple sizes. The plot illustrates that the test statistic generated by the A t-Sahalia expansion does faithfully capture the average curvature of the log likelihood function in a m isspeci ed m odel.

For extreme cases (situation IC and D) the t-test safely rejects the null for sm all sizes (see gure 6.3 and the inset). This indicates that the data is well outside the particular parametric model class under study, but one can still test if some asymptotic QM LE results hold. Figure 6.4 plots the exact probability density of the 2 (3) random variable as well a test statistic given in [50] (which will be denoted by HW 25) W e see that both the approximation and the exact transition density appear close to the predicted lim it distribution indicating that the asym ptotic results approximately hold for the sample sizes used. I quantitatively compare how well the empirical distributions match the limit distribution by using the Kolmogorov-Sm imov (KS) test with various sample sizes in the inset of gure 6.4²⁶. The average p-value is obtained by applying the one sample KS test [8] using 500 draws (with replacement) of size N samples from the pool of HW random variables associated with the N $_{\rm sam \ ples}$ paths using the 2 (3) density as the null. The result of this procedure is shown in the inset of gure 6.4. We see that the test statistic created using the A t-Sahalia expansion is rejected before that associated with the true density indicating the possibility that the errors in the expansion cause a mildly in ated rejection rate

²⁵ HW := Mg()rg()C₍₎rg()^T g()^T where g() is the gradient (written as a row vector)

of the log likelihood function. If 2 R^k then under conditions stated in [50] this random variable converges in distribution to a ² (k) random variable. This statistic was originally proposed by H albert W hite [50].

 $^{^{26}}$ In this particular application, we are still signi cantly away from the lim it distribution. The sample sizes used for estimation are large enough that a test as powerful as the KS would reject equality of the two distributions with very high certainty if one used all of the data at hand. For this reason I only present portions of the data to the KS test. In many interesting atom istic simulation studies, one can only a ord to generate a couple hundred sam ple paths making this type of goodness-of-t test useful in practice. An alternative would be to partition the CDF into bins and use the ² square goodness-of-t test [39].




Fig. 6.3. Model M isspeci cation t-test Results The left/bottom axis plots the t-statistic obtained by summing the components of F_{OP} and $F_{Hessian}$ for various sample sizes (time series length is xed, dierent N_{samples} values correspond to using dierent sample path numbers to create the random variables required to generate the sample mean and standard deviation needed for the t-test). The right/top axis is to be used with the lines without symbols; the top axis is the critical value (cv) of the t-test (lowest tipneeded to reject the null for a given). Samples were drawn at random, but once a T r.v. was drawn it contributed to the cumulative average plotted. The solid line corresponds to the theoretical cv of a sample size = 375 and the dashed line corresponds to a sample size = 10. The inset plots the situation ID test which can be rejected quickly with high con dence.

in situation IC.

6.4. Le C am 's M ethod and Likelihood R atio E xpansions R esults. Table 6.5 presents parameter estimates of the screened data (the neighborhood size used is given in the captions) from situation II B.W e see that as the neighborhood size decreases the estimator mean moves closer to that of the \uncontaminated" model but the variance of the estimator increases. I use Le Cam's LAQ expansion with the A t-Sahalia transition density expansions in order to quantify the uncertainty in the measurement. One should observe that the LAQ matrix is closely related to the variance of the parameter distributions (for a more precise description of the connection consult [28, 6]). The agreement between the estimated and measured parameter variance is not as sharp as it was in the case of a stationary distribution, but there one had the convenience of evaluating a deterministic integral (in situation A). Furtherm ore the asymptotic results are harder to realize because som e observation pairs are not used to obtain parameter estimates (due to the screening). If one has

a situation where the neighborhood size is small enough to give \m eaningful" QM LE parameter estimates and the number of observation pairs is large enough to appeal to asymptotic methods, then the LAQ screening method can be used to de nea cost function which can be used to intelligently choose the screening neighborhood size.

6.5. Local Polynom ial D i usion M odels R esults. In the rst application, the pp SD E m ethod is applied to data generated by the unperturbed C IR m odel (= = 0); I pretend that the functional form of the drift or di usion coe cient of the data generating process is unknown and instead use the m odel in equation 3.4. Five

arbitrary state points denoted by fE $_{i}g_{i=1,5}$ (shown as circles in gure 6.5) are chosen and the parameters of the a ne SDE are obtained there. The LAQ expansion is used in order to obtain parameter uncertainty estimates and the results are compared to the empirical parameter distribution measured by carrying out QM LE on the screened data in table 6.6 .

At this point we have in hand, estimates of the constant and linear sensitivities of the coe cients of the SDE. The \global" drift and di usion coe cient functions

can be approxim ated by the following interpolation procedure:

where j = 1;2 corresponds to the drift and di usion coe cients respectively, w^L and w^R are the weights associated with the left and right expansion point, $f_j^L(x)$ is the a ne approximation to the nonlinear function based on the closest expansion point whose value is less than or equal to x (similarly for $f_j^R(x)$, but use the nearest expansion point strictly greater than x). The weights were assigned by the ad hoc nule:




Fig. 6.5. Piecewise Polynom ial Approximation of CIR Model The top panels plot the di usion (left) and drift (right) function obtained by the interpolation procedure given in section 6.5. The top left panel plots the rst order Taylor expansion (evaluated at $X_{\circ} = 16$) of the di usion coe cient from the known function to show how much the true function deviates from linearity and how well the procedure detects this change. The bottom gures plot the corresponding relative errors (using the exact known SDE coe cient functions). See footnote 27 for a discussion on system atic versus random errors.

The results of this simple interpolation procedure are shown as a dotted lines in gure 6.5 (in the rule above, $_{\rm C}$ and $_{\rm D}$ are the empirically measured parameter standard deviations of the constant and linear term of the di usion term; the interpolation rule for the drift is analogous). Figure 6.5 plots the relative error of using this procedure using the known SDE coe cient functions as the \truth". The errors in the di usion coe cient function do not indicate a system atic bias in contrast to the drift coe cient 27 .

In the nalapplication, the parameters of the model are unknown. The parameter were obtained with the LAQ screening technique. The SSA process was run until N sample paths reached approximately \invariant distributions" 28 . Then N = 200 paths were used to obtain initial param eter estim ates; for expansion points in the tails of the $\$ invariant distribution" an additional N = 600 paths were simulated in order to get sharper estim ates of the poorly sam pled state points 29 . Here a B-spline [11] was used (MATLAB's cubic sm oothing spline, \spaps" was used) to piece together the constants (a;c) of the local models in order to smoothly interpolate between state points. Each point was given the same weight when creating the spline, the LAO technique for measuring parameter uncertainty could be used to give di erent weights to the measured parameters, but this procedure was not carried out here because the inherent jump nature of the data complicates m atters slightly 30 . The information contained in the linear coe cients (b;d) was not used for interpolation purposes because the variance of the param eter of the linear term s was much larger than those of the constant terms in the case studied. However, if one ignores the linear terms in the local model the constants estimated are significantly a ected (see gure 6.6). O ne observes signi cant departure of the SSA model parameters from the limiting drift function (plotted as a dashed red line). The number of particles in the SSA system was increased to 2 $\,$ 10 5 and the parameters of the electric model in the drift were estim ated and dem onstrate that the lim iting drift function is measured with the estimators used (see inset in qure 6.6). As the system size increases, the noise decreases, limiting the state points visited (hence the drift function estimated does not cover as large as a range as the rst SSA case considered). The estim ated di usion function in gure 6.6 dem onstrates dependence on the transition density used (A t-Sahalia order one and Euler). In this application the Omstein-Uhlenbeck (OU) m odel was also used to dem onstrate the in portance of accounting for state dependent noise (note the system atic di erence in the constant noise param eter estim ated using

from an Euler simulation with Euler step sizes corresponding to the observation frequency then one is in the \G aussian case". In between expansion points, the Taylor expansion of the known di usion function consistently over estimates the di usion function at nearby points (the di usion coe cient is concave). The true transition density of the SDE has a smaller variance (the data generating process) than the determ inistic Taylor series prediction. When one uses the simple Euler density approximation in QMLE, the magnitude of the mean reversion parameter appears to be larger than it really is because of the error in the Taylor series approximation of the di usion function (larger noise is expected making the determ inistic trend appear stronger). The actual situation is much more complicated due to the fact that the distributions are not G aussian, a complicated nonlinear function is used to obtain parameter estimates (QMLE), nite sampling e ects, etc.; however gure 6.5 is consistent with this overly simplie ed intuitive explanation.

²⁸ It is known that the free energy surface of this model contains two stable free energy wells and one saddle; no particles were able to overcome the large free energy barrier for the time series lengths used, hence the quotes on \invariant distributions"

²⁹Param eters were initially optim ized over individual paths in order to estim ate the param eter distribution variance. W hen param eter were optim ized on a pathwise basis, a signi cant fraction (25%) of observation pairs resulted in assumed spurious singularities in the A t-Sahalia expansion. To constrain the param eter space explored in the optim ization, I found the QM LE param eters with all of the data (over time and paths). This helped prevent the optim ization routine from attempting to evaluate the log likelihood function at param eter values that cause spurious singularities because the param eter space explored was reduced because the trial QM LE param eters needed to be good for all of the paths.

 $^{^{30}}$ In practice one could overcom e this di culty by obtaining the QM LE, generate SD E sam ple paths with the model parameters obtained, then nd the LAQ parameter variance of a genuine di usion. In applications where the uncertainty associated with using the local SD E model technique on imperfect data is desired, the problem is much harder. One should consult the specialized literature [9, 45, 48] for guidance; this author can not make any sound general recommendations.




Fig. 6.6. Estimated Nonlinear Drift (G bbal) The LAQ screening method was used to obtain the plots shown. The results of three di erent transition density estimates are shown (the OU model sets d in equation 3.4 equal to zero). The left panel contains the drift coe cient corresponding to a SSA simulation containing 60² particles. The thick solid line corresponds to in nite system size drift function. The dotted line corresponding to a SSA simulation containing 60² particles. The thick solid line of the A t-Sahalia Expansion. The inset shows the drift coe cient corresponding to a SSA simulation containing 2 10⁵ particles. Observe how the drift function convergence towards the expected limit equation with \larger" systems, however for small particle systems the results are substantially di erent. The right panel displays the measured di usion coe cient (the in nite sample limit has zero noise)

the three di erent transition density estim ators).

Figure 6.7 plots the \invariant" empiricalCDF of the SSA data versus that predicted by a sample path simulation of our obtained nonlinear di usion approximation (constructed from the B-spline interpolation of the estimated localSDE models). The inset plots the di erence between the two empiricalCDF's. Our interest in this application was in getting a parametric description of the \invariant" distribution, if the dynamics of the process are of more interest consult [12] for a useful test which is made possible if one has an approximation of the transition density.

7. Conclusions and Outbook. In this paper I have demonstrated that the expansions of A t-Sahalia can potentially be a useful tool in the parametric estimation associated with computational studies of multiscale systems. Parameter estimates can accurately be obtained and the curvature of the model is accurately represented by the expansion in a variety of applications. These facts can be exploited to estimate parameter distributions and construct useful inference procedures. The overly simple Euler expansion behaves poorly in accuracy of the estimate and in the curvature of the transition density (as shown early on by Lo [40]), but it has the redeem ing feature that it does not introduce any spurious singularities into the transition density (for the C IR model). In large sample statistics applications, point singularities can usually be remedied [35, 36, 38] by using likelihood ratio expansions. Unfortunately, many of these techniques require an extrem ely accurate estimate of the transition density. For im perfect transition densities with system atic errors, this becomes middly problem atic (from a computational standpoint) ³¹.

I have also dem onstrated a heuristic m ethod for locally approxim ating a nontriv-

³¹ M ethods proposed in [5] are applicable to a wider class of m odels and help the accuracy of the transition density expansion in the scalar case, but the vector case poses a m ore challenging problem




Fig. 6.7. CDF and KS test (N $_{\rm m\ olecules}$ = 3600) The CDF of the SSA \invariant distribution" (empirically measured) plotted against that of the piecew ise-polynom ial (pp) local SDE m odel (simulated by long time Euler integration [30]). In addition the (actual) invariant distribution of the OU m odel obtained is plotted (the model parameters of the local OU m odel were measured at the single state point where the drift is zero). This was done to show what e ect neglecting the nonlinear drift and state dependent di usion has on the invariant CDF. The inset plots the di erence between the \invariant CDF" of the SSA data and that of the pp SDE m odel.

ial SDE by a collection of simple local models. The application was inspired by the need to accurately measure the parameters, quantify the uncertainty and determ ine the goodness-of-t of parametric di usion models around atom istic data. The pp SDE technique presented is simple in nature, but it raises many deep questions. Insight from the sem iparametric, robust and large sample statistics communities would greatly assist in further developing this type of numerical method. The general method is appealing because it can be used to estimate nonlinear elective di usion models where the elective SDE's coelectors are smooth, but of unknown functional form. The resulting parametric model structure (which is typically a complicated function due to the \matching" used) can then be passed on to di usion path simulation methods in order to generate additional data which can be used in order to construct con dence bands or carry out established inference procedures.

From a practical point of view it would be desirable to apply the techniques in this paper to A t-Sahalia's method in the vector case because many interesting physical systems depend on a couple of \reaction coordinates" [27, 46, 14]. Unfortunately the vector version of the expansion usually requires one to use an additional Taylor series approximation (which increases the chance of spurious singularities and decreases the

quality of the curvature estimate); this researcher has been able to use the expansions in order to get useful parameter estimates, but has not had as much success in pushing them as far as the scalar expansions. A numerical method which can be used in conjunction with the expansions of A t-Sahalia in order to get detailed information about the log likelihood ratio associated with smooth SDE's (di usion and jump models) is currently being explored by the author.
