Bandwidth-controlvs.doping-controlM ott transition in the Hubbard model

W e reinvestigate the bandwidth-controland doping-controlM ott transitions (BCM T and DCM T) from a spin liquid M ott insulator to a Ferm i liquid m etal based on the slave-rotor representation of the H ubbard m odel,[1] where the M ott transitions are described by softening of bosonic collective excitations. W e nd that the nature of the insulating phase away from half lling is di erent from that of half lling in the respect that a charge density wave coexists with a topological order (spin liquid) away from half lling because the condensation of vortices generically breaks translational sym m etry in the presence of "dualm agnetic elds" resulting from hole doping while the topological order rem ains stable owing to gapless excitations near the Ferm i surface. Perform ing a renorm alization group analysis, we discuss the role of dissipative gauge uctuations due to the Ferm i surface in both the BCM T and the DCM T.

I. IN TRODUCTION

Landau-G inzburg-W ilson (LGW) paradigm has been our unique theoretical fram ework for classical phase transitions. Starting from an electron H am iltonian, one can derive an e ective LGW free energy functional in term sof order param eters associated with som e sym m etry breaking. The LGW fram ework has been also applied to quantum phase transitions by taking tem poral uctuations of order param eters into account, usually called the H ertz-M illis theory.[2]

There are models of quantum phase transitions, on the other hand, which may defy interpretation in the LGW paradigm. Consider the super uid-insulator transition of a boson Hubbard-type model. The boson density (n) and its phase () are canonically conjugate, satisfying the uncertainty relation n & 1, and the competing nature of the two variables results in the condensation of one variable or the other, depending on the ratio of phase sti ness and the com pressibility. The quantum conjugate nature of the variables, satisfying an uncertainty relation, lies at the heart of the quantum phase transition in this particular case. It is not obvious how LGW theory, written solely in terms of an order parameter, captures the inherent competing nature of the conjugate variables driving the quantum phase transition.

As another example of a quantum phase transition where an order parameter description is likely to fail, we mention the metal to paramagnetic insulator transition (M ott transition) found in the study of the two dimensional Hubbard model. As recent dynamical mean-

eld theory (DMFT) studies show, the transition is associated with the vanishing of the spectral weight of the quasiparticle peak, but not with any symmetry breaking

eld, hence the order param eter approach in the LGW paradigm is not clear to be applicable.[3]

Recently, Florens and Georges (FG) reexamined a bandwidth-controlM ott transition (BCM T) from a paramagnetic M ott insulator of a spin liquid to a correlated metal of a Fermi liquid at half lling in the Hubbard model.[1] In order to describe the BCMT they introduced an elegant formulation based on the slave-rotor representation, and investigated properties of metallic and insulating phases of the model. M any of the properties obtained at the mean-eld level matched well with them ore sophisticated DMFT calculations.[3] In this formulation the competing nature of canonically quantum conjugate variables naturally appears. W ithin this theoretical fram ework the M ott transition is understood by softening of bosonic collective excitations, physically associated with zero-sound modes in a Ferm i liquid. W hen these bosonic excitations are gapped, a param agnetic M ott insulator with charge gap but no spin gap results, thus called a spin liquid. On the other hand, condensation of the boson excitations causes a coherent quasiparticle peak at zero energy, resulting in a Ferm i liquid in the low energy lim it.

In the present paper we investigate a doping-control M ott transition (DCMT) from the spin liquid to the Ferm i liquid based on the slave-rotor representation of the Hubbard model. We nd that the DCMT di ers from the BCMT in the respect that the nature of the M ott insulator and the mechanism of the M ott transition are di erent from each other. Hole doping results in a nontrivial Berry phase term to the boson eld, lead-ing to an e ective magnetic eld for its vortex eld in the dual form ulation. It is shown that this e ective magnetic

eld induces a crystalline phase of doped holes, coexisting with the spin liquid. On the other hand, the param agnetic M ott insulator at half lling is the sam e spin liquid, but without any charge orders. W e argue that the doped spin liquid with charge order evolves into the Ferm i liquid via a continuous phase transition.

The present scenario for the DCMT was discussed before, but based on the boson-only (Hubbard) model, where ferm ionic excitations are ignored [4, 5] or decoupled to the bosonic excitations [6] in the renorm alization group (RG) sense. In this paper we start from the electron Hubbard model, and derive an elective bosonic eld theory. It should be noted that this elective eld theory

is totally di erent from that in the boson Hubbard model owing to the presence of dam ped gauge uctuations resulting from gapless ferm ion excitations. A lthough the Berry phase plays the same role in both doped (boson and ferm ion) M ott insulators, nature of the M ott transitions would be di erent owing to the presence of dissipative gauge uctuations in the slave-rotor representation of the electron Hubbard model. Performing an RG analysis, we show that the dissipative dynam ics of gauge excitations makes both the BCMT and the DCMT in the electron Hubbard model di er from those in the boson Hubbard model. There also exists a previous study considering ferm ion excitations coupled to bosonic elds.[7] How ever, this study starts from the quantum dimermodel, and considers a valance bond solid instead of the spin liquid with a Ferm i surface. Thus, the ferm ion excitations in the model are gapped (for the s wave pairing case), thus ignored in the low energy lim it. We would like to emphasize that our crystalline phase is nothing to do with Cooper pairs, [5, 6, 7] instead associated with doped holes.[4]

II. EFFECTIVE FIELD THEORY FOR THE MOTT TRANSITION

We derive the slave-rotor representation of the Hubbard model in the path-integral formulation. We note that FG derived it based on not only the canonical quantization method but also the path integral formulation. However, we argue that our path integral derivation more clearly shows the connection between Hubbard-Stratonovich (HS) elds and rotor variables.

W e consider the Hubbard model in two dimensions

Here t is a hopping integral of electrons, and U the strength of local interactions. $n_i = c_i^y c_i$ is an electron density.

A usualmethodology treating the Hubbard U term is a HS transformation. Using the coherent state representation and performing the HS transformation, we obtain the partition function

where 'i is an order parameter associated with a charge density wave (CDW), and , the chemical potential of electrons. Physically, the 'i eld corresponds to an effective electric potential. In the usual mean-eld manner the CDW order parameter is given by $i_i = 2Uh c_i c_i i$.

Integrating over electronic excitations in Eq. (2) and expanding the resulting logarithm ic term for the e ective potential', one can obtain an e ective LGW free energy functional in terms of the CDW order parameter'. As m entioned in the introduction, it is not clear that this LGW theoretical fram ework has the competing nature of quantum conjugate variables because there exists only one CDW order parameter. One can say that the formulation Eq. (2) is exact, and thus the LGW fram ework may be a good starting point. However, an important point is how to expand the resulting logarithm ic term. The expansion should be approximately performed, and thus one cannot say validity of the LGW fram ework for quantum phase transitions.[8]

It is clear that the metal-insulator transition is associated with charge uctuations. One way controlling charge uctuations is to introduce the canonical conjugate variable of the charge density. Unfortunately, $'_{i}$ is not the canonically conjugate variable of the charge density because it is an electric potential.

 \mathbbm{W} e consider the gauge transform ation for an electron $\ensuremath{\operatorname{eld}}$

Here eⁱ ⁱ is assigned to be an annihilation operator of an electron charge, and f_i an annihilation operator of an electron spin. In this paper we calle ⁱ ⁱ and f_i chargon and spinon, respectively.

Inserting Eq. (3) into Eq. (2), we obtain

Performing the HS transformation $(1=4U)'_{i}^{2}$! UL_i² + iL_i'_i, and shifting '_i into '_i ! '_i @ _i, we obtain the following expression for the partition function

Integrating over the ' $_{i}$ eld, one nds $\underline{L} = {}^{P} f_{i}^{y} f_{i}$. In this respect L_{i} corresponds to the density variable of FG .[1]

Eq. (5) has an interesting structure for the quantum phase transition. First of all, there is the competing nature of canonically conjugate quantum variables. The i eld is canonically conjugate to the charge density $L_i = f_i^y f_i$, as one can see from the coupling term $iL_i@_i$ of the Lagrangian derived above. These two operators satisfy the commutation relation $[i;L_j] = i_{ij}$,

and thus the uncertainty relation $L_i \ i \& 1$ works. Fluctuations of the i eld correspond to bosonic collective excitations, here associated with zero sound modes of a Ferm i liquid when it becomes condensed.[1] This can be justiled from the fact that the dispersion of the i eld in its condensed phase is given by that of sound waves.

The quantity $'_{i}$ is the CDW order parameter in Eq. (2). In the formulation presented in Eq. (5), however, it transforms as the time component of a U (1) gauge

eld. Under the U (1) gauge transform ation for the m atter elds, $f_i ! e^{i \cdot i} f_i$ and i ! i + i, the e ective potential should be transform ed into 'i ! 'i + @i. This gauge- eld aspect of the order parameter is introduced due to the mapping of Eq. (3), which involved the new phase degree of freedom.

Integrating over the L_i eld, Eq. (5) reads

This expression is nothing but the slave-rotor representation of the Hubbard model, obtained by FG in a dierent fashion.[1] It is clear that the CDW order parameter appears to be the time component of a U (1) gauge eld. This can be understood by the fact that physics of the CDW order parameter is an elective potential.

This e ective Lagrangian should be considered to generalize the LGW theoretical fram ework. If uctuations of the $_i$ elds are ignored, the resulting e ective eld theory belongs to the LGW fram ework. However, as clearly demonstrated by FG, $_i$ uctuations are mainly responsible for the metal-insulator transition occurring in the Hubbard model at half-lling. K eeping the $_i$ uctuations, the e ective eld theory for the M ott transition is naturally given by a gauge theory.[9] In this respect the M ott transition should be viewed beyond the LGW paradigm.

A standard treatment of the hopping term in Eq. (6) yields the electric Lagrangian

where _{ij} and _{ij} are spinon and chargon hopping order parameters, respectively.

A saddle point analysis results in the self-consistent equations

where N is a total number of lattice sites. Eq. (9) is our starting point for the metal-insulator transition.[10]

In this e ective gauge theory two important facts should be taken into account since they discriminate the DCMT from the BCMT. One is an elective chemical potential $_{eff} = + iT_i$ in the spinon Lagrangian L_f . Particle-hole symmetry at half lling causes the elective chemical potential to vanish. On the other hand, away from half lling the particle-hole symmetry is broken, resulting in a nonzero chemical potential.

The other important feature is a Berry phase term arising from the phase- uctuation term in the chargon Lagrangian L

At half lling the Berry phase does not play any roles because time reversal symmetry considered in this paper leads to he $_{i}i = 0$, and the average occupation number of spinons is given by h $f_{i}^{y}f_{i}i = 1$. Inserting this into the expression of Berry phase, one obtains $S_{B} = \begin{bmatrix} p \\ 1 \end{bmatrix}_{0} d$ is i = 2 i $_{i}q_{i}$, where q_{i} is an integer representing an instanton number, here a vortex

charge. Thus, the contribution of Berry phase to the partition function is nothing because of e^{S_B} = 1. Away from half ling the Berry phase action is obtained to be $S_B = 2$ i $_i q_i$ with modular 2. This results in a complex phase factor to the partition function, given by $Z = _{Q} e^{2 \ i \ Q} Z_{Q}$, where $Q = _{i} q_{i}$ is a total instanton number, and Z_{Q} , the partition function for a xed Q. The observation of Berry phase gives the motivation for this paper. In this paper we investigate how the e ect of Berry phase makes the DCM T di er from the BCM T.

III. BANDW IDTH-CONTROL MOTT TRANSIT ION

First, we discuss the BCMT.Zero e ective chemical potential and no Berry phase e ect result in the following e ective eld theory

In the absence of U (1) gauge uctuations this e ective action was intensively studied by FG .[1] For the mean

eld treatm ent FG utilized large N generalization of the chargon eld, and derived the saddle point equations in Eq. (8) at half lling. They found that there exists a critical U =t for chargon condensation.[11] In the case of U=t> $(U=t)_{c}$ chargons are gapped, but spinons are massless. Existence of charge gap but no spin gap corresponds to a spin liquid M ott insulator. In the spin liquid there is no coherent quasiparticle peak at zero energy, and only incoherent hum p was found near the energy U. In the case of U=t < (U=t)c condensation of chargons occurs, causing a coherent quasiparticle peak at zero energy in the presence of incoherent hum p near the energy U.As a result a correlated param agnetic m etal appears. Furtherm ore, FG analyzed the saddle point equations near the M ott critical point $(U=t)_c$, and obtained m ean eld critical exponents for the charge gap and the quasiparticle weight. They also found that the e ective mass of quasiparticles does not diverge near the M ott critical point owing to the spinon dispersion.

However, the mean eld analysis of FG should be checked in the presence of U (1) gauge uctuations since instanton excitations of U (1) gauge elds can cause connem ent of spinons and chargons, completely spoiling the mean eld picture. In two space and one time dimensions [(2 + 1)D] it is well known that static charged matter elds are always con ned owing to instanton condensation.[12] For the mean eld picture of the spin liquid and the M ott transition to be physically meaningful beyond the mean eld level, the stability of Eq. (11) should be guaranteed against instanton excitations in the RG sense.

Recently, the present author exam ined decon nem ent of ferm ions in the presence of a Ferm i surface.[13] It has been argued that the ferm ion Lagrangian L_f in Eq. (11) has a nontrivial charged xed point [14, 15] as the quantum electrodynamics in (2 + 1)D (QED₃) without a Ferm i surface. [16, 17] The present author investigated the stability of the charged critical point against instanton excitations, [13] following the strategy in Ref. [16]. In the presence of a Ferm i surface the conductivity f of ferm ions is shown to play the sim ilar role as the avor num ber N of D irac ferm ions in the Q E D $_3$.[13] Since avor number of D irac ferm ions is proportional to the screening channels for the gauge propagator, large avors weaken gauge uctuations in the $Q \ge D_3$. In the same way the conductivity of ferm ions near the Ferm i surface determ ines strength of gauge uctuations. Remarkably, the charged xed point is found to be stable against instanton excitations when the ferm ion conductivity is su ciently large.[13] This im plies that the U (1) auge eld can be considered to be noncom pact. Eq. (11) an be a stable theory against instanton excitations. In his respect the spin liquid state can survive beyond the ean eld level. But, the spinons are not free particles iny more owing to long range gauge interactions, resulting in an algebraic behavior of the spin-spin correlation

function with an anom alous critical exponent.[15, 18] The M ott transition beyond the mean eld description

is more complex owing to the dissipative nature of gauge uctuations. Integrating over the spinons, one can obtain the elds in the continuum limit

Here $D_0^{-1}(q_r; i!_n) = (q_r^2 + !_n^2)=g^2$ is the bare propagator of the gauge eld given by the M axwell gauge action, resulting from integration of high energy uctuations of spinons and chargons. g is an internal gauge charge of the spinon and chargon. $(q; i!_n)$ is the self-energy of the gauge eld, given by a correlation function of spinon charge (number) currents. Since the current-current correlation function is calculated in the noninteracting ferm ion ensemble, its structure is well known [19, 20]

Here the spinon conductivity (q_r) is given by (q_r) $k_0=q_r$ in the clean limit while it is (q_r) $_0 = k_0 l$ in the dirty lim it, where k_0 is of order k_F (Ferm in on entum), and 1 the spinon mean free path determined by disorder scattering. The diam agnetic susceptibility is given by $m_{\rm f}{}^1$, where $m_{\rm f}$ (t) 1 is the band m ass of spinons. The frequency part of the kernel $(q;i!_{\rm n})$ shows the dissipative propagation of the gauge eld owing to particle-hole excitations of spinons near the Ferm i surface.

Eq. (12) should be a starting point for the BCMT. In the study of FG [1] U (1) gauge uctuations are ignored, and thus the physical picture of the M ott transition should be modi ed. In the absence of U (1) gauge uctuations the transition falls into the XY universality class. However, long range gauge interactions alter the XY universality nature into the inverted-XY (IXY) universality class if the Landau damping term in Eq. (14) is ignored, and only the Maxwell kinetic energy of the gauge eld is taken into account.[21] This means that if one considers a critical exponent associated with the charge gap $_{\rm q}$ JU $U_{\rm c}$ j with the critical value $U_{\rm c}$, the critical exponent changes from X Y of the XY transition to IXY of the IXY transition. Damped gauge interactions are expected to modify the IXY Mott transition.[22]

Perform ing the duality transform ation for the phase eld in Eq. (12), we obtain the dual vortex action

Here is a vortex eld, and c a vortex gauge eld. m_v is a vortex mass, given by m_v^2 (U=t)_c U=t, and u_v a phenom enologically introduced parameter for local interactions between vortices. (U=t)_c is the critical strength of local interactions, associated with the M ott transition in the mean eld level.

In the dual vortex form ulation the BCM T arises from controlling the vortex m ass as a function of the parameter U=t. In the case of $m_v^2 < 0$ (U=t> (U=t)_c) condensation of vortices occurs, resulting in a M ott insulator of chargons. In the case of $m_v^2 > 0$ (U=t < (U=t)_c) vortices are gapped, im plying condensation of chargons, and a param agnetic m etal results.

Perform ing the G aussian integration for the gauge eld

where \overline{g} is a rede ned variable including the susceptibility. In the following we consider dirty cases characterized by $(q_r) = _0$.

Before we analyze Eq. (16) by using an RG m ethod, we consider two physical limits; one is $_0$! 0 corresponding to an insulator of spinons, and the other, $_0$! 1 identi ed with a perfect m etal of spinons. In the spinon insulator the kernelK (q_r ; i!_n) becomes a constant value, m aking vortex gauge uctuations (c) gapped, thus ignored in the low energy limit. This is because long range gauge interactions (a) m ake it m assive the low energy m ode (G oldstonem ode) represented by the vortex gauge eld, appearing at high energies. The usual ⁴ action

for the vortex eld is obtained. On the other hand, in the perfect spinon m etal gauge uctuations a are com – pletely screened by spinon excitations, causing the kernel to vanish, and the M axwell gauge action for the vortex gauge eld results. The resulting vortex action is reduced to the standard scalar QED₃. Varying the spinon con– ductivity ₀, these two lim its would be connected.

We perform an RG analysis for Eq. (16). A nisotropy in the M axwell gauge action for the vortex gauge eld is assumed to be irrelevant, and only the isotropic M axwell gauge action is considered by replacing U;1=4t with $1=(2e_v^2)$. Here e_v is a vortex charge. In the lim it of sm all anisotropy the anisotropy was shown to be irrelevant at one loop level.[23] To address the quantum critical behavior at the M ott transition, we introduce the scaling $r = e^{1}r^{0}$ and $= e^{1} {}^{0}$,[24] and consider the renorm alized theory at the transition point $m_y^2 = 0$

The rst RG equation for the vortex charge can be understood in the following way. Integrating out critical vortex uctuations near the critical point $m_v^2 = 0$, we obtain the singular contribution for the elective gauge action

The rst term in the kernel (g; i! _ n) results from the screening e ect of the vortex charge via vortex polarization, causing the $N_v e_v^4$ term in the RG equation while the second originates from that via spinon excitations, yielding the (= _0)e_v^4 term. The rst (4 D) e_v^2 term denotes the bare scaling dimension of the vortex charge.

For the second RG equation, unfortunately, we do not know the exact functional form soft ($_0; e_v^2$) and g($_0; e_v^2$) ow ing to the complexity of the gauge kernel. Ow ing to the spinon contribution K ($q_r; i!_n$) [Eq. (17)] the kernel of the gauge propagator (c)

should be utilized instead of the M axwell propagator in calculating one loop diagram s.[21, 23, 25, 26] Note the dependence of the vortex charge e_v^2 in the e ective gauge propagator. This gives the dependence of the vortex

charge to the analytic functions $h(_0;e_v^2)$ and $g(_0;e_v^2)$. A lthough the exact functional forms are not known, the limiting values of these functions are clearly revealed. In the limit of $_0$! 0 the gauge kernel vanishes, thus causing $h(_0 ! 0;e_v^2) ! 0$ and $g(_0 ! 0;e_v^2) ! 0$. In the sm all $_0$ limit the gauge kernel is given by

In the scalar QED₃ there is a delicate issue about the existence of the charged xed point ($e^2 \notin 0$).[21, 23, 26] In this paper we do not touch this issue. Instead we assume the existence of the charged critical point in the scalar QED₃ by controlling the value. Then, the charged critical point (e_v^2 (_0); $u_v [e_v^2$ (_0)]) in Eq. (20) is expected to vary as a function of the spinon conductivity in the range of

where the xed point (e_{i}^{2} ($_{0}$! 0); u_{v} (e_{v}^{2} ($_{0}$! 0)]) corresponds to the IX Y one in the original boson model [Eq. (12)], and the xed point (e_{v}^{2} ($_{0}$! 1); u_{v} (e_{v}^{2} ($_{0}$! 1)]) coincides with the XY one in Eq. (12). The spinon contribution ($_{0}$) connects the XY xed point to the IX Y one sm oothly in the chargon action Eq. (12).[28] This im – plies that the critical exponents near the M ott transition change continuously, depending on the spinon conductivity. This would be measured in some experiments. Because the spinon conductivity depends on disorder, we

would have some dierent critical points by controlling density of disorder, resulting in various critical exponents between the exponents of the XY and IXY transitions. How ever, one interesting possibility should be taken into account that the glassy behavior of the chargon eld can originate from random potentials. This important subject is under current investigation.

IV. DOPING-CONTROL MOTT TRANSITION

Next, we investigate the $\mathsf{D} \mathsf{C} \mathsf{M} \mathsf{T}$, described by the effective eld theory

Note the presence of the e ective chem ical potential and Berry phase. This Lagrangian is analyzed by employing a duality transform ation .5, 6] In the dual form ulation the e ect of Berry phase is represented as e ective magnetic

elds for dual vortex variables.

where the U(1) gauge eld a was ignored in the mean

eld level. The Berry phase e ect is re ected as an e ective m agnetic eld h = 2U for the vortex eld in the term \overline{h} (@ c) . Remember the expression of the vortex m ass m²_v (U=t)_c U=t. A cautious readerm ay suspect that the vortex m ass should depend on hole concentration. From the discussion below Eq. (9) it is important to note that the e ect of hole doping appears only in the chem ical potential and Berry phase term s. Furtherm ore, at half lling Eq. (22) should be dual to the chargon Lagrangian L in Eq. (11). Thus, the vortex m ass should depend on only the parameter U=t.

In the dual vortex formulation the BCM T is driven by controlling the vortex m ass, as shown in the previous section. On the other hand, the DCM T is nothing to do with the vortex m ass. Instead, controlling the e ective m agnetic eld causes the M ott transition. This leads us to consider that the nature of the DCM T di ers from the BCM T.

The presence of the e ective magnetic eld rem inds us of a well known H ofstadter problem for vortex elds. In the context of a super uid-insulator transition this was extensively studied in R efs. [5, 6]. Here we brie y sketch the procedure and key results. We rst investigate the nature of a doped M ott insulating state in a mean eld fashion, i.e., the absence of U (1) gauge uctuations a, and discuss the DCMT beyond the mean eld level.

Following Ref. [5], we consider commensurate hole concentration = p=q, where p and q are relatively prime integers. Under this e ective magnetic eld , the vortex Lagrangian Eq. (22) has q-fold degenerate m in im a in the magnetic Brillouin zone. Low energy uctuations near the q-fold degenerate vacua are assigned to be with l = 0; ...; q 1. A key question is how to construct a LGW free energy functional in terms of the 1 elds. Constraints for an e ective potential of 1 are sym metry properties associated with lattice translations and rotations in the presence of the e ective magnetic elds.[5] Based on the symmetry properties one can construct a LGW free energy functional of $_1$, and perform a standard mean eld analysis. In this free energy a super uid of original bosons (chargons) is given by $h_1 i = 0$ for all 1 = 0; ...; q 1 while a M ott insulator is characterized by h li & 0 for at least one l. Although the free energy functional has all sym m etries, the ground state can be sym m etry-broken. In other words, the M ott insulator can have broken translational sym m etries.

To see this, one can construct a density wave order param eter by considering bilinear and gauge-invariant com binations of the low energy vortices 1. Condensation of

1 leads to a nonzero value of the density wave order param eter, causing a vortex density wave. A density wave of vortices can be interpreted as a crystalline phase of doped holes in the original language.[4, 5, 6] In appendix we review the simple q = 2 case. C on bining this chargon physics with the spinon physics, we can conclude that a doped M ott insulator consists of a density wave of chargons and a spin liquid of spinons with a Ferm i surface. It should be noted that this doped M ott insulator is di erent from the M ott insulator at half lling because there is no charge order in the undoped M ott insulator.

Remember that the crystalline phase of doped holes is nothing to do with the spin liquid in the mean eld level. Integrating out the gapped chargon degrees of freedom, we obtain the same spinon-gauge action for the doped spin liquid with that for the undoped one beyond the mean eld level. It has been argued that the spinon-gauge action is a critical eld theory at the nontrivial charged xed point, [13] as discussed in the previous section. Thus, the spin-spin correlation function shows a power law behavior with respect to frequency and tem perature.[15, 18] On the other hand, no infrared response for charge uctuations is expected ow ing to the M ott gap. Instead, the charge order would be re ected in the electron density of states as a spatially m odulated pattern because of the translational sym metry breaking.[29] The electron density of states is proportional to the imaginary part of the electron green function, given by convolution of the spinon and chargon propagators in the slave-rotor formulation. Thus, the spatial inhom ogeneity of the chargon distribution results in the spatially modulated pattern in the density of states. Because there is excitation gap in the chargon spectrum, only incoherent hump would be shown in the electron spectral function. This is another di erent point from the usual density wave.

O ne cautious person m ay suspect the coexistence of the spin liquid and charge density wave (CDW) because such a commensurate CDW can destroy the spinon Ferm i surface through a space-dependent e ective chem icalpotential, causing the spin liquid to be unstable. However, we argue that the spinon Ferm i surface can be preserved even in the commensurate CDW when the Ferm i surface nesting is not perfect due to interaction or frustration effects. Considering the low energy vortex excitations 1 near the q-fold degenerate vacua, one can define the ective dual action

Here l = 1; :::; q corresponds to a color index of low energy vortex elds, and V (j $_{n}^{(l)}$) is an elective vortex potential determ ined by symmetry properties, where the coef-

cients are e ectively doping dependent (see appendix). The last gauge action in the spinon sector originates from high energy contributions of matter elds, where g is an internal gauge charge of spinons.

The question is what happens in the Ferm i surface when vortex condensation occurs, resulting in translational sym metry breaking. Ignoring spinon-gauge uctuations a as the mean eld approximation, the spinon-gauge action is completely decoupled from the vortex-gauge action, as discussed before. This indicates that the Ferm i surface is not a ected by the CDW form ation in the vortex sector. Now, we allow spinon-gauge excitations. Integrating out a_i in the limit of g ! 1, one obtains the constraint

W hen the vortices are condensed to cause translational sym metry breaking, the above quantity should depend on positions. This e ect can be introduced in the spinon action by allowing a position-dependent e ective chemical potential, interpreted as a higher order e ect due to gauge uctuations. In this case the commensurate CDW can destroy the Ferm i surface. How ever, it should be noted that this depends on the shape of the Ferm i surface. W hen the perfect nesting of the Ferm i surface does not appear due to interaction or frustration e ects, only partial parts of the Ferm i surface would open the CDW gap, and other parts of the Ferm i surface, not connected by the CDW wave vector, are expected to remain gapless. This would indeed happen when there is frustration, destroying the Ferm i surface nesting. This expectation coincides with our ignorance of spin ordering because strong frustration kills magnetic ordering.

We should emphasize that the above discussion is applied to the g ! 1 limit. Since we are considering low energy uctuations, high energy matter elds should be integrated out, resulting in the M axwell gauge action, the last term in S_f of Eq. (23). Then, the above constraint cannot be used because one cannot integrate out a_i directly. In this case of spin-charge separation due to a nite value of g, the position-dependent dual magnetic ux is not directly related with the spinon density ow ing to the spinon-gauge ux. If one utilizes average values in the constraint equation instead of the operator identity, the sam e argum ent above can be applied. G enerically, there should be a gapless Ferm i surface, not connected by the CDW wave vector, at least in the fustrated lat-

tice.

The present doped spin liquid is an interesting new phase in the respect that a conventional order described by the CDW order parameter (in the LGW paradigm) and an exotic order associated with a conserved internal gauge ux[30, 31] coexist. This phase is expected to be stable beyond the mean eld level because instanton excitations can be suppressed via spinon excitations near the Ferm i surface, as discussed before. A next im portant question is which phase this doped spin liquid evolves into. M ore concretely, when chargon condensation occurs, does the CDW order survive? Remember that in the BCMT chargon condensation results in a Ferm i liquid, where condensed chargons are con ned with spinons to form electrons (quasiparticles). This corresponds to a Higgs-con nem ent phase in the context of gauge theory, where the internal gauge ux is not conserved.[30, 31] In the DCMT the chargon condensation also causes electronic quasiparticles. In this case the CDW order is expected to disappear, thus resulting in the same Ferm i liquid as that in the BCMT. See Eq. (22). Because we are considering gapped vortex excitations, they can be ignored in the low energy lim it. Thus, there remain uniform e ective magnetic elds. This im plies that condensed chargons are hom ogenously distributed. As a result the CDW order of chargons disappears. A nother way to say this is that since there are no vortex charges (ow ing to the gap in the vortex excitations) in the Berry phase term Eq. (10), the e ect of Berry phase disappears. This is analogous to the case in the nonlinear model for the quantum antiferrom agnet, where the Berry phase e ect can be ignored in the antiferrom agnetic phase.[30]

Now we discuss a critical eld theory for the DCMT. Integrating over the spinon and gauge (a) excitations in Eq. (23) as performed at half lling, one can construct

K results from the anom alous contribution of spinongauge uctuations to vortex-gauge excitations, given by Eq. (17) with a di erent $_0$ owing to the chemical potential $_{eff}$. h = 2U is an applied e ective magnetic eld, and $h_{f} = 2U_{q}$ a nearby one with commensurate hole concentration $_{q} = p=q$. One can estimate a criticale ective magnetic eld h with a given $U=t > (U=t)_{c}$ by calculating the condensation energy. The critical hole concentration $_{c}$ corresponding to the critical magnetic eld h_{e} would be di erent from $_{q}$ generally. In this case

one m ay determ ine a m oderate value of q near the critical doping $_{c}$. Then, there rem ain residual e ective m agnetic elds h h_{q} , corresponding to the incom m ensurability $_{q}$.

W e propose that Eq. (24) is a starting point for the DCMT. If the vortex "superconductor" falls into the type-I class, the residualm agnetic eld would be expelled owing to the dual "M eissner" e ect. A critical eld theory for this M ott transition is expected to be without the residualm agnetic eld

Because the e ective vortex action depends on q and V ($_1$), it is di cult to predict critical vortex dynamics for general q values. The q = 1 case corresponds to the undoped spin liquid, already discussed in the previous section. In the q = 2 case the e ective vortex potential is obtained to be

well discussed in appendix. At the critical point $m^2 = 0$ the last eighth-order term is certainly irrelevant owing to its high order. Furthermore, the cubic anisotropy term (v_4) is well known to be irrelevant in the case of $q < q_c = 4.[27]$ As a result, the Heisenberg xed point $(v_4 = 0 \text{ and } u_4 \neq 0)$ appears in the absence of vortex gauge uctuations.[27] Introducing the vortex gauge




FIG.1: A schematic phase diagram in the slave-rotor representation of the Hubbard model

elds at the H eisenberg xed point, we have qualitatively the same xed point with Eq. (16) except the q = 2vortices. Since the charged critical point depends on the spinon conductivity, the critical exponents vary as a function of the spinon conductivity. At higher q values we do not understand the nature of the M ott transition owing to the com plexity of the vortex potential. G enerally speaking, a continuous M ott transition from the U (1) spin liquid with a commensurate density wave order to the Ferm i liquid is possible.

On the other hand, if the vortex superconductor belongs to the type-II class, the residual magnetic eld can penetrate the superconductor, forming a dual A brikosov "vortex" lattice. This corresponds to an incommensurate M ott insulator, where hole density is $\{\sigma_q, [5]\}$ In this case the nature of the M ott transition from the U (1) spin liquid with an incommensurate density wave order to the Fermi liquid is not clear owing to the Berry phase elect. Furthermore, the Landau damping term should be taken into account in the critical eld theory as the case of the BCM T because it changes the nature of the M ott transition. A continuous transition to the Fermi liquid may be possible in this case. A detailed analysis of this DCM T is beyond the scope of this paper.

W e propose a phase diagram Fig. 1 in the slave-rotor representation of the Hubbard model on two dimensional square lattice. Here U1SL, FL, and CDW represent U (1) spin liquid, Ferm i liquid, and charge density wave, respectively.

The route 1 is the BCMT from U1SL to FL at half lling while the route 2, that from U1SL + CDW to FL at commensurate hole concentration. In these cases we showed critical eld theories, and discussed nature of the continuous phase transitions.

The route 3 is the DCMT at a nite U=t. In this case the critical eld theory depends on the nature of the vortex superconductor. Nature of the quantum phase transition from the U1SL with an incomm ensurate CDW to the FL is not clear owing to incomm ensurability.

So far, we considered a zero ux state, and thus obtained the U (1) spin liquid with a Ferm isurface. The uniform spin liquid phase turns out to be stable (with respect to the ux phase) in the triangular lattice at the mean-

eld level near the undoped M ott transition point[9]. H ow ever, it is in portant to consider a ux phase since this phase is usually obtained as a stable mean eld state in the square lattice w ithout frustration [32]. In the ux phase low energy spinon excitations are given by D irac ferm ions near four nodal points. As a result the e ective spinon Lagrangian is obtained to be $Q \ge D_3$. For the BCM T at half lling there is no dissipation in gauge

uctuations. The role of m assless D irac ferm ions is to weaken gauge interactions, resulting from screening of gauge charges owing to particle-hole polarization. Thus, increasing the avor number N of D irac ferm ions in the 1=N approximation, the IXY transition is expected to turn into the XY one [33]. On the other hand, for the D CM T there remains dissipation in gauge uctuations owing to a nonzero e ective chem ical potential. Thus, damped gauge uctuations would still play some special roles in the D CM T.

In this paper we discussed how the doping-control M ott transition di ers from the bandwidth-control one based on the slave-rotor representation of the Hubbard m odel. W e found that the doped M ott insulator consists of a crystalline phase of doped holes and a U (1) spin liquid with a Ferm isurface while the M ott insulator at half lling is the U (1) spin liquid without any charge orders. This originates from the fact that hole doping causes a Berry phase term to the chargon eld. This Berry phase e ect results in an e ective magnetic eld to the vortex eld of the chargon eld. In the dual vortex form ulation

we showed that the bandwidth-control M ott transition is driven by the sign change of the vortex mass while the doping-control one is achieved by the control of the e ective magnetic eld. The presence of dual e ective magnetic elds leads to translational symmetry breaking when vortices are condensed. We argued that this charge order does not destroy the spinon Ferm i surface when there is strong frustration, causing the Ferm i nesting to disappear. As a result, the spin liquid phase can rem ain stable to coexist with the density wave. Furthermore, we pointed out that dam ped U (1) gauge uctuations resulting from spinon excitations should be taken into account for both M ott transitions because the nature of the M ott transitions is m odi ed by the dissipative gauge excitations. Performing a renormalization group analysis, we showed that the M ott critical point depends on the spinon conductivity characterizing the strength of dissipation. This interesting result leads us to predict that varying the density of disorder would cause di erent critical exponents because disorder determ ines the conductivity of spinons.

APPENDIX A:MEAN FIELD ANALYSIS

In this appendix we review a mean eld analysis for the q = 2 case following Refs. [34, 35]. Ignoring vortex gauge uctuations in Eq. (22), we can write down the vortex action with the elective magnetic eld = 1=2 in a lattice version

where n;m label sites in the dual lattice, and the sign of the hopping integral t_{nm}^v around a plaquette is 1 ow ing to the ux background.

The vortex hopping term can be easily diagonalized in the eigenvectors ${}_{n}^{0} = (1 + 2) e^{i n_{y}}$ and ${}_{n}^{0} = e^{i n_{x}} [(1 + 2) + e^{i n_{y}}]$, resulting in two low energy modes near the momentum k = (0;0) and k = (;0). Then, the low energy dynamics of this system can be described by the low energy vortex elds $_{0n}$ and $_{1n}$ in $_{n} = {}_{0n} {}_{n}^{0} + {}_{1n} {}_{n}$.

In order to construct the e ective vortex potential one can introduce the following two complex elds

where $T_{x(y)}$ and $R_{=2}$ are associated with lattice translations and rotations. The LGW e ective potential allowed by these symmetry operations is obtained to be[34]

O ne cautious reader m ay ask how the coe cients in the LGW free energy functional can be determ ined. A lthough the sym m etry constraints restrict the functional form of the e ective potential, they cannot determ ine the rem aining param eters in the free energy. O ur question is whether these param eters are doping dependent or not. R em em ber that there is no doping dependence in the original vortex m ass m_{y}^{2} in Eq. (15). It depends on only

Based on the elective vortex potential Eq. (A 4), one can perform a mean eld analysis. Condensation of vortices occurs in the case of $m^2 < 0$ and $u_4 > 0$. The

signs of v_4 and v_8 then determ ine the ground state. For $v_4 < 0$, both vortices have a nonzero vacuum expectation value $\mathfrak{h}_0 \mathfrak{i} \mathfrak{j} = \mathfrak{h}_1 \mathfrak{i} \mathfrak{j} \in 0$, and their relative phase is determ ined by the sign of v_8 . In the case of $v_8 > 0$ the resulting vortex state corresponds to the colum nardim er order, breaking the rotational and translational sym m etries. In the case of $v_8 < 0$ the resulting phase exhibits the plaquette pattern, braking the rotational sym m etries. On the other hand, if $v_4 > 0$, the ground states are given by either $\mathfrak{h}_0 \mathfrak{i} \mathfrak{j} \in 0$; $\mathfrak{h}_1 \mathfrak{i} \mathfrak{j} = 0$ or $\mathfrak{h}_0 \mathfrak{i} \mathfrak{j} = 0$; $\mathfrak{h}_1 \mathfrak{i} \mathfrak{j} \in 0$, and the sign of v_8 is irrelevant. Thus, the spinon contribution characterized by the spinon conductivity $_0$ connects these two xed points sm oothly.
