Tail States below the Thouless G ap in SN S junctions : C lassical F luctuations.

W e study the tails of the density of states (DOS) in a di usive superconductor-norm al m etalsuperconductor (SNS) junction below the Thouless gap. W e show that long-wave uctuations of the concentration of impurities in the norm al layer lead to the form ation of subgap quasiparticle states, and calculate the associated subgap DOS in all e ective dimensionalities. W e compare the resulting tails with those arising from m esoscopic gap uctuations, and determ ine the dimensionless parameters controlling which contribution dominates the subgap DOS. W e observe that the two contributions are form ally related to each other by a dimensional reduction.

I. IN TRODUCTION.




FIG.1: A schematic plot of an SNS junction: two bulk superconducting electrodes (S) connected to a di usive metal (N) of thickness L_z . The interfaces have linear size L_x , L_y .

The properties of hybrid superconductor-norm alm etal structures (SN) continue to attract considerable attention both experimentally¹ and theoretically^{2,3,4,5,6,7,8,9}, though the fundam ental process governing the physics of such system s, Andreev re ection¹⁰, has been discovered long ago. In fact, while it is well known that generically the proximity to a superconductor leads to a modi cation of the density of states in the norm alm etal, the nature and extent of this e ect depends on the details the hybrid structure. In particular, it was recently pointed out² that when a closed m esoscopic m etallic region is contacted on one side to a superconductor, the resulting DOS turns out to depend on its shape. If integrable, the DOS is nite everywhere but at the Ferm i level, where it vanishes as a power law. On the contrary, in a generic chaotic metallic region one expects the opening of a gap around the Ferm i level, the Thouless gap³. In analogy with the considerations above, a di usive m etallic region sandw iched between two bulk superconducting electrodes has been predicted to have a gapped density of states, the gap being at energies com parable to to the Thouless energy $E_{Th} = D = L_z^2$, where D is the di usion constant and L_z the width of the norm all $ayer^{4,5,6,7}$ [see Fig.1].

In a diusive SNS structure with transparent SN interfaces, the density of states in the norm alpart, averaged over its thickness, and at energies Epright above the gap edge E_g ' 3:12 E_{Th} , is / 1= V (E $E_{q} = \frac{3}{0}$ where $_{0} = (E_{q}^{2})^{1=3}$, $= 1=(_{0}V)$, and $V = L_{x}L_{y}L_{z}$ is the volume of the normal region. This dependence is rem iniscent of the density of states at the edge of a W igner sem icircle in Random Matrix Theory [RMT], 0 being the e ective level spacing right above the gap edge. U sing this analogy, Vaviby et al.⁸ realized that the disorder averaged DOS should not display a real gap, but have exponentially sm all tails below the gap edge, analogous to the Tracy-Widom tails¹¹ in RMT.A rigorous study in terms of a Supersymmetric Sigma Model description of the SNS structure has shown that this is indeed the case⁹. However, in analogy to the theory of Lifshits tails¹² in disordered conductors, the nature of the resulting subgap quasiparticle states depends additionally on the elective dimensionality d, determined by comparing the interface length scales $L_x; L_y$, with the typical length scale of a subgap quasiparticle state, L_2 . In particular, if $L_x = L_2 > L_y$ or $L_x; L_y = L_2$ the subgap quasiparticle states are localized either in the x direction or in the x y plane along the interface, respectively. Correspondingly, the asymptotic tails of the DOS deviate from the universal RM T result, applicable only in the zero dimensional case $[L_x; L_y < L_2]$.

The analogy with RMT applies, within the appropriate symmetry class, to other physical situations, such as di usive superconductors containing m agnetic in purities^{8,13,14}, and superconductors with inhom ogeneous coupling constants¹⁵. In both cases, at mean eld level the density of states has a square root singularity close to the gap edge^{16,17}. Correspondingly, accounting form esoscopic RM -like uctuation, the disorder averaged density of states has tails below the gap edge, with an asym ptotics similar to the one calculated in Ref.[9] for SNS structures. On the other hand, in the case of di usive superconductors containing magnetic impurities, it was shown^{18,19} that, in addition to mesoscopic uctuations, subgap quasiparticle states can form as a result of classical uctuations, i.e. long-wave uctuations of the concentration of magnetic impurities associated to their Poissonian statistics. Sim ilarly, also in superconductors with inhom ogeneous coupling constant long-wave uctuations of the coarse grained gap lead to the appearance of subgap quasiparticle states, and consequently to tails of the DOS¹⁷. Interestingly, in both cases the tails originating from mesoscopic uctuations and from classical ones are form ally related by a dimensional reduction¹⁸.

In this paper, we close this set of analogies, studying the contribution to the subgap tails of the DOS in a di usive SNS junction arising from long-wave uctuations of the concentration of im purities in the norm allayer. Com bining the results of this analysis with those obtained by O strovsky, Skvortsov, and Feigelm an⁹, who considered the subgap tails originating from m esoscopic uctuations, we provide a consistent picture of the physics of the subgap states. In particular, a quantitative comparison of the two contribution shows that m esoscopic uctuations dom inate in long and dirty junctions, while classical uctuations dom inate in wider and/or cleaner ones. In analogy with di usive superconductors with m agnetic im purities, and superconductors with inhom ogeneous coupling constants, also in the present case the two contributions to the subgap tails, arising from m esoscopic and classical uctuations, are related by a dim ensional reduction.

The rest of the paper is organized as follows: in Sec.II we present the details of the analysis of the subgap D O S arising from uctuations of the concentration of impurities $n_{\rm im\ p}$ in an SN S junction. In Sec.III, we compare the two contributions to the subgap D O S associated to m esoscopic and classical uctuations. In Sec.IV, we present our conclusions.

II. SUBGAP DOS ASSOCIATED TO $\label{eq:stable} FLUCTUATIONS OF n_{\text{imp}}.$

Let us start considering a di usive m etallic layer in between two superconducting bulk electrodes, a geom etry represented schem atically in Fig.1. A ssum ing $k_{\rm F}$ l>> 1, where l is the m ean free path, this system can be described in terms of the quasiclassical approximation. In particular, at m ean eld level [i.e., neglecting both m esoscopic and classical uctuations], neglecting electronelectron interaction, and assum ing the thickness of the m etallic layer L_z >> l, one can describe the SNS structure by the U sadel equation^{20,21}

where $D = v_F^2 = 3$ is the di usion constant, E is the energy measured from the Fermi level, assumed to be jE j , where is the gap in the bulk electrodes.

The eld is related to the quasiclassical G reen's functions and the anom alous G reen's function by the relations $g(r; E) = \cos[(r; E)]$, $f(r; E) = i\sin[(r; E)]$. In addition, assuming the interfaces to be perfectly transparent, the proximity to the two superconducting regions can be described by the boundary conditions $(z = I_z = 2) = = 2$.

It is convenient to measure all lengths in units L_z , and set = =2 + i . Therefore, Eq.(1) becomes

where $E_{Th} = D = L_z^2$ is the Thouless energy. The boundary conditions for the eld are simply (z = 1=2) = 0.

In term s of the DOS is $= 2_0$ Im [sinh []], where $_0$ is the density of states of the norm alm etal at the Ferm i

level. The DOS can be calculated looking for solutions of Eq.(2) uniform in the x y plane^{4,5,6,9}. In particular, for E < E_g C₂E_{Th} [C₂' 3:122] all solutions of Eq.(2) are real, im plying = 0. Therefore, one identi es E_g with the proximity induced gap within the norm alm etal layer. The mean eld DOS right above E_g averaged over the z direction is found to be

Let us proceed analyzing the tails of the DOS at energies E < E_g arising from uctuations of the concentration of in purities, i.e. long-wave inhom ogeneities in the x y plane of 1= . We rst consider an SNS structure such that the linear size of the SN interfaces is much larger than the thickness of the metallic layer $[L_x;L_y \quad L_z]$. In the framework of the U sadel description of the metallic layer [eq.(2)] one can account for long-wave transversal uctuations of the concentration of in purities by promoting E_{Th} , or equivalently $E_g = C_2 E_{Th}$, to be a position dependent random variable, characterized by the statistics

where d is the elective dimensionality of the system , and n_d the elective concentration of in purities. A schown below , d is determined by comparing the linear sizes of the interface $L_x; L_y$ to the linear scale of the subgap states L_2 ' $L_z = (E_g \ E) = E_g)^{1=4}$. If $L_x; L_y \ L_2$ the system is electively two dimensional, and $n_2 = n_{im \ p} L_z$. On the other hand, if $L_x < L_2$ L_y [or $L_y < L_2$ L_x], the system is electively one dimensional, and $n_1 = n_{im \ p} \ L_z \ L_x$.

A ccounting for these uctuations, the U sadel equation $\mathrm{E}\,\mathrm{q}\,.(2)$ becomes

O urpurpose is to calculate the DOS averaged over uctuations of E_g at energies $E < E_g$. For this sake, let us introduce $E = E_g = E$, and (z;x) = (z;x) = 0 (z), where $_0$ is the solution of Eq.(2) at $E = E_g$. Expanding Eq.(7) and keeping the lowest order nonlinearity in one obtains

In order to sim plify further Eq.(8), it is useful to notice that the operator $H = (f_z^2 f_0(z), diagonalized with zero boundary conditions at 1=2, adm its an eigenstate 0 with zero eigenvalue. Physically, 0 determ ines the shape of the mean eld z-dependent DOS obtained from Eq.(2). Therefore, it is natural to set$

Interestingly, this set of equations is analogous to the equations obtained by Larkin and O vchinikov in the context of the study of gap sm earing in inhom ogeneous superconductors¹⁷, and to the equations obtained by the author and Io e in the context of the study of subgap tails in di usive superconductors containing magnetic im purities¹⁸.

Let us now proceed with the calculation of the DOS. In the present notation, the DOS averaged over the thickness of the norm al layer is given by

We are interested in calculating the average density of states h $i=_0$ ' 3:72hvi at energies below the Thouless gap [> 0]. In this parameter range, the corresponding functional integral

receives its most important contributions by exponentially rare instanton congurations of g such that, at specic locations along the interfaces of the junction, g(x). The remaining task is to select among all these uctuations the one that dom inates the functional integralEq.(15), i.e. the optim all uctuation.

The action associated to a conguration of $\ _g$ is

where we used Eq.(12) to express $_g$ in term s of u;v, and, with exponential accuracy, neglected the term v^2 in the action. In order to nd the optim al uctuation one has to nd a nontrivial saddle point u_0 of S, tending asymptotically to the solution of the hom ogeneous problem $[u_0 !]$, and subject to the constraint of having nontrivial solutions for v of Eq.(13).

Since the norm alm etal layer is di usive, and m om entum scattering isotropic, it is natural to assume the optim al uctuation to be spherically symmetric. The Euler-Lagrange equation associated to S is

This equation is equivalent to the hom ogeneous U sadel equation with uniform E_g , i.e. Eq.(10) with $_g = 0$. Though this equation has de nitely nontrivial instanton solutions for u with the appropriate asymptotics, it is possible to show that the constraint of Eq.(13) is satis ed only by v = 0. This is physically obvious since Eq.(19) describes a uniform system where all long-wave uctuations of 1= have been suppressed, and thus, within the present approximation scheme, the subgap DOS must vanish. How ever, it should be pointed out that, accounting for mesoscopic uctuations, the instanton solutions of Eq.(19) describe the optim al uctuation associated to mesoscopic gap uctuations, as shown in Ref.[9].

Let us now look for the nontrivial saddle point. Equation (17) is equivalent to the system

which can be reduced to a single second order instanton equation setting $h = (20_r u)=r$. W ith this substitution, Eq.(20) becomes the derivative of Eq.(21), which now reads

N otice that this equation is, upon reduction of the dim ensionality by 2, identical in form to the one associated to mesoscopic uctuations, Eq.(19). As we will see later, this reduction of dimensionality relates in a similar way the dependence of the action associated to classical and mesoscopic uctuations on \cdot .

It is now straightforward to see that the instanton solution u_0 of this equation with the appropriate asymptotics describes indeed the optimal uctuation, the constraint of Eq.(13) being automatically satis ed in virtue of Eq.(20), with $v_0 / (2\varrho_r u_0)=r$. Moreover, the corresponding optimal uctuation of g is $g = 2\varrho_r u_0=r$.

It is clear that the instanton solutions of Eq.(22) must have the form $u_0 = (r=)$, with $= 1=(1^{-1})^4$. The corresponding equation for (r) is $\theta_r^2 + (d-3)=r \Phi$

 2 + 1 = 0. The instanton solution of this equation can be easily found num erically, and the corresponding action S calculated. The result is

W ithin our approximation scheme, the density of states is h i / W $\exp[S]$, where W is a prefactor due to gaussian uctuations around the instanton saddle point. The calculation of W can be performed using the standard technique due to Z ittarz and Langer, and is similar to those reported in Ref.[18,17]. To leading order in the saddle point approximation, the nal result is

The result in Eq.(24) relies on a saddle point approximation, which is justiled provided S_d 1. This translates into the condition

As m entioned before, the e ective dimensionality, and therefore the asymptotic density of states, is determined by comparing the linear size of the optimal uctuation, in dimensionfull units L_2 ' $L_z = L_z = \frac{1-4}{2}$, to the linear dimensions of the interfaces L_x ; L_y . If L_x ; L_y L_2 the asym ptotics is e ectively two dimensional [d = 2], while for L_v L_?; L_x L_? the asymptotic DOS is e ectively one dimensional [d = 1]. Since L₂ increases as the energy gets closer to the average gap edge, it is clear that in any nite size system the applicable asymptotics might exhibit various crossovers, 2d ! 1d ! 0d, as ! 0.In particular, the tails are zero dimensional when L_x ; $L_y <$ L_2 , in which case the asymptotic form of the DOS is obtained by calculating the integral

III. M ESOSCOPIC VS.CLASSICAL FLUCTUATIONS.

In the previous section we have discussed the asymptotic density of states below the Thouless gap originating from classical uctuations, i.e. inhom ogeneities in the concentration of impurities or equivalently in 1 = . As discussed in the introduction, this mechanism to generate subgap states is complementary to mesoscopic uctuations of the gap edge.

The tails associated to mesoscopic gap uctuations have been calculated by 0 strovsky, Feigel'man and Skvortsov in Ref.[9]. To exponential accuracy, the subgap DOS associated to mesoscopic uctuations is h i= $_0$ / exp[S_d], where

The scale of the optim all uctuation associated to mesoscopic uctuations is also L_2 ' $L_z = ()^{4}$. Therefore, the elective dimensionality d is to be determined according to the criteria presented in the previous section.

Before discussing the comparison of mesoscopic and classical uctuations, let us rst explain the rationale behind the separation these two contributions. Though it is clear that the only physical uctuations in a real sample are associated to uctuations in the positions of impurities, these uctuations can a ect the DOS in two ways: i)-depress the Thouless gap edge by increasing locally the scattering rate [classical uctuations], or ii)take advantage of interference e ects in the quasiparticle wave functions to generate quasiparticle states that couple ine ciently to the superconducting banks [m esoscopic uctuations]. It makes sense to think of two types of e ects separately if the actions associated to them are very di erent in magnitude [S S or vice versa]. Obviously, in the crossover region, where S S the separation of these two mechanisms is meaningless, because the system can take advantage of both at the same time.

W ith this caveat, let us proceed in the comparison of these two contributions, starting with the zero dimensional case. Since the dimensionless conductance is $G_0 = E_g =$, where 1 = 6V is the level spacing, then the d = 0 action associated to mesoscopic uctuations can be written as

where $_0 = (E_g^{2})^{1=3}$, where $= 1=(_0V)$ is the level spacing in the metallic layer. Physically, $_0$ can be interpreted as being the elevel spacing right above the gap edge. Indeed, from Eq.(3) one sees that

Therefore, the result of Eq.(31) indicates that tails originating from m esoscopic uctuations of the gap edge are universal [in d = 0], in accordance to the conjecture formulated in Ref.[3] on the basis of R andom M atrix Theory. In turn, in the zero dimensional case the action associated to classical uctuations is

where $E_0 = E_g = \frac{p}{n_{im \, p}V}$ is the scale of typical uctuations of the gap edge associated to uctuations of the concentration of impurities. The dimensionless parameter controlling which which mechanism dominates is therefore

C learly, for $_0$ 1 m esoscopic uctuations dom inate the subgap tails, while for $_0$ 1 classical uctuations give the largest contribution to the subgap DOS²⁴.

Let us now write $_0$ in terms of elementary length scales, one can estimate

where we used the fact that the scattering cross section of a single impurity is typically of the same order of $\frac{2}{r}$. Within the assumptions of the theory, $_0$ is the ratio of two large num bers, and therefore its precise value depends on the system parameters. However, from Eq.(35) we see that making the junction longer and longer, i.e. increasing Lz, tends to favorm esoscopic uctuations. Intultively, this is due to the fact that as L_z increases, the dim ensionless conductance of the junction dim inishes while the average number of impurities increases, therefore suppressing the associated uctuations of the gap edge. At the same time, increasing the area of the junction, or making them cleaner, reverses the situation. In sum m ary, m esoscopic uctuations are favored in long and dirty junctions, while classical uctuations are favored in wider and/or cleaner ones.

Since in higher dimensionalities the linear scale of the optimal uctuation associated to the two mechanism is identical $[L_2 = L_z = ()^{1=4}]$, it is possible, and physically suggestive, to reduce the form of the actions in d = 1;2

to a zero dimensional action calculated within the typical volume of the optimal uctuation. The latter is $V_2 = L_x L_2 L_z$ for d = 1, and $V_2 = L_2^2 L_z$ in d = 2. For example, for d = 1 one can write

In analogy to the zero dimensional case, one is therefore led to conclude that also in for one dimensional tails long and dirty junctions are dominated by m esoscopic uctuations, while wider and/or cleaner junctions favor classical ones. This qualitative statement is indeed correct, but the proof is complicated by the energy dependence $L_{\rm ?}$.

The appropriate way to proceed for d = 1;2 is to write the actions associated to classical and m esoscopic uctuations in compact form as

If $_{\rm d}$ 1, the subgap DOS is dom inated by m esoscopic gap uctuations, and the applicable result is Eq.(27). On the other hand, for $_{\rm d}$ 1 the DOS below the gap is determ ined by long-wave uctuations of 1= [Eq.(24)]. Finally, estimating $_{\rm d}$ in terms of elementary length scales, one obtains

In analogy to Eq.(35), the fact that $_{\rm d}$ is proportional to a power of L_z=l im plies that m esoscopic uctuations are dom inant in long junctions, while the inverse proportionality of $_{\rm d}$ on a power of k_F l and of the linear size of the interface [in d = 0;1] im plies that wide interfaces and/or cleaner sam ples m ay favor the contribution arising from classical uctuations.

IV. CONCLUSIONS

In this paper, we discussed the e ect of inhom ogeneous uctuations of the concentration of im purities, or equivalently of 1= , on the tails of the DOS below the Thouless gap in di usive SNS junctions. We have shown that these classical uctuations lead to the form ation of subgap quasiparticle states and are com plem entary to meso-scopic uctuations in determ ining the asymptotic DOS. Finding the dimensionless parameter that controls which mechanism gives the dominant contribution to the subgap tails, one nds that, qualitatively, mesoscopic uctuations are favored in long and dirty junctions, while classical ones dominate in wider and/or cleaner ones.

W e have observed that, as for di usive superconductors containing m agnetic in purities, and for di usive superconductors with an inhom ogeneous coupling constant, the two contributions are form ally related by a dim ensional reduction by 2, both at the level of instanton equations determ ining the optim al uctuation, and in the dependence of the DOS on the distance from the gap edge

. As in other physical system $\frac{25}{5}$, it is natural to expect that supersymmetry is at the root of dimensional reduction also in this context. This fact could in principle be elucidated generalizing the Sigm a M odel describing mesoscopic uctuations to include the physics associated to classical uctuations.
