Dielectric Response of Periodic Systems from Quantum Monte Carlo Calculations

We present a novel approach that allows to calculate the dielectric response of periodic systems in the quantum M onte C arlo form alism. We employ a many-body generalization for the electric enthalpy functional, where the coupling with the eld is expressed via the Berry-phase formulation for the macroscopic polarization. A self-consistent local H am iltonian then determines the ground-state wavefunction, allowing for accurate di usion quantum M onte C arlo calculations where the polarization's xed point is estimated from the average on an iterative sequence, sampled via forward-walking. This approach has been validated for the case of an isolated hydrogen atom, and then applied to a periodic system, to calculate the dielectric susceptibility of molecular-hydrogen chains. The results found are in excellent agreement with the best estimates obtained from the extrapolation of quantum—chem istry calculations.

The response of an extended system to an electric eld is an intrinsic property of central importance to the understanding and characterization of bulk materials. First, it depends very sensitively on an accurate description of the correlations between interacting electrons. Second, it allows one to predict observable quantities such as the infrared or (non-resonant) Ram an and hyper-Raman spectra, establishing a direct link between m acroscopic experim ental observations and m icroscopic calculations. Density-functional approaches to calculate dielectric susceptibilities in periodic systems were introduced more than two decades ago [1, 2, 3, 4]. However, the resulting agreement with experiments is less striking than for the case of structural or vibrational properties, even though the response to a static electric eld is strictly a ground-state property [2]. These discrepancies have been related to the intrinsic dependence of the exchange and correlation functional on the polarization [5]; non-local exchange-correlation functionals such as the weighted-density approximation (WDA) [6] also show some improvements upon the local-density (LDA) [2] or generalized-gradient approximations (GGAs) [7]. While in the case of crystalline sem iconductors dielectric susceptibilities are usually overestim ated by 10 30% in LDA or GGAs, linear dielectric susceptibilities of conjugated polymers are usually overestimated by a factor 3, and non-linear susceptibilities by orders of magnitude [8, 9, 10]. Linear chains of hydrogen dim ers are another clear exam ple of LDA or GGAs failures, and have thus become a stringent test case to assess new developments in density-functional theory [10, 11, 12, 13]. Correlated quantum -chem istry m ethods are able to predict accurate linear and non-linear polarizabilities for polymeric chains [14], but their less favourable scaling and the need, in the absence of periodic boundary-conditions (PBCs), to extrapolate the results to the in nite system lim it their range of applicability.

Highly-accurate ground-state electronic-structure cal-

culations can be performed using continuous quantum Monte Carlo (QMC) methods [15], which bene t from scaling costs as low as N N 3 [16], where N is the num ber of electrons. Although di usion QMC has been successfully applied to address the polarizability of small molecules [17], the extension to bulk materials is hindered by the diculty in treating the response to a linear electric eld, since the latter is non-periodic and incompatible with PBCs. Only the response of the electron gas to a nite wavelength perturbation has been investigated [18]. In density-functional calculations, the response to an electric eld has been calculated via its long-wavelength limit using supercells of increasing size [1, 6, 19], or, more elegantly, using linear-response theory [4, 20]. A general approach able to deal with nite elds, and thus both linear and non-linear e ects, has also been recently introduced [21, 22]. This method is based on the fact that the macroscopic polarization can be properly de ned even in PBCs 23, 24]; then, instead of applying a eld in the form a linear potential, a Legendre transform allows one to introduce an electric enthalpy functional whose minimization leads to the correct wavefunctions.

In this work we apply these ideas to the case of correlated electrons, using the many-body formulation of the Berry-phase polarization [25, 26] to dealw ith the generalization of the electric-enthalpy functional [21, 22, 27, 28] to the interacting case [29]. We show how such an approach can be applied to the case of di usion quantum M onte Carlo (DMC) calculations, where a local Herm itian operator is needed to evolve a population of walkers representing the ground state.

Let's consider a system of N interacting electrons in a periodic cell of size L (to simplify the notation we describe the one-dimensional case, but the extension to higher dimensions is straightforward). The normalized

The polarization of the system can be obtained from the single-point Berry phase [25]

where is the size of the cell $\beta 0$, e is the electron charge, G = 2 = L, and \hat{X} the N-body operator

The de nition of Eq. (2) coincides, in the thermodynam ic lim it, with the exact many-body observable [25], but it also remains well-de ned for any nite L. With the many-body polarization well de ned, the ground-state wavefunction of a periodic, extended system in the presence of an electric eld E can be obtained from the minimum of the generalized electric enthalpy [21, 22, 27, 28, 29]

where E $^0\,[\,\,\,]$ is the energy functional for the unperturbed H am iltonian H 0 .

The functional in Eq. (5) could be directly m in imit ized using a variational M onte Carlo approach [31], but it can't be applied directly to the more accurate case of DMC calculations, since these can only deal with H amiltonians that are both local and H ermitian. A local H ermitian operator can nevertheless be derived from the minimum condition for the electric enthalpy

with an appropriate Lagrange multiplier [33]. The that minimizes Eq. (5) is also the ground-state for the many-body self-consistent Hamiltonian

where z depends on through Eq. (3). For any given L, there exists a well-de ned interval for E centered around 0 for which the electric enthalpy can be m in in ized w ithout encountering runaway solutions [21, 22]. In addition, all physical observables of interest here (e.g. the linear and nonlinear dielectric susceptibilities) are derivatives of the electric enthalpy with respect to the eld and thus remain well-de ned for every L.

Due to the self-consistent nature of the operator H(z) de ned in Eq. (7), the ground state in the presence of an electric eld must be found through an iterative procedure. We start from a rst value z for z, e.g. as found in

the single-particle calculations or in the m any-body trial wave function $_{\rm T}$; the local H am iltonian H (z_1) is then constructed. DMC evolution using this operator leads to a new expectation value for z, called z_2 , which in turn determ ines a second H am iltonian H (z_2) . In the absence of stochastic noise, this process could be iterated to convergence z_1 ! z_2 ! z_3 ! \vdots : ! z_n , to nd the xeapoint of the complex-plane m ap

Since the M onte C arlo procedure introduces a statistical error in every estimate of z_i , the map f becomes a stochastic function in the complex plane. Now, the linear approximation f(z)=az+b is made close to the xed point of f(z) (linearity will be shown numerically later). Then, the average over a sequence of fz_ig provides the estimate for the xed point b=(1 a) of f(z), from which the polarization is then obtained via Eq. (2). Finally, supposing that the error in the complex plane is isotropic with a quadratic spread i=1, the fixing will be distributed around the xed point with a quadratic spread i=1.

M ost implementations of DMC use importance sampling: during diffusion in imaginary time, the walkers at a time that are distributed as $_{\rm T}$ (R) (R), where is the correct ground-state wavefunction and $_{\rm T}$ is the trial wavefunction ($_{\rm T}$ is chosen here to be the product of a Jastrow factor and a Slater determinant). Since the operator ${\rm e}^{{\rm i}G}$ does not commute with the Hamiltonian, we use a forward-walking strategy [35, 36] to sample the expectation value z. where N $\,$ is the number of walkers at timestep $\,$, and X $_{\rm j}^{\rm 0},$ $\,$ corresponds to the ascendant con guration of the walker j at an interval $\,$ t back in imaginary time.

We implemented this approach in the QMC Casino package [37]; the single-particle orbitals for the Slater

determ inant of the trial wavefunction $_{\rm T}$ were obtained from Quantum ESPRESSO [38], using consistently the same nite electric eld E of the QMC calculation 39].




FIG.1: (a) Polarization of an isolated H atom in the absence of an electric eld as a function of the forward walking parameter t, using a trial wavefunction expressed by a PBE-GGA orbital calculated in the presence of an electric eld of 0.005 a.u.. The dashed line is a guide to the eye. (b) Polarizability of an isolated H atom, for each of the self-consistent DMC runs in the iterative sequence (see text). The dashed line is a guide to the eye.

To validate our approach, we st calculate the polarizability of an isolated hydrogen atom, using a large supercell and periodic-boundary conditions. For this case, a homogeneous nite eld can be explicitly applied using a saw-tooth potential (i.e. a potential that is both periodic and piecew ise linear), and the results compared with those obtained with our method. We use the same GGA trialwavefunctions for both tests, as calculated under an applied electric eld of 0:005 a.u. using a local H pseudopotential, 50 Ry cuto in the plane-wave basis set, and a cell of 20 200 a.u. (the longest direction coincides with the applied electric eld, and a large supercell has been used to elim inate nite-size errors 40]). In all DMC calculations we choose a timestep of 0:02 a.u., assuring an acceptance ratio greater than 99.7%. Then, the projection time the forward-walking is determined. We show in Fig. 1 (a) the dependence of the expectation value for the polarization of the atom in the absence of an applied eld, as a function of the projection time tin Eq. (9), showing convergence to 0 a.u. for t 600 timesteps. With these parameters, we start our iterative sequence of calculations. The rst value for z is taken from the GGA results, and then after each DMC run the local operator H (z) is updated using the current expectation value for z. W e report in Fig. 1(b) the atom ic polarizability calculated from each one of the $z_{\rm i}$ along the sequence of DMC runs. The average of the z_i over the last 13 runs gives us a xed point estimate $10^{4}i$ 4: $10^{6}i$) for 2: $10^{7} + 7:05$ (0:9995072 f(z), and a corresponding polarizability for the H atom of 4:49 0:03 a.u., in excellent agreem ent with the result obtained for the saw-tooth potential (4:52 0:05 a.u.) and the exact value of 4:5 a.u. [41].

Having validated our scheme in an isolated case, we proceed to apply it to a genuine periodic system, namely a linear chain of hydrogen dimers, where standard density-functional theory performs very poorly [10].




FIG. 2: (a) Linear polarizability per $\rm H_2$ unit for a periodic linear chain of 22 $\rm H_2$ dimers in PBCs, for each of the self-consistent DMC runs in the iterative sequence (see text). The dashed line is a guide to the eye. (b) Last ten $\rm z_i$ values (thin), and estimate of the xed point of f(z) (bold).

We adopt one of the standard geometries reported in the literature [9, 42], where the hydrogen dim ers have a H-H bond length of 2.0 a.u. and are separated by 2.5 au. . For this case, reliable reference results for the polarizability per dim er unit are available from correlated quantum -chem istry approaches (= 53:6 a.u. = 50:6 a.u. in CCSD(T)) [42]; these in MP4 and num bers should be contrasted with the PBE-GGA result = 144:5 a.u. [43]. To calculate the DMC susceptibility, we use a trial wavefunction composed of a Slater determinant of PBE-GGA single-particle orbitals (consistently calculated with an electric eld of 0:001 a.u.) tim es a Jastrow term containing the electron-electron and electron-nucleus term s [44]. W e consider three supercells containing 10, 16 and 22 H₂ units, and the same electric eld of 0:001 a.u. . The polarizabilities per unit dim er are found by nite di erences (note that the polarization at zero eld is zero by symmetry). In Fig. 2(a), we show the polarizability calculated at each DMC run in the 22-unit supercell. After the second iteration, the instantaneous polarizability oscillates roughly around the nalvalue; again, we stress that it is the average of fzig that delivers the estimate of the xed point

and thus the nal polarization. In Fig.2(b), we show the distribution of the last ten zi, and the xed point $(0.8029 \ 4: \ 10^{4} + 6.0 \ 10^{2}i \ 1: \ 10^{3}i)$, obtained from their average. In Table I, we illustrate the convergence of the calculated polarizability with respect to the supercell size [45]: The faster convergence with respect to the PBE-GGA case originates in the the stronger localization of in DMC. Indeed, the localization spread 2 (de ned as $(L^2=N 4^2) \ln \frac{1}{2}$ [46]) decreases from 4:32 a.u. (i.e. Bohr²) for PBE-GGA to 2:44 0:01 a.u. in DMC for the 22 units supercell. Finally, we compare in Table II our nal result = 53:4 1:1 a.u. with those obtained using other approaches: we nd excellent agreem ent with the m ost accurate results available using M P 3 and M P 4. W e note in passing that the correlated quantum chem istry polarizabilities have been extrapolated from calculations performed for nite chains 42], with the extrapolative correction amounting to 20% of the nal results.

In conclusion, we introduced and validated a novelap-proach to study periodic systems in the presence of - nite electric- elds with highly-accurate, and in principle linear-scaling, di usion QMC calculations. In particular, we presented the rst QMC evaluation of the dielectric susceptibility of an extended system. For the paradigmatic test case of hydrogen chains, we obtained excellent agreement with the best quantum-chemistry results. Our approach opens the possibility to evaluate linear and nonlinear dielectric properties, elective charges, and R am an and infrared coupling tensors using QMC calculations.
