
Using NMR to Validate First-Principles Granular Flow Equations

A bstract Nuclear magnetic resonance (NMR) experiments are described for two granular- ow systems, the vibro uidized bed and the gas- uidized bed.U sing pulsed eld gradient, magnetic resonance imaging, and hyper-

polarized gas NM R, detailed inform ation is obtained for the density and motions of both grains and interstitial gas. For the vibro uidized bed, the granular temperature pro le is measured and compared with a rstprinciples formulation of granular hydrodynamics. For the gas- uidized bed, dynamic correlations in the grain density are used to measure the bubble velocity and hyperpolarized xenon gas NM R is used to measure the bubble-emulsion exchange rate. A goal of these measurements is to verify in earth gravity rst-principles theories of granular ows, which then can be used to make concrete predictions for granular ows in reduced gravity.

1 Introduction

G ranular ow and uidized-bed properties in reduced gravity and interstitial gas pressure will be important for processing, storage, and other applications during lunar and M artian m issions. How ever, current engineering

practice for granular ows is based on correlations of Earth-gravity data and so cannot be extrapolated with any certainty to reduced gravity. An alternative path is to use experiments to validate granular ow equations derived from fundamental physical principles, in which the acceleration of gravity appears as an explicit input parameter. To the extent that this is possible, reasonable predictions for reduced gravity granular systems can be m ade, although it will remain necessary to test the predictions in actual microgravity experiments (Fig. 1).

Nuclear magnetic resonance (NMR) enables noninvasive measurements to be made on dense, opaque systems such as granular media. We are engaged in a program of experiments to build up detailed pictures of dense, three-dimensional granular systems in E arth gravity using NMR methods combining MRI, PFG-NMR, and hyperpolarized-gas NMR. Using these methods we are able to measure density proles, and grain as well as gas motions over millisecond to second time scales. We




Fig. 2 Typical NMR pulse sequence used for grain measurem ents in granular ows. The vertical lines indicate radiofrequency pulses, and the rectangles indicate gradient pulses of variable strength. U sing this type of sequence, it is possible to measure the joint distribution of grain motions during the interval twith m resolution, and grain positions with sub-mm resolution. The entire sequence can be completed in as little as 2 m s, although it m ust be repeated m any tim es to build up the distribution information.

vibro uidized bed and the bubbling gas- uidized bed.


2 N M R techniques for granular ows

Broadly, two requirements must be met to carry out NMR experiments on a owing granular medium. First, a system must be set up in the desired granular ow state (e.g., bubbling gas- uidized bed) which also gives a substantial NMR signal for the subsystem to be measured (grains or gas). Second, suitable NMR protocols must be devised to extract the desired inform ation such as density, velocity, di usion, exchange between phases, etc. The ways in which these two requirem ents are met are quite di erent for grain and gas NMR, yet som et in es it is possible to carry out grain and gas measurements on nearly identical system s.

2.1 Grain NMR techniques

Due to the rapid molecular tumbling, uids give NMR signals much more suitable for im aging-type studies than do solids [1]. Botanical seeds, which typically contain liquid oil that gives a strong NMR signal, have been one populartype of sam ple for granular-m edia studies [4;14]. To allow NMR studies over a wider range of grain sizes, sm all am ounts of organic liquids can be adsorbed onto substrates such as porous catalyst particles [21]. In the experiments described here, both types of grains were em ployed.

For grain-phase studies, we typically use NMR pulse sequences that can encode both the motion of the grains and their positions (Fig. 2). Using strong gradient pulses (up to 1000 G / cm), it is possible to resolve grain m otion overtim es ofone millisecond or less. In this type of study, the individual grains are not in aged. Rather, the pint probability distribution over all grains is measured as a function of grain position and grain displacement in a



will describe our studies of two granular ow system s: the Fig. 3 Joint distribution p(z;z) of vertical displacements z in t = 1:38 m s and heights z, for the grains in a vibro uidized bed of mustard seeds [11]. Near the bottom of the bed (sm all z) the distribution is highly skewed due to collisions with the vibrating bottom wall, while at large z the distribution is nearly Guassian.

speci ed tim e interval [2]. Figure 3 shows an exam ple of this type of data. Note that for our studies of system s with continuous, rapid grain movem ent both the NMR techniques used and the type of data obtained are quite di erent from ealier studies of quasistatic ow s [14].

22 GasNMR techniques




Fig. 4 Simplied diagram of apparatus for using hyperpolarized xenon to study gas motion in a uidized granular bed.

Under equilibrium conditions, the NMR signal from gasses is very weak (due to their low density), often making gas-phase NMR studies di cult. By using hyperpolarized gas, which has been shown to be practical for ³He and ¹²⁹Xe, the NMR signal can be increased by a factor of order 10⁴ [23]. Figure 4 shows a simpli ed diagram of the apparatus we use to study the gas motion in a gas- uidized granular bed. In this apparatus, xenon gas is polarized by spin exchange with rubidium vapor in a laser optical pum ping cell. The hyperpolarized xenon is then used as the uidizing gas for a small granular bed located within the NMR magnet.

3 The vibro uidized bed: Granular hydrodynam ics

The rst granular system to which we have applied these techniques is the vibro uidized bed. Mechanical vibration is a fundam ental and widely used technique for transform ing granularm edia from solid-like to uid-like states. In addition, vibration is often used as an aid for other uidization m ethods such as gas ow or gravity-driven ow.

Questions one would like to be able to answer from basic physical principles include: W hat am plitude and frequency of vibration are required for uidization? W hat are average grain density and grain speeds as functions of height within the bed?

One theoretical approach has been to treat the individual grains like molecules in a (pseudo) uid, and to bring to bear m ethods of statistical physics such as kinetic theory and hydrodynam ics [9; 10; 13; 18; 22]. This approach is most tractable (and more likely to be valid) in the \rapid granular ow " regime, in which the transient two-body collisions between the grains dom inate over longer-lived and m any-particle interactions [3]. For a vibro uidized bed, this regime occurs for strong, high frequency driving of relatively shallow beds [11].




Fig. 5 Distribution of horizontal grain displacements in a vibro uidized bed under the same conditions as Fig. 3. The NMR observation time twas 1.38 ms, considerably shorter than the mean grain collision time 6 m s [11]. Therefore, the measured displacement distribution should give a good approximation to the grain velocity distribution. The curves show ts to a G aussian function with and without power-law stretching of the exponent. The distribution deviates only slightly from an unstretched G aussian function, which would describe the distribution of velocities of molecules in a molecular uid.




Fig. 6 Density $n = nd^3$ (top) and granular tem perature T = T = m qd (bottom) as functions of height z = z = d, for a vibro uidized bed under the sam e conditions as Fig. 3 (the starred variables have been nondim ensionalized by the grain diam eter and m ass d;m and the acceleration of gravity q). The sym bols show NMR m easurem ents, while the curves show a t to the granular-hydrodam ics theory of R ef. [7]. A notable feature (in both the experiment and the theory) is a \tem perature inversion" even though the energy ow is strictly upwards, the tem perature falls with increasing height z and then rises again at large heights. At heights above the tem perature m in im um, the ow of granular \heat" is from colder to hotter tem peratures, an e ect that is only possible in highly out-of-equilibrium systems.

Several earlier studies had used video techniques to m easure grain m otion statistics in guasi-two dim ensional vibro uized beds [5; 17; 19; 20; 25]. Som e of these twodim ensional studies found strong deviations of the grain velocity distribution from the nearly-Boltzm ann distribution that m ight be expected from the statisticalm odels.U sing NMR, we have been able to non invasivly probe the grain velocity distribution in a three-dimensional bed. For the conditions of our experiments we nd that the grain velocity distribution is close to the Boltzm ann distribution (Fig. 5), validating a statistical approach. Beyond this, we are able to make a detailed joint tof the m easured density and granular tem perature pro les, to a 4 The gas-uidized bed: G rain and gas NMR

rst-principles calculation [7] of granular hydrodynam ic coe cients (Fig. 6).

The hydrodynamic equations used to generate the theory curves in Fig. 6 explicitly reference gravity (using a Bernoulli relation, see Ref. [11] for details). A fter validating the hydrodynam ic theory in Earth gravity by a series of ts like that shown in Fig. 6, it is reasonable and easy to extend the theory to reduced gravity by recalculating it with reduced g. The output of such a calculation could be a prediction for the density pro le in a granular bed vibro uidized in lunar or Martian gravity. This is a (perhaps rather sim plistic) example of the program outlined in Fig.1.

Gas- uidized granular beds are widely used in industry for catalytic cracking, e cient combustion, and many other large-scale processes [8; 15; 16] It is reasonable to in agine that gas uidization (or pneum atic transport of granularm aterial, which is closely related) would play a prom inent role in in-situ resource utilization on them oon or M ars, yet the behavior of a gas- uidized bed in reduced gravity is alm ost com pletely unknown at present.

To promote mixing, gas- uidized beds are typically used in the bubbling regime, in which large bubble-like voids devoid of grains rise through the bed at a velocity much larger than the mean gas velocity. From a theo-

retical standpoint the bubbling gas- uidized bed is extrem ely com plex, with signi cant motion over a wide range of length scales (from grain to bubble) and uid dynam ics with self-consistently moving boundary conditions. M icroscopically-m otivated theories of uidizedbed behavior have been formulated (see, for example R ef. [12]) yet to achieve closure these theories must make various unveried assumptions. For example, in a \two

uid" model it might be assumed that the grains and gas behave like two interpenetrating Newtonian uids [12]. Yet, at present it is not established theoretically or experim entally that a dense granular medium is ever well described as a Newtonian uid.

bed is di cult to probe experim entally in a non-invasive m anner. To better understand the dynam ics of the bubbles and their interaction with the dense (\emulsion") phase of the bed, many techniques have been tried including x-ray photography and tracer-gas injection [8].

Here we show prelim inary data for two projects we are carrying out using NMR to probe the bubbles. Neither project has reached the stage of detailed agreem ent with rst-principles theory, as shown above for the vibro uidized bed. Nevertheless som e quantitative connections with model predictions are made.

4.1 M easurem ent of bubble velocity using grain NM R

Simple and basic questions for the bubbling gas- uidized bed are: what is the velocity vb of the rising bubbles, and how is the velocity related to the bubble diam eter d, gas

ow rate, and other bed parameters? In analogy with gas bubbles in a liquid (or by dimensional analysis), it can be argued $v_{\rm b}$ $(dq)^{1=2}$, and such a relation has been proposed for the gas- uidized granular bed with a phenom enological prefactor [6]. Yet it is not easy to measure the mean velocity of bubbles rising in the interior of a chaotically bubbling gas- uidized bed.




Fig. 7 Preliminary measurement of correlations between uctuations in the density of a gas-uidized bed of 75-106 m diameter alum ina particles, measured using NMR. A small quantity of dodecane is adsorbed onto the porous particles, to give NMR sensitivity. The correlations are plotted as a function of the time shift t and the height shift z. For the left plot, there is no gas ow through the bed and hence no uctuations. For the right plot, there is a gas ow su cient to put the bed into the bubbling regime (super cial gas velocity $v_g = 1.4$ cm /scan be measured directly from the slope of the ridge in the correlation plot.

W e have devised a new m ethod to m easure the m ean velocity and other characteristics of the bubbles, using NMR on the grains. A pulse sequence (di erent from that shown in Fig. 2) is used to measure the bed density pro le twice, separated by a time interval t, and the experim ent is repeated m any tim es. Bubbles in the bed appear as localized, downward uctuations in the bed density. W hen the cross correlation between the uctuations in the two time-separated density measurements are plotted (Fig. 7) a ridge appears corresponding to uctuations that propagate at a de nite velocity. The mean velocity of the bubbles can be accurately measured from the slope of the ridge, while the width and shape of the ridge presum ably indirectly re ect the size and shape of the bubbles. This analysis has not yet been completed, but it is already clear that the bubble velocity and size (from the slope and width of the ridge) are approxim ately consistent with the excess gas ow overm in im um

uidization ow. Sim ilarly, the bubble size and velocity from the graph are approximately consistent with the d vs.vb correlation proposed in Ref. [6].

42 M easurem ent of bubble-em ulsion exchange using hyperpolarized gasNMR

U sing the setup shown in Fig. 4, we are able to perform NMR experiments directly on the gas within the idized bed. Signi cantly, we have used the same porous alum ina particles and the sam e bed diam eter as for the grain-NMR experiments summarized above. Therefore, In comm on with other granularm edia, the gas- uidized we can correlate grain and gas NMR inform ation in essentially identical uidization conditions (as veri ed by visual m easurem ents of the bed-height hysteresis curve, which is extremely sensitive to the uidization state).

> The¹²⁹XeNMR frequency is sensitive to the physical environm ent of the gasm olecule, which makes it possible




Fig. 8 ¹²⁹X e spectra for an alum ina-particle bed uidized by hyperpolarized xenon gas, measured at 11 di erent gas ow rates ranging from 15 to 125 scom. Three peaks may be distinguished: a narrow peak due to gas within the bubbles, a broader peak at nearly the same frequency due to gas within the interstitial volum e of the em ulsion (dense granular) phase, and a second broad peak shifted to higher frequency due to gas adsorbed on the porous alum ina particles. As the ow rate is increased, the fraction of gas in the bubbles also clearly increases.

to distinguish spectroscopically between gas in the bubbles, gas between the grains, and gas adsorbed onto the grains (Fig. 8). Using a suitably tailored NMR pulse sequence [24], we are able to selectively elim inate the signal from gas outside the bubbles and then observe this signal re-grow due to gas motion in the bed. In this way an im portant engineering parameter for gas- uidized beds, the bubble-emulsion exchange rate, can be directly and




Fig. 9 Prelim inary measurement of bubble-emulsion exchange rate as a function of gas ow rate for a bed of alumina particles uidized by hyperpolarized xenon gas. The exchange rate gives the rate at which gas within the bubbles interchanges with gas within the dense granular phase, and is a key parameter for engineering applications of uidized beds. The solid curve show sthe exchange rate calculated from the measured bed expansion along with the phenomenological theory from R ef. [6], while the points with error bars show a direct measurement of the exchange rate using ¹²⁹X e NM R.

noninvasively measured (Fig. 9). The exchange rate K is dened by the following equation [15]:

$$\frac{1}{V_{\rm b}}\frac{\mathrm{dN}_{\rm b}}{\mathrm{dt}} = K (C_{\rm b} C_{\rm e})$$

where N_b is the quantity of a tracer gas within a bubble of volume V_b , and C_b ; C_e are the concentrations of the

tracer in the bubble and emulsion phase respectively.For our experiments the hyperpolarized xenon gas serves as a completely neutral tracer, and its concentration in the various phases can be measured accurately and noninvasively using NM R.

5 C on clusions

U sing NM R m ethods, it is possible to m easure the densities and m otion of both grains and gas in continuously excited granular systems such as the vibro uidized and gas- uidized beds. Quantitative results can be obtained for m any parameters including the grain density pro-

le, granular tem perature (m ean random grain kinetic energy), grain bubble velocity and size, and gas bubbleemulsion exchange rate.

Where rst-principles physical theories exist for the granular ow state, e.g., the highly excited vibro uidized bed, these theories can be directly tested. Conversely, for more complex systems like the gas-uidized bed theoreticalm odels must make more ad-hoc assumptions (for example that the bubbles behave approximately as bubbles in a uid). In this case non-invasive NMR measurements o er possibilities to directly test the results of such assumptions (e.g., predictions of the bubble velocity-size relationship and bubble-emulsion exchange rate).

In both cases, a key goal is to understand the granular system su ciently well to enable extrapolations to as yet unexplored regions of parameter space, such as reduced-gravity operations. The di culty and risk of actual reduced-gravity experiments render well-supported predictions for reduced gravity especially valuable.
