O rbital magnetic elde ects in spin liquid with spinon Fermi sea: Possible application to $-(ET)_2Cu_2(CN)_3$

We consider orbital magnetic elde ects in a spin liquid phase of a half-lled triangular lattice Hubbard system close to the Mott transition, continuing an earlier exploration of a state with spinon Ferm i surface. Starting from the Hubbard model and focusing on the insulator side, we derive an elective spin Hamiltonian up to four-spin exchanges in the presence of magnetic eld, and not that the magnetic eld couples linearly to spin chirality on the triangles. The latter corresponds to a ux of an internal gauge eld in a gauge theory description of the spin liquid, and therefore a static such internal ux is induced. A quantitative estimate of the elect is obtained using a spinon mean eld analysis, where we not that this orbital eld seen by the spinons is comparable to or even larger than the applied eld. We further argue that because the still ness of the emergent internal gauge eld is very small, such a spinon-gauge system is strongly susceptible at low temperatures to an instability of the homogeneous state due to strong Landau level quantization for spinons. This instability is reminiscent of the so-called strong magnetic interaction regime in metals with the usual electromagnetic eld, but we estimate that the corresponding temperature (magnetic eld range is signicantly broader in the spinon-gauge system).

I. INTRODUCTION

Experim ental studies 1,2,3 of the quasi-two-dim ensional organic material $-(ET)_2Cu_2(CN)_3$ strongly suggest a spin liquid state in the insulating phase at ambient pressure. $-(ET)_2Cu_2(CN)_3$ is a strongly correlated half-led Hubbard system on an almost isotropic triangular lattice. The material is just near the boundary of the insulator-metal transition 1,2,3,4,5,6,7 It is an insulator at ambient pressure with a charge gap of order 350 K, and shows no signs of magnetic ordering down to 32 mK despite a relatively large exchange coupling J 250 K. Experiments not that this spin liquid maintains a nite susceptibility and a nite $1=(T_1T)$ for the ^{13}C nuclear spin relaxation rate down to low temperatures, 1,5 and also that this insulator has large spin entropy. 2,3

These observations and related num erical studies^{7,8} led the present author,⁹ and also the authors of Ref. 10, to propose a spin liquid state with spinon Ferm i surface as a likely candidate. In Ref. 9, this state was shown to be energetically favored in a spin model with Heisenberg and ring exchanges appropriate for the description of the insulator, while Ref. 10 used the mean eld slave particle approach and also derived an elective gauge theory description of the proposed spin liquid.

Here, we exam ine the response of this spin liquid to strong magnetic elds. One motivation is to look for possible direct probes of the spinon Ferm i surface similar to the ones used in metals such as magneto-oscillations or magnetoacoustic resonance. A nother motivation is the observations in Refs. 3 and 5 of signicant broadening of the ¹³C NMR line in a large magnetic eld up to 9 T at low temperatures below 10 30 K. Systematic studies³ reveal that the lines broaden symmetrically and the broadening increases with increasing eld and also with decreasing temperature. At the present, it is not clear whether this anom alous behavior is intrinsic, or is

the result of extrinsic disorder e ects in the critical spin liquid.

A simple intuition about the Mott insulator would be that the charge motion is suppressed and only spin degrees of freedom couple to the magnetic eld. If this were the case, then one would not expect any strong intrinsic e ects in the presence of the magnetic eld. In particular, in the spin liquid state with spinon Ferm i surface and just the Zeem an spin coupling to the applied eld one would expect only Pauli spin param agnetism. We argue, however, that orbitale ects need to be carefully included when analyzing the response of the spin liquid in $-(ET)_2Cu_2(CN)_3$. This is because charge uctuations, which become more prominent in the vicinity of the insulator-metal transition, also induce an e ective \orbital" coupling to the magnetic eld. The e ect of such coupling on the proposed spinon Ferm isea state is further amplied by the fact that this phase itself is stabilized against other competing spin liquids or the antiferrom agnetically ordered state by charge uctuations that produce the four-spin ring exchange term s.9,10

First, we show that in the presence of the external magnetic eld the spinons e ectively experience an \internal" orbital eld that is comparable to and maybe even larger than the applied eld. This is despite the fact that spinons do not transport electrical charge, but follows when we derive an e ective spin Hamiltonian from electronic degrees of freedom in the presence of the applied magnetic eld. We not that the magnetic eld couples linearly to the spin chirality on the elementary triangles. The e ective description of the spin liquid state contains spinons coupled to a dynamically generated \internal" gauge eld. The physical meaning of the ux of the internal gauge eld is precisely the spin chirality, and the external magnetic eld therefore induces a static internal ux seen by the spinons that is comparable to the applied eld.

Second, we argue that because the sti ness of the internalgauge eld is very small (see Appendix C for num ericalestim ates), the response of the spinon-gauge eld system changes dram atically at low tem peratures such that the Landau quantization of the spinons in the static internal eld is not sm eared by the tem perature. These e ects are similar to strong electronic magnetism in quantizing eld at low tem peratures fam iliar in magneto-oscillation studies of metals 11,12,13 (which we also review in Appendix D). In particular, the homogeneous state with continuously varying internal eld becomes unstable below some tem perature, which for the $-(ET)_2Cu_2(CN)_3$ spin liquid we estimate to be several Kelvin in typical laboratory elds. The instability regime is signi cantly wider in the spinon-gauge system than in metals because the internal gauge eld sti ness is so much smaller than that of the physical electrom agnetic eld. C rudely, the spinon states with integer Landau level lling are more stable than the states with a continuously varying lling, and it becomes advantageous for the internal gauge eld to adjust itself discontinuously to achieve this. This instability also preem pts the possibility of a direct observation of the spinon Ferm isurface using magneto-oscillation probes, but can be viewed as an extreme manifestation of such magneto-oscillations.

The objective of the present paper is to characterize the above two predictions in the spinon-gauge system focusing on the $-(ET)_2Cu_2(CN)_3$ m aterial. The paper is organized as follows. In Sec. II (and also Appendix A), we describe the e ective spin Hamiltonian derived from the triangular lattice Hubbard model in the magnetic eld. In the main part of the paper, Sec. III, we perform a spinon mean eld study of the e ective Hamiltonian. We start with a review of the system in zero eld and progressively add the needed ingredients for the discussion of the response to the magnetic eld such as the appearance of the static internal gauge eld and the importance of the spinon Landau level quantization at low tem peratures. We then argue that a homogeneous spin liquid state with continuously varying static internal ux becom es un stable at low but experim entally relevant tem peratures of few Kelvin. We nalize this section with a more careful discussion of the physical setting in the real system. Helpful connections with the gauge theory description and analogies with magnetic interaction effects in m etals are sum m arized in Appendixes C and D. Throughout, we use the $-(ET)_2Cu_2(CN)_3$ param eters as a guide for the relevant questions. In Sec. IV, we collect the main estimates for the $-(ET)_2Cu_2(CN)_3$ material and consider som e experim ental aspects.

II. RING EXCHANGE HAM ILTONIAN IN THE PRESENCE OF MAGNETIC FIELD

The approach adopted in Ref. 9 and pursued here is to focus on the spin degrees of freedom when describing the insulating state. This is achieved by consider-

ing an e ective spin H am iltonian obtained from the microscopic H ubbard model by a canonical transform ation that projects out the double occupancy. The importance of the charge uctuations is retained in the form of more complicated multispin exchanges. The spin system is still more am enable to analysis because there is much less disproportion between the relevant energy scales and the couplings in the elective H am iltonian, unlike in the original H ubbard model.

The e ective Hamiltonian to order $t^4=U^3$ on the isotropic triangular lattice reads (see also Appendix A)

Here we use multispin exchange operators de ned as $P_{12:::n}:j_1;_2;:::;_{n}i!:j_n;_{1}:::;_{n}i$. For two spins, this reduces to the familiar Heisenberg exchange, $P_{12}=P_{12}^{y}=2S_1$ §+ $\frac{1}{2}$. The rst two lines give the effective Hamiltonian in the absence of the magnetic eld. As discussed in Ref. 9, in portant terms in this Hamiltonian are the nearest-neighbor two-spin exchanges and the ring exchanges around the rhombiof the triangular lattice. The corresponding coupling constants are given in terms of the Hubbard model parameters as

The second—and third-neighbor Heisenberg exchanges $J^{00} = 16t^4 = U^3$ and $J^{000} = 4t^4 = U^3$, though nom inally of the same order as the ring exchange coupling, were argued to play a minor role because of the weak correlations between such further-neighbor spins in the magnetically disordered state.

The last line in Eq. (3) shows a new term that appears at order $t^3=U^2$ in the presence of the magnetic eld. This term involves three-spin exchanges around the elementary triangles and is proportional to the enclosed ux with the coupling constant

The dimensionless ux is $_4^{\rm ext}$ = eB A_4 = (~c), where B is the eld and A_4 is the triangle area. The Ham iltonian Eq. (3) is written to linear order in the external ux, which is assumed to be small, $_4^{\rm ext}$ 1. Each triangle is counted once and is traversed in the same direction. We can write the J_3 term more explicitly as $\sin\left(\frac{\exp t}{123}\right)$ i (P_{123} H x:), where $\frac{\exp t}{123}$ is the complex phase of the loop product $t_{12}t_{23}t_{31}$ of the electron hopping amplitudes in the eld. In general, each contribution from

an exchange path that encloses ux is a ected by the magnetic eld (cf. Appendix A). However, the couplings J_2 , J_4 , J^{00} , and J^{00} , are modi ed only at quadratic order in $^{\rm ext}$. The exhibited three-spin terms represent the full e ect linear in $^{\rm ext}$ to order $t^4=U^3$. The e ective H am iltonian contains only term $s\,P_{12}$, $(P_{1234}+H\,c:)$, and $i\,(P_{123}-H\,c:)$, which was achieved with the help of the following identities valid in the spin-1/2 case:

The three-spin operator i (P_{123} H x:) has a simple physical meaning { it represents the spin chirality:

Thus, the external $\,$ eld couples linearly to the spin chirality and therefore induces such chirality density in the system .

In the above discussion, we have not mentioned the originalZeem an coupling of the electrons to the magnetic eld. Since the Zeem an term involves the conserved total S_z , we can simply reinstate it in the nale ective spin H am iltonian.

For the $-(ET)_2Cu_2(CN)_3$, we use t = 55 meV and U=t = 82 to obtain J_2 ′ 7 meV, $J_4=J_2$ ′ 0:3, and $J_3=J_2$ ′ 0:7; the Heisenberg exchange coupling is $J=2J_2$ ′ 160 K, which is comparable with the estimate J ′ 250 K in Ref. 1.

To sum marize, when charge uctuations are signi—cant, the e ective spin Ham iltonian in the presence of the applied magnetic eld is modi ed beyond the direct Zeem an term and contains a linear coupling of the spin chirality to the external eld. This orbitale ect is important when considering the response of such insulator to the magnetic eld.

III. SPINON MEAN FIELD DESCRIPTION

${\tt A}$. ${\tt G}$ eneral setting

In Ref. 9 we considered the situation with no magnetic eld and argued that the four-spin ring exchanges stabilize the spin liquid state with spinon Ferm i surface. This state can be viewed as a Gutzwiller projection of a ferm ionicm ean eld state in which spinonshop on the triangular lattice. We performed a direct variational wave function study, and also provided an intuitive mean eld argument for the stabilization of this state.

A sim ilar mean eld treatment is pursued here to understand the elects of the magnetic eld. To simplify the discussion, we will focus on the $\rm J_2$ – $\rm J_3$ – $\rm J_4$ terms in H $_{\rm e}$. As mentioned earlier, the second—and third-neighbor Heisenberg exchanges are not expected to have signi—cantellect.

Each spin-1/2 is represented in terms of two \spinon" operators f_* ; f_* , with the occupancy constraint f_* .

In this representation, the $J_2-J_3-J_4$ H am iltonian reads

For clarity, we use the form of the J_3 term valid for general $^{\rm ext}$ (cf.Appendix A), even though we are interested in the case of small $^{\rm ext}_4$ 1.

We consider trial spinon hopping Hamiltonians 15,16

with generalhopping am plitudes $t_{rr^0}^{sp\,inon}=(t_{r^0r}^{sp\,inon})$. The occupancy constraints are implemented on average by the appropriate chemical potentials $_r$. The mean eld scheme that we use here is to evaluate the above exchange terms by contracting only the fermions with the same spin index. This approach can be justified in a large-N fermionic generalization, since any other contraction is down by a factor of 1=N . While the present N = 2 is not large, the other contractions do not introduce qualitatively new terms, and this scheme is expected to capture the relevant physics rather well. The mean eld energy is

Here $_{\rm rr^0}$ $h_{\rm r}^{\rm f'} f_{\rm r}$ i are link expectation values evaluated for one spin species, and the powers-of-two num erical factors appear from the spin summations. We also introduce phenomenological renormalization factors g_2 , g_4 , and g_3 , to keep us aware of the schematic character of the mean eld treatment. In a more quantitative treatment, these factors can be estimated by matching to numerical evaluations with the Gutzwiller-projected wave functions. This is done in Appendix B, where we not that g_2 1:7, g_4 8, and g_3 5, reproduce fairly well such direct trial wave function computations.

The mean eld energy is to be minimized over the trial spinon hopping amplitudes $t_{rr^0}^{spinon}$. We focus on the states that describe translationally invariant spin liquids. These are the projected Ferm is a state with

real hopping am plitudes and the so-called ux states with complex $t_{\rm rr^0}^{\rm spinon}$ realizing nontrivial internal" uxes through the hopping loops. The ux can be either uniform or have a staggered pattern. The projected Ferm is sea state is a special case with zero ux. Here, we are primarily interested in the uniform ux states since these are natural candidates in the presence of the external magnetic eld if one starts with the zero-ux state in the absence of the magnetic eld.

The mean eld energy per site for a uniform ux state is

Here, $_{rr^0} = j$ jexp (ia_{rr^0}) and int is the ux of the \internal values $_{rr^0}$ obtain the same ux pattern as the input amplitudes $t_{rr^0}^{sp\,inon}$. The gauge theory language is explained in Appendix C.

B. Review of the zero-eld case

Let us set consider $^{\rm ext}=0$ following Ref. 9. We not that for small $g_1J_4=(g_2J_2)$ 0:69, the lowest energy state has $_4==2$ ux through each triangle, while for larger ring exchanges the best state has zero ux (see Fig. 1). The corresponding num erical values of j j for the half-led triangular lattice are

It is known¹⁷ that ux states have large absolute value j j and therefore good Heisenberg energies. On the other hand, the ring exchanges are directly sensitive to the placket uxes and dislike any uxes, as can be seen from Eq. (12). This is why the zero- ux state is stabilized for large $J_4=J_2$. As explained in Ref. 9, we do not consider so-called dimer states even though form ally for xed g_1J_2 these have the lowest mean eld energy in the range $g_4J_4=(g_2J_2)$ 2.4. Our reasoning is that J_2 is xed, and to go from the mean eld evaluations to the projected wave functions, the renormalization factor g_2 is larger for the translationally invariant states.




FIG. 2: Mean eld numerical data for uniform ux states on the half-led triangular lattice. The gure shows the absolute value of the bond expectation value j j $\inf_{r^0}^{r_0} f_r ij$ as a function of the spinon lling factor with respect to the internal ux (one spin species is considered). The dotted line is the enveloping function Eq. (14), while the dash-dotted line is the full model function Eq. (17). The data plotted correspond to rather large int, but the same behavior is expected to continue for small uxes.

For later convenience, Fig. 2 shows the behavior of j jevaluated numerically for the triangular lattice ux states. It is useful to note the enveloping function for small uxes, which we not to be

for J_4 0:145 J_2 . From this and sim ilar comparisons we estimate that $g_4=g_2$ is roughly 4 to 5 { see Appendix B for more details.

In the $-(ET)_2Cu_2$ (CN) $_3$ compound, we have $J_4=J_2$ '0:3, which is not far from the regime where it would be advantageous to spontaneously generate such internal ux. We therefore reason that the spinon Ferm i sea state in the $-(ET)_2Cu_2$ (CN) $_3$ compound is rather susceptible to the internal ux generation. In particular, we expect some enhancement in the response to the external magnetic eld, to which we now turn.

The dierent ingredients have the following physical origin. The J_3 in the numerator represents the coupling of the magnetic eld to the internal gauge ux through the corresponding three-spin term. On the other hand, the J_4 in the denominator represents the stiness of the internal gauge eld that originates from the four-spin exchanges. For the $-(ET)_2Cu_2(CN)_3$ param eters, we estim ate $g_3J_3=(12g_4J_4j_0j)$ '0:7. The term in the square brackets in the denominator reects the enhanced susceptibility to the uxes discussed above; it can be also viewed as a suppression of the internal gauge eld sti ness. In particular, when this term goes to zero, the spinon Ferm i sea state becom es un stable to spontaneous ux generation even in the absence of the external eld. G iven the proxim ity of the competing states, it is therefore reasonable to estim ate this number to be of order one-half, so for the $-(ET)_2Cu_2(CN)_3$ m aterial we roughly estim ate

Thus, we conclude that due to the triangular ring exchanges and the proxim ity to the ux (or antiferrom agnetic) instability, the e ective orbital eld seen by the spinons is comparable and can even be larger than the applied magnetic eld!

We now examine the mean eld energy Eq. (12) more

carefully. In the presence of the static internal gauge ux, the spinon spectrum consists of Landau bands. For either spin species, the lling factor of these Landau levels is = $=(2 \frac{int}{4})$, and the ux states are special when is integer. Thus, the bond expectation value j jhas upward-pointing cusps at these uxes as can be seen in Fig. 2. The states with integer are therefore expected to be more stable. In fact, when the mean eld energy is m in im ized with respect to intusing the material param eters quoted above, we nd that the optim alsuch ux does not change continuously but instead goes through this discrete set corresponding to the integer lling of

Let us exhibit the structure of the discussed mean in a more transparent way. The reason behind the elementary manipulations below is to draw a connection with the so-called strong magnetic interaction e ects in the magneto-oscillation studies in metals. These are reviewed in Appendix D, which contains useful interpretations of the expressions below. At the expense of being repetitious, what follows will allow us to estimate appropriate e ective param eters, which we will then use in our discussion of the spinon system at nite temperature.




FIG.3: Result of the mean eld energy minimization with respect to in the presence of the magnetic eld at zero tem perature. The optim alspinon lling factor int is plotted vs the nominal lling factor ext for the applied magnetic eld. The gure shows a sequence of rst-order transitions with integer values. The parameters roughly correspond to our estimates for the -(ET)2Cu2 (CN)3 from Sec. II, with appropriate renormalization factors from Appendix B. The dotted line shows the overall trend Eq. (15). The data plotted correspond to unrealistically large elds, but the same behavior is expected to continue for smaller laboratory elds.

where we separate the envelope Eq. (14), which is the band structure e $\,$ ect, and the oscillating part $\,$ osc due to the discreteness of the spinon Landau levels. The latter is well approximated by the familiar expression for the oscillating piece of the energy of the continuum Landau problem,

Here is de ned in Eq. (15); $y = 1 + gJ_2 = (16g_4J_4j_0f)$; 2y=(1 2cy). We rem ind that the energy here is per triangular lattice site, and see that 4 is the corresponding measure of the sti ness of the internal gauge eld see Appendix C. We also see explicitly how the magnetic eld acts to induce the internal gauge ux. On the other hand, using Eq. (17), we can interpret osc as an oscillating piece of som e ferm ion kinetic energy of spinful ferm ions hopping on the triangular lattice with amplitude t_{spinon}. It is useful to rem ember that we are analyzing the mean eld energy Eq. (12), and from this we are separating out what looks like an e ective spinon kinetic energy. The division of the mean eld energy into the gauge eld and the spinon parts is somewhat arbitrary, but represents a useful separation by the character of their dependence on int. In particular, we can now see the sim ilarity with Eq. (D3) and thus connect with the studies of magnetic interaction e ects in metals sum m arized in Appendix D. The above equations constitute the main result of this section.

To emphasize the variational energetics character of the mean eld procedure and the intrinsically common origin of the gauge eld and the spinon parts, we do not use such suggestive separation explicitly in the treatment below. A formal condition for an extrem um of $_{\rm m}$ f reads

which can be solved graphically by plotting the right-hand side as a function of int and seeking crossings with the horizontal line ext. This can be compared with Eq. (D4) in Appendix D. Here we remark that the oscillations of the \magnetization" M osc have roughly the saw tooth pattern familiar in two dimensions, with the amplitude which can be estimated from the data in Fig. 2. Note that the internal gauge eld sti ness is implicitly included in M osc, cf. Eq. (D4). We estimate that the corresponding M osc jn ax is as large as 1. In particular, we conclude that at zero temperature essentially each oscillation period supplies such graphical solutions of Eq. (24). Solutions are found even in the region with

1 (corresponding to very large internal ux) even when ext is small. Remembering the cusps in j j this means that each integer lling gives a locally stable minimum, which we can also verify directly by plotting mf as a function of int. The globalm inimum is given by an integer lling near that corresponding to Eq. (15). This provides a more complete description of our direct minimization result Fig. 3 at zero temperature, and is useful when generalizing to nite temperature.

The multiple solutions signify an instability of the ux states with continuously varying $^{\rm int}$. The instability occurs whenever the derivative of the right-hand side of Eq. (24) becomes negative:

This is just a more form al restatement of our discussion in the preceding paragraph: given 1 osc j_{h ax} 1, the instability condition is satis ed all the way to very large internal elds corresponding to 1. This is unlike the ordinary metals where the largest magnetic eld that allows such an instability is typically much smaller. As explained in Appendix D, the origin of this is the very small internal gauge eld sti ness, which is implicitly built into the numerical estimate 1 osc j_{h ax} 1 in the above formalism. However, such large numerical value of 1 osc j_{h ax} is unavoidable since it is the same mean eld energetics that stabilizes the Ferm is a state and determines both the gauge eld sti ness and the spinon kinetic energy.

D. Mean eld description at nite temperature

The preceding analysis was performed at zero temperature. Also, we ignored the Zeem an spin coupling to the magnetic eld. We rst note that for integer Iling the spinon spectrum has a gap given roughly by the corresponding cyclotron frequency. Such an integer quantum Hall state of spinons is in fact a chiral spin liquid¹⁸ induced by the magnetic eld, and the above treatment suggests a sequence of rst-order transitions stepping through such states rather than a continuous variation of int (see Fig. 3). Finite temperature smears the elects of the discreteness of the Landau levels, and the instability of the ux states with continuously varying int becomes weaker.

To proceed more quantitatively, we again use mean eld and apply standard magneto-oscillation results at nite-tem perature in two dimensions supplemented with our estimates of the elective parameters such as the cyclotron frequency Eq. (19). Thus, we can roughly incorporate the elects of the nite temperature and the Zeem an spin splitting by multiplying the oscillating magnetization M $^{\rm osc}$ by the corresponding suppression factors $R_{\rm T}$ and $R_{\rm S}$ from Eq. (D2) in Appendix D. The instability condition Eq. (25) then reads

For a xed external magnetic eld, we can use Eq. (15) to estim ate the corresponding spinon lling in the internal gauge eld. Focusing on the tem perature suppression factor, the hom ogeneous ux state becomes unstable when the tem perature is below

For high lling factors and using $M^{\circ c}_{j_n ax}$ 1, we estim atewith logarithmic accuracy x 2 log(). We give numerical estimates for the $-(ET)_2Cu_2(CN)_3$ material in Sec. IV.

Let us brie y think what happens beyond the mean eld. The chiral spin liquid states are stable topologically ordered phases at zero temperature, but strictly

speaking do not survive on long length scales at any nonzero tem perature in two dimensions. Instead, the spin system can be continuously connected to the featureless high-tem perature param agnet. In this case, we interpret the mean eld estimate Eq. (27) as delineating the temperature-eld regime in which the spin system becomes particularly \soft" in its response to the magnetic eld. It is also possible for a T = 0 rst-order transition between chiral states to extend to small nite tem peratures even though the param agnetic phases on both sides do not have a symmetry or topological distinction anymore. Note also that in the above schematic treatm ent, we have not considered the tem perature dependence of the e ective param eters For example, in the form almean eld, the e ective Epinon decreases with tem perature and disappears above T 50 100K for the $-(ET)_2Cu_2(CN)_3$ param eters (this can be viewed as a crude estim ate of the tem perature below which quantum spin correlations develop). Such detailed questions on the behavior of the spin system at nite temperature rem ain open for future investigations.

${\tt E}$. Inhom ogeneous state in the physical system at low tem peratures

We conclude the mean eld description with a discussion of some experimentally relevant aspects. Our analysis indicates the instability of the hom ogeneous ux states with continuously varying int at temperatures below T_{instab}.. Throughout, we treat the external magnetic eld as xed, and the instability represents a strong nonlinear back action of the spinons onto the internal gauge eld in the presence of such xed external source. Treating the magnetic eld as xed is justi ed since, as we describe in Appendixes C and D, the electrom agnetic eld is six to seven orders of magnitude more stithan the internal gauge eld and will not adjust itself to the electronic system until much lower tem peratures. Of course, there is a slight e ect on the local magnetic eld depending on the state of the spin system, but for example for ux mean eld state we estimate the orthe uniform bital contribution to be one order of magnitude smaller than the Pauli spin contribution. 19 The physical setting therefore has xed ext. In particular, we do not have access to di erent sam ple \dem agnetization geom etries" considered for the magnetic interaction phenomenon in conventional metals 11,12 { the internal gauge eld does not \leak out" of the sam ple.

In such setting in an ideal crystal system at zero temperature, we predict a sequence of rst-order transitions, 20 but each phase is still a uniform ux state with the corresponding integer. This situation, however, is highly susceptible to large-scale imperfections of a real system, and an outcome with many domains is likely. A nother important consideration is the possible crystal mosaic in the sample, since the discussed orbitale ects are determined by the component of the magnetic eld

 ${\rm H}_{\,?}$ norm alto the two-dimensional plane. A detailed characterization of the possible inhomogeneities clearly requires much more material knowledge.

IV. APPLICATION TO -(ET)2CU2(CN)3

Throughout, we have used the $-(ET)_2Cu_2(CN)_3$ param eters to motivate various approximations and make the otherwise formal discussion more physical. Here we want to focus more on the material itself and collect the relevant numbers in one place.

We rst want to point out that the material is rather clean. Thus, we estimate $k_F \; l \; \& \; 50$ in the metallic phase at 0.8 GPa. Shubnikov-deHaas (SdH) oscillations are observed at temperatures around 1.5 K, which is another indication of the material quality. The SdH signal is consistent with the Fermi surface and the one-band model description. For reference, the Landau level ling factor for the $-(ET)_2Cu_2\,(CN)_3$ material is given by $^{\rm ext} = 3595 = H$ [Tesla]. In Appendix D, we estimate the characteristic magnetic eld $H_0 = 5$ T and temperature $T_{\rm dm} = 0.16$ K for the magnetic interaction instability 22,23,24 in this metallic phase coupled to the electromagnetic eld.

Turning to the spin liquid phase, in Ref. 9 we used the low-tem perature susceptibility to estim ate the spinon hopping am plitude $t_{\rm spinon}$ ' 350 K . We can also use the mean eld estim ate Eq. (23), which gives a smaller but reasonable value $t_{\rm spinon}$ ' 100 K . Using Eqs. (19) and (27), and $^{\rm int} = ^{\rm ext} = ^{\rm with}$ ' 1 2, we obtain the characteristic tem perature at B = 8 T to be $T_{\rm instab}$: ' 1 2 K . Above this tem perature, we expect uniform ux state. ¹⁹

We now sum marize qualitative predictions for the inhom ogeneous state induced by large magnetic elds at low tem peratures below Tinstab. As discussed in the paragraph following Eq. (24), the characteristic eld H_0 for the spinon system is beyond any practical elds, and we predict that in the laboratory elds the instability tem perature will increase roughly linearly with the applied eld, Eq. (27). Manifestations of this instability become more pronounced with increasing eld and decreasing temperature. Since this is an orbitale ect, we expect distinction for elds perpendicular and parallel to the conducting planes. One consequence of this scenario is that magneto-oscillation measurements in their usual sense cannot be used to detect the spinon Ferm i surface in the spin liquid state considered here. This is because the regim e where such oscillations can become visible is likely preem pted by the instability of the homogeneous state. Since the instability is in some sense an extreme m anifestation of the magneto-oscillations, conditions of the magnetic eld uniform ity and the crystal mosaic are im portant experim ental considerations, as discussed in Sec. IIIE. O ther m easurem ents in the spin liquid phase perform ed in high magnetic eld and at low temperature may also require more careful interpretation. Finally,

som e di erent direct probes of the Ferm i surface such as magneto-acoustic resonance that are less sensitive to the eld hom ogeneity may still be possible.

V. CONCLUSIONS

The main content of this work was summarized in the introduction, and possible application to the (ET)2Cu2 (CN)3 experiments including some numerical estimates was discussed in the preceding section. Here we want to conclude with a more general point. W hile there has been a signi cant progress in the theoretical understanding of exotic quantum phases, the lack of the material evidence is viewed as a major obstacle. Recently, several candidate spin liquid systems have been found in frustrated spin system $s_i^{1,25,26}$ of which the - $(ET)_2Cu_2(CN)_3$ is a very prom ising example. This materialm otivated and guided the detailed theoretical considerations in the present work on the magnetic eld response of the spin liquid state stabilized near the Mott transition. Without such a guide, the proposed e ects would be hard to anticipate. More work matching experim ent and theory focusing on material properties will likely be fruitful in developing our understanding and in further pursuits of such unusual quantum phases.

One speci c motivation for the present study has been the anomalous NMR line broadening reported in Refs. 3 and 5. While some of our expectations for the inhom ogeneous state at low temperatures resemble the experim ental phenom enology, the gradual developm ent of the broadening starting from rather high tem peratures and also the magnitude of the inhomogeneous elds are m ore suggestive of a stronger impurity mechanism. Experim ents in parallel eld can further clarify the role of the impurity and orbitale ects. The main predictions in the present paper of the spinon orbital eld and the fragility of the spinon Ferm isea state in the applied magnetic eld represent intrinsic response of the spin liquid and are expected to play an important role at low temperatures. It is hoped that our proposals will stimulate further experim ental and theoretical questions.

Note added: Recently, the author learned of Ref. 29, which also discusses the coupling of the external eld to the spin chirality and considers possible elects in some

di erent contexts for Hubbard systems with triangles.

For exam ple, the three-spin exchange in term softhe ferm ions is $P_{123}=(c_1^{y}\ c_1\)(c_2^{y}\ c_2\)(c_3^{y}\ c_3\)$, and acts on the spins as $P_{123}:j_1;_2;_3i!:j_3;_1;_2i$. To simplify the nal expressions, we used the identities Eqs. (6,7) specic to the spin-1/2 case.

The sum in H $_2$ is over all bonds of the lattice. The sum in H $_3$ is over all three-site loops, where each group of three sites connected by the links enters the sum precisely once. Sim ilarly, the sum in the second line for H $_4$ is over four-site loops, which are counted with no base point or orientation. Finally, the primed sum in the rst line for H $_4$ is over distinct sites 1;2;3 with nonzero t_{12} and t_{13} (each contribution will therefore appear two times). Eq. (3) in the main text is obtained by specializing to the isotropic triangular lattice.

Note that the complex phase of a loop product of $t_{\rm rr^0}$ measures the ux of the magnetic eld through the loop. Without such uxes, H_3 vanishes and after some transformations we reproduce the result of Ref. 27.

As a side remark, we observe that in the absence of three-site loops, there is no linear coupling to the magnetic eld to this order in t=U. One can also show that for a half-lled Hubbard model on a bipartite lattice, the effective Hamiltonian in the presence of the magnetic eld can only contain terms that are even in the applied eld.

Finally, it is also useful to give an expression for an elective local electrical current operator. In the original Hubbard model, the current on a link 1! 2 is $I_{1!} = \frac{e}{i^2} (t_{12} c_1^V c_2)$ H x:). Upon the canonical transform ation to the lowest nontrivial order in t=U, the current operator becomes in terms of the spin variables

W e can use this expression e.g. to estim ate the physical magnetic eld produced by the underlying orbital motion in the chiral spin states discussed in the main text. 19

APPENDIX B:RENORMALIZED MEAN FIELD




FIG. 4: Expectation value of the two-spin exchange P_{12} on each link evaluated in the Gutzwiller-projected uniform—ux state. The data is for commensurate—uxes on triangular lattice cuts with sizes 36—12 (squares) and 48—12 (circles) with periodic boundary conditions. The line shows the renormalized mean—eld estimate with q=1.7 (the mean—eld data is obtained using Fig. 2). Since we are interested only in the variation with—int, a constant o—set is added to the mean—eld values.




FIG.5: Sam e as in Fig.4, but for the ring exchange operator P_{1234} + H \approx around a rhom bus.

In this appendix, we estimate the renormalization factors g_2 , g_4 , and g_3 used in the mean eld treatment in Sec. III. We consider the uniform ux states and measure the relevant expectation values of P_{12} , $(P_{1234} + H \text{ c.})$, and i $(P_{123} + H \text{ c.})$ in the Gutzwiller-projected wavefunctions. The variation of the expectation values with int is matched with the corresponding mean eld estimates see Eq. (11). Figures 4, 5, and 6 show this matching and are self-explanatory. We note that the Gutzwiller wavefunction evaluations can be performed only for small system sizes and large values of int. However, we expect the same trend to remain for small uxes as well. For small uxes, an analytical mean eld treatment is then performed (Sec. III) using the estimated renormalization

APPENDIX C:SPINON-GAUGE THEORY

In the main text, we often use the gauge theory language, 14 and it is useful to state the connection more explicitly. We follow the treatment of Ref. 10 as an example. One starts with a slave-rotor representation $c_r^V = f_r^V e^{i_r}$ of the Hubbard model and obtains the following excitive theory for the spinons f_r and chargons




FIG. 6: Same as in Fig. 4, but for the three-spin operator $i(P_{123} \ H \ r:)$ around an elementary triangle. The orientation of the triangular loop $1 \ ! \ 2 \ ! \ 3 \ ! \ 1$ coincides with that of $\inf_{123} = \inf_{4} I$.

The imaginary time is continuous, while the space lattice is retained to indicate similarity of the spinon part with that in Eq. (10). The spinons and the chargens are coupled with opposite charge to the internal gauge eld (a; a^0), whose spatial components represent uctuations of the phase of the spinon hopping eld, $\frac{spinon}{rr^0} = t_f e^{ia_{rr^0}}$, while the temporal a_r^0 implement the slave-particle constraints. The coupling to the external eld A^{ext} is included schematically by assigning the electron charge to the chargen eld.

Assuming the chargons are gapped and integrating them out, we are left with the spinon-gauge system where the gauge $\,$ eld now has some sti ness ,

Ourm ean eld treatment Eq. (11) roughly corresponds to considering the spinon-gauge system with static but possibly spatially varying gauge eld a. Observe that the internal gauge eld obtains its sti ness after integrating out the massive chargons, and also observe how the magnetic eld couples to the internal gauge eld. This is similar to our discussion of the elective spin Hamiltonian, where the crucial ingredient is also charge uctuations. Note however that the elective Hamiltonian

treatm ent is m ore explicit. Thus, the gauge eld sti ness originates primarily from the four-spin ring exchanges, while the coupling to the magnetic eld comes from the three-spin processes { see Eqs. (11) and (20). In the schem atic gauge theory derivation this distinction is not being made. The result = 1 of such schematic treatment roughly agrees with our estimate using Eq. (15), but this is rather fortuitous { e.g., as we mention towards the end of Appendix A, in a Hubbard model on a lattice with no elem entary triangles the linear coupling of the internal gauge ux to the applied magnetic eld does not appear even to order $t^4=U^3$. To capture the detail present in our Eq. (15) in the gauge theory approach, one needs to go back to the original slave particle rewriting and carefully consider saddle point conditions and integrations overm assive elds when deriving Eq. (C1) in the presence of the external eld. As an example, the suppression of the gauge eld sti ness due to the proxim ity to the ux phase discussed after Eq. (15) originates from som e m odes which becom e soft near the ux phase. The e ective spin Ham iltonian approach is more transparent in this respect and also allows quantitative estimates of the physical quantities.

In particular, from Eq. (22) we quote the internal gauge eld sti ness in terms of the energy cost per triangular lattice site, $_{int} = _{4} (_{4}^{int})^{2}$,

This can be compared with the corresponding stiness of the physical electrom agnetic (EM) eld in the bulk of the $-(ET)_2Cu_2(CN)_3$ compound, $_{EM} = VB^2 = (8)$ $_{EM} \left(\frac{^4}{^4} \right)^2$,

Here V = 850:6 A 3 is the 3d volum e per triangular lattice site, A $_4$ = 28:76 A 2 is the area of an elem entary triangle, and $_4^{\rm ext}$ = eB A $_4$ = (~c) is the appropriate dimensionless external ux.

We therefore conclude that the bare internal gauge eld sti ness is 10 times smaller than the electromagnetic eld sti ness. As we discuss in the following Appendix D, this makes a dramatic di erence in the response of the spinon-gauge system to the external eld compared with that of electrons in a conventional metal.

APPENDIX D: ANALOGY W ITH MAGNETIC INTERACTION EFFECTS IN METALS

The purpose of this appendix is to clarify the status of our mean eld treatment in Sec. III by pointing out the analogy with the so-called magnetic interaction elects in the study of magneto-oscillations in metals. This material is available in textbooks. The presentation below

parallels some of our discussion in Sec. III in a dierent language, but we hope that the reader will bene t from this duplication.

For ease of reference, we stw rite down the oscillating part of the magnetization of a two-dimensional electron gas in a eld H at a nite temperature T:

Only the main harm onic is shown. The magnetization is given per unit area, and n is the 2d electron density (including spin); m is the cyclotron mass; F = n c~=e so that F = H = i is the Landau level lling for each spin species. The suppression factors R_T and R_S due to nite temperature and Zeem an spin splitting are

where g is the spin g-factor.

The essence of the magnetic interaction elects is the back action of the electrons onto the electromagnetic eld, which can be signicantly enhanced by the oscillating character of M . Specically, consider fermions coupled to a dynamical gauge eld a in the presence of the external eld $A^{\rm ext}$, with the Lagrangian density $L_{\rm f}+L_{\rm a}$ given by Eqs. (C1,C2). The microscopic magnetic eld is b=r a and the external eld is $H^{\rm ext}=r$ $A^{\rm ext}$. In the case of electrons, a represents the physical electromagnetic eld and is the appropriate EM stiness; e.g., in a 2d layered material the magnetic eld energy per unit area is d $b^2=8$ where d is the spacing between the layers.

The key observation is that electrons see the average m icroscopic eld B because the typical Larm or orbits are large. The mean eld treatment is then to assume a static but possibly spatially varying such eld B (r) and solve the Landau problem for electrons moving in this eld. The mean eld functional including the energy of the gauge eld $is^{1,12,13}$

where $_{\rm ferm}$ (B) is the free energy density for ferm ions in the static eld B (r). The mean eld functional is to be minimized with respect to B (r). If we look for a uniform solution, we obtain

Eq. (D 4) is to be solved for B . It is custom ary to plot the right hand side as a function of B and seek the intersection with the horizontal line H $^{\rm ext}$. When this is

unique, the corresponding uniform $\$ eld is the sought for stable solution. However, M $\$ (B) contains an oscillating piece, and if we $\$ nd that

then the solution is no longer unique, which signals an instability. Note that while the amplitude of the oscillations $M_{jh} \propto (T=0) = n e^{-2} (2m c)$ is small in metals compared to typical H, the amplitude of the \susceptibility" $M_{jh} \approx 0$ obtains an additional factor $F=H^2$, and the instability condition can be satisfed at low temperatures and not too large elds. A firer simple transformations, the instability condition reads

where k_F is the Ferm i wavevector. When this condition is satisfied, the gain in the ferm ion energy when the eld B is adjusted to obtain integer Landau level lling overweights the magnetic eld energy cost. Since R_T and R_S do not exceed 1, the above equation sets the maximal value H $_0$ for the instability to occur at zero temperature. On the other hand, at a nite temperature, we also require the Landau levels to be resolved, which is determined by R_T . Roughly, for elds of order H $_0$, we require $2\ ^2T$. $\sim !_{\, C}$ with ! $_{\, C}$ set by H $_0$.

The 2d Landau problem for free electrons can be solved beyond the above single-harm onic treatm ent, and R ef. 22 contains such expressions for the phase boundary of the instability region. For example, the eld $\rm H_0$ is determined from

Ref. 22 also contains form ulae directly appropriate for the layered organic m aterials. As a numerical application, consider the metallic phase of the $-(\text{ET})_2\text{C}\,\text{u}_2\,(\text{CN})_3$ compound obtained under pressure of 0:76 GPa, in which magneto-oscillations were reported in Ref. 21. Using $_F$ 100m eV, the cyclotron mass ratio $_c$ = m = m $_e$ 4, the inter-layer spacing d = 14:84 A, and ignoring sample demagnetization elects, we estimate H_0 5 T; the peak temperature on the phase boundary of the instability regime is estimated to be T_{dm} 0:16K.

Various aspects of what happens once the homogeneous state becomes unstable are discussed in textbooks. There is also a growing recent literature on the observation of Condon domains in metals, see Ref. 24 and references therein.

The point that we want to make is that our mean eld treatment in Sec. III has the same character as the described treatment of the magnetic interaction elects in metals. Thus, our mean eld energy Eq. (20) can be readily identified with Eq. (D3), while the self-consistency condition Eq. (24) corresponds to Eq. (D4). Clearly, the treatment of the magnetic interaction elects requires taking into account the energy of the gauge eld. This is

im plicit in our mean eld treatment of Sec. III. At this mean eld stage, we do not need to disentangle the gauge eld energy from the total energy and worry about the emergent nature of the gauge eld, and this makes the procedure more simple.

An important dierence between the spinon-gauge system and the electrons in metals coupled to the EM eld is the very small gauge eld sti ness in the spinon case, as we estimated in Appendix C. Because of this, the instability condition is satised more readily in the spinon-gauge system. Thus, because the internal gauge eld sti ness is 10° 10° times smaller while the kinetic parameters of spinons are not far from those of electrons, the above estimate of H $_0$ is to be multiplied by a factor of order 10° . This is an impractically large eld, and the

spinon-gauge system in the laboratory is in the regime of much smaller elds. In this regime, the temperature at which the instability occurs in a given eld H can be estimated as

This tem perature depends on the sti ness only logarithmically, but as numerical estimates in Sec. III show, even under the logarithmic the seven orders of magnitude difference in the relevant sti nesses produces a much wider temperature range for the instability in the spinon-gauge system.

O ther chiral spin liquid states such as a Gutzwiller-projected d+ id state can also improve the trial energy in the presence of the magnetic eld. The present work focuses on the ux states for their simplicity, but the detailed energetics including other competing states has not been explored.

As a crude estimate of the electron agnetic eld, we can calculate the orbital magnetic moment of an elementary triangle to be $\operatorname{Im}_4^{\operatorname{orb}} i = \frac{\operatorname{eh}_4}{-\operatorname{c}} J_3 \operatorname{hi}(P_{123} + \operatorname{H.c.}) i$, where we used the expression Eq. (A 7) for the electrical current operator. Using the mean eld estimates Eqs. (11, 15) (see also Fig. 6), we evaluate that in the eld of 8 Tesla such orbital magnetic moment per site is of the order of 10 4 B. For comparison, this applied eld induces spin magnetic moment roughly equal to 3 10^3 B per site, which is more than an order of magnitude larger; to make the latter estimate we used the experimental lowtem perature susceptibility of $= 2 \cdot 10^4$ emu/mol from Refs. 1-3.

An interesting possibility discussed in the literature (see e.g. Ref. 12 and references therein) is a \true" inhom ogeneous ux state that would be inhom ogeneous also in an ideal crystal and in any geom etry. The analysis predicting a sequence of rst-order transitions assumes that at such transition the energy of a domain wall between the two neighboring phases is positive. If, on the other hand, the domain wall energy turns out to be negative, then the different phases want to mix and instead the true ground state has an inhom ogeneous ux distribution, possibly modulated at some wavevector. This interesting scenario, which is usually believed to be less likely, has not been explored in the present work.
