Spin-3 Chromium Bose-Einstein Condensates

We analyze the physics of spin-3 Bose-Einstein condensates, and in particular the new physics expected in on-going experiments with condensates of Chromium atoms. We rst discuss the ground-state properties, which, depending on still unknown Chromium parameters, and for low magnetic elds can present various types of phases. We also discuss the spinor-dynamics in Chromium spinor condensates, which present signicant qualitative dierences when compared to other spinor condensates. In particular, dipole-induced spin relaxation may lead for low magnetic elds to transfer of spin into angular momentum similar to the well-known Einstein-de Haas elect. Additionally, a rapid large transference of population between distant magnetic states becomes also possible.

Within the very active eld of ultra cold atomic gases, multicom ponent (spinor) Bose-Einstein condensates (BECs) have recently attracted a rapidly growing attention. Numerous works have addressed the rich variety of phenomena revealed by spinor BEC, in particular in what concerns ground-state and spin dynamics [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18]. The rst experiments on spinor BEC were performed at JILA using mixtures of 87Rb BEC in two magnetically con ned internal states (spin-1=2 BEC) [10]. Optical trapping of spinor condensates was rst realized in spin-1 Sodium BEC at MIT [11] constituting a major breakthrough since, whereas magnetic trapping con nes the BEC to weak-seeking magnetic states, an optical trap enables con nem ent of all magnetic substates. In addition, the atom s in a magnetic substate can be converted into atoms in other substates through interatom ic interactions. Hence, these experiments paved the way towards the above mentioned fascinating phenomenology originating from the spin degree of freedom. Various experim ents have been realized since then in spin-1 BEC, in particular in 87 Rb in the F = 1 manifold. It has been predicted that spin-1 BEC can present just two different ground states phases, either ferrom agnetic or polar [1]. In the case of $F = 1^{87}Rb$ it has been shown that the ground-state presents a ferrom agnetic behavior [13, 14, 19]. These analyses have been recently extended to spin-2 BEC, which presents an even richer variety of possible ground-states, including in addition the so-called cyclic phases [5, 6]. Recent experiments have shown a behavior compatible with a polar ground-state, although in the very vicinity of the cyclic phase [13, 19]. Recently, spin dynamics has attracted a major interest, revealing the fascinating physics of the coherent oscillations between the di erent components of the manifold [12, 13, 14, 15, 16, 17].

Very recently, a Chromium BEC (Cr-BEC) has been

achieved at Stuttgart University [20]. Cr-BEC presents fascinating new features when compared to other experim ents in BEC.On one hand, since the ground state of 52 Cris 7 S $_{3}$,Cr-BEC constitutes the rst accessible exam ple of a spin-3 BEC. We show below that this fact may have very important consequences for both the groundstate and the dynamics of spinor Cr-BEC.On the other hand, when aligned into the state with magnetic quantum num ber $m = 3_{I}^{52}$ C r presents a magnetic m om ent = 6 $_{\rm B}$, where $_{\rm B}$ is the Bohr magneton. This dipolar m om ent should be compared to alkali atom s, which have a m axim um m agnetic m om ent of 1 $_{\rm B}$, and hence 36 tim es smaller dipole-dipole interactions. U ltra cold dipolar gases have attracted a rapidly growing attention, in particular in what concerns its stability and excitations [21]. The interplay of the dipole-dipole interaction and spinor-BEC physics has been also considered [7, 8]. Recently, the dipolar e ects have been observed for the rst time in the expansion of a Cr-BEC [22].

This Letter analyzes spin-3 BEC, and in particular the new physics expected in on-going experim ents in Cr-BEC. A fter deriving the equations that describe this system, we focus on the ground-state, using single-mode approximation (SMA), showing that various phases are possible, depending on the applied magnetic eld, and the (still unknown) value of the s-w ave scattering length for the channel of total spin zero. This phase diagram presents certain di erences with respect to the diagram rst worked out recently by Diener and Ho [23]. In the second part of this Letter, we discuss the spinor dynam ics, departing from the SMA. The double nature of Cr-BEC as a spin-3 BEC and a dipolar BEC is shown to lead to signi cant qualitative di erences when compared to other spinor BECs. The larger spin can allow for fast population transfer from m = 0 to m = 0sequential dynamics as in $F = 2^{87}Rb$ [13]. In addition, dipolar relaxation violates spin conservation, leading to

rotation of the di erent com ponents, resembling the wellknown Einstein-de Haas (EH) e ect [24].

In the following we consider an optically trapped Cr-BEC with N particles. The Ham iltonian regulating Cr-BEC is of the form $\mbox{H}^{\hat{}} = \mbox{H}^{\hat{}}_{0} + \mbox{V}_{\text{sr}} + \mbox{V}_{\text{dd}}.$ The singleparticle part of the H am iltonian, \hat{H}_0 , includes the trapping energy and the linear Zeem an e ect (quadratic Zeeman e ect is absent in Cr-BEC), being of the form

where $\frac{^{^{\prime}}}{^{^{\prime}}}$ ($\frac{^{^{\prime}}}{^{^{\prime}}}$) is the creation (annihilation) operator in the m state, M is the atom ic mass, and $p = g_B B$, with g = 2 for ^{52}Cr , and B is the applied magnetic eld.

The short-range (van der W aals) interactions are given by \hat{V}_{sr} . For any interacting pair with spins $S_{1;2}$, \hat{V}_{sr} conserves the total spin, S, and is thus described in term s of the projector operators on dierent total spins P's, where S = 0, 2, 4, and 6 (only even S is allowed) [1]:

where $g_S = 4 h^2 a_S = M$, and a_S is the s-wave scattering length for a total spin S. where \hat{P}_0 (r) = $\frac{1}{7}^P$ m;n (1)ⁿ⁺ⁿ n m n n n n, and c_0 = (11g + 81g₄ + 7g₆)=77, c_1 = (g₆ g₂)=18, c_2 = g_0 + ($55g_1$ + $27g_4$ $5g_5$)=33, c_3 = g_2 =126 g_i =77+ g_6 =198. For the case of 52 Cr [25], $a_6 = 112a_B$, where a_B is the Bohr radius, and $c_0 = 0.65q_6$, $c_1 = 0.059q_6$, $c_2 =$ $g0 + 0.374g_6$, and $c_3 = 0.002g_6$. The value of a_0 is unknown, and hence, in the following, we consider dierent scenarios depending on the value of go=go. Note that Eq. (3) is similar to that obtained for spin-2 BEC [5, 6], the main new feature being the c_3 term, which introduce qualitatively new physics as discussed below.

The dipole-dipole interaction \hat{V}_{dd} is of the form

where $c_d = 0$ $\frac{2}{B}$ $g_S^2 = 4$, with 0 the magnetic permeability of vacuum, and $e = (r r^0) = r r^0$. For 52 Cr




FIG. 1: Phase diagram function of $g_0 = g_6$ and $g_0 = g_6$, where $p = 2q_S B = N$.

Note that contrary to the short-range interactions, \hat{V}_{dd} does not conserve the total spin, and may induce a transference of angular mom entum into the center of m ass (CM) degrees of freedom.

We rst discuss the ground-state of the spin-3 BEC for dierent values of g_0 , and the magnetic eld, p. W e consider m ean-eld (MF) approximation \hat{m} (r) ' \overline{N}_{m} (r). In order to $\sin p$ lify the analysis of the possible ground-state solutions we perform SMA: $_{m}$ (r) = (r) m, with drj (r) $j^2 = 1$. Apart from spinindependent term s the energy per particle is of the form:

Let us consider a magnetic eld in the z-direction. Hence, the ground-state magnetization must be aligned with the external_p eld, and $f_+ = f = 0$. where p = 2p=N, and $c_1 = c_1$ g=2+ p = (7) 16 = 5 $0 c_d = .$ Since c_d c_1 , dipolar e ects are not relevant for the equilibrium discussion. We will hence set 0 = 0.

We have minimized Eq. (7) with respect to $_{\rm m}$, under the constraints $\tilde{j}_{m} \tilde{j}_{m} \tilde{j} = 1$ and $f_{+} = 0$ [26]. Figs. 1 shows the corresponding phase diagram, which although in basic agreem ent with that worked out recently in Ref. [23] presents certain di erences in its nal form. For the phases discussed below = 0 [27]. For su ciently negative q_0 the system is in a polar phase P = (c; 0; 0; 0; 0; 0; s), with c cos, and s sin. This phase is characterized by f_z ' $3p=p_c$ (p_c ' $6c_1$ ' 0:36), $(p=p_z)^2$, z = 9, and j = 0. The po-4 + 3 + 4 = 1lar phase extends up to $g_0=g_6=0.01$ for p=0. For su ciently large g_0 and p, $CY_{3;2} = (c;0;0;0;0;s;0)$ occurs. This phase is cyclic (s = 0) and it is characterized by $f_z = 3p - p_c$, $z' 6 + 3p - p_c$, and j j = 0. Both P and CY $_{3;2}$ continuously transform at p = p_c into a ferrom agnetic phase F = (1;0;0;0;0;0;0). For 0.04 < p $2q + 9c_3 CY_{3;2}$ becomes degenerated with the cyclic phase CY $_{1;2} = (0;0;c;0;0;0;s;0)$. The latter state diers from CY $_{3;2}$, since $_{z}$ = 2 For su ciently large g_0 and p < 0.04, a cyclic phase (CY $_{3; 1;1;3}$) of the form ($_{3}$;0; $_{1}$;0; $_{1}$;0; $_{3}$) occurs. Contrary to the other cyclic phases this phase is characterized by j j> 0 [28]. Finally for a region around $g_0 = 0$ an additional phase with j j > 0, is j > 0 is found. In this phase two possible ground states are degenerated [29], namely $S_{2;0;2} = (0; 2;0; 0;0; +2;0)$, and S $_{3; 1;1;3}$, which has a similar form as CY $_{3; 1;1;3}$.

For a CrBEC in a spherical trap of frequency ! in the Thom as Ferm i regim e, p = pc for a magnetic eld (in m G) B ' 125 N=10 5 !=10 3 2 $^{6-5}$. Hence, most probably, magnetic shielding seems necessary for the observation of non-ferrom agnetic ground-state phases. We would like to stress as well, that there are still uncertainties in the exact values of a2;4;6. In this sense, we have checked for a6 = 98aB, a4 = 64aB, and a2 = 27aB, that apart from a shift of 0.2 towards larger values of g0=g6, the phase diagram remains qualitatively the same.

In the last part of this Letter, we consider the spinor dynam ics within the MF approximation, but abandoning the SMA. The equations for the dynam ics are obtained by deriving the MFH am iltonian with respect to $_{\rm m}$ (r):




FIG. 2: $j_{m=2}(r)^{\frac{2}{p}}$ at !t = 40 (a) and 120 (b) for p = 0, $g_0=0$, ! $_z=1$ kH z, N = $p_1^2 \frac{0^4}{1}$ atom s, and (t = 0) = $_{m=3}$. The x and y axes are in $\frac{1}{1}$ units.

We consider for simplicity a quasi-2D BEC, i.e. a strong con nem ent in the z-direction by a harm onic potential of frequency $!_z$. Hence $_{\rm m}$ (r) = $_{\rm 0}$ (z) $_{\rm m}$ (), where $_{\rm 0}$ (z) = $\exp{[~~z^2=2l_z^2]^{\!\!\!\!2}}$ = $^{1=4^{\rm P}}$ $\overline{l_z}$, with l_z = $h=m=!_z$. We have then solved the 2D equations using Crank-Nicholson method, considering a harmonic con nem ent of frequency ! in the xy-plane. In 2D, $_{1:z}$ = 0, but these terms vanish also in 3D due to sym m etry, and hence the 2D physics is representative of the 3D one. The vanishing of 1;z is rather in portant, $since if (t = 0) = _{m = 3},$ 1;z is responsible for a fast dipolar relaxation (for ! t 1). Hence, a BEC with (t = 0) = 3 does not present any signi cant fast spin dynamics. However signicant spin relaxation appears in the long time scale, due to the 2; (r) term s. This is the case of Fig. 2, where we (t=0) = m = 3 [30].

One of the most striking e ects related with spin relaxation is the transference of spin into CM angular momentum, which resembles the famous EH e ect [24]. The analysis of this e ect motivated us to avoid the SMA in




FIG. 3: Population of $_{0;1;2;3}$ versus!t for $g_0=g_6$, p=0, and $(0)=_0$. Note the rapid growth of m=3 (arrow).

the study of the spinor dynam ics. In Figs. 2 we show snapshots of the spatial distribution of the m=2 component. Observe that the wavefunction clearly loose its polar symmetry, since spin is converted into orbital angular momentum. The spatial patterns become progressively more complicated in time.

The other special feature of Cr-BEC, namely the appearance of the c3 term can have signi cant qualitative e ects in the dynam ics both for short and for long time scales. The evolution at long time scale may present interesting features, as large revivals, and it will be considered in future work. Here, we would like to focus on the short-time scales, where the c3 term may produce fast transference from m=0 to the extremes m=3. The latter is illustrated in Fig. 3, where we consider $g_0 = g_6$. The population is initially all in them = 0 BO]. Contrary to the case of F = 2 in 87 Rb [13], there is at short time scales a jump to the extremes (the population of mis the same due to sym metry since p = 0). This large jum p is absent if $c_3 = 0$, and depends on the value of g_0 . In particular, if $g_0 = 0$ one obtains at short time scales a sequential population as for $F = 2^{87}Rb$ [13].

We nally comment on the dynamics if $p \in 0$. In the case of F=1 or F=2 $^{87}{\rm Rb}$, the dynamics is independent of p since the linear Zeem an elect may be gauged out by transforming $_{\rm m}$! $_{\rm m}$ ${\rm e}^{{\rm ipm}}$ $^{{\rm t}={\rm h}}$, due to the conservation of the total spin. In CrBEC the situation is very dierent, since the $_{\rm 1;z}$ and $_{\rm 2;}$ do not conserve the total spin, and hence oscillate with the Larm or frequency ! $_{\rm L}=$ p=h and 2! $_{\rm L}$, respectively. If ! $_{\rm L}$! one may perform rotating-wave approximation and eliminate these terms. Hence the coherent EH-like elect disappears for suiciently large applied magnetic elds.

In conclusion, spin-3 CrBEC is predicted to show different types of spin phases depending on a_0 and the magnetic eld. The spinor dynamics also presents novel features, as a fast transference between $_0$! $_3$, and the Einstein-de H aas-like transform ation of spin into rotation of the di erent components due to the dipole interaction.
