M agnetic order in the quasi-one-dim ensional spin 1/2 chain, copper pyrazine dinitrate

We present the $\,$ rst evidence of magnetic order in the quasi-one-dimensional spin 1/2 molecular chain compound, copper pyrazine dimitrate Cu (C $_4$ H $_4$ N $_2$) (NO $_3$) $_2$. Zero $\,$ eld muon-spin relaxation measurements made at dilution refrigerator temperatures show oscillations in the measured asymmetry, characteristic of a quasistatic magnetic eld at the muon sites. Our measurements provide convincing evidence for long range magnetic order below a temperature T_N = 107(1) mK. This leads to an estimate of the interchain coupling constant of $jJ^0 \! \not = \! k_B = 0.046$ K and to a ratio $jJ^0 \! \not = \! J \! = \! 4:4 \quad 10^3$.

Experimental studies of quantum many-body physics rely on the existence of simple and well characterised model systems. One such system is the linear chain Heisenberg antiferrom agnet (LCHAFM) which is described by the Ham iltonian

$$H = \begin{bmatrix} JS_{i}S_{i+1} + g_{B}B & \beta_{i}; \\ i \end{bmatrix}; (1)$$

where J is the nearest neighbour exchange constant along the chain and B is an applied magnetic eld. For B =0, the system will not show long-range magnetic order (LRO) for T > 0, but will display excitations in the form of S = 1=2 spinons which form a gapless, two-particle continuum [1, 2]. The magnetic eld B can tune the system through a quantum critical point (QCP) [3], (i.e. a zero temperature phase transition) at $B = \frac{1}{2}J=g_B j$ where the spin state becomes fully polarized [4, 5].

Experimental realisations of the LCHAFM have been made in several copper chain compounds, the most successful of which is copper pyrazine dimitrate Cu (C₄H₄N₂) (NO₃)₂ or CuP zN. This material has a relatively low value of J (= 10:3(1) K, determined from high

eld m agnetization and speci c heat m easurem ents6]), ensuring the QCP is at an experim entally accessiblem agnetic eld, but also a sm all ratio of intrachain to interchain exchange constants (estim ated as $jT^0=Jj < 10^4$ [7]), showing that the chains are well isolated. This has allowed the magnetic eld dependence of the excitations in the two-spinon continuum to be m easured and led to the identi cation of an extended critical state §], con-

m ing long-standing predictions of theoretical and num erical studies [9, 10, 11]. Three-dim ensional (3D) LRO has not been detected in CuPzN down to 70 mK on the basis of speci cheat m easurem ents [2]. However, as we shall dem onstrate, im planted positive m uons are a m uch m ore sensitive probe of 3D LRO than speci cheat for the case of very an isotropic m agnetic chains. In this letter we show for the rst time that CuPzN does indeed undergo a transition into a state of 3D LRO and provide an estimate of $jJ^0=J$ jwhich is larger than previously thought.

Zero- eld muon-spin relaxation (ZF + SR) measurements werem ade on a pow der sam ple of CuP zN using the LTF instrument at the Swiss Muon Source (S S), Paul Scherrer Institut, V illigen, Switzerland and the MuSR instrument at the ISIS facility, Rutherford Appleton Laboratory, UK. In a + SR experiment [13] spin polarised muons are implanted into the sam ple. The quantity of interest is the asymmetry A (t), which is proportional to the spin polarization of the muon ensemble.




FIG.1: ZF + SR spectra for CuPzN at three temperatures. (a) T = 36 mK: O scillations are observed in the asymmetry, characteristic of long-range magnetic order. A t is shown to Eq.(2). (b) T = 120 mK: the spectra are described by two components. A fast relaxing signal, probably due to the existence of a radical state, and a larger component, seen to be exponential in form. A t is shown to Eq.(3). (c) T = 405 mK: The fast relaxing component is still evident, although the larger component now shows a Gaussian form. A t is shown to Eq.(3).

Example ZF ⁺ SR spectra measured using a dilution refrigerator at S S are shown in Fig.1. In spectra measured below a temperature T = 110 mK oscillations in the asymmetry are observed (Fig.1(a)). These oscillations are characteristic of a quasi-static local magnetic

eld at the muon stopping site, which causes a coherent precession of the spins of those muons with a component of their spin polarization perpendicular to this local eld (expected to be 2/3 of the total polarization). The frequency of the oscillations is given by $_i = B_i=2$, where is the muon gyrom agnetic ratio (= 2 1355 M Hz T⁻¹) and B_i is the average magnitude of the local magnetic eld at the ith muon site. Any uctuation in magnitude of these local elds will result in a relaxation of the oscillations at low temperatures in CuP zN provides convincing evidence that this material is magnetically ordered below 110 m K.

Two separate frequencies were identi ed in the low temperature spectra, corresponding to two magnetically inequivalent muon stopping sites in the material. We note here that two muon sites have been observed in other copper pyrazine-based compounds [14]. The precession frequencies, which are proportional to the internalmagnetic eld as experienced by the muon, may be

viewed as an e ective order parameter for these systems. In order to extract the temperature dependence of the frequencies, the low temperature data were tted to the functional form

$$A (t) = A_{1} \exp(_{1}t) \cos(2 _{1}t + _{1}) + A_{2} \exp(_{2}t) \cos(2 _{2}t + _{2}) + A_{3} \exp(_{1}t) + A_{bq} \exp(_{bq}t); (2)$$

where $A_3 \exp($ t) accounts for the contribution from those muons with a spin component parallel to the localmagnetic eld. The term $A_{bg} \exp($ $_{bg}t)$ re ects the small signal from those muons which stop in the silver sample holder or cryostat tail (with $_{bg}$).

A cross the m easured tem perature range, the two frequencies were found to be in the proportions $_1$: $_2$ = 1:0:65 while the relaxation rates $_{i}$ were found to be in the ratio $_1$: $_2 = 1:0.75$. These quantities were xed in these ratios during the tting procedure. The am plitudes and phases best describing the data are given in [15]. We note that the ratio of longitudinal to transverse components is in excess of the expected value of $A_3 = (A_1 + A_2) = 1 = 2$ (see below). Nonzero phases were also required to t the data, as observed in previous studies of Cu-based chain compounds of this sort [14]. The m agnitudes of the frequencies were tted as a function of tem perature with other parameters in Eq.(2) xed [5]. The resulting tem perature evolution of the precession frequencies is shown in F ig 2(a).

From ts of $_i$ to the form $_i$ (T) = $_i$ (O) (1 T=T_N) close to T_N , we estimate T_N = 107 (1) mK, leading to a value of the ratio j_{K_B} T_N =J j= 0.0103 (1). The parameter

is highly sensitive to the chosen value of T_N due to the di culty of obtaining data su ciently close to the transition. Using $T_N = 107(1) \text{ mK}$, we estimate =

 $0\,:\!18\,(5)\,,w\,hich$ is consistent with low dimensional (i.e. 2D Ising or 2D X Y) behaviour. Fits to $_i$ (T) = $_i$ (0) (1 (T=T_N)) with = 3 yield $_1$ (0) = 1:922 (4) M Hz and $_2$ (0) = 1:257 (3) M Hz corresponding to local magnetic elds at the two muon sites of B₁ = 141:8 (3) G and B $_2$ = 92:7 (2) G.




FIG.2: Tem perature evolution of the variable parameters in Eq.(2) for T 140 mK. (a) M uon precession frequencies $_{\rm i}$ with ts shown to the expression $_{\rm i}(T)$ = $_{\rm i}(0)$ (1 $(T=T_{\rm N})$) (see m ain text). (b) Transverse relaxation rates $_{\rm i}$ are seen to increase as the m agnetic transition is approached from below. (c) The longitudinal relaxation rate , which decreases as the transition is approached from below.

Further evidence for a magnetic transition is seen in the transverse relaxation rates $_i$, which increase as the magnetic transition is approached from below (Fig.2 (b)), as would be expected for critical slowing of uctuations near a magnetic transition. The longitudinal relaxation rate decreases as the transition is approached from below (Fig.2 (c)), suggesting that this quantity is dominated by the magnitude of the local magnetic eld at the muon site.

At tem peratures just above T_N the measured spectra are best described by two components (Fig.1 (b)). One is a fast relaxing contribution, with an amplitude 58, likely to arise due to a fraction of the muons which initially form radical states. This component will also exist in the magnetically ordered regime, but is not resolvable from the longitudinal relaxation and partly explains why the value of A_3 is greater than that expected. The second component observed in this regime is an exponential functional form, characteristic of fast dynamics in the local magnetic eld at the muon sites [6]. At higher tem peratures still (T > 400 mK), this second com ponent in the spectra appears G aussian in form (F ig.1 (c)), characteristic of the early tim e behaviour of a K ubo Toyabe function [16] due to the magnetic eld distribution of a static, disordered system, with slow dynamics preventing the characteristic recovery of the polarization at late times. It is likely that at these elevated temperatures, the electronic moments are uctuating too fast com pared to the muon time scale, and are therefore mo-

tionally narrowed from the spectra. Instead the muon ensemble is depolarized by the magnetic eld distribution at the muon site due to the quasi-static nuclear moments of the surrounding nuclei. This interpretation is supported by the observation that applied magnetic

elds of magnitude 100 G repolarize the relaxation, as expected for a static distribution (repolarization in plies $\lim_{t=1} A(t) = A(0)$). The measured data for $T > T_N$ were therefore tted to the function

$$A(t) = A_4 \exp(4t) + A_5 \exp(5t) + A_{bq}$$




FIG.3: (a) Results of thing data for T > 110 mK to Eq.(3). (D ashed lines show $T = T_N$.) Inset: The parameter changing from = 1 (exponential relaxation) to = 2 (G aussian relaxation) as the dynamics move out of the muon time w indow with increasing tem perature. M ain panel: The relaxation rate $_5$ increases as the transition is approached from above. (b) LF $^+$ SR spectra m ade at T = 2 K in several applied m agnetic elds B_L. Fits are shown to the LFKT function with xed at 0.271 M Hz for all elds.

 (3)

where the stretching parameter describes the passage from exponential to G aussian behaviour. The results of this analysis is shown in Fig.3 (a). The fact that the relaxation rate $_5$ increases sharply as the proposed transition temperature is approached from above lends further weight to the case for the existence of a magnetic transition.

In order to further investigate the high temperature behaviour of the material measurements were made in an applied longitudinal magnetic eld (LF) B_L using a ${}^{4}\text{H}\,\text{e}\,\text{cryostat}$ at the ISIS facility. The pulsed structure of the muon source at ISIS has the advantage of allowing

the observation of the muon polarization at longer times than at a continuous source such as S S. This enables us to better characterise the data with the Kubo Toyabe function generalised for applied LFs [16]. The loss of tim e resolution at a pulsed source causes the fast relaxing component described above to be missing from the signalentirely. The results of these m easurem ents, m ade at T = 2 K, are shown in Fig.3(b). The spectra are found to be approximately temperature independent in the range 2 т 50 K. The application of a eld repolarizes the slow ly relaxing component of asymmetry for B < 100 G consistent with the interpretation that the relaxation at these tem peratures is due to the disordered, quasistatic nuclear m agnetic m om ents. The m easured ZF and LF spectra for both m aterials at 2 K are well described by the longitudinal eld K ubo Toyabe (LFKT) function describing the relaxation due to an ensemble of disordered magnetic moments, although the LFKT function must be multiplied by an exponential function with constant relaxation rate to account for the weak relaxation due to dynamic uctuations [7]. This treatment has only $hB_{loc}^{2}i$, where $hB_{loc}^{2}i$ is the one free param eter second moment of the average local magnetic eld distribution at the muon sites in ZF. This analysis yields a

value of = 0.271 MHz for CuPzN.

An e cacious method for estimating the interchain $\operatorname{coupling} J^0$ in LCHAFM 's has recently been developed, based on a modi ed random phase approximation, modelled with classical and quantum M onte Carlo simulations [18]. This approach leads to an empirical formula for the interchain coupling, given by

$$jJ^{0} \frac{j}{j} k_{B} = \frac{T_{N}}{4c \ln \left(\frac{jJj}{k_{B} T_{N}}\right) + \frac{1}{2} \ln \ln \left(\frac{jJj}{k_{B} T_{N}}\right)}; \quad (4)$$

with = 2:6 and c = 0:233. Substituting our value of $T_N = 107(1) \text{ mK}$ and using $J=k_B = 10:3(1) \text{ K}$, yields $jJ^0 \neq k_B$ ' 0:046 K and a ratio $jJ^0=Jj = 4:4 = 10^3$. The parameters describing a number of copper-chain compounds are presented in table I. Comparing values of the ratio $jJ^0=Jj$ shows that CuPzN is approximately ve times better isolated than copper bispyridine dichloride (Cu (py)₂Cl₂ or CPC) [19, 20], while $jJ^0=Jj$ for CuPzN is around one quarter of that for the best isolated LCHAFM, Sr₂CuO₃ (although this material has a QCP at a eld around 200 times larger than that for CuPzN) [21, 22].

The failure of speci c heat studies [2] to detect an anomaly due to the onset of 3D LRO in CuPzN down to 70 mK, may be attributed to the value of the ratio $jJ^0=Jj$. Investigations using a stochastic series quantum M onte C arlo m ethod [25] show that the height of the expected peak decreases with decreasing jJ^0j becom ing nearly linear below $jJ^0=Jj=0.2$. For smaller value of the ratio $jJ^0=Jj$ the entropy change at the critical tem perature is so sm all that it makes an undetectable contribution to the measured speci c heat.

In conclusion we demonstrated the existence of long range magnetic order in the LCHAFM material CuPzN with $T_N = 107 (1) \text{ mK}$. This leads to an estimate of the interchain coupling of $jJ^0 = k_B$ ' 0.046 K. Form any 1D systems, small values of $jJ^0 = J$ jprevent the detection of 3D LRO with speci c heat, and reduced ordered moments make the use of other techniques problem atical (coupled

chain m ean- eld theory [24] then predicts an ordered m om ent size of 0.05_B for CuPzN). Thus we expect that m uonsm ay provide a particularly valuable tool for future m agnetic m easurem ents of the key param eters of highly anisotropic low-dim ensional system s.
