Fluctuation spectrum of quasispherical membranes with force-dipole activity

The uctuation spectrum of a quasi-spherical vesicle with active membrane proteins is calculated. The activity of the proteins is modeled as the proteins pushing on their surroundings giving rise to non-local force distributions. Both the contributions from the thermal uctuations of the active protein densities and the temporal noise in the individual active force distributions of the proteins are taken into account. The noise in the individual force distributions is found to become signicant at short wavelengths.

I. INTRODUCTION

Biological membranes are mixtures of basically lipids and proteins that actively participate in many biological processes. The lipids, being the basic component, form a bilayer in which proteins are included. Many of these membrane proteins are molecular machines, which can use some readily available energy source, for instance light or ATP, to perform dierent tasks [1]. A prominent example is the transportation of ions across a membrane against a chemical potential gradient. Due to this constant activity a biological membrane is a system out of thermal equilibrium.

One way to observe non-equilibrium behavior of membranes is to study their shape uctuations. Lipid membranes in their uid phase are exible structures undergoing them ally excited shape uctuations that can be observed directly by video microscopy [2]. Indirect studies of the uctuations, using microm anipulation techniques to measure the amount of membrane excess area stored in the uctuations, have already given evidence that activated proteins incorporated in lipid membranes enhance these uctuations [3, 4]. E orts are being put into extending these studies to use video microscopy to obtain the uctuation spectrum directly [5].

A theoreticalm odelwasproposed in [6], which explains the activity induced enhancement of the uctuations as being a result of the active proteins pushing on their uid surroundings. This pushing could arise when a protein is pumping material across the membrane, or when it is changing its conguration as part of an active cycle. This model will be called the force-dipole model here, because it was from ulated mathematically as each protein contributing with a force-dipole to the hydrodynamic equations of the uids surrounding the membrane. The consequences of this model for excess area stored in the uctuations of a planar membrane was calculated in [6],

and from this calculation it was found that the model constitutes a possible explanation of the results of the microm anipulation experiments.

A video m icroscopy study of quasi-spherical vesicles would test the force-dipole model further, because the uctuations at di erent wavelength can be measured, and not just the sum over all wavelength giving the excess area. However, it is not easy to calculate the predictions of the model for the uctuation spectrum of a quasi-spherical vesicle directly, because the equations of motion for the surrounding bulk uids would then have to be solved in a spherical geom etry including the presence of the force-dipoles.

In [7] the force-dipole m odel was reform ulated into an equivalent but calculationwise m ore manageable form ulation, which was called the G ibbs form ulation for the system. One purpose of the present paper is to show how this reform ulation makes it possible to calculate the uctuation spectrum of a quasi-spherical vesicle.

A second purpose of this paper is to include the nonthem al noise of the activity in the calculation of the uctuation spectrum. This was neglected in [6], where the magnitude of the force-dipole generated by each active protein was treated as being constant in time. However, there does not seem to be good reasons to assum e that the forces with which a protein is actively pushing on its surroundings is constant in time as the protein m oves through one cycle of, say, pum ping an ion across the membrane. Estimates performed for a planar membrane in [8], where the e ect of active noise were treated independently of the activities tim e-averaged constant effect on the dynam ics, showed that the noise can have a signicant e ect. Here we will include both e ects for force-dipoles, the time averaged and the corresponding tem poral noise, and calculate the combined e ect on the uctuation spectrum of a quasi-spherical vesicle.

The presentation of the calculation will begin in section Π , where the near-equilibrium dynamics of them embrane is established. The dynamics is formulated as a set of Langevin equations in section $\Pi\Pi$, and the appropriate statistics of the thermal noise is worked out. This

is in turn based on a calculation of the equilibrium uctuations performed in appendix A. The activity is introduced in section IV, where the Langevin equations for the membrane dynamics is modied to include the active force-dipoles. The main result of the paper, equation (57), is in section V, where the activity modi ed Langevin equations are solved for the shape uctuations of the vesicle and the dierent contributions to the result are estimated and discussed. In section VI it is brie y sketched what impact the inclusion of the non-therm al noise has on the analysis of the existing m icropipette experim ents. Finally, a conclusion is given in section VII.

II. NEAR-EQUILIBRIUM DYNAM ICS

In this section we will set up the near-equilibrium dynamics following the formalism developed in [9]. The notational conventions regarding di erential geom etry is the same as in [7, 9].

Our starting point is an excess Helm holtz free energy F of the membrane which is

The rst term represents the bending resistance of the mem brane with being the bending rigidity and H the mean curvature. The second term is a coupling between the mean curvature and the protein concentrations per m em brane area, n_{p^+} and n_p , where + and label the two possible orientations that an asymmetric transmem brane protein in a membrane can have. The third term is a consequence of the observation that inhom ogeneities arising from local compression of the area of the membrane relax much faster than bending deform ations [10]. The term therefore has the form of a local constraint being a Lagrange multiplier eld [18]. The eld , which is constrained to be 1, is a linear combination of the dierent density elds n A of molecules in the mem brane, with each species (including both proteins and lipids) weighted by the area a^A the individual molecules prefer to take up in the membrane

The unitless number is a global quantity that measures the m ism atch between the area that the membrane prefers to have,

The average of over the area of the m em brane is therm odynam ically conjugate to the area A, and thus this average can be understood as the tension of the membrane. The fourth term in Equation (1) is an elective interaction potential between the protein $elds n_p$. The functional form is left unspecied, but it should include at least the mixing entropy for the protein $elds n_p$, and could also contain terms related to other interactions between the protein molecules. The -eld in this term is introduced for convenience, because then the potential V will not be present in the force balance equation of the m em brane, see Equations (7) to (9) later.

Having specied the free energy in Equation (1), we can now follow the form alism of [9] and write down the dynam ics of the mem brane. At low Reynolds number the equation of motion for the shape eld R is simply the condition of force balance of the membrane. Following [6] we ignore internal dissipation in the membrane and write the force balance as

where we have introduced the density dierence eld $n = n_{p^+} n_p$. This eld has a natural partner in the eld $n = n_{p^+} + n_p$, which will be used later. The force densities T are the stresses of the bulk uids on them em brane surface. At low Reynolds num ber the bulk uids are governed by the Navier-Stokes equation

together with the incompressibility condition r v = 0. Here v = v (r;t) are the velocities of the bulk uids with r labeling the position and t time.p are the pressure elds and the viscosity. Given a solution of the bulk hydrodynam ics we can calculate the stress tensors of the bulk uids as

To actually nd a solution of the bulk hydrodynam ics we need boundary conditions for the bulk velocity elds v at the mem brane surface. The boundary condition that is usually imposed when dealing with viscous uids is the so-called no-slip boundary condition, where the bulk uid at the boundary is constrained to have the velocity of the boundary material. In [9] it was argued that for a multicom ponent m embrane the general form of this boundary condition was a linear combination of the ows of the di erent species of molecules in the membrane. If we let j_A be the current for the density n_A entering the conservation law [9]

where the phenomenological constants LA are areas of ng olecular sizes. They should satisfy the constraint $_{n}$ L^A n_{A} = 1 such that it is possible to have uniform motion of the whole system. In [9] it was argued that the precise values of the LA can in uence the distribution of proteins in the m em brane if the m em brane is subjected to a bulk shear ow with velocities of the order $k_B T = (L^A)$. However, the velocities in the bulk uids induced by them all noise are of the order $k_B T = (2)$, where is the wavelength of the undulation in question. Thus when we are interested in undulations much longer than the molecular length scales we can ignore shear ow e ects arising due to therm al uctuations. This means that the detailed values of the LA are unim portant for the coupling of the bulk uid dynamics to the dynamics of the protein densities in the present problem. Thus we are allowed to make a convenient choice that will simplify calculations. We will choose: $L^A = a^A = (1 + 1)$ such that

 Q_+R . Thus the motion of the mem where v t = vbrane shape R is related to the motion of the bulk uids v at the m em brane surface, w ithout the protein densities n_p entering directly.

From Equations (7) to (9) we see that the dynam ics of the shape eld R is coupled to the density di erence eld n . The equation of motion for n is a conservation law, Equation (13), but we need the expression for the current j. This current can be divided into two contributions, $j = n v + j_{d}$, where the rst term is the

The second term is the dissipative part of the current. Close to equilibrium we can write down a constitutive relation coupling this current linearly to possible driving forces. The only driving force we have that transform in the same way as ja under symmetry transformations (including the approxim ate sym m etry of exchanging n_{p^+} and n_p) is the gradient of the corresponding chem ical

is a phenom enological param eter related to w here the di usion constant of the proteins, see Equation (65) later.

Having worked so far with equations that are true for any m em brane shape, we will now restrict ourselves to a shape which is uctuating around a spherical average shape with radius Ro, and only keep terms up to rst order in deviations from this average shape. where the subscript 0 indicates that the quantity has the value of the average state and $u_{\,\text{im}}$, $n_{\,\,\text{j'm}}$, $n_{\,\,\text{j'm}}$ and ;'m represent small deviations from this state. Note that we follow [6] in making the simplifying assumption that the proteins are distributed sym m etrically between the two possible orientations in the membrane such that n_0 ; vanishes.

The solution of the equations of motion to zeroth order in the deviations from a spherical membrane shape is that R_0 and n_0 ; are constant due to volum e and m olecular num ber conservation. Furtherm ore the force balance condition, Equation (6), becomes

which is Laplace's law with p_0 being the average pressures in the bulk. The value of the tension $_0$; is in principle related to the value of , but we will choose $_0$; to be the free parameter here. The reader is referred to [11] for further details on the subject of membrane tensions and their conjugate areas.

Calculating to 1st order in the deviations from a spherical shape is more tedious. Especially we need to nd expressions for the hydrodynam ic forces T term s of the state variables of the membrane. Fortunately, a solution to the Navier-Stokes equation at low Reynolds number in spherical geometry is known. This solution is called the Lamb solution [12], and we can use in terms of v . Having worked this out we can then elim in ate ; m and v from the dynam ics of um and n; to arrive at a closed set of rst order di erential equations for u_m and n_{m} . n_{m} will not enter the equations for u_m and n_m , because $(0^2V = (0n \ 0n))_{n=0} = 0$ since the system should then be sym m etric with respect to reversing the two sides of the m em brane. W e do not write out the interm ediate results of the full calculation here. Instead we refer to [10] where an analogous calculation was performed in detail. We state the nalresult by collecting the dynamical elds into a column vector w $_{\text{m}}$, where the transpose of w $_{\text{m}}$ is $w_{m}^{T} = (u_{m}; n;_{m})$, and then w rite the dierential equations as

III. THERMALNOISE

Equation (25) represents the near-equilibrium dynamics of the average shape of the membrane. To include the elect of the thermal forces on the dynamics of the shape we follow the Langevin approach [13] and add a white-noise term to the dynamic equations. The result is the stochastic equation

IV. ACTIVITY

Having set up the stochastic equations for the near-equilibrium dynam ics we will now modify these to include the e ect of the active force-dipoles. Most of the work needed to do this was done in [7], where it was found that the important contribution of the force-dipoles to the dynam ics was to modify the force balance condition for the membrane to

The quantity $_{\rm dip}$ is a modi cation of the tension induced by the activity. Due to the fast balancing of forces in the tangential directions of the membrane, uctuations in $_{\rm dip}$ will immediately be counterbalanced by changes in , and therefore only the average value $_{0;\rm dip}$ will have an in uence on the dynamics of the membrane shape. A discussion of the magnitude of this contribution can be found in [7]. Q is a measure of how much the bending moments in the membrane is modied by the activity of the force-dipoles. The model we will use for Q is

The constant $F_{(2)}$ is related to the param eters of [6] by being the quadrupole m on ent of the shifted force-dipole of an active protein:

Here F_a is a force and w and w are length scales related to how the active proteins insert them selves in the membrane. S represents the noise arising when the force-dipole generated by an individual protein is not constant during the cycle of the activity. It has zero average

Note that, contrary to [6, 7], we have for simplicity ignored any dependence of the protein activity on the

local curvature of the membrane, but included internal noise in the model instead.

We calculate the stochastic equations of motion for u_m and n_{m} as before using the force balance condition of Equation (36), instead of Equation (6). This gives a changed set of stochastic equations which becomes





FIG. 1: The uctuation spectrum, Equation (57). The param eters are as explained in the text for the dotted curve. The solid curve is the equilibrium result, i.e. F $_{(2)}$, $_a$ and $_{0;\text{dip}}$ has been set to zero. For the dashed curve we have taken $_a$ = 0 such that only the internal active noise of the proteins is ignored.

A plot showing how the force-dipole activity modi es the uctuation spectrum is shown in qure 1. The param eters have been chosen in accordance with the estimates and ndings of [6] for a lipid membrane with the proton pump bacteriorhodopsin incorporated. Thus we have taken = $10k_B T$ with $k_B T$ = 4 10^{21} J. The protein potential V is taken to be purely entropic and thus = $k_B T = n_0$; with n_0 ; = $10^{\overline{16}}$ m $^{\overline{2}}$ for the total density of proteins. We have assumed that the single protein and collective di usion constants are identical and taken them to be D $= D_{sp} = 10^{-12} \text{m}^2 = \text{s. For}$ sim plicity we have ignored any asymmetry in the nonactive interactions between the proteins and the lipids and taken = 0. We have taken the vesicle to have a radius of R₀ = 10 m with a tension $_{0}$; = 5 10^{8} N=m which is increased by 50% when the proteins are active to $\sim = 7.5 \cdot 10^8 \text{ N} = \text{m}$. The relation between the constant F $_{(2)}$ here and the param eters of [6] is that F $_{(2)}$ = 2w P $_{a}$, where w is the membrane thickness and Pa has the units of a force-dipole. Using the values of [6] this gives $F_{(2)} = 10 \, \text{nm}$. The amplitude of the internal noise a should be related to $F_{(2)}$ and here we have sim ply taken $_{a} = F_{(2)}^{2}$. For the characteristic time of the active process we have taken the duration of a bacteriorhodopsin photocycle, a = 5 m s. F inally the surrounding m ediumhas the viscosity of water = 10^{3} Pa s.

D i erent ways in which the activity of the force-dipoles modify the uctuation spectrum can be seen in gure 1. First of all the increase in the tension, $_{\rm dip}$, decreases the uctuations at large wavelengths (sm all '). Secondly, the therm all uctuations of n enhances the shape uctuations at short wavelengths through the active contribution to the bending moment: F $_{(2)}$ n . This was the explanation given in [6] for the increase in the uctuations observed in [3]. However, it can also be seen in the gure that the internal active noise can give a third modi cation at short wavelength, which sets in gradually as x increases to become of order one, see gure 2. Note that



eventually as the modenum ber 'goes to in nity, the contributions of the activity to the uctuations scales as ' 4 , i.e. in the same way as the thermal uctuations. In the classication scheme of [8, 16] the wavelength behavior of the uctuations in the force-dipole model corresponds to the case of \curvature-force".

The physics behind the gradual onset of the e ect of the internal active noise can be understood from the tim e-scales of the problem. Using the explicit values of the parameters chosen for the plot we not that at high 'we have $''_{1}$ 100s= $'^{3}$ and $_{D}$; ' 100s= $'^{2}$. Looking at the fractions of time scales in Equation (66) we see that all of these fractions will be at maximum of the order unity except ;= \ (see also gure 2), which will be bigger than one for 'small enough such that ; is larger than a. Since this fraction enters in the denom inator of x_{\cdot} , we will have that x_{\cdot} is small for 's that are smaller than, say, 20. The physical origin of this is that when the m em brane shape dynam ics is slower than the dynam ics of the internal active noise, then the shape cannot move fast enough to accomm odate the temporary stresses that the internal active noise induces. Thus the noise will not in uence the movement of the shape at long wavelength.

Note that the time scale for disusion $_{D}$; is slower than the time scale formem brane shape relaxation; A simplifying approximation in Equations (56) and (66) would thus be to discard terms proportional to $_{C} = _{D}$;

VI. M ICROPIPETTE EXPERIMENTS

To understand what im pact including the non-therm al noise represented by $_{a}$ in the force-dipole model has on interpreting existing experimental data, we will brie y discuss micropipette experiments in this section [19].

In micropipette experiments a relation between the area of a vesicle and the tension in its membrane is measured. The vesicle is aspirated to a pipette at low suction pressure inducing a tension in the membrane of the size N=m and above [17]. The tension is then increased by

increasing the suction pressure and it is measured how the visible area of the membrane changes in response. At low tension it is usually assumed that the increase in visible area is taken from the excess area stored in the uctuations of the membrane without the true area being increased.

W e can calculate the excess area, which we will denote by 0 to distinguish it from the of Equation (5), for the force-dipole model applied to an spherical vesicle from Equation (57). Expanding the area of the vesicle surface, A, to second order in $u_{\,\mathrm{m}}$ one nds for a spherical vesicle with xed volume

where l_{max} is a cut-o wavenumber beyond which the free energy of Equation (1) is not expected to be valid anym ore. Due to the relatively high tensions in the micropipette experim ents (in com parison with what can be achieved in video m icroscopy experim ents) the uctuations of the low wavenum bers 'do not contribute much to the excess area. We can therefore simply replace factors of, say, '+ 2 in Equations (57) and (67) with land convert the sum to an integral to simplify the calculation. As mentioned at the end of the last section we can also put factors of y=D; to zero. To simplify the expression for x, we will simply take to be zero such that $x_i = 1$ for high ', and assume that the tension is high enough such that the term s in the square brackets of Equation (57) is suppressed by the tension for the lower lwhere x, is not unity. With these simplications we get

is an elective temperature whose ratio with T is a measure of how much the excess area has been increased by the activity induced uctuations in comparison with equilibrium .

In [4, 6] a factor two to three increase of T^e in micropipette experiments on active membranes were reported. This increase was assigned to the averaged force-dipole activity represented by $F_{(2)}$ in Equation (69). But as Equation (69) shows, the noise of the activity represented by F_a might well give a contribution of comparable size. Actually, with the estimated values chosen in

the previous section the contributions of the corresponding two terms in Equation (69) become exactly equal. Further experiments are needed to make it possible to distinguish the contributions of the two mechanisms. An obvious candidate for such experiments is a video microscopy experiment, where the two contributions might be distinguishable due to the onset at high 'modes of the internal noise represented by a discussed in the last section. However, a limit of the video microscopy experiments is the resolution of the experimental setup, setting a limit for the range of 'modes that can be obtained in such an experiment. Currently this limit seems to be the rst 20 to 30 modes [5], making the possibility of observing an onset very sensitive to the actual parameters, a etc., of the system.

VII. CONCLUSION

In this paper the G ibbs form alism of [7, 9] was used to calculate the quasi-spherical shape uctuation spectrum, given in E quation (57), for the force-dipole m odel of [6]. This calculation allows for further testing of the force-dipole through video m icroscopy experim ents, som ething which is needed to test the model more stringently. The shortcom ing of the micropipette experiments is that they only provide one data point for each set of experimental conditions. A video microscopy experiment on the other would provide a data point for each modenumber 'in the spectrum that can be measured.

Following a general view point promoted in [8] an additional contribution due to temporal noise in the strength of the force-dipoles of the individual active proteins was included in the calculation. The contribution of this noise was found to be insignicant at long wavelengths, but it is turned gradually on as themode number 'increases when the corresponding characteristic time scale formem brane shape relaxation crosses the time scale associated with the correlations in the noise from the activity. This gradual onset o ers a possible way to distinguish the contribution from those of the original force-dipole model of [6] when the shape uctuation spectrum obtained by for instance a video microscopy experiment is analyzed.
