Fractional-Period Excitations in Continuum Periodic Systems

W e investigate the generation of fractional-period states in continuum periodic system s. As an example, we consider a Bose-E instein condensate con ned in an optical-lattice potential. We show that when the potential is turned on non-adiabatically, the system explores a number of transient states whose periodicity is a fraction of that of the lattice. W e illustrate the origin of fractional-period states analytically by treating them as resonant states of a parametrically forced Du ng oscillator and discuss their transient nature and potential observability.

I. IN TRODUCTION

In the past few years, there has been considerable interest in both genuinely discrete and continuum but periodic system s [1]. These arise in diverse physical contexts [2], including coupled waveguide arrays and photorefractive crystals in nonlinear optics [3], Bose-E instein condensates (BECs) in optical lattices (OLs) in atom ic physics [4], and DNA double-strand dynam ics in biophysics [5]. One of the most interesting them es that em erges in this context is the concept of \e ective discreteness" induced by continuum periodic dynamics. There have been many e orts both to derive discrete system s that emulate the dynamics of continuum periodic ones [6] and to obtain continuum system s that m in ic properties of discrete ones [7]. Additionally, the connection between discrete and continuum systems in various settings is one of the main research thrusts that has emerged from studies of the Ferm i-Pasta-Ulam problem [2].

This paper exam ines a type of excitation, not previously analyzed (to the best of our know ledge), with the intriguing characteristic that it can be observed in continuum periodic system s but cannot be captured using a genuinely discrete description of the same problem. The reason for this is that these states bear the unusual feature that their length scale is a fraction of that of the continuum periodic potential. Thus, the \fractional-period" states reported in this paper are not stationary states of the latter problem, but rather transient excitations that persist for nite, observable times.

To illustrate these fractional states, we consider the example of a trapped BEC in which an OL potential is turned on (as a non-adiabatic perturbation) [4]. Our results can also be applied in the context of optics by considering, for example, the e ect of abruptly turning on an ordinary polarization beam in a photorefractive crystal [3]. Our particular interest in BECs is motivated by recent experiments [8], where after bading the condensate in an OL, the amplitude of the pertinent standing wave was modulated and the resulting excitations were probed. These notings were subsequently analyzed in the framework of the Gross-Pitaevskii equation in [9], where it was argued that a parametric resonance occurs due to the OL amplitude modulation. These results were further enforced by the analysis of [10], which included a computation of the relevant stability diagram and grow th rates of parametrically unstable modes. The results of [8] were also exam ined in [11] by treating the Bose gas as a Tom onaga-Luttinger liquid.

A sim ilar experiment, illustrating the controllability of such OLs, was recently reported in [12], where instead of modulating the amplitude of the lattice, its location was translated (shaken) periodically. This resulted in mixing between vibrational levels and the observation of perioddoubled states. Such states were predicted earlier [13, 14] in both lattice (discrete nonlinear Schrodinger) and continuum (Gross-Pitaevskii) frameworks in connection to a modulational instability [15, 16] and were also exam ined recently in [17]. Period-multiplied states may exist as stationary (often unstable) solutions of such nonlinear problem s and can usually be captured in the relevant lattice models.

To obtain fractional-period states, which cannot be constructed using B loch's theorem [18], we will consider a setting sim ilar to that of [9], akin to the experiments of [8]. However, contrary to the aforem entioned earlier works (but still within the realm of the experimentally available possibilities of, e.g., Ref. [8]), we propose applying a strong non-adiabatic perturbation to the system (which originally consists of a magnetically con ned BEC) by abruptly switching on an OL potential. As a result, the BEC is far from its desired ground state. Because of these nonequilibrium conditions, the system \wanders" in con guration space while trying to achieve its energetically desired state. In this process, we monitor the fractional-period states as observable transient excitations and report their signature in Fourier space. A fter presenting the relevant setup, we give an analysis of halfperiod and quarter-period states in a simpli ed setting. We illustrate how these states emerge, respectively, as harm onic and 1.2 superharm onic resonances of a parametrically forced D u ng oscillator describing the spatial dynamics of BEC standing waves (see Appendices A and B for details). We subsequently monitor these states in appropriately crafted numerical experiments and examine their dependence on system parameters. Finally, we also suggest possible means for observing the relevant states experimentally.

The rest of this paper is organized as follows. In Section II, we present the model and the analytical results. (The details of the derivation of these results are presented in appendices; Appendix A discusses half-period states and Appendix B discusses quarter-period states.) W e present our num erical results in Section III and sum marize our ndings and present our conclusions in Section IV.

II. MODELAND ANALYSIS

A. Setup

A quasi-1D BEC is described by the dimensionless G ross-P itaevskii (GP) equation [4, 19],

where (x;t) is the mean-eld wavefunction (with atom ic density j \hat{j} rescaled by the peak density n_0), x is measured in units of the healing length = $\sim = \frac{p}{n_0 g_{1D} m}$ (where m is the atom ic mass), t is measured in units of =c (where $c = \frac{p}{n_0 g_{1D} = m}$ is the Bogoliubov speed of sound), $g_{1D} = 2 \sim !_{?}$ a is the e ective 1D interaction strength, !_? is the transverse con nement frequency, a is the scattering length, and energy is measured in units of the chemical potential = $g_{1D} n_0$. The nonlinearity strength g (proportional to a) is taken to be positive in connection to the ⁸⁷Rb experiments of [8]. The potential,

consists of a harm onic (magnetic) trap of strength

 \sim !_x=g_{1D} n₀ (where !_x is the longitudinal con nem ent frequency) and an OL of wavenum ber q, which is turned on abruptly at t = 0 [via the H eaviside function H (t)]. The lattice depth, given by V₀ [l + A sin (!t)], is periodically m odulated with frequency !.

To estim ate the physical values of the param eters involved in this setting, we assume (for xed values of the trap strength and norm alized chem ical potential, given by = 0.01 and $_0 = 1$, respectively) a magnetic trap with $!_2 = 2$ 1000 Hz. Then, for a 87 Rb (23 Na) condensate with 1D peak density 5 10^7 m 1 and longitudinal connem ent frequency $!_x = 2$ 6 Hz (2 2.8 Hz), the space and time units are 0.4 m (1.25 m) and 0.27 m s (0.57 m s), respectively, and the number of atom s (for q = 1) is N 4200 (12000).

B. A nalytical R esults

To provide an analytical description of fractionalperiod states, we initially consider the case of a hom ogeneous, untrapped condensate in a time-independent lattice (i.e., = A = 0). We then apply a standing wave ansatz to Eq. (1) to obtain a param etrically forced Du – ing oscillator (i.e., a cubic nonlinear M athieu equation) describing the wavefunction's spatial dynam ics. As exam ples, we analyze both half-period and quarter-period states. We discuss their construction brie y in the present section and provide further details in Appendices A and B, respectively.

W e insert the standing wave ansatz

into Eq. (1) to obtain

where primes denote dimension with respect to x, = 2 $_0$, ~= 2g, " $\nabla_0 = \nabla_0$, and = 2q.

W e construct fractional-period states using a multiplescale perturbation expansion [20], de ning "x and

 $bx = (1 + "b_1 + "^2b_2 +)x \text{ for stretching parameters} \\ b_j. W e then expand the wavefunction amplitude R in a power series,$

Note that although and both depend on the variable x, the prefactor " in indicates that it varies much more slow ly than so that the two variables describe phenom ena on di erent spatial scales. In proceeding with a perturbative analysis, we treat and as if they were independent variables (as discussed in detail in Ref. [20]) in order to isolate the dynam ics arising at di erent scales [26]. We also incorporate a detuning into the procedure (in anticipation of our construction of resonant solutions) by also stretching the spatial dependence in the OL, which gives W () = " $V_0 \cos($) for the last term in Eq. (4) [22]. We insert Eq. (5) into Eq. (4), expand the resulting ordinary di erential equation (ODE) in a power series in ", and equate the coe cents of like powers of ".

At each O ("^j), this yields a linear ODE in that $R_j = R_j(;)$ must satisfy:

where h_j depends explicitly on and on R_k and its derivatives (with respect to both and) for all k < j. We use the notation $D^{-1}R_k$ in the right hand side of Eq. (6) to indicate its functional dependence on derivatives of R_k . In particular, because of the second derivative term in Eq. (4), these terms are of the form $\frac{\theta^2 R_k}{\theta - 2}$, $\frac{\theta^2 R_k}{\theta - \theta}$. [See, for example, Eq. (11) in Appendix A.]

W e scale ~ (see the discussion below) to include at least one power of " in the nonlinearity coe cient in order to obtain an unforced harmonic oscillator when j = 0(so that h_0 vanishes identically) [21]. At each order, we expand h_j in terms of its constituent harmonics, equate the coe cients of the independent secular terms to zero, and solve the resulting equations to obtain expressions for each of the R_j in turn. (The forcing terms h_j and the solutions R_j are given in Appendix A for half-period states and Appendix B for quarter-period states.) Each R_j depends on the variable through the integration constants obtained by integrating Eq. (6) with respect to . The result of this analysis is an initial wavefunction, (x;0) = R (x), given by Eq. (5).

We obtain half-period states of Eq. (4) (and hence of the GP equation) by constructing solutions in harm onic (1:1) resonance with the OL (i.e., P = 2q) [23]. To perform the (second-order) multiple-scale analysis for this construction (see Appendix A), it is necessary to scale the nonlinearity to be of size O (") (i.e., $\sim =$ "), where " is a form al sm all parameter. [The OL is also of size O (").] We show below that fullnum erical simulations of the GP equation with a stationary OL using initial conditions obtained from the multiple-scale analysis yield stable half-period solutions even for large nonlinearities. The oscillations in time about this state are just larger because of the O (1) nonlinearity.

W e also obtain quarter-period states of Eq. (4) (and hence of the GP equation) by constructing solutions in 12 superharm onic resonance with the OL (i.e., = 2 = 4q). Because the 12 superharm onic resonant solutions of the linearization of (4) [that is, of the linear M athieu equation] are 4th-order M athieu functions [24], we must use a fourth-order multiple-scale expansion (see Appendix B) to obtain such solutions in the nonlinear problem when starting from trigonom etric functions at 0 (1). Accordingly, it is necessary to scale the nonlinearity to be of size O ("4) (i.e., $\sim =$ "4). [The OL is still of size 0 (").] Nevertheless, as with half-period states, we show below that full num erical simulations of the GP equation with a stationary OL using initial conditions obtained from the multiple-scale analysis yield stable quarter-period solutions even for large nonlinearities. The oscillations in time about this state are again larger because of the 0 (1) nonlinearity.




FIG.1: (Coloronline) Evolution of the half-period state found by numerically integrating Eq. (1). (Leff) Space-time plot. (Right) Snapshots of the density $j \int_{1}^{2} at t = 0, t = 100, t = 200, and t = 300$. The parameter values are = A = 0(i.e., a time-independent OL and no magnetic trap), g = 1, $\nabla_0 = 1, q = -8$ (so = -4), = -0.05, and $b_1 = b_2 = -1$. The dashed curve shows the OL potential.

III. NUMERICAL RESULTS

Having shown the origin of fractional-period states analytically, we now use num erical simulations to illustrate their dynam ical relevance.




FIG.2: (Color online) Evolution of the quarter-period state found by num erically integrating Eq. (1). (As in Fig.1, the lattice is tim e-independent and the magnetic trap is not included.) We show snapshots of the density $j \stackrel{2}{j}$ at t = 0, t = 100, t = 200, and t = 300. The parameter values are = A = 0, g = 1, $\nabla_0 = 1$, q = =8 (so $\frac{1}{2} = -2$), " = 0.05, and $b_1 = b_2 = b_3 = b_4 = -1$. The dashed curve shows the O L potential.

First, we consider the case with a stationary OL (A = 0) in the absence of the magnetic trap (= 0). We exam ine the tim e-evolution of half-period states by num erically integrating Eq. (1) with the initial condition given by Eqs. (3) and (5). We show an example in Fig. 1, where $q = 1, V_0 = 1, q = -8, and " = 0.05$. The half-period state persists for long times (beyond t = 300). The param eter values correspond to a ⁸⁷Rb (²³Na) BEC with a 1D peak density of 5^{-10^7} m⁻¹ con ned in a trap with frequencies $!_{?} = 2$ 1000 Hz, ! x = 0, and number of atom s N 4000 (12500). In real units, t = 300 is about 80ms (170ms). We sim ilarly exam ine the timeevolution of quarter-period states by num erically integrating Eq. (1) with the initial condition again given by Eqs. (3) and (5), but now for the case of the superharmonic 12 resonance. In Fig. 2, we show an example for a sim ilar choice of param eters as for half-period states [25].

W e subsequently exam ine the generation of such states through direct num erical experim ents using Eq. (1) in the presence of magnetic trapping. Initially, we include the parabolic and periodic components of the potential but leave the potential tim e-independent, setting A = 0, 2=2. First, we consider $_{0} = 1, V_{0} = 1, and q =$ the case of a weak parabolic trap with = 0.001. Using the nonlinearity $\cos \operatorname{cient} g = 1$, we perform the num erical experim ent as follows: We integrate the GP equation in imaginary time to nd the \exact" ground state (in the absence of the OL) and then we switch on the OL at t = 0. We monitor the density j(x;t), its Fourier transform $j(k;t)j^2$, and the spectral components at k = 2q (the OL wavenum ber) and k = 4q (half the wavenum ber). Note that the spectrum also contains a DC " component (at k = 0, corresponding to the ground state) as well as (very weak) higher harm onics.




FIG. 3: (Color online) Top panels: Snapshots of j (x;t) j (left) and its Fourier transform j (k;t) j² (right) for the case of a tim e-independent lattice and a m agnetic trap at time st = 12, t = 7:3, and t = 7:7. The parameter values are = 0:001, $_0 = 1$, $V_0 = 1$, $q = \frac{12}{2}$, and A = 0. The dashed curves (in the left panels) show the OL.Bottom panel: Evolution of j (4q) j² (thin curve) and j (2q) j² (bold curve). For t = 12, the density has the same period as the OL (i.e., k = 2q). For t = 7:3 (t = 7:7), we observe the form ation of a quasiharm onic (non-harm onic) half-period state with wavenum ber k = 4q.

In general, the spectral component at k = 2q is significantly stronger than that at k = 4q (see the bottom panel of Fig. 3), in plying that the preferable scale (pe-

riod) of the system is set by the OL.This behavior is most prominent at certain times (e.g., at t = 12), where the spectral component at k = 2q is much stronger than the other harm onics. Nevertheless, there are specic time intervals (of length denoted by) with j $(4q)j^2 > j (2q)j^2$, where we observe the form ation of what we will henceforth call a \quasi-harm onic" half-period state. For example, one can see such a state at t = 73. The purpose of the term \quasi-harm onic" is to characterize half-period 4

One can use the time-evolution of the spectral com ponents as a quantitative method to identify the formation of half-period states. This diagnostic tool also reveals a \revival" of the state, which disappears and then reappears a number of times before vanishing com pletely. Furtherm ore, we observe that other states that can also be characterized as half-period ones (which tend to have longer lifetim es than quasi-harm onic states) are also form ed during the tim e-evolution, as shown in Fig. 3 at t = 7:7. These states, which we will hereafter call \non-harm onic" half-period states, have a shape which is de nititvely non-sinusoidal (in contrast to the quasiharm onic states); they are nevertheless periodic structures of period k = 4q. In fact, the prim ary Fourier peak of the non-harm onic half-period states is always greater than the secondary one. Such states can be observed for times t such that the empirically selected condition of j (2q;t)j² $3j (4q;t)j^2$ is satis ed.

shape, like the wavefunctions we constructed analytically.

W e next consider a stronger parabolic trap, setting = 0:01. Because the system is generally less hom ogeneous in this case, we expect that the analytical prediction (valid for = 0) may no longer be valid and that half-period states may cease to exist. We con med this num erically for the quasi-harm onic half-period states. However, non-harm onic half-period states do still appear. The time-evolution of the spectral components at k = 2qand k = 4q is much more complicated and less e cient as a diagnostic tool, as j $(4q;t)j^2 < j (2q;t)j^2$ for all t. Interestingly, the non-harm onic half-period states seem to persist as is increased, even when the resonance condition -= = 2q is violated. For example, we found that for time-independent lattices (i.e., A = 0), the lifeting e of a half-period state in the resonant case with q =2=2 (recall that $_0 = 1$) is 1:72, whereas for q = 1=2 it is




FIG.4: Halfperiod (top panels) and quarter-period (bottom panels) states for the case of a tem porally modulated OL. The state in the top left panel has wavenum ber $q = \frac{1}{2-2}$ (resonant), and that in the top right panel has wavenum ber q = 1=2 (non-resonant). Sim light, the states in the bottom panels have wavenum bers $q = \frac{1}{2-4}$ (left, resonant) and q = 1=4 (right, non-resonant).

0.84. M oreover, the simulations show that the lifetimes become longer for periodically modulated OLs (using, e.g., A = 1; also see the discussion below). In particular, in the aforementioned resonant (non-resonant) case with $q = \frac{1}{2}$ (q = 1=2), the lifetime of the half-period states has a maximum value, at ! = 1.59 (! = 0.75), of 8.24, or 4.7 ms (5.72, or 3.3 ms) for a ²³N a condensate. We show the formation of these states in the top panels of Fig. 4.




FIG. 5: The lifetime of the half-period (upper curve) and quarter-period (lower curve) states as a function of the lattice-m odulation amplitude A. For the half-period (quarter-period) state, we show the case with wavenum ber q = 2=2 (q = 2=4). In both examples, we used $_0 = 1$ and lattice-m odulation frequency ! = 1:59.

We also considered other fractional states. For example, using the same parameter values as before except for = 2 (so that q = 2=4), we observed quarter-period transient states with lifetime 2:9. These states occurred even in the non-resonant case with q = 1=4 (yielding 1). We show these cases (for a tem porally modulated lattice with modulation amplitude A = 1) in the bottom panels of Fig. 4. In Fig. 5, we show the lifetime

for the half-period and quarter-period states as a function of A. Observe that the lifetime becomes m axim al(for values of A 1:5) around the value A = 1 considered

above. Understanding the shape of these curves and the optim allifetime dependence on A in greater detailm ight be an interesting topic for further study.




FIG.6: (Color online) Density pro les for a fractional state with = (5=4), so that q = 2 2=5 (for $_0 = 1$, lattice-modulation amplitude A = 1, and lattice-modulation frequency ! = 1.59). The system oscillates in time between half-period (bottom panel) and third-period (bottom panel) states.

Finally, we also exam ined non-integer excitations, for which the system oscillates between the closest integer harmonics. For example, in Fig. 6, we show a state corresponding to = (5=4), so that q = 2 2=5 (with $_0 = 1$). The system oscillates between the k = 4q(half-period) and k = 6q (third-period) states. Recall that the case presented in the top right panel of Fig. 4 (with q = 1=2) was identified as a \non-resonant halfperiod state" (the resonant state satis es q = 2=2=2). Here it is worth remarking that this value, q = 1=2, is

 $p_{\overline{2}=3}$ (characterizing the third-period state) closer to g = than to 2=2. Nevertheless, no matter which characterization one uses, the salient feature is that the value q = 1=2 is nonresonant and lies between the third-period and half-period wavenum bers. A coordingly, the respective state oscillates between third-period and half-period states. Thus, in the case shown in the top right panel of Fig. 4, the third-period state also occurs (though we do not show it in the gure) and has a lifetime of = 42(2:4 ms), while for $q = 2^{2} = 2 = 5$ its lifetime is = 2:92 (1:67 m s). This indicates that states with wavenum bers closer to the value of the resonant third-period state have larger lifetim es. This alternating oscillation between the nearest resonant period states is a typical feature that we have observed for the non-resonant cases.

IV. CONCLUSIONS

In summary, we have investigated the formation and tim e-evolution of fractional-period states in continuum periodic system s. A lthough our analysis was based on a G ross-P itaevskii equation describing B ose-E instein condensates con ned in optical lattices, it can also be applied to several other system s (such as photonic crystals in nonlinear optics). We have shown analytically and dem onstrated num erically the form ation of fractionalperiod states and found that they may persist for su ciently long times to be observed in experiments. The most natural signature of the presence of such states should be available by monitoring the Fourier transform of the wavepacket through the existence of appropriate harm onics corresponding to the fractional-period states (e.g., k = 4q for half-period states, k = 8q for quarterperiod states, etc.).

It would be interesting to expand the study of the param etric excitation of such states in order to better understand how to optim ally select the relevant driving amplitude. Sim ilarly, it would be valuable to exam ine m ore quantitatively the features of the ensuing states as a function of the frequency of the param etric drive and the parabolic potential. To construct half-period states, we use the resonance relation = and the scaling $\sim =$ ", so that Eq. (4) is written

where we recall that = "x, = bx = $(1 + "b_1 + "^2b_2 + "b_1 + "b_2 + "$

)x, and R_k signi es the presence of derivatives of R_k in the right hand side of the equation. Because of the scaling in Eq. (7), $h_0 = 0$, so that the O (1) term is an unforced harm onic oscillator. Its solution is

where A_0 and B_0 will be determ ined by the solvability condition at 0 (").

The O ("^j) (j 1) equations arising from (7) are forced harm onic oscillators, with forcing term s depending on the previously obtained R_k (;) (k < j) and their derivatives. Their solutions take the form

where each R $_{\rm jp}$ contains contributions from various harmonics. As sinusoidal terms giving a 1:1 resonance with the OL arise at O ("²), we can stop at that order.

At O ("), there is a contribution from both the OL and the nonlinearity, giving

where we recall that the OL depends on the stretched spatial variable because we are detuning from a resonant state [22]. W ith Eq. (9), we obtain

Similar to what occurs at O ($"^2$), the coe cient c₃₆ is the prefactor for $\cos(0)$ and a $\sin(0)$ term (not show n) occurs in (38) as well. The extra terms (from the resonance relation) that go into the slow evolution equations and the resulting expressions for the periodic orbits (i.e., the equilibria of the slow ow) arise from the term swith prefactors c_{39} and c_{311} . (The harm onics corresponding to the coe cients c_{31} and c_{34} are always secular, but those corresponding to c_{39} and c_{311} are secular only for 12 superharm onic resonances.)

One inserts equilibrium values of A_{j} and B_{j} (j 2 f0;1;2;3g) into Eqs. (25), (29), (31), and (35) to obtain the spatial pro $le R = R_0 + "R_1 + "^2R_2 + "^3R^3 + O("^4)$ used as the initial wavefunction in num erical simulations of the GP equation (1) with a stationary OL.
