Collective modes of Ferm i super uid containing vortices along the BEC-BCS crossover

U sing the coarse-grain averaged hydrodynam ic approach, we calculate all low energy transverse excitation spectrum of a rotating Ferm i super uid containing vortex lattices for all regimes along the BEC-BCS crossover. In the fast rotating regime, the molecular BEC enters into the lowest Landau level, but the super uid in the unitarity and the BCS regimes occupies many low-lying Landau levels. The dierence between the breathing mode frequencies at the BEC and unitarity limit shrinks to zero as the rotation speed approaches the radial trap frequency, in contrast to the nite dierence in the non-rotating systems.

Strongly interacting two-component Fermigases provide a unique testing ground for the theories of exotic systems in nature. In atom ic Fermigases, tunable strong interactions are produced using Feshbach resonance [1, 2, 3]. By sweeping the magnetic eld in the Feshbach resonance experim ents, magnitude and nature of the two-body interaction strength changes from repulsive to attractive. A cross the resonance the s-w ave scattering length a goes from large positive to large negative values. The ferm ionic system becomes molecular Bose-Einstein condensates (BEC) for strong repulsive interaction and transform into the Bardeen-Cooper-Schrie er (BCS) super uid when the interaction is attractive. The rst observations of BEC of molecules consisting of loosely bound ferm ionic atoms [4, 5, 6] initiated a series of explorations [7, 8, 9, 10, 11, 12] of the crossover between ${\tt BEC}$ and ${\tt BCS}$ super uid. Near the resonance, the zero energy s-wave scattering length a exceeds the interparticle spacing and the interparticle interactions are unitarity lim ited and universal.

One of the hallmarks of super uidity, be it bosonic or ferm ionic, is the presence of quantized vortices. Recently, large number of vortices in a Ferm i gas along the BEC-BCS crossover are indeed observed [13] and it proofs that this strongly interacting system is really super uid. Equilibrium properties of vortices in a rotating Ferm i super uid described by BCS theory have already been the subject of several studies [14, 15, 16, 17, 18]. There have been known several outstanding vortex problems associated with the ferm ionic excitations around a vortex core in the quantum limit of a superconductor under magnetic eld [19].

The successful measurements of the breathing mode frequencies in a non-rotating Ferm i super uid [20, 21] and the availability of the vortex lattices in a rotating Ferm i super uid [13] have stimulated us to study theoretically the collective excitation spectrum of a rotating Ferm i super uid containing large number of vortices along the BEC-BCS crossover. So far, both theoretical [22, 23, 24] and experimental [25] results have been obtained for low-energy modes of a rotating, weakly interacting condensates with large number of vortices. As in the case of a rotating bosonic clouds, the frequencies

of the collective modes of a Ferm i super uid along the crossover in presence of the vortex lattices can be measured experimentally with high accuracy.

In this work, we calculate all low energy frequencies of the transverse excitations of a strongly interacting Ferm i super uid contains vortex lattices along the BEC-BCS crossover. In particular, we nd that the Ferm i superuid in the BEC regime enters into the lowest Landau level at fast rotation. However, the superuid in the unitarity and the BCS regimes occupy many low-lying Landau levels even at fast rotation. At fast rotation, the radial breathing mode frequency becomes close to $2!_r$ (!r is the radial trap frequency) in all the regimes along the crossover, in contrast to the non-monotonous behavior of the breathing mode along the crossover in the non-rotating systems [26].

W e consider a large number of vortices form ed in a rotating Ferm i super uid con ned by a cigar shaped harm onic trap potential $V_{ho}\left(r;z\right)=\left(M=2\right)\left(!\frac{2}{r}r^2+!\frac{2}{z}z^2\right)$. We shall use the concept of di used vorticity which has been successfully used to study the low energy excitations and the dynam ics of the weakly interacting atom ic BEC in presence of large number of vortices [22, 23, 24]. The di used vorticity, r=v=2, of a vortex lattice is an elective coarse-grain averaged description that simplies the form alism by smoothing out the elect of the individual vortices. The concept of di used vorticity is suicient to describe the dynam ics at macroscopic distances, larger than the average distance between vortices.

W e assume that the system behaves hydrodynam ically throughout all the regime. If the system is BCS superuid, then as long as the oscillation frequency is below the gap frequency ($_{\rm g}$ =h) needed to break up a Cooper pair, this condition is expected to be fullled. W ithin the coarse-grain hydrodynam ic description, the equations of motion for the density and the velocity eld which are written by the following continuity and Euler equations, respectively,

where (n) is the density-dependent chemical potential. Also, $v=(h=2M\)r$ is the super uid velocity of a particle of mass M . The terms 2M v and $r\ [(l=2)M\ ^2r^2\]$ are the Coriolis and the centrifugal forces, respectively. The equation of state enters through the density-dependent chemical potential. We assume the power-law form of the equation of state as (n) = C n . At equilibrium, the density pro letakes the form $n_0(r)=(=C)^{1=}(1\ r^2)^{1=}$, where $=(M=2)(!\frac{2}{r})^2R_?^2$ is the chemical potential, $R_?$ is the radial size and $r=r=R_?$. We are interested to study the radial excitations, therefore, we neglect the weak harm onic con nement along the z-direction.

We linearize the density, velocity eld and the equation of state (n) around their equilibrium values as $n=n_0(r)+n$, $v=v_0+v$ and (n)= $(n_0)+(\theta=\theta n)j_{n=n_0}$ n. In the co-rotating frame, the equilibrium velocity eld $v_0=0$. Thus we obtain the equations of motion for the density and the velocity uctuations in the rotating frame as

We shall follow Ref. [24] to determ ine the relationship between the density and the phase uctuations in presence of the vortex lattices. We are looking for the normal mode solutions of the density and phase uctuations as $n / e^{im} e^{i!t}$ and $e^{im} e^{i!t}$, where m is the azim uthal quantum number, is the polar angle and ! is the excitation frequency in the rotating frame. Equation (4) can be written in terms of the phase uctuations after separating into radial and angular components as

Integrating Eq. (5) with respect to r, we then get,

Equating equations (6) and (7), one gets

D i erentiating the above equation on both sides with respect to the radial coordinate r and it gives the C auchy equation:

The general solution of the above equation is given by $= c^{\dagger} r^{m} + c r^{m}$, where c^{\dagger} and c are arbitrary constants. The velocity uctuation along the radial direction can be obtained as $v_{r} = (h=2M)(m=r)(c^{\dagger} r^{m} c r^{m})$. The radial velocity can not diverge as r! 0. Therefore, c = 0 for m > 0 and $c^{\dagger} = 0$ for m < 0. This gives us

Substituting Eq. (10) into Eq. (6), we obtain the following relationship between the density and the phase uctuations:

Taking gradient of Eq. (11) and then substituting it into Eq. (3), we then get,

where $\cdot = !=!_r$ and $\sim = =!_r$. Here, $: (n_r;m)$ is a set of two quantum numbers, where n_r is the radial quantum number.

W hen = 0, the solutions of Eq. (12) are known analytically [27]. For = 0, the eigenspectrum is given by

where $P_n^{(a,b)}(x)$ is a Jacobi polynom ial of order n. Assuming the net elect of a coarse grain averaged vortex lattice on the wave functions to be a modication of the elective trapping potential. Therefore, we shall use the above wave function as our ansatz. With this ansatz for n (r;), the expectation value of Eq. (12) is given by

The above quadratic equation can be solved to get the following eigenfrequencies in the rotating frame:

The eigen frequencies in the laboratory frame are obtained by using the simple relation $!_{\rm rot} = !_{\rm lab} \mod$ and it is given by

The frequencies of the m = 0 m odes are identical in both the rotating and the laboratory frames and the energy degeneracy is restored for the m = 1 m odes in the laboratory frame. The dipole mode gives $\raisebox{.06ex}{$\stackrel{\cdot}{}_{0}$}$, $\raisebox{.06ex}{$_{1}$}$ = 1 for all which satis es the generalized K ohn's theorem .

When = 1, it reproduces the known result for weakly interacting rotating BEC with a large number of vortices [24]. The eigenfrequencies given in Eq. (17) with = 1 successfully describes the low energy transverse excitations of a rotating atom ic BEC containing large number of vortices [24]. In particular, the rst (! $_{1,0}$) and second (! $_{2,0}$) radial breathing modes are in good agreement with the experimental as well as numerical results of weakly interacting BEC [25, 28]. Moreover, the quadrupole modes (! $_{0,2}$) are in good agreement with the numerical results obtained by solving the Bogoliubov-de Gennes equation [29].

At zero tem perature, the energy per particle of a dilute Ferm i system can be written as = (3=5)E_F (y), where $E_F=h^2k_F^2$ =2M is the free particle Ferm i energy and (y) is a function of the interaction parameter $y=1=k_F$ a. The M onte C arlo calculations of Refs. [30,31] nd (y!0) = 0.42 0.01 which is in fair agreement with the experiments [9, 10]. On the basis of the data of Ref. [31], M anini and Salasnich [32] proposed the following analytical thing formula of (y) for all the regimes along the BEC-BCS crossover:

This analytical expression is well tted with the data of Ref. [31] for a wide range of y on both sides of the resonance. Two-di erent sets of parameters are considered in Ref. [32]: one set in the BCS regime (y < 0) and another set in the BEC regime (y > 0). In the BCS limit, the values of the parameters [32] are $_1 = 0.42$, $_2 = 0.3692$, $_3 = 1.044$, $_1 = 1.4328$ and $_2 = 0.5523$. In the BEC limit, the values of the parameters [32] are $_1 = 0.42$, $_2 = 0.2674$, $_3 = 5.04$, $_1 = 0.1126$ and $_2 = 0.4552$. The chemical potential is given by [32]

where $^0(y)=0$ (y)=0y and F (y) = (y) (y=5) $^0(y)$. Due to the e ect of the solid body rotation and the harmonic trapping potential, the free Ferm i energy can be written as E $_F=h!_r$ [3N $(1 \ ^{2})^{1=3}$ with $=!_z=!_r$. The radialand the axial sizes can be written, respectively, as R $_?=a_r$ (24N $_?)^{1=6}$ (1 $_?^2$) $^{1=6}$ F (y), where $a_i=\frac{p}{h=M}$ $!_i$ is the harmonic oscillator length with i=r;z. The aspect ratio is given by R $_z=R$ $_?=(1 \ ^{2})^{1=2}=$ which shows that the rapidly rotating Ferm i super uid takes a pancake form even if the conning trap has a cigar shape. It is interesting to note that the aspect ratio is the same for all the regimes along the BEC-BCS crossover.

It is seen from Eq. (17) that when $! !_r$ all transverse modes with m = 0 in all the regimes along the




FIG.1: Plots of the chem ical potential vs coupling parameter y of a trapped Ferm igas with $N=2 ext{10}^6$ and =23-57.

BEC-BCS crossover approach to the degenerate value 2!r. Such a macroscopic degeneracy is reminiscent of the degeneracy of the energy levels of a single particle in an uniform magnetic eld, leading to the well known Landau level structure. However, we should mention that our results here hold not for a single particle, but for a system of interacting particles along the BEC-BCS crossover. Therefore, the strongly interacting, rotating Ferm i super uid form s the Landau level structure when ! ! r. In Fig. 1, we plot the chem ical potential for various values of . Fig. 1 shows that the chemical potential in the BEC side is less than the cyclotron energy gap (2h!r) at the fast rotation and the system enters into the lowest Landau level. However, at the fast rotation, the chemical potential in the unitarity and in the BCS regim es are quite large com pared to the cyclotron energy gap. The ferm ionic super uid in the BCS as well as in the unitarity regimes occupies many low-lying Landau levels even at !!r.

One can extract an elective adiabatic index and its dependence on the scattering length a by de ning the logarithm ic derivative as [32]

From Eq. (17), the rst radial breathing mode frequency can be written as

When = 0, the dierence between the breathing mode frequencies at the BEC limit and unitarity limit is $\frac{1}{10} \cdot \frac{1}{10} \cdot \frac{1}{1$




FIG. 2: Plots of the rst breathing mode frequency for ~ 0 (solid line), ~ 0.75 (dashed line), ~ 0.85 (dot-dashed line) and ~ 0.97 (dotted line).

in fair agreem ent with the theoretical result $!_1$ (= 0) = $\frac{1}{2(+1)!_r}$. In Fig. 2, we plot the rst radial breathing m ode in all the regimes along the BEC-BCS crossover for various values of . It is interesting to see from Fig. 2

that the di erence between the breathing mode frequencies at the BEC-lim it and the unitarity \lim it decreases as increases. In fact, the breathing mode in all the regimes approaches 2! $_{\rm r}$ when $! !_{\rm r}$. The shrinking of the di erence of the breathing mode frequency could be observed in the future experiment.

In conclusion, we have obtained an analytic expression for the collective excitation spectrum of a Ferm i superuid containing vortices along the BEC-BCS crossover. The spectrum reduces to the Landau level structure in the fast rotating regime. The super uid in the BEC regime goes into the lowest Landau level when $!\ !\ r$. However, the super uid in the unitarity and the BCS regimes occupies many low-lying Landau levels at the fast rotating regime. The dierence between the breathing mode frequencies at the unitarity and the BEC limits shrinks to zero in the fast rotating regime.
