# Superconducting pairing and density-wave instabilities in quasi-one-dim ensional conductors

U sing a renorm alization group approach, we determ ine the phase diagram of an extended quasi-one-dim ensional electron gas model that includes interchain hopping, nesting deviations and both intrachain and interchain repulsive interactions. d-wave superconductivity, which dominates over the spin-density-wave (SDW) phase at large nesting deviations, becomes unstable to the benet of a triplet f-wave phase for a weak repulsive interchain backscattering term  $g_1^2 > 0$ , despite the persistence of dominant SDW correlations in the normal state. Antiferrom agnetism becomes unstable against the formation of a charge-density-wave state when  $g_1^2$  exceeds some critical value. While these features persist when both Umklapp processes and interchain forward scattering ( $g_2^2$ ) are taken into account, the elect of  $g_2^2$  alone is found to frustrate nearest-neighbor interchain d-and f-wave pairing and instead favor next-nearest-neighbor interchain singlet or triplet pairing. We argue that the close proximity of SDW and charge-density-wave phases, singlet d-wave and triplet f-wave superconducting phases in the theoretical phase diagram provides a possible explanation for recent puzzling experimental notings in the Bechgaard salts, including the coexistence of SDW and charge-density-wave phases and the possibility of a triplet pairing in the superconducting phase.

#### I. IN TRODUCTION

The theory of low-dim ensional metals has exerted a strong in uence on our understanding of ordered phases in quasi-one-dim ensional (quasi-1D) organic conductors. The description of the extensively studied Bechgaard salts series ((TMTSF)2X) and their sulfur analogs, the Fabre ((TMTTF) $_2$ X) salts, has served over more than two decades to illustrate this view . 1,2,3 For these materials, a direct correspondence can be traced between the various modulated spin and charge ordered states of their phase diagram and the possible states of the quasi-1D electron gas model when the couplings are repulsive and the lling of the band is commensurate with the underlying lattice.4,5 In its standard form, this generic model is de ned by the phenom enological expression of the direct interaction between electrons in term sofweak intrachain backward (g1) and forward (g2) electron-electron scattering processes, to which Umklapp (g3) scattering amplitudes are added at com m ensurate band lling.5,6,7,8 The quasi-1D character of the model is dened by adding an interchain single electron hopping integral to, which is at least an order of magnitude smaller than its longitudinal counterpart.

In virtually all compounds of the above series, superconductivity is observed next to a spin-density-wave state for some critical value on the pressure scale, 9,10,11,12 whereas antiferrom agnetic spin correlations are found to dominate the metallic state precursor to superconductivity over a wide range of temperatures. 13,14 On the theoretical side, however, for spin-independent repulsive couplings and for a Ferm i surface with good nesting prop-

erties, the coexistence of spin-density-wave (SDW) and superconducting (SC) correlations is essentially excluded from the model phase diagram. 15,16 It is only when deviations from perfect electron-hole sym metry (nesting) are introduced and the long-range component of the SDW order is suppressed that superconductivity can be actually realized in place of magnetism. 17,18 In the anisotropic metallic phase where this suppression takes place, interchain Cooper pairing is enhanced and superconductivity em erges from the coupling between the weakened electron-hole and the still singular electron-electron scattering channels. Recent calculations 19,20,21 using the renormalization group (RG) method did con methoexistence of such an electronic pairing mechanism beyond the level of single-channel RPA-like approaches. 22,23,24,25,26 A smooth crossover from the SDW state to superconductivity has then been found whenever the amplitude of nesting deviations reaches some threshold { a result in accordance with the sequence of transitions observed as a function of pressure.9,11,27

The RG approach shows nevertheless that whenever antiferrom agnetism stands out as the dom inant correlation in the normal state, the most stable interchain pairing is invariably a spin singlet state corresponding to a d-wave' symmetry gap with nodes on the Fermi surface. Although some experimental ndings in the Bechgaard salts and their sulfur analogs do agree with this type of pairing, 27,28 other series of observations have rather been interpreted in support of a triplet order parameter, 29,30,31,32 thus challenging the singlet scenario for superconductivity. Though there is too little so far to favor one scenario over another, these observations

bring us to the question of whether triplet superconductivity can be possible or not when short-range antiferrom agnetic correlations are dom inant in the m etallic state. As is well known for the electron gas model, there is a region of the phase diagram where triplet 'p-wave' superconductivity does exist as the most stable state. It has been suggested, on a phenomenological basis, that such a state is realized in the Bechgaard salts. 33 W ithin a microscopic approach, the region where p-wave superconductivity is stable is de ned by irrelevant Um klapp scattering and by a backward scattering coupling that is much larger than forward scattering. However, this description pattern for superconductivity can be considered unsatisfactory given the unrealistic constraint it puts on the coupling constants, and for the suppression of both the antiferrom agnetism at short distance and the M ott pseudo gap in the charge sector. These aws can hardly be reconciled with the related phenomenology of these m olecular com pounds observed around the critical pressure for superconductivity, when either the temperature or the magnetic eld is varied. 1,14,34,35,36

Another way to look at this problem is to consider m ore closely the e ect of charge uctuations on superconductivity. Staggered charge uctuations are known to favor triplet pairing at odd but large angular momentum, a mechanism whose roots go back to the early work of Kohn and Luttinger about Cooper pairing in the presence of charge { Friedel { oscillations in isotropic Ferm isystem s. For the quasi-1D electron gasm odel and its version for lattice electrons, recent calculations have shown that triplet f-wave pairing is indeed enhanced when intrachain couplings are chosen to boost chargedensity-wave (CDW) uctuations close to the level found in the SDW channel. 21,38,39,40 However, for realistic repulsive couplings, d-wave pairing still remains tied to the highest critical tem perature and hence to the most stable state for superconductivity.

A 11 this goes to establish the robustness of d-w ave pairing for the model with repulsive intrachain couplings and nesting deviations. It turns out, however, that the model is incomplete when charge uctuations are found along the chains since then interchain Coulomb interaction is also present in practice. The inclusion of direct interchain electron-electron scattering processes, which will be denoted by  $g_{i=1;2;3}^{?}$  in the following, de nes the quasi-1D electron gas model in its extended form. 41 At large momentum transfer, the interchain interaction is wellknown to favor a CDW ordered state. 41,42,43,44,45 This mechanism is mostly responsible for CDW long-range order observed in several organic and inorganic low-dimensional solids.46,47 The physical relevance of interchain interactions in the Bechgaard salts, besides the intrachain gi and to, is supported by x-ray studies, which revealed that the SDW phase of these compounds is actually accompanied by CDW order. 48,49,50 On the theoretical grounds, very little is known about the impact of adding direct interchain interactions on the structure of the phase diagram, especially in the repulsive sector when both a nite t?

and nesting deviations are present.

In this work we wish to determ ine the possible densitywave and superconducting states of the extended quasi-1D electron-gas model. In order to tackle this problem we shall apply the renormalization group method, which at the one-loop level has proved to be suited to reach a controlled description of interfering density-wave and superconducting channels of correlations. Am ong the results reported below, we have the unexpected nding that a small repulsive interchain backscattering term  $q_1^2 > 0$ is su cient to make d-wave superconductivity unstable to the bene t of a triplet f-wave phase. This occurs despite dominant SDW correlations in the metallic state and stable itinerant antiferrom agnetism at lower nesting deviations. Under the latter conditions, SDW order becomes in turn unstable to the formation of a CDW state when the amplitude of gi exceeds some critical value. While these features persist when commensurability e ects are taken into account and small { half-lling { Umklapp scattering is included, the e ect of interchain forward scattering  $(g_2^2 > 0)$  is found to frustrate nearestneighbor interchain d- and f-wave pairing and to favor instead superconductivity with next-nearest-neighbor interchain pairing. Part of these results have been reported in Refs. 51,52.

In Section II, we introduce the model and the RG scheme employed for the four point vertices and the response functions. By way of illustration, the RG results at the one-loop levelare given for purely intrachain interactions. In Section III, we present the results for non zero interchain backward and forward interactions by which the dierent possibilities of ordered states in the phase diagram are obtained in the incommensurate case. The in uence of Umklapp processes in the half-lled case is examined in Section IV. A discussion of the results is given in section V, where a possible connection between theory and experiments is made.

## II. THE EXTENDED ELECTRON GAS MODEL

### A. M odel

We consider a lattice of N  $_2$  coupled metallic spains described by the partition function Z = D D e  $^{(S_0+S_{\rm I})}$ , which is expressed as a functional integration over anticommuting (G rassmann) elds . Here  $S_0$  and  $S_{\rm I}$  are the noninteracting and interacting parts of the action, respectively. The former part is given by

where is the chemical potential taken as temperature independent. Here we have linearized the spectrum in the chain direction, using  $v_F = 2t_k \sin k_F$  as the longitudinal Ferm ivelocity,  $k_F$  being the parallel Ferm iw ave vector if t? = 0. Throughout this work both the chain lattice constant a and the interchain distance d? are put equal to unity. The interchain single electron hopping t? is considered smallwith respect to the longitudinal bandwidth 2  $_{0}$ . In the following, we will take 2  $_{0} = 30t_{2}$ , which is a typical gure for the anisotropy ratio in quasi-1D conductors like the Bechgaard and Fabre salts. 53,54 The next nearest-neighborhopping  $t_2^0$ to in the transverse direction gives the amplitude of nesting deviations. In Eq. (3), we have neglected the possibility of hopping in the third direction, which does not have any sizeable e ect on our calculations. Its existence is of course crucial for the stabilization of true long-range order at nite tem perature.

In the framework of the quasi-1D electron gas model,  $^{6,16}$  the electron-electron interaction is parameterized by means of the g-ology approach. One rst distinguishes between right and left moving fermions, depending on their velocity along the chains, so that the Grassmann variables  $^{()}_{\kappa}$  become

where N is the number of lattice sites and G =  $(0;4k_F;0)$  the reciprocal lattice vector along the chains, which is involved in the Um klapp scattering at half-lling. Here we have om itted the so-called  $g_4$  contribution for the interaction of electrons of the same branch since this coupling does not contribute to the singular channels of correlation in the renormalization group ow at the one-loop level. If we restrict ourselves to intrachain and nearestneighbor chain interactions, the amplitudes of the bare interactions are given by

where the only  $\{$  transverse  $\{$  m om entum dependence com es from the interchain interaction. In this work we

analyze the properties of the model for repulsive  $g_j$ ,  $g_j^2$  and nite Umklapp scattering, which is the physically relevant sector for realmaterials like the Bechgaard salts and their sulfur analogs.

# B. Renorm alization group equations for the interactions

The renormalization group can be applied to the problem of quasi-1D systems of interacting electrons in different ways. 19,55,56,57 In the following, we shall adopt the so-called one-particle irreducible (1PI) momentum shellRG scheme, as developed by Honerkamp et al.  $^{58}$  (cf. also Binz et al. 59). In this scheme, the 1PI vertex func-(K i) of a physical system with infrared cuto are calculated. Only degrees of freedom with energies equal to or greater than the cuto are integrated out, which allows one to establish a direct link with the low energy e ective action S eff with an ultraviolet cuto , as obtained in a Kadano -Wilson renormalization group scheme. According to Morris,  $^{60}$  if  $_{\rm k_{+}}$  < , the eective interactions geff (K i) that appear in Seff are simply  $q^{eff}(K_{i}) =$ (K ;).

The free particle propagator is suppressed for energies below an infrared cuto ,

where is the step function. Setting all vertices involving m ore than two particles to zero, the renormalization group equations to the one-loop level are obtained. We also neglect self-energy corrections.

It is practically impossible to take into account the complete functional dependence of the vertices, which will in general vary with the wave vectors k as well as with the frequencies  $k_0$  of the incoming and outgoing particles. By means of scaling arguments, one can show that the frequency dependence is irrelevant in the renormalization group sense, cf. for example Ref. 61. The same is true for the dependence on the distance of the wave vector k from the Fermi surface. Irrelevant variables are not necessarily negligible, in the sense that they may in principle have an in uence on the RG ow before they vanish. However, the  $k_s$  dependence, with  $k_s$  the projection of the wave vector on the Fermi surface, remains by far the most important one in the low energy limit. We will hence only consider the dependence of the functions

on the positions of the wave vectors along the Ferm i surface, which we will param eterize by  $k_{?}$ . Due to momentum conservation, it is in general in possible to have all four arguments of a given vertex on the Ferm i surface. U sually, the ow of the vertices with three arguments on the Ferm i surface is calculated. In the case of in perfect nesting, such a procedure will underestimate the SDW correlations. In our case, the strong anisotropy of the dispersion relation allows us to make a slightly dierent

choice. We x the values of  $k_k$  and  $k_0$  such that the most divergent contributions to the renormalization group ow are taken into account. If we dene the Cooper, Landau, and Peierls momentum variables

In this equation,  $\mathbf{q}_{\mathbb{L}}$ ,  $\mathbf{q}_{\mathbb{L}}$  and  $\mathbf{q}_{\mathbb{P}}$  are functions of the internal loop momentum—frequency  $k_{\text{loop}}$ . The most divergent contributions to the RG ow are obtained if  $\mathbf{q}_{\mathbb{C};0} = \mathbf{q}_{\mathbb{C};0}^{(0)} = 0$  for the frequencies, as well as

for the longitudinal components. Note that, for either choice of the  $k_k$  dependence, one does not obtain a closed set of equations. The renormalization group equations for vertices for which relations (9) are valid contain vertex functions with dierent values of  $q_{\!\scriptscriptstyle C}$ ,  $q_{\!\scriptscriptstyle P}$ . We will therefore need to replace these functions by those calculated by in posing conditions (9).

For the dim ensionless vertices  $^{\sim}$  = ~ =  $v_{\rm F}$  , we thus obtain the equations  $^{62}$

For continuity reasons, we always take (0) :=  $\frac{1}{2}$ . The starting values are given by the bare interactions, cf. section IIA.

It is useful to consider the following limiting cases for the RG equations. As long as t<sub>?</sub>, we may take their 1D lim it (to = 0). In this regime, the Cooper and Peierls renormalization channels are entirely coupled, in the sense that all vertices are strongly renormalized in both channels (except for Umklapp processes, which only appear in the Peierls channel). When the coupling between the Cooper and Peierls channels is weak in the sense that, depending on the arguments k?, most vertices are strongly renormalized in only one (or no) channel at a time. Nevertheless, the remaining interplay between the channels is at the origin of spinand charge-uctuation-induced superconductivity in the weak coupling regime. For purely repulsive interactions, the Peierls channel is the most important one as long as deviations from perfect nesting may be neglected, i. e.  $t_2^0$ . In the presence of attractive e ective interactions, the Cooper channel plays an important role, and

will be dominant when  $t_2^0$ . The RG equations are written in these limits in appendix A.

A sim ilar dimensional crossover may be observed with respect to the temperature instead of . As long as T t<sub>2</sub>, the functions we calculate do not vary very strongly with the transverse wave vector, contrary to the low temperature case. An example is given in Fig. 2 (a).

#### C. Response functions

In order to evaluate susceptibilities, we add a term of the form

to the action. The rst term describes pairing and the second term density-wave correlations. The external elds  $h^{(\ )}(q)$  are taken to be in nitesimal. They couple to pairs of ferm ionic variables which we will de ne in the following. Let us rst introduce the particle-particle operators

The function z describes the orbital sym m etry of the superconducting order parameter. We classify these or-

We will make use of these relations in the following, when we discuss density uctuation induced Cooperpairing. Note that Um klapp processes do not couple to the Cooper channel, and therefore a ect Cooperpair form ation only indirectly via their election  $g_{\rm C}$ ,  $g_{\rm S}$ .

The RG equations are solved numerically, using a fourth order Runge-Kutta algorithm  $^{63}$  with xed step

sizes (taking large steps in the beginning of the ow and short steps close to the divergence). The graphs showing transition temperatures are obtained with the help of an adaptive stepsize algorithm  $^{63,64}$  As far as the  $k_{?}$  dependence of the vertex functions is concerned, we discretize the Ferm i surface using 32 patches for each sheet. Taking advantage of all symmetries of the problem, we thus have to calculate 9010 dierent function values for each  $_{\rm j}$ . The use of twice the number of patches does not significantly modify our results. The integral of the functions B  $_{\rm C,p}$  must be calculated more precisely; we use a fourth order R unge-K utta algorithm with adaptive stepsize.





FIG. 1: RG phase diagram for the quasi-1D electron gas model at incommensurate lling  $(g_3=0)$  with intrachain interactions  $(g_j^2=0)$  and nesting deviations, parameterized by  $t_j^0$ . The circles indicate the transition temperature for SDW and the triangles that for SCd. All gures in this article are obtained using the bare intrachain interactions  $g_1=0.32$ ,  $g_2=0.64$  and the anisotropy ratio  $_0$ = $t_2$ =15.

#### D . Results for the case of intrachain interactions

To illustrate our method, we shall rst consider the by now wellknown case of a quasi-ID electron gas model with purely intrachain interactions and no Umklapp scattering. This case has been studied in detail by Duprat and Bourbonnais<sup>19</sup> using a Kadano -Wilson RG scheme and an approximation where only two independent momentum variables for the vertices were taken into account. We here use the IPI scheme and retain the full three variable dependence for the vertices. Our results con mm those of reference 19.

The RG calculations that follow are performed for the values  $g_1 = 0.32$  and  $g_2 = 0.64$ , which are representative of the couplings likely to be found in practice in low dim ensional conductors. Thus for not too large nesting deviations, the renormalization group ow scales to strong coupling, which leads to a singular behavior in the susceptibility of a particular channel of correlations. This signals an instability of the normal state towards an ordered phase. The phase diagram obtained as a function of to is shown in Fig. 1. For good nesting, there is an SDW phase with a modulation wave vector  $Q_0 = (2k_F; )$  that corresponds to the best nesting vector of the spectrum (2). The transition temperature obtained for perfect nesting ( $t_c^0 = 0$ ) is  $T_c^0$ 200 K, we have  $T_c^0$  11 K, which falls If we take  $t_?$ in the range of the experimental Tc for systems like the Bechgaard salts at low pressure. By increasing  $t_0^0$ , the transition temperature decreases until the threshold value  $t_{2}^{0}$ 0:045t 9 K is reached, where the SDW is suppressed and replaced by d-wave superconductivity (SCd). The maximum temperature for the SCd state m ates for  $t_{\rm c}^0$  and  $T_{\rm c}$  are com parable to the experim ental results.  $^{9,19,65,66}$ is found to be  $T_c^0$  (SCd) 0:4 K. These esti-






FIG .2: Tem perature dependence of the susceptibilities in the norm alphase  $(g_3 = 0, g_1^2 = 0)$ :





The orderparam eter of the low temperature phase can be identied in two dierent ways, which give equivalent results. The rst one follows from the identication of the most singular behavior in the temperature dependence of the various susceptibilities, as shown in Fig. 2 for values of  $t_{\rm c}^0$  below and above the threshold for superconductivity.




FIG. 3:  $^{\sim}_{\text{S}}$  (  $k_{2}^{0}$ ;  $k_{2}^{0}$ ;  $k_{2}$ ;  $k_{2}$ ;  $k_{2}$ ) in the SDW regime ( $t_{2}^{0}$  = 0.04 $t_{2}$ ) close to the divergence (a), in the SCd regime ( $t_{2}^{0}$  = 0.048 $t_{2}$ ) at an intermediate stage of the ow (b) and close to the divergence (c). The vertical scale is arbitrary.

An alternative way to determ ine the nature of the ordered phase is to look at the wave vector dependence of the renormalized vertex functions close to the divergence. In Fig. 3, we have plotted the SDW vertex function  $_{\rm S}$  (  $k_{\rm c}^0$ ;  $k_{\rm c}$

A plot of the singlet interaction amplitude  $_{\rm S}$  gives essentially the same picture. From Eq. (27), it is clear that the most divergent vertex part in such a situation is the one proportional to  $\cos k_2$ .

Recall that the vertex functions we calculate in our RG scheme are equal to the elective interactions  $g^{eff}$  of a Wilsonian low energy elective theory. Quite early during the ow, the vertex associated to the spin density,  $g(k_{j?})$ , and hence  $g(k_{j?})$ , develops a peak structure similar to the one close to the SDW transition, but less pronounced, cf. Fig. 3 (b). There are thus important spin uctuations at temperature or energy scales above the transition temperature for superconductivity, as is conmed by the behavior of the associated susceptibility, Fig. 2 (b). The same peak structure appears in the elective interaction between electrons forming a singlet (or triplet) pair,  $g(k_{j?})$ . We can decompose the peak of  $g(k_{j?})$ ,  $k_{j?}$ ,  $k_{j?}$ ,  $k_{j?}$ , at intermediate cuto in terms

jn j corresponds to the distance between the chains where the two interacting electrons are located. In the SDW regime, Fig. 3(a), gs has the form of a peak, so that  $all a_n > 0$  will be equal. In the superconducting regim e, Fig. 3 (b), the peak is slightly enlarged, so that  $a_n > 0$  will be som e decreasing function of jn j. W e thus see that, due to the spin uctuations, the e ective interaction between particles forming a singlet pair contains attractive contributions at all chain distances. (Note that, according to our de nitions Eqs. (29) and (30), an \attractive" interaction corresponds to positive  $g_{s;t}$ .) The most important one is the nearest-neighbor chain one,  $cosk_?$  (SCd), followed by  $\sin 2k_2$  (SCg),  $\cos 3k_2$  etc., as it can also be seen from the calculation of the related pairing susceptibilities, cf. Fig. 2(b). Note that, according to the relations (31), gs also gives an attractive contribution to the triplet channel. However, all the three components of a { spin-one boson { SDW uctuation contribute to the superconducting coupling in the singlet channel, whereas only one contributes to the triplet channel. Antiferrom agnetic uctuations thus favor singlet pairing as com pared to triplet pairing. On the other hand, according to Eq. (31), strong charge uctuations should in principle be able to change this tendency.

# III. IN TERCHAIN IN TERACTIONS AND TRIPLET SUPERCONDUCTIVITY: IN COMMENSURATE CASE

In this section, we exam ine the role of interchain interactions in the phase diagram of the extended quasi-1D electron gasm odel. We will rst consider the in uence of interchain backward scattering  $g_1^2$  and forward scattering  $g_2^2$  separately, before studying their combined electron. The intrachain interactions are kept in xed to their values used in the previous section. Concerning the nesting quality, the overall picture remains the same. For weak deviations from perfect nesting, we indicate the same of the previous sections, and the discarding possible Kohn-Luttinger electrons, and the discarding possible Kohn-Luttinger electrons at low temperatures beyond the numerical accuracy of our RG calculations are the reallic phase when the nesting is deteriorated even more.




FIG. 4: Low temperature phases versus  $g_1^2$ , keeping  $g_2^2=0$  and  $g_3=0$ . Circles indicate a SDW phase, squares a CDW phase, triangles SCd ( $\cos k_2$ ) and crosses SCf (r  $\cos k_2$ ). In the region below the dotted line, spin uctuations dominate over charge uctuations in the normal phase.




FIG . 5: Transition temperatures for dierent values of  $g_1^?$  , when  $g_2^?$  = 0 and  $g_3$  = 0:




FIG. 6: Temperature dependence of the susceptibilities in the normal phase above the SCd phase ((a)  $\mathbf{g}_1^2=0$  and (b)  $\mathbf{g}_1^2=0.98$ ) and above the SCf phase ((c)  $\mathbf{g}_1^2=0.10$ ), keeping  $\mathbf{g}_2^2=0$ ,  $\mathbf{g}_3=0$  and  $\mathbf{t}_2^0=0.956\mathbf{t}_2$ . The continuous line corresponds to SDW, the dotted line to CDW, the dashed line to SCd and the dashed-dotted line to SCf correlations.

By sw itching on  $g_1^2$  gradually on the positive scale, one observes that at small values of  $g_1^2$ , the SDW phase remains essentially una ected, whereas the transition temperature for d-wave superconductivity is considerably re-

duced by the presence of a nite  $g_1^2$  (Fig. 5), and the region where superconductivity is stable shrinks (Fig. 4). For higher  $g_1^2$  ( $g_1^2$  of the order of  $\frac{1}{3}$  of the intrachain backscattering g1), d-wave superconductivity turns out to be no longer stable and an f-wave triplet superconducting phase appears. In this param eter range,  $(2k_F;$ ) charge uctuations are strongly enhanced by interchain backward scattering (Fig. 6). However, spin uctuations remain important, and in a sizeable region of the phase diagram, triplet superconductivity is preceded in temperature by dominant spin uctuations in the normal state (Figs. 4 and 6). For the values of intrachain interactions used in this section, and  $g_1^2 = 0.105$ , one nds a max- $\operatorname{im} \operatorname{um} \operatorname{T}_{c}^{0}(\operatorname{SC} f)$ 0:001t 02 K, that is of the same order of m agnitude as that of the d-w ave case.  $T_{\text{c}}$  (SC f) increases with the amplitude of  $g_1^?$  , and the superconducting phase widens (Figs. 4 and 5). Once triplet superconductivity occurs,  $g_1^2$  starts to a ect the density wave phase: The SDW state is suppressed and replaced by a CDW. The values of  $g_1^2$  for which SCf and CDW phases rst appear depend on the values of intrachain interactions and increase with the value of the ratio  $q_1 = q_2$ .

The origin of the f-wave SC and CDW phases can be understood by considering the contribution of the  $g_j^2$ 's to the (bare) scattering am plitudes in the singlet and triplet particle-particle channels, as well as in the charge and spin channels:

From these equations, it can be easily seen that the interchain repulsion  $g_1^2$  contributes positively to  $g_0^2$  at  $q_2=$ , and therefore induces CDW correlations with a phase dierence of between neighboring chains. In the Cooper channel,  $g_1^2$  favors triplet f-wave and singlet  $d_{xy}$ -wave pairing, whereas its contribution to singlet  $d_{x^2-y^2}$ -wave and triplet  $p_y$ -wave pairing is negative. As for  $g_2^2$ , it tends to suppress both singlet and triplet pairings on nearest-neighbor chains.

In addition to this direct' contribution there is also an indirect e ect due to the exchange of density uctuations. Upon renorm alization,  $(2k_F; )$  CDW correlations are enhanced beyond the level expected from a mean-eld treatment of  $g_1^2$ . A These CDW uctuations enhance triplet f-wave pairing but suppress singlet pairing, whereas the SDW uctuations are well known to favor singlet pairing (see Eqs. (31)). Eq. (32) shows that the latter reinforce  $d_{x^2-y^2}$ -but suppress  $d_{xy}$ -wave pairing. Regardless of the values of the interaction constants  $g_1$ ,  $g_2$  and  $g_2^2$ , the CDW and triplet f-wave phases always appear almost simultaneously when  $g_1^2$  increases. This suggests that CDW uctuations (rather than the direct e ect of  $g_1^2$  in the Cooper channel [Eqs. (34)]) provide the dominant driving force leading to f-wave superconductivity.




FIG .7: Low temperature phases for  $g_2^2$  varying, keeping  $g_1^2=0$  and  $g_3=0$ . Circles indicate a SDW phase, triangles SCd and diam onds SCg (r sin  $2k_2$ ).




FIG. 8: Transition temperatures for dierent values of  $\mathbf{g}_2^2$ , if  $\mathbf{g}_1^2=0$  and  $\mathbf{g}_3=0$ :  $\mathbf{g}_2^2=0$  (SDW! SCd, continuous line), 0:16 (SDW! SCd, dashed line) and 0:20 (SDW! SCg, dotted line).

We now consider the e ect of interchain forward scattering  $g_2^2$  alone, setting  $g_1^2=0$ . From Eqs. (34), it can easily be seen that  $g_2^2$  contributes negatively to both  $g_s^2$  and  $g_t^2$  and then favors the suppression of the nearestneighbor-chain Cooper pairing induced by spin uctuations. Our results (Figs. 7 and 8) show that this is

indeed the case. We have seen, however, in section IID, that SDW uctuations can generate a smaller yet present attractive interaction between electrons on next-nearest-neighbor chains, which is not a ected by  $g_2^2$ . It follows that when d-wave superconductivity is su ciently weakened by  $g_2^2$ , it is replaced by g-wave singlet pairing

#### $(r(k_2) / r \sin 2k_2)$ . This is shown in Fig. 7.

It is worth noting that the instability of the normal state with respect to superconductivity with high angular momentum pairing can be seen as a result of the K ohn-Luttinger e ect originally predicted for isotropic metals. At variance with more isotropic systems, however, the RG results show that for a quasi-1D metal, the transition temperature of high angular momentum superconducting phases, like SC g, remains experimentally accessible. We not  $T_{\rm c;SC\,g}^{\rm max}$ 0.0025, 0.4 K. Finally, the SDW phase remains nearly una ected by  $g_2^2$ . This can be understood from Eqs. (33), which indicate that its contribution averages out over the Fermi surface in the particle-hole channel of the RG equations.




FIG. 9: Low temperature phases for  $g_1^2=g_2^2$ ,  $g_3=0$ . Circles indicate a SDW phase, black squares a CDW phase, triangles SCd ( $\cos k_2$ ), white diam onds SCg ( $r \sin 2k_2$ ) and crosses SCf ( $r \cos k_2$ ). Below the dotted line, spin uctuations dominate over charge uctuations in the normal phase.

We now consider the combined e ect of  $g_1^2$  and  $g_2^2$ . Fig. 9 shows the results for  $g_1^2=g_2^2$ , where all aforem entioned phases appear. In the presence of both  $g_1^2$  and  $g_2^2$ , d-wave pairing is suppressed even faster than by  $g_1^2$  or  $g_2^2$  alone. The appearance of f-wave pairing is retarded by  $g_2^2$  which, as previously mentioned, is detrimental to nearest neighbor chain pairing (Eq. (34)). However, for our choice of intrachain interactions, no triplet phase with pairing on next-nearest-neighbor chains is found for

 $g_1^2=g_2^2$ , since  $g_1^2$  favors nearest-neighbor triplet pairing at the outset. As for CDW 's, they are found to occur at slightly higher values of  $g_1^2$  in the presence of a nite  $g_2^2$ . As mentioned before,  $g_2^2$  has no important e ect in the particle-hole channel alone. The slight suppression of the CDW due to  $g_2^2$  must therefore come from the 1D regime, where the correlation channels are coupled. This can be checked from the RG equations for  $t_2=0$  given in appendix A.

The phase diagram (Fig. 9) depends quantitatively and qualitatively on the bare intrachain interactions. When the ratio  $g_1 = g_2$  increases, higher values of the interchain interactions are necessary for obtaining CDW and SCf

phases because  $_{C}$  is more negative at the outset. For  $g_1=g_2$ , we even and a triplet SC f order parameter of the form  $_{r}$  ( $k_?$ ) /  $\sin 2k_?$ , corresponding to second-nearest-neighbor chain pairing, instead of  $_{r}$  ( $k_?$ ) /  $r\cos k_?$ . This is coherent with the fact that, in the 1D regime, the renormalization of  $_{1}^{2}$  is proportional to  $_{1}^{2}$   $_{C}$ , so that a more negative  $_{C}$  reduces  $_{1}^{2}$  and hence nearest-neighbor chain triplet pairing (appendix A).

## IV. EFFECT OF UM KLAPP PROCESSES

Conductors like the Bechgaard and Fabre salts are slightly dimerized in the direction of the organic chains. It follows that at low energy or temperature, the hole band can be considered as electively half led rather than quarter—led and this gives rise to Umklapp scattering processes with amplitudes  $g_3$  and  $g_3^2$ . To leading order, the bare amplitude of  $g_3$  g per E F is proportional to the dimerization gap per A,7,67 which yields a  $g_3$  that is rather weak as compared to  $g_{1;2}$ . We assume a similar ratio between the interchain couplings  $g_3^2$  and




FIG. 10: Transition temperatures when Um klapp processes are taken into account. (a) W ithout interchain Um klapp scattering:  $\mathbf{g}_3 = 0$ ,  $\mathbf{g}_j^2 = 0$  (SDW! SCd, continuous line),  $\mathbf{g}_3 = 0.02$ ,  $\mathbf{g}_j^2 = 0$  (SDW! SCd, dashed line),  $\mathbf{g}_3 = 0.02$ ,  $\mathbf{g}_1^2 = \mathbf{g}_2^2 = 0.1$ ,  $\mathbf{g}_3^2 = 0$ , (SDW! SCf, dotted line). (b) E ect of interchain Um klapp processes:  $\mathbf{g}_3 = 0.02$ ,  $\mathbf{g}_1^2 = \mathbf{g}_2^2 = 0.1$ ,  $\mathbf{g}_3^2 = 0$  (SDW! SCf, dotted line) and  $\mathbf{g}_3^2 = \frac{\mathbf{g}_1}{\mathbf{g}_1} \mathbf{g}_1^2$  (SDW! SCf, continuous line).

Intrachain Um klapp processes enhance the form ation of 'site' centered SDW correlations and bond' centered CDW correlations and weaken bond SDW and site CDW uctuations, as can be seen from Eqs. (25). Thus, contrary to the incom m ensurate case, site and bond densitywave orders no longer join together and must be considered separately with their distinct strengths at half lling. In addition, intrachain Um klapp scattering reinforces the e ective interactions  $g_C$  and  $g_S$  at momentum transfers  $(2k_F;)$ , thus increasing spin and charge density uctuations of both site and bond type. These e ects are known in the 1D case (see e.g. Ref. 69 and also Appendix A), as well as from calculations restricted to the particle-hole channels (Ref. 70 and Appendix A). Even though Umklapp processes do not enter the particle-particle channel directly, they do enhance Cooper pairing, because they am plify the peak at  $(2k_F; )$  in the e ective interactions gs:c and thus the attraction between electrons on neighboring chains [see Eq. (32)]. Since density-wave correlations are enhanced with respect to the incommensurate case, transition temperatures are also higher. This is true for the form ation of density-wave states as well as for superconductivity (Fig. 10(a)). The ratio  $T_c^0 = T_{c:SC}^{max}$ remains essentially una ected by  $g_3$ . The critical  $t_2^0$ needed to destroy the density-wave phase is also higher in the presence of Um klapp scattering.




FIG. 11: Low temperature phases in the presence of Um k-lapp processes, with  $g_3^2=0$  (a) and  $g_3^2=g_3=g_1^2=g_1$  (b), taking  $g_2^2=g_1^2$ . Circles indicate a site-SDW phase, squares a bond-CDW phase, triangles SCd (cosk<sub>2</sub>) and crosses SCf (r cosk<sub>2</sub>). Below the dotted lines, spin uctuations dominate over charge uctuations in the normal phase.

Let us now turn to the e ect of interchain interactions in the presence of Um klapp processes. We will rst consider the e ect of a nite intrachain  $g_3$ , for  $g_1^2 = g_2^2 > 0$  and  $g_3^2 = 0$ . A comparison of Figs. 9 and 11 (a) shows that the regions of d-wave and f-wave superconductivity are now enlarged, and there is no more SC g phase corresponding to next-nearest-neighbor chain singlet pairing. This is a consequence of the fact that density-wave correlations are reinforced by Um klapp scattering. A stronger  $g_2^2$  would then be needed to destroy nearest-neighbor chain pairing, but owing to the condition  $g_1^2 = g_2^2$  the

SCf phase is also reinforced and in turn stabilized once the SCd phase is suppressed.

When we nally add interchain Umklapp scattering g<sup>?</sup>, the picture does not change signicantly (Fig. 11 (b)). The only e ect is that the occurrence of SCf and CDW phases takes place at slightly higher values of the interchain interactions in the phase diagram, whereas transition temperatures are scarcely lower (Fig. 10 (b)). In the  $t_2$ ),  $g_3^2$  enhances  $g_C$  (appendix A), 1D regime ( but this is only a second order e ect. On the other hand, the bare contribution of  $g_3^?$  , Eq. (6), reduces the peak in the e ective interaction  $g_3(k_{1?}^0; k_{2?}^0; k_{2?}; k_{1?})$  at  $k_{12}^0$  $k_{1?}$  = , which is connected to the charge density uctuations (appendix A). This in uence is linear in  $g_3^2$  and therefore stronger than the 1D e ect, thus explaining the overall weakening of CDW and, in tum, of SCf correlations. There is no direct e ect ofg? on SDW correlations. However, the RG equations (Appendix A) show that  $g_3^2$  weakens the renormalization of  $g_3$  in the 1D regime and in turn the increase of transition temperatures in comparison to the incommensurate situation.

In Fig. 12, we show the typical behavior of the most

in portant susceptibilities as a function of temperature in the normal phase above the superconducting phases. Fig. 12 (a) shows that for su ciently important interchain interactions, triplet correlations are already strongly enhanced, although the ordered phase still corresponds to spin singlet pairing. SDW correlations are always important. They are the dominant uctuations in the normal phase in the major part of the parameter range we have explored, sometimes even above the triplet SC phase (cf. Figs. 12 (c) and 11).

### V. DISCUSSION AND CONCLUSION

In this work, we have determined the possible electronic phases of the extended quasi-ID electron gas model that includes both intrachain and interchain repulsive interactions, interchain electron hopping and the in uence of nesting deviations. Our results reveal that in correlated quasi-ID metals both for zero and non zero Umklapp scattering, interchain interactions can act as a key factor in expanding the range of possibilities of ordered states compared to the case where only repulsive intrachain interactions are present. 19,20,21 At large momentum transfer, the interchain electron-electron cou-




FIG. 12: Tem perature dependence of the susceptibilities in the normal phase above the SCd phase ((a)  $t_{\rm c}^0=0.152t_{\rm c}$ ,  $g_1^2=0.08)$  and above the SCf phase ((b)  $t_{\rm c}^0=0.152t_{\rm c}$  and (c)  $t_{\rm c}^0=0.176t_{\rm c}$ , both for  $g_1^2=0.12$ ), taking  $g_3=0.02$  and  $g_2^2=g_1^2=\frac{g_1}{g_3^2}g_3^2$ . The continuous line corresponds to SDW, the dotted line to CDW, the dashed line to SCd and the dashed-dotted line to SCf correlations.

pling acts as a short-range interaction that is responsible for the enhancement of CDW correlations, consistently with what was found long ago in the absence of interchain hopping.  $^{41,44}$  For nite  $t_?$ , however, interchain interaction leaves the amplitude of SDW correlations essentially una ected and a relatively small critical value of  $g_1^2$  coupling is then needed to make the CDW ordered state possible, and this, on equal footing with the SDW phase, which is known to dominate the phase diagram when only repulsive intrachain interactions are present. When nesting deviations are cranked up beyond some threshold value  $t_2^0$ , density-wave order is suppressed and

interchain interactions turn out to a ect correlations of the Cooper channel too. Thus an important conclusion that emerges from this work is the gradual suppression of interchain d-wave pairing when repulsive short-range interchain interaction increases. As a result of the growth of CDW correlations in the normal state, it ultimately yields the stabilization of a triplet SC f superconducting phase corresponding to an order parameter  $_{\rm r}(k_?) = {\rm r}\cos k_?$  having nodes on the warped Ferm i surface that are at the same locus as for the SC d case. The normal phase is still dominated by strong SDW uctuations over a sizable region of the phase diagram in this sector.

It is interesting to consider how far the RG results of this work are applicable to quasi-1D organic conductors. In the case of the Bechgaard (TM TSF)2X salts with centrosym m etric anions X for example, the observation of a SDW -CDW coexistence below the critical pressure for superconductivity 48,50,71 indicates that interchain electron repulsion is a relevant interaction in these materials besides intrachain interactions and interchain hopping. Accordingly, the RG calculations show that a relatively small and realistic amplitude of repulsive interchain interaction is su cient to bring the stability of CDW order close to SDW, indicating that this part of interaction would indeed play an important role in the emergence of density-wave order in these materials. The suppression of the SDW state (and presum ably of CDW as well) followed by the emergence of superconductivity is well known to constitute the closing sequence of transitions that characterizes virtually allm embers of the Bechgaard and Fabre salts series as one moves along the pressure scale. Since pressure introduces alterations of the electron spectrum, it prompts deviations from perfect nesting. In our model, these simulate the main e ect of pressure, which together with a reasonable set of parameters, yield a 'pressure' pro le of the critical tem perature that agrees quite well with the characteristic variation seen in experim ents. 72 A s to the nature of the superconductivity in these materials, our results based on a purely electronic model, indicate that given the observation of the close proxim ity between SDW and CDW ordered states, not only SCd but also triplet SCf order parameter becom e serious candidates for the description of the superconducting phase in these compounds (Figs. 4,9, and 11). However, as pressure also a ects the normalized am plitudes  $g_i^{(?)}$  through the band width and the dim erization gap (Umklapp), and gi through the interchain distance,7,45 the actual trajectory in the phase diagram under pressure cannot be determined with great precision. It follows that besides the possibilities SDW! SCd or SDW ! SCf, sequence of transitions such as SDW ! SCd! SCf, where one can pass from singlet to triplet SC order under pressure, cannot be excluded. It is worth rem arking that in this sector of the phase diagram, the addition of a small magnetic eld { as actually used in m any experim ents<sup>31,32</sup> { or accounting for the sm all but yet nite spin anisotropy would tend to tip the balance

in favor of a triplet order param eter. 21,73

Experim ental features of the norm alphase also argue in favor of this region of the phase diagram for the Bechgaard salts. This is the case of the puzzling growth of CDW correlations seen in optical conductivity in the low tem perature part of the metallic phase above the superconducting transition. CDW correlations are found to be signicantly enhanced in a temperature region where NMR experiments reveal the existence of strong SDW correlations. This feature cannot be captured for realistic intrachain interactions alone. It can not, however, a natural explanation in the framework of the extended quasi-ID electron gas model, for which interchain interactions can boost the amplitude of CDW correlations besides those of the SDW channel that are kept essentially unchanged.

In the case of non-centrosymmetric anions (e.g.  $X = C D_4$ ), our approach should be re ned in order to take into account the doubling of the unit cell in the transverse direction due to the anion ordering taking place below 24 K in the normal phase. The concomittant reduction of the Brillouin zone yields two electronic bands at the Ferm i level and in turn multiple nesting vectors. 75,76 An accurate description of this Ferm i surface should be incorporated in the RG approach, and a modi cation of the node structure for the SC gap is expected. 77 A previous (sim pli ed) RPA-like calculation has shown that the nodes of a d-wave SC order param eter, which are located at  $k_2 =$ =2, are precisely found where a gap opens due to  $CD_4$  anion ordering, thus making the SC phase e ectively nodeless at low temperature. 73

The results presented in this work may also be relevant for the phase diagram of other series of quasi-1D organic superconductors. In this matter, the case of the twochain compounds TTF [M] (dm  $it)_2$ ] (M = Ni, Pd) is of particular interest. These compounds are characterized by an incommensurate CDW state that takes place on the M (dm it)2 stacks at low pressure. At some critical pressure, they become superconducting. 79,80 The variation of the critical tem perature under pressure has been analyzed in detail in the case of M = Pd, which shows close sim ilarity with the one found for the Bechgaard and Fabre salts. The temperature scale for the CDW instability at low pressure is relatively large, however, and owing to the pronounced anisotropy of the band param eters in these compounds, 78,81 this indicates that the interchain interaction is likely to be a key coupling in the stabilization of a 3D ordered state in these materials. A coording to our model, these conditions would be favorable to the existence of a triplet SCf state in these system s under pressure (see e.g. Fig. 9).

A nother result that is highlighted by our analysis in the incommensurate case is the occurrence of a singlet SCg state when the interchain electron scattering dominates for small momentum transfer. The  $g_2^2$  coupling tends to suppress electron pairing between the rst nearestneighbor chains, which therefore suppresses SCd or SCf type of superconductivity. However, an instability of the

norm al state rem ains possible. It results from the oscillating tail of density-wave correlations in the transverse direction which favors longer range pairing between electrons separated by more than one interchain distance. The fact that an instability of the normal state persists in the Cooper channel illustrates how the quasi-1D geometry for electrons, with its inherent interference between Peierls and Cooper channels, is prone to magnify the Kohn-Luttingerm echanism for the (Cooper) instability of a Fermi liquid for repulsive interactions. One can easily infer from our results that the addition of longer range interchain interactions will frustrate short-range interchain pairing and shift it to larger interchain distances, thus unfolding possibilities of superconductivity at even larger angular momentum pairing.





# APPENDIX A:RG EQUATIONS IN LIMITING CASES

A lternatively, we may restrict the renormalization to a given correlation channel in certain situations. For the particle-hole channel, it is convenient to rewrite the RG equations in terms of the vertex functions  $_{\text{C},\text{S}}$  and








FIG. 13: Typical pictures of the interactions  $_{\rm S}$  (  $k_2^0$ ; $k_2^0$ ; $k_2^0$ ; $k_2^0$ ; $k_2^0$ ;  $k_$

These equations are rem arquably sym m etric with respect to spin and charge density correlations, cf. e.g. the results when we take  $g_S = g_C$  from the beginning (Fig. 13). For low temperature and energy cuto , the particle-hole loop integral  $B_P$  ( $q_P$ ) is strongly peaked for momentum transfers equal to the best nesting vector, i. e.  $q_P = .$  As can be seen from the preceding equations, this generates a peak at  $k_{1P}^0$   $k_P = in_S$  (responsible for the SDW) and in  $_C$  (responsible for the CDW). In  $_S$ , peaks are created at  $k_{1P}^0$   $k_P = as$  well as  $k_{1P}^0$   $k_P = .$  The peak in  $_S$  for  $k_{1P}^0$   $k_{2P}^0$  enhances the spin density correlations, whereas the one for  $k_{1P}^0$   $k_{1P}^0$  supports the charge density correlations.

Let us now consider the in uence of interchain interactions Eq. (6)] on these structures. Interchain Um klapp scattering  $g_3^2$  reduces the latter peak and thus weakens the charge uctuations, whereas it has no direct in uence on the spin correlations.  $g_1^2$  and  $g_2^2$  have no direct elect on the spin uctuations either. Interchain backward scattering  $g_1^2$ , on the contrary, reinforces the peak in  $g_0$  at  $k_{12}^0$  kg and thus supports the form ation of charge density waves.

We nally give the RG equations restricted to the particle-particle channel. They are most conveniently written in terms of the singlet and triplet pair interactions, = s, t:
