A ctive di usion of m otor particles

The movement of motor particles consisting of one or several molecular motors bound to a cargo particle is studied theoretically. The particles move on patterns of immobilized laments. Several patterns are described for which the motor particles undergo non-directed but enhanced di usion. Depending on the walking distance of the particles and the mesh size of the patterns, the active di usion coe cient exhibits three di erent regimes. For micrometer-sized motor particles in water, e.g., this di usion coe cient can be enhanced by two orders of magnitude.

Introduction. B iological m otor m olecules such as the cytoskeletal m otors kinesin and m yosin, which convert the chem ical free energy released from the hydrolysis of adenosine triphosphate (ATP) into directed m ovem ents along cytoskeletal lam ents, represent powerfulnanom achines. It seems rather prom ising to construct articial biom in etic devices based on these m olecular m otors and to use them, e.g., for the transport of cargo particles in the nano- and m icrom eter regine [1, 2]. These approaches are based on two di erent in vitro m otility assays, the gliding assay, for which m olecular m otors are anchored at a substrate surface and drag lam ents along this surface, and the bead assay, for which the lam ents are im m obilized on the surface and the m otors pullbeads or cargo along these lam ents [3].

In order to obtain spatial control of the movem ents, motormolecules or laments can be bound to the substrate surface in well de ned patterns by controlling the surface topography and/or chem istry. Examples are m otor-covered surface channels or grooves which guide the gliding laments, chem ical patterning of a surface to bind laments or motors selectively, and combinations of topographic and chem ical patterning, see, e.g., [4, 5, 6, 7, 8, 9, 10]. In this way, one can create 'active stripes' along which the active transport takes place. The directionality of these stripes can be controlled in a rather direct way for systems based on the bead assay, since unidirectionalm ovem ent of m otors can be realized by aligning lam ents in parallel with the same orientation [9, 10]. In gliding assays, movement of laments usually occurs random ly in both directions, but unidirectional m ovem ents can be obtained constructing special surface dom ain patterns [7].

U sually, molecular motors undergo directed movements which can be used for transport over large distances. However, the active motion of molecular motors can also be used to generate e ectively di usive movements by sequences of active directed movements into random directions. We will call these ATP-dependent and thus energy-consuming, but e ectively non-directed movements active di usion. It should be useful under conditions where simple di usion is slow, i.e., for large cargoes or high viscosity of the uid. A ctive di usion is also present in vivo, where various motor-driven cargoes such as vesicles, messenger RNA, and viruses exhibit active back-and-forth movements [11].

In the following, we will discuss active di usion in severalsimple system swhich can be realized experimentally. We present results for several cases where patterns of 'active stripes' have been created on a surface by im m obilizing cytoskeletal laments in certain well-de ned patterns, so that they constitute a system of tracks for the active movements of particles coated with molecular motors. Even though we focus on these latter systems derived from bead assays with mobile motors, our arguments can be easily extended to mobile laments gliding in motor-covered surface grooves.

M odel. In order to study the elective di usion arising from active motion along patterns of laments, we describe these movements as random walks on a lattice [12, 13]. We consider a cubic lattice with lattice constant 'on which certain lines of lattice sites represent the laments or active stripes. If a motor-driven particle occupies such a lattice site, it makes a forward step (along the orientation of the lament), a backward step, and no step with probabilities , , and pertime unit , respectively. In addition, it may escape to each of the n_{ad} adjacent non-lament sites with probability =6 (n_{ad} = 3 and 4 for a lament at a wall and in solution, respectively). An unbound particle, i.e., a particle at




FIG.1: Lattice m odel for the active m otor m ovem ents along lam ents. M otors m ake forward and backward steps along the lam ent with probabilities and , respectively and no step with probability . Unbinding from the lam ent occurs with probability $_0 = n_{ad} = 6$ where n_{ad} is the number of non-lam ent neighbor sites, and a m otor reaching the lam ent binds to it with sticking probability $_{ad}$.




FIG. 2: Active di usion in a tube with two antiparallel + aments (double-logarithm ic plot): The variance x² of the particle position as a fuction of time t for motor-driven particles with unbinding probabilities = 0.01 (solid), 10³ (dashed), and 10⁴ (dotted line) and other parameters as described in the text. The thin dashed line indicates unbound di usion which is much smaller than active di usion. Here and in the following gures, lengths and times are expressed in units of `and , respectively.

a non-lament site, performs a symmetric random walk and steps to each neighbor site with probability 1=6 per time . An unbound motor reaching a lament site binds to it with probability $_{\rm ad}$. The parameters of the random walks can be adapted to the measured transport properties [12]. Con ning surfaces are in plan ented by rejecting all stepping attempts to lattice sites of the surfaces.

For the simulations, we chose the basic length scale to be '= 50nm and the basic time scale to be = 25m s. These values result in a di usion coe cient D $_{\rm ub}$ 10 1 m =s as appropriate for a m icrom eter-sized particle in water. We take = 0.5, = 0, and $_{\rm ad}$ = 1, corresponding to a velocity v_b ' 1 m =s and a binding rate in the order of 100s 1 for m otors within a capture range of 50nm from the lament.

Active di usion in 1d. In order to discuss the sim plest case of active di usion, let us consider two parallel lam ents with opposite polarity. We denote the coordinate axis parallel to the lam ents by x and take the lam ents to be su ciently long, so that the lam ent ends are not reached within the observation time. The lam ents are placed within a long and thin tube or channel with a rectangular cross section (with width L and height H), so that unbound m otors cannot escape, but rebind with a nite mean return time, a situation that min ics the axon of a nerve cell.

W e have studied this case using an analyticalFourier{ Laplace technique as in Refs. [13] and computer simulations. Some results are shown in Fig. 2. Because of the antiparallelorientation of the laments, no netmovement is obtained in such a system, and the elective velocity is zero on large scales. The elective dilusion coelcient, D $\lim_{t! 1} x^2(t)=2t$, de ned via the long-time behaviour of the positional variance $x^2 + hx^2i + hx^2i$, is found to be given by

$$D = D + D_{act}P_b; \qquad (1)$$

where the rst term is the weighted average of the bound and unbound di usion coe cient, $D = D_b P_b + D_{ub} (1 P_b)$ with the probability $P_b = 1 = [1 + (=_{ad})LH = ^2]$ that the m otor is bound to the lament at large times. The contribution of the bound di usion coe cient is usually sm all, so that $D' D_{ub} (1 P_b)$. The second term describes active di usion, i.e., additional spreading of a distribution of m any m otors due to the active directed m ovem ents into both directions with

$$D_{act} = \frac{3v_b^2}{2} : \qquad (2)$$

The latter contribution can be written as $D_{act} = \frac{1}{2}hL_s^2 i= t_b = x_b v_b$ with the average walking time $t_b = 3=(2)$, the average walking distance $x_b = v_b t_b$, and the mean square of the distance L_s traveled actively before a change of direction via unbinding, as obtained from the distribution P (L_s) = $\frac{1}{2} \frac{1}{x_b} e^{\frac{T}{2} \frac{1}{s} \frac{1}{r}} x_b$ of the walking distances.

This contribution is present even if the di usive motion of unbound motors is strongly suppressed, e.g. because of their large cargoes or because of a high viscosity of the uid. In cells, this should apply to the movements of large organelles such as mitochondria (where, how ever, the switching of direction is accomplished via di erent types of motors rather than via the orientation of the lam ents) [11].

A ctive di usion as given by x^2 2D t is valid at large tim es with t t $2D = v_b^2$ ' $3P_b = , see F ig. 2$. Note that the larger the active di usion coe cient, the larger is also the crossover tim et and, thus, the tim e necessary to observe the active di usion.

An enhancement of di usion occurs also in rather different contexts such as electrophoresis, chrom atographic columns, and di usion in hydrodynamic ow which can also be described by multi-state random walk models [14, 15]. In all of these cases, however, the directed motion arises from externally applied elds rather than from the active movements of the motor particles.




FIG.3: Substrate surfaces with active stripes which consist of lam ents in m obilized onto striped surface dom ains: For the system architectures (A1) and (B1), all stripes contain lam ents with both orientations, for (A2) and (B2), the lam ents within one stripe have the same orientation, but lam ents on neighboring stripes have opposite orientation.

A mays of laments on a surface. Let us now consider laments which are immobilized on patterned surfaces with two-dimensional arrays of stripes. We consider four systems as shown in Fig. 3: (A1, A2) consist of arrays of parallel stripes whereas (B1, B2) correspond to intersecting stripes which form a two-dimensional square lattice with lattice constant L. The stripes have a width W; in our simulations, we used W = `. In both cases, we studied two situations: (i) Each stripe contains laments with both possible orientations as in (A1, B1), and m otor particles which bind to a stripe can start to m ove in either direction (which is chosen random ly in the sim ulations); and (ii) neighboring stripes are covered by lam ents with opposite orientation as in (A2, B2). Note that all patterns have no directional bias on large scales.




FIG.4: (a) E ective di usion coe cients D $_{\rm k}$ (circles) and D $_{\rm 2}$ (triangles) as functions of the stripe separation L. The open and lled symbols correspond to the two system architectures (A1) and (A2), respectively, com pare Fig.3. The full lines indicate the analytical result for (A1). (b) E ective di usion coe cient D as a function of the unbinding probability . D exhibits three regimes (I) { (III) as discussed in the text. The open and lled symbols correspond to the two system architectures (B1) and (B2), respectively, as in Fig.3. The parameters are as described in the text; we used = 0:0025, H = 100 ' in (a) and L = H = 100 ' in (b).

The motors can change their direction of movement via unbinding and rebinding to another lament. In the stripe lattices, they can also change direction at the vertices by switching to another lament, which is chosen random ly. Finally, we take the di usion in the direction perpendicular to the surface to be restricted to a slab of height H. To study the active di usion for this case, we determ ined the di usion coe cient by extensive M onte C arlo simulations form otor-driven active particles of microm eter size and for a wide range of the unbinding rate and the stripe separation L as shown in Fig. 4.

A mangements of laments of this type are accessible to experiments and can be created using structured surfaces as described above. Lattice patterns of laments can also be formed by the self-organization of laments and motor com plexes [16] or by the assembly of crosslinked networks on micropillars [17].

Parallel active stripes. A mays of parallel active stripes which contain laments with both orientations (A1) exhibit active di usion very similar to the onedim ensional case discussed above. How ever, in this case, the elective di usion coe cient depends on the spatial direction. W hile the e ective di usion is described by Eq. (1) in the direction parallel to the stripes, which leads to the parallel di usion coe cient D $_{\rm k}$ = D + D $_{\rm act} P_{\rm b}$, the di usion perpendicular to the stripes is characterized by $D_{?} = D_{ub}$ (1) P_{b}), see Fig. 4(a). The latter expression is also valid if the directionality of the stripes alternates (A 2), where the unbound motors return predom inantly to the same stripe which leads to a higher value of D_k as shown in Fig. 4(a).

Regular lattices of active stripes. In the system architectures (B1,B2), the motor-driven active particles can perform two-dimensional random walks on the stripe lattice even if they remain bound to the laments. In addition, e ectively distive behavior can arise from the repeated unbinding from and binding to lament. Let us consider case (B1). The distion co-e cient is given by $D = D_{act}P_b + D_{ub}(1 - P_b)$ with $P_b = 1=[1 + (=_{ad})LH = (2W \)]$ for the stripe lattice. Depending on the processivity of the active particles, i.e. on the value of the unbinding rate, there are three regimes:

(I) If the unbinding rate is small, so that the walking distance is large compared to the pattern m esh size, $x_{\rm b} = 2v_{\rm b} = 1$, the particle performs a random walk along the active stripe lattice and the di usion coe cient is D D (= 0) = $\frac{1}{4}v_{\rm b}L$. This case should be appropriate for cargo particles driven by m any processive m otors.

(II) If the average walking distance before unbinding is smaller than the mesh size, $x_b = 2v_b = L$ as appropriate, e.g., for transport by single processive motors,

changes in direction of movement will mainly be through unbinding and rebinding to another lament. In that case, the distance traveled before a change of direction is given by the walking distance $x_{\rm b}$ and, similar to the one-dimensional case discussed before, the di usion coefcient is D $\frac{1}{2} x_{\rm b} v_{\rm b} P_{\rm b}$ [18].

(III) F inally, if m otor particles spend m ost of the time unbound, i.e., for large as appropriate for weakly processive m otors, the di usion coe cient is simply given by the unbound B row nian m otion, D D_{ub} .

The three regimes can be summarized in one form ula by using $D_{act} = v_b L_s = 4$ and defining the interpolated distance traveled between two changes of direction by $L_s = L2 \times b = (L + 2 \times b)$ which leads to

$$D = \frac{v_{b}}{2} \frac{L x_{b}}{L + 2 x_{b}} P_{b} + D_{ub} (1 P_{b}):$$

The latter expression leads to the solid line in Fig. 4 (b), which agrees well with the data points (open circles) from our simulations.

The value of the active di usion coe cient can be further enhanced by controlling the orientation of the lam ents along the stripes, i.e., by using lam ent patterns such as (B2) for which we obtain an active di usion coe cient twice as large as for case (B1). In regime (I) this factor is due to the fact that a fully random choice of the new direction is completed after a walk over the distance 2L. However, Eq. (3) with an additional factor of two in the active di usion term describes rather well our simulation data also in regime (II).

Discussion. Finally, let us estimate the order of magnitude of the active di usion in systems that are experimentally accessible. Free di usion in a Newtonian uid is governed by the Stokes (Einstein relation from which the di usion coe cient is obtained as D $_{\rm ub}$ '

(100nm = R_{hyd}) 2:4 m²=s water= . In the latter expression, R_{hyd} is the elective hydrodynamic radius of the particle and the viscosity of the medium. For a microm eter-sized particle in water, we have D_{ub} 0:1 m²=s, for a 100nm -sized particle D_{ub} 1 m²=s. (The di usion coe cient of bound motors moving along laments is much smaller, typically of the order of D_{b}

 v_b ' 0:01 m²=sw th v_b 1 m =s and ' 10nm.)

The active di usion coe cient, on the other hand, is of the order of $\frac{1}{4}v_bL_sP_b$ with L_s given by the lament length in regime (I) and by the walking distance in regime (II).W ith a typical lament length of a few tens of m, this means that active di usion coe cients of the order of 10 m²=s can be obtained for cargo particles driven by many motors, for which regime (I) is appropriate. For microm eter-sized particles this is two orders of magnitude larger than the di usion coe cient of unbound B rownian motion. For cargo particles driven by a single or a few motors, regime (II) applies, and for a typical unbinding rate of 1=s, we obtain an active di usion coe cient of 1 m²=s.

These estimates as well as our simulation data are for di usion in water. In a more viscous medium with viscosity > $_{water}$, di usion is even more enhanced due to the active processes, because active di usion does not obey the E instein relation and is largely independent of [19]: the viscous force on a microm eter-sized bead moving with 1 m =s is of the order of = $_{water}$ 10² pN which is sm all compared to the piconew ton forces required to slow down the active movements of a single motor. Unbound di usion is however reduced by the factor $_{water}$ = , so that the ratio D =D ub increases with increasing viscosity .

Active di usion will therefore be useful for particles

which explore surface patterns with linear dimensions of tens of micrometers or even millimeters, e.g., in order to nd a speci c binding partner or to deliver a cargo, in particular if the surrounding uid has a high viscosity. One potential application is provided by the integration of these biom in etic transport system s into labs-on-a-chip for genomics or proteomics.

In sum m ary, we propose here to use chem ically or topographically patterned surfaces to create well de ned arrangem ents of active stripes covered by lam ents and to use the random walks arising from the active m ovem ents of m otor-covered particles along these stripes to achieve fast di usion on the surface.
