Field Theory Renorm alization G roup: The Tom onaga-Luttinger M odel Revisited

A bstract. We apply eld theoretical renorm alization group (RG) methods to describe the Tom onaga-Luttinger model as an important test ground to deal with spin-charge separation e ects in higher spatial dimensions. We calculate the RG equations for the renorm alized forward couplings g_{2R} and g_{4R} up to two-loop order and demonstrate that they don't ow in the vicinities of the Fem ipoints (FPs). We solve the Callan-Sym anzik equation for G $_{(a)R}$ in the vicinities of the FPs. We calculate the related spectral function and the momentum distribution function at $p = k_F$; $p_0 = !$. We compute the renorm alized one-particle irreducible function $_{(+)R}^{(2)}$ (p; $p_0 = 0$;) and show it carries important spin-charge separation e ects in agreement with well known results. Finally we discuss the implementation of the RG scheme taking into account the important simplic cations produced by the W ard identities.

1. Introduction

The discovery of high-tem perature superconductors and other related oxide based m aterials have attracted a lot of attention regarding the unique properties of low dimensional solids. The sim plest and more notorious representation of a one-dimensional (1d) conductor is the the so-called Tom onaga-Luttinger (TL) model[1]. That model essentially describes 1d electrons in the vicinity of their right and left Ferm i points interacting with each other by means of forward scattering processes. Due to the special equivalence relations between bosons and ferm ions and left and right charge conservation laws the TL model can be solved exactly by either bosonization [2] or, making full use of the W ard identities, by quantum eld theory methods [3].

The one-particle G meen's function for the TL model can also be calculated exactly by those methods. However such a direct solution is provided only in coordinate space. To obtain the associated spectral function which determ ines the photoem ission and the inverse photoem ission spectra one needs to evaluate an intricate double Fourier transform and perform numerical approximations[4].

B osonization m ethods are hard to implement in higher dimensions[5]. In addition, those W ard identities simplications are inherent to 1d and to the exact number conservation of right (+) and left (-) particles. As a result to deal with strongly correlated fermions in two or more spatial dimensions one generally resorts to other schemes. One of those alternative approaches is the renormalization group (RG) m ethod. RG m ethods were used with success to predict the various instabilities of the 1d electron gas as a function of the existing coupling parameters[6]. The RG ow softhe renormalized couplings are also in agreement with the bosonization solutions in several related problems. D espite that the RG m ethod is not frequently used to perform a direct calculation of the single-particle G reen's function and its associated spectral function [7, 8]. Since in the TL m odel there are only low-energy bosonic spin and charge collective m odes it is not clear that the right physics will emerge out of approximate fermionic RG schemes. Besides, it is also fair to say that RG methods have not yet been proved capable of dealing, in full force, with spin-charge separation elects. Within the g-ology framework the role of the forward coupling g_4 has not been fully explored in the RG context so far. One should therefore try to establish how to deal with spin-charge elects in well known grounds, such as the TL m odel, before implementing RG methods in more dil cult problems such as spin-charge separated states in higher spatial dimensions.

In this work we apply the eld theoretical RG method \mathfrak{P} to describe the TL model in detail. This work is not intended to review exhaustively all the di erent RG applications for the TLM. We refer the reader to several authoritative review articles for that purpose[10]. Rather we concentrate here uniquely on the eld theoretical RG description of the TLM. Using this scheme we derive the α we equations for the forward couplings g_R and g_{4R} up to two-bop order. In calculating the respective renorm alized one-particle irreducible functions $\binom{4}{2R}$ and $\binom{4}{4R}$ we show that non-parquet vertex contributions are the only source of logarithm ic divergences in our perturbative calculations. Taking into account the self-energy corrections calculated earlier we dem onstrate that, in two-loop order, the non- ow condition for q_R and q_{4R} is assured by the exact cancelation produced by the contributions originated by the anom alous dimension and by the counterterm s added to our renorm alized TL Lagrangian. Based on our perturbative RG results we construct and solve the Callan-Sym anzik equation for the renorm alized one-particle Green's function G_R at the Fermi points. We show that it correctly possesses a branch cut structure due to its non trivial anom abus dimension. Using G $_{\rm R}$ we derive the spectral function and the momentum distribution function at the Ferm ipoints. Our results are in agreem ent with earlier bosonization work [4] as well as more recent RG estimates [9]. Using a momentum RG scale parameter we use perturbation theory to derive $\frac{(2)}{R} = G_R^{-1}$ at the Fermi energy $p_0 = 0$ and in the vicinity of $p = k_F$. One in portant feature emerges naturally from our result. There are now two emergent characteristic velocities which we relate immediately to the spin-charge separation e ects. M oreover, the general form of the resulting $\frac{(2)}{R}$ is in qualitative agreement with the D zyaloshinskii and Larkin's W and identity solution (D L) β]. Our estimates are entirely perturbative since at that stage we only consider contributions up to two-loop order. To go beyond perturbation theory we relate the e ective two-particle propagators D_+ and D_{++} , introduced earlier by DL, to $\frac{4}{2R}^{(4)}$ and $\frac{4}{4R}^{(4)}$ and show how to implement the regularization, up to in nite order, of all the divergences which are originated in the perturbation series for these two one-particle irreducible functions.

Recently new versions of the functional RG containing both ferm ionic and auxiliary bosonic elds have been developed with success[4, 15]. In one of those [14], the W ard identities are also used to truncate the vertex functions hierarchical equations and as a result they are able to reproduce the correct TL spectral function at the Ferm i points for the case in which $g_4 = 0$.

2. The TL Lagrangian M odel

Follow ing the so-called g-ology convention the renorm alized TL ferm ionic lagrangian is given by




Figure 1. The direct renorm alized couplings.

where the momentum p is restricted to the interval $jj k_F$ in the vicinities of the right and left Ferm i points and Z = Z 1. In Figure 1 we display the direct couplings g_{2R} and g_{4R} . For practical purposes we can also take the limit ! 1. We assume beforehand that neither the Ferm i velocity nor the Ferm im on entum are renormalized by interactions. The quasiparticle weight Z is nulli ed by interactions at the Ferm i points since there are no stable quasiparticles in the TL regime but we assume tactically that we don't know this a priori. In general Z is the multiplicative factor which relate the bare and the renormalized ferm ion elds to each other. The counterterm s associated with the contributions from g_{2R} and g_{4R} are included to regularize the logarithm ic divergences which arise in perturbation theory.

The corresponding right and left non-interacting G reen's functions of this m odel are sim ply





Figure 2. The non-interacting G reen's functions.


Using the appropriate Feynman rules for L_{TL} we can now proceed with the perturbative calculations of the one-particle irreducible functions $\binom{44}{2R}$, $\binom{44}{4R}$ and $\binom{22}{2R}$. In general, following the renormalization theory, we can relate those functions at the Fermi points to observable physical quantities.

D ue to the fact that only forward scattering processes are accounted for in L_{TL} the right (+) and left () lines never m ix in a single loop. As a result in this way no divergence arises from non-interacting particle-hole loop diagram s. Taking into account the spin sum m ation factors we not instead

These $^{(0)}$'s reduce simply to $i=v_F$ at the Ferm i points if we take the limits q_0 ! 0 and q ! 0.





Another important feature due to the neglect of backscattering processes is that the symmetrized sums of all diagrams containing closed loops with more than two fermion lines vanish exactly [3]. Thanks to this important simplication there are only divergent diagrams in the perturbative series expansions for both $\binom{(4)}{2R}$ and $\binom{(4)}{4R}$ in two-loop order. Those divergences, which are precisely the object of attention of renorm alization theory, are cancelled out exactly by the counterterms sadded to the Lagrangian model. How ever at this order of perturbation theory we are also obliged to take into account self-energy corrections. Therefore before discussing the RG ow of the renorm alized couplings we apply the RG method for the calculation of the self-energy $_{R(+)}$.

3. O ne-Particle Irreducible Function $^{(2)}_{2R}$ up to Two-Loop O rder C om puting diagram matically the self-energy $_{R(+)}$ (p;p₀) for the TL m odel up to two-bop order, we nd:




Figure 4. The self-energy $_{R(+)}$.

Having established what $_{R(+)}$ is we move on to calculate the related one-particle G reen's function G $_{(+)R} = \frac{(2)}{R(+)}^{1}$ where

and since 0 for non-zero forward coupling Z (!) is nulli ed at the FP when !! 0 in agreem ent with the fact that there are no well de ned quasiparticles in the TL state. This result was obtained earlier in Refs. [10, 11].

4. Flow Equations for the R enorm alized C ouplings Following the renormalization theory we can relate the physical couplings g_{2R} and g_{4R} to theparticle irreducible functions $\begin{pmatrix} 4 \\ 2R \end{pmatrix}$ and $\begin{pmatrix} 4 \\ 4R \end{pmatrix}$ at the Fermi points. In this way for the external momenta $p_1 = p_3 = k_F$, $p_2 = k_F$ and $p_{10} = p_{20} = p_{30} = !=2$ 0 we de ne




Figure 5. The g_{4R} channel.

U sing standard diagram m atic analysis as shown in the Figure 5 we have at the vicinity of the Ferm i point




Figure 6. The g_{2R} channel.




Figure 7. The counterterm i g_{2R} (!).

We display the diagrams for $\binom{4}{2R} \frac{1}{2} p$ in Figure 6. Following the same strategy as before we indicate in Figure 7 how to proceed with the calculation of the counterterm i g_{2R} (!).

From RG theory we know that the bare and renorm alized couplings are related to each other by

A rigorous mathematical proof of the vanishing of the beta functions in all orders of perturbation theory in the TLM is given in Ref. [13].

5. RG Calculation of the One-Particle G reen's Function at the Ferm iPoints As we saw in the previous section the TL liquid is characterized by the non- ow of the renormalized forward couplings. This simplies the RG approach to this problem. In this scheme we relate, quite generically, the renormalized G reen's function G_R to its bare analogue

Considering that the anomalous dimension is constant, this equation can be easily integrated to give

which has indeed a branch cut structure as opposed to the simple pole nature, typical of the Ferm i liquid one-particle G reen's function. Consequently, for $p_0 = 0$, at the Ferm i points,

This result is in agreement with earlier RG estimates of K opietz and cow orkers [8]. To calculate next the momentum distribution function n ($p = k_F$) at the FPs, it su ces to integrate A _{(a)R} over an energy interval of width 2! around $p_0 = 0$. We nd

Let us now consider the alternative limit $p_0 = 0$ and p = 0 where the parameter is now our RG momentum scale which will be used to take the physical system towards the FPs. If we repeat our RG analysis for $(A)_{iR}^{(4)}$ making use of such RG scale we nd at the FPs

The presence of two di erent velocities violates the single-pole character of the one-particle G reen's function and it is directly related to the spin-charge separation which takes place in the TLM [17]. This spin-charge separation is a feature which emerges naturally from our perturbative RG analysis. Notice that up to order O (\overline{g}_{2R}^2), in the weak coupling lim it, v_F $p_{\overline{u_c u_s}}$ and $p_{\overline{u_c u_s}}^{(2)}$ reduces to

which is in qualitative agreem ent with well-known results [18]. However, our estimates for u_c and u_s are only valid up to two-loop order. For this reason they cannot be identical to the velocities obtained from the solutions of Schwinger-Dyson equations which include contributions up to in nite order [].

6. W ard Identities

As dem onstrated by D zyabshinskii and Larkin [3] the use of W and identities greatly simpli es the analysis of the TL model. Making use of these identities and taking into account the simpli cations produced by the cancelation of the symmetrized sum of all diagrams containing closed loops with more than two ferm ion lines we are naturally led, following DL, to introduce two interactions propagators D₊₊ and D₊. These two propagators can be used to describe the e ective two-particle interactions in the TLM D_{++} and D₊ are nite at the FPs and do not need to undergo any regularization procedure. In contrast with that, as we discussed in section 4, the one-particle interactions $\binom{40}{2R}$ and $\binom{40}{4R}$ produce non-parquet vertex contributions which need to be regularized order by order in perturbation series. Therefore to relate the D L interaction propagators back to the corresponding one-particle irreducible functions we must include appropriate vertex functions. Considering these feature we can readily extend our perturbative results writing the exact one-particle irreducible functions $\binom{40}{2R}$ and $\binom{40}{2R}$ in the form

These $_{iR}^{(4)}$'s are represented diagram m atically in F igure 8. Thanks to the already m entioned simpli cation inherent to the TLM, the propagators D_+ and D_{++} are determ ined exactly by solving the Schwinger-D yson equations indicated in F igures 9 and 10. Solving these SDE's for D_{++} and D_+ , diagram m atically, we arrive im m ediately at the DL results for the charge and spin velocities, namely, $u_c = v_F \frac{p}{(1 + \overline{g}_{4R} =)^2} \frac{(\overline{g}_{2R} =)^2}{(\overline{g}_{2R} =)^2}$ and $u_s = v_F$.

Since the interaction propagators are independent of renorm alization parameters they are RG invariants. In contrast the vertex functions 's produce logarithm ic singularities which need to be cancelled out by appropriate counterterm s. As we showed before, in the RG fram ework, we solve this problem either by relating the bare and renorm alized vertices to each other through relations of the type

with a = +;, or by constructing the necessary counterterm directly, order by order in perturbation theory. Following this latter route, up to two-loop order the renormalized vertex function $\frac{R}{a}$ is determined by the diagram s shown in Figure (11).

If we de ne a^{R} such that $a^{R}_{A} = 1$ it then follows that the vertex counterterm diagram which appears in Figure (12) is determined exactly by this condition.

This gives




Figure 8. The exact one-particle irreducible functions $\frac{(4)}{2R}$ and $\frac{(4)}{4R}$.




Figure 9. The exact interaction propagators iD + and iD

It follows from this that the vertex renormalization constant Z_2 must be identical to the quasiparticle weight:

Such an equivalence between the vertex renorm alization constant Z_2 and the quasiparticle amplitude Z was also pointed out in Ref. [12]. In fact, since the W and identity (W I) is preserved by the renorm alization process, this result emerges naturally from the W I itself. As a consequence of this simplication, at the FPs, the renorm alized one-particle irreducible functions $^{(4)}_{2R}$ and $^{(4)}_{4R}$ reduce simply to the interaction propagators iD_+ and iD_{++} respectively, which by being RG invariants, produce vanishing beta functions to all orders in perturbation theory in agreem ent with the rigorous analysis of Ref. [13].

7. Conclusion

We implement the eld theoretical RG method in the presence of spin-charge separation e ects in one spatial dimension. We take the Tom onaga-Luttinger model as our reference test ground in dealing with future higher dimensional problems. As is well known true TLM was solved by bosonization and by quantum eld theoretical methods which take into explicit account the simplications produced by the W and identities. Unfortunately those simplications are inherent to one dimension and contrary to the RG scheme both methods are discut to implement in more general situations.

Using our RG method we calculate the self-energy up to two-loop order. From it we nd a non-zero anom alous dimension and a quasiparticle weight which is nullied at the Fermi points. We compute the RG equations for the renormalized coupling constants g_{2R} and g_{4R} , up to two-loop order, and demonstrate that they don't ow in the vicinities of the FPs. We derive the Callan-Sym anzik equation for the one-particle G reen's function at $p = k_F$; $p_0 = !$. The




Figure 10. The propagators iD_{++} and iD_{++} .




Figure 11. The Renorm alized vertex function $\frac{R}{+}$.

C SE is easily integrated producing an expected branch cut structure in $G_{(a)R}$. Using this we derive the spectral function and the momentum distribution function at $p = k_F$. We calculate the one-particle irreducible function ${(2) \atop (+)_R}$ ($p; p_0 = 0;$) taking into explicit account spin-charge separation e ects in the weak coupling regime. Our results are in qualitative agreement with the other approaches. Finally we discuss the inclusion of the W and identities in the RG scheme. We show that their present forms are preserved upon the renormalization and thanks to them the one-particle irreducible functions in the vicinities of the FPs reduce to interaction propagators which can be solved exactly by appropriate Schwinger-Dyson equations. To conclude we add that some of the material discussed in this paper have appeared before in the literature in one form or another. We tried to relate, whenever possible, our results to some of those works. By presenting them here in a edd theoretical self-contained form we hope to bring new insights concerning the RG applications with both spin-charge separation e ects and W ard identities in more general problem s.




Figure 12. The vertex function counterterm $\frac{R}{+}$.
