Ballistic and di usive: theory of vortices in the two-band superconductor M qB2

M otivated by the recent results on impurity elects in M gB_2 , we present a theoretical model for a two-band superconductor in which the character of quasiparticle motion is ballistic in one band and discipation in the other. We apply our model to calculate the electronic structure in the vicinity of an isolated vortex. We assume that superconductivity in the discipation () band is induced by that in the clean () band, as suggested by experimental evidence for M gB_2 . We focus our attention to the spatial variations of the order parameter, the current density, and the vortex core spectrum in the two bands. Our results indicate that the coupling to the band can lead to the appearance of additional bound states near the gap edge in the band that are absent in the single-band case.

It is now well established that M gB2 is a two-gap superconductor, and its essential superconducting properties are well described by an isotropic s-wave two-band model [1, 2, 3, 4, 5, 6, 7]. The two bands' in MgB₂ are the 'strong' band that arises from the boron orbitals (with the energy gap 72m eV), and the band that derives from the boron orbitals 2:3m eV). Despite the fact that each band' consists in reality of a pair of bands, the variation of the gap within each corresponding pair of Ferm i-surface sheets can be neglected [8, 9]. The two energy gaps are observed to vanish at a com m on transition tem perature Tc: no second transition has been observed, and there is evidence of induced superconductivity in the band [5, 10, 11].

There have been considerable e orts to understand im purity e ects in M gB 2 [7]. Besides the potential applications of M gB 2 as m agnetic devices [12], these studies have aim ed at testing a prediction of the two-band model: the reduction of T_c and the gap ratio by non-magnetic impurities. However, Mazin et al. [13, 14] have shown that this does not apply to M gB2, i.e. to M g-site im purities or defects, which are more favourable energetically than those at B sites. While the band is strongly a ected by such impurities, the band is more robust, and there is little m ixing of the two bands because of negligible interband scattering [13, 14]. This is consistent with accumulating experim ental evidence suggesting that the and bands are essentially in the ballistic and di usive lim it, respectively [15] (see also references in Refs. [13, 14]). Nevertheless, so far in theoretical studies both of the two bands have been assumed to be either in the clean [16] or in the dirty lim it [17].

In this Letter, we exam ine theoretically the e ects of induced superconductivity and impurities on the vortex-core structure in a two-band superconductor. Our work is motivated by the experimental investigation of the vor-

tex state in M gB $_2$ using scanning tunnelling spectroscopy [10]. We present a novel formulation of coupled quasiclassical Eilenberger and U sadel equations to describe a multiband superconductor with one ballistic and one di usive band with negligible interband scattering: the two bands are assumed to be coupled only by the pairing interaction.

We apply our model to calculate numerically the local density of states (LDOS) and supercurrent density around an isolated vortex. We exam ine in detail the intriguing spatial variation of these quantities and the order parameter in the two bands. A particularly interesting result emerging from our studies is the possibility of additional bound states near the gap edge in the band.

Our model is based on the equilibrium quasiclassical theory of superconductivity, where the physical inform ation is contained in the G reen function, or propagator, \mathsection (; p_F ; R). Here is the quasiparticle energy measured from the chemical potential, p_F the quasiparticle momentum on the Fermi surface of band 2~f; g, and R is the spatial coordinate (the hat refers to the 2~2~m atrix structure of the propagator in the particle-hole space). In the clean band, \mathsection (; p_F ; R) satis es the E ilenberger equation [18]

where v_F is the Ferm i velocity and ^ the (spatially varying) order parameter in the band. Throughout this work, we ignore the external magnetic eld (this is justified because M gB $_2$ is a strong type-II superconductor). The coherence length in the band is de ned as

In the presence of strong impurity scattering, the G reen function has no momentum dependence and the E ilenberger equation reduces to the U sadelequation [19].

We assume this to be the appropriate description for the dirty band, and take the propagator \hat{g} (;R) to satisfy

The di usion constant D de nes the -band coherence length as = $D = 2 T_c$. Additionally, both propagators are normalized according to $\hat{q}^2 = \hat{q}^2 = 2\hat{1}$.

We assume that the quasiparticles in dierent bands are coupled only through the pairing interaction, neglecting interband scattering by the impurities. The gap equations for the multiband system are given as

Here f is the upper o -diagonal (1,2) element of the matrix propagator \hat{g} , h $_{p_{\rm F}}$ i denotes averaging over the band Ferm i surface, and $_{\rm C}$ is a cut-o energy.

We solve the system of equations (1) { (4) numerically. The normalization condition is taken into account with the Riccatiparam eterisation for the Green functions [20, 21]. After self-consistency has been achieved for the order parameter, the (for the band angle-resolved) LDOS in each band can be calculated as

where g is the upper diagonal (1,1) element of \hat{g} .

The current density around the vortex has contributions from both the band and the band. The corresponding expressions are (e = jejis the electron charge)

Throughout this work, we focus on the e ects of purely induced superconductivity in the band. D is gonalization of the coupling matrix in Eq. (3) decouples the gap equations. The larger of the two eigenvalues of the matrix V N $_{\rm F}$, denoted by $^{(0)}$, determines the critical temperature $T_{\rm c}$ and can be eliminated together with $_{\rm c}$. The smaller eigenvalue $^{(1)}$ is parameterized by the cut-o independent combination = $^{(0)}$ $^{(1)}$ =($^{(0)}$ $^{(1)}$). The




FIG. 1: Magnitude of the order parameter, j ; (x)j in the -and band, as a function of coordinate x on a path through the vortex center, at $T=0.1T_{\rm c}$: (a) for di erent ratios = and xed strength of the induced -band gap, parameterized by the mixing ratio (see text), = 0.3; (b) for di erent and xed = 5. A weak e ective repulsion due to C oulom b interaction was assumed in the subdom inant (1) pairing channel, parameterized by = 0.1 (see text).

pairing interactions have been calculated with ab initio m ethods, em ploying an electron-phonon coupling m odel [3, 8]; from these studies, taking Coulomb repulsion into account [9], we estimate < 0:3 for M gB 2. We present results for = 0:1 (implying a weak repulsion in the subdom inant (1) channel). The ratio of the magnitude of the bulk gaps = j bulk j bulk j near Tc param eterizes the strength of the induced superconductivity in the band; experim entally 0:3 in M gB 2. For sim plicity, we have set $N_F = N_F$ in our calculations; the densities of states of the two bands are indeed of comparable size [8, 9]. A cylindrical Ferm i surface was used for the two-dimensional band. For the ratio of the coherence lengths in the two bands we present results for = = 1, 3, and 5. An estimate from experiments [10, 22] gives for $M gB_2$ a value between 1 and 3.

In Fig. 1 we present the order-param eter magnitudes for each band as a function of coordinate x along a path through the vortex center. In Fig. 1 (a) we show the order param eter variation at T = 0:1T_c for several coherencelength ratios = and gap ratio = 0:3. Surprisingly, we nd that an increase of results in an increase of the recovery length of the order param eter (the characteristic length over which the order parameter changes from zero to the bulk value) in the band, while the recovery length in the band is barely a ected. Thus, the recovery lengths in the two bands can dier considerably, even though the superconductivity in the band is induced by the band. In Fig. 1 (b), the gap ratio is varied for xed = = 5.0 ne can see that, apart from the well-known increase of the bulk , the recovery length in the with increasing bulk band increases considerably with increasing . The band recovery length is also enhanced together with that of the band if > 0:3, as clearly seen for = 0:5. For = 0:1,near the vortex core is enhanced from its bulk value.




FIG. 2: (a) Local density of states (LDOS) for the band, as a function of energy for di erent distances r from the vortex center. The spectra are shifted in vertical direction for convenience. (b) LDOS at the chem ical potential, = 0, as a function of r for di erent and xed T = 0.5T, = 3.

To understand these e ects we have perform ed calculations for di erent values of that characterizes the Coulomb repulsion in the band. We have found that for > 0 the ratio j j j j is reduced in the core region with respect to its bulk value, however is enhanced for < 0. This leads to a renormalization of the recovery lengths of the order parameters in both bands.




FIG. 3: (a) LDOS for the band as a function of energy for di erent distances r from the vortex center. (b) The developm ent of an extra bound state near the gap edge in the band for di erent param eter combinations. The bound state develops for su ciently large mixing ratio and coherence length ratio = . (c) Angle-resolved LDOS for quasiparticles with momentum along the x axis at positions along the y axis in the band, showing the bound states as a function of y. The dispersion of the bound states as a function of y. The dispersion of the bound states as a function of y. Spectra in (a)-(c) are shifted in vertical direction for convenience.

In Fig. 2 we show the spectral properties of the band. The LDOS, shown in Fig. 2 (a), is at at the vortex center (r = 0), in agreement with the experiment of Ref. [10]. Outside the vortex core the BCS density of states is recovered. The decay of the zero-bias LDOS as a function of radial coordinate is shown in Fig. 2 (b), and compared with that of the band (btained from the data in Fig. 3 (a)]. The decay length of the zero-bias DOS is clearly diperent for the two bands. For the band it is given by and thus dominated by the parameter. In the band the length scale of the decay is and thus shorter than that in the band. The existence of two apparent length scales in the LDOS was also reported in the case of two clean bands [16] and two dirty bands [17].

In Fig. 3 we show the vortex-core spectra in the band. The LDOS, N (;R) = hN (;p_F ;R) i_{p_F} , as a function of energy for di erent distances from the vortex center is plotted in Fig. 3 (a), showing the wellknown Caroli-de Gennes-Matricon bound-state bands at low energies. The new feature of our model is the additional bound states in the vortex-core region near the gap edges, that are clearly visible in Fig. 3 (a). This is in strong contrast with the case of a single-band superconductor, where the spectrum near the vortex center is suppressed at the gap edges, showing neither a coherence peak nor additional bound states. We note that the selfconsistency of the order-param eter pro le is essential for discussing the presence of the bound states at the gap edges. We illustrate the development of these additional bound states in terms of the spectrum at the vortex center. We not that for a given = , the bound state exists for larger than a certain critical value, as seen in the left panel of Fig. 3 (b). For a given , on the other hand,

the bound state develops if = exceeds a critical value, which is between 1 and 3 for = 0.3, as can be inferred from the right panel of Fig. 3 (b). The bound states are, e.g., clearly resolved for = 0.3 and = = 3, values appropriate for M gB $_2$. We have found a similar bound state spectrum also for > 0. The bound states m ove with the gap edge as a function of temperature.

The bound-state spectrum is most clearly discussed in terms of the angle-resolved spectra, shown in Fig. 3 (c). Here the spectrum of quasiparticles moving in the x direction is shown as a function of position along the y axis. The position of the bound states as a function of y is shown in Fig. 3 (d). The main bound state branch crosses the chemical potential in the vortex center. The additional bound states are seen near the gap edge, and show a weak dispersion. In fact, a close inspection reveals that there are two additional branches; however, only one of them is present at the vortex center.




FIG. 4: Contribution to the current density as a function of distance from the vortex center, shown separately for the band and the band for xed mixing ratio = 0:3 and di erent temperatures T; (a) for = = 1, (b) = = 3, and (c) = = 5. In (d) the -band contribution to the total current density is shown as a function of radial coordinate, for $T = 0:1T_c$, = 0:3, and di erent = .

Finally, in Fig. 4 we show contributions from the two bands to the supercurrent density around the vortex separately. We show the results for =0.3, and (a) ==1, (b) ==3, and (c) ==5, at $T=T_c=0.1$, 0.3 and 0.5. The current density from the band is enhanced for low tem peratures near the vortex center, and the maximum approaches the center for

T! 0. This is due to the well-known Kramer-Pesch band. The current density due e ect for the clean to the induced superconductivity in the band is also enhanced by decreasing tem perature, but the maximum does not approach the vortex center as in the band. With increasing r, the contribution of the band is reduced, and the contribution of the band becomes considerable when = & 1. At the same time, j shows tem perature dependence only in the core area, whereas j is tem perature dependent also far outside the core. To discuss this e ect, we note that at a large distance r from the vortex center (but sm all com pared to the London penetration depth), the current-density m agnitudes $eN_F v_F^2 = 2r$ and are approximately given by j (r) eN F D j j=r. The tem perature dependence of j is thus dom inated by that of j

A nother in portant observation is that, for the parameters appropriate for M gB_2 , the contribution of j is considerable outside the vortex core. In fact, already for a moderate ratio = = 3 the -band contribution is restricted to the region very close to the vortex center and is negligible outside the core for 0:3. To understand this e ect, shown in Fig. 4 (d), we note that the current-density ratio far away from the vortex center approaches

C learly, the —band contribution to the current density dom inates when $(=)^2 > (j = j - T_c)^{-1}$, which is a case relevant for M gB₂.

In conclusion, we have form ulated a model for coupled ballistic and di usive bands in terms of coupled Eilenberger and U sadel equations. We have studied the effects of induced superconductivity in the Weak' di usive band on the order parameter, the current density and the spectral properties of the 'strong' ballistic band. We have found that (a) the recovery lengths of the order parameters in the two bands are renormalized by Coulomb interactions; (b) the vortex core spectrum in the band shows additional bound states at the gap edges; and (c) the current density is dominated in the vortex core by the -band contribution, and outside the vortex core the band contribution is substantial, or even dominating,

for param eters appropriate for M gB_2 . Our predictions concerning the vortex-core spectrum of the band can be tested in future tunnelling experiments.
