## Physics of C om plex M agnetic M aterials: Quasiparticle M any-Body D ynam ics

## A bstract

A brief survey of the author's works on the quantum theory of magnetism. Theoretical foundation and applications of the generalized spin-ferm ion (sp-d) exchange lattice model to various magnetic systems, e.g., rare-earth metals and compounds, and magnetic and diluted magnetic sem iconductors are discussed brie y. The main emphasis is put on the dynamic behavior of two interacting subsystems, the localized spins and spin density of itinerant carriers. A nonperturbative many-body approach was used to describe the quasiparticle dynamics. The approach permits to investigate and clarify the role of various interactions and disorder e ects in combined quantum models of magnetism in uni ed and coherent fashion.

The existence and properties of localized and itinerant magnetism in metals, oxides, and alloys, and their interplay is an interesting but not yet fully understood problem of quantum theory of magnetism [1, 2]. The behavior and the true nature of the electronic and spin states, and their quasiparticle dynam ics are of central im portance to the understanding of physics of correlated system s such as m agnetism and M ott-H ubbard m etal-insulator transition in m etals and oxides, m agnetism and heavy ferm ions in rare earths compounds, and anom abus transport properties in perovskite manganites. This class of systems is characterized by complex, manybranch spectra of elementary excitations. Moreover, the correlation e ects (com petition and interplay of Coulomb correlation, direct or indirect exchange, sp-d hybridization, electron-phonon interaction, disorder, etc.) are essential[3, 4]. These m aterials are system s of great interest both intrinsically and as a possible source of understanding the magnetism of matter generally [5, 6]. There has been considerable interest in identifying the microscopic origin of quasiparticle states [3, 4, 6] in these system s and a few m odel approaches have been proposed. M any m agnetic and electronic properties of rare-earth m etals and com pounds, and m agnetic sem iconductors [7] and related complex m agnetic m aterials m ay reasonably be interpreted

in term s of com bined spin-ferm ion m odels which include interacting spin and charge subsystem s [8, 9, 10]. This approach perm its one to describe signi cant and interesting physics, e.g., bound states and m agnetic polarons [9], anom abus transport properties, etc.

The problem of adequate physical description within various types of spin-ferm ion model has intensively been studied during the last decades, especially in the context of magnetic and transport properties of rare-earth and transition metals and their com pounds and magnetic sem iconductors.

Substances which we refer to as magnetic sem iconductors, occupy an intermediate position between magnetic metals and magnetic dielectrics. Magnetic sem iconductors are characterized by the existence of two well de ned subsystems, the system of magnetic moments which are localized at lattice sites, and a band of itinerant or conduction carriers (conduction electrons or holes). Typical examples are the Euchalcogenides, where the localm om ents arise from 4felectrons of the Eu ion, and the spinell chalcogenides containing  $C r^{3+}$  as a magnetic ion [7]. There is experimental evidence of a substantial mutual in uence of spin and charge subsystems in these compounds. This is possible due to the sp d(f) exchange interaction of the localized spins and itinerant charge carriers. More recent e orts have been directed to the study of the properties of diluted magnetic sem iconductors (DMS) [10]. Further attempts have been made to study and exploit carriers which are exchange-coupled to the localized spins. The e ect of carriers on the magnetic ordering temperature is found to be very strong in DMS. Diluted magnetic sem iconductors are mixed crystals in which magnetic ions (usually M  $n^{++}$ ) are incorporated in a substitutional position of the host (typically a II-V I or III-V) crystal lattice. The diluted magnetic sem iconductors o era unique possibility for a gradual change of the m agnitude and sign of exchange interaction by means of technological control of carrier concentration and band parameters. This eld is very active and there are many aspects to the problem. A lot of materials were synthesized and tested. The new material design approach to fabrication of new functional diluted magnetic sem iconductors resulted in producing a variety of compounds. The presence of the spin degree of freedom in DMS may lead to a new sem iconductor spin electronics which will combine the advantages of the sem iconducting devices with the new features due to the possibilities of controlling the magnetic state. However, the coexistence of ferrom agnetism and sem iconducting properties in these com pounds require a suitable theoretical model which would describe well both the magnetic cooperative behavior and the sem iconducting properties as well as a rich eld of interplay between them. The majority of theoretical papers on DMS studied their properties mainly within the mean eld approximation and continuous media terms. In a picture like this the disorder e ects, which play an essential role, can be taken into account roughly only. Moreover, there are dierent opinions on the intrinsic origin and the nature of disorder in DMS. Thus, many experim ental and theoretical investigations call for a better understanding of the relevant physics and the nature of solutions (especially magnetic) within the lattice spin-ferm ion model[8, 9, 10]. For treating the problem swe used a nonperturbative many-body approach, the form alism of the method of Irreducible Green Functions (IGF) [4]. This IGF method allows one to

describe quasiparticle spectra with damping for many-particle systems on a lattice with complex spectra and a strong correlation in a very general and natural way. This scheme diers from the traditional method of decoupling of an in nite chain of equations [1] and permits a construction of the relevant dynamic solutions in a self-consistent way at the level of the D yson equation without decoupling the chain of equations of motion for the GFs.

In paper [9] the concepts of bound and scattering states were analysed and developed to elucidate the nature of itinerant charge carrier states in magnetic sem iconductors and similar complex magnetic materials. By contrasting the scattering and bound states of carriers within the s d exchange model, the nature of bound states at nite tem peratures was clari ed. The free magnetic polaron at certain conditions is realized as a bound state of the carrier (electron or hole) with the spin wave. Quite generally, a self-consistent theory of a magnetic polaron was formulated within the IGF method which was used to describe the quasiparticle many-body dynamics at nite tem peratures. Within the above approach we elaborated a self-consistent picture of dynam ic behavior of two interacting subsystems, the localized spins and the it inerant charge carriers. In particular, it was shown that the relevant generalized mean elds emerges naturally within our form alism. At the same time, the correct separation of elastic scattering corrections permitted one to consider the damping e ects (inelastic scattering corrections) self-consistently. The damping of magnetic polaron state, which is quite di erent from the damping of the scattering states, nds a natural interpretation within the present self-consistent scheme.

In paper [10], we applied the IGF form alism to consider quasiparticle spectra for the lattice spin-ferm ion m odel consisting of two interacting subsystems. It was the purpose of that paper to explore m ore fully the notion of G eneralized M ean Fields (GMF) [4] which m ay arise in the system of interacting localized spins (including e ects of disorder) and lattice ferm ions to justify and understand the nature of the relevant m ean elds. Background and applications of the generalized spin-ferm ion (sp-d) exchange m odel to m agnetic and diluted m agnetic sem iconductors were discussed in some detail. The capabilities of the m odel to describe quasiparticle spectra were investigated. The key problem of m ost of the work was the form ation of spin excitation spectra under various conditions on the param eters of the m odel. In paper [10], we concentrated on the description of the m agnetic excitation spectra and treated the disorder e ects in the sim plest VCA (virtual crystal approxim ation) to emphasize the need for a suitable de nition of the relevant generalized m ean elds and for internal self-consistency in the description of the spin quasiparticle m anybody dynam ics.

Thus, we were able to calculate the quasiparticle spectra and GMF of the magnetic sem iconductors consisting of two interacting charge and spin subsystem within the lattice spin-ferm ion model to analyze the role and in uence of the Coulomb correlation, exchange, and e ects of disorder in a uni ed and coherent fashion.
