We study random ber bundle model (RFBM) with dierent threshold strength distributions and load sharing rules. A mixed RFBM within global load sharing scheme is introduced which consists of weak and strong bers with uniform distribution of threshold strength of bers having a discontinuity. The dependence of the critical stress of the above model on the measure of the discontinuity of the distribution is extensively studied. A similar RFBM with two types of bers belonging to two dierent Weibull distribution of threshold strength is also studied. The variation of the critical stress of a one dimensional RFBM with the number of bers is obtained for strictly uniform distribution and local load sharing using an exact method which assumes one-sided load transfer. The critical behaviour of RFBM with bers placed on a random graph having co-ordination number 3 is investigated numerically for uniformly distributed threshold strength of bers subjected to local load sharing rule, and mean eld critical behaviour is established.

#### I. INTRODUCTION

Sudden catastrophic failure of structures due to unexpected fracture of component materials is a concern and a challenging problem of physics as well as engineering. The dynamics of the failure of materials show interesting properties and hence there has been an enorm ous am ount of study on the breakdown phenomena till now 1,2,3,4,5. A total analysis of the fracture of materials should include the investigation of a possible fracture before the occurrence of large deform ations and hence the determ ination of the critical load beyond which if the load on the system increases, the complete failure occurs. Future progress in the understanding of fracture and the application of that know ledge dem and the integration of continuum mechanics with the scienti c disciplines of material science, physics, mathematics and chemistry. The main challenge here is to deal with the inherent stochasticity of the system and the statistical evolution of microscopic crack to accurately predict the point of nal rupture.




FIG. 1: The vertical parallel lines correspond to bers which are connected to two horizontal plates (shown with bold lines). The upper plate is xed and the lower plate is movable. Fig. 1 (a) shows a smaller force  $F_1$  applied on the bundle producing a strain . Fig. 1 (b) corresponds to a higher value of load, leading to a strain  $^{\circ}$  and bers begin to break.

Having said about the complexity involved in fracture processes, one can still get an idea of fracture phenom ena by studying simpli ed models. The simplest available model is Fiber Bundle Model (FBM)<sup>6,7,8</sup>. It consists of N parallel bers. All of them have their ends connected to horizontal rods as shown in Fig. 1. The disorder of a real system is introduced in the ber bundle in the form of random distribution of strength of each ber taken from a probability distribution P ( ) and hence called R andom Fiber Bundle Model (RFBM). The strength of each ber is called its threshold strength. As a force F is applied externally on a bundle of N bers, a stress = F = N acts on each of them. The bers which have their threshold strength smaller than the stress generated, will break imm ediately. The next question that arises is the a ect of breaking of bers on the remaining intact bers in: one has to decide a load sharing rule. The two extreme cases of load sharing mechanisms are Global Load Sharing  $(GLS)^{7,9}$  and Local Load Sharing  $(LLS)^{10,11,12}$ . In

GLS, the stress of the broken ber is equally distributed to the remaining intact bers. This rule neglects local uctuations in stress and therefore is electively a meaneld model with long range interactions among the elements of the system 13. On the other hand, in LLS the stress of the broken ber is given only to its nearest surviving neighbours. It is obvious that the actual breaking process involves a sharing rule which is in between GLS and LLS. Several studies have been made which considers a rule interpolating between GLS and LLS 14,15.

For a given force F, the bers break and distribute their load following a load sharing rule until all the bers have their threshold strength greater than the redistributed stress acting on them . This corresponds to the xed point of the dynamics of the system . As the applied force is increased on the system, more and more bers break and the additional stress is redistributed amongst the other bers. There exist a critical load (or stress c) beyond which if the load is applied, complete failure of the system takes place. Most of the studies on FBM involve the

determ ination of the critical stress c and the investiga-

tion of the type of phase transition from a state of partial failure to a state of complete failure. It has been shown that a bundle following GLS has a nite value of critical stress and belongs to a universality class with a speciex set of critical exponents  $^{9,16}$  whereas there is no nite critical stress  $_{\rm C}$  at them odynam ic limit in the case of LLS in one dimension  $^{10,17,18,19}$ . On the other hand, LLS on complex network has been shown to belong to the same universality class as that of GLS with the same critical exponents  $^{20}$ .

The paper is organised as follows. Section II consists ofm ixed bers with uniform distribution (UD) of threshold strength of bers and GLS. The critical behaviour of such a model is explored analytically. Mixed bers with Weibull distribution (WD) of threshold strength along with GLS is studied using a quasistatic approach of load increase in section III. One dimensional, one sided LLS with strictly uniform distribution (UD) is presented in section IV. Section V consists of a bundle of bers whose tips are placed on a random graph with co-ordination number 3. The main conclusions are presented in section VI.

# II. M IXED FIBERS W ITH UNIFORM D ISTRIBUTION AND GLS

Let us consider a  ${}^0m$  ixed  ${}^0$  ber bundle m odel w ith norm alised density distribution of threshold strength as shown below:




FIG. 2: Mixed Uniform Distribution.

The present model clearly consists of bers of two dierent types. This classication is based on whether a random ly chosen ber from the bundle belongs to class A of bers (0 < thousand 1) or class B of bers (2 thousand 1)

as shown in Fig. 2. In other words, the model consists of weak and strong bers but no bers with strengths between  $_1$  and  $_2$ , which is the forbidden region for the

ber strength. Since we are considering GLS here, the exact location of class A or class B bers is im m aterial. The aim is to determ ine the critical stress  $_{\rm C}$  for this model such that if the external stress exceeds  $_{\rm C}$ , the bundle breaks down completely.

If a fraction x of the total bers belong to class A and the remaining 1 x to class B, then to maintain the uniform ity of the distribution (Eq. (1)), we must have

The above equation provides the relationship between x,  $_1$  and  $_2$  showing that once x and  $_1$  are set,  $_2$  is xed autom atically. This equation at the same time puts a restriction on  $_1$ . One can check that if  $_1$  > x,  $_2$  becomes smaller than  $_1$ , which is impossible with the given form of distribution (Eq. (1)). We shall therefore restrict the value of  $_1$  to be smaller than x.

The mechanism of the failure of RFBM is the following: under an external stress , a fraction of bershaving threshold strength less than the applied stress fail immediately. The additional load due to breaking of these bers is redistributed globally among the remaining intact bers. This redistribution causes further failures. Let us de ne  $U_t = N_t = N$  as the fraction of unbroken bers after a time step t. Then,

The recurrence relation between  $U_t$  and  $U_{t+1}$  for a given applied stress is obtained as  $^9$ :

This dynamics propagate (in discrete time) until no further breaking takes place.

If the initial applied load is very small so that the redistributed stress is always less than  $_2$ , then no bers from class B will fail. Thus for breaking of class B bers, the redistributed stress has to be greater than  $_2$ . Let  $_{\rm t}$  (the redistributed stress) cross  $_2$  at some instant t. Then the critical stress of the system can be calculated as follows:

It can be shown easily that the solution with + in the parenthesis gives a stable solution. Therefore,  $_{\rm C}$  is the critical stress of the system because if the applied stress

is less than  $_{\rm c}$ , the system reaches a xed point. If the applied stress is greater than  $_{\rm c}$ , U becomes in aginary and the bundle breaks down completely. It is interesting to note that at =  $_{\rm c}$ ; U = 1=2[1 ( $_{\rm 2}$   $_{\rm 1}$ )] i.e., m one than half of the bers are still unbroken at critical point.

We should now look at the restrictions on  $_1$ ,  $_2$  and x (other than  $_1$  < x) so that the above calculations are valid. From Eq. (4), we not that if the width of the forbidden region ( $_2$   $_1$ ) is greater than half, U ( $_c$ ) > 1 which is unphysical. Therefore, ( $_2$   $_1$ ) should be smaller than 1/2 for all values of x for the above calculations to hold. Using this restriction in Eq. (5), we not that the critical stress  $_c$  will always be less than 1/2. Now, looking at the physical meaning of U , we must also check that the fraction of broken bers at the xed point corresponding to critical stress  $_c$  must be greater than the fraction of bers having their threshold stress smaller than the critical stress. We sum marise all the restrictions below:

In the table below, we enlist some allowed values of  $_1$ ,  $_2$  for dierent x and also the corresponding critical stress.

From the table, we observe that the critical stress depends entirely on the width of the forbidden region, i.e.,  $_2$   $_1$ . A lso, when  $_1$  is increased for a  $\,$  xed x,  $_2$  decreases and hence  $_c$  decreases. Physically, decreasing  $_2$  (with x  $\,$  xed) means that lowest threshold of the strong

bers (class B) gets lowered. It is found that  $_1$  cannot be very small compared to  $\mathbf{x}$ , else all the above mentioned conditions do not get satis ed.

One can de ne an order param eter as shown below:

The order parameter goes to 0 as  $\frac{1}{c}$  following a power law  $\frac{1}{c}$ . Susceptibility can be defined as the increment in the number of broken bers for an innitesimal increase of load. Therefore,




FIG.3: Variation of  $_{\rm C}$  with  $_{\rm 2}$   $_{\rm 1}$  for a m ixed RFBM with a distribution as in Fig. 2

As expected, the model follows mean—eld exponents with = 1=2 and = 1=2. The interesting features of this model are: In this model, the forbidden zone has a nontrivial role to play. (i)By changing (  $_2$   $_1$  ) and x, we can tune the strength of the system . However there are restrictions on the parameters as discussed above.  $_{\rm c}$  as a function of (  $_2$   $_1$  ) is shown in Fig. 3. (ii) If x = 0,  $_2$  € 0;  $_1$  = 0 (from Eq. 2) which gives  $_{\rm c}$  = 1=4 (1  $_2$ ) and we observe an elastic to plastic deform ation as discussed in reference 9. In this case, for <  $_2$ , the ber in the bundle obey Hook's law . As soon as >  $_2$ , the dynam ics of failure of bers start. (iii) If  $_2$   $_1$  = 0, the problem is that of a simple UD with threshold strength between 0 and 1 which has a critical stress  $_{\rm c}$  = 0.25°.

These results con  $\,$  m that the failure of mixed  $\,$  ber bundle model with G lobal Load Sharing belongs to a universality class with critical exponents  $\,$  = 1=2 and  $\,$  = 1=2.

# III. M IXED FIBERS W ITH W EIBULL DISTRIBUTION AND GLS

In the Weibull distribution of threshold strength of bers, the probability of failure of each element has the

form

where  $_0$  is a reference strength and is the W eibull index. We now consider a mixed RFBM as in section II with W D of threshold strength of bers. As in the UD case (of Sec. (2)), here also a fraction x of bers belong to the class A (W D with = 2) and the remaining (1 x) fraction belong to the class B (W D with = 3) with the reference strength  $_0$  equal to 1 in either case.

For the conventional W D, consider a situation where the stress on each ber increases from  $_1$  to  $_2$ . The probability that a ber random ly chosen from the W D survives from the load  $_1$  but fails when the load is  $_2$ , is given by

Thus the probability that the chosen ber that has survived the load  $_1$  also survives the (higher) load  $_2$  is  $q(_1;_2) = e^{_{_1} 2} - 1$ ). The key point is that the force F on the bundle is increased quasistatically so that only one ber am ongst the remaining intact bers break. As mentioned previously, the dynamics of breaking will continue till the system reaches a xed point. The process of slow increase of external load is carried on up to the critical stress  $_{_{\rm C}}$ .

To deal with the nature of the present  $^0$ m ixed  $^0$  random ber bundle m odel, the m ethod used by M oreno, G om ez and P acheco  $^{21}$  is generalised in the following manner. It is important here to keep track of number of unbroken bers in each distribution separately. Let us assume that after a loading is done and a xed point is reached,  $N_{k_2}$  and  $N_{k_3}$  are the number of unbroken bers corresponding to = 2 and = 3 distribution respectively, where each ber has a stress  $_k$ .




FIG. 4: Variation of fraction of broken bers with external load per ber for a RFBM with two distributions corresponding to = 2 and = 3.N = 50000, x = 0.5

The breaking of one ber and the redistribution of its stress causes some more failures. Let us say that during this avalanche, at some point before the exed point is reached, there are  $N_{k_2}$  and  $N_{k_3}$  number of unbroken bers belonging to the two distributions where each bers under a stress  $f_k$ . This stress causes some more failures and as a result  $N_{k_2}$  and  $N_{k_3}$  bers are unbroken. Let the new stress developed is  $k_3$ . The number of bers which survive  $k_3$  are obtained using the relation

The stress on each ber is now equal to  $(N_{k_3}^{\circ} + N_{k_2}^{\circ})_k^{\circ} = (N_{k_2}^{\circ} + N_{k_3}^{\circ})$ . Eq (12) and Eq. (13) are used again and again until a xed point is reached. The xed point condition is given by  $(N_{k_2}^{\circ} + N_{k_3}^{\circ})_k^{\circ} = (N_{k_2}^{\circ} + N_{k_3}^{\circ})_k^{\circ} < N_{k_2}^{\circ} + N_{k_3}^{\circ} < N_{k$ 

A first the xed point is reached, stress  $_{\rm l}$  is calculated once again as mentioned before and the whole process is repeated till complete failure occurs at  $_{\rm c}$ . The above mentioned approach has the advantage that it does not require the random averaging of M onte C arlo simulations.




FIG. 5: Scaling behaviour of avalanche size as the critical point is reached for the m ixed m odel. A lso shown is a straight line (dotted) with slope (-1/2). Here, N = 50000 and x = 0.5.




FIG. 6: Variation of critical stress  $_{\text{c}}$  with x. Slope of the straight line is 0.068. N = 50000

Fig. 4 shows the fraction of total number of broken bers as a function of applied stress for the case x = 0.5. The graph clearly shows the existence of a critical stress,  $_{\text{c}}$  = 0:46, which lies between the critical stress of = 2 (0.42) and = 3 (0.49) distribution . These theoretical values are obtained from the analytical expression  $^{7}$   $_{\text{c}}$  = ( e)  $^{1\text{=}}$  . The avalanche size S is de ned as the number of broken bers between two successive loadings. It diverges near the critical point with an exponent = 1=2 as ( $_{c}$  ) . Scaling behaviour of avalanche size S is shown in Fig. 5. This con mms the mean eld nature of GLS models even with mixed bers. The most attractive feature of the mixed RFBM is shown in Fig. (6) which contains the variation of c with the fraction x of class A bers. Interestingly, decreases linearly as x is increased.

### IV. ONE DIMENSIONAL, ONE SIDED LLS

In numerical studies, it is dicult to generate a strictly uniform distribution of the threshold strength of random bers. In this work, we have addressed the problem of random bers with UD of threshold with LLS scheme using an exact treatment of one sided load distribution 10. The complication arising in the present approach due to the uniform nature of the threshold distribution will also be emphasised later.

In one sided LLS, the additional load due to breaking of a ber is transferred only to its neighbour in a given direction. The bers are placed along the circum ference of a circle with periodic boundary conditions. The method is based on the k-failure concept. If k is chosen appropriately, then more than k adjacent failures is equivalent to complete failure of the system. The scheme involved is as follows: let  $p_i = p(i)$  is the probability of failure of a ber supporting a load i (where is the initial applied load per ber). This is same as the probability of failure

ofall the previous (i 1) bers. Let  $P_N$  ( ) represents the probability that a system of N bers break when an initial force equal to N is applied and  $Q_N$  ( ) = 1  $P_N$  ( ) is the probability that the bundle does not break because of initial bad N . We have de ned the critical bad  $_{\rm C}$  by setting  $P_N$  (  $_{\rm C}$ ) = 0.5. However, any other choice of  $P_N$  (  $_{\rm C}$ ) does not alter the result.  $Q_N$  ( ) can be easily identified as the probability that out of N bers, there is no chain of adjacent broken bers of length greater than k.




FIG. 7: Possible breaking con gurations of a set with N=4 elements when the maximum allowed crack length is k=2 for one sided one dimensional LLS

 ${\rm Q}_{\,\rm N}$  ( ) can be calculated by using a simple iterative procedure described in Fig. 7. The  $\,$  gure shows all possi-

ble states of a ber in a system of 4 bers with maximum num ber of allow ed ad jacent broken bers equal to 2 (i.e., k=2). The notation m eans the following: the symbols 1 and 2 m ean that in the corresponding position, the ber breaks with a stress 1, 2 respectively.  $1^0$ ;  $2^0$ ;  $3^0$  m eans that the corresponding element does not break under the stress 1, 2 and 3 respectively. This simple notation can be extended to a system of N bers. If a ber site has a symbol m, the two possibilities for the next ber are (m + 1) and  $(m + 1)^0$ . If the site has  $m^0$ , the two possibilities are 1 and  $1^0$  for the next site as m  $^0$  m eans that the ber has not broken and hence no additional stress is given to the next ber. But if m = k, then the only allowed possibility for the berat the next site is  $(k+1)^{\circ}$ . This is to ensure that we are looking at only those con gurations in which the complete breakdown does not take place. The aim is to write  $Q_N$  () in term s of  $Q_{N-1}$  (). Let B<sub>i</sub>(N), where i k is the sum of probability contributions of the paths of length N ending in the symboli. A lso, B<sub>i0</sub> (N) with  $i^0$  k + 1, is the sum of contributions of all paths ending in symbol i0. The following relations can then be obtained

and hence the critical point can be obtained by dem anding that  $Q_N$  ( ) is 0.5 as the critical point is reached. B(N) can be written in a column matrix form where  $B_i(N)$  and  $B_i^0(N)$  are its (2k+1) components. The set of equations represented by Eq.(14) can then be written as:

Since the model is based on the k-failure concept, the next question that arises is what an appropriate value for k should be (which exest the matrix size). This can be obtained by a simple criterion of convergence: if results do not vary when matrix size is increased from k to k+1, then that value of k is su cient for k-failure concept. This is equivalent to saying that the probability of breaking when the stress on a ber is (k+1) is 1 (by the denition of k-failure) and hence there is no further change as one increases k (as the complete failure has already occurred).

The above described convergence can be clearly seen if one uses W D of threshold strength  $^{10}$ . As mentioned before, the situation is dierent in the case of UD. The method used above allows the probability of failure to go beyond 1 if UD is used. The probability that a ber breaks when the stress is x is x, where x should vary




FIG. 8: The variation of  $_{\rm c}$  w ith k for UD is shown in Fig. 8(a). Fig. 8(b) shows the variation of  $1=_{\rm c}$  w ith  $\log_2 N$ .

from 1 to k. It may happen that for some x and , the matrix elements become greater than 1 which is clearly unphysical as each matrix element corresponds to a probability. It is observed that the value of c increases with k and after attaining an almost constant c, it starts decreasing. This decrease actually corresponds to the situation when the matrix elements at some stage of the calculation is either greater than 1 or less than 0 and hence not a saturation but a peak is obtained. Fig. 8 (a) shows the variation of c with k where a peak is observed. We have taken k=8 for our further calculations.

In Fig. 8(b), we have shown the variation of 1/  $_{\rm C}$  with  $\log_2 N$  . Clearly it is a straight line which matches with the previously obtained analytical and numerical results  $^{10,17,18}$  . The slope of the line is 0.81. The critical stress vanishes in the therm odynamic limit indicating the absence of a critical behaviour in one sided, one dimensional RFBM .

#### V. FIBERSON A RANDOM GRAPH




FIG. 9: An example of a random graph with coordination number 3 and 16 sites

Construct a random graph having N sites such that each site has exactly 3 neighbours. The algorithm used is as follows: label the sites by integers from 1 to N where N is even. Connect site i to i+1 for all i such that site N is connected to site 1. We call this connection as direct connection. Thus we have a ring of N sites. Now connect each site random by to a unique site other than i+1 and i 1, thus form ing N=2 pairs of sites. This connection is called random connection. Each site in such a graph has a coordination number 3. In this construction, all sites are on the same footing (See Fig. 9). The tip of the bers are placed on these N sites and are associated with a UD of threshold strength.

The system is then exposed to a total load N such that each vertex carries a stress (i) = . If  $_{\rm th}$  (i) < (i) at any site i, the ber breaks and its stress is equally distributed to its surviving neighbours. The above condition is exam ined for each site and is repeated until there is no more breaking. Increase the total load N to N ( + d ).




FIG. 10: The variation of  $\,$  with  $\,$  for di erent values of N . Here, N =  $2^{13}$ ;  $2^{14}$ ;  $2^{15}$ ;  $2^{16}$ ;  $2^{17}$ ;  $10^5$ ; 2  $\,$  10 $^5$ . The lower  $\,$  corresponds to a higher value of N .

The new total load is then shared by the remaining unbroken bers and once again the breaking condition is checked at each site. To make sure that the total load is conserved, if a ber encounters a situation in which one of its neighbours is broken, it gives its stress to the next nearest surviving neighbour in that direction. This rule how ever is not applicable to the random ly connected

ber i.e., if the random ly connected neighbour of a broken ber is already broken, the stress then is given only to its directly connected neighbours. Once again, the load is increased and the process is repeated till complete breakdown of the system. In the numerical simulations, do is taken to be 0.0001 and the average is taken over  $10^4$  to  $10^5$  congurations.

Fig. (10) shows the variation of , the fraction of unbroken bers, with stress for dierent values of N . Clearly, there exist a non-zero value of critical stress even for large N .

To determ ine  $\,_{\text{c}}$  precisely, we use the standard  $\,$  nite

size scaling m ethod<sup>23</sup> with the scaling assumption




FIG.11: Precise determ ination of  $_{\rm c}$  from the nite size scaling form (18). The  $_{\rm c}$  at which the curves intersect is 0.173

where f(x) is the scaling function and the exponent describes the divergence of the correlation length—near the critical point, i.e., / j \_cj . If / (\_c \_) , we obtain the relation a = = . The plots of N^aw ith—for di—erent N crosses through a unique point = \_c= 0.173 w ith the exponent a = 0.5 (See Fig. 11).




FIG. 12: D at a collapse with a = 0.5, = 1

With this value of c and a, one can again use the scaling relation (18) to determ ine the exponent by making the data points to collapse to an almost single smooth curve as displayed in Fig. (12). The value of obtained in thism anner is equal to 1 which autom atically gives the value of the other exponent = 0.5. This m atches with the mean eld exponents derived analytically. A random graph with connections as described above is equivalent to a Bethe lattice with co-ordination number z (= 3 in present case) for large N<sup>24</sup>. It is observed that in this model, accurate value of c (Fig. 11) and data collapse (Fig. 12) obtained by nite size scaling method is applicable in the lim it of large N. It may be because of the resemblance of the underlying structure of the system with the Bethe lattice that it has mean eld exponents. This should also be compared to Ising models with in nite-range interaction (which corresponds to GLS in the present context) 13 and with short-range interaction on a Bethe lattice both showing mean eld critical behaviour.

#### VI. CONCLUSION

We have introduced a mixed RFBM with UD in one case and WD in the otherwithin GLS scheme. The mixed RFBM with UD has a forbidden region  $_2$   $_1$  so that the distribution of the threshold strength is discontinuous though the uniformity is ensured. The width of

the forbidden region tunes the critical stress of the system and thus exhibits a rich critical behaviour. At the same time, restrictions on the parameters of the distribution for which the analytical method holds good are also clearly pointed out. The burst avalanche distribution of this type of discontinuous threshold distribution is expected to be very interesting and that is the sub-

ject of our further research. To study m ixed RFBM with WD, a quasistatic approach is employed to determ ine the critical stress which decreases linearly with the fraction of class A bers. Exponents obtained in both the above cases fall under mean eld universality class. The most interesting feature of the mixed models is the tunability of the critical stress with the system parameters.

The behaviour of critical stress in a one dimensional RFBM with one sided LLS and strictly UD is also studied using an exact method and the complication arising due to the uniform nature of distribution is emphasized. We have also looked at the breakdown phenomena of RFBM on a random graph with coordination number 3. The critical stress is obtained using the nite size scaling method. The mean eld nature of transition is established in the lim it N! 1.
