# Lateral and norm al forces betw een patterned substrates induced by nem atic uctuations

#### Abstract

W e consider a nem atic liquid crystal con ned by two parallel at substrates whose anchoring conditions vary periodically in one lateral direction. W ith in the G aussian approxim ation, we study the e ective forces between the pattemed substrates induced by the therm al uctuations of the nem atic director. The shear force oscillates as function of the lateral shift betw een the pattems on the lower and the upper substrates. We com pare the strength of this uctuation-induced lateral force w th the lateral van der $W$ aals force arising from chem ically structured adsorbed $m$ onolayers. The uctuation-induced force in nom aldirection is either repulsive or attractive, depending on the m odel param eters.

## I. IN T R O D U C T IO N

Liquid crystals are characterized by large them al uctuations in their local orientational order arising from collective alignm ent of the long axis of their constituent $m$ olecules [11]. D ue to such soft anisotropy, liquid crystals tend to respond easily to extemal forces. C on n ing geom etries such as thin $\mathrm{m} s$, on which $m$ ost $a p-$ plications of liquid crystals are based, change the uctuation spectrum. This can cause not only structural changes $\left[\begin{array}{ll}{[1,1]} \\ \hline\end{array}\right]$ but also leads to uctuation-induced effective forces betw een the substrates [ $\left[\begin{array}{l}{[1]}\end{array}\right]$, also known as therm odynam ic $C$ asim ire ect. In correlated uids such as liquid crystals this C asim ir force exhibits a universal pow er-law decay_as a function of the separation betw een the substrates [ ${ }_{-1}^{1}$ ]. H ow ever, this behavior is m odi ed in the presence of other characteristic scales in the sys-
 m odulated, discrete lateralm odes of therm al uctuations are also excited. Under such conditions, in addition to the forces acting penpendicularly to the substrates, e ec-
 ing technological applications. W e study the in uence of anchoring conditions, which vary periodically in one lateraldirection, on the uctuations of a uniform ly ordered nem atic liquid crystal. Obviously, the periodicity of the substrate pattem gives rise to an oscillatory behavior for the lateral force as a function of the lateral shiff
betw een the substrates. For sm all inhom ogeneities the

[^0]lateral force is proportional to $\sin (2=)$. (T he analysis of nonperiodic pattems would provide an understanding of nem atic phases exposed to chem ically disordered substrates.) The present study actually extends our previous w ork $[1] 1]$ where we considered the case in which only one of two con ning substrates exhibits a chem ical pattem so that there are no lateral forces. H ere, in addition to the uctuation-induced lateral forces, we calculate the lateral force betw een the pattemed substrates across the vacuum, i.e., the background van der $W$ aals foroe acting parallel to the substrates. This background force is generated by the necessary chem icalm odulations providing the laterally varying anchoring strengths.

In Sec. II our m odel and the theoretical form alism are speci ed. In Sec. 'IMAA', the uctuation-induced lateral force is obtained. In Sec. $\overline{I M B}$ w we calculate the lateral van der $W$ aals force betw een the pattemed substrates. $T$ he results for the uctuation-induced nom al force are presented in Sec.'IV' and nally Sec. 'Vi' summ arizes our results.

## II. SYSTEM AND FORMALISM

W e consider a nem atic liquid crystal con ned by two at but chem ically pattemed substrates at a separation d. The pattems on the both substrates consist of the sam e periodic stripes of anchoring energies per area $W$ a and $W_{b}$ along the $x$ direction but shifted relative to each other by the length (see Fig. 1). The substrates are translationally invariant in the $y$ direction. T he stripes are considered to vary with respect to the strength of hom eotropic anchoring so that the $m$ ean orientation of the director $n$ is spatially hom ogeneous but the them al uctuations vary laterally giving rise to e ective lateral

describe the stripe m odulations at the low er and the upper substrates, respectively, ( $x$ ) is the H eaviside step function, and is the periodicity. The stripes have the sam e width $a_{b}=b_{b}$ and are separated by shanp chem ical steps. The functions $a(x)$ and $b(x)$ equal one at the regions characterized by W a and zero elsew here at the lower and the upper substrates, respectively. ## A. Path integral techn ique

The norm alized [see, c.f., after E q. $(\bar{q})$ ( 1 ) ] partition function $Z$ of the uctuating elds i, $i=1 ; 2$, sub ject to the boundary conditions given by Eqs. (8 and ( 8 blo can be calculated w ithin the path integralapproach (see Ref. [ [11] and references therein). The boundary conditions act as constraints which can be im plem ented by delta functions. They, in tum, can be written as integral representations by introducing two auxiliary elds localized at $z=0$ and $z=d$, respectively $\left[12^{2}, ~ r 133^{\prime}\right]$. A $f-$ ter perform ing the corresponding $G$ aussian integrals over
ir $i=1 ; 2$, the path integral reduces to a Gaussian functional integral over the auxiliary elds with a matrix kemelM, so that obtaining the result for $Z$ reduces

B. P eriodic m odulation

The $m$ atrix kemel $M$ is a functional of the patteming function $a(x)$ on the substrates and therefore calculation of the inverse of $M$ is nontrivial. How ever, in system $s$ w ith in-plane sym $m$ etries one $m$ ay proceed by a lateral Fourier transform ation w th respect
to the lateral coordinates $x=(x ; y)$. In Ref. [1] $\left.{ }^{[1}{ }^{1}\right]$, it is shown how the electrodynam ic C asim ir force can be calculated for a periodically $m$ odulated substrate (see also Refs. [1] [1] []). In this reference, the lateral periodicity is used to transform the $m$ atrix $M$ to a block-diagRnal form in Fourier space ( $p ; q$ ) in which $M(p ; q)=d^{2} x d^{2} x^{0} M\left(x ; x^{0}\right) e^{i p} x^{i q} x^{0}$. III. LATERALEORCES
A. Fluctuation-induced shear forces

The lateral force oscillates as function of re ecting the underlying lateral periodic pattem and its $m$ agnitude decays exponentially as function of $\mathrm{d}=$, because $\mathrm{f}(1 ; \mathrm{v})<1$.

For_arbitrary values of $d$, we evaluate the force _in Eq. (1-1 ) num erically. A though the matrix B Eq. (1]íl)] is in nite-dim ensional, the value of the force saturates at some nite values for $k$;l. O ur num erical results for the uctuation-induced lateral force as function of the shift for arbitrary strength of the contrast $b$ a are show $n$ in $F$ ig. 2 . The lateral force acts against the increase of the lateral displacem ent in the interval $[0 ;=2$ ) by being a restoring force and acts favorably $w$ ith the increase of in the interval ( $=2$; ] by being a pulling force. Therefore the force is antisym $m$ etric w th respect to $==0: 5$. U pon approaching the $\mathrm{max}-$ im um m isalignm ent, i.e., $=0: 5$, the restoring force vanishes. This implies that the interaction free energy $V_{\text {lat }}()={ }_{0}^{\mathrm{R}} \mathrm{F}_{\text {lat }}\left({ }^{0}\right) \mathrm{d}^{0}$ has its m axim um at $=0: 5$ where the opposing parts of the substrates face each other and attains its m inim um $=0$. A sym ptotically, $\mathrm{F}_{\text {lat }}=\left(\mathrm{k}_{\mathrm{B}}\right.$ T S $\left.={ }^{3}\right)$ vanishes as $0: 003 e^{2 d=}=(d=)$ for $a==4, b==8$, and $=0.25$.

W e note that due to the assum ption $\mathrm{a}=\mathrm{b}$ interchanging a and $b$ leaves the system unchanged $\mathbb{E}$ ig. $\left.{ }^{\prime} 11\right]$. $T$ hus the force must be identical for a $\$ \mathrm{~b} . \mathrm{W}$ hile in Eqs. (2 $2 \mathbf{O}_{1}^{\prime}$ ) and (211) this symmetry is explicitly valid up to the second order in ( $b \quad a$ ), the num erical results respect this sym $m$ etry fully. This provides a very useful check of the num erical calculations.

## B . Lateral van der $W$ aals force

E ndow ing the substratesw ith the envisaged stripe pattems requires corresponding chem ical pattems which in

tum involve at least tw o di erent species providing the chem ical contrast. These species do not only interact (di erently) w th the nem atic liquid crystal in the vicin-止y of the substrate, giving rise to tw o di erent extrapolation lengths a and b, but also interact across the liquid crystalw ith each other via dispersion forces. The later interaction provides a lateral force as w ell w hich adds to the uctuation-induced lateral force. N ote that such a

lateral force due to direct interactions is the sam e if the tw o pattemed substrates are separated by vacuum or by a nem atic liquid crystal, as long as the $m$ ean nem atic order is not a ected by the stripe pattems.

In order to estim ate these direct interactions betw een the pattemed substrates, we consider each substrate to be covered by a monolayer whose chem ical com position varies periodically, altemating betw een A-and Bparticles. W e neglect non-additivity aspects of the dispersion forces and consider pairw ise interactions betw een the pattemed $m$ onolayers at $z=0$ and $z=d$. Since we consider $d$ to be large com pared $w$ th the diam eters of the A and B particles, we can disregard that particles form ing the $m$ onolayers occupy discrete lattice sites. A s pair potentials betw een the tw o species we take LennardJones potentials

From Fig. $\overline{1}$ one nds, for the same system parameters and $\bar{d}$ considered above and at room tem perature, for the uctuation-induced lateral force $F_{\text {lat }}$ $0: 02 \mathrm{pN} \mathrm{S}=(\mathrm{m})^{2}$. T hus the background lateral van der $W$ aals force tends to be stronger than the nem atic uctuation induced force. H ow ever, for a suitably chosen chem ical contrast of the particles form ing the chem ical stripes, it appears to be possible to determ ine the uctuation-induced lateral force by $m$ easuring the shear force once $w$ th and once $w$ thout the nem atic liquid between the pattemed substrates. The ratio of the two forces for $d==0: 05, a==4, b==8$, and $\mathrm{E}={ }^{5} \quad 1: 5 \quad 10^{5} \mathrm{pN}=(\mathrm{m})^{2}$ as function of is shown in Fig. ion . It appears that the uctuationinduced lateral force becom es $m$ ore prom inent around

responding lateralvan der $W$ aals background force. $T$ his ratio is inversely proportionalto $E=E_{A A} \quad 2 \mathrm{E}_{\mathrm{A}}+\mathrm{E}_{\mathrm{B}}$. $F$ igure ${ }_{1} \bar{G}_{1}$ corresponds to a param eter choice for which $E$ is estim ated by an individual $\mathrm{E}_{\mathrm{ij}}$ and not by the actual contrast expressed by E , which vanishes for $\mathrm{A}=\mathrm{B}$. $\mathrm{Ac} \mathrm{c}^{-}$ cordingly, for suitable choioes of A and B, E can be signi cantly sm aller than the $E_{i j}$ used in $F$ ig. ${ }^{\prime}$ 'G w wich then leads to a signi cantly larger ratio.

## IV . FLUCTUATION-INDUCED NORMAL FORCE

The e ect of a periodic anchoring at one substrate, w ith the second substrate being hom ogeneous, on the uctuation-induced nom al force w as studied in $R$ ef. $\left.{ }_{[1] i n}^{1} 1_{1}^{1}\right]$. It tumed out that for the description of the norm al force the single pattemed substrate can be replaced by a uni-

form substrate $w$ ith an e ective anchoring strength, i.e., the force is given by the force found betw een tw o uniform substrates characterized by their e ective anchoring. D epending on the $m$ odelparam eters, the norm al force is either repulsive or attractive $\{$ corresponding to an e ective sim ilar-dissim ilar or an e ective sim ilar-sim ilarboundary condition, respectively. In the present case of two pattemed substrates, we have calculated the norm al force num erically Eq. (1-G)]. Figure 'ī' show s the dependence of the norm al force $\mathrm{F}_{\text {norm }}$ on d . For $\mathrm{d}<\mathrm{a} ; \mathrm{b}$ as shown here, the force is attractive and decays m onotonically as function of $d$. In this regim $e$, the anchoring is weak at both substrates so that the e ect of the periodicity is not visible. W e note that in this case the uctuationinduced norm al force $\mathbb{F}$ ig..$\left._{1}^{17} \overline{1}\right]$ is about 1000 (100) tim es larger than the uctuation-induced lateral force $\mathbb{F}$ ig. ${ }^{\prime}$ for $a=4$ (2). Figure, $\bar{q}$, how ever, show $s$ the behavior of $\mathrm{F}_{\text {nom }}$ as function of $\overline{\text { in }}$ the regin e ofstrong but nite anchoring $d>a ; b$. In this case the norm alforce is oscillatory and attractive, and its m agnitude is com parable


## V. SUMMARYAND CONCLUSION

W e have calculated the uctuation-induced foroes acting on two substrates chem ically m odulated $w$ th period

and con ning a nem atic $m$ of thickness $d$ ( $F$ ig. ${ }_{1}^{-1}$ ). $T$ he substrates are characterized by hom eotropic anchoring with altemating extrapolation lengths $a$ and $b$. We have studied the shear force as function of the lateral shift between the pattems on the substrates and of their separation $d$. For $j_{b} a j a$ and $d$, the lateral force sinusoidally oscillates as a fiunction of

In order to com plete the picture of the forces in the presence of the pattemed substrates we have also calculated num erically the uctuation-induced norm al forces $\mathbb{E}$ igs. $\overline{1}_{1}^{1}$, and $\left[\frac{1}{1}\right]$ parable w ith the uctuation-induced lateral force in the case of strong anchoring $\mathbb{E}$ ig. .'9,
$P$ atteming at sm all length scales gives rise to rich interfacialphenom ena. Surface m odulations open the possibility of controlling them orphology ofw etting lm sand generate structuralphase transitionsw hich are centralto the behavior ofstructural forces induced by distortions of the liquid crystalorder param eter. In such cases, in addition to the uctuation-induced forces, the substrates are sub ject to liquid-crystalline elastic forces [3] forces scalew th K Eq. (Z, $)$ ] and are for large d larger than the uctuation-induced forces which scale with $k_{B} T$. Since for sm all $d$ the elastic foroes scale as d $0: 5$
the uctuation-induced force as d ${ }^{3}$ [5్1] $\left.{ }^{1}\right]$, the latter can, how ever, even dom inate for $s m$ all $d$. The $m$ ean eld director contributions are com pletely elim inated for such m odelparam eters and boundary conditions for $w$ hich the director structure is uniform. In Ref. [1d] it has been dem onstrated that this uniform ity can indeed occur for suitable com binations ofm odelparam eters, even in cases of com peting planar and hom eotropic anchoring conditions, which have not been considered here. C apillary forces due to capillary condensation and the form ation of bridge phases $\left[\begin{array}{ll}2 \\ 0 & 1\end{array}, \overline{2} \overline{1}_{1}^{1}, ~, ~ i 2 \overline{2}\right]$ are other sources for the structural foroes in the vicinity of the nem atic-isotropic phase transition. If the uid is con ned to very narrow slits, patteming $m$ ay give rise to capillary bridges of different liquid crystalline order. U nder such conditions, it w ould be interesting to study the stress under the shear strains by shifting the lateral substrate structures out of phase [23]] which $m$ ight give rise to rather strong lateral forces.

Lateral forces can technologically be used to align the parallel substrate structures. For instance, for those ranges of the $m$ odel param eters for which the liquid crystalline lateral foroes are signi cant, the liquid crystal can be lled into the slit pore to align the substrate structure and then be rem oved.
