Interplay between Zeem an interaction and spin-orbit coupling in a two-dimensional sem iconductor system

We analyse the interplay between D resselhaus, Bychkov-R ashba, and Zeem an interactions in a two-dimensional sem iconductor quantum system under the action of a magnetic eld. When a vertical magnetic eld is considered, we predict that the interplay results in an elective cyclotron frequency that depends on a spin-dependent contribution. For in-plane magnetic elds, we found that the interplay induces an anisotropic elective gyrom agnetic factor that depends on the orientation of the applied eld as well as on the orientation of the electron momentum.

The e ects produced by di erent spin-dependent interactions in sem iconductor structures are currently in the forefront of experimental and theoretical e orts in m esoscopic physics. The explosive activity is motivated by the desire for a deep understanding of quantum coherence phenomena. The other driving force is the hope that the spintronics research would provide novel, lowdissipative m icroelectronic devices [1, 2].

M ost m easurements of spin e ects in semiconductor m icrostructures are performed applying a magnetic eld. In this case, two intrinsic spin-dependent interactions naturally appear: the well-known Zeeman interaction, which couples the electron spin with the applied eld, and the spin-orbit coupling. The latter has been extensively studied starting from two-dimensional electron gas to quantum dots [3, 4, 5, 6, 7, 8], and constitutes the basis of several proposals for spin-based applications [9, 10, 11].

In a sem iconductor, the spin-orbit coupling originates as a relativistic e ect caused by electric elds present in the material (cf [12]). Such a system can be described by the H am iltonian

Here $T = p_x^2 + p_y^2 = 2m$ is the kinetic energy with the e ective mass m of electrons in the conduction band of the sample and p_x ; p_y are components of the momentum. The electric eld caused by the bulk inversion asymmetry of the crystalline structure contributes to the H am iltonian, Eq.(1), with the D resselhaus term, H_D [13]. This term has, in general, a cubic dependence on the mom entum of the carriers. For a narrow [0;0;1] quantum well, it reduces to the 2D, linear m om entum dependent term $(p_{x x} p_{y y}) = \sim$. Here, the 's are the Pauli $H_D =$ m atrices, and is the intensity of this interaction (cf Ref.12). The electric eld caused by the structure inversion asymmetry (SIA) of the heterostructure generates the Bychkov-Rashba term , H_R [14]. Since in the asym metric quantum wells the SIA comes from the vertical direction, the Bychkov-Rashba interaction H_R has the form : H_R = $(p_{y x} p_{x y}) =$, where is the corresponding strength [12].

The correlation between di erent spin-dependent interactions is a key point in the understanding of spin phenomena in sem iconductors. In this work, we shall study a two-dimensional (2D) sem iconductor system in a magnetic eld, described by the H am iltonian (1), paying special attention to the interplay between the Zeem an and spin-orbit interactions. We will show that depending on the orientation of the magnetic eld and the strength of the spin-orbit coupling this interplay produces a dramatic e ect on the electronic spin structure of a 2D heterostructure.

We rst consider the case of B jj[0;0;1], i.e., of the magnetic eld parallel to the growth direction (z) of most heterostructures. In this case the momentum p is replaced by a generalized momentum P = p + (e=c)A, where the vector potential A of the vertical magnetic eld B = (0;0;B) is taken in the symmetric gauge A = B = 2(y;x;0). In the latter case the Zeem an term is given by: $H_Z = g_{BB} B_{Z} = 2 = "_{Z} = 2,$ where g represents the bulk e ective gyrom agnetic factor, that is assumed to be constant, $B = e^{-2m}e^{-c}$ is the Bohr's magneton and B the intensity of the applied eld.

W hen a single source of spin-orbit coupling is considered, the Rashba or the D resselhaus one, it can be completely solved [15, 16, 17]. The Ham iltonian com – mutes with the total angular momentum operator $(J_z = L_z + S_z)$ when the Bychkov-Rashba interaction is only considered. On contrary, when the D resselhaus term presents alone, the sym metry operator is given by $L_z - S_z$ [18]. If both terms are considered, no symmetry is available and a solution is unknown. Below we propose an approximate solution for the full problem, which is one of the main results of the paper.

In the absence of any spin-orbit coupling, one obtains

Landau levels spaced in energy by the cyclotron frequency $(!_{c} = eB = m c)$ and having a spin splitting given by the Zeem an interaction. To include the e ects of the spin-orbit coupling, we transform the Ham iltonian Eq.(1) to the reference fram e where it is diagonal in a spin space up to a second order

The explicit expressions of the operators involved in the unitary transform ation read,

W e expand the transform ed H am iltonian, Eq.(2), up to the second order in the param eters of the transform ation. Third order term s can be neglected if the magnitude of the operator involved in the transform ation is much smaller than unity. This requirem ent is satis ed for the spin-dependent term s that are dom inated by the orbital e ect of the magnetic eld. Therefore, the validity of the present approach is roughly restricted to the regime where the energy scale concerning the spin-dependent interactions $("_z; ;)$ is much sm aller than the energy scale given by the cyclotron frequency $(~!_{c})$. Nevertheless, note that no restriction is in posed on the relative weight of the spin-orbit coupling and the Zeem an interaction.

Under the above hypothesis, the resulting transform ed Ham iltonian is diagonal in spin space

and the corresponding eigenstates have their spin aligned in the vertical direction $(_z)$. The last term in Eq.(5) represents the contribution of the interplay between the whole set of spin-dependent interactions: D resselhaus, Bychkov-Rashba and Zeem an. It is diagonal in spin, although it has a crossed dependence on the inplane components of the generalized momentum. To illum inate the relevance of this term to the spectrum, we apply a second transform ation to the Ham iltonian, Eq.(5),

and keep all contributions, up to the second order. This approximation is well justied within our approach, since the magnitude of the term is much smaller than the

corresponding orbitale ect of the magnetic eld. In this way, the last term in Eq.(5) is transform ed to a kineticlike one: $\frac{m}{a^4} = \frac{2 \frac{\pi}{z}}{(a^2 + a^2)^2 \frac{\pi}{z}}^2 (P_x^2 + P_y^2)_z$. The intensity of this term has a sixth order dependence on the param eters of the spin-dependent interactions (; ;" $_z$). It is much smaller than the rst kinetic terms in Eq.(5). As a consequence, this term has no relevant e ect on the spectrum and can be safely neglected.

Under this approximation, one can see that the main e ect of the spin-orbit coupling and its interplay with the Zeem an interaction is contained in the st term of the Ham iltonian (5). In the transform ed reference fram e, this term is composed of the initial generalized kinetic term plus a spin-dependent one. The third term is just a constant that rede nes the origin of the energy, whereas the second one corresponds to the Zeem an interaction associated with the vertical eld.

Comparing with the usual expression for the kinetic energy, one observes that the spin-orbit interaction cause a rede nition of the e ective mass of the system . This effective mass (m "; #) depends now on the spin orientation of the electrons as well as on the param eters characterising the di erent spin-dependent interactions. In this way we face with a Landau problem of free electron motion (with this e ective mass) in the magnetic eld.

The spectrum associated with the Ham iltonian, Eq.(5)without the last term, can be obtained straightforwardly and it reads

ds= 1 denotes the di erent spin states. In Eq.(7), e expression '(2n + jlj+ l+ 1)' is usually replaced by (2N + 1)' corresponding to the principal Landau level index. The second term is the usual Zeem an contribution and the last one represents the constant shift. Note, that the correction introduced by the spin-orbit coupling in the spectrum, Eq.(8), depends quadratically on the intensities of the di erent spin-orbit term s, in contrast with the situation at zero magnetic eld, where the e ect in the spectrum depends linearly on these intensities. For a quantum dot, when only Zeem an and Rashba term s are considered [19], the interplay between the above terms modi es the spin-orbit intensity, while the kinetic term manifests a weak dependence on the spit-orbit coupling. For q = 0 (Zeem an term is absent) in a quantum dot, the kinetic term and the spin-orbit coupling remain without m odi cations.

W hen the Zeem an term is absent in the 2D system, the resulting spectrum shows, however, an e ective spindependent cyclotron frequency, ! c;s = ! c 2m (²

²)s=~³. M aterials with the e ective g = 0 can be created by changing the concentration of one of the components of a sample (see, for example, [20]). C om paring the latter expression with that given by Eq. (8), it can be seen that the di erent spin-orbit term s (Bychkov-R ashba and D resselhaus) interact in a di erent way with the Zeem an one. In both cases, the e ect is quanti ed by the ratio between the Zeem an energy and the conventional cyclotron frequency (= "z=~!c). Note, that this ratio is independent on the strength of the magnetic factor and the e ective m ass

Therefore, the interplay acts, in an e ective way, renormalising the intensities corresponding to the di erent spin-orbit term s. The character of this renorm alisation depends as well as on the sign of the gyrom agnetic factor of the sem iconductor material. If the sign of the gyrom agnetic e ective factor is negative then the e ective strength of the Bychkov-Rashba term is reduced, whereas the corresponding to the D resselhaus term is enhanced. On contrary, if the sign of 'g ' is positive, the e ective Bychkov-Rashba term is enhanced and the Dresselhaus one tends to be suppressed. Thus, our analytical results provide a transparent explanation for num erical results obtained for 2D electron gas with Rashba spin-orbit coupling only [21] and predict various new phenomena related to the interplay between both spin-orbit and Zeem an term s.

In table I there are listed the typical values of the effective gyrom agnetic factor and the e ective m ass corresponding to di erent sem iconductor m aterials. A wide gap m aterial such as G aAs, characterized by a relatively weak spin-orbit interaction, exhibits a sm all correction of the spin-orbit e ect of about 15%. However, in the case of narrow gap sem iconductors, which are characterized by strong spin-orbit intensities and g-factors, the interplay between both interactions yields a sizeable correction of the e ect corresponding to the di erent spin-orbit term s of about 17% for InAs and 35% for InSb.

If the magnetic eld is parallel to the plane of an electron motion, the situation changes substantially. In 2D systems, the orbital e ect of the applied in-plane magnetic eld is frozen due to the strong con nement in the vertical direction. The only e ect of the eld appears through the Zeem an interaction. In this case, the H am iltonian, Eq.(1), preserves the translational invariance and the m om entum is conserved. The Zeem an term now reads

where the angle represents the azim uthal orientation of the magnetic eld in the x y plane. The corresponding spectrum is given by the following analytical expression:

where k_x' and k_y' are the components of the in-plane momentum. This is a contrast to a quantum dot, where the approximate analytical solutions are available only for $H_z = 0$ and for $H_{R,p}$ H_Z [18].

To elucidate the in plications of the above expression, let us analyse som e illustrative lim it cases. First, we will consider the case when a single source of spin-orbit coupling is present. In the absence of the magnetic eld, the spectrum is de ned by " $_{k} = -k^{2}k^{2} = 2m$ ik (i = ;). The spin splitting ' ik' is isotropic, i.e., it doesn't depend on the orientation of the momentum. How ever, this sym - metry disappears when the Zeem an term is included. In the lim it = 0 the spin splitting can be written as

where the angle ' ' represents the azim uthal orientation of the momentum in the x-y plane. Note that, when the momentum is perpendicular to the magnetic eld (= =2 +), the spin-orbit coupling and the Zeem an term s are decoupled in the spectrum. The same happens for the D resselhaus interaction, but, in this case, when them om entum and the applied eld satisfy the condition (=). In general, how ever, the interplay between the Zeem an interaction and the spin-orbit coupling is reected by m eans of Eq. (12).

Let us consider the lim it of sm all Zeem an energy com – pared to ' k', which is usually satis ed near the Ferm i level of typical sem iconductor heterostructures. Expanding Eq. (12), we obtain

is an anisotropic elective gyrom agnetic factor originated due to the interplay between the two spin-dependent interactions. Thus, at B \notin 0, the splitting partners, determ ined by the term s k in Eq.(13), are enriched by the second term that is linear dependent on the magnetic eld. Due to a random orientation of an electron momentum in plane, the borders of such sub-bands are restricted within the range $[g_B B = 2; +g_B B = 2], cor$ responding to the di erent momentum orientations ' ', instead of the discrete spin states $g_B B = 2$ associated with an isotropic g-factor. Depending on the relative orientation between momentum and the applied eld, the value of the e ective q-factor can change its sign with respect to the initial bulk value. In fact, in experiments with a tilted magnetic eld [22] it was observed that the e ective g-factor depends on the tilted angle in the growth direction (z). In this case the increase/decrease of the q-factor may be in uenced by the orbital motion alone, since the tilting of the magnetic eld a ects different com ponents of the orbitalm om entum . In contrast to this experim ent, we provide a transparent m echanism of the anisotropy of the e ective q-factor in plane due to the interplay between magnetic eld and strong spinorbit coupling. This phenom enon may serve as a quideline to construct a novel class of read/w rite devices based on nanostructures with the strong spin-orbit interaction.

In the opposite limit " $_z$ $_ik$, the spectrum can be approximated by

Consequently, in this limit, there is an angular dependence of the orbital contribution to the spin splitting, which can be attributed to an anisotropic e ective strength of the Bychkov-Rashba term.

A nother interesting lim it is that the intensities of both spin-orbit term s are equal (j j = j j). A ssum ing = , the spin splitting reads

where $k_{yx} = k_y$ k_x . When the magnetic eld is oriented at = =4, the spin-orbit and the Zeem an terms don't couple in the spectrum, independently on the momentum's orientation. In this case the H am iltonian has a symmetry in a spin space and, consequently, orbital motion and spin are electively decoupled and the spin-orbit interaction is electively suppressed. Thus, we generalize the result found at B = 0 by Schliem ann at el [11] for a nonzero magnetic eld.

In summary, we have analytically studied the e ect of an applied magnetic eld on the interplay between the Zeem an, Bychkov-Rashba and Dresselhaus interactions in a 2D electron system . W hen the magnetic eld is perpendicular to the plane, we found that the spinorbit interaction induces a renorm alization of the e ective mass that becomes dependent on the spin orientation of the electrons. This spin-dependent contribution is noticeably in uenced by the interplay between the Zeem an interaction and the spin-orbit coupling, which m odi es in a di erent way the e ective strength corresponding to each spin-orbit term . The spin-orbit coupling effectively transforms to a spin-dependent cyclotron frequency (! $_{c;s} = eB_z = m_s c$) that in poses di erent spatial scale of an electron motion. Indeed, the spin separation of cyclotron m otion has been observed recently in [23] but in case of 2D hole gas, which exhibits a stronger spin-orbit interaction. The magnitude of the interplay between both spin-dependent interactions has a sizeable value for a narrow gap sem iconductors with large g-factors. For the in-plane magnetic eld, the interplay induces the an isotropic e ective gyrom agnetic factor that would lead to the observation of a continuum of Zeem an sub-levels in the spin structure of the spectrum. W hen the Zeem an interaction dom inates over the spin-orbit coupling, an anisotropic e ective spin-orbit intensity em erges.
