Theoretical constraints for the magnetic-dimer transition in two-dimensional spin models

From general arguments, that are valid for spin models with su ciently short-range interactions, we derive strong constraints on the excitation spectrum across a continuous phase transition at zero temperature between a magnetic and a dimerized phase, that breaks the translational symmetry. From the dimerized symmetries of the two phases, it is possible to predict, at the quantum critical point, a branch of gapless excitations, not described by standard semi-classical approaches. By using these arguments, supported by intensive numerical calculations, we obtain a rather convincing evidence in favor of a mathematic ransition from the ferrom agnetic to the dimerized phase in the two-dimensional spin-half model with four-spin ring-exchange interaction, recently introduced by A W. Sandvik et al. Phys. Rev. Lett. 89, 247201 (2002)].

I. IN TRODUCTION

In the last years, a large amount of work has been done to clarify the properties of unconventionalm agnetic system s. Indeed, the presence of frustrated interactions, generated either by the geometry of the lattice or by the competing interactions, can give rise to many anom abus low energy properties.¹ O ne of the most exciting is the possibility to obtain phases with no magnetic order even at zero temperature.² The actual interest in this subject has been recently renewed by the discovery of severalm aterials^{3,4,5} that do not show any sign of magnetic order down to very low tem peratures. From a theoretical point of view, a considerable progress has been done in elucidating the possible unconventional states and, apart from magnetic phases, it is now well accepted that many systems exhibit a large variety of disordered ground states. One class of such param agnetic states is given by the so-called valence-bond solids, where pairs of nearest-neighbor spins form a singlet, leading to an ordered pattern of valence bonds. These states explicitly break the translational sym m etry, im plying a degenerate ground state, and represent the two-dim ensional extension of the celebrated dim erized state, rather well established in quasi-one-dim ensionalm aterials.⁶ A nother class of disordered phases is given by the so-called spin liquids, that do not break any local symmetry. It is now rather widely accepted that also spin liquids possess som e degeneracy, or even a gapless spectrum, and have som e kind of order, called topological order, related to non-local operators.7,8

M uch recent research has focused on the way to describe transitions between di erent quantum phases. Indeed, from the Landau's arguments valid for classical critical phenomena, if one exclude a delicate ne tuning of the parameters, there is no reason to have a continuous transition between two phases with di erent symmetries of the order parameters, like for instance between a magnetic system and a valence-bond solid, and a rst-order transition would be the most natural scenario. However, very recently,^{9,10} these arguments have been questioned and it has been argued that the situation can be more complex and richer in quantum systems, where the Landau paradigm could be violated, giving rise to an appealing way to escape a rst-order transition. Therefore, it has been suggested that a quantum phase transition is intrinsically di erent from a classical one. In particular, when considering quantum phases, the natural description is no longer by using order parameters but instead by considering new degrees of freedom carrying fractional quantum num bers, that emerge at the critical point.

The arguments given in Refs. 9 and 10, based on eldtheory approaches, are rather convincing but it is natural to ask if microscopic spin models, de ned on a lattice, could present the same low-energy critical behavior. In this sense, however, we face a technical di culty: a good diagnosis would require to study large enough clusters, but this is not possible since quantum M onte C arlo sim – ulations of frustrated antiferrom agnets are plagued with a very severem inus sign problem. In this respect, it is im – portant to nd out microscopic models that do not su er from this problem but, at the same time, present phase transitions between quantum phases. Recently, Sandvik and collaborators¹¹ introduced a spin-halfm odel on the two-dimensional square lattice in the presence of a particular ring-exchange interaction:

Here hi; ji denotes a pair of nearest neighbor sites and [i; j;k;l] indicates the sites on the corners of a plaque-

tte. In particular, H_{Ring} is a ring-exchange interactions that acts as a cyclic permutation on the spins of a given plaquette whenever they are in a S^z = 0 con guration with parallel spins on opposite comers.¹² The case with J > 0 and K > 0 is considered, in order to avoid the sign problem . Notice that H is invariant under global U (1) transform ations S⁺_i ! eⁱ S⁺_i.

The Hamiltonian (1) has been investigated by using quantum M onte Carlo^{11,13} and it has been shown that, at zero tem perature and zero magnetic eld, there is a transition between a ferrom agnetic phase, stable for sm all values of K = J, and a dim erized one, characterized by columnar order at Q = (;0) and Q = (0;), stable for interm ediate ring-exchange couplings. Finally, for large K =J a checkerboard phase is also expected.^{11,13} Note that, in our notation, J is twice time bigger than the one used in Refs. 11 and 13. Once scaled in our units, their best estimate for the transition point from the magnetic to the dimerized phase is $K_c = J = 3.957$. In the original paper,¹¹ it has been shown that, by increasing the strength of the ring exchange, both the spin sti ness s and the magnetization M decrease and eventually vanish, with a corresponding insurgence of a nite dim er order param eter. Hence, the Ham iltonian (1) has been suggested as a prototype model to test the ideas of Refs. 9 and 10. However, subsequent and more accurate calculations have raised som e doubt on the previous ones, suggesting instead a weak rst-order transition¹⁵. The actual nature of the transition is therefore still controversial.

In this paper, we propose a di erent point of view to investigate the properties of a phase transition between a magnetic and a dimerized phase of a generic spin Ham iltonian with su ciently short-range interactions. Indeed, instead of calculating the order parameters and the sti ness, we derive strong constraints on the excitation spectrum across a continuous phase transition between a magnetically ordered and a dimerized phase, breaking translational symmetry. These constraints can be veri ed by using numerical techniques, such as the G reen's function M onte C arlo method.¹⁶ In our opinion this way to proceed represents the rst attempt to clarify the evolution of the excitation spectrum and can give important insight into the nature of the transition point also in other contexts.

The paper is organized as follow: in Sec. II we develop the general theoretical form alism, in Sec. III we present our num erical results, and in Sec. IV we draw our conclusions.

II. THEORETICAL FORM ALISM

In this section, we describe in detail the implications of a continuous phase transition from a magnetically ordered phase to a dimerized one on the excitation spectrum near the quantum critical point. In the following, we will consider an H amiltonian with a generic translational invariant two-spin coupling and SU (2) symmetry, and at the end of the section we will also discuss the cases with U (1) symmetry or multi-spin interactions.

Let us consider the H eisenberg H am iltonian on a twodimensional lattice with N = L L sites:

where $J_{i;j}$ is the coupling between the spins at site R_i and R_j and $S_i = (S_i^x; S_i^y; S_i^z)$ is the spin operator at the site R_i . For a translational invariant magnetic coupling that depends only upon $R_i \quad R_j$; i.e., $J_{i;j} = J_{ji}$, $j_j = J_r$, we can perform the Fourier transform and easily obtain:

where $S_q = 1 = \frac{p - P}{N}_j e^{iqR_j} S_j$ and $J_q = \frac{P}{r} e^{iqR_r} J_r$ dene the Fourier transform of the local spin operator and the magnetic coupling, respectively. In the following, we will consider interactions that are su ciently short range, that is:

For the SU (2) case, the eigenstates can be classi ed according to the total spin S and the ground state, here denoted by j $_{Q_0}$ i, is generally a singlet with momentum Q_0 . By means of the so-called Feynman construction, originally introduced to describe the excitations of the liquid H elium,¹⁷ we can easily de ne a variational state for the triplet excited state with momentum q with respect to the ground state:

 S_q being one of the three components of the total spin S_q (= x;y;z). Then, it is easy to calculate the variational energy E_{Q_0+q} of $j_{Q_0+q}i$

where h:::i stands for the average value over j $_{Q_0}$ i and the function F_{α} is given by the double commutator

By using standard commutation relations for the spin operators and by summing over all the spin components , we obtain

A fler perform ing the inverse Fourier transform , we have

where we used that $jS_i S_j ij S(S + 1)$ and the shortrange condition (4). Notice that the previous bound does not rely upon a small-q expansion, but it is instead valid for all m om enta. Therefore, we arrive to the important result that:

where S (q) = hS $_qS_q$ i is the static magnetic structure factor, that, in the SU (2) case, does not depend upon . Since j $_{Q_0+q}i$ is a variational state, its average energy has to be higher than the lowest exact triplet excitation with given momentum $Q_0 + q$. We conclude, therefore, that the inequality (10) will also hold for the exact triplet excitation energy with momentum $Q_0 + q$.

In the following we will argue that the rigorous bound on the excitation spectrum (10) quite naturally implies the existence of a new branch of gapless excitations close to an hypothetical second-order phase transition from a m agnetic phase to a dim erized one. W e will focus on the square lattice case and an ordered phase with staggered m agnetization at Q = (;), but sim ilar results can be also found in the case of di erent lattice structures or spiralm agnetic orders. For the sake of sim plicity, we can in agine that J_q depends upon one parameter g, proportional to the frustration of model: for instance, in the $J_1 \quad J_2 \mod J_q = 2(\cos q_x + \cos q_y) + 4g \cos q_x \cos q_y$ with $g = J_2 = J_1$. Suppose that, by increasing the frustrating parameter g, the system has a continuous transition from a magnetically ordered phase to a dimerized one. In this latter, the lowest triplet excitation remains gapped in the therm odynam ic lim it and the ground state is fourfold degenerate, with four di erent m om enta q = (0;0), (0;), (;0), and (;). Again, the following arguments willalso hold for any other dim erpatterns, having ground states with momenta $q \in (0;0)$ and $q \in (;)$. By applying the Feynm an construction with q = (;) to the state with q = (0;) and by using the inequality (10), we obtain that

In the dimerized region, i.e., for $g > g_c$, the spectrum is gapped, in plying that S(;) is nite, and the constraint (11) does not give us any useful inform ation on the excitations. How ever, if the transition is continuous, the four-fold degeneracy will hold down to the critical point $g = g_c$, where S(;) diverges, because of the incipient m agnetic phase, stable for $g < g_c$. Indeed, at the critical




FIG.1: (Coloronline) C om parison on a 6 6 lattice between Lanczos and G FM C for the lowest energy gap. Upper panel: $^+$ (;0) (see text) [in unit of (K + J)], as a function of K =J. Lower panel: $_{\rm SP}$ (;0) (see text) [in unit of (K + J)], as a function of K =J. Inset: direct com parison of the dynam ical correlation function for the dimer operator calculated by G FM C approach and by Lanczos.

point the spin-spin correlations are expected to decay as L 1 . The actual value \mathcal{R} j⁽¹⁺⁾, leading to S(;) of can be found by considering the corresponding classicalm odel in three dim ensions. In the Heisenberg m odel with nearest-neighbor interactions, we have that 0, implying a rather strong divergence of the static structure factor at the critical point. How ever, this divergence can be much weaker, i.e., 0:5, in the case where no free topological singularities are allowed but only pairs of them are present.^{18,19} W e point out here that our conclusions remain valid as long as 1, the structure factor being logarithm ically divergent in the case of = 1.

Therefore, because the operator S_q used in the Feynman construction carries S = 1, we immediately arrive to the conclusion that Eq. (11) implies the existence of a branch of excitations, with S = 1 and q = (;0), that becomes gapless at $g = g_c$. A nalogously, by considering the ground state with momentum q = (;0), we obtain a branch of excitations with S = 1 and q = (0;). This outcome contrasts the common understanding of the low – energy properties of magnetic system swith O (3) symmetry, which contains only two branches of gapless excitations at q = (0; 0) and q = (; 0), while the triplet excitations at q = (0; 0) and q = (0;) are always gapped.²⁰




FIG.2: (Color online) The dimergap $_{SP}$ (;0) [in unit of (K + J)] obtained by GFMC as a function of the size N of the cluster for di erent values of K =J. The lines are linear ts of the points. Inset: the extrapolated value in the therm odynam ic lim it as a function of K =J.

Therefore, one is left with the following three possibilities: the stone is to have an O (3) critical point with more than two gapless modes, not described by standard theories of magnetic phase transitions. The second one is that the dimerized phase is separated from the magnetic phase by a st-order transition: in that case the spectrum can evolve discontinuously and the triplet states at q = (0;) and q = (0;) can remain gapped. The third possibility is that there is still a continuous transition but the non-magnetic phase does not break the translational invariance and, therefore, has no dimer order. Then, the dimerized phase could be eventually stabilized through a further (continuous) transition.

W e stress that a continuous transition between a magnetically ordered phase and a dimerized one is instead possible in models that explicitly break the translational invariance, like for instance the coupled ladder system,²¹ where due to the folding of the Brillouin zone q = (;0) [or q = (0;)] is equivalent to q = (0;0).

Now we would like to discuss what happens for system s with di erent kinds of interactions. In the case of multispin interactions, it is easy to prove that we can arrive to similar expressions and the only di erence is the prefactor, due to a di erent value of the double com m utator (7). A littlem ore carem ust be paid to a model with U (1) sym m etry. Here, the total spin S does not com m ute with the Ham iltonian, and only S^z is a good quantum number. Furtherm ore, the states with $S^{z} = 0$ can be also classied according the discrete particle-hole sym m etry (PH) S^z ! S^z. In the weakly frustrated lim it, without loss of generality, we can consider the ferrom agnetic X Y m odel, that has only one gapless branch at q = (0; 0). On a nite cluster, the ground state has $S^{z} = 0$ and can be taken to be even under the PH sym metry, i.e., with PH = +1. In this case, we can construct two di erent variational states for the low-energy excitations. The stone, with $S^{z} = 1$, is given by $j_{Q_{0}+q}i = S_{q}^{+}j_{Q_{0}}i$, S_{q}^{+} being the

Fourier transform of $S_{j}^{+} = S_{j}^{x} + iS_{j}^{y}$, and has

Instead, the second possibility, with $S^{z} = 0$ and PH = 1, is given by $j_{Q_{0}+q}i = S_{q}^{z}j_{Q_{0}}i$ and has

In the dimerized phase the ground state is four-fold degenerate with four di erent m om enta q = (0;0), (0;),(;0), and (;), all of them having S^z = 0 and PH = +1 [this is equivalent to have all singlets in the SU (2) case]. Then, in close relation with the SU (2) case, the Feynman construction (12) with q! (0;0) applied to the state with momentum q = (;0) implies the existence of a gapless branch of excitations at q = (;0)with $S^z \in 0$. Indeed, in this case F_q^+ is nite for jgj! 0 and the structure factor in the denom inator diverges at the critical point, as hS ${}_qS^+_qi$ / $1=q^1$. Hence, we arrive to the same conclusions as before: excluding the possibility of having more than one gapless branch in a model with 0 (2) symmetry, in contrast with sem iclassical approaches, 20 the transition must be either st order or second order to a non-dimerized phase. Finally, it should be noted that, under an additional assum ption, also Eq. (13) gives a strict bound to the spectrum . Indeed, F_q^z / q^2 for jqj! 0 and, whenever at the critical point $\overset{\neg}{h}S^{\,z}_{\,q}S^{\,z}_{q}i$ does not vanish too fast, i.e., $hS^{z}_{q}S^{z}_{q}i/q^{2}$ with > 0, also $^{z}(q)!$ 0 for jqj! 0.

III. NUMERICAL RESULTS

In this section, we present our num erical results for the H am iltonian (1), by using the G reen's function M onte C arlo (G FM C) technique with a nite and xed population of walkers.¹⁶ In order to m inim ize the statistical uctuations, we im plem ented the im portance sam pling, de ned by the variational wave function²²

where f i is the ferrom agnetic state with the magnetization along the x direction, i.e., f i = $_i(j"i_i + j\#i_i)$, P_z is the projector onto the subspace with $S^z = 0$, and J is a spin Jastrow factor

with the two-body potential $v_{i;j}$ that depends only upon the distance \Re_i R_j jand can be optimized by using the minimization technique described in Ref. 23.

Since the H am iltonian (1) does not su er from the sign problem, it is possible to sample the exact ground-state




FIG.3: (Color online) The spin-wave spectrum [in unit of (K + J)] obtained by GFMC by using the operator $O_q = S_q^z$. The linear sizes of the cluster are L = 16 and 18, and the lines are guides to the eye. The vector q is taken along the (1;0) direction. Upper inset: the behavior of the nite-size gap at the minimum momentum, i.e., $q_{min} = (2 = L;0)$ as a function of L for di erent values of K =J. Lower inset: the therm odynam ic limit of the gap at q = (0;0) as a function of K =J.

wave function $_{0}(x) = hxj_{0}i$ (being jki a generic spin con guration), or, with importance sampling, the positive quantity $_{0}(x) _{V}(x) = hxj_{0}ihxj_{V}i$. Moreover, it is possible to evaluate the imaginary time evolution of the following dynamical correlation function:

where O_q is a given operator with a denite momentum q. This technique has been already successfully used by one of us to compute the excitation spectrum of a quasione-dimensional magnetic system $.^{24}$ It is easy to show that, for large in aginary time, G (q;) behaves like:

where $_q = E_q E_0$ is the energy gap between the ground state and the state j_qi such that

Therefore, from the tofthe large behavior of the dynam ical correlation function, it is possible to extract the lowest gap with a given momentum q and the symmetry properties in posed by the condition (18).

W henever the operator O_q is diagonal in the spin conguration jki, like, for instance the case of S_q^z , the expression (16) can be easily calculated by using the standard forward walking technique.¹⁶ O n the other hand, for non-diagonal operators, i.e., for S_q^+ , a m ore involved calculation is needed, since the operator breaks the M arkov chain of the M onte C arlo simulation. In order to avoid this extra num ericale ort, we have calculated m ore e - ciently $^+$ (q) by sam pling the ground state w ith $S^z = 1$ and by calculating its excitation spectrum, for instance by using S_q^z . Then, $^+$ (q) can be found from :

where the term in the st bracket can be calculated by tting G (q;) and the last two terms are just the ground-state energies of the two sectors with $S^z = 0$ and $S^z = 1$, easily calculated by GFMC.

In order to verify the accuracy of GFMC for the evaluation of the gap, we can perform calculations on a 6 6 lattice, where the exact results are available by the Lanczos m ethod. In particular, we consider the dim er operator $O_q = O_q^{SP} = 1 = N^{-1} = e^{iqR_j} S_j^z S_{j+x}^z$ with q = (;0). In this case, the operator O_q does not change the PH quantum number and we have access to the lowest gap with the same PH of the ground state. In Fig. 1, we com pare, for di erent values of the ring-exchange coupling K =J, the exact energy gap at q = (;0) and even under PH with the one extracted from the large- behavior of G (q;), and denoted by SP (;0). Moreover, as a further check of the statistical approach, we can also compute exactly the dynam ical correlation function and make the comparison with the GFMC calculations (see the inset of Fig. 1). It should be stressed that, for our purpose, we are only interested in the lowest energy gap, and, therefore, we tonly the large-part of G (q;). This can be achieved by using only two or three exponents at most.²⁵ In the same gure, we also report the comparison for + (;0), extracted from the decomposition of Eq. (19): also in this case the agreem ent is excellent.

The lowest dimer gap $_{\rm SP}$ (;0) provides us the informations on the appearance of a dimerized phase with spin-Peierls order. In Fig. 2, we report the size-scaling calculations of $_{\rm SP}$ (;0) as a function of the inverse of the size N, for dimer values of the ring exchange. The dimer gap is clearly nite in the magnetically ordered phase, with a decreasing behavior by approaching the transition. The therm odynam ic limit indicates a vanishing value of $_{\rm SP}$ (;0) for K =J & 3:95, in close agreement with Ref. 11.

Let us now turn to the spin-wave operators S_q^+ and S_q^z , in order to apply the arguments developed in the previous section and assess the nature of the transition. First of all, it should be noticed that, in the X Y model, S_q^z acts on the ground state by creating a standard spin-wave excitation. This can be easily seen by considering the Holstein-Primako representation at the leading order in




FIG.4: (Color online) The gap + (;0) [in unit of (K + J)] calculated by GFMC as a function of the size N of the cluster for di erent values of K = J. The lines are linear ts of the points. Inset: the therm odynam ic value of the gap as a function of K = J.

A fter standard calculations, we arrive to the result that

where jDi is the spin-wave ground state and $\frac{y}{q}$ is the creation operator of the elementary excitation, defined by the Bogoliubov transformation. Therefore, the states of the gapless branch have non-zero overlap with the (normalized) states generated either by S_q^y or by S_q^z , allowing us to assess directly the spin-wave spectrum. As shown in Fig (3), for small values of the ring-exchange coupling, the excitation spectrum remains gapless for jgj! 0 and the opening of a gap, for K =J 3:95, signals the transition to the disordered phase. Moreover, in the ordered phase, the spectrum is linear for small momenta, i.e.,

 z (q) cjqj (see Fig. 3), the constant c de ning the spin-wave velocity. From our num erical results, it com es out that, as assumed in sem i-classical approaches, the spin velocity c is not strongly renorm alized by frustration and remains nite up to the transition.

By using the same spin-wave operators S_q^+ and S_q^z at q = (;0) and q = (0;), we can assess the nature of the transition between the ferrom agnet and the dimer state. In particular, according to Eq. (12), a continuous phase transition in plies a vanishing + (q) for q = (;0) and q = (0;). In Fig. (4), we report the results for the gap + (;0) for di erent ratios K =J and various sizes of the




FIG.5: (Color online) The gap z (;0) [in unit of (K + J)] calculated by GFMC as a function of the size N of the cluster for di erent values of K = J. The lines are linear ts of the points. Inset: the therm odynam ic value of the gap as a function of K = J.

cluster. From our results, it turns out rather clearly that

 $^+$ (;0) remains nite in the therm odynamic limit for all the values of the ring-exchange couplings, also very close to the transition point. Of course, we cannot nule out the existence of a very tiny region, near to the transition point, in which this gap would drop down to zero. A nother possibility form issing the vanishing behavior of the gap could be due to an anom alous size scaling, that changes its behavior beyond a characteristic length scale $L_{\rm c}$ much bigger than the values of L considered here. However, from our GFMC calculations, we do not have any sizable sign that could indicate the existence of gapless excitation at q = (;0) or q = (0;), and even at the transition point $K_{\rm c}=J$ 3:957 the extrapolated value of $^+$ (;0) remains clearly nite. Since a clear dimer order appears as soon as we enter the disordered region, 11 we

appears as soon as we enter the disordered region,¹¹ we can safely rule out the possibility to have a spin-liquid phase in between the ferrom agnetic and the dimerized phases. Therefore, our results on +(;0) strongly suggest that a rst-order transition is the more likely scenario in this O (2) model with ring-exchange interactions. Similarly, also the gap z (q) at q = (;0) and q = (0;) does not show any evidence of softening and remains - nite at the transition, see Fig. 5.

IV. CONCLUSIONS

In conclusion, we investigated the excitation spectrum of a spin m odel close to the transition from a magnetic phase to a dimerized one, which is particularly important in view of the theoretical predictions of Senthil and coworkers. In particular, we considered an X Y m odel in presence of a frustrating ring-exchange interaction, a m odel that certainly leads to a magnetic-dimer transition, as recently shown by Sandvik and collaborators.^{11,13}

The central part of our work is the derivation of a gen-

eral constraint for the excitation spectrum for a broad class of short-range spin Ham iltonians: whenever the transition is second-order a new branch of gapless excitations must exists, besides the ones expected from standard sem i-classical approaches. In particular, on the square lattice with a typical four-fold dim er ground state, these modes are spin-wave-like excitations at momenta q = (0;) and q = (;0). On the contrary, by using a num erically exact technique, we did not nd any evidence of these gapless modes. Therefore, our results rule out both conventional and unconventional continuous transition, im plying that a rst-order transition represents the most likely scenario, in agreem ent with recent

calculations.¹⁵ Although we cannot exclude anom alous

nite-size e ects, that should be particularly important for correlation functions (see R ef. 11), we expect that the excitation spectrum does not su er from these problem s, depending only on total energy di erences.
