## On the conservation of spin currents in spin-orbit coupled system s

> A pplying the G ordon-decom position-like technique, the convective spin current (C SC ) is extracted from the total angular-momentum current. The C SC describes the transport properties of the electron spin and is conserved in the relativistic quantum mechanics approach where the spinorbit coupling has been intrinsically taken into account. A mestingly, in the presence of external electrom agnetic eld, the component of the convective spin along the eld remain still conserved. This conserved C SC is also derived for the rst time in the nonrelativistic limit using the Foldy-W outhuysen transform ation.

Spintronics is a fast developing eld in condensed m atter physics, where the research on the spin transport and manipulation in solid state systems appears to be a central subject.<sup>1,2</sup> Typically, the spin transport is strongly a ected by a coupling of spin and orbital degrees of freedom in semiconductors. Of particular interest is the spin Hall e ect in a spin-orbit coupled system. The spin Hall e ect means that a transverse spin current can be induced by applying an electric eld. Earlier studies focused on the extrinsic e ects due to the spin dependent scattering.<sup>3,4,5</sup> Recently, an intrinsic spin Hall e ect (ISHE), which is resulted from the spin-orbit coupled bands and may exist in the clean systems, has attracted considerable attentions.<sup>6,7,8,9,10,11,12,13,14,15,16,17,18,19,20,21,22,23,24,25,26,27,2</sup>

On the theoretical side, the ISHE has been predicted in the p-doped sem iconductors described by the Luttingerlike m odel<sup>6</sup> and in the two-dimensional electron gas described by the Rashba-like m odel<sup>7</sup>. The ISHE in the two-dimensional hole gas<sup>20</sup> and the impurity scattering e ect on the ISHE <sup>15,16,17,18,19,20,21</sup> have also been analyzed. On the experimental side, the spin accumulation related to the spin Hall e ect has been observed in the n-type bulk sem iconductor<sup>30</sup> and in the two-dimensional hole gas.<sup>31</sup>

The spin current is an important issue in discussing the spin Halle ect and other spin transport phenom ena. In spite of the extensive investigation on the ISHE, there is still a fundam ental problem that what is the proper de nition of the spin current operator in the spin-orbit coupled system. The conventional de nition of the spin current operator is the anticom m utator of the P auli spin matrix and the velocity of the electron.<sup>6,7</sup> The electron spin is not a conserved quantity in the spin-orbit coupled system . As a result, there is a source term , namely spin torque, in the continuity-like equation related to the conventional spin current.<sup>25,26,27</sup> The spin torque represents the spin precession caused by the external eld and the spin-orbit coupling. The presence of the nonzero source term in the continuity-like equation makes the conventional spin current an ill-de ned quantity to describe the transport of spin. On the other hand, the non-conserved part of the conventional spin current has

very fast dynam ics and can not contribute to the low frequency response.<sup>24</sup> Therefore, it is essential to de ne a conserved e ective spin current from a rst principle for studying the spin transport properties in the spin-orbit coupled system.

There are already some e orts focusing on the understanding of the nonconservation of the conventional spin current.<sup>22,23,24,25,26,27,28,29</sup> In the p-doped sem iconductor described by the Luttinger-like model, M urakam i et al<sup>24</sup> have proposed a conserved e ective spin current of the spin 3=2 hole by modifying both the spin density and the spin current operator. By rewriting the spin torque as the divergence of a torque dipole density, another approach to the conserved e ective spin current was also prophosed<sup>23,27</sup> where the spin density operator remains unchanged and only the spin current operator is modi-

ed. In this paper, motivated by the fact that the spinorbit coupling in the sem iconductors com es from the relativistic correction of the electron motion, we develop a conserved e ective spin current in the relativistic quantum mechanics approach where the spin-orbit coupling has been intrinsically taken into account. For a relativistic electron, the spin is not conserved, but the total angular-momentum (TAM) consisting of both spin and orbit angular-m om entum is a conserved quantity in the absence of external elds. Therefore, there is the conserved TAM current according to the Noether's theorem . Under the Gordon-decom position-like scheme, the TAM current can be divided into two parts: the convective TAM current and the internal one. It is found that the spin part of the convective TAM current, namely the convective spin current (CSC) satis es the continuity equation. The CSC is not only conserved but also closely related to the spin ux of the electron moving in the spatial space and therefore is an appropriate candidate for the spin current operator in discussing the spin transport properties. In the presence of external electrom agnetic eld, neither the TAM nor the CSC is conserved in a general case because of the mutual exchange of the angular-m om entum between the electron and the external eld. How ever, more intriguingly, we nd that if both the electric eld and the magnetic eld are along the sam e direction, namely the z-direction, the z-components of the CSC and the TAM still remain conserved. Remarkably, this is just the case in the Rashba-like spin-orbit coupled system. As a result, the CSC is also likely robust subject to the external eld in some sense. Finally, by using the Foldy-W outhuysen transform ation, the conserved CSC is derived in the nonrelativistic (NR) limit, which has a potential application in spintronics.

W e start with the brief review on the G ordon decom position of the probability current of the relativistic electron. For the electron of the mass m traveling in the three-dimensional free space, the four-component wave function of the electron satis es the D irac equation

where the momentum  $p = \ln r$ , the matrices  $= \begin{pmatrix} 0 \\ 0 \end{pmatrix}, = \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ , is the Pauli spin matrix and 1 is the 2 2 unity matrix. The invariance of the D irac Eq. (1) under the U (1) gauge transform ation results in the continuity equation for the probability current

where the probability density = y and the current  $j = c^{y}$ . The Dirac Eq. (1) can be rewritten as

Substituting Eq. (3) into the denitions of and j, one nds that the density and current can be divided into the convective and internal parts, known as the G ordon decom position,<sup>32,33</sup> in the form

where

and the matrix =  $\binom{0}{0}$  as well as = y. The internal parts of the density and current are closely related to the internal state of the electron. For the electron of charge q, qM is essentially the magnetic moment density of the electron arising from its spin and qP is the electric polarization belonging to the spin. The convective parts of the density and current are determined by the rate of change of in space and time and closely related

to the motion of the electron in the spatial space. Notice that the convective and internal parts of the density are separately conserved. For the NR lim it, i is zero up to the zeroth order in (1=c),  $j_i$  is only a curl term and has nothing to do with the electron accumulation, and the convective parts of the current and the density are reduced to the usual form in the NR quantum mechanics,

with the two-component wave function of the electron.

Next, we turn to the spin current. A coording to the Noether's theorem, the invariance of the D irac Eq. (1) under the Lorentz rotation leads to the continuity equation for the TAM current<sup>34</sup>

where the density of the -component of the TAM is

where the component of the TAM operator J = ((h=2) + r p) with the position operator r and the index = x;y;z. The TAM contains two parts, the spin part (h=2) and the orbit part r p. For a relativistic electron, unlike the TAM, neither the spin density nor the orbit angular-m om entum density is conserved alone. Similar to the probability current, the TAM current can also be divided into the convective and internal parts<sup>35</sup>

The convective and internal parts of the TAM current have the same structure as those of the probability current. For the NR lim it,  $_{\rm i}$  is zero up to the zeroth order in (l=c), j<sub>i</sub> is only a curl term and has nothing to do with the accumulation of the TAM. Let's consider the spin

part of the convective TAM current, namely the CSC, with the density for the spin- component

The CSC is determined by the rate of change of in space and time and ought to be closely related to the spin ux of the electron moving in the spatial space. Moreover, noting that the solution of the D irac Eq. (1) is also a solution of the K lein-G ordon equation, one can easily nd that the CSC satis as the continuity equation

despite that the bare spin is not a conserved quantity for the relativistic electron. Therefore, we argue that the CSC is just the correct e ective spin current for discussing the spin transport properties of the relativistic electron.

The results we present above are valid for the electrons m oving in the free space. The in uence of the external electrom agnetic eld can be taken into account by m aking the transform ation

with the charge of the electron q, the scalar potential V and the vector potential A. The density and current of the convective spin in the external electrom agnetic eld are written as

In the external electrom agnetic eld, neither the TAM northe CSC is conserved generally because of the mutual exchange of the angularm om entum between the electron and the external eld. The continuity-like equation of the CSC reads

where the Bohr Magneton  $_{\rm B}$  = qh=2m c, the magnetic eld B = r A, and the electric eld E =

(@A = @t) r V. A lthough the CSC is not conserved, the source and drain of the CSC in Eq. (21) are only the external elds, while those of the bare spin include the contributions from both the external elds and the orbit angular-m om entum. Therefore, the CSC is still m ore suitable than the bare spin current for discussing the spin transport of the relativistic electron in the external elds. For a particular case that both the electric and m agnetic

elds are along the sam e direction, nam ely the z direction, one can nd from Eq. (21) that the z-component of the convective spin is still conserved. This particular case is relevant to the two-dimensional electron gas with the Rashba interaction where the electron is free in the x-y plane and the con nem ent potential is only along the z direction. The z-component of the spin is also of the m ost interest in the Rashba system. In the following text we are restricted to this particular case, where the CSC is still conserved and can be served as the proper quantity for discussing the spin transport of the relativistic electron.

In order to apply the idea of the CSC into the spintronics, the NR lim it of the CSC operator is needed. The H am iltonian of the relativistic electron in the external electrom agnetic eld reads

TheNR lim it of the H am iltonian (22) can be made by the Foldy-W outhuysen transform ation.<sup>34,36</sup> Up to the  $(1=c^2)$  order, the NR H am iltonian of the electron is given as

and the two-component wave function , i.e., the large component of the four-component spinor in the Foldy-W outhuysen representation corresponding the positive energy solutions, satis es the Schrodinger equation in (@ =@t) =  $H_{\rm NR}$ . The Schrodinger equation and the H am iltonian (23) are the starting point for discussing the motion of the election in the NR quantum mechanics including some relativistic corrections up to the ( $1=c^2$ ) order. We recall the physical meanings of each term in Eq. (23). The rst three terms are the NR kinetic energy, the potential energy, and the Zeem an energy arising from the electron spin, respectively. The fourth and fit terms are the so-called D arw in term and the spin-orbit interaction, respectively. All other terms are of even higher orders.

W ith the help of the Ham iltonian (22) and the D irac equation, the convective spin density in Eq. (19) can be rewritten as  $c^{s-z} = y c^{s-z} + hc$ : =2, with the operator

O ne can easily verify that  $c^{s-z}$  is an Herm itian operator and commutes with the Ham iltonian (22) and therefore is a conserved quantity. The di erence between the

convective spin and the bare spin is the second term in Eq. (24) which is a higher order relativistic correction term coupling the large and small components of the four-component spinor . The NR lim it of the convective spin density operator up to the  $(1=c^2)$  order, the same order as that of the H am iltonian, is obtained by the same unitary transform ations applied to the H am iltonian (22) in the Foldy-W outhuysen scheme. A fler the Foldy-W outhuysen transform ation, the convective spin density is also reduced to an even operator as the H am iltonian does, which does not couple the large and small com ponents of . The NR convective spin density operator acting on the two-component spinor is obtained as

with the operator  $\hat{C} = \frac{2}{x} + \frac{2}{y} = \frac{2}{z} (x + y + y) = z$ . With the help of the operator (25) the convective spin density is written as  $\frac{S^2}{C,NR} = \frac{y + S^2}{C,NR} + hc$ : =2. Due to the unitarity of the transform ation, the NR convective spin density operator Eq. (25) commutes with the Ham iltonian (23) and remains as the conserved quantity up to the  $(1=c^2)$  order. The di erence between the convective spin and the bare spin is the second term in Eq. (25) which is of the order of  $(1=c^2)$  and is very small. How - ever, the spin-orbit interaction is also originated from the relativistic correction of the electron motion up to the  $(1=c^2)$  order. Therefore, the second term in Eq. (25) can not be neglected when discussing the spin current in the spin-orbit coupled system .

A lthough there are m any term s in the NR H am iltonian (23), only the spin-orbit term is of particular interest on the topic of the spin H all e ect. Therefore, we rem ove the other relativistic corrections and rew rite the e ective H am iltonian in the form

It should also be noted that, in going from Eq. (23) to Eq. (26), it has been assumed that the electric eld is static, i.e., E = r V, and the external elds are along the z-direction. It can be easily veri ed that  ${}^{S^{-}Z}_{C,N,R}$  commutes with H<sub>SO</sub> and therefore served as a conserved quantity to calculate the spin ux in the spin-orbit coupled system. W ith the help of Eqs. (25), (26), and the Schrödinger equation in (@ =@t) = H<sub>SO</sub>, the continuity equation for the CSC in the NR limit is obtained in the form

Eqs. (25), (27), and (28) constitute the main results of this paper. Comparing to the conventional spin current,<sup>7</sup> the CSC (28) has an additional correction term

which comes from the second term in Eq. (25). One nds that both the spin density and current have been modiled to construct the conserved CSC. The modication, the second term in Eq. (25) and Eq. (29), is a kind of the relativistic correction resulting from the coupling between the large and small components of the four-component spinor . Those corrections are of the  $(1=c^2)$  order and are often small enough to be neglected. However, the spin-orbit interaction is also a relativistic correction of the  $(1=c^2)$  order. Therefore, the CSC ought to be used instead of the bare spin current in the spinorbit coupled system.

A lthough the H am iltonian (26) boks similar to the Rashba model<sup>37,38</sup> in the sem iconductor heterostructure, a realistic situation is quite complicated. The Rashba coe cient may not be directly determined by the external electric eld, but the asymmetry in the band structure parameters of the heterostructure like the electron mass.<sup>2,39</sup> The discussion in this paper is restricted to the case that the electron moves in a uniform space. Therefore, it is interesting and desirable to apply the above idea of the conserved CSC to the sem iconductor heterostructure tures or quantum wires in future, though is highly non-trivial.

In summary, the CSC has been extracted from the TAM current by the Gordon-like decomposition in the relativistic quantum mechanics approach. The NR limit of the CSC is also derived. The CSC describes the transport properties of the electron spin and is conserved in the spin-orbit coupled system. It is also shown that the CSC remains robust in the external electrom agnetic eld if both the electric eld and the magnetic eld are along the same direction. As a result, the CSC is a good substitution for the bare spin current in studying the spin transport phenom ena in spin-orbit coupled system s.
