Trapped ferm ions with density imbalance in the BEC lim it

We analyze the e ects of imbalancing the populations of two-component trapped ferm ions, in the BEC limit of the attractive interaction between dierent ferm ions. Starting from the gap equation with two ferm ionic chemical potentials, we derive a set of coupled equations that describe composite bosons and excess ferm ions. We include in these equations the processes leading to the correct dimeralment and dimeraferm ion scattering lengths. The coupled equations are then solved in the Thomas Ferm iapproximation to obtain the density process for composite bosons and excess ferm ions, which are relevant to the recent experiments with trapped ferm ionic atoms.

Lately there has been mounting interest in trapped atom ic ferm ion super uids, both experimentally and theoretically. These systems allows one to explore the BCS-BEC crossoverwith the use of Fano-Feshbach resonances. Interesting many-body issues for fermionic super uids have been addressed in this context, aiming also at making connections with high-temperature superconductors and nuclear and quark matters. Until recently, only the case of two fermionic species with equal populations was experimentally explored.

Two new experimental studies of ferm ionic super uidity with trapped atoms having imbalanced populations [1, 2] have raised novel interest in these systems. Density profess of the two ferm ionic species [1, 2] as well as vortices [1] have been detected. A quantum phase transition to the normal state on the weak-coupling side of the BCS-BEC crossover [1] as well as a phase separation in the crossover region [1, 2], both driven by density imbalance, have been identified.

The many-body problem becomes reacher when the ferm ionic populations are imbalanced, since this additional degree of freedom gives rise to new phenomena. The elects of density in balance on ferm ionic super uids have been studied theoretically mostly within meaneld and on the weak-coupling (BCS) side of the crossover, both for the homogeneous [3] and trapped case [4]. Only recently these calculations have been extended to cover the BCS-BEC crossover [5], but without considering the elects of the trap which are essential to account for the experimental results with density in balance [1, 2].

The e ects of the trap are especially in portant to produce a phase separation between the density pro less of the two ferm ionic species, which may otherwise remain at the verge of an instability for a homogeneous system. In this respect, consideration of the strong-coupling (BEC) side of the crossover appears relevant, since phase separation is more robust in this limit. On the weak-coupling side, on the other hand, density in balance acts to quickly destroy the super uid phase.] In addition, on the BEC side theoretical studies can rely on more accurate treatments beyond mean eld, by exploiting the diluteness

condition of the system . From previous experience on the BCS-BEC crossover, one expects the results obtained on the BEC side to be qualitatively similar to those occurring near unitarity.

A coordingly, in this paper we analyze the BEC side of the crossover where trapped ferm ions with imbalanced populations get rearranged into a system of composite bosons (dim ers) plus a num ber of excess (unpaired) ferm ions. We consider specically the limit of low temperature, whereby all dimers are condensed, and derive a set of coupled equations describing the dim ers and the excess ferm ions, which are interacting through dimer-dimer and dim er-ferm ion scattering processes. To the extent that the system is dilute, we can consider these processes exhaustively. Due to these interactions, the mutual effects between dim ers and excess ferm ions need to be dealt with self-consistently in the equations. This results in a nontrivial evolution of their density pro les as the degree of density imbalance increases. We determ in a numerically these density pro les within a local approximation and nd that dim ers and excess ferm ions tend to reside in di erent spatial regions of the trap. We also show how from these pro les one can, in reverse, extract the ratio $a_{BF} = a_F$ of the dim er-ferm ion to the ferm ion-ferm ion scattering lengths.

We rst consider the derivation of the above coupled equations within mean eld. When the populations of the two ferm ionic species (labeled by " and #) are equal, it has already been shown [6] that the Bogoliubov-de Gennes (BdG) equations for trapped ferm ions can be mapped in the BEC limit onto the Gross-Pitaevskii equation for composite bosons, the only remnant of the original ferm ionic nature residing in the dimer-dimer scattering length entering that equation. In the case of interest here of imbalanced populations, this mapping has to be reconsidered since composite bosons and excess ferm ions coexist and mutually interact. In the following, we shall recall schematically the derivation of Ref.[6], and indicate where and how it needs to be modiled to account for population imbalance.

The presence of two ferm ionic species with popula-

tions N " and N " requires us to introduce two chemical potentials " and ". (For de niteness, we assume N " N ".) In analogy to Ref.[6], we consider the non-interacting G reen's functions which satisfy the equation [i!s H (r)] $G_0(r;r^0;!sj) = (r r^0)$, being subject to the trap potential V (r) entering the single-particle Ham iltonian H (r) = $r^2 = (2m) + V(r)$. Here, = (";#), m is the ferm ion mass, and !s = (2s+1) = (s integer) is a ferm ionic M atsubara frequency (being the inverse temperature). With these noninteracting G reen's functions we form the matrix:

The corresponding interacting single-particle Green's functions within mean eld are obtained by solving the integral equation:

contains the local gap (r). Solution of the integral equation (1) is equivalent to the solution of the BdG equations in the trap in the presence of density in balance.

The elements (1;1) and (2;2) of the matrix (1) determine the local densities, while the element (2;1) determines the local gap. To obtain the coupled equations of interest we expand them up to order 2 and 3 , respectively, in analogy to what was done in Ref.[6] in the absence of density imbalance. The gap equation reads:

where is a positive in nitesimal and y < 0 is the strength of the attractive contact potential between ferm ions of opposite spins. As in Ref.[6], the coe cients a_0 , b_0 , and c_0 of Eq.(2) are expressed in terms of the noninteracting G reen's functions G_0 (), here with chemical potentials appropriate to imbalanced populations. While b_0 (r) = m a_F = (16) retains the same value as for equal populations, a_0 and c_0 are a ected by density inbalance in a relevant way. With the local ansatz for G_0 () introduced in Ref.[6] in terms of the noninteracting G reen's functions of the associated hom ogeneous problem, we obtain at low temperature:

Equation (3) can be cast in the meaningful form

where we have identi ed the dimer-ferm ion scattering length $a_{B\,F}$ which takes the Born value $8a_F=3$ at the mean-eld level. We obtain in addition:

The gap equation (2) eventually reduces to the followpq equation for the condensate wave function (r) = $m^2a_F = (8)$ (r):

where m $_{\rm B}=2m$ is the dimer mass and the dimer-dimer scattering length $a_{\rm B}$ takes the Born value $2a_{\rm F}$ at the mean-eld level. Note how the last contribution in Eq.(6) combines with the term proportional to $n_{\rm f}$ in Eq.(5), to yield in Eq.(7) the density of excess fermions:

By this mechanism, Eq.(7) contains the e ect of the ferm ionic distribution n(r) on the bosonic one, an e ect which is reciprocated in Eq.(8) by the bosonic distribution $j(r)^2$ on the ferm ionic one.

The nal equation results from considering the total density $n(r) = n_*(r) + n_*(r)$ where:




FIG. 1: Tadpole diagram s for composite bosons representing the gap equation in the BEC limit: Mean-eld contributions (a); Contributions including the dimer-ferm ion (b) and dimerdimer (c) scattering processed beyond the Born approximation. Full line: ferm ionic propagator of given spin; broken line: ferm ionic interaction v_0 .

E quations (7) and (9), together with the de nition (8), are the desired closed set of equations which determ ine (r) and n (r) in the B $\frac{R}{R}$ C \lim it, for given total number of ferm ions $\frac{R}{N}$ " + N $_{\#}$ = drn (r) and density in balance N " N $_{\#}$ = dr n (r).

The validity of these equations can be extended by improving on the values of the scattering lengths $a_{\rm B\,F}$ and $a_{\rm B}$. At the mean—eld level so far considered, these values correspond to the Bom approximation, yielding $a_{\rm B\,F}=8a_{\rm F}=3$ and $a_{\rm B}=2a_{\rm F}$. The exact value $1.18a_{\rm F}$ of $a_{\rm B\,F}$ has been known for some time [7], while the exact value $0.6a_{\rm F}$ of $a_{\rm B\,F}$ has been obtained by diagram matic methods in the limit of vanishing density, for $a_{\rm B\,F}$ in Ref.[9] and for $a_{\rm B\,B}$ in Ref.[10]. To improve on the derivation of Eqs.(7) and (9), so as to include the exact values of $a_{\rm B\,F}$ and $a_{\rm B\,F}$, we thus need to identify additional fermionic diagrams beyond mean—eld, which contain the correct diagram—matic sequences for $a_{\rm B\,F}$ and $a_{\rm B\,G}$ as sub-units. This can be achieved as follows.

In the BEC limit, the gap equation can be inter-

preted as the condition of vanishing \tadpole" insertions for composite bosons, with a natural extension of what is done for point-like bosons [11]. Within mean the diagram s representing this condition are depicted in Fig.1(a). Here, a composite-boson propagator with zero four-momentum can be inserted from the left, while the corresponds to a condensate line. We have already shown that these diagrams contain the dimer-ferm ion and dimer-dimer scattering processes within the Bom approximation. Additional tadpole diagrams, whose effect is to modify the values of a_{BF} and a_{B} in Eq.(7), are depicted in Figs.1 (b) and 1 (c), in the order. These diagram s exclude the Born contributions already included in the mean-eld diagram sof Fig.1 (a). A comment is in order on how to factor out from the diagram sofFig.1 (b) the product a_{BF} times n that enters Eq.(7). From the structure of these diagrams one concludes that the integration over the wave vector P is bounded within the Ferm isphere with radius $\frac{1}{2m}$, while the remaining , extend outintegrations over the wave vectors q, q^0 , side this Ferm isphere. A coordingly, one may neglect the P-dependence everywhere in the diagram s of Fig.1 (b), except in the ferm ion propagator labelled by P and corresponding to a spin-" ferm ion. The density of excess ferm ions results in this way from the P-integration [12], while the remaining parts of the diagram syield the exact \dim er-ferm ion scattering matrix $T_{3}^{\,{}^{\circ}}\left(0\right)$, which excludes the Born contribution resulting from mean eld.

A sim ilar analysis can be carried out for the density equation (9), where only the value of the dim er-ferm ion scattering length $a_{\rm BF}$ needs to be corrected beyond meaneld [cf. Eq.(8)]. In this case the relevant diagrams are similar to those of Fig.1 (b), but with an additional condensate () line in the place of the incoming composite-boson propagator with zero four-momentum and with a doubling of the spin-" ferm ion propagator with four-momentum P. This doubling provides the derivative with respect to " in Eq.(8), while the remaining parts of the diagram syield again T_3° (0).

We thus solve the coupled equations (7) and (9) with the exact values of $a_{\rm B\,F}$ and $a_{\rm B}$. To make contact with the recent experimental ndings [1, 2], we determ ine the density proles n(r) and $n_{\rm B}(r)=j(r)^2$ by solving these equations in the Thomas-Fermi approximation for a spherical trap, as functions of the asymmetry parameter = $(N_{\rm B} N_{\rm B}) = (N_{\rm B} + N_{\rm B})$ (with 0 1).




FIG. 2: Radial density pro les $\,n\,(r)\,$ (full lines) and $\,n_0\,(r)\,$ (broken lines) vs r= jrjfor ($\!k_F\,a_F\!\,)^{-1}=3$ and $\,=0.2$ (upper panel), $\,=0.5\,$ (m iddle panel), $\,=0.8\,$ (lower panel) [r is in units of R $_{\rm TF}$ and densities are in units of (N $_{\rm T}+$ N $_{\rm F})=R^{\rm T}_{\rm TF}$]. The insets show the results for ($\!k_F\,a_F\!\,)^{-1}=1$ at the same values of . Here, R $_{\rm TF}$ and k_F are the TF radius and Ferm i wave vector for equal populations.

In Fig 2 we report the radial density prolles in (r) and n_0 (r) vs the distance r= jrj from the center of the trap, for three characteristic values of and for the coupling ($k_F \, a_F$) $^1=3$ on the BEC side of the crossover. The spatial separation between the condensed composite bosons and the excess fermions is evident from these plots. For the coupling here considered, this phase separation occurs for all values of , because in (r) tends to set outside the region occupied by n_0 (r). Note that, for each value of , the maximum of n (r) occurs where n_0 (r) vanishes.




FIG. 3: Column density pro les n() (full lines) and n₀() (broken lines) vs for $(k_F\,a_F)^{-1}=3$ and =0.2 (upper panel), =0.5 (m iddle panel), =0.8 (lower panel) [is in units of R_{TF} and densities are in units of $(N_{\parallel}+N_{\parallel})=R_{\perp F}^2$]. The insets show the results for $(k_F\,a_F)^{-1}=1$ at the same values of . Here, R_{TF} and k_F are the TF radius and Ferm i wave vector for equal populations.

Note also the progressive size shrinking of n_0 (r) for increasing , with a simultaneous penetration of n (r) toward the center of the trap. The insets show the results for the sm aller coupling $(k_F a_F)^{1} = 1$. The phase separation between the two species appears sharper in this case, corresponding to enhanced e ects of the dim er-ferm ion repulsion. For the column density pro les reported in Fig.3 (obtained from the above radial pro lesby integrating over, say, the z axis) the phase separation appears less pronounced even for $(k_F a_F)^{-1} = 1$, since the corresponding distribution dz n (;z) leaks toward = 0 where it acquires a nite value. In particular, for the coupling $(k_F a_F)^1 = 1$ near the boundary of the BEC region our column density pro les are similar to those reported in Fig 2 of Ref. [2]. To enhance the visibility of phase separation, it would therefore be preferable to consider radial rather than column density proles.

Our calculation does not reveal evidence for a critical value $_{\text{C}}$ below which the phase separation does not occur. This somewhat contrasts with the experimental claim made in Ref.[2], where at unitarity $_{\text{C}}$ was esti-

m ated to be about 0:10. This dierence may either be due to the limited experimental resolution when revealing small excess densities, or possibly to the vanishing of $_{\rm c}$ when the BEC region (considered in our calculation) is approached.




FIG. 4: Critical radius R $_{\text{c}}$ of the condensate density vs the asymmetry parameter (normalized to the value R $_{\text{c}}$ (0) at = 0) for the coupling values ($k_{\text{F}} \, a_{\text{F}}$) 1 = (1;2;3) from bottom to top. The inset shows the ratio between the column density of excess fermions at the center of the trap and its maximum value at R $_{\text{c}}$ vs $a_{\text{BF}} = a_{\text{F}}$, for = 0.5 and the coupling values ($k_{\text{F}} \, a_{\text{F}}$) 1 = (2;3;4) from bottom to top.

In Fig.4 the critical radius R $_{\rm c}$ of the condensate density is plotted vs for di erent couplings, showing specifically how the condensate density shrinks for varying and coupling. This quantity should have direct experim entalaccess, because it identi es also the position of the maximum of the density of excess ferm ions. This maximum value can be compared with the value of the excess density at the center of the trap, to determ ine how their depends on the dim er-ferm ion scattering length $a_{B\,F}$ (assum ing that the value of a_{B} is independently determ ined). Column density pro les are found to have a more marked dependence on a_{BF} than radial density pro les. A coordingly, in the inset of Fig. 4 we report the corresponding ratio vs a_{BF} for = 0.5 and di erent couplings. The ratherm arked dependence on $a_{B\,F}$ shown by this quantity should make it possible to extract from

the experim ental data the expected value 1:18 of $a_{\rm B\,F}$ = $a_{\rm F}$, using our plots for calibration .

We mention, nally, that, to compare with Fig 2D of Ref.[2], we have also calculated the ratio for = 0.57 and various couplings down to $(k_F\,a_F)^{-1}=1$, and extrapolated eventually the results toward the unitarity limit, obtaining for this ratio about 0.5 in agreement with the experimental value.
