## Enhancem ent of electron spin coherence by optical preparation of nuclear spins

We study a large ensemble of nuclear spins interacting with a single electron spin in a quantum dot under optical excitation and photon detection. When a pair of applied laser elds satisfy two-photon resonance between the two ground electronic spin states, detection of light scattering from the intermediate exciton state acts as a weak quantum measurement of the electron agnetic (O verhauser) eld due to the nuclear spins. If the spin were driven into a coherent population trapping state where no light scattering takes place, then the nuclear state would be projected into an eigenstate of the O verhauser eld operator and electron decoherence due to nuclear spins would be suppressed: we show that this lim it can be approached by adapting the laser frequencies when a photon is detected. We use a Lindblad equation to describe the time evolution of the driven system under photon emission and detection. Numerically, we nd an increase of the electron coherence time from 5 ns to 500 ns after a preparation time of 10 m icroseconds.

Introduction. Single electron spins localized in sm all arti cial structures, such as sem iconductor quantum dots (Q D s), have become available and to a large extent controllable [1, 2, 3, 4]. Of particular interest is the phase coherence of such electron spins as single quantum objects, both from a fundam ental physics point of view and because of their potential use as quantum bits (qubits) for quantum information processing [6, 7].

A number of physical mechanisms that lead to the gradual reduction of the quantum phase coherence (decoherence) of the electron spin have been analyzed [8]. It has been established experim entally and theoretically that for an electron in a G aA s Q D, the predom inant decoherence mechanism is the hyper ne coupling to the nuclear spins in the host m aterial [9, 10, 11, 12, 13, 14]. For an unpolarized ensemble of N nuclei and an e ective hyper ne interaction energy A, the dephasing time n in the presence of a weak magnetic eld is  $T_2$ 1= N=A where is the width of the distribution of nuclear eld values  $h_z$  parallel to the eld. In a typical GaAs QD 90 eV or  $A = g_B = 3.5 T$  [15], the num ber with A of G a and A s nuclei (spin I = 3=2) is N 10and 5 5ns; this value is supported by the experimental  $T_2$ evidence [4, 5]. The T<sub>2</sub> decay originates from nuclear ensemble averaging and can be prolonged by narrowing the nuclear spin distribution [13]. A nother strategy is to polarize the nuclear spins [9], but this requires a polarization close to 100% which is currently not available [13]. Two schemes have been proposed to achieve a narrowing of the nuclear spin distribution, based on electron transport [16] and gate-controlled electronic Rabi oscillations [17].

Here, we analyze an optical scheme for nuclear spin preparation that makes use of spin- ip two-photon (Raman) resonance in a driven three-level system (TLS), in analogy to electrom agnetically induced transparency (EIT) in atom ic system s [18]. The low est electronic states in a QD formed in a III-V sem iconductor (e.g., GaAs)




FIG.1: Three-level system . State 1 (2) is a spin-up (down) conduction-band (E<sub>C</sub>) electron, with splitting g  $_{\rm B}$  B<sub>tot</sub> + h<sub>z</sub> where h<sub>z</sub> is the z-component of the nuclear (O verhauser) eld uctuations. State 3 is a trion with J<sub>z<sup>0</sup></sub> = 3=2. Two laser elds with frequencies ! p and ! c are applied near the 13 and 23 resonances with detunings 1;2. For + circularly polarized excitation (along z<sup>0</sup>), both transitions are allowed for

that are optically active under  $_+$  circularly polarized excitation are a Zeem an-split single electron in the localized conduction band (E<sub>C</sub>) ground state and the negatively charged exciton (trion) K i, i.e., two electrons (spin up and down) plus one valence band heavy hole (hh) with angular momentum  $J_{z^0} = +3=2$  (Fig. 1). The

J = 3=2 sector in the valence band is split into Ih and hh states along the quantization axis z<sup>0</sup> determ ined by the direction of strong QD con nem ent. Here, we assume excitation from the hh  $(J_{z^0} = 3=2)$  subband only. The quantization axis z in E<sub>C</sub> is parallel to the totalm agnetic eld B <sub>tot</sub>, and we assume that the axes z and  $z^0$  enclose an angle > 0. The spin up and down states in  $E_{C}$  are then j"i  $j''_{i} = \cos() j''_{i} + \sin() j''_{i}$  and  $j''_{i}$ ₩  $i_z = \cos()j\#i_z \sin()j\#i_z$ . From now on, we drop the index z. Two circularly polarized (+) continuouswave lasers at the frequencies  $!_p = !_X !_{"}$ 1 and 2 stimulate the transitions between j'i  $!_{c} = !_{X} !_{\#}$ and X i and between #i and X i, while the trion with  $J_{z^0} = 3=2$  is not excited.

The mechanism leading to a narrowing of the nuclear eld distribution works as follows. The population of the excited state K i, and thus the probability of photon emission (scattering) is only non-zero away from the twophoton resonance = 0 where = 1 2. In the presence of the nuclear spins this resonance moves to =  $h_z$  where  $h_z$  is the deviation of the nuclear eld (along z) from its mean  $hh_z$  i. The absence of photon emission during a waiting time t constitutes a weak measurement of the quantum operator  $h_z$ . In the limit t ! 1, it becomes a strong measurement, projecting the nuclear state onto j  $h_z = 0$  i (width = 0), thus eliminating electron decoherence due to the uctuating eld  $h_z$ .

M odel. The H am iltonian for the TLS coupled to nuclei,

and can be neglected in the RW A [19], leading to a blockdiagonal H am iltonian H = diag (H<sub>1</sub>;H<sub>2</sub>;:::;H<sub>K</sub>), with

where  $h_z^k$  are the eigenvalues of the operator  $h_z$ . The state of the TLS combined with the nuclear spins is described by the density matrix , which we divide up into 3-by-3 blocks  $_{kk^0}$ . The density matrix evolves according to the generalized master equation [18]

ij 1 = jiihjj acts on the TLS only. The rate x describes the radiative decay of the exciton  $\chi$  i into one of the single-electron states = j'i; j#i, while is the pure dephasing rate of state  $= j\#i; \chi$  i with respect to j'i. Since H has block form, the master equations for the various blocks are decoupled, and have the closed form

The diagonal blocks obey the fam iliar Lindblad equation,




FIG.2: Conditional evolution of the nuclear spin distribution ( $h_{z}^{k}$ ) =  $_{kk}$ . (a) D uring the rst period  $t_{1}$  of evolution w ithout photon emission, the initial G aussian distribution (solid line) develops a peak at the two-photon resonance (dashed line). (b) Change of ( $h_{z}$ ) after emission at  $t_{1}$  (solid line), until before emission time  $t_{2}$  of the second photon (dashed line). The two-photon resonance has been shifted to the position of the left maximum (adaptive technique). The depleted region around  $h_{z}^{k} = 0$  is developed at  $t_{1}$ . (c) A nahogous situation between  $t_{11}$  and  $t_{12}$ . (d) ( $h_{z}$ ) is obtained after a total time of 10 s. Inset: M agni cation of peak in (d). The width of ( $h_{z}$ ) is reduced by a factor of 100 com pared to the initial width in (a). The parameters used for this calculation are  $_{c} = _{p} = 0.2 \, {\rm ns}^{1}$ , = 0,  $_{x} = _{x} = 1 \, {\rm ns}^{1}$ , and  $_{y} = _{x} = 0.901 \, {\rm ns}^{1}$ .

Stationary state. We start with the factorized initial state  $_0 = _0 _0$  with arbitrary initial density matrices  $_0$  and  $_0$  of the TLS and the nuclear ensemble, where  $_{0} = \int_{kk^{0} kk^{0}} j h_{z}^{k} j h_{z}^{k^{\circ}} j$  and  $j h_{z}^{k} j$  are eigenstates of the Overhauser operator,  $h_z j h_z^k i = h_z^k j h_z^k i$ . As the o -diagonal elements of 0 turn out to be irrelevant for the stationary state of the TLS, our analysis is valid both for a pure initial state (e.g., with  $kk^0 = \frac{P_{kk}}{k} \frac{1}{k} \frac{1$ for a mixed initial state (e.g., the completely mixed state,  $_{kk^{0}}$  /  $_{kk^{0}}$  ). We assume a Gaussian distribution  $_{kk}$  = (2) <sup>1=2</sup>  $\int_{1}^{1} \exp\left[\left(\frac{h}{2}\right)^2 = 2^2\right]$ , with an initial width = p = A = N, plotted as a solid line in Fig. 2 (a). For our num erical calculations we choose A = 90 eV and 10 corresponding to  $_0$  ' 0:13 eV ' 0:2 h 5 with = 1 ns. W e choose a sample of n (2I + 1)<sup>N</sup> states from the total Hilbert space (n 4000).

Due to the hyper ne coupling between the TLS and the nuclei, the two systems become entangled as the stationary state is reached. The stationary density matrix  $_{P}$  is independent of  $_{0}$  and has the general form =  $_{kk^{0} \ kk^{0}}$  j  $\frac{k}{2}$  in  $h_{z}^{k^{0}}$  j. We derived an analytical expression for the 3-by-3 diagonal blocks  $_{kk}$  of as a function of all parameters, including  $h_{k}$ . We nd num erically that the o-diagonal blocks  $_{kk^{0}}$  (k  $\in k^{0}$ ), i.e., the nuclear coherences, decay exponentially and thus vanish in the stationary density matrix . Therefore, is block-diagonal,  $_{kk^{0}} = _{kk^{0} \ kk}$ .

Evolution of the observed system . In order to enhance the electron spin coherence, we aim at narrowing the nuclear spin distribution. In the case of a Gaussian distribution, this amounts to decreasing the width w ith respect to its initial value 0, thus increasing the electron coherence time  $t_0$  ' 1=2 . Ideally, we would perform a projective measurement P on the nuclear spins such that P<sub>kk</sub>P/(片 ). This also bounds the o -diagonal elements of = Tr , where Tr is the partial trace over the TLS, because j<sub>kk</sub>oj  $kk k^0k^0$  due to the positivity of . The measurement P can be successively approxim ated by monitoring the photon emission from the QD. The longer the period t during which no photon is em itted, the higher is the probability for  $h_z$  to be at the two-photon resonance,  $h_z =$ 

To describe the state of the system conditional on a certain measurement record, we use the conditional density matrix <sup>c</sup>. In the absence of photon emission, <sub>c</sub> obeys Eq. (6) with  $L_k$  replaced by  $L_k$  S, with the collapse operator S [20],




FIG. 3: Electron coherence function  $jS_+$  (t) $i \neq jS_+$  (0)i j vs. electronic precession time t calculated from ( $h_2$ ) in Fig. 2 after emission of the nth photon (n = 1;6;:::;26). The initial decay is approximately G aussian.

W e have num erically calculated <sup>c</sup> conditional on the absence of emitted photons for a given duration t. W e plot the updated probability distribution  $_{kk}$  from = Tr <sup>c</sup> as a dashed line in Fig.2(a). W e nd that the a posteriori probability is concentrated around the two-photon resonance. O f course, this process will eventually be stopped by the emission of a photon.

Photon em ission. The stationary em ission rate is [20]

where =  $x_{*} + x_{\#}$ . The average number of photons em itted during time t is  $hN_{ph}i = t_{em}$  and the a priori probability for  $N_{ph} = 0$  is, according to Poissonian statistics,  $P_{dark}(t) = exp(em t)$ . The waiting time distribution for photon em issions is  $p_{wait}(t) = \frac{1}{em} exp(em t)$ with a mean waiting time  $hti = \frac{1}{em}$ . The progressive narrowing of the O verhauser eld distribution, Eqs. (7) and (8), leads to a decreasing photon em ission rate em, and therefore to an increasing average waiting time t. We rst assume that every em itted photon is detected and later generalize to the case of in perfect detection.

Using Eq. (8), we nd for the update rule of the nuclear density matrix upon photon emission  $^{0}$  = Tr S  $^{c}$ =TrS  $^{c}$ . The Overhauser eld distribution after the emission is

where  $_{kk}$  and  $(_{kk})_{X X} = hX j_{kk} K$  i are taken before the emission. According to Eq. (9), the population in the O verhauser eld  $h_z$  corresponding to the two photon resonance  $h_z =$  is depleted by the photon emission (Fig. 2b, solid line). However, the combined e ect of the observed evolution without emission and the collapse leads to narrowing of the nuclear distribution.




FIG.4: Characteristic time  $t_0$  of the initial Gaussian decay in  $j_{S_+}(t) i = j_{S_+}(0) i j$  in Fig.3 as a function of the optical preparation time t, averaged over 50 numerical nuns (with error bars indicating the standard deviation).

Adaptive technique. The stationary, isolated TLS at the two-photon resonance is in a dark state. However, the coupling to the nuclei introduces a nonzero probability for occupation of the X i state and for emission of a photon. The detection of a photon provides inform ation about  $h_z$  and an adjustment of the EIT setup. Thus, photon em ission does not necessarily signify a failed attempt to narrow the nuclear eld distribution, but can be used as an input for the next weak m easurem ent with adjusted frequencies of the driving lasers,  $l_p^0 = l_p + =2$ and  $!_{c}^{0} = !_{c}$ =2, so that the new two-photon resonance condition is  $h_z = {}^0 w here {}^0 =$ + while  $^{0} = .$ We choose such that the new resonance with the O verhauser eld lies in one of the two maxim a  $h_z^{max}$  form ed after the photon em ission, see Fig. 2b. This situation is formally described by Eq. (3) with the substitution +  $\frac{m}{2}$  ax. We note that the adaptive technique ! also works by changing only one of the laser frequencies. R ight after the photon em ission, the TLS is in one of the single electron states, "ior #i.W ithin a time 1= , much faster than any nuclear time scale, the driven electronic system will reach the new stationary state. Then, the photon emission from the QD can again be monitored, leading to an enhanced nuclear population at the new resonance (Fig. 2b, dashed line), thus further narrow ing the nuclear distribution and further enhancing the electron spin coherence. This procedure can be repeated many times, leading to a nuclear distribution that is limited only by the width of the EIT resonance (Fig.  $2c_rd$ ).

Electron spin decoherence. The electron spin coherence is quantiled using the expectation value of the raising operator  $S_+$  (t) in a state  $j_{k_+}$  i that is prepared per4

pendicular to the total  $% \mathcal{B}_{\mathrm{tot}}$  eld B  $_{\mathrm{tot}}$  and is freely precessing about the ucpuating nuclear eld  $h_z$ ,  $hS_+$  (t)i  $hx_{+}jS_{+}(t)jx_{+}i =$  $_{k}$   $_{kk}h$   $h_{2}^{k}$   $j_{X+}$   $j_{F+}$  (t)  $j_{X+}$  ij  $h_{2}^{k}i$ . Using h  $h_z^k \mathfrak{F}_+$  (t) j  $h_z^k i = e^{it h_z^k z^2} S_+$  (0)  $e^{it h_z^k z^2}$ , we obtain  $hS_+$  (t) i = (h=2)  $k_k \exp(it h_z^k)$ , which we plot in Fig. 3 at various stages in an adaptive optical measurement scheme. We make a Gaussian t, hS+ (t)i / exp  $(t^2 = t_0^2)$ , for short times t and plot the coherence time  $t_0$  as a function of total waiting time in Fig. 4. This is the main result of our theoretical analysis: The repeated observation of the QD photon emission and adaptation of the laser frequencies ! c and ! p after each photon em ission leads to a pronounced enhancem ent of the electron coherence time, for the realistic parameters chosen, from  $t_0 = 5 \text{ ns to}$ 500 ns within a total observation time of 10 s.

Im perfect detectors. W e cannot expect to have perfect photon detectors at our disposal, therefore we discuss here the case of a detector with e ciency e < 1. For an in perfect detector, Eq. (7) becomes  $\frac{c}{-k} = (L_k)$ eS)<sup>c</sup><sub>kk</sub>, re ecting that a photon is only detected with probability e. We have num erically analyzed the case of e = 10%(other parameters as above) and  $nd t_0$ 460 ns after a preparation time of t = 50 s. The requirem ent for longer preparation times is a consequence of the reduced photon detection rate e  $\ _{\mathrm{em}}$  . W e note that this is still orders of m agnitude shorter than the time after which the nuclear spin di uses, estim ated to be around 0:01 s due to higherorder hyper ne ip- op term s [17], but possibly longer due to Knight shift gradient e ects. Long tim e scales for the decay of nuclear polarization, on the order of seconds in the case of nuclear spins in contact with donors in G aAs, have also been seen experimentally [21].

Conclusions. We nd that it is possible to e ciently enhance the quantum phase coherence of an electron spin in a QD surrounded by a large ensemble of nuclear spins by a continuous weak measurement of the Overhauser ekl using optical excitation at a two-photon resonance of the TLS formed by the spin-split conduction band electron and one of the trion states. An intriguing question is whether the electron spin coherence can be enhanced by a quantum Zeno type e ect to the point where it is ultimately determined by spin-orbit interaction: since reservoir correlation time of dom inant electron spin decoherence due to ip- op terms of the hyper ne interaction is 1 s, this would most likely require high e ciency detection of the scattered photons.
