## N on-U niversal F in ite Size E ects with U niversal In nite-Size Free Energy for the -X Y m odel

We study nite size e ects in a family of systems in which a parameter controls interaction-range. In the long-range regime where the in nite-size free energy is universal, we show that the nite size e ects are not universal but depend on the interaction-range. The nite size e ects are observed through discrepancies between time-averages of macroscopic variables in H am iltonian dynamics and canonical averages of ones with in nite degrees of freedom. For a high energy regime, the relation to a pair of the discrepancies is theoretically predicted and num erically con rm ed. We also num erically show that the nite-size e ects of macroscopic variables in the canonical ensemble are close to ones in the dynamical systems.

#### x1. Introduction

In m any body systems, the range of interactions governs physical features. Longrange interactions induce a phase transition, and typical ones are the mean-eld interactions. For instance, the H am iltonian mean-eld (HMF) model which consists of planar rotators shows a second-order phase transition between a low energy ordered phase and a high energy disordered phase.<sup>1)</sup> On the other hand, short-range interactions are hard to occur the phase transition, particularly in low-dimensional systems. If the planar rotators are on a one-dimensional lattice with nearest-neighbor interactions, then no phase transition occurs.

To investigate how the range of interactions a ects the existence of a phase transition, the HMF model is extended to a model having algebraically decaying interactions, called the -XY model, described by the following Ham iltonian:<sup>2)</sup>

Each rotator is placed on a site of the periodic d-dimensional simple lattice, that is N = L<sup>d</sup> for the lattice of size L, and  $r_{ij}$  is the shortest distance between the sites i and j. The -XY model includes the HMF model as = 0, and the nearest neighbor interaction realizes in ! 1. The factor N' is introduced for recovering the extensivity of the system, but the factor does not make the system additive for 0 =d < 1. In this article, N' is de ned as  $\sum_{i=1}^{N} 1=r_{ij}$ .<sup>3)</sup> In the long-range regime 0 =d < 1, Campa et al. show that the -XY model including the external magnetic eld essentially has the same canonical partition function with the HMF model in N ! 1,<sup>3)</sup> and the critical value of the energy for a second-order phase transition is common as U = E =N = 0:75, with E being the value of the Ham iltonian. Recent studies of the -XY model are brie y summarized in Ref.4). In this article, in the long-range regime, we investigate how macroscopic variables for the -XY system with nite N approaches the therm odynamic limit (N ! 1). They could go towards canonical averages as N increases (see Appendix, and Refs. 5){7) for the HMF model), but it is not obvious whether the convergence speed depends on =d or not. Some non-universalities appear as dynamical aspects in 0 =d < 1,<sup>4)</sup> and hence we compare canonical averages of the macroscopic variables in N ! 1 and time-averaged variables with nite N. The time-averaged variables are obtained by integrating the canonical equation of motion yielded from the Ham iltonian (1.1). We set d = 1 for the convenience of num erical computations, and show that, for the supercritical energy regime, the time-averages taken in N ! 1 as N increases, and the exponents depend on .

## x2. Theoretical Prediction

As macroscopic variables we observe, we adopt modulus of the magnetization and the temperature. The magnetization vector  $M \coloneqq_q (\underbrace{M_x; M_y})$  and its modulus M are dened as  $M \coloneqq_{i=1}^{P} (\cos q_i; \sin q_i) = N$  and  $M \coloneqq_q (\underbrace{M_x; M_y})$ , respectively. The temperature in the sence of dynamics is dened as  $T_N^d \coloneqq_{j=1}^{P} p_j^2 = N$ . Note that we numerically compute averages through Hamiltonian dynamics instead of canonical ensemble, then a xed variable is neither T nor  $T_N^d$ , but the internal energy U = E = N. In this section, we estimate the following two discrepancies

where  $hX_{i_N}$  and  $hX_{i_1}$  denote the canonical average of X with nite N degrees of freedom and one in N ! 1 respectively.  $hU_{i_N}$  and  $hM_{i_N}$  are calculated in Ref 8) with the aid of the saddle-point approximation.<sup>3)</sup>  $T_N$  is the temperature for the system with N degrees of freedom and is de ned as

The relation (2.2) bridges between H am iltonian dynamics and canonical statistics. We require that the relation (2.2) holds in any degrees of freedom and hence hU  $i_N$  ( $T_N$ ) = hU  $i_1$  (T): The average hU  $i_1$  (T) is related to T and hM  $i_1^2$  as

The relation (2.3) is straightforwardly obtained for the HMF model, and holds in the long-range regime 0 < 1 due to the universality of the canonical partition function.<sup>3)</sup>

A lthough we do not show the derivation, we can show the following relation for  $T_c$ ,  $T_c$  being the canonical critical tem perature<sup>8)</sup>

The constant b represents the diagonal elements of the matrix  $(1=r_{ij})$ , and can be chosen arbitrarily. We select b = 2.0 to obtain a fully positive spectrum which enables us to apply the Hubburd-Stratonovitch transform ation.<sup>3)</sup>

#### x3. Numerical Results

Let us check the validity of our theoretical predictions of  $_T$  and  $_M$  num erically. The time-averaged temperature  $T^d_N_t$  and the order parameter  $M_t$  is are dened as follow s:




Fig.1. Time-averaged values  $hT_N^d i_t(t_0)$  and  $hM i_t(t_0)$  as functions of computing time  $t_0$ . Parameters are taken at N = 256, = 0.3;0:6;0:9 and U = 0:8, for which hM  $i_1 = 0:0$ . The horizontal solid line represents the corresponding canonical temperature T = 0:6.

N um erical integrations of the canonical equation of motion are performed by using a fourth-order symplectic integrator.<sup>9)</sup> Thanks to the Fast Fourier Transformation technique, the calculation times are of order N ln N. The time slice of the integrator is set at 0.2 and it suppresses the relative energy error  $E = E = 10^{-5}$ . Our initial condition is, for all values of , the canonical equilibrium distribution of the HM F model, that is p and q are random by taken from the distributions being proportional to exp ( $p^2=2$ ) and exp ( $hM i_1 \cos q$ )<sup>7)</sup> respectively, where = 1=T. The sum of momenta is an integral of motion, and we initially set it to zero. The computing time,  $t_0$  in Eq.(3.1), are set to more than  $10^6$  to realize equilibrium states in the sense of dynamics, where we de ne such equilibrium as when the time-averaged m acroscopic variables are alm ost stational. Typical time sequence of both hM  $i_t$  ( $t_0$ ) and  $T_N^d t_t$  ( $t_0$ ) are shown in Fig.1 as functions of computing time  $t_0$ . In Fig.1, we observe nite size e ects M and T, which are discrepancies from hM  $i_1$  and T respectively.




Fig.2. Dependence on N of the two discrepancies (a) hM i\_-hM i\_ and (b)  $hT_N^d i_t$ -T at U = 5.0. A symptotic power-law decays are observed.

For the supercritical energy regime, we investigate the nite size e ects for two values of energy. One is the high enough energy U = 5.0, and the other one is supercritical but the middle energy U = 0.8. The discrepancies  $_{\rm M}$  (N) and  $_{\rm T}$  (N) are shown in Fig2 as functions of N. It is shown that the discrepancies algebraically decrease as N increases, that is

A coording to the theoretical prediction (2.4), the exponent  $_{\rm M}\,$  should be related to the other  $_{\rm T}$  as

Let us check the relation (3.3) by observing the exponents  $_{\rm M}$  and  $_{\rm T}$  as functions of .




Fig. 3. Exponents  $_{M}$  and  $_{T}$  as functions of . (a) U = 5:0. (b) U = 0:8. D ashed curves represent theoretical predictions.

For the high enough energy U = 5.0 (see Fig.3 (a)), the theoretical curve is in good agreem ent with num erical results in the interval 0 . 0.6. In addition, the theoretical prediction is qualitatively good for U = 0.8 (see Fig.3 (b)). For further discussions, we refer the reader to R ef.8).

## x4. Conclusions

In this article the -XY model (1.1) with d = 1 has been studied for the long-range regime 0 < 1, so that we clarify the role of interaction length in H am iltonian system s with m any degrees of freedom  $\cdot^{8)}$  W e have studied dependences on degrees of freedom for time-averaged m acroscopic variables calculated through

H am iltonian dynam ics with nite degrees of freedom, contrasted with the canonical averages of ones in the therm odynam ic lim it. A non-universal behavior in 0 < 1 is observed in the asymptotic behavior of the discrepancies for the supercritical regime. For the supercritical regime, the discrepancy between the two averages decays as a power-type function, and the exponents depending on are explained by applying the canonical ensemble with nite degrees of freedom with the aid of the saddle-point approximation. This non-universal behavior sheds light on the study of H am iltonian system s with long-range interactions.

### Appendix




Fig. 4. Dependence on N of the values of macroscopic variables in the canonical ensemble with = 0.3, (a) hM i<sub>N</sub> -hU i<sub>N</sub> and (b) T -hU i<sub>N</sub> .




Fig.5. Dependence on N of the values of macroscopic variables in the dynamical system with = 0.3, (a) hM i<sub>t</sub>-U and (b)  $hT_N^d$  i<sub>t</sub>-U. Here the lines denote the canonical averages of M and  $T_N^d$  in N ! 1.




Fig.6. Dependence on N of the values of m acroscopic variables in the canonical ensemble with = 0.9, (a) hM i<sub>N</sub> -hU i<sub>N</sub> and (b) T -hU i<sub>N</sub>.




Fig.7. Dependence on N of the values of macroscopic variables in the dynamical system with = 0.9, (a) hM  $i_t$ -U and (b) hT\_N^d  $i_t$ -U. Here the lines denote the canonical averages of M and  $T_N^d$  in N ! 1.

In this appendix, to show that the values of the canonical averages of m acroscopic variables are close to the values of tim e-averages of ones, we num erically study equilibrium values of macroscopic variables for models with nite N and d = 1 in each situation. In the canonical ensemble and in the dynamical system, we use a conventional canonical M onte C arb algorithm and a fourth sym plectic integrator respectively. First, for the model with = 0:3, and this is close to = 0, Figs.4 and 5 show that the relation hM  $i_N$  +U  $i_N$  in the canonical ensemble are close to hM  $i_1$ -U in the dynam ical system . Furtherm ore, it is suggested that the tim e-averaged values of m acroscopic variables go towards the canonical averages of ones evaluated in the therm odynam ic lim it as N increases. Next, for the model with = 0:9, we show the values of the m agnetization and the tem perature as functions of the energy density in Figs.6 and 7. The relation hM  $i_N$  -hU  $i_N$  in the canonical ensemble are close to hM i\_U in the dynamical system again. However, in this case, the prediction from the canonical average evaluated in the therm odynam ic lim it is not close to the relations hM  $i_N$  -hU  $i_N$  and hM  $i_L$ -U.

Thus, from the observations in the two cases = 0.3 and = 0.9, we conclude that, at a xed value of provided < 1, the relations hM  $i_N$  -hU  $i_N$  in the canonical ensemble are close to the relations hM  $i_t$ -U in the dynam ical system . Meanwhile, at any xed value of N, the discrepancies between hM  $i_N$  -hU  $i_N$  and hM  $i_1$  -hU  $i_1$ , and between hM  $i_t$ -U and hM  $i_1$  -hU  $i_1$ , become larger as increases up to unity. This tendency of the discrepancy is consistent with ones in Fig.3 for the supercritical energy regime.
