# Hole spin dephasing in p-type sem iconductor quantum wells

Hole spin dephasing time due to the D'yakonov-Perel' mechanism in p-type G aAs (100) quantum wells with well separated light-hole and heavy-hole bands is studied by constructing and numerically solving the kinetic spin B loch equations. We include all the spin-conserving scattering such as the hole-phonon and the hole-nonm agnetic in purity as well as the hole-hole C oulom b scattering in our calculation. D i erent e ects such as the tem perature, the hole density, the impurity density and the R ashba coe cient on the spin dephasing are investigated in detail. We also show that the C oulom b scattering makes marked contribution to the spin dephasing. The spin dephasing time can either increase or decrease with tem perature, hole/impurity density or the inclusion of the C oulom b scattering. It is also show n that due to the di erent spin-orbit coupling strengthes, many spin dephasing properties of holes are quite di erent from those of electrons.

## I. IN TRODUCTION

M uch attention has been devoted to the spin degree of freedom of carriers in Z inc-blende sem iconductors recently due to the possible application to the spintronic devices.<sup>1,2,3,4</sup> Understanding spin dephasing/relaxation of carriers in sem iconductor quantum wells (QW s) is one of the most important prerequisites for the realization of such devices. There are many studies of spin dephasing/relaxation of electrons in n-type QW s where the spin dephasing is determ ined by the D'yakonov and Perel' (DP) mechanism.<sup>5</sup> M ost studies are within the fram ework of single-particle approxim ation<sup>6,7,8,9,10,11,12</sup> and the spin dephasing time (SDT) can be written as<sup>6</sup>

Here  $_{\rm p}$  (k) is the momentum relaxation time. (k) is the DP term which is composed of the D resselhaus term  $^{13}$  due to the bulk inversion asymmetry (BIA) and the Rashba term  $^{14}$  due to the structure inversion asymmetry (SIA). (k)<sup>2</sup> denotes the average of  $^{2}$  (k) over all directions of k. In GaAsQW s, the D resselhaus term is the leading term and (k) has the form :

in which  $hk_z^2$  i represents the average of the operator

 $(@=@z)^2$  over the electronic state of the low est subband and is therefore  $^2=a^2$  under the in nite well-depth assumption. is the D resselhaus spin-orbit parameter.<sup>6,15</sup> It is noted that Eq. (1) is valid only when  $j j_p = 1$ and the scattering is elastic. In this limiting case, the angular rotation of electron spin over time  $_p$  is small and spin relaxation occurs as a result of a number of accidental sm all rotations.<sup>6</sup> This approach captures the low est (rst) order of the anisotropy due to the fact that (k) = (k).

It is shown recently by W u et al. from a full m anybody m icroscopic approach<sup>16,17,18,19,20,21,22,23</sup> that the single-particle approach is inadequate in accounting for the spin dephasing/relaxation. The momentum dependence of the e ective m agnetic eld (the DP term), and even the momentum dependence of the spin di usion rate along the spacial gradient<sup>22</sup> or the random spin-orbit coupling,<sup>24</sup> serve as inhom ogeneous broadenings.<sup>17,18</sup> In the presence of the inhom ogeneous broadening, any scattering, including the carrier-carrier C oulom b scattering (beyond the H artree-Fock self-energy from the C oulom b interaction), can cause irreversible dephasing. This m any-body approach takes account of the inhom ogeneous broadening not only from di erent directions of

(k) (not only j(k) j and + j(k)), but also from the modulus of the DP e ective eld, i.e., j (k) j.<sup>25</sup> M oreover, this approach also takes full account of the counter e ect of the scattering to the inhom ogeneous broadening instead of only the lowest-order elastic scattering: The scattering tends to drive carriers to more hom ogeneous states and therefore suppresses the inhom ogeneous broadening induced by the DP term . Finally, this approach is valid even when j (k) j  $_{\rm p}$  ' 1 and is applicable to system s far away from equilibrium (eg., system s with high spin polarization<sup>19</sup> and/or in the presence of high electric eld parallel to QW s).<sup>20,21</sup> U sing this method, W eng and W u perform ed a system ic studies of spin dephasing in n-type G aAs (100) QW sat high tem peratures and showed that the e ects beyond the single-particle approach Eq. (1) are dominant even for systems near equilibrium.<sup>19</sup> These e ects include the many-body effects, the inhomogeneous broadening induced spin dephasing and the counter e ect of the scattering to the inhom ogeneous broadening. For small well width, the calculated electron SDTs using this microscopic manybody theory increase with temperature and are in agreement with the experiment both qualitatively and quantitatively, while the SDTs of earlier simplied treatment drop dramatically with temperature and are one order of magnitude larger than the experiment data.<sup>19</sup> For larger wellwidth, the SDT may rst increase then decrease with temperature.<sup>21</sup> These properties come from the competing e ects between the DP term and the scattering.

A lthough there are extensive investigations on the spin relaxation/dephasing of electrons, investigations on the spin relaxation/dephasing of holes in p-type sem iconductor QW s are relatively limited.<sup>26,27</sup> N evertheless, know l-edge of the spin relaxation/dephasing of holes in p-type QW s is very important to the assessment of the feasibility of hole-based spintronic devices. This is because a possible way to achieve high electronic spin injection without the conductance m ism atch<sup>32</sup> is to use m agnetic sem iconductors as spin source and m ost m agnetic sem iconductors are p-type at high temperature.<sup>33</sup> Very recently there are some reports on the hole spin relaxation/dephasing.<sup>28,29,30,31</sup> All the theoretical calculations in these works are within the framework of the single-particle approximation Eq. (1).<sup>30,31</sup>

It has been shown in electron systems that Eq. (1) is inadequate in accounting for the spin dephasing. M oreover, the electronic states and spin-orbit coupling of holes are very dierent from those of electrons.<sup>34,35,36</sup> In bulk material, the -point degeneracy of the heave hole (HH) and the light hole (LH) makes the hole spin relaxation in the same order of the momentum relaxation (100 fs).<sup>28</sup> This degeneracy is lifted in QW s. Under the parabolic approximation, the HH and LH bands can be treated independently for QW sofsmallwellwidth. Unlike the conduction band where the DP term mainly comes from the BIA contribution in GaAsQWs, in p-type GaAsQWs, the SIA contribution is usually the dom inant one. It is noted that in hole system the relation  $j j_p$ 1 is usually unsatis ed due to the strong spin-orbit coupling and consequently the validity of Eq. (1) is even more questionable. Therefore, in this paper we investigate the hole spin dephasing using our fullm any-body m icroscopic approach.We calculate the SDT of the HH and LH by num erically solving the many-body spin kinetic B loch equations with all the scattering explicitly included. Then we discuss how the tem perature, the hole density, the Coulomb scattering, the Rashba coe cient and the impurity density a ect the SDT.We show that the earlier treatm ent based on the single particle approximation is not valid in hole system s and unlike the case of electrons where the scattering \always" raises the SDT at low-spin polarization, the scattering can either enhance or suppress the SDT of holes based on the relative in portance of the Rashba term and the scattering.

The paper is organized as follows: In Sec. II we set up our model and kinetic equations. Then in Sec. III we present our num erical results. We rst show the time evolution of the spin signal in Sec. III A. In Sec. III B we investigate how the tem perature a ects the spin dephasing. The C oulom b scattering, the impurity density and hole density dependence of the SD T are discussed separately in Sec. III B, C and D. W e conclude in Sec. IV. In Appendix A we show the e ect of the scattering to spin dephasing when it is much weaker than the spinorbit coupling strength. In Appendix B we present a simpli ed analytical analysis of the SD T and show the

## II. KINETIC SPIN BLOCH EQUATIONS

di erent e ects of the scattering to the spin dephasing at

strong/weak scattering regime.

W e start our investigation from a p-doped (100) G aAs QW of well width a. The growth direction is assumed to be along the z axis. A moderate magnetic eld B is applied along the x axis (in the Voigt con guration). Here we assume only the lowest subband is populated. It is noted that for two-dimensional hole system, the lowest subband is HH -liked. By applying a suitable strain, the lowest subband can be LH -liked. We assume the connem ent is large enough so that the HH and LH bands are well separated and we may consider the HH s and LH s separately. W ith the DP term included, the H am iltonian of the holes can be written as:

Here = LH; H H denotes the LH or HH state, = +; stands for the spin.  $"_k = k^2 = 2m$  is the energy of hole with wave vector k and e ective mass m . are the Paulim atrices. The DP term is mainly from the Rashba term . For (100) G aAs QW s, we have

for LHs.<sup>35</sup> It is seen from these equations that the m agnitude of the Rashba term can be tuned by m eans of an external gate voltage which changes the electric eld E<sub>z</sub> in the sample.<sup>38,39,40,41</sup> (7h7h), 7h7h, <sup>6161</sup>, <sup>6161</sup> and <sup>6161</sup> in Eqs. with  $_0$  representing the energy gap of the split-o band (from the -point of the valence band).  $_1$ ,  $_2$  and  $_3$ are the Luttinger parameters. From Eqs. (4-9) one can see that the HH R ashba terms include only the cubic terms whereas the LH ones include both the cubic and the linear terms. The ratio of the cubic and the linear terms depends on the well width a:  $hk_z^2$  i in the linear terms decreases with a<sup>2</sup>. Futherm ore, one can see from Eqs. (10) and (12) that h1 decreases faster with a than hs, which makes  $\frac{6161}{53}$  and  $\frac{6161}{54}$  increase faster with a than  $\frac{6161}{53}$ . Therefore, the cubic terms weighted by  $\frac{6161}{53}$  and  ${}_{54}^{6161}$  increase faster with well width than the linear term sweighted by  ${}_{52}^{6161}$ . In brief, when a is small, both the linear and the cubic term s are important; W hen a gets larger, the cubic term s are the leading term s.

The interaction H am iltonian H<sub>I</sub> in Eq. (3) is composed of the hole-hole C oulomb interaction and hole-phonon scattering, as well as hole-in purity scattering. Their expressions can be found in textbooks.<sup>42,43</sup>

W e construct the many-body kinetic spin B loch equations by the non-equilibrium G reen function method as follows:

with  $_k$ ;  $\circ$  representing the single-particle density matrix elements. The diagonal elements  $_k$ ;  $f_k$ ; describe the hole distribution functions of wavevector k, state and spin. The o-diagonal elements  $_{k;;+} = k;;+$  describe the inter-spin-band correlations for the spin coherence.  $_{-k}$ ;  $\circ j_{coh}$  describe the coherent spin precessions around the applied magnetic eld B in the Voigt con guration, the elective magnetic eld

\_k;  $\circ j_{scatt}$  in Eq. (13) denote the hole-hole Coulomb, hole-phonon and hole-in purity scattering. The expressions of these scattering terms and the details of solving these many-body kinetic spin B loch equations can be found in Ref. [20]. ently sum m ed spin coherence




FIG.1: Typicalhole densities of spin-up and spin-down bands and the incoherently sum m ed spin coherence  $_{\rm H~H}$  vs. timet shown for the case of the H H s. N ote that the scale of the spin coherence is on the right side of the gure. The dotted line represents the slope of the envelope of  $_{\rm H~H}$ .

The material parameters of G aAs in our calculation are tabulated in Table Iwhere  $_{Lo}$  represents the LO phonon frequency and  $_1$  ( $_0$ ) is the optical (static) dielectric constant.<sup>35,45</sup> O ur main results are plotted in Figs. 1-6. In these calculations the width of the QW is chosen to be 5 nm unless otherwise specified; the initial spin polarization P = (N ;+ N; )=(N ;+ + N; ) is 2.5 % with

representing the hole density of -spin band; the magnetic eld B = 4 T, and the Rashba coe cient  ${}_{54}^{7h7h}E_{z}m_{0}$  is taken to 0.5 nm when a = 5 nm.

## III. NUMERICAL RESULTS

W e num erically solve the kinetic spin B loch equations and obtain temporal evolution of the hole distribution  $f_k$ ; (t) and the spin coherence  $_k$  (t). We include the hole-phonon and the hole-hole scattering throughout our computation. A swe concentrate on the relatively high-temperature regime (T 120 K), we only include the hole-LO-phonon scattering. The hole-impurity scattering is included when stated. A s discussed in the previous papers,  $^{16,17,42,44}$  the irreversible spin dephasing can be well de ned by the slope of the envelope of the incoher-

## A. Tem poral evolution of the spin signal

We rst study the tem poralevolution of the spin signal in a GaAs QW at T = 300 K. In Fig. 1 we show the typical evolution of the HH densities in the spin-up and – down bands together with the incoherently sum m ed spin coherence for the total HH density N<sub>H H;+</sub> + N<sub>H H;</sub> =  $4 \quad 10^{11}$  cm<sup>-2</sup> and impurity density N<sub>i</sub> = 0. It is seen from the gure that the hole densities in the spin-up and – down bands and the incoherently sum m ed spin coherence oscillate due to the presence of the magnetic eld. From the slope of the envelope of the incoherently sum m ed spin coherence, one is able to deduce the SDT.

## B. Tem perature dependence of the SD T




FIG. 2: SDT of LHs [Fig. 2(a)] and HHs [Fig. 2(b)] vs. temperature T at di erent in purity densities. : N<sub>i</sub> = 0; N: N<sub>i</sub> = 0:1N<sub>h</sub>; and : N<sub>i</sub> = 1:0N<sub>h</sub>. The dashed curves in Fig. 2(a) are the corresponding curves but at bigger wellwidth a = 7 nm. The SDTs calculated from the sim pli ed treatment (solid curves) and our many-body treatment (dashed curves) are plotted in the insets for comparison.

W e now turn to study the tem perature dependence of the SDT at di erent in purity densities N<sub>i</sub>. W e plot the SDT softhe LH and the HH in Fig. 2 (a) and (b) as functions of tem perature. The total LH and HH densities N<sub>LH</sub> and N<sub>HH</sub> are taken to be N<sub>h</sub> = 4  $10^{11}$  cm<sup>2</sup>. One nds from Fig. 2 (a) that for the LH, when there are no in purity N<sub>i</sub> = 0 or low in purities N<sub>i</sub> = 0.1N<sub>h</sub>, the SDT rst decreases then increases with tem perature. The minimum occurs at sm aller tem perature for higher in purity densities: 140 K when N<sub>i</sub> = 0.1N<sub>h</sub> and 200 K when N<sub>i</sub> = 0. W hen the in purity density N<sub>i</sub> = N<sub>h</sub>, the SDT increases with temperature monotonically. These temperature dependences are quite di erent from those of electrons in QW s with the same electron density and initial spin polarization where the SDT increases monotonically with temperature.<sup>19</sup>

It is noted that the property of spin dephasing is quite dierentwhen jjp' 1 and jjp 1.Whenjjp'1, the scattering is weak in comparison to the DP e ective eld (inhomogeneous broadening) and the counter e ect of the scattering to the inhom ogeneous broadening is unimportant or can be ignored. In the presence of inhom ogeneous broadening, adding a new scattering provides an additional dephasing channel.17,42,46 This effect has been revealed in detail in Appendix A. Therefore, the scattering in this regime provides a spin dephasing channel and the increase of the tem perature leads to a stronger scattering and consequently a faster spin dephasing. Moreover, the increase of the temperature drives holes to a higher k-state, and holes experience a larger j (k) j i.e., a stronger inhom ogeneous broadening. This tends to reduce the SDT too. Therefore, the SDT decreases with temperature when  $jj_p$  ' 1. Whenjjp 1, the scattering is strong in comparison to the DP term . Hence the countere ect of the scattering to the inhom ogeneous broadening cannot be ignored any m ore. As the scattering tends to drive carriers to m ore hom ogeneous states in k-space, it tends to increase the SDT. Therefore, whether the SDT increases or decreases with temperature depends on the competition between the scattering and the DP term . It will be shown later that when the linear part in the DP term is dom in ant, the increase of the inhom ogeneous broadening with tem perature is relatively slower than that of the scattering and the SDT increases with tem perature. Nonetheless, when the cubic part in the DP term is dominant, the increase of the inhom ogeneous broadening with tem perature turns out to be faster than the increase of the scattering and the SDT decreases with tem perature.

For electrons in GaAs QW s, the spin-orbit coupling is not very strong.  $jj_p$  is usually much smaller than 1 (typically  $jj_p = 0.016$  at T = 100 K, a = 15 nm, and the total electron density  $N_{e;+} + N_{e;} = 4 - 10^{11}$  cm<sup>2</sup>). Therefore when the linear (cubic) term in Eq. (2) is dom inant, the SDT of electrons increases (decreases) with tem perature.<sup>19,21</sup>

Situations are more complicated for hole system due to the strong spin-orbit coupling. The Rashba coe cients of the coupling in Eqs. (4-9) are listed in Table II. For LHs, when a = 5 nm,  $\frac{6161}{52}$  E  $_{z}$  m  $_{0}\frac{hk_{z}^{2}i}{hk_{z}^{2}i}$  changes from 3:36 nm to 1:46 nm when the temperature changes from 100

K to 300 K. Here  $hk_k^2$  i represents the average of  $k_k^2$ . It is seen from Table II that both  $\frac{6161}{53}$  and  $\frac{6161}{54}$  are smaller  $\frac{6161 \frac{hk_z^2}{2}i}{hk_z^2i}$ . Therefore the linear terms in Eqs. (7) than and (8) are dominant. From these coe cients, one may further nd that when there is no impurity, the spin-orbit coupling for LH s is one or two orders of m agnitude larger than that of electrons. Consequently neither j  $^{LH}$  j  $_{p}$  / 1 1 is satised here. The value of  $j^{\hat{L}H} j_p$ norj<sup>LH</sup>jp is usually slightly sm aller than 1. In this regime, both the competing e ects of the scattering addressed above can not be neglected. Therefore the tem perature dependence of the SDT depends on the competition between the e ect of the increase of the spin dephasing due to the increase of the inhom ogeneous broadening and the increase of the scattering with tem perature (The latter provides additional spin dephasing channel) (E ect I) and the e ect of the decrease of the spin dephasing due to the counter e ect from the increase of scattering which suppresses the inhom ogeneous broadening (E ect II). The results for impurity free case shown in Fig. 2 (a) indicate

that when T < 200 K and the total scattering is not so strong, E ect I is more important and hence the SDT decreases with T.W hen temperature keeps increasing and the total scattering is further enhanced, the countere ect of the scattering to the inhom ogeneous broadening (E ffect II) becomes more important and the SDT increases with T. Comparing with our previous works,<sup>19,21</sup> one further nds that the absolute value of the SDT of LHs is one or two orders of magnitude sm aller than the SDT of electrons. This can be easily understood from the fact that the Rashba coe cients here are larger.

Now we include the hole-in purity scattering with the in purity density  $N_i = 0.1 N_h$ . As expected, when the total scattering becom es stronger, the counter e ect of the scattering to the inhom ogeneous broadening takes the leading place easier and the SDT starts to increase with tem perature earlier than the im purity-free case. W hen  $N_i = 1.0N_h$ , the total scattering is further enhanced. Now if one uses the hole-in purity scattering and the holephonon scattering to calculate the momentum relaxation time, and takes the lowest order of  $p^{1}(k)$  and LH(k)after expanding them over the function  $A_1(k)$  de ned in Eq. (B1), one gets the typical value of  $j^{LH}(k)j_{p}(k)$ at the average of k to be 0:11 at T = 100 K. It has already entered the regime of strong scattering, and similar to the case of electrons when the linear part of the DP term is dom inant, the SDT increases monotonically with tem perature.

W hen the well width becom es larger, the cubic term becomes more important. For example, when a = 7 nm,  ${}_{52}^{6161}$ E  $_{z}$ m  $_{0}\frac{hk_{z}^{2}i}{hk^{2}i}$  changes from 1:39 nm to 0:60 nm when the tem perature changes from 100 K to 300 K.O ne can see from Table II that the cubic terms weighted by  $\frac{6161}{53}$ are dom inant. The SDT in this case is plotted in Fig. 2 (a) as dashed curves for com parison. One can see that now the SDT decreases monotonically with temperature. It is because the increase of the inhom ogeneous broadening with tem perature is much faster when the cubic term in the DP term is dominant. Therefore E ect I always surpasses E ect II with the increase of tem perature and the SDT decreases monotonically with T. The same situation happens in the case of HHs where there is only cubic term in the DP term . It is seen from Fig. 2 (b) that the SDT decreases monotonically with temperature even when a = 5 nm. This is consistent to the electron case when the cubic term is dominant or the only term (bulk case) where the SDT also decreases monotonically with tem perature.<sup>17,21</sup>

O ne can nd from the discussion above that the spin dephasing is a combined e ect from the scattering and the inhom ogeneous broadening due to the DP term. The inhom ogeneous broadening induced spin dephasing<sup>17,18</sup> and the counter e ect of the scattering to the inhom ogeneous broadening, are both very important and neither can be neglected. Nevertheless, these e ects are either not or not fully accounted in the sim pli ed m odel which is based on the single-particle approximation Eq. (1). Furtherm ore, one should notice that the simplied model is based on the assumption of  $jj_p = 1$ ,<sup>6</sup> which is not always satistical for holes. To show the differences between the many-body approach and the earlier treatment, we also compare our results with those given by the simplied model which now reads:

( $E_k$ ; ) stands for the scattering cross section of the hole-phonon and the hole-impurity scattering, and the expressions can be found in Eq. (B8).

In the insets of Figs. 2(a) and (b), we plot the corresponding SDTs of LHs and HHs from the simplied treatments in solid curves. SDTs from our many-body approach are plotted in dashed curves. One can see that both the curvatures and the absolute values are m arkedly dierent between the two treatments. The simplied treatment shows that the SDT of both HHs and LHs decreases monotonically with temperature regardless of the impurity densities. Moreover, when the impurity density increases, the SDT increases very fast. This is because the single-particle treatment totally ignores the fact that in the presence of the inhom ogeneous broadening, adding a new scattering means adding a new spin dephasing channel. It also does not treat the counter effect of the scattering to the inhom ogeneous broadening su ciently. Moreover, it does not include the Coulomb scattering which we will show in the next subsection to be very important. By comparing the SDT spredicted by the two models, one can see that it is important to study the SDT of holes from the many-body approach.

# C . $\mbox{ E }$ ect of C ou lom b scattering on SD T

Now we turn to study the e ect of the C oulom b scattering in  $_{k}$ ;  $^{\circ}j_{scatt}$  to the SDT. It has been shown recently by W u et al. that unlike the common belief that the C oulom b scattering cannot cause spin dephasing, in the presence of inhom ogeneous broadening, it can also lead to spin dephasing<sup>17</sup> and for electrons in G aAs QW s, the C oulom b scattering is very in portant and can m arkedly increase the SDT.<sup>19,20</sup> G lazov and Ivchenko have also drawn the sim ilar conclusion.<sup>47</sup> Since the spinorbit coupling of hole system is much larger than that




FIG.3: SDT vs. the scale coe cient of the DP term for (a) T = 120 K and (b) T = 300 K.The solid (dashed) curves are the results with (without) the Coulomb scattering. : Electrons; N:LHs; :HHs.

of electron one, it would be interesting to see how the C oulom b scattering can a ect the SD T. Unlike the case of electron system, here we nd that the hole-hole scattering m arkedly reduces the SD T. This is consistent to the optical dephasing of sem iconductors where the C oulom b scattering gives rise to a stronger optical dephasing.<sup>17,42</sup>

In order to understand the di erence between the hole system and the previous electron one, we plot in Fig. 3 the SDT of the LH and the HH as function of a dim ensionless scale coe cient of the DP term at T = 120K and 300 K.Here is introduced by hand in front of the DP term, i.e., (k) with = 1 corresponding to the case of the original DP term. The solid curves are for the case with both the hole-hole scattering and the hole-phonon scattering and the dashed ones are for the case with the hole-phonon scattering only. It is pointed out here that notwithstanding the fact we sw eep through two orders of magnitude, experim entally the value of the Rashba coe cients can only be tuned within a small range by applying an external electric  $eld_{r}^{36,37}$  and can be determined by analyzing the Shubnikov-de H aas oscillations.<sup>38,39,40,41</sup> It is seen from the qure that when = 1, the SDTs of both the HH and the LH decrease when the Coulom b scattering is in-




FIG.4: SDT vs. the impurity density N  $_{i}$ =N  $_{h}$  with di erent scale coe cients of the DP term at T = 120 K for (a) LHs and (b) HHs. : = 0:128; N: = 0:256; : = 0:512; = 1:024.

cluded. How ever, when one decreases the spin-orbit coupling by decreasing the scale coe cient , one enters a regime where the C oulom b scattering increases the SD T. This is consistent with our previous observation that the competing e ects of the inhom ogeneous broadening and the scattering in di erent regimes. In the regime where the inhomogeneous broadening is weak (j jp 1), the hole-hole scattering mainly suppresses the inhom ogeneous broadening and consequently raises the SDT. In the regime where the inhom ogeneous broadening is strong, (j jp ' 1), adding a new scattering provides a new spin dephasing channel and reduces the SDT. It happens that for hole system, the spin-orbit coupling<sup>36</sup> is within the strong inhom ogeneous broadening regime. The same is true also for the optical dephasing where adding a new scattering also provides a new dephasing channel.<sup>17,42</sup> One also nds from Fig. 3 that the SDT decreases with . This can be easily understood because the spin dephasing becom es stronger when the spin-orbit coupling is larger. It is further noted that when the tem perature rises, the e ect from the Coulomb scattering is smaller. This is because the hole-phonon scattering becom es m ore im portant with the increase of tem perature. In order to compare the hole system with electron one,




FIG. 5: SDT vs. the impurity density at di erent temperatures for (a) LHs and (b) HHs. = 1

we add a scale coe cient in front of the electron D resselhaus term Eq. (2) and calculate the SDT of electrons in a QW (a = 5 nm) as function of with and without the electron-electron C oulom b scattering. The results are plotted in the same gure for comparison. Sim ilar to the case of holes, one nds that when the spin-orbit coupling is strong, the Coulomb scattering reduces the SDT also. It happens that the unscaled DP term (=1) is within the regime of weak inhom ogeneous broadening. It is also seen from the gure that the SDT of holes is much smaller than that of electrons when = 1.

#### Im purity density dependence of SD T D.

Now we turn to study how impurities a ect the hole SDT. In Fig. 4 we plot the SDT of LHs as function of the impurity density N<sub>i</sub>. It is seen from Fig. 4(a) that for LHs when = 0:128 or = 0.256, the SDT increases m onotonically with the impurity density. Again the spin-orbit coupling here is in the regime where the inhom ogeneous broadening is weak and the hole-in purity scattering mainly suppresses the inhom ogeneous broadening and raises the SDT. When the scale coe cient

= 0:512 and N<sub>i</sub> = 0, j<sup>LH</sup> (k) j<sub>p</sub> (k) is close to 1 at

the average of k: [j <sup>LH</sup> (k)j<sub>p</sub> (k)]j<sub>k=hki</sub> = 0:32. The effect that adding a new scattering provides a new spin dephasing channel becomes dom inant and the SDT rst decreases with the inpurity density. This is similar to the e ect of the Coulomb scattering discussed above while the spin-orbit coupling is large. However, with the increase of the inpurity density, p gets smaller and j <sup>LH</sup> (k)j<sub>p</sub> (k) gets smaller again. When N<sub>i</sub> = 0:1N<sub>h</sub>, [j <sup>LH</sup> (k)j<sub>p</sub> (k)]<sub>k=hki</sub> = 0:16, the SDT reaches a minimum . Further increasing the inpurity density, one enters the strong scattering regime ([j <sup>LH</sup> (k)j<sub>p</sub> (k)]<sub>k=hki</sub> = 0:049 1 at N<sub>i</sub> = 1:0N<sub>h</sub>), and the SDT keeps increasing with N<sub>i</sub> in this regime. When the scale coe cient

= 1:024, j (k) jbecom es even larger and the m inim um of the SDT occurs at larger N<sub>i</sub>. The sim ilar is also true for the case of HHs in Fig. 4 (b). It is noted that in reality is around 1 and the SDT will rst decrease then increase with the impurity density. This is totally different from the electron case and also di erent from the prediction of the single-particle approach where the SDT always increases with the impurity density.

We further investigate the impurity density dependence of the SDT at di erent temperatures. Here the scale coe cient is xed to be 1. In Fig. 5 one nds that when the temperature is low, the SDT rst decreases with N<sub>i</sub> as then the total scattering is weak, and then increases with it after the SDT reaches a minimum. When the temperature gets higher, the SDT always increases with N<sub>i</sub> as then j  $j_p$  1 can always be satis ed and the hole-impurity scattering mainly suppresses the inhomm ogeneous broadening.

## E. Hole density dependence of SD T




FIG. 6: SDT vs. the hole density at di erent tem peratures. (a): LHswith a = 5 nm; (b): LHswith a = 7 nm; (c): HHs with a = 5 nm.

Finally we investigate the hole density dependence of the SDT at dierent temperatures and well widthes. Here the hole-in purity scattering is excluded and 1. In Fig. 6 (a) we plot the SDT of LH s as function of the LH density with a = 5 nm. The SDT decreases with the hole density when the tem perature is low but increases with it when the tem perature is high enough. To understand this result, we rst analyze the Rashba term [Eqs. (4-9)]. W hen T = 300 K , one nds  ${}^{6161}_{52}$  E  $_z$  m  $_0 {}^{\frac{hk_z^2 i}{2}}_{\frac{1}{k_z^2 i}}$  changes from 2:58 nm to 1:46 nm when N<sub>h</sub> changes from 5 1010 cm  $^{2}$  to 4  $10^{11}$  cm  $^{2}$ , and the absolute value becomes even larger when T = 100 K. Therefore, it can be seen from Table II that both  $\frac{6161}{53}$  and  $\frac{6161}{54}$  are sm aller than  $\frac{6161}{52}\frac{hk_2^2i}{hk_1^2i}$ , and the linear terms in Eqs. (7) and (8) are dom inant. M oreover, again j<sup>LH</sup> j<sub>p</sub> is slightly sm aller than 1. Sim ilar to the case in Sec. III B when the linear Rashba term is dominant, the hole density  $N_{\rm h}$  in uences the spin dephasing through two competing e ects: E ect I: The increase of the spin dephasing due to the increase of the inhomogeneous broadening with  $N_{\rm h}$  as holes are

populated at higher k-states at high hole density; and

due to the increase of the scattering which provides additional spin dephasing channel. E ect II: The decrease of the spin dephasing due to the counter e ect of the increased scattering which suppresses the inhom ogeneous broadening. The results shown in Fig. 5 (a) indicate that when T 220 K and the total scattering is not so strong, E ect I is more important and the SDT decreases with N<sub>h</sub>. W hen the hole density keeps increasing and the total scattering is further enhanced, E ect II becom esm ore important and the SDT increases with N<sub>h</sub>.

We further plot the SDT of LHswith a = 7 nm in Fig.

6 (b) where the cubic term s become more in portant. For example, when T = 300 K,  $\frac{6161}{52}$ E  $_{z}$ m  $_{0}\frac{hk_{z}^{2}i}{hk_{z}^{2}i}$  changes from 1:06 nm to 0:60 nm when N<sub>h</sub> changes from 5  $10^{10}$  cm  $^{2}$  to 4  $10^{11}$  cm  $^{2}$ . One can see from Table II that the cubic term sweighted by  $\frac{6161}{53}$  are dominant. Sim ilar to the case in Sec. III B, when the cubic Rashba term is dominant, the increase of the inhom ogeneous broadening with hole density ism uch faster than the counter e ect of the scattering and consequently E ect I always surpasses E ect II with the increase of hole density. As expected, one nds that the SD T decreases monotonically with N<sub>h</sub>. The same is true for H H s in F ig. 6 (c) where the Rashba term [Eqs. (4-6)] includes only the cubic one.

## IV. CONCLUSION

In conclusion, we have perform ed a system atic m icroscopic many-body investigation on the hole spin dephasing of p-type G aA s QW s of sm all well width where the HH and LH bands are well separated, by constructing a set of kinetic spin B loch equations based on the nonequilibrium Green function method. We included the magnetic eld, the Rashba spin-orbit coupling and all spin conserving scattering such as the hole-phonon, the holenonm agnetic impurity and the hole-hole scattering. By num erically solving the kinetic equations, we obtained the time evolution of the distribution functions and the spin coherence of holes. The SDT is calculated from the slope of the envelope of the incoherently sum m ed spin coherence. D i ering from earlier studies on spin dephasing based on the single-particle approach which only includes the lowest-order elastic scattering and the anisotropy from j(k) j and + j(k) j this approach takes full account of the inhom ogeneous broadening from dierent k-states of the Rashba term as well as the e ect of all the scattering. Furtherm ore, this approach is valid regardless of the strength of scattering whereas the earlier single-particle approach is valid only when the scattering is strong enough, i.e., j j <sub>p</sub> 1. U sing this m any-body approach, we studied in detail how the hole spin dephasing are a ected by tem perature, the hole-hole Coulom b scattering, the impurity and the hole densities.

W e showed that the spin dephasing is mainly a ected by two e ects: The inhom ogeneous broadening and the scattering. Any e ect that increases the inhom ogeneous broadening tends to reduce the SDT. However, the effect of scattering on the spin dephasing is di erent when 1 and jjp ' 1: W hen jjp 1 and therejjρ fore the scattering is strong in comparison to the DP term, the counter e ect of the scattering to the inhom ogeneous broadening is im portant. In this regime, the scattering tends to drive carriers to a m ore hom ogeneous state in k-space and consequently reduces the inhom ogeneous broadening. This tends to increase the SDT.W hen j j p ' 1, the scattering is weak in comparison to the DP term (inhom ogeneous broadening) and the counter e ect

can be neglected, adding a new scattering provides an additional dephasing channel. In this regime, the counter e ect of the scattering to the inhom ogeneous broadening can be ignored and the scattering reduces the SDT.All the factors, such as temperature, well width, impurity density and hole density, can a ect the inhom ogeneous broadening and the scattering and therefore in uence the SDT.

The temperature a ects the SDT in two ways: On the one hand, the increase of the tem perature drives holes to higher k-states, and leads to a stronger inhom ogeneous broadening. On the other hand, the scattering is enhanced with the increase of the tem perature. W hen the linear Rashba term is dominant, such as LHs with a = 5nm at the hole density in our investigation, it is shown that the SDT decreases with T when the tem perature is low and the impurity density is small. This can be understood as it is in the regime where j<sup>LH</sup> jand 1 = p are comparable and the increase of the spin dephasing due to the increase of the inhom ogeneous broadening and the increase of the spin dephasing channel by the increase of the scattering with tem perature are dom inant. W hen the tem perature keeps increasing so that the scattering becom es stronger or when the im purity density is high, the SDT increases with T when the system enters the regime where j<sup>LH</sup> j<sub>p</sub> 1 and the counter e ect of the scattering to the inhom ogeneous broadening becom es dom inant. W hen the cubic Rashba term is dom inant (such as LHs with a = 7 nm in our investigation) or is the only term (such as HHs), the SDT decreases monotonically with tem perature as the increase of the inhom ogeneous broadening with tem perature is much faster than the increase of scattering. These results are quite di erent from the case of electrons where the spin-orbit coupling is within the regime of weak inhom ogeneous broad-1) and the SDT increases monotonically ening (jjp with tem perature when the linear DP term is dom inant. W e also compared the SDTs predicated by our manybody approach with the results of the earlier sim plied treatment, and showed that the simplied treatment is inadequate in studying the hole spin dephasing.

The hole density also in uences the inhom ogeneous broadening and the scattering simultaneously. Similar to the case of temperature dependence, it is shown that for the LHs with a = 5 nm where the linear Rashba term is dominant, the SDT decreases with N<sub>h</sub> when the temperature is low because it is in the regime of strong inhom ogeneous broadening, and increases with N<sub>h</sub> when the temperature is higher and the inhom ogeneous broadening is weak. For LHs with a = 7 nm or HHs where the cubic Rashba term is the leading/only term, the SDT decreases m onotonically with N<sub>h</sub>.

W e further showed that the C oulom b scattering contributes m arkedly to the SD T .W hen the inhom ogeneous broadening is stronger than the scattering, the C oulom b scattering enhances the spin dephasing. O therw ise, it reduces the spin dephasing. In the earlier single-particle treatm ent, the C oulom b scattering was considered to be unable to cause spin dephasing.

In the calculation, the magnetic eld in the Voigt conguration is taken to be 4 T.W e found that for hole system, the magnetic eld dependence is marginal as the Rashba term is very large. In this investigation, the Elliott-Yafet mechanism<sup>48</sup> is not included. A full microscopic many-body treatment of the this mechanism is much more complicated than the DP mechanism and will be published elsewhere. Up till now there is no experimental investigation on the SDT for holes in (001) QW s. Experiments such as spin-echo measurements<sup>49</sup> and time-resolved Faraday rotation measurements<sup>50</sup> can be used to measure the SDT.

# APPENDIX A : EFFECT OF SCATTER ING TO SDT




FIG.7: Temporal evolution of the incoherently sum m ed spin coherence  $_{\rm L\,H}$  (t) (solid curve) and the coherently sum m ed spin coherence  $_{\rm L\,H}^0$  (t) (D otted curve) without any scattering and the temporal evolution of the incoherently sum m ed spin coherence  $_{\rm L\,H}$  (t) with only hole-im purity scattering with N  $_{\rm i}$  = 0.01N  $_{\rm h}$  (C hained Curve).

In Sec. III B we pointed out that when the scattering is weak in comparison to the DP e ective eld (inhom ogeneous broadening), the main e ect of scattering is to add an additional dephasing channel. Therefore the scattering here reduces the SDT. To dem onstrate this e ect, we now study the spin dephasing in the limiting case of no scattering included in the calculation. In Fig. 7 we show the tem poral evolution of the incoherently sum m ed spin coherence  $_{LH} = \int_{k} j_{kLH}$  (t) j for LHs with total LH density  $N_h = 4$   $10^{11}$  cm<sup>-2</sup> and T = 300 K. The coherently sum m ed spin coherence  ${}^{0}_{LH} = j_{k} k_{LH}$  (t) jis also plotted for com parison. One can see that the am plitude of <sup>0</sup><sub>LH</sub> oscillates and decays to zero very quickly due to the interference caused by the momentum dependence of the DP term . However, the incoherently summed spin coherence LH does not decay, which means that there is no irreversible dephasing.<sup>16,42,44</sup> This is consistent to the fact of no scattering as there is no dissipation process here. By adding a scattering, one introduces the dissipation into the system which causes an irreversible dephasing. This can be seen in the same gure where the incoherently sum m ed spin coherence LH is plotted with the impurity density N  $_{\rm i}$  = 0:01N  $_{\rm h}$ . One nds that the

LH now decays with time, although much slower than the one in Fig. 1 where all the scattering is included.

# APPENDIX B:A SIM PLIFIED ANALYTICAL ANALYSIS OF SDT

In Sec. III B we pointed out that the ratio of the DP term to the scattering rate determ ines the way how the scattering a ects the spin dephasing. To reveal part of this e ect analytically, we now study a much simpli ed case with only the hole-in purity scattering and the dom - inant part of the DP term, i.e., for LH s we include only the linear Rashba term weighted by  $\frac{6161}{52}$  and for HH s only the cubic Rashba term weighted by  $\frac{7h7h}{54}$ . Furtherm ore, we will also neglect the inhom ogeneous broadening later.

First we consider the H H case. We expand 2 2 density matrix  $_{\rm kH\,H}$  as follows:

In order to nd the solution, we multiply = (x; y; z) to both sides of this equation and calculate the trace. By de ning the HH \spin" vector to be Tr(HH; 1) (k)  $S_{HH; 1}$  (k), one can rewrite Eq. (B9) into

One nds that  $S_{HH;1}(k)$  is only related to  $S_{HH;1}_{3}(k)$ . By considering the lowest orders with l = 0, and 3 and de ning  $S_{H H}$  (k) =  $(S_{H H}; {}_{3}$  (k); $S_{H H};_{0}$  (k); $S_{H H};_{3}$  (k))<sup>T</sup>, Eq. (B10) can be written as:

In Eq. (B14) we have used the relations  $U_3^2$  (k) =  $U_3^2$  (k) and  $U_0^2$  (k) = 0.

Now one can solve Eq. (B12) analytically. To reveal the main characteristic analytically, we make the assumption that the spin relaxation/dephasing occurs mainly around the Ferm i surface and  $k_f = 0$ . By doing so, one throws away the interference between di erent k-states [except for the states with  $k_f (= 0 \text{ here})$ , and  $k_f = 2$  =3], and therefore the inhom ogeneous broadening. Then the H H spin  $S_{H H}$  ( $S_{H H;l}^x$ ; $S_{H H;l}^y$ ; $S_{H H;l}^z$ ) has the form : l = 3;0;3

in which  $\mathbf{x} = \frac{U_3^2 (\mathbf{k}_f)^p \overline{2}}{\frac{7h^{7h} E_z k_f^3}{54^{17h} E_z k_f^3}}$  is proportional to the ratio of the

scattering rate to the DP term,  $t_1 = \frac{54P_D E_z k_f^3}{2} t$  and  $S_0$  represents the initial spin polarization along the z-axis. One can see from Eq. (B16) that when x < 4, the SDT is proportional to 1=x and decreases with x, whereas when x > 4, the SDT is proportional to 1=( $x = \frac{x^2}{x^2} = 16$ ) and increases with x. This result indicates that the scattering reduces the SDT when the scattering is weak in comparison to the DP e ective eld but increases the SDT when the scattering is no scattering is strong in comparison to the DP e ective eld. M oreover, when  $U_3 = 0$ , i.e., there is no scattering. This is consistent with the num erical result presented in Appendix A.

Similarly one can derive the equation for spin of LHs  $S_{LH}$  with only the linear part of the Rashba term included. One gets the same equations Eqs. (B15-B17) but with  $x = \frac{U_1^2 (k_f)^p \overline{2}}{\frac{6161_E}{52} \ln k_z^2 i k_f}$  and  $t_1 = \frac{\frac{6161_E}{52} \ln k_z^2 i k_f}{p} t$ .

These results coincide qualitatively with the results shown in Fig. 4: The SDT rst decreases then increases with the hole-in purity scattering when the spin-orbit coupling is strong; but increases m onotonically with the scattering when the spin-orbit coupling is weak. Furthermore, by making the approximation that the hole-phonon scattering is also an elastic scattering and by including the hole-phonon scattering in the scattering term,  $U_q^2$  in Eq. (B8) can be modiled as:

is the hole-phonon interaction m atrix element, and N  $_{\rm q}$  = l=[exp( $_{\rm LO}$ =k\_B T) 1] is the B ose distribution of the LO phonon. Then the results also coincide qualitatively with those in Fig.5(b): the SD T rst decreases then increases with the hole-impurity scattering when the total scattering is weak, but always increases with scattering when the total scattering is strong. Finally we point out that as we do not include the inhom ogeneous broadening and all the scattering in this simplied model, many other features predicted in the text cannot be obtained here.
