W atanabe and Hu Reply: In a recent Letter [1], W atanabe, Yukawa, Ito, and Hu (W Y IH) proposed the idea of superscaling for percolation on rectangular domains and used num erical data near the e ective critical density $^0_{\rm c}$ to support such idea. In [2], Pruessner and Moloney (PM) pointed out som e problem s in [1]. Most of these problems are caused by the di erences in using ⁰ or the bulk critical density _c in the analysis. Figure 2 of [1] shows clearly that at $= _{c}$ the existence probabilities E_p for di erent aspect ratios R are di erent [3]. Thus it is natural that we consider a horizontal line at $E_p = 0.5$ in Fig. 2(a) to de ne the e ective critical density ⁰_c for curves with dierent aspect ratios R and using data near 0_c to study superscaling shown in Fig. 4 of [1]. P lease note that at $^0_{c}$, the correlation length is of the order of vertical linear dimension L.By considering E $_{\rm p}$ near $\frac{0}{c}$ rather than near c, we will not have the problem s m entioned at the second and the third paragraphs of [2]. To avoid the confusion, in the abstract and the rst paragraph of [1] we should replace \deviation from the critical point "by \deviation from the e ective critical point $^{0}_{c}$, "; we should also replace the term \the critical point" below Eq. (1) and $\ _{\rm c}$ " of Eq. (2) by \the e ective critical point $^{0}_{c}$ " and $\setminus ^{0}_{c}$ ", respectively.

The value of b in Eq. (10) of [1] was determ ined by PM to be 3=8 ($y_t=2$) based on P (L;R;) = P (RL;R⁻¹;), while W Y IH obtained b = 0.05. This discrepancy is caused by di erences in de nitions of percolating clusters. PM used only the largest cluster to de ne the percolation probability P and thus obtained P (L;R;) = P (RL;R⁻¹;). W Y IH used all clusters extending from the top to the bottom of the system to de ne P and have P (L;R;) P (RL;R⁻¹;). for R > 1. Besides, W Y IH used the e ective critical density $_{c}^{0}$ in Fig. 7 of [1] to determ ine b = 0.05, while PM did not used $_{c}^{0}$. To avoid the confusion, we should also use the e ective critical density rather than the critical density to de net in Eq. (10) of [1] as in the case of Fig. 7.

Since a horizontal line at $E_p = E_p(L;0;1)$ in Fig. 2 of [1] has been used to de ned $_c^0$, Fig. 2 indicates that $_c^0$ depends on L and R and $\lim_{L \downarrow 1} E_p(L; _c^0 c; R)$ $E_p(L;0;R) \in 0$ for $R \in 1$. Thus PM correctly pointed out that the di erence between using $_c^0$ and $_c$ does not vanish in the lim it L ! 1 for $R \in 1$. For this reason, we should replace \correct for nite-size e ects" above Eq. (9) in [1] by \study superscaling behavior".




FIG.1: The mapping functions f in Eq. (1), which are nonlinear for R > 1. The inset shows how to obtain f from E_p . The solid circles are the elective critical points c_{e}° .

The meaning of the nonlinear scaling variable questioned by PM can be understood from the mapping function f() de ned by $E_p(L; ;R) = E_p(L;f();1)$, with f determined numerically and plotted in Fig. 1 which shows nonlinear dependence on for R > 1 and is consistent with Fig. 6 and Table I of [1]. Finite-size scaling in plies $E_p(L;f();1)$ F ((f() $_c)L^{y_t}$); com – bining this with the expansion of f() at $_c^0$ up to the linear term with (@f=@) $_{c}^{\circ}$ R^a gives $E_p(L;;R)$ F (($_c^0)L^{y_t}R^a$), which shows superscaling of E_p with scaling variable $x = (_c^\circ)L^{y_t}R^a$ and $_c^0$ (instead of $_c$) enters x naturally. We nd that \ln (@f=@) $_{c}^{\circ}$ increases

linearly with $\ln R$ with a well de ned exponent a = 0:14[4] which is consistent with that obtained in [1]. Sim ilar calculations of the m apping functions of the percolation probability give the exponent b = 0:05 [4] which is also consistent with that in [1].

Scaling can be considered as \data collapse" for critical system s with di erent sizes [5]. W e found very good data collapse for system s with di erent aspect ratios in [1]. It is appropriate to call such results \superscaling".
