M agnetic relaxation studies on a single-m olecule m agnet by tim e-resolved inelastic neutron scattering

T in e-resolved inelastic neutron scattering measurements on an array of single-crystals of the single-molecule magnet $M n_{12}$ as are presented. The data facilitate a spectroscopic investigation of the slow relaxation of the magnetization in this compound in the time domain.

A detailed understanding of the m agnetic relaxation in sm allm agnetic particles is of fundam ental im portance for their application. The discovery of m agnetic bistability at the m olecular level in polym etallic clusters such as M n₁₂ ac, the so-called single-m olecule m agnets (SM M s), has opened new possibilities.¹ The slow relaxation of the m agnetization in SM M s below a blocking temperature T_B is associated with a large ground-state spin S and easy-axis anisotropy D M² (S and M are the total spin and m agnetic quantum num bers, and D < 0). The 2S + 1 levels of the spin ground state are thus split, as indicated in F ig. 2a, producing an energy barrier of height

DS² separating the up and down orientations of the spin (for M n_{12} ac, S = 10, = 67 K, T B 3.5 K).¹

The relaxation behavior of SM M s has been studied by various techniques, such as magnetization m easurements, nuclear magnetic resonance, and frequency-domain electron spin resonance.^{1,2} In this work are presented timeresolved inelastic neutron scattering (INS) measurements on an array of single-crystals of M n_{12} ac. T in e-resolved INS has been applied previously to the study of rotational tunneling phenomena³. It is shown here that this approach, due to recent in provements in INS spectrom - etry, can be applied to the study of magnetic relaxation.




FIG.1: (a) Schematic of an alum inium platelet. The black bars depict M n_{12} ac crystals positioned in the grooves, such that the anisotropy axes z (= needle axes) are oriented along the grooves. (b) Photograph of the alum inium box containing the platelets lled with M n_{12} ac crystals.

Needle-shaped single crystals of non-deuterated $[M n_{12}O_{12} (CH_3COO)_{16} (H_2O)_4]$, $M n_{12}ac$, with approximate dimensions 5 0.5 0.5 mm³ and mass ca. 2 mg were obtained following literature procedures.⁴ $M n_{12}ac$ crystallizes in the space group I4; the magnetic anisotropy axis z is coincident with the needle axis. This permitted the construction of a sample consisting of an array of many (ca. 500) single crystals, aligned in grooves (dimensions: 13 0.6 0.6 mm³, 16 groovesper platelet) milled into 1 mm thick 15 15 mm² aluminium platelets (Fig. 1a). A total of 15 platelets were stacked in an aluminium container (Fig. 1b), and sealed under He with an indium seal and aluminium screws.

Inelastic neutron scattering (INS) measurements were performed on the time-of-ight spectrometer IN5 at the

Institut Laue-Langevin in G renoble, France. The sample was inserted into an orange ${}^{4}\text{He}$ cryostat equipped with a 2.5 T vertical- eld magnet. The sample was aligned with the z axes of the crystals parallel to the magnetic eld. The eld was changed at the maximum ramp rate provided by the power supply (4 m T/s for elds above ca. 0.2 T, but signi cantly slower for lower elds). An initial neutron wavelength of 5.9 A was used, a ording a resolution of 60 eV at the elastic line. In this energy range, the background of alum inum is negligible. The data were corrected for detector e ciency using a vanadium standard. The spectra shown below correspond to the sum over all the scattering angles.




FIG.2: (a-c) Schem atics showing the transitions observed for (a) B = 0, (b) 0 < B = 0.5 T, and (c) B > 0.5 T. Transitions I and I_{+} are indicated by arrows. Circles symbolize the populations of the M = 10 and M = +10 levels. (d) 1.5 K neutron-energy-loss spectra for the magnetic elds indicated. Curves are o set for clarity.

In the following the dependence of the M n_{12} ac IN S spectrum on a magnetic eld B applied parallel to the z axis shall rst be discussed. M easurements were made by rst cooling the sample in zero eld from 5 K, i.e., above the blocking temperature, to 1.5 K. A coordingly, the lowest levels on both sides of the double-well potential, i.e., the M = 10 levels, were equally populated, see Fig. 2a (the population densities of the M = 10 levels are denoted as n). The eld was then increased stepwise. The resulting spectra are shown in Fig. 2d. The zero-eld spectrum shows the known peak at E $_0$ =124 m eV, corre-

9 (I) and sponding to the two transitions M = 10! $M = +10! + 9 (I_{+})^{5,6}$ as indicated in Fig. 2a. Increasing the eld leads to a tilting of the double-wellpotential due to the Zeem an energy, see Fig. 2b. The energies of the two transitions I and I_{+} are now di erent, they appear at $E = E_0 + g_B B$ and $E_+ = E_0 g_B B$, respectively (g = 2:0, $_{\rm B}$ is the Bohrmagneton). The experim ental data for B 0.5 T indeed exhibit two peaks at exactly E and E_+ , see Fig. 2d. Note that for the elds used here the level M = +10 lies considerably above the ground state, e.g., $20g_B B = 0.93 \text{ meV}$ at 0.4 T, and would thus normally be depopulated. The observation of both transitions I and I_+ thus directly relects the slow relaxation of the magnetization in M $n_{12}acat 1.5~K$, which perm its the metastable state with the M = +10level populated. For B > 0.5 T, however, the system com pletely relaxed back to the ground state due to the crossing of the M = +10 and M = 9 levels (Fig. 2c). Accordingly, only the I peak was observed in this eld range. Interestingly, the linew idths are resolution lim ited, indicating an alignment of the crystals within 5. This is possibly because of a self alignment of the crystals due to the torque exerted by an applied magnetic ed.

The above experiments clearly show i) that for B 0.5 T it is possible to create a metastable situation of the populations and ii) that for B > 0 the populations of the M = +10 and M = 10 levels can be measured individually via the intensities of the transitions I and I₊ appearing at dimensities of the transitions I and I₊ appearing at dimensities of the magnetic relaxation in M n₁₂ ac as follows: First, only the M = +10 level was populated by applying a negative eld of -0.85 T. Then, the eld was swept quickly to a positive value B > 0 0.5 T, so that all molecules were in the now higher lying M = +10 level. This triggered the relaxation of the system tow and s




FIG.3: (a) Neutron energy-loss spectra at 2.65 K as measured with the s&g protocol (see text). Curves are o set for clarity. (b) T in e dependence of the norm alized intensities of the transitions I (squares) and I₊ (circles). Solid curves correspond to a t to an exponential decay with a relaxation time as indicated. (c) A mhenius plot for the relaxation times. Circles are experimental points, the line is a t to the A mhenius law = $_{0}e^{E_{a}=(k_{B}T)}$ with parameters as indicated.

the M = 10 level, which was followed by repeated IN S m easurements (a run time of t = 5 m in already gave reasonable spectra; typically, however, t = 30 m in was chosen). In M n₁₂ac the relaxation time is some years at 1.5 K, and a few seconds at the blocking temperature. Thus, through varying the temperature, the relaxation time could be tuned such that time slices of t = 5-30 m in allowed reasonable time resolution. Speci cally, time-resolved INS spectra were recorded for T = 2.45, 2.65, and 2.70 K with B = 0.4 T (data not shown). At B = 0.4 T, the I and I₊ transitions appear at transfer energies of E = 1.29 m eV and E₊ = 1.19 m eV, respectively, see Fig. 2d.

A more re ned measurement protocol, denoted stopand-go (s& g), allow s for an im provem ent over the above constant-T protocol. Here, the tem perature is set to a value T much lower than the tem perature T at which the relaxation is to be studied, such as to essentially freeze the system . A fter initialization steps as above (but at T), the relaxation is followed by repeatedly setting the tem perature to the target tem perature T, waiting for a time t, cooling back to T , and measuring for a time t. Since the relaxation time at T is much longer than at T, this amounts to taking snapshots of the population distribution at intervals of t. The possibility of freezing a state during recovery to equilibrium thus perm its both short time intervals and reasonable acquisition times. The time-resolved INS spectrum was recorded with the s&g protocolat T = 2.65 K with t = 2 min, see Fig. 3a (B = 0.4 T, T = 2.3 K, t = 30 m in; an anim ated movie is provided in the supporting material).

The experimental data clearly allow one to follow the relaxation of the populations of the M = 10 levels. The time dependence of the peak intensities were ana-




FIG. 4: IN S spectra after 2 m in and long waiting times recorded at 2.65 K using the s&g protocol. Solid lines are best-t curves, for details see the text.

lyzed quantitatively by thing the data at each time step to two Gaussians with a constant o set. In the ts, the linew idths of the Gaussians were xed to the spectrom eter resolution. The values obtained for the peak intensities were then normalized such as to add up to 1 on average. The result is shown in Fig. 3b. The time dependence of the peak intensities, or populations n and n_{+} , respectively, are well described by an exponential decay, n (t) = exp(t=) and n_+ (t) = 1 n (t), as dem onstrated by the solid lines in Fig. 3b. For the current experim ents, the population was not inverted com pletely after the initialization step, i.e., about 15% of the m olecules remained in the ground state (this is evident from the 0 m in curve in Fig. 3a, which shows small intensity also at 1.29 m eV). This is attributed to the slow ram p rates provided by the magnet power supply near zero eld.

The relaxation times obtained from the exponential decay tswere 8.1 (2) m in for the s& g experiment at 2.65 K, and 74 (2), 10.6 (7), and 6.0 (5) m in for the constant-T experiments at 2.45, 2.65, and 2.70 K, respectively. The relaxation times obtained by the s& g and constant-T protocols at 2.65 K are in good agreement. Plotting the relaxation time as a function of the inverse temperature (A mhenius plot, F ig. 3c), reveals a them ally activated behavior consistent with therm ally-assisted tunneling of M n₁₂ ac in this temperature range.¹ The activation energy $E_a = 70$ (2) K, thus determined, is slightly larger than the zero- eld value of 62 K.¹ Zero- eld relaxation m easurements on SM M s generally yield $E_a <$, which has been explained by e cient tunneling paths near the top of the barrier.¹ In the present case, how ever, the Zeem an energy rem oves these paths increasing E_a .

The data, allowing also for a time-resolved investigation of the peak positions, revealed an interesting e ect. A fter initialization, both peaks were shifted slightly towards the center E₀ as compared to their equilibrium positions $E = E_0 g_B B$. The shifts were small, about 8 eV, but statistically signi cant. This is illustrated by the s&g-INS spectra of Fig. 3a at 2 m in and after long waiting times, presented in more detail in Fig. 4. The two solid lines which t the data well correspond to best-t curves, where both intensities and positions were tted. The third curve, which approximates the 2 m in data with less accuracy, was obtained from a t but with the transfer energies xed to the equilibrium values. The shift of the I peak at ca. 1.29 m eV tow ards low erenergies is clearly visible. The observations m ay be described in term s of a time-dependent e ective m agnetic eld B (t) = B_{eq} B (t), which diers from the eld at equilibrium B_{eq} . The experiments yield B (0) 70 m T . As a function of time, the peak positions approached their equilibrium values, but the limited statistics of the data did not allow a precise determ ination of the relaxation law. The e ect described has been observed in all m easurements with similar values for B (0). It might seem natural to associate B (t) with the magnetization М = В H (in units of T). However, for needles the depolarization factor N = 1 and the essentially cubic arrangem ent of the M n₁₂ ac m olecules in the crystals m eans that the localm agnetic eld is equal to the externalm agnetic eld. Further studies are necessary to elucidate the details of this phenom enon.

In conclusion, we have demonstrated that with highperform ance tim e-of- ight spectrom eters, such as \mathbb{N} 5 at the ILL, the magnetic relaxation processes in magnetic compounds can be studied with tim e-resolved \mathbb{N} S m easurem ents. We believe that the spectroscopic resolution provided by this methodology will allow unprecedented insights into the physics of magnetic relaxation.
