We analytically investigate the spatial coherence properties of the signal emission from onedimensional optical parametric oscillators. Because of the reduced dimensionality, quantum uctuations are able to destroy the long-range phase coherence even far above threshold. The spatial decay of coherence is exponential and, for realistic parameters of sem iconductor photonic wires in the strong exciton-photon coupling regime, it is predicted to occur on an experimentally accessible length scale.

### I. IN TRODUCTION

A central concept in the theory of nonlinear dynam ical system s is the so-called pattern form ation phenom enon, where a spatially ordered structure appears in an otherwise hom ogeneous system when this is driven far from them odynam ical equilibrium<sup>1</sup>. Very important examples of pattern form ation are found in the transverse dynam ics of nonlinear optical system  $s^{2,3}$ , e.g. lasers, bistable devices, as well as planar optical parametric os-cillators (OPO s).

In OPOs, the pattern form ation phenom enon manifests itself as the appearance of two additional coherent beam s, called the signal and the idler, originating from nonlinear conversion of the pump beam when its intensity is brought beyond a threshold value<sup>4</sup>. An interesting point of view on OPO operation is provided by the analogy with the Bose-E instein condensation phenom enon of equilibrium statistical mechanics<sup>5</sup>: as it happens for the matter Bose eld in the condensate mode when the tem perature is low ered below the condensation tem perature, the population of the signal/idlerm odes becom esm acroscopic above the threshold and the eld becom es coherent. Although many aspects of the OPO operation are successfully interpreted in terms of concepts of equilibrium statistical mechanics<sup>6,7</sup>, care has to be paid as a non-equilibrium steady state is fundam entally di erent from a therm odynam ical equilibrium state: it is in fact determined by a dynamical equilibrium between externaldriving and dissipation and does not follow a simple therm alBoltzm ann law<sup>8,9</sup>.

At equilibrium, it is well known that long-wavelength uctuations of both therm al and quantum origin can destroy long-range phase coherence in reduced dimensionality Bose systems, thus replacing true Bose-E instein condensates with quasi-condensates<sup>5,10,11</sup>. First studies for the non-equilibrium case have been recently published in an optical context<sup>7,12,13</sup> pointing out several analogies with the equilibrium case, but the peculiarities of the non-equilibrium case have not been fully appreciated yet nor experimentally investigated.

The aim of the present paper is to obtain analyticalpredictions for the long-range coherence properties of the param etric em ission from one-dimensional photonic wires. A lthough the theory that we develop for reduceddimensionality e ects in non-equilibrium systems is a general one and can be extended to a large class of physical systems showing non-equilibrium phase transitions and pattern formation, our attention will be focussed on a speci c example of solid-state system in which the effects we predict are experimentally accessible with the current sem iconductor technology.

## II. THE PHYSICAL SYSTEM

We consider planar sem iconductorm icrocavities in the strong-coupling regim  $e^{14,15}$ , a system in which OPO operation has been recently observed<sup>16,17</sup>. The extrem ely large value of the excitonic nonlinearity is responsible for the ultra-low OPO threshold of these systems, which suggests an enhanced role of quantum uctuations. By nanostructuring planar cavities, reduced dimensionality photonic wires can be obtained without spoiling the strong-coupling condition, nor the possibility of OPO operation<sup>18</sup>. All these facts make these systems an ideal candidate for the study of quantum elects on pattern form ation in non-equilibrium systems, in particular low-dimensional ones.




FIG.1: (a) Sketch of a sem iconductor photonic wire with an embedded quantum well (QW). Con nement in the z;y directions is provided by respectively a pair of D istributed Bragg Re ectors (DBR) and a lateral etching of the cavity. (b) Linear regime dispersions of signal, pump and idler subbands and sketch of the parametric process under examination. (c) Exciton density in the pump and signal modes as a function of the pump laser intensity for a given  $\sim$ !<sub>p</sub> = 1:398725 eV. Full (dashed) lines represent linearly stable (unstable) solutions. Cavity parameters inspired by Ref.18:  $\sim$ !<sub>c</sub><sup>o</sup> =  $\sim$ !<sub>x</sub><sup>o</sup> = 1:4eV, k<sub>z</sub> = 20 m<sup>-1</sup>,  $\sim$  R = 2:5 meV, Ly = 4 m,  $\sim$ g = 5 10 <sup>6</sup>eV m<sup>2</sup> and  $\sim$  <sub>stpti</sub> = 0:15 meV.

A schem atic plot of a photonic wire is given in Fig.1a: light is conned in the growth z direction and in the transverse y direction by respectively the DBR mirrors and the lateral etching of the structure. On the other hand, it is free to propagate along the longitudinal x direction. The photonic states are then classified<sup>18</sup> by the longitudinal wave vector k, the subband index j and the polarization index = fk;? g, and can be used as a basis over which to expand the (vectorial) electric eld operator:

The polarization and spatial prole of the mode  $E_{kj}$  (y;z) depends on the details of the specic structure and has to be computed by solving M axwell's equations for the specic geometry under consideration. Generally,

it will show a non-trivial spatial and polarization structure<sup>19</sup>. As a function of the longitudinal wavevectork the dispersion of the j subband is approximately given<sup>18</sup> by

where  $k_{y;j}$  and  $k_{z;j}$  are the quantized photon wavevectors in respectively the y and z directions.

The strong dipole coupling between cavity photons and the quantum well exciton results in a Rabi frequency  $_{\rm R}$  larger than the damping rates so that the eigenm odes of the system at linear regime are polaritons, i.e. coherent superpositions of cavity-photonic and excitonic modes. C om pared to the photonic one (2), the dispersion of the exciton is negligible, so that the excitonic response can be safely considered as being local. As a consequence, each photonic subband only m ixes with the excitonic state of wavefunction  $E_{\rm kj}$  (y; z =  $z_{\rm QW}$ ),  $z_{\rm QW}$  being the position of the quantum well<sup>31</sup>.

An example of the polaritonic dispersion  $"_{j}(k)$  of the three lowest s;p;i subbands is plotted in Fig.lb for realistic experimental parameters. For each subband, only a single polarization state is considered here: as experimentally shown in Ref. 18, the splitting between the

= k;? polarization states in photonic wires is in fact large enough for the parametric process to select a single polarization state, while the other one can be safely neglected.

Polaritons are injected into the cavity by means of a coherent and monochrom atic pump laser incident on the cavity at a frequency  $!_L$  close to resonance with the central p subband. In order to exclusively inject k = 0 polaritons into the p subband, the laser eld amplitude has

to be constant along the x direction and to have a negligible overlap in the y direction with all subbands but for the p one. A possible choice to full lboth conditions, is to use a wide laser beam incident on the sample along the yz plane at an angle chosen in such a way to m atch the quantized  $k_v$  wavevector of the p subband.

Because of the nonlinearity due to exciton-exciton interactions within the quantum well, two pump polaritons in the p subband are then parametrically converted into one signal polariton in the s subband and one idler polariton in the i subband.

# III. THE THEORETICAL MODEL

As discussed in detail in Ref.7, a simple, yet quantitative description of the dynam ics of the polariton quantum eld in a microcavity is based on a Wigner representation of the quantum elds in terms of classical, yet stochastic C -num ber polariton elds. As the parametric dynamics is concentrated in the three s;p;i subbands, it is useful to project the polariton eld onto these modes, so to restrict our analysis to three one-dimensional polaritonic elds  $_{s,p;i}(x)$ . Within the Wigner framework<sup>32</sup>, the time-evolution of the elds  $_{s,p;i}(x)$  is described by stochastic di erential equations, whose form in Fourier space is:

A s discussed in the previous section, the incident laser coherently drives the pump subband p with an am plitude  $F_L$ . The damping rates  $_j(k)$  accounts for radiative and non-radiative losses of both the excitonic and photonic components of the polaritons. In the region of interest<sup>33</sup>, they have a weak dependence on k. In agreement with the uctuation-dissipation theorem<sup>20</sup>, damping is intimately connected to quantum uctuations. These show up in the W igner form alism as G aussian, com plex-valued, white noise term s dW  $_j(k;t)$  satisfying

Expectation values of sym m etrically-ordered observables are then obtained as averages of the corresponding C – num ber quantity over the noise dW  $_{\rm j}$  (x;t).

The nonlinear coupling responsible for the param etric process comes from the collisional exciton-exciton interactions in the quantum well. All other nonlinear processes are in fact much weaker and do not contribute in a signi cant way to the dynam ics of the system . At the simplest level, exciton-exciton collisional interactions can be modelled by a polarization-independent, repulsive contact potential with strength  $g > 0^{14,15}$ .

Under the hypothesis that the polaritonic dynamics is restricted to the s;p;i subbands of the lower polariton, the mean-eld polariton-polariton interaction energy can be written as

where the overlap integrals of the excitonic component of the transverse wave functions of the dierent subbands are de ned as:

The transverse excitonic wavefunctions  $\substack{j \\ X?}$  (y) are proportional to  $E_{kj}$  (y;z =  $z_{QW}$ ) and normalized to the excitonic Hop eld weight of the subband:

For the sake of notational simplicity, we have not explicitely indicated the k-dependence of the transverse wavefunction  $j_{X?}(y)$ : given the small range of wavevectors k involved in the parametric emission (of the order of the inverse coherence length  $1=1_{c}$ ), it can be safely neglected in the following.

The generalization of (7) to the case of spin-dependent exciton-exciton interactions is straightforward: in this case, the scalar coupling constant g has to the replaced by a four-indices tensor<sup>21,22</sup> which is to be contracted with the four (vectorial) excitonic wavefunctions  $j_{\chi_2}^{j}$  (y).

# IV. MEAN-FIELD

The mean-eld solution of the motion equations (3) once the noise term s are neglected has the simple plane wave structure:

At low pump intensities, a stable solution with a nite density in the pump mode only (i.e.  ${}_{\rm s}^{\circ} = {}_{\rm i}^{\circ} = 0$ ) exists. The wavevector  $k_{\rm p} = 0$ , as well as the frequency  $!_{\rm p} = !_{\rm L}$  are xed by the external laser; in particular, we have chosen  $!_{\rm L}$  to be just below the bottom of the p subband so as to avoid com plicated pump bistability e ects<sup>23,24,25</sup>. For increasing pump powers, this solution eventually becomes dynam ically unstable above some threshold, and is replaced by a new solution with - nite signal and idler intensities  ${}_{\rm s,i}^{\circ}$ . The pump frequency and wavevector rem ain the same  $!_{\rm p} = !_{\rm L}$  and  $k_{\rm p} = 0$ ,

while many values are possible for the signal/idler frequencies  $!_{s;i}$  and wavevectors  $k_{s;i}$ , with the only constraint that  $!_i = 2!_L$  $!_{s}$  and  $k_{i} = k_{s}$  and that the solution is dynam ically stable. This latter condition denes a band<sup>1</sup> of stable  $k_s$  values and for each of them, the densities ost in ply obtained by substituting the ansatz (9) into the determ inistic part of the motion equation (3). W hile the phase  $_{p}$  of the pump eld is xed by the one of the incident laser, the signal and idler ones  $_{\rm s;i}$  rem ain free, with only a constraint on their sum  $_{\rm s}$  +  $_{\rm i}$ . The phase rotation s;i ! s;i is in fact a symmetry of the problem, a U (1) sym m etry w hich is spontaneously broken<sup>26</sup> above the parametric threshold by the solution (9).

The results for the signal, pump, and idler densities  $_{s,p;i}^{\circ}$  are plotted in Fig.1c as a function of the pump laser intensity  $I_{\rm L}=f_{\rm L}f$  for the speci c case of a signal wavevector  $k_{\rm s}=0$ , which is the rst to become unstable for the chosen parameters. The results would however be qualitatively similar if a nite  $k_{\rm s} \in 0$  was taken. The signal/idler densities  $_{s,i}^{\circ}$  continuously grow from zero starting from the lower threshold, get to their maximum value, and then go back to zero at the upper threshold, where we are back to a pump-only mean-eld solution  $_{\rm s}^{\circ}= _{\rm i}^{\circ}=0^{24,25}$ .

#### V. BOGOLIUBOV THEORY

The simplest way to include the e ect of noise term s is to linearize the W igner equation (3) around the meaneld solution (9) and treat the noise as a perturbation. This is best done using the same ansatz:

as in the generalized density-phase Bogoliubov theory developed for the study of quasi-condensates at equilibrium  $^{10,11}$ . This approach does not require the existence of long-distance coherence, but only that density uctuations are small j jj  $^{\circ}_{j}$ , and the signal and idler phases are well de ned and locally locked by the parametric process  $p_{p}$  s ij 1.

Simple Ito manipulations of (3), lead to the linearized motion equation for the uctuations in frequency space:

The index m takes here the values 1;2;3 corresponding respectively to the subbands s;p;i. The complex-valued noise 6-vector is analogously de ned as  $W(k;!) = [W(k;!); w(k; !)^{T}]$ , and is such that




FIG. 2: Im aginary (a) and real (b) parts of the Bogoliubov excitation spectrum around the mean eld steady-state. Solid line indicates the Goldstone branch. Pum p-intensity as at the dotted line in Fig.1b. Same cavity parameters as in Fig.1.

The eigenvalues of the L (k) matrix give the excitation spectrum (k) of our system around the mean-eld steady-state solution. An example of such a spectrum is plotted in Fig.2. Dynamical stability of the meaneld solution requires that for all branches Im [(k)] < 0for all values of k. As the mean-eld solution (9) spontaneously breaks the U (1) signal/idler phase symmetry of the motion equation (3), a Goldstone s;i s;i branch is necessarily present. For clarity, it will be denoted in the following by the index = G. Its main property is that its dispersion  $_{G}(k)$  at k = 0 is exactly  $_{\rm G}$  (k = 0) = 0<sup>1</sup>. The behavior of this eigenvalue  $_{\rm G}$  (k) in the neighborhood of k = 0 is crucial for the long-distance properties of our system . D ynam ical stability and analyticity  $^{1,27}$  argum ents guarantee that for k ! 0 one can expand

with a strictly positive coe cient a > 0: di erently from zero-sound in equilibrium Bose gases, the Goldstone mode is here a di usive, non-propagating mode<sup>26,28</sup>.

Note that this result, being based on symmetry arguments, does not depend on the restriction of our model to a single polarization state per subband. Explicite inclusion of all polarization states would simply increase the dimension of L to 12 12. More Bogoliubov branches would then appear in g.2 but no signi cant changes would a ect the nature nor the dispersion relation of the Goldstone mode, which (as we shall see in the next section) is the only responsible for the long-distance coherence properties of the em ission.

### VI. FIRST ORDER CORRELATION FUNCTION

The rst-order spatial coherence of the parametric em ission is determ ined by the spatial coherence of the incavity polaritons<sup>7,29</sup> (added ref. to baas). In the W igner representation, this can be written for  $x_1 \in x_2$  as:

N eglecting in (10) the density uctuations  $_{j}$  which do not contribute to long-distance properties, and expanding higher order correlations by m eans of the W ick theorem for G aussian stochastic variables<sup>20</sup>, one obtains:

The vector P is de ned as  $P = (1;0;0; 1;0;0)^T$  and the matrices B (k) are the projectors on the eigenspace corresponding to the eigenvalue (k). The frequency integral in (18) can then be performed closing the integration contour in the complex plane:

A s usual, the large distance properties are determ ined by the k 0 region, and the dom inant contribution comes from the Goldstone mode, that is for = = G. A simple analytical expression can be obtained by keeping only thism ode, then approxim ating the sm ooth function  $_{GG}$  (k) with its k = 0 value  $_{GG}^{\circ}$  (of the order of the




FIG. 3: Analytical prediction (22) (solid) and QMC data (circles) for the coherence length as a function of the pump power. Same cavity parameters as in Fig.1.

In Fig.3, c is plotted as a function of the pump power. Its behaviour closely follows the one of the signal density s so that c goes to 0 at the edges of the OPO region, and has its maximum in the middle. This prediction can be compared to the num erical results of a full M onte C arb simulation of the W igner equation as reported in R ef.7. The agreement is good and the small quantitative discrepancy is mostly due to the three-mode expansion performed here, which does not take into account the upper polariton.

For a given value of the mean-eld interaction energy g<sub>j</sub> and all detuning and cavity parameters kept xed, the coherence length has the remarkable scaling c/1=g. The extremely high value of the excitonic nonlinearity in plies that the e ect of quantum uctuations is strongly enhanced as compared to OPOs based on conventional nonlinear optical media<sup>6,12,25,30</sup>. In particular, one can observe in Fig.3 that the predicted coherence length is of the order of hundred microns for realistic experimental parameters, which means that it should be within experimental reach with the current semiconductor technology.

As a nalpoint, it is very instructive to compare the non-equilibrium form ula (22) with the one for a degenerate 1D Bose gas of density n at equilibrium. The symmetry which is spontaneously broken is in fact the same U (1) in the two cases<sup>26</sup>. While at T = 0 the equilibrium system shows a power law decay of correlations, an exponential decay is recovered at nite T, with a coherence length given by<sup>11</sup>:

The dependence on the density is the same in the equilibrium and non-equilibrium cases, while the role of the tem perature T is played in the non-equilibrium case by the noise associated to dam ping. Another, m ore striking, di erence concerns the free boson m ass m, which is replaced in the non-equilibrium case by the param eter a de ned in (14), i.e. the inverse of the second derivative of the imaginary part of the G oldstone m ode dispersion.

#### VII. CONCLUSIONS

In conclusion, we have developed an analytical theory which is able to describe the long-distance phase coherence of the light emitted by a one-dimensional optical parametric oscillator above threshold. Because of the reduced dimensionality, quantum uctuations turn out to be able to destroy the long-range order. At long distances, the coherence function shows an exponential decay with a coherence length '\_ inversely proportional to the nonlinear coupling constant.

This result is very general and holds for any kind of one-dimensional parametrical oscillator, as well as for other examples of non-equilibrium phase transitions in reduced dimensionality. We have concentrated our attention on sem iconductor photonic wires in the strong coupling regime simply because such systems appear as very promising candidates to experimentally investigate this physics. The extrem ely large value of the excitonexciton interactions corresponds in fact to a value of 'c short enough to be within reach of the current sem iconductor technology.

In addition to their interest for the fundamental physics of pattern formation and non-equilibrium phase transitions, the conclusions of the present paper may also have signi cant consequences for device applications of OPOs, as quantum uctuations provide an intrinsic lim – itation to the long distance phase coherence that can be obtained even in the absence of other decoherence and disorder e ects.
