Levy {Brownian motion on nite intervals: Mean rst passage time analysis.

We present the analysis of the rst passage time problem on a nite interval for the generalized Wiener process that is driven by Levy stable noises. The complexity of the rst passage time statistics (mean rst passage time, cumulative rst passage time distribution) is elucidated together with a discussion of the proper setup of corresponding boundary conditions that correctly yield the statistics of rst passages for these non-Gaussian noises. The validity of the method is tested numerically and compared against analytical formulae when the stability index approaches 2, recovering in this limit he standard results for the Fokker-Planck dynamics driven by Gaussian white noise.

I. INTRODUCTION

Stochastic Levy processes serve as paradigm s for the description of m any unusual transport processes leading to anom alous di usion as characterized by an anom alous m ean squared displacem ent, i.e.,

which deviates with € 1 from the linear dependence $h(x)^{2}i / t$ that characterizes normal diusion. In the above formula stands for the anomalous diusion exponent that speci es the process at hand as either behaving subdi usive (with 0 < < 1), superdi usive) or ballistic (for = 2) [1, 2, 3, 4]. Among the class of Levy processes, the free Levy ights (LF) represent a special class of discontinuous M arkovian processes, for which the mean squared displacement, as dened in equation (1) diverges due to the heavy-tail distribution of the independent increments x. In this case, the mean squared displacement is always superdiusive; i.e. $h(x(t) - hx(t)i)^2i / t^{2} - h(x(t) - hx(t)i)^2i / t^{2} - hx(t)^2i / t^{2} - hx(t)^2i / t^{2} - hx(t)^2i / t^{2} - hx$ < 2 denotes the stability index of the Levy (Brownian motion process, see below in Sect. II. In contrast to the spatio-tem poral coupling characterizing general form s of non-M arkovian, or more precisely, sem i-Markovian [2] Levy walks (LW) [1, 3, 4], Levy ights correspond to the class of M arkov processes that emerge from a Langevin equation with correlated, white Levy noise. Because LFs typically possess a broad jum p length distribution with an asymptotic power law behavior their trajectories display at all scales self-sim ilar clustering of local so purns that become interrupted by long jum ps into the other location in the phase

space where a new clustering form s. Early discoveries of LF-like phenomena were related to intermittent chaotic systems and description of the motion of the uid particles in fully developed turbulence [1, 2, 3]. Now adays, their applications range from description of the dynam ics in plasm as, di usion in the energy space, self-di usion in m icelle systems and transport in polymer systems under conform ationalm otion [1, 5] to the spectral analysis of paleoclimatic [6] or economic data [7]. Despite the ubiquitous use of LFs as phenom enological models for noise sources, their in uence on the kinetics subjected to boundary conditions has been addressed scarcely only. For free normal diusion, the knowledge of the Green function, together with the local boundary conditions, is su cient to determ ine the rst passage time statistics. The same information can be also obtained by use of the m ethod of im ages or by solving the corresponding, local boundary value problem of the di usive Fokker-Planck equation [8, 9].

In particular, for processes driven by white Gaussian noise these boundary conditions for rejection or absorption are locally de ned and well known [9, 10]. However, for the case of LFs, the method of images fails, yielding results that contradict the Sparre-Andersen theorem [11, 12]. By virtue of the latter [13], for any discrete time random walk starting out at $x_0 \in 0$ with the step length sampled from a continuous, symmetric distribution, the rst passage time density decays asymptotically as t 3=2. In order to further explore the intricate problem of proper boundary conditions for absorption and re ection for non-Gaussian white noise composed of independent Levy ight increments, we elucidate with this work the situation of a free, overdam ped Levy (Brownian motion, being restricted to a bounded domain of attraction.

II. RESTRICTED LEVY (BROWNIAN MOTION

W e consider the free B rownian motion on a restricted, nite interval that is driven by Levy stable noise. More specically, the dynamical evolution of a stochastic state variable x (t) is described in terms of the Langevin equation

(t) denotes a Levy stable white noise process which is composed of independent dierential increments that are distributed according to the stable density with the index ; i.e. L; (;; = 0). Put dierently, stands for the generalized white noise process which is obtained from the time derivative of the corresponding Levy (Brownian (Markovian) stable process. The param eter choice = 2 yields the usual, -correlated Gaussian white noise. In contrast, with 0 < < 2 the corresponding Levy white noise is generated from Levy (Brownian motion possessing discontinuous sample paths with in nite variance and the higher cumulants. Its statitiscal properties can be however characterized by fractional moments of order which exist and are nte for < 2 [14]. Because it is composed of independent increments, this Levy stable white noise also constitutes a singular white noise process whose autocorrelation again is formally -correlated [14]. Here, the parameter denotes the stability index, yielding the asymptotic power law for the jump length distribution being proportional to $j j^1$. The parameter acterizes a scale, de nes an asymmetry (skewness) of the distribution, whereas denotes the location param eter. We deal only with strictly stable distributions not exhibiting a drift regime; this implies a vanishing location parameter = 0 throughout the remaining part of this work. For € 1, the characteristic function $(k) = {1 \choose 1} e^{ik} L$; (; = 0)d of an -stable random variable can be represented by

while for = 1 this expression reads

The three remaining parameters vary within the regimes 2 (0;2); 2 [1;1]; 2 (0;1).

The stochastic di erential equation in (2) yields normal, free Brownian motion when = 2, and free superdi usion when 2 (0;2). The numerical integration of equation (2) has been performed by use of standard techniques of integration of stochastic di erential equation with respect to the Levy stable measures and studied by use of the Monte Carlo methods [15]. In particular, the error bars visible in the gures were calculated

using the bootstrap method. The position of a Levy{ Brownian particle has been obtained by a direct integration of Eq. (2) leading to the following approximation [16, 17, 18, 19, 20, 21]

i are independent random variables distributed with the probability density function (PDF) L; (; = 0) and N s = t. All our illustrations in this work are based on trajectory calculations sampled from the Langevin equation (2). Absorbing boundary conditions have been realized by stopping the trajectory whenever it reached the boundary, or, more typically, it has jum ped beyond that boundary location. The condition of re ection has been assured by wrapping the hitting (or crossing) trajectory around the boundary location, while preserving its assigned length. The Appendix A provides som e further details on the num erical schem e for stochastic di erential equations driven by Levy white noise. We also like to emphasize that our results om it cases when = 1 with 60. In fact, this parameter set is known to induce instabilities in the numerical evaluation of corresponding trajectories [16, 17, 18, 19, 20, 21]. Thus, for our num erics with θ 0, the param eter value = 1 has been excluded from the consideration.

III. M EAN FIRST PASSAGE TIM ES FOR -STABLE NOISES




FIG. 1: Setup for the investigation of the rst passage time analysis of Levy white noise driven free Brownian motion being conned between the two boundaries located at B $_1$ and B $_2$, respectively.




FIG. 2: Left panel: Typical sample trajectories of conned, normal diusion, i.e. = 2, with two absorbing AA boundaries. Right panel: Conned normal Brownian motion between a left-sided rejecting boundary (R) and a right-sided absorbing boundary (A), denoted as RA in the text. The particles start out at midpoint x=L=0.5, undergoing state-continuous stochastic motion with evolving time t.

Our main objective is the investigation of the mean rst passage time (MFPT) of Levy {Brownian motion on a nite intervalas illustrated with Fig. 1. The boundaries at both ends will be assumed to be of either absorbing or also of the re ecting type. W ith generally non-Gaussian white noise the know ledge of the boundary location alone cannot specify in full the corresponding boundary conditions for absorption or re ection, respectively. In particular, the trajectories driven by non-Gaussian white noise depict discontinuous jumps, cf. Figs. 2 and 4 below. As a consequence, the location of the boundary itself is not hit by the majority of discontinuous sample trajectories. This im plies that regim es beyond the location of the boundaries must be properly accounted for when setting up the boundary conditions. Most importantly, returns (i.e. so term ed re-crossings of the boundary location) from excursions beyond the speci ed state space back into this very nite interval where the process proceeds must be excluded. Thus, the problem of proper formulation of boundary conditions in such cases poses an open challenge that has not been addressed with sufcient care in the prior literature [22, 24]. In contrast to the case with normaldiusion (i.e. when = 2; = 0), these boundary conditions are of a nonlocal nature; as a consequence, an analytical investigation of the mean rst passage problem becomes very demanding and cumbersom e. In this work, we therefore restrict ourselves predom inantly (for < 2) to detailed, precise num erical simulations.

The setup for the studies is schem atically depicted in Fig. 1. The stochastic motion of a free Levy particle is conned in an interval specified by the two boundaries B_1 ; B_2 . The dynamics of the LFs trajectories derived from Eq. (2) are consequently conned to this state space in-between B_1 and B_2 .

A. The test case: norm aldiusion

For = 2 (see Fig. 2), white Levy stable noise becomes equivalent to Gaussian white noise and the corresponding Langevin eqution (2) describes a free Brownian motion

(W iener process) for which the probability density functions (PDFs) of the rst passage times distributions are known explicitly from the literature [8, 9]. Here, due to reasons of convenience, instead of estimating the PDFs itself we simulate the equivalent cumulative distribution functions (CDFs) of rst passage times. For the sake of simplicity it has been assumed that the left boundary is located at x = 0 and the other one at x = L. In the following we typically use, although not exclusively, for the initial condition, x_0 , the center of the interval, $x_0 = L = 2$. In the case when both B_1 and B_2 are absorbing boundaries, denoted as AA, the cumulative distribution function F of rst passage times has been obtained by integration of the rst passage time density f (t), i.e. K_t (t) K_t (t)

Analogously, for a left absorbing boundary (A) and a re-ecting right boundary (R), denoted as AR, the corresponding CDF of rst passage times reads (B, 9, 10)

Finally, for a left re-ecting boundary (R) and a absorbing right boundary (A), denoted as RA, the corresponding CDF of rst passage times reads [8, 9, 10]




FIG. 3: First passage time statistics for free normaldiusion (= 2) occurring between two boundaries located at x = 0 and x = 5. The cumulative rst passage time distribution F (t) is depicted versus the rst passage time variable t. The initial motion starts out at $x_0=3.5$ and the noise strength is $^2=5$. The chosen time step is $t=10^{-5}$ and the results have been averaged over N = 3 10^4 realizations. The simulation results are presented for AA , RA and AR congurations (from the top to the bottom) along with lines representing the analytical formulae for these cases. The numerical data match perfectly the analytical results, plotted on superinposed lines. The inset depicts this agreement on an extended time span up to time t=20.

where the scaling parameter stands for the amplitude of the noise intensity for the additive white G aussian noise; i.e. h (t) (s) $i = 2^2$ (t s). Note, that for a particle starting its motion at $x_0 = L=2$, F (t) for a RA boundary setup is the same as for the symmetrically chosen AR situation, cf. the formulae above. To test our employed software, we evaluated numerically the rst passage times distributions with the same boundary conditions as speci ed above. Eq. (2) has been integrated num erically for $B_1 = 0$, $B_2 = 5$, $x_0 = 3.5$ with $t = 10^{-5}$ and averaged over N = 3 10^4 realizations. Figure 3 depicts the num erical results along with their corresponding analytical expressions for the corresponding com pound distribution functions (CDFs) of rst passage times for a Levy-Gaussian case (= 2). We nd a perfect agreem ent between the theoretical and the num erical results. On purpose, we have chosen here an asym metric starting point in order to impose an explicit di erence between the AR and the corresponding RA setup, respectively.

B. Con ned Levy{Brownian motion

A fler having tested the num erical algorithm, we next study the mean rst passage time for con ned Levy{ Brownian motion on a nite interval.

M FPT for sym m etric Levy noise




FIG. 4: Sam ple trajectories for AA (left panel) and RA (right panel) with the two boundaries located at B $_1=0$ and B $_2=L$ for sym m etric Levy ights with =1.4;=0. For <2 large excursions of the trajectory are more probable than for the normal Brownian motion. A test \particle" can skip over the border, i.e. it can escape from the domain of motion with a single jump.

U sing the discussed simulation procedure we start out with the case of conned Levy {B rownian motion with symmetric stable Levy noise, i.e. we set = 0. Exemplary trajectories are depicted in Fig. 4. for the stability index = 1.4. In clear contrast to normal B rownian motion we detect discontinuous jumps, characterizing random jumps over large distances (note the horizontal excursions in Fig. 4). As a consequence, the boundaries at B_1 ; B_2 are typically not hit, but rather crossed in a ight-like manner, being characteristic for Levy distributed jumps. In fact, for < 2 large excursions of the trajectory are more probable than for normal B rownian motion. In elect, a test particle can skip over the border, i.e. it can escape from the domain of motion via a single jump.

As discussed in the literature [1, 3, 11], the scaling nature of the jump length PDFs causes a clustering of Levy ights. Random localized motion is occasionally interrupted by long so journs on all length scales and, additionally, there are clusters of local motion within clus-

ters. A nom alous trajectories of Levy ights with stability index < 2 in uence also the boundary condition for the mean rst passage time and its corresponding statistics.

From the perspective of a random walk approximation to the Langevin equation in (2), the behavior of a Levy walker is drastically dierent for Levy jump length statistics as compared with a traditional Gaussian case: The increments of the normal (state-continuous) diusion process x (t) are characterized by statistics which excludes with very large probability the occurrence of long jumps. Therefore, the walker is more probable to approach { and eventually hit { a point-like boundary (cf. Fig. 2). In contrast (see Fig. 4), with the Levy jump statistics (< 2), a m eandering particle m ay easily cross the local boundary during its long jum p and m ay recross into the nite interval many times, unless the particle is im mediately absorbed upon crossing for the rst time the boundary B₁ or B₂, respectively. This brings about a formulation of the boundary condition that necessarily must be non-local in nature.

Indeed, the rst passage time problem for Eq. (2) can also be rephrased in terms of the fractional Fokker-Planck equation [11, 25, 26, 27, 28, 29]. For a free Levy (Brownian motion this equation with = 0 assumes the form:

The boundary conditions for the $\,$ rst passage time problem associated with two absorbing boundaries at B $_1$ and B $_2$ are now nonlocal; reading,

$$p(x;t) = 0 \text{ for } x \in B_1 \text{ and } p(x;t) = 0 \text{ for } x > B_2: (10)$$

Due to discontinuous character of trajectories of Levy

processes we note that the usual form of boundary conditions, i.e. p(x = 0;t) = 0 and p(x = L;t) = 0, incorrectly employed in the literature [22, 24, 30, 31] is expected to lead to erroneous results; such a boundary condition does not account for the fact that the process can skip the location of the boundary without hitting it. The corresponding M FPT can be num errically integrated, yielding

which after a partial integration equals

This expression has been tested versus the statistical de nition based on histogram analysis of the corresponding trajectories Eq. (2), for which the appropriate boundary conditions were imposed.




FIG.5: Mean rst passage time versus the stability index of conned Brownian motion driven by stable symmetric Levy noise. We depict the case of two absorbing boundaries, AA (left panel), and the situation of a rejecting and absorbing barrier, AR/RA (right panel). The initial starting point has been chosen at midpoint $x_0 = 2$, yielding identical results for AR and RAp respectively. The simulations parameters are: = 0, = 2, time step $t = 10^4$, number of realizations $N = 2 = 10^2$. The boundaries are located at $B_1 = 0$ and $B_2 = 4$. The theory-result from Ref. [22] (Eq. (39) therein) is plotted as a dashed line.

Likewise, we also have studied the case where one of the two boundaries becomes rejecting. The rejecting boundary is imposed on the trajectory simulations via an in nite high hard wall, yielding immediate rejection [32]. For the numerical implementation of this rejecting case see below Eq.5. In Fig.5 we compare our numerical results for the case of two absorbing boundaries, case AA, and as well, for the symmetric situation, AR = RA, of a rejecting boundary and an absorbing boundary with the initial starting value chosen at midpoint.

Fig. 5 depicts the num erical results for the M FPT for sym m etric Levy stable noise after in plem enting num erically the appropriate boundary conditions as discussed above. In the left panel of Fig. 5 the num erical results for the M FPT are compared with the theoretical notings for the M FPT T in this superdiusive case, reading from Eq. (39) in Refs. [22, 23],

The maximal MFPT is assumed for '1. The behavior of the MFPT assumes a bell-shaped behavior around = 1; it refects the different interplay of the probability of nding long jumps versus a decreasing stability index < 2, implying a decreasing noise intensity. Put differently, the occurrence of long jumps beyond the nite interval is dominating the escape over a decreasing noise intensity for for < 1.

The expected discrepancy between these analytical results and numerical estimation is due to assumed local boundary condition of vanishing probabilities p(x=0)=p(x=L)=0, which are correct only for normal Brownian motion; i.e. = 2. Indeed, our numerical result just coincides precisely at this very special value. In our simulation of the Langevin equation in (2) the whole exterior of the prescribed interval ($B_1=0$; $B_2=4$) is absorbing throughout, while for the analytical calculations the awed, point-like boundary conditions are assumed [22].

C learly, the extension of the absorbing regime to the whole two sem i-lines outside the con ning interval yields the physically correct value that accounts for the escape of the particle from the interval via long jumps. The numerical results for < 2 systematically exceed the theory-result of Ref. [22].

The right panel of Fig. 5 depicts the case for the MF-PTs with AR and RA boundaries, respectively. Due to sym metric chosen initial condition and the sym metric stochastic driving the results for AR and RA become identical.

M FPT for asym m etric Levy noise




FIG. 6: Probability density functions for the -stable variables x with = 1.5 (left panel) and = 0.9 (right panel). The sym metric case is for = 0, while = 1 corresponds to asym metric densities. Note the dierences in the positions of the maxima for < 1 and > 1. Most importantly, the support of the densities for the fully asymmetric cases with = 1 and < 1 (right panel) is covering not the whole axis; it assumes only negative values for = 1 and only positive values for = 1. This in turn causes the discontinuous behavior depicted with Fig. 7.




FIG. 7: M FPTs versus the stability index for asym m etric Levy noise for di erent boundary conditions: AA (left panel), AR (right panel). The simulations parameters are as in Fig. 5. Note that the results for the AR setting with = 1 and < 1 are the same as for the AA settings with 1 and < 1.

A sym metric Levy noise is characterized by a non-vanishing skewness parameter 60 (see the exemplary probability density functions in Fig. 6). Fig. 7 presents the results of MFPT evaluations for fully asymmetric Levy stable noise driving with j = 1. The left panel displays results for the Levy {Brownian motion with = 1 within the AA boundaries setups. Due to the imposed symmetry of a starting point, the results coincide with those for the Levy noise driving with = 1. The right panel depicts the results for AR boundaries with = 1. As can be inferred by inspection of Fig. 6, due to the skewness character of the Levy stable distribution, the

results for AA boundaries with < 1 and = 1 are the same as for AR boundaries with < 1 and = 1. The e ect is caused by a visible shift of the probability m ass apart from x = 0 to the left (or to the right) for skewed distributions with < 1. In contrast, these results dier for > 1 where both boundary setups, i.e. AA and AR, lead to dierent values for MFPTs.




FIG. 8: M FPTs versus the skew ness param eter for AA (left panel) and AR (right panel) boundaries for Levy (B row nian m otion w ith = 0.5. The simulations param eters are like in Fig. 5.

As can be intuitively expected, the cumulative rst

passage time distributions (CDFs) of the rst passage tim es as governed by Eq. (2) for the AA boundaries with a sym m etric starting point, i.e. $x_0 = L=2$, are invariant under the transform ation! . Therefore, the quantities derived from the num erically determ ined CDFs are sym m etric around = 0, cf. the left panel of Fig. 8. Furtherm ore, because of the chosen symmetric initial conditions the cum ulative rst passage time distributions evaluated for the RA boundaries setup can be constructed from the appropriate distribution for the AR case by exchanging with . It is caused by the fact that the asym m etry induced by a nonzero skewness param eter can be compensated by an exchange of boundaries, cf. left panel of Fig. 8 and Fig. 6.

C . First passage time statistics




FIG. 9: Cumulative rst passage time distribution function for sym metric Levy {B rownian motion on a restricted interval, i.e. = 0, with = 1:9;1:0;0:5 for AA (left panel) and AR (right panel) boundaries. The results have been simulated for = $\frac{1}{2}$, t= $\frac{10}{4}$ and have been averaged over N = $\frac{10}{4}$ realizations. The boundaries B₁; B₂ are located at x = 0 and x = 4. The particle starts out at midpoint; i.e. $x_0 = 2$.




FIG. 10: Cumulative rst passage time distribution function versus rst passage time t for Levy noises with = 1:5 and = 1:0;0:0;1:0 for AA (left panel) and AR (right panel) boundaries. The simulations details are the same as in Fig. 5.

The simulation data for the mean rst passage time yield as well the results for the cumulative rst passage time distribution functions (CDFs). Typical such distributions are depicted in Fig. 9 for symmetric—stable noise and in Fig. 10 for asymmetric stable Levy white noises with a stability index = 1.5. With symmetric noise we observe that the escape, starting out at midpoint, is speeded up with two absorbing boundaries AA as compared to the situation with AR=RA. The recting boundary clearly slows down the ultimate escape from the nite interval.

For escape driven by asymmetric white Levy noise, see Fig. 10, we note that for the case of two absorbing boundaries AA (left panel) the CDFs become identical for = , given the midpoint starting value. We also can detect a more rapid saturation with $\frac{1}{2}$ 0 as compared to the fully symmetric situation with = 0; implying a somewhat faster escape scenario. This fact originates from the skewness in the distribution of jump

values, in plying a faster escape towards the corresponding absorbing boundary.

With an AR boundary setup the situation becomes more intricate. Now, depending on the choice of the asymmetry parameter the escape can be enhanced, recting the skewness of the corresponding stable distribution and the relative character of the boundary setup.

Note that the results for the AA settings with = 1 overlap.




FIG. 11: The cumulative rst passage time distribution F (t) versus rst passage time t for Levy{Sm imo driven Levy{B rownian motion, i.e. = 0.5 and = 1 and a scale parameter = $\frac{1}{2}$. Because the Levy{Sm imo statistics assumes only positive values the distributions F (t) for AA and RA con gurations become the same. The simulations parameters are as in Fig. 5.

This complexity is elucidated further in panel 11 for the case of stable Levy $\{Sm \text{ imo noise where } = 0.5; = 1.$ The CDF F (t) is depicted in Fig. 11. For < 1 and j = 1 Levy stable distributions are totally skewed, taking on either only positive values (= 1) or negative

values only = 1. Therefore, the results for < 1 and j j= 1 for AA boundaries are the same as for AR (= 1) or RA (= 1) boundaries. This e ect is clearly visible for the Levy {Sm imo case depicted in Fig. 11. Now, the results for AA and RA boundaries are the same, as expected. A similar behavior is observed in Fig. 7 above, where the values of the MFPTs for < 1 for AA and AR boundaries agree.

Survival probability: com parison with Sparre-Andersen scaling




FIG. 12: Survival probability S(t)=1 F(t) for connect, symmetric Levy{Brownian motion = 0 on the interval $B_1=0$; $B_2=4$ with absorbing half-line for x<0 and absorbing (or rejecting) half-line for x>0 for various values of the stability index and midpoint initial conditions at $x_0=2$. The left panel depicts the results for AA boundary setups; the AR cases are displayed with the right panel. The solid line in both data sets represents the power law t^{1-2} which describes an asymptotic behavior foreseen by the Sparre-Andersen theorem [13] for dijusion on semi-in nite intervals.

The survival probability S(t)=1 F(t) for sym metric Levy {B row nian motion on the nite interval is displayed in Fig. 12. The motion on a connect support leads to an exponential decay of the survival probability with the steepness of the slope depending on the stability index. Notable differences can be observed for various boundary setups: For motion occurring between two absorbing boundaries, the survival probability decays faster than for the case when one of the boundaries is taken as recting. It is also useful to emphasize that deviations from the exponential behavior of the survival probability can be observed in systems subjected to both, dichotom ic and Levy stable noises [33, 34], respectively.

Finally, for the systems driven by Levy stable noises we also tested the Sparre-Andersen scaling behavior on an in nite half line. A coording to the Sparre-Andersen theorem [13] for a free stochastic processes driven by symmetric white noises, the rst passage time densities $\frac{\mathrm{d}F}{\mathrm{d}t}$, process from the real half line asymptotically behave like t $^{3=2}$. Consequently the survival probability, i.e. the probability of nding a particle starting its motion at




FIG. 13: Survival probability S (t) = 1 F (t) for free Levy ights on the half line with absorbing boundary for x < 0 for various values of stability index and various initial conditions x_0 . Remaining simulation parameters like in Fig. 5. The survival probability nicely ts t $^{1-2}$ slope predicted by Sparre-Andersen scaling.

 $x_0>0$ in the real half line, scales like t $^{1-2}$. In Fig. 13 the survival probability S (t) = 1 F (t) is depicted for various stability indices and various initial conditions x_0 . It is clearly visible that the survival probability S (t) behaves like a power law with the exponent (1=2), as predicted by the Sparre-Andersen theorem. For the testing of the Sparre-Andersen theorem the whole negative half line was assumed to be absorbing.

IV. CONCLUSIONS

With this work we investigated the problem of the mean rst passage time and the rst passage time statistics for Markovian, Levy (Brownian motion proceeding on a nite interval. The intricate problem of setting up the proper boundary conditions for absorption and reection are discussed with possible pitfalls being pointed out. In particular, it has been demonstrated by num erical studies that the use of the commonly known, local boundary condition of vanishing ux (in case of re ection) and vanishing probability (in case of absorbtion), valid for normal Brownian motion (i.e. = 2) no longer apply for Levy white noise. This is so, because the large, jum p like excursions of Levy ight increm ents causes noncontinuous, i.e. discontinuous sam ple tra jectories. This in turn requires the use of nonlocal boundary conditions. It is presently not known how these nonlocal boundary conditions can be recast as in equivalent form as a modi ed, locally de ned di erential condition involving the statistical quantities of interest (the M FPT and the rst passage time densities) at the location of the boundary alone [35, 36].

For sym metric, stable Levy white noise driven Brownian motion we nd a bell-shaped, non-monotonic behavior of the MFPTs for absorbing-absorbing boundaries, with the maximum being assumed for = 1. In contrast, for rejecting-absorbing boundaries we nd a monotonic increase. With asymmetric Levy white noise, i.e. with a non-vanishing skewness parameter 60 the MFPT results in an even more complex behavior. As a function of the stability index the MFPT can exhibit a discontinuous behavior, see the right panel in Fig. 7.

In addition we have studies also the statistics of the rst passage times in terms of the cumulative rst passage time distribution function (CDF) and the corresponding survival probability. In this context, we also belabor the role of a nite support and dierent boundary setups for Levy white noise driven Brownian motion for the universal scaling law of Sparre-Andersen. While the restricted Levy {Brownian motion exhibits an exponential behavior on nite intervals, the crossover to the universalt 1=2 -power law, being valid on the half-line for all stability indexes is assumed for large intervals only.

APPENDIX A: -STABLE RANDOM VARIABLES

The random variables corresponding to the characteristic functions (3) and (4) can be generated using the Janicki(W eron algorithm [16, 17]. For $\frac{6}{5}$ 1, their representation reads

For = 1, the random variable can be calculated from the form ula

In the above equations V and W denote independent random variables; namely, V is uniformly distributed in the interval ($\frac{1}{2}$; $\frac{1}{2}$) while W is exponentially distributed with a unit mean [16]. The numerical integration scheme has been performed for = 0 with the increments of x (see Eqs. (2) and (5)) sampled from the strictly stable distributions [19].

The analytical expressions for stable probability distributions L; (;;) are known in few cases only: For = 0.5; = 1 the resulting distribution is the Levy{ Sm imo one; i.e.,

In contrast, for = 1; = 0 one obtains the C auchy distribution

The fam iliar case with = 2 with arbitrary yields the Gaussian PDF. The prominent characteristic feature of the distributions L; (;;) is its existence of moments up to the order, i.e. the integral $_1^1$ L; (;;) d is nite. This statement results in the conclusion that the only stable distribution possessing a nite second moment is the Gaussian; for all other values of the variance of a stable distribution diverges, and for < 1 even the rst moment does not exist.
