Multipole Ordering and Fluctuations in f-Electron Systems

We investigate elects of multipole moments in f-electron systems both from phenomenological and microscopic viewpoints. First, we discuss signicant elects of octupole moment on the magnetic susceptibility in a paramagnetic phase. It is found that even within mean-eld approximation, the magnetic susceptibility deviates from the Curie-Weiss law due to interactions between dipole and octupole moments. Next, we proceed to a microscopic theory for multipole ordering on the basis of a j-j coupling scheme. After brief explanation of a method to derive multipole interactions from the f-electron model, we discuss several multipole ordered phases depending on lattice structure. Finally, we show our new development of the microscopic approach to the evaluation of multipole response functions. We apply uctuation exchange approximation to the f-electron model, and evaluate multipole response functions.

KEYW ORDS: octupole m om ent, j-j coupling scheme, Curie-Weisslaw, uctuation exchange approximation

1. Introduction

Novelmagnetism and exotic superconductivity in rareearth and actinide compounds have attracted much attention in the research eld of condensed matter physics. In order to elucidate the mechanism of these phenomena, it is quite in portant to describe f-electron states in a system atic way by considering correctly the sym metry of f-electron orbitals. On the other hand, we encounter di culties to express f-electron states by m eans of a sim ple combination of spin and orbital degrees of freedom, as has been done for d-electron states, since the spin-orbit interaction is strong for f orbitals in general. For such a case, it is rather convenient to exploit multipole degrees of freedom, including charge (rank-0), dipole (rank-1), quadrupole (rank-2), and octupole (rank-3) components. Fortunately, am ong such multipole m om ents, dipole and quadrupole correspond to ordinary spin and orbital degrees of freedom, respectively. Thus, phenomena concerning dipole and/or quadrupole m om ents are basically understood by analogy with d-electron physics. In this sense, octupole is considered to be the rst exotic multipole m om ent in the solid state physics.

Although it has been very rare to observe phenomena related to octupole moment in d-electron compounds, we have sometimes found octupole-related phenomena in f-electron compounds. For instance, in order to understand anom alous properties of CeB6, signi cant roles of octupole m om ent have been discussed actively. In particular, apparent contradiction between neutron scattering and NMR measurements on the so-called phase II of CeB6 has been clearly resolved by considering e ects of magnetic-eld induced octupole moment on the hyper ne coupling.3 In recent years, furtherm ore, possibility of ordering of octupoles them selves has been intensively discussed for $Ce_xLa_{1x}B_6^{4\{9\}}$ and for $NpO_2.10\{17\}$ In both materials, the crystalline electric eld (CEF) ground states are 8 quartets, 18{22 and in such CEF ground states, there are dipole, quadrupole, and octupole degrees of freedom. 23 In fact, several experim ental facts

have been reconciled by assum ing $_{5\mathrm{u}}$ antiferro-octupole ordering in these m aterials.

In order to contribute to the further development of multipole physics, there are two dierent ways for the direction of research. One is to clarify the e ect of octupole moment in a paramagnetic phase, not in the ordered state, in a phenomenological level. It is one of natural extensions of the research for mutipoles, since the phenomenological theory for octupole ordering has been developed so far. Here it should be noted that octupole moments are magnetic, that is, parity of octupoles is odd under time reversal. Thus, in principle, octupoles would in uence magnetic properties even in the paramagnetic phase. However, such e ects have not been studied seriously. We should make e orts to include such e ects to analyze magnetic properties of materials with active octupole degrees of freedom.

A nother direction of the research is to develop a microscopic theory for multipole-related phenomena. The construction of such a microscopic theory was considered to be dicult, since it has been believed that it is standard to use the LS coupling scheme to express the f-electron state. However, we have recently developed a microscopic theory for f-electron systems by exploiting a j-j coupling scheme. The ground and low-energy excited states can be well described by a microscopic model on the basis of the j-j coupling scheme, in contrast to the naive belief for the limitation of the j-j coupling scheme. For instance, we have successfully explained the microscopic origin of octupole ordering of NpO $_2$ even in a simple d-electron-like approximation. 25,26

Since we have shown that the microscopic model on the basis of the j-j coupling scheme is useful to understand multipole ordering for f-electron systems, it is natural to investigate further the electron systems, it is natural to investigate further the electron multipole uctuations in a microscopic level. We believe that it is challenging and important development of the microscopic theory for f-electron materials. In fact, it has been actually proposed that exotic superconductivity in PrOs $_4$ Sb $_{12}$

m ay be induced by quadrupole uctuations, $^{28\{30}$ since a quadrupole ordered phase appears under a magnetic eld. 31,32 In order to discuss such a possibility from a microscopic view point, it is necessary to include multipole uctuations in a microscopic theory for superconductivity. In particular, we should classify complex uctuations in f-electron systems into multiple components.

In this paper, we exhibit our new developm ent form ultipole physics including review of our previous work. In x 2, rst we brie y review our simple phenom enological theory to understand the e ect of octupole m om ent in a param agnetic phase. 33 In particular, we discusse ects of octupoles on the magnetic susceptibility, to clarify how octupoles in uence macroscopic properties in the param agnetic phase. In x 3, we explain the recent developm ent of our microscopic theory for multipole phenomena. A fter a short explanation of the model on the basis of the j-j coupling scheme, we brie y review the microscopic theory for multipole ordering. 25,26 In particular, we nd the 5u longitudinal antiferro-octupole ordering for an fcc lattice, which has been proposed for NpO2. Then, we explain new developm ent of our theory to treat multipole uctuations. We present our fram ework for the microscopic approach to evaluate multipole response functions with some calculated results. Finally, in x 4, we sum marize this paper. Throughout this paper, we use such units as $\sim = k_B = 1$.

2. Phenom enological Approach

In order to clarify complex e ects of multipole moment, it is useful to consider rst the problem in a phenom enological level. In fact, there are lots of literatures treating multipole ordering along this direction and the phase diagram including multipole ordered state has been successfully explained by applying a mean-eld approximation to the Heisenberg-like model for multipole m om ents. In this section, we brie y review our recent result based on such a phenom enological model, to clarify signi cant e ect of octupole m om ent on m agnetic properties in the param agnetic phase within the mean-eld approxim ation.33

Let us here consider a cubic system for simplicity. There is no essential di culty to extend the theory to other cases. In a cubic system, the octupole moment T with the same symmetry $_{4u}$ as the dipole moment J is an independent degree of freedom in a certain CEF ground state, e.g., 8 ground state. In such a case, octupole and dipole m om ents interact each other. In general, we should note that T is not orthogonal to J. Thus, we rede ne T⁰, a linear combination of T and J, which is orthogonal to J, i.e., $tr(J T^0) = 0$, where indicates a cartesian component and tr() denotes the sum the expectation values over the CEF ground states. We normalize T^0 so as to satisfy $tr(J \ J) = tr(T^0 T^0)$.

Then, a m ean-eld H am iltonian under a m agnetic eld H along the z-direction up to 0 (H) is given by




Fig. 1. Tem perature dependence of the inverse of the magnetic susceptibility of UO $_2$ under H = 10 kO e and H k $[100]^{36}$ (solid curve). The dotted curve represents the Curie-W eiss law with $_{\rm e}$ = 3.23 $_{\rm B}$ [C = $_{\rm e}^2$ = (3 $k_{\rm B}$)] and = 223 K . The inset shows a schematic view of the dipole moment J and octupole moment T in a 5 CEF ground state.




Fig. 2. Tem perature dependence of the inverse of the magnetic susceptibility of NpO₂ under H = 10 kOe and $H \text{ k} [100]^{39}$ (solid curve). The dashed curve represents the tobtained with eq.(2.5) w ith $_{\rm e}$ = 3.20 $_{\rm B}$, = 146:1 K, $_{\rm 1}$ = 161:9 K, and $_2$ = 22:5 K . The dotted curve represents the Curie-W eiss t w ith $_{\rm e}$ = 3:20 $_{\rm B}$ and = 139 K .The inset shows a schematic view of the dipole m om ent J, octupole m om ent T, and T 0 w hich is orthogonal to J in a 8 CEF ground state.

g-factor, and $_{\rm B}$ is the Bohrm agneton. Phenom enologicaldipole-dipole, octupole-octupole, and dipole-octupole interactions are expressed by d, o, and do. We have multiplied the factor $(g_{J-B})^2$ to the interaction terms for convenience. In general, there are other multipole interactions, 34 but the mean eld from them cancel out $_{\mbox{\scriptsize O}}\mbox{\scriptsize IV}$ ithin 0 (H) due to the cubic sym m etry. Thus, eq. (2.1) does not change, even if we consider other multipole interactions.

Now we diagonalize the mean-eld Hamiltonian by introducing the linear combinations of J_z and T_z^0 :

W e have norm alized M $_{\rm z}^{(1)}$ and M $_{\rm z}^{(2)}$ so that the sum of

them is the m agnetic m om ent M $_z$, i.e., M $_z^{(1)}$ + M $_z^{(2)}$ = M $_z$ = g_J $_B$ J_z . By choosing the parameter , we can diagonalize the m ean-eld H am iltonian as

Then, the moment M $_{\rm z}^{(1)}$ (M $_{\rm z}^{(2)}$) follows the Curie-W eiss law with the Curie constant C $_1$ = C \cos^2 (C $_2$ = C \sin^2) and the W eiss temperature $_1$ = C $_1$ $_1$ ($_2$ = C $_2$ $_2$), where C = C $_1$ + C $_2$ is the Curie constant for a free ion. The following relations for the W eiss temperatures without the parameter may be useful: $_1$ + $_2$ =C ($_d$ + $_0$) and $_1$ $_2$ =C $_2$ ($_d$ $_0$). Then, the magnetic susceptibility is given by

where = $(C_{1\ 1}+C_{2\ 2})$ =C=C $_{d}$ is the W eiss tem perature, i.e., the magnetic susceptibility follows the Curie-W eiss law = C=(T) asym ptotically at high tem peratures.

As a typical application of the present theory, we compare experimental results of UO $_2$ ^{35,36} and NpO $_2$. ³⁷⁽³⁹ In UO $_2$, the CEF ground state is a $_5$ triplet. ^{40,41} In this CEF ground state, the $_{4u}$ octupole moment is proportional to the dipole moment (see the inset of Fig. 1), and thus, we expect Curie-Weiss behavior. In Fig. 1, we show the temperature dependence of the magnetic susceptibility of UO $_2$, which follows the Curie-Weiss law very well above the antiferrom agnetic transition temperature 30 K at least up to 300 K.

In NpO $_2$, the CEF ground state is a $_8$ quartet. ^{21,22} In this CEF ground state, the $_{4u}$ octupole m oment is linearly independent of the dipole m oment (see the inset of Fig. 2), and the present theory is applicable. Indeed, as shown in Fig. 2, the magnetic susceptibility deviates from the Curie-W eiss law below 150 K. This temperature is much higher than the transition temperature 25 K. Moreover, this transition is probably a transition to an ordered state of $_{5u}$ octupole moments, $^{12\{17}$ which do not in uence the magnetic susceptibility at least within the mean-eld theory. Thus, this deviation of the magnetic susceptibility from the Curie-Weiss law is unlikely to stem from critical phenomena. Rather, the present theory can naturally explain this deviation, as shown in Fig. 2.

3. M icroscopic Approach

In the previous section, we have brie y reviewed the phenom enological approach to multipole physics, by focusing on the e ect of octupole moment on magnetic susceptibility in the paramagnetic phase. In order to obtain a deeper insight into the phenomena concerning multipole degrees of freedom, it is highly requested to proceed to a microscopic theory beyond the phenomenological level. For this purpose, we have recently developed the theory on the basis of a j-j coupling scheme. A fter

the explanation of the starting model, we show our microscopic theory for multipole ordering as well as recent development for the treatment of multipole uctuations.

3.1 Model in a j-j coupling scheme

In order to include the e ect of Coulom b interactions, spin-orbit coupling, and CEF potential in f-electron system s, the LS coupling scheme has been frequently used. However, it is not possible to apply standard quantum eld theoretical technique in the LS coupling scheme, since W ick's theorem does not hold. In order to overcom e this di culty, it has been proposed to construct a microscopic model for f-electron systems by exploiting the j-j coupling scheme, $e_{\mathbf{r}}^{24}$ where we include rst the spin-orbit coupling so as to de ne the state labeled by the total angular momentum j. For f orbitals with angular m om entum '= 3, we im m ediately obtain an octet with j = 7/2 (= 3 + 1/2) and a sextet with j = 5/2 (= 3 1/2), which are well separated by the spin-orbit interaction. Since the spin-orbital coupling is, at least, in the order of 0.1 eV for f electrons, it would be enough to take into account the j= 5/2 sextet, when we investigate lowtem perature properties of f-electron compounds in the j-j coupling scheme.

Then, the ${\tt H}$ am iltonian is written as

where a_r is the annihilation operator of the f electron with the z-component of the total angular momentum j=5/2 at site r, a denotes a vector connecting nearest-neighbor sites, t^a is the hopping integral between electron for -state at site r+a and that for -state at r, B is the CEF potential, and the Coulomb integral I in the j-j coupling scheme is expressed by using three R acah parameters, E_0 , E_1 , and E_2 . In this study, we use a simple form for the hopping integrals, i.e., we consider the hopping integrals through the (ff) bonding.

3.2 Multipole ordering

Concerning multipole ordering, we have already reported a microscopic approach by considering correct f-electron symmetry. 25,26 Thus, in this subsection, we brie y review the method and obtained multipole ordered states.

Let us consider again a cubic system for simplicity. In this case, it is convenient to express f-electron state in terms of the eigenstates, $_7$ and $_8$, in a cubic CEF potential. Annihilation operators for the $_8$ states are given by

where we introduce pseudo-spin index (= " and #) to distinguish the states in each K ram ers doublet, while orbital index distinguishes degenerate K ram ers doublets. Annihilation operators for the 7 states are given by

Now we consider the reduction of the Ham iltonian by suppressing 7 orbital, in particular, for actinide dioxides. The reasons are as follows: First, we note that the 7 wave-function extends along the [111] direction and other equivalent directions. Since in actinide dioxides, oxygen anions locate in these directions, the 7 state should be energetically penalized. Thus, it is expected to be higher than the 8 level. Second, when we accommodate two, three, and four electrons in the 8 orbitals, the ground states are $_5$, $_8^{(2)}$, and $_1$, respectively. In fact, these states have been found as the CEF ground states in UO_2 , 40,41 NpO₂, 21,22 and PuO₂, 42,43 respectively. Finally, the CEF excitation energy in PuO2 is as large as 123 m eV. It is expected to be the sam e order of magnitude as the splitting between the 8 and 7 levels, and thus we can ignore the 7 states at low temperatures.

A fter transform ing the Ham iltonian eq. (3.1) to that in the $_{7}$ - $_{8}$ basis, we simply discard the terms concerning 7 orbital. Then, we obtain the 8-orbital Hubbard m odelas

where $\mathfrak{T}_{0,0}$ is the hopping integral of an electron with (0 ; $^{'0}$) at site r+a to the (;) state at r, n. $=f_{r}^{y}$ f_{r} , and n_{r} = n_{r} . The coupling constants U, U, J, and J denote the intra-orbital, interorbital, exchange, and pair-hopping interactions, respectively. These are expressed in term sofR acah param eters, and we obtain the relation $U = U^0 + J + J^0$.

In order to estimate interactions among multipoles from the above 8-orbital model, we apply the secondorder perturbation theory with respect to the hopping integrals of 8 electrons, in a manner to estimate the superexchange interactions in d-electron systems. Here we note that the hopping integrals are depend on the pseudo-spin , orbital , and the direction of the hopping a due to the f-electron sym m etry. Thus, the hopping integrals depend on the lattice structures, and we obtain di erent multipole interactions for di erent lattices.

The obtained multipole interaction models have been further analyzed by using the mean-eld theory. For a \sin ple cubic lattice, we $\mbox{ nd a }_{3g}$ antiferro-quadrupole ordering at a nite tem perature, and as we lower the tem perature further, we nd another transition to a ferromagnetic state. For a bcc lattice, we nd a 2u antiferrooctupole transition, and a ferrom agnetic transition follows it. For an fcc lattice, we analyze the multipole interaction model carefully, since the foc lattice has geom etrical frustration. Thus, we rst evaluate multipole correlation functions num erically, and determ ine relevant interactions to the ground state. Then, we apply meaneld theory to a sim pli ed m odel including only these relevant interactions, and nd a 5u longitudinal antiferrooctupole ordering. This 5u ordering has been proposed for the ordered state of NpO2, in which Np ions forms an fcc lattice and the CEF ground state is a 8 quartet.

3.3 Multipole uctuations

In the previous subsection, we have reviewed our microscopic theory for multipole ordering. It is considered to be natural to attempt to extend our theory to treat multipole uctuations. In order to clarify multipole uctuations from a microscopic view point, again we resort to a m ethod which has been widely used in the d-electron research eld. Namely, we apply the uctuation exchange (FLEX) approximation to the model based on the j-j coupling scheme.

Although there is no essential diculty to consider a three-dimensional lattice, here we consider a twodim ensional square lattice for sim plicity. By keeping both 7 and 8 orbitals, we rewrite the model Hamiltonian (3.1) as

where $U = U \stackrel{0}{=} E_0$. Note that for simplicity, we consider the situation in which one of Racah parameters E_0 is nite and the other R acah param eters are zero, since the interactions between them are complicated in general. We believe that characteristics of multipole uctuations will be grasped even in this simplied model, as long as we treat the f-electron sym m etry correctly. In eq. (3.6), we have introduced CEF parameters and 0 , where denotes the splitting energy between 8 orbitals, while 0 indicates the splitting between $_{8}$ and $_{7}$ orbitals. Note also that is introduced to include partly the e ect of a tetragonalCEF potential.

In the present model, since the pseudo-spin is a conserved quantity, the G reen's function does not depend on . Then, the G reen's function is represented by 3 3 matrix. The D yson-G orkov equation in a matrix form is given by

The 6 6 m atrix 0 is obtained by using the operator equivalent m ethod for each multipole operator. We normalize 0 so that the sum of squares of eigenvalues is unity, for convenience.




Fig. 3. Ferm i surface and multipole response functions for = 0. (a) Ferm i surface for U = U 0 = 0. (b) $_{4u}$ dipole response functions. (c) $_{4u}$ octupole response functions. (d) $_{5u}$ octupole response functions.




Fig. 4. Ferm i surface and multipole response functions for = 2t. (a) Ferm i surface for U = U 0 = 0. (b) $_{4u}$ dipole response functions. (c) $_{4u}$ octupole response functions. (d) $_{5u}$ octupole response functions.

In the following, we show results for a 32 tice, at U = U = 4t, T = 0.02t, and = 0.1 he number of f electrons per site is one. In the calculation, we use 1024 Matsubara frequencies. In Figs. 3 and 4, we show the multipole response functions for = 0 and = 2t, respectively. Even for $^{0}=0$, the number n_{r} of electrons in the 7 orbital is alm ost zero for these model parameters, since the 7 orbital in the present model on a square lattice is localized and the system cannot gain kinetic energy by increasing the number of electrons in the 7 orbital. Thus, for these param eter sets, the present model is virtually equivalent to the 8 model, which has been already studied by Takim oto et al.44 The antiferrom agnetic uctuations pointed out by Takim oto et al. can be classied into multipole uctuations in f-electron system sas shown in Figs. 3 and 4.

For = 0, there is no signi cant structures in the multipole response functions, as shown in Figs. 3 (b) { (d). By changing the CEF parameter , the Fermi surface changes [see Figs. 3 (a) and 4 (a)], and the uctuations around the M point [q = (;)] become signicant. Then, the multipole response functions for the 4u dipole, $_{4u}$ octupole, and $_{5u}$ octupole m om ents enhance around the M point. On the other hand, the other multipole response functions do not enhance signi cantly. The 4u dipole and octupole components around at M point are naturally considered to compose antiferrom agnetic uctuations, but the enhancement of 5u octupole uctuation is quite peculiar. It seems to be interesting to seek for anom alous component of Cooper paring induced by 5u octupole uctuation. This is one of future problem s.

4. Sum m ary

In this paper, we have discussed three topics on multipoles in f-electron systems. First, we have explained e ects of octupole m om ents on the magnetic susceptibility in the paramagnetic phase of a cubic system. When the $_{\rm 4u}$ octupole moment is independent of the dipole moment as in the $_{\rm 8}$ CEF ground state, there are interactions between the $_{\rm 4u}$ octupole and dipole moments in

general. Then, the magnetic susceptibility deviates from the Curie-W eiss law even within the mean-eld theory. By considering such elects of octupoles, we can naturally understand the difference between the temperature dependence of the magnetic susceptibilities of UO $_2$ and NpO $_2$.

Second, we have derived multipole interactions from the microscopic model based on the j-j coupling scheme. Then, we have found several multipole ordered states, depending on the type of lattice structure. In particular, for an fcc lattice, we not the $_{5u}$ longitudinal triple-q antiferro-octupole ordering, which has been proposed for N pO $_{2}$ phenomenologically.

Finally, we have evaluated multipole response functions by applying the FLEX approximations to the j= 5/2 m odel including both the $_8$ and $_7$ orbitals. In f-electron systems, the complex uctuations, which are composed of spin, charge, and orbital degrees of freedom, can be classified into multipole uctuations. We will study such multipole uctuations by changing the CEF parameters, dimensionality, and Coulomb interactions, in order to clarify superconductivity relating to the

multipole uctuations in the near future.
