## Ferrom agnetism, param agnetism and a Curie-W eiss metal in an electron doped Hubbard model on a triangular lattice

M otivated by the unconventional properties and rich phase diagram of N  $a_x$  C oO  $_2$  we consider the electronic and magnetic properties of a two-dimensional Hubbard model on an isotropic triangular lattice doped with electrons away from half-lling. Dynam ical mean-eld theory (DMFT) calculations predict that for negative inter-site hopping am plitudes (t < 0) and an on-site C oulom b repulsion, U, com parable to the bandwidth, the system displays properties typical of a weakly correlated m etal. In contrast, fort > 0 a large enhancem ent of the e ective m ass, it inerant ferrom agnetism and a metallic phase with a Curie-W eiss magnetic susceptibility are found in a broad electron doping range. The di erent behavior encountered is a consequence of the larger non-interacting density of states (DOS) at the Ferm i level for t > 0 than for t < 0, which e ectively enhances the mass and the scattering amplitude of the quasiparticles. The shape of the DOS is crucial for the occurrence of ferrom agnetism as for t > 0 the energy cost of polarizing the system is much smaller than for t < 0. Our observation of N agaoka ferrom agnetism is consistent with the A-type antiferrom agnetism (i.e. ferrom agnetic layers stacked antiferrom agnetically) observed in neutron scattering experiments on Nax CoO2. The transport and magnetic properties measured in Nax CoO2 are consistent with DMFT predictions of a metal close to the M ott insulator and we discuss the role of N a ordering in driving the system towards the M ott transition. We propose that \C urie-W eiss metal" phase observed in N  $a_x$  C oO  $_2$  is a consequence of the crossover from  $\bad$  m etal" with incoherent quasiparticles at tem peratures T > T and Ferm i liquid behavior with enhanced parameters below T, where T is a low energy coherence scale induced by strong local C oulom b electron correlations. Our analysis also shows that the one band Hubbard model on a triangular lattice is not enough to describe the unusual properties of N  $a_x$  C oO  $_2$  and is used to identify the simplest relevant m odel that captures the essential physics in Na<sub>x</sub>CoO<sub>2</sub>. We propose a model which allows for the Na ordering phenomena observed in the system which, we propose, drives the system close to the M ott insulating phase even at large dopings.

#### I. IN TRODUCTION

One of the outstanding problems in quantum manybody physics is to understand quasi-two-dim ensional systems in which both electron-electron interactions and frustration e ects are strong.<sup>1</sup> New exotic phases are expected to result from the interplay of these e ects. Recently a num ber of materials have been discovered where the interplay of geom etrical frustration and strong electronic correlations lead to the emergence of unconventional phases. Examples of such materials include inorganic materials and organic charge transfer salts such as  $-(BEDT-TTF)_2Cu_2$  (CN)<sub>3</sub> or  $^0-Pd$  (dm it)<sub>2</sub> )X (Refs. 2 and 3 explain this nom enclature). A ntiferrom agnets on triangular lattices m ay be isotropic as in N iG  $a_2S_4$ , -(BEDT-TTF)<sub>2</sub>Cu<sub>2</sub> (CN)<sub>3</sub>, and, the material we will focus on, Na<sub>x</sub>CoO<sub>2</sub>, or anisotropic as in Cs<sub>2</sub>CuCl<sub>4</sub>, -(BEDT-TTF)<sub>2</sub>Cu N (CN)<sub>2</sub> Cl. There is also a great deal of interest in other frustrated geometries such as the Kagome and pyrochlore lattices. However,  $Na_xCoO_2$  has the, so far, unique property among strongly correlated triangular lattice compounds, that it can be doped. In

 $-(ET)_2Cu_2$  (CN)<sub>3</sub> a spin liquid state gives way to superconductivity when hydrostatic pressure is applied.<sup>4</sup>

The  $^{0}-\mathbb{P}d(\dim it)_{2}$  X series<sup>5</sup> of com pounds, C s<sub>2</sub>C uC l<sub>4</sub> (Ref. 6) and N iG a<sub>2</sub>S<sub>4</sub> (Ref. 7) m ay also show spin liquid behavior. Interestingly, the underlying structures of  $-(ET)_{2}Cu_{2}$  (CN)<sub>3</sub> and the  $^{0}-\mathbb{P}d(\dim it)_{2}$  X compounds are very sim ilar to that of N iG a<sub>2</sub>S<sub>4</sub> and N a<sub>x</sub>C oO<sub>2</sub> with either the organicm olecules, the N iatom sor the C o atom s arranged in a triangular geom etry. Understanding the physics of these system s in which both frustration and correlations are present is clearly a major challenge to theory.

M uch attention has been focused on the occurrence of superconductivity in Na<sub>x</sub>CoO<sub>2</sub> yHO. However, the non-superconducting, non-hydrated counterpart, Na<sub>x</sub>CoO<sub>2</sub>, displays m any interesting m agnetic and electronic properties. These include a charge ordered insulating state in a narrow band of doping around<sup>8</sup> x = 0.5, A -type antiferrom agnetism<sup>9</sup> for x & 0:75 and a m etallic phase with a Curie(W eiss susceptibility, (T) 1=(T + ), whose m agnitude is much larger than the Pauli susceptibility expected for a weakly interacting m etal<sup>8</sup> (the Curie(W eiss m etal). This phase also has an extrem ely large therm opower (of order k<sub>B</sub> =e) that is tem perature and eld dependent.<sup>10</sup> Foo et al. suggested<sup>8</sup> that the m etallic state for x < 0.5 should be regarded as param –

agnetic and the state for 0.5 < x < 0.75 be thought of as a Curie {W eiss m etal. These results should be com pared with the measurements of Prabhakaran et al.<sup>11</sup> which display a di erent behavior with the Curie-W eiss behavior strongest at x = 0.5 (the lowest value of x in their sample set) and the susceptibility becoming less tem perature dependent as x is increased. These di erences m ay be due to the rather di erent strength elds used in the two di erent experim ents,<sup>13</sup> a strong dependence on the direction of the eld or to some extrinsic e ect. For x > 0.75 A -type antiferrom agnetism (in-plane ferromagnetic ordering stacked in alternate directions along the c-axis) is observed.<sup>14,15,16,17</sup> On the triangular lattice this raises the interesting possibility of in-plane Nagaoka ferrom agnetism, 18 which we will discuss further below. There is also direct experimental evidence for strong electron-electron correlations which com es from unconventional behavior of transport properties. For instance, a Ferm i liquid like resistivity  $[(T) = _0 + AT^2]$ is only observed  $^{19}\,$  for T  $\,$  . 1 K , and the value of the K adowaki{W oods ratio is com parable to ruthenates and heavy ferm ions.<sup>19,20</sup> The low tem perature scale and the K adow aki-W oods ratio are strongly eld dependent with the system becoming more weakly correlated with increasing eld.

Interestingly, some of the above properties are rem iniscent of the predictions of the dynam ical mean-eld theory (DMFT) of the Hubbard model.<sup>21</sup> At half lling (n = 1) DMFT predicts a Mott m etal-insulator transition for U  ${\tt W}\,$  . In the metallic phase close to the  ${\tt M}$  ott transition there is a low temperature scale, T (n), at which there is a smooth crossover from a Ferm i liquid to an incoherent \bad m etal".<sup>21,22,23</sup> Transport properties display a crossover from those expected in a Ferm i liquid to properties characteristic of incoherent excitations as the tem perature is increased. W ithin the \bad m etal" phase, that is for T > T, electrons behave as quasilocalized m om ents which leads to a Curie-W eiss behavior of the magnetic susceptibility.<sup>21,22</sup> The above discussion suggests that DMFT, which treats the local electronic correlations exactly, may capture the relevant physics needed to describe the tem perature dependence of m any of the transport and m agnetic properties of N  $a_x C \circ O_2$ .

An important rst step in studying the properties of  $Na_x CoO_2$  is to consider the two-dimensional triangular lattice Hubbard model. This is motivated by the arrangement of the Co atoms and because correlation effects can be singled out and better understood in the simplest model. Related models such as the t J model on the triangular lattice have been recently analyzed using resonating valence bond (RVB) theory.<sup>12</sup> The implicit assumption in this kind of approach is that many important aspects of more realistic models for  $Na_x CoO_2$  are already contained in the simpler triangular lattice model. O ur present study, how ever, leads to the important conclusion that a single band Hubbard model on a triangular lattice is not enough to describe the magnetic and electronic properties of  $Na_x CoO_2$  and a more realistic model

is proposed.




FIG.1: Phase diagram for the electron doped Hubbard model on a triangular lattice obtained from DMFT calculations. U=jj is the ratio of the on-site C oulom b repulsion to the absolute value of the hopping matrix element t and n is the average num ber of electrons per site. The sign of thas a leads to qualitative changes in the phase diagram. In the t > 0 case, a ferrom agnetic metal and a metal with Curie-W eiss susceptibility are found. In contrast, for t < 0 a param agnetic metal appears throughout the phase diagram. To make a direct com parison with Na<sub>x</sub> C OO<sub>2</sub> one should note that x = n 1.

Ourmain nding, sum marized in Fig. 1, is that DMFT predicts dram atic changes in the behavior of the Hubbard model on a triangular lattice when the sign of t is changed. For t > 0 we nd signi cant e ects due to strong electronic correlations. We nd that in the electron doped triangular lattice a Curie-W eiss m etal and m etallic ferrom agnetism arise when only local C oulom b correlations are taken into account. The Curie{W eiss m etal occurs for su ciently large C oulom b repulsion energies U & W and t > 0, where W is the bandwidth. In this parameter region, the local magnetic susceptibility smoothly changes from the Curie form characteristic of local m om ents at high tem perature to Ferm i liquid behaviorat low tem peratures, T < T (n)  $_{\rm F}$ , where  $_{\rm F}$  is the Ferm i energy. In the Curie-W eiss m etal the uniform susceptibility is strongly enhanced by both band narrow ing due to correlations and the proximity to the ferrom agnetic instability. In contrast, the electron doped triangular Hubbard model with t < 0 and U & W displays Pauli param agnetism weakly enhanced by the Coulom b repulsion; a behavior typical of weakly correlated m etals. Thus our analysis shows how the non-interacting dispersion has a dram atic e ect on the electronic and m agnetic properties of a frustrated Hubbard model. Thus, our work is relevant to DMFT applications on realm aterials where sim ilar LDA density of states appear helping to understand the physics in the more complicated situations.

The remainder of this paper is organized as follows. In Sec. II we introduce the Hubbard model on a triangular model discussed above, and then exam ine the solution of this model on three sites which already contains som e features of, and gives signi cant insight too, the solution of the triangular lattice in the therm odynam ic lim it. In Sec. III we introduce the main DMFT equations and present argum ents which suggest that DMFT, which is only exact in in nite dimensions, may capture the essential physics of the Hubbard model on a twodim ensional triangular lattice due to frustration. In Sec. IV we analyze the tem perature dependence of the local and uniform magnetic susceptibilities for both t < 0 and t > 0. In Sec. V we analyze the local correlation e ects and the electronic properties of the model. We report spectral densities and self-energies in both signs of t and their relation with the di erent m agnetic susceptibilities found in Sec. IV. In Sec. VIwe show that fort > 0 and electron doping we nd Nagaoka ferrom agnetism . In Sec. V II we discuss the experimental situation on N  $a_x C \circ O_2$ in the light of our results. In Sec. VIII we discuss im provem ents and extensions to both the model and the approximation used to study it, we argue that multiple band models and particularly the e ects of ordering of the N a ions are essential to understand the behaviour observed in  $Na_xCoO_2$ . The paper ends in Sec. IX in which a summary of main results is given and our conclusions are drawn.

## II. THE HUBBARD MODELON A TRIANGULAR LATTICE

As stated in the introduction, we analyze the magnetic and electronic properties of a Hubbard model on a triangular lattice,

where ,t and U are the chem ical potential, the nearest-neighbor hopping am plitude and the on-site C oulom b repulsion energies, respectively,  $c_i^{(y)}$  (creates) destroys an electron on site i with spin , h:::i indicates that the

sum is over nearest neighbours only and the num ber operator is  $n_i \qquad \ \ \, c_i \ \ \, .$ 

For U = 0 the above model gives a tight-binding dispersion

with bandwidth W = 9 j.j.

## A. Review of previous work

For the Hubbard model on the square lattice at half lling, the ground state is believed to be a M ott insulator with N eel order for all values of U=t. The fact that this occurs even for arbitrarily sm all U=t is due to the perfect nesting of the non-interacting Ferm i surface at half lling. In contrast, the triangular lattice m ay exhibit diverse phases as U=t is varied. Possible ground states that have been proposed include the M ott insulator, com m ensurate non-collinear antiferrom agnetism , incom m ensurate spin-density wave (both m etallic and insulating), spin liquid, superconducting, and m etallic states.

In the strong correlation lim it, U t, there is a gap in the charge excitation spectrum and the ground state is a M ott insulator. The spin excitations are described by an antiferrom agnetic H eisenberg m odel on the triangular lattice with exchange constant  $J = 4t^2 = U$ . Num erical calculations from a range of techniques including exact diagonalisation,<sup>24</sup> variational quantum M onte Carlo,<sup>25,26</sup> coupled cluster methods,  $r^{27}$  and series expansions  $s^{28,29}$ suggest that this has a m agnetically ordered ground state in which neighbouring spins are rotated by 120 degrees relative to one another, as in the classical ground state. This agrees with the predictions of spin wave theory.<sup>30</sup> However, series expansions calculations suggest that the excitation spectrum is qualitatively di erent from that predicted by non-linear spin wave theory.<sup>31</sup>

At half-lling there is no nesting of the non-interacting Ferm i surface and so for sm all U =t a m etallic state is possible. Exact diagonalisation calculations of the D rude weight for lattices with 12 sites suggest that there is a rst-order transition from a metal to a Mott insulator when U ' 12:1 t,<sup>32</sup> mean-eld RVB calculations in the therm odynam ic lim it nd a remarkably sim ilar result with a rst order M ott transition occurring at U ' 12:4 t.<sup>33</sup> W hen U 4t the e ective spin Ham iltonian in M ott insulating phase should include ring exchange term s of order  $t^3 = U^2$  (R ef. 34). On the triangular lattice this can lead to a spin liquid ground state.<sup>35</sup> The possible realisation of a spin liquid in  $-(ET)_2Cu_2(CN)_3$ (Ref. 4) has stimulated the proposal of specic analytical theories for the ground state in this regim  $e^{36,37}$  In this param eter regime a superconducting ground state with  $d + id sym m etry_1^{38}$  or odd frequency pairing<sup>39</sup> have also been proposed [it is therefore interesting to note that odd frequency pairing has also been discussed on the basis

of speci c m icroscopic calculations for  $Na_x CoO_2$  yHO (Ref. 40)].

Hartree-Fock<sup>41</sup> and slave boson mean-eld calculations<sup>42</sup> have found that near the metal-insulator phase boundary that incommensurate spin-density wave states are also stable. Simulated annealing calculations of mean-eld solutions with large possible unit cells found that for U = 2t and U = 4t that the most stable states were metals with charge and spin ordering.<sup>43</sup>

For electron doping away from half-lling and U t, doubly occupied states can be projected out and a t J m odel can describe the system . Extensive studies of this m odel have been m ade. 12,44 These studies show that the sign of t has a signi cant e ect on the type of ground state.<sup>12</sup> RVB calculations<sup>12,44</sup> found that, fort > 0, d+ id superconductivity was possible for a range of dopings and suggested a variety of unusualm etallic states. Series expansions<sup>45</sup> have emphasized the competition between singlet and triplet form ation on the triangular lattice in term s of competition between RVB states and Nagaoka ferrom agnetism . This work concludes that for hole doping the RVB state is favoured by t > 0 and the N agaoka state is favoured by t < 0. Changing the sign of t is equivalent to changing from electron to hole doping, therefore this result is entirely consistent with the results sum marised in Fig. 1. A more detailed comparison between our results and those of K oretsune and O gata<sup>45</sup> will be given in Sec. VI.

#### B. Relevance to N $a_{\rm x} C \mbox{ oO}_2$

For Na<sub>x</sub>CoO<sub>2</sub> the LDA bandwidth gives jj 0:1 eV.<sup>47,48</sup> For electron doping the dispersion (2) leads to a Ferm i surface which is hole-like for t < 0 and electron-like for t > 0, thus t < 0 is roughly consistent with the band structure calculations and angle resolved photoem ission spectroscopy (ARPES) experiments for  $Na_x CoO_2$ . However, the band structure of Na<sub>x</sub>CoO<sub>2</sub> is still controversial. ARPES<sup>46</sup> seems to sugqest that a simple tight binding model with t < 0 on the triangular lattice may be su cient to describe the  $a_{1g}$  bands of N  $a_x$  C oO 2. How ever, even within a single band model hopping matrix elements up to at least 3rd nearest neighbors48,49,50 need to be included in order to correctly reproduce the LDA band structure. Further, LDA calculations<sup>47,48</sup> predict the existence of six sm all elliptical hole pockets near to the K-points if x. 0:6. It is not clear, at this point, whether or not the elliptical pockets actually exist.<sup>51,52</sup> In contrast to the  $a_{1g}$  bands, the LDA dispersion of the  $e_{1q}$  bands is better tted to a t > 0 triangular lattice tight-binding dispersion<sup>48</sup>.

Several attem pts<sup>46,47</sup> have been m ade to estimate U for Na<sub>x</sub>CoO<sub>2</sub>; all of these nd that U W. This is much larger than in the organic charge transfer salts such as  $-(ET)_2Cu_2$  (CN)<sub>3</sub> or  $^0-Pd$  (dm it)<sub>2</sub>X, in which U & W (R ef. 53 and references therein).

It is worth keeping in mind the limitations of this

Ham iltonian as a model for  $Na_x CoO_2$ . For instance, the charge ordered state observed in a narrow region around x = 0.5 seems likely to be due to the response of the electronic system to the ordering of the Na atom s which is observed even at high temperatures by x-ray di raction.<sup>8</sup> Therefore one does not expect this phase to appear in purely electronic models such as those considered here. Nevertheless, before attem pting to understand more complicated models with realistic band structures (including possibly multiple bands) or including the effects of N a ordering, it is important to have a m understanding of strong correlations in sim ple frustrated m odels. Therefore, despite the remarks above, we present below a DMFT study of the Hubbard model on a triangular lattice (1). In section V IIIB we discuss extensions to the Hubbard model which allow one to investigate such e ects.

### C. K inetic energy frustration

G eom etrically frustrated antiferrom agnetism has been studied extensively and the triangular lattice provides a m odel system to investigate. Three of the m ost w idely used quantitative m easures of frustration in antiferrom agnets are (i) the degeneracy of the ground state, (ii) the m agnitude of the entropy at low tem peratures, and (iii) the ratio of the ground state energy to the total energy of m axim ising the individual interaction energies.<sup>31</sup>

In a non-interacting electron model the only proposal we are aw are of for a quantitative measure of the geom etrical frustration of the kinetic energy is due to Barford and K im  $.^{54}$  They noted that, for t > 0, an electron at the bottom of the band does not gain the full lattice kinetic energy, while a hole at the top of the band does. They suggested that for tight binding models a measure of the frustration is then =  $j_k^{max} j_k^{min} j_k^{min}$  where  $k_k^{max}$ and  $k^{m \text{ in}}$  are the energies (relative to the energy of the system with no electrons) of the top and bottom of the band respectively. This frustration increases the density of states for positive energies for t > 0 (negative energies for t < 0) which represents an increased degeneracy and enhances the many-body e ects when the Ferm i energy is in this regime. However, perhaps a simpler measure of the kinetic energy frustration is  $W = 2z \pm j$ , where W is the bandwidth and z is the coordination number of the lattice. The sm aller this ratio, the stronger the frustration is, while for an unfrustrated lattice  $W = 2z \pm j = 1$ . For example, on the triangular lattice the kinetic energy frustration leads to a bandwidth, W = 9 ti instead of 12 t j as one m ight naively predict from W = 2z t j since z = 6.

We show below that geometrical frustration of the kinetic energy is a key concept required to understand the properties of the Hubbard model on the triangular lattice. In particular it leads to particle-hole asymmetry which enhances many-body elects for electron (hole) doped t > 0 (t < 0) lattices.

It should be noted that geom etrical frustration of the kinetic energy is a strictly quantum mechanical e ect arising from quantum interference. This interference arises from hopping around triangular clusters which will have an amplitude proportional to t<sup>3</sup> which clearly changes sign when t changes sign. In contrast on the, unfrustrated, square lattice the sm allest possible cluster is the square the am plitude for hopping around a square is independent of the sign of t as it is proportional to  $t^4$ . Barford and K im  $^{54}$  noted that the phase collected by hopping around a frustrated cluster may be exactly cancelled by the Aharonov-Bohm phase associated with hopping around the cluster for a particular choice of applied magnetic eld. Thus a magnetic eld may be used to lift the e ects of kinetic energy frustration. The quantum mechanical nature of kinetic energy frustration is in distinct contrast to geom etrical frustration in antiferrom agnets which can occur for purely classical spins.

## D. The Hubbard model on a triangular cluster

## 1. Non-interacting case (U = 0)

In order to gain som e basic insights into som e of the rich physics associated with the triangular lattice Hubbard m odel, we now review the exact solution on a single triangle. This is the simplest possible model with kinetic frustration and strongly correlated electrons. This m odel already contains som e of the features found in the solution of the Hubbard model on the triangular lattice in the therm odynam ic lim it and gives signi cant insight into that problem. In particular the solution of this toy problem illustrates why the sign of t is important and why ferrom agnetism arises in the solution to a problem that only contains kinetic, local and (via superexchange) antiferrom agnetic interactions.

Let us begin by recalling the solution of the two site cluster with U = 0 and spinless ferm ions. Let us label the W annier functions on the two sites 11 and 12i. For t > 0 the single electron ground state is the bonding orbitalwith wavefunction  $ji = \frac{p^2}{p^2}$  (jli + j2i) and energy E = t = jj. For t < 0 the single electron ground state is the antibonding orbital with  $ji = \frac{p^2}{2}$  (jii) j2i) tj. (Note that in general changing the and E = t =sign oft reverses the ordering of the energy levels.) Thus W = 2t for the two site cluster which, as z = 1 for the two site lattice, tswith the general expectation that, for an unfrustrated lattice, the bandwidth is given by 2zt.

The ground state of the U = 0 triangular cluster has some signi cantly di erent properties compared to the two-site cluster. For t > 0 the single electron ground state is completely bonding with  $ji = \frac{p_{-1}^1}{3}(jli + jli + jli)$ and E = 2t = 2jj but for t < 0 we cannot construct a completely antibonding solution and so the single electron ground state is degenerate with  $ji = \frac{p_{-1}^1}{6}(jli + jli + jli)$  or  $ji = \frac{p_{-1}^1}{6}(jli + jli + jli)$  and

t>0:




FIG.2: Energy cost in spin polarizing the three site triangular cluster with four non-interacting electrons. For t > 0 the ground state is degenerate and there is no energy cost in ipping one spin. In contrast, it costs 3 ± j to polarize the t < 0cluster. This indicates that the tendency to ferrom agnetism of the electron doped t > 0 triangular cluster is much stronger than that of the cluster with t < 0 even at the one-electron level.

E = t = 1; Thus even at the non-interacting level the bandwidth is reduced (W = 3t, z = 2 which implies W = 2zt = 3=4) by the elects of geometric frustration.

M oving to noninteracting spin 1=2 ferm ions, one can already see how the three site cluster with t > 0 is easier to magnetize than the t < 0 case. In Fig. 2 the energy level structure of the t < 0 and t > 0 three site clusters containing four electrons are displayed. It costs no energy to ip one spin in the cluster, E = E ("""#) E ("#"#) = 0, for t > 0 whereas there is an energy cost of  $E = 3 \pm j$ associated with ipping a spin in the t < 0 case. W e will see in section VI that this tendency to ferrom agnetism persists in the non-interacting triangular lattice.

#### 2. Interacting case (U > 0)

For a strongly interacting system the lling factor n will play an important role in the solution. A non-trivial case in the triangle relevant to  $Na_x CoO_2$  is  $n = \frac{4}{3}$ . The  $n = \frac{5}{3}$  case is trivial as is simply the case of a single (and therefore non-interacting) hole, while the half lled case will not be studied in detail in this paper. The relevant basis set is rather di erent from that for non-interacting particles and we therefore illustrate the solution in Fig. 6. To represent this basis set m ore precisely we will adopt the notation j;; i where the values of

, and indicate the state on the rst, second and third sites respectively. We allow , and to take the values 0, indicating an unoccupied site, ", indicating a site singly occupied with a spin up electron, #, indicating a site singly occupied with a spin down electron, and which indicates a doubly occupied site.<sup>55</sup> For t < 0 we nd that for any nite U the ground state has energy<sup>56</sup>

and the normalisation factor is  $A = {}^{P} \frac{3+3\cos^2}{3+3\cos^2}$ . Clearly, ! 0 as U ! 1 and ! =4 as U ! 0. We sketch this wavefunction in the low erpart of gure 3.

j i is a superposition of the resonating valence bond state and the states with two doubly occupied sites. The fact that ! 0 as U ! 1 indicates that the am plitude for having two doubly occupied sites vanishes in this lim it as one expects. Clearly j i has no net m agnetization, this state leads to the param agnetic state found in the therm odynam ic lim it for t < 0 (c.f. gure 1). j i has signi cant short-range antiferrom agnetic spin uctuations, which are not captured in the purely local DMFT treatment that follows, although it is likely that these persist in the true therm odynam ic ground state (see section IIA).

For any nite U and t> 0 the ground state has energy  $E_{+} = 2t + U$  and is threefold degenerate. All three states are spin 1 and three degenerate states correspond to  $S_{z} = 1;0$  and 1. The respective eigenstates correspond to superpositions of triplets and are




FIG. 3: (Color online). A pictorial representation of the ground states of the Hubbard model on a triangular cluster with four electrons. Doubly occupied sites are indicated by the presence of two arrows, one pointing up and the other pointing down, while unoccupied sites have no arrows. In the cases where we have only one doubly occupied site the remaining sites with only one electron can form either a singlet (indicated by a thick red line with arrows on the two sites pointing in opposite directions) or a triplet (indicated by a thick blue line with arrows on the two sites pointing in the sam e direction). Thus, the m iddle left triangle indicates the state  $\frac{p^{\perp}}{2}$  (j ; "; #i j ; #; "i). The top left triangle indicates one the three states  $j #; #; i, \frac{p^2}{2} (j "; #; i + j #; "; i)$  or j";"; i.<sup>55</sup> To keep the gure as simple as possible we have not included normalization factors in the gure, but the correct norm alizations are given in Eqs. (4), (6), (7) and (8). The lower part of the gure illustrates j i, the ground state for any non-zero value of U and t < 0 [c.f. eqn. (4)] (the ground state is degenerate for t < 0 and U = 0). The upper part of the gure illustrates all three degenerate states  $j_{+}^{*}$  i,  $j_{+}^{0}$  i and  $j_{+}^{"}$  i as these only dier by the value of the S  $_{z} = 0$ projection of the triplet. These states are the ground states fort < 0 and any value of U [c.f., eqns. (6), (7) and (8)]. j i depends on the variable which is a function of the ratio  $U = t_r$ given by eqn. (5). ! 0 as U ! 1 ; = -4 for U = 0.

These wavefunctions are illustrated in the upper part of gure 3.

 $j_{+}^{*}i, j_{-}^{0}i$  and  $j_{+}^{*}i$  display short range ferrom agnetic uctuations for all nite U, in particular the total spin of the system is a maximum along one axis as the ground state consists of a superposition of triplets. As the ferromagnetism is associated with kinetic energy frustration, we have a N agaoka type ferrom agnet for any nite value of U. In the calculations for the in nite triangular lattice with t> 0 presented below we will again see this type of magnetism for som e llings, but with a phase transition from a Curie-W eiss metal to a Nagaoka ferrom agnet at some nite value of U, as is shown in Fig. 1.

In order to quantify the nature and m agnitude of the spin interactions induced by the correlations we evaluate the expectation value of  $S_i S_j$  for neighbouring sites on the triangle. We nd that for t > 0, this expectation value is 1/12, whereas for t < 0 it is  $\cos^2 = \beta (1 + \cos^2) ]$  which become smore negative with increasing U and tends to -1/6 for U j.j. For reference, for the two site H ubbard m odel, with two electrons, this expectation value is always negative, regardless of the sign of t, indicating antiferrom agnetic spin correlations. Here, we see that for the triangular cluster, the sign of t determ ines whether the nearest neighbour spin correlations are ferrom agnetic or antiferrom agnetic.

### III. DYNAM ICAL MEAN-FIELD THEORY

# A. Relevance of DMFT to the two dimensional triangular lattice

Before presenting our results an important issue to address is the relevance of DMFT to model (1) which describes a two-dimensional system. DMFT is only exact in in nite dimensions or for a lattice with in nite coordination number. We will see below that an important role of the triangular lattice, as compared to other, nonfrustrated, lattices, is not just that the shape of the bare DOS changes (which is extremely important) but also to make DMFT a good approximation.

DMFT has become an important tool in the description of strongly correlated systems. It has provided a realistic description of transport and dynam ical properties of materials such as transition metal oxides and layered organic superconductors with frustrated lattices such as  $-(BEDT-TTF)_2X$  where X is an anion, e.g., I<sub>3</sub> or Cu<sub>2</sub> (CN)<sub>3</sub>. The -(BEDT-TTF)<sub>2</sub>X fam ily have a phase diagram (as a function of pressure, uniaxial stress, or chemical substitution) in which a superconducting phase is in close proximity to a M ott insulating phase. In the metallic phase of the  $-(BEDT-TTF)_2X$ there is a temperature scale, T , at which there is a smooth crossover from a Fermiliquid to an incoherent \bad metal" [characterized by the absence of a D rude peak in the frequency dependent conductivity, a resistivity of the order of the Io e-Regel-M ott lim it (~= $e^2a$ , where a is the lattice constant), a therm opower of the order of k<sub>B</sub> = jej and a non-monotonic temperature dependence of the therm opower and resistivity].<sup>23,59</sup> The tem perature dependence of transport properties displays a crossover from coherent Ferm i liquid behavior to incoherent excitations. In the case of the organic superconductors it has been found that the DMFT of the Hubbard m odel gives both a qualitative<sup>23</sup> and quantitative<sup>59</sup> description of this crossover from a Ferm i liquid to a \bad m etal" in which there are no quasi-particles.

The crossover tem perature scale is related to the de-

struction of K ondo screening and Ferm i liquid behavior with increasing tem perature (above the K ondo tem perature  $T_K$  ) in the Anderson model (which is the e ective model solved in the DMFT equations as described above). In the Anderson model the conduction electrons are strongly scattered by a (localised) magnetic im purity for  $T > T_K$ . But for  $T < T_K$  a singlet form s between the impurity and the conduction electrons. In the DMFT of the Hubbard model for T > T the electrons are quasi-localised and the electrons on the single site treated exactly strongly scatter those in the bath. How ever, for T < T transport is coherent and the electrons only scatter one another weakly, thus Ferm i liquid behaviour is regained. This is why, for example, the tem perature dependence of the resistivities of the Anderson and Hubbard models are so sim ilar.

The success of DMFT in describing the transport properties and the phase diagram of many organic charge transfer salts down to tem peratures of about 10-20 K (where, for example, superconductivity becomes in portant) has been rather puzzling given that these materials are quasi-two-dimensional and DMFT is only expected to be a good approximation in the limit of high dimension or co-ordination number. However, the applicability of DMFT to low-dimensional systems with large frustration is consistent with the fact that for frustrated m aqnetic models a Curie-W eiss law holds down to a much lower temperature than for unfrustrated models  $^{60,61,62}$ indicating the presence of well form ed local moments. Recently, Zheng et al.<sup>62</sup> calculated the tem perature dependence of the magnetic susceptibility of the antiferrom agnetic H eisenberg m odel on an anisotropic triangular lattice. They found that form odels close to the isotropic triangular lattice (i.e., models with signi cant magnetic frustration) that the Curie-W eiss law (which is a mean-

eld, single site approximation) holds down to relatively low tem peratures. Deviations from Curie-Weiss behavior result from spatially dependent correlations. Hence, we expect that a DM FT treatm ent of the Hubbard modelon the triangular lattice will be a good approxim ation down to much lower temperatures than unfrustrated models. Furtherm ore, in the \bad m etal" region m agnetic properties such as the uniform susceptibility and spin relaxation rate, can be described by the Heisenberg model because the electrons are essentially localized due to the proximity to the M ott insulating phase. This means that the susceptibility can be t to a Curie-Weiss form down to tem peratures much less than the exchange energy J. Furtherm ore, the spin correlation length of the antiferrom agnetic H eisenberg m odel increases with tem perature T much more slowly for the triangular lattice than the square lattice.<sup>63</sup> Speci cally, at T = 0:3J the spin correlation length is only one lattice constant for the triangular lattice. In contrast, for the square lattice the correlation length is about 50 lattice constants, at T = 0.3J.<sup>63</sup>

The above arguments have been recently tested by means of cluster DMFT calculations. These calculations show how for the isotropic triangular lattice the solution

coincides with single site DMFT (in particular a quasiparticle peak appears at the Ferm i energy). However, as soon as frustration is released a pseudogap opens up in the one-electron spectra as a result of short range antiferrom agnetic correlations.<sup>64</sup>

A further hint that DMFT is a better approximation on the triangular lattice than on the square lattice com es from the fact that we nd that at half lling our calculationspredict that the M ott transition occurs at U<sub>c</sub> 15ti (see Figs. 1 and 9). This com pares with exact diagonalization studies on 12 site lattices<sup>32</sup> which nd that the M ott transition takes place at U 12 j. 0 n the square lattice it is known that perfect nesting means that the ground state is a M ott insulator for any nite U. However, DMFT predicts<sup>21</sup> that U<sub>c</sub> 12 j un less antiferrom agnetism is included. Thus (without including antiferrom agnetism ) DMFT gives a qualitatively incorrect result for the (unfrustrated) square lattice, but a qualitatively correct result for the (frustrated) triangular lattice.

## B. Form alism

The electronic and magnetic properties of the Hubbard model on the triangular lattice (1) are analyzed below using DMFT.<sup>21</sup> P reviously, various properties of doped M ott insulators on an hypercubic lattice have been explored within DMFT in the context of the high- $T_c$  superconductors<sup>22</sup> using Q uantum M onte C arlo (QMC) techniques. Here, we apply DMFT to a frustrated lattice and use exact diagonalization and Lanczos techniques to solve the associated Anderson in purity problem <sup>57</sup> at - nite and zero temperature, respectively.

W e will now brie y describe the DMFT form alism focusing on the relevant equations and quantities of interest in this work. For a more detailed discussion see, for example, Ref. 21. DMFT treats the quantum dynam ics on a single site exactly and the remaining lattice sites provide a bath with which this site interacts. One may map the Hubbard model onto an Anderson single-impurity model which must be solved self-consistently. The bath is described through the W eiss eld, G<sub>0</sub> (i!<sub>n</sub>). The iterative procedure starts by solving the Anderson model for a given choice of G<sub>0</sub> (i!<sub>n</sub>). From the on-site G reens function, G (i!<sub>n</sub>) we may obtain the self-energy of the system

#### 1. Magnetic susceptibilities

#### 2. Num ericalm ethods

D ue to the rapid convergence of the solution with the bath size<sup>57</sup> it is su cient to use a discrete set of states of  $n_s = 6$  10 sites to m odel the electronic bath in order to obtain reliable results. In what follows we use Lanczos diagonalization on  $n_s = 8$  sites to calculate zero tem – perature properties. In Sec. IV we also present results for high tem peratures for which the Lanczos technique is not adequate, we therefore use exact diagonalization to solve the A nderson in purity problem . How ever, as exact diagonalization is m ore com putationally expensive than Lanczos diagonalization we are limited to  $n_s = 6$  for these calculations. Further it is wellknow  $n^{21}$  that for exact diagonalization there is a low energy scale  $T^{ns} = E_1 = E_0$ ,

where E<sub>0</sub> and E<sub>1</sub> are respectively the ground state energy and the energy of the rst excited state of the system (recall that there is a nite energy gap to the rst excited state because of the nite bath size), below which the results of exact diagonalization calculations are not trustworthy. We therefore present exact diagonalization results for nite temperatures with T > T<sup>ns</sup> and Lanczos data valid in the T ! 0 limit. Combining the two m ethods allow s us to have a rather com plete description of the T-dependence of various properties.

### IV. TEM PERATURE DEPENDENCE OF MAGNETIC SUSCEPTIBILITY

W e now analyze the behavior of the uniform and local m agnetic susceptibilities obtained from DMFT for the Hubbard m odel on the triangular lattice for both t > 0 and t < 0. We not that the two di erent signs of the hopping integrallead to very di erent magnetic responses (c.f. Fig. 1) and that Curie-W eiss m etallic behavior appears when t > 0 but not for t < 0.

#### A. Local M agnetic susceptibility

The degree of localization of the electrons in the triangular lattice with di erent signs of t can be explored by computing the imaginary time, , local spin autocorrelation function,

It then follows that H () = H (), as one expects for the correlation function of commuting operators,<sup>66</sup> and H () should be symmetric about = =2. The function H () is related to the local susceptibility at M atsubara frequencies by equation (15).

The simplest possible form that the frequency dependent local susceptibility  $_{\rm loc}(!)$  [com pare equations (16) and (17)] can take is a \D rude" type form with a single relaxation rate, ,  $_{\rm loc}(!) = _0 = (1 + i! = )$ , leading to a Lorentzian form for the spectral density. We note that for a single in purity Anderson m odel it was found that this D rude form of the relaxation rate is a good approximation for tem peratures larger than the K ondo tem perature.<sup>67</sup>




FIG. 4: (Color online.) The imaginary time local spin autocorrelation function for both t > 0 and t < 0 with n = 1.3, U = 10 j and = 3= j. The larger values of hS<sub>z</sub>(0)S<sub>z</sub>(= =2)i for t > 0 than for t < 0 indicates the greater degree of localization of the electrons for t > 0.


recovering the C urie law for localised m agnetic m om ents. In F ig. 4 we have plotted  $hS_z(0)S_z()$  if for U = 10 j n = 13 at inverse temperature of = 3= j for both t > 0 and t < 0. Indeed we nd that electrons for the t > 0 triangular lattice (weak -dependence) are m ore localized than those in the t < 0 case (strong -dependence). B oth curves are symmetric about = 2 as is required.

We nd that  $hS_z(0)S_z()$  is not constant for either sign oftwhich re ects spin relaxation processes and the fact that electrons are not completely localized. The actualbehavior at large temperatures is not the pure C urie behavior of Eq. (21) but rather, to a good approxim ation, can be tted to the C urie W eiss form

where, T (n), is again the coherence scale.

In Fig. 5 we plot  $1 = l_{\text{loc}}(T)$  from the actual num erical results obtained from DMFT for di erent electron occupation comparing t > 0 with the t < 0 case. Over a broad tem perature range the tem perature dependence is consistent with a Curie-W eiss form. How ever, the coherence scale is much larger for t < 0 than for t > 0.



#### B. Uniform M agnetic susceptibility




FIG.6: (Color online.) Curie-W eiss versus param agnetic behavior of the uniform susceptibility, (T), for the Hubbard model on the triangular lattice with U = 10 J; The inset shows (T)= 0 (where 0 is the zero temperature non-interacting magnetic susceptibility) comparing the strong T - dependence for t > 0 with the nearly temperature independent behavior for t < 0 (Pauli param agnetism). For n = 1:4 ferrom agnetism appears below a critical temperature, T<sub>c</sub>. The main panel displays the inverse of the uniform susceptibility,  $_0 =$  (T), showing the Curie-W eiss T-dependence for t > 0. The arrow indicates the coherence temperature T found from tting the local susceptibility data in Fig. 5 to Eq. (22).

In Fig. 6 we show the temperature dependence of (T) = 0 for the triangular lattice with t > 0 and U = 10 to the triangular lattice with t > 0 and U = 10 to the triangular lattice. We not that the temperature dependence of the uniform magnetic susceptibilities are very di erent for the di erent signs of the hopping integral. The magnetic susceptibility displays Curie-W eiss behavior at large temperatures when t > 0 whereas for t < 0, (T) displays the Pauliparam agnetism characteristic of a weakly correlated m etal.

We now discuss the t > 0 case in more detail. To be speci c, for t > 0 and at high tem peratures, the uniform susceptibility can be tted to the expression

(n) and depend on U and n. Note that the where tem perature scale (n) reduces to (n) =₹, where T<sub>c</sub> is the critical tem perature at which the ferrom agnetic transition occurs for certain values of n, (1:35. n. 1:6 for U = 10 j; see section VI for details). The Curie-Weiss behavior described by Eq. (23) is valid for large tem peratures, T > T (n). This is because in this tem perature regime the electronic system behaves like a set of quasi-localized magnetic moments. For T < T (n) the Curie-W eiss behavior crosses over to a behavior more rem iniscent of a renorm alized Ferm i liquid with a weak temperature dependence. Fitting our results to Eq. (23) for T > T (n), gives (n = 1:7) 0:17 tj and 0:01 to n = 1:3. For the ferrom agnetic (n = 1:3)m etal appearing for, say, n = 1:38, the transition to a ferrom agnetic m etal occurs at  $T_C =$ (n = 1:4)0:05 tj.

The elective magnetic moment, obtained from the tting varies between = 0.7 B for n = 1.3 and = 0.4 B for n = 1.7.




FIG. 7: (Color online.) Electron occupation dependence of the coherence scale, T (n), the Curie-W eiss scale (n) and the e ective m om ent in the uniform magnetic susceptibility, for xed U = 10 tj and t > 0. These parameters are extracted by tting the results of our DMFT calculations of magnetic susceptibilities to Eqs. (22) and (23). For these values of U and t ferrom agnetism is observed in the range 1:3 < n < 1:6(c.f. Fig. 1). (n) > 0 for n < 1:3 and no ferrom agnetism is found at these dopings. decreases to zero as n ! 2 as the density of unpaired electrons decreases. This appears to be responsible for the absence of ferrom agnetism for n > 1:6.

Asn is increased one expects that the average m om ent will be roughly proportional to the density of unpaired electrons, 2 n, at each lattice site. Thus <sup>2</sup> is suppressed with increasing n and xed U. Hence one expects that <sup>2</sup> varies between =  $_{\rm B}$  for n = 1 (half-led system) and = 0 for n = 2 (led band). This is consistent with the values of obtained from the tofEq. (23) to our num erical results (see the inset of Fig. 7). As the tem perature is decreased the susceptibility changes its behavior so that  $_0 = (T)$  becomes less dependent on temperature (this is most obvious for n = 1.7). A crossover from Curie-W eiss behavior at high tem peratures to Ferm i liquid behavior at low tem peratures is encountered. The properties of the Ferm i liquid state (e.g., e ective mass renorm alization, susceptibility enhancem ent) at low tem perature will be discussed in the following section.

In Fig. 7 we show a plot of both temperature scales obtained from thing our data to the Curie-W eiss laws of Eqs. (22) and (23) to obtain, T (n) and (n), respectively. T (n) increases with the electron occupancy. This is to be expected as the system becomes more weakly correlated in the n ! 2 limit, remaining coherent at temperatures comparable with the non-interacting Ferm i temperature. On the other hand, (n) can change sign, which is related to the electric short rangem agnetic cou-

As the system is driven closer to the M ott insulating state:  $n \mid 1$ ,  $(n) \mid J(n) \text{ as } T(n) \mid 0$  which indicates the m etal-insulator transition. In this lim it the system behaves as a H eisenberg antiferrom agnet with antiferrom agnetic exchange coupling given by  $J = 4t^2=U$ , with U > tj. A change of sign in (n) happens at about n = 1.3 in Fig. 7 signalling a ferrom agnetic exchange interaction. Indeed, this is approximately the doping at which the ferrom agnetic state is found for U = 10tj (c.f. Fig. 1). Thus, as the electronic occupation increases,

(n) changes from positive (antiferrom agnetic) to negative (ferrom agnetic) when J < T. This is the threshold ferrom agnetic interaction for the \bad m etal" to become ferrom agnetic. At larger doping values the absolute yields of the m agnetic m om ent, , become suppressed as the number of unpaired electrons is reduced becoming ! 0 as n ! 2 which coincides with the destruction of

ferrom agnetism .

In contrast to the rather unconventionalm etallic state found for t > 0, the magnetic susceptibility for t < 0 is Pauli-like, moderately enhanced by many-body e ects. This can be observed in the inset of Fig. 6 where a weak temperature dependence for all n (for clarity only n = 1:3 is shown) is found. To be speci c, for T F the low temperature behavior of the susceptibility for a noninteracting m etal is given by68

where () is the density of states per spin and the primes indicate derivatives of the DOS with respect to . The non-interacting susceptibility at zero temperature is given by  $_0 = 2 \frac{2}{B}$  (F). Fort < 0 a direct evaluation of the temperature dependence gives nearly zero for electron doping the triangular lattice. Our numerical results agree with temperature dependence given by Eq. (25), with a moderate enhancement of (T)=  $_0$  suggesting moderate many-body elects. Hence, we conclude that the t < 0 electron doped triangular lattice behaves as a renorm alized paramagnetic metal.

# V. RENORMALIZATION OF QUASIPARTICLES FOR DIFFERENT SIGNS OF t

DMFT typically predicts a metal-insulator transition 1 at half-  $\lim_{\bullet} q_{\bullet}^{21}$  As soon as U is increased to U=W as the system is doped away from half-lling, the system becomes metallic<sup>22</sup> with electrons having their mass renorm alized by the Coulomb interaction. We nd that the two di erent densities of states corresponding to the two di erent signs oft lead to di erent renorm alizations of the quasiparticles although  $W = 9 \pm j$  is the same for both DOS. This result is in contrast to the half-lled and unfrustrated cases where the results do not depend on the sign of t. This is because for unfrustrated lattices particle-hole symmetry is respected, whereas particlehole symmetry is broken on the doped triangular lattice. Half-lled frustrated lattices are not particle-hole sym m etric, but this asym m etry is suppressed at large U, and particularly in the M ott insulating state.




FIG.8: (Color online.) Comparison of the imaginary part of the self-energy for t > 0 with the same quantities with t < 0. Results are reported for U = 10 j and various electron dopings. The linear dependence of the self-energy at low energies indicates Ferm i liquid behavior. The slope near i! = 0 is used to extract the quasiparticle weight Z, shown in Fig. 9.

In order to understand the electronic properties and di erent magnetic behavior obtained for t < 0 and t > 0(above), the imaginary part of the self-energy along the imaginary axis, Im (i!) for t < 0 and t > 0 is computed and shown in Fig. 8 for U = 10 j. The quasiparticle weight can be extracted from the slope of the self-energy,

The increasing slope at low frequencies of Im (i!) as n ! 1 indicates a stronger renorm alization of the quasiparticles as the system gets closer to the M ott m etalinsulator transition. This behavior is apparent for both signs of t. How ever, for t > 0 electrons are m ore strongly renorm alized than for t < 0. For example, for n = 1:3the slope of Im (i!) as ! ! 0 is steeper by a factor of about 2 for t > 0 than it is for t < 0.

## A. E ective m ass




FIG. 9: (Color online.) Dependence of the quasi-particle weight Z on the Coulom b repulsion U=jtj at various electron dopings. The quasiparticles become more renormalized as the doping is decreased due to the proximity to the M ott transition. For a given value of U, quasiparticles on the triangular lattice with t < 0 are less renormalized than for t > 0. In contrast, for the half-lled case (n = 1), we not the same behavior of Z for both t > 0 and t < 0 with a M ott m etal-insulator transition taking place at a common value U=W 1:66.

The quasiparticle weight extracted from the selfenergy as a function of the C oulom b interaction U is shown in Fig. 9. Z is compared fort > 0 and t < 0 when n = 1:3. The e ective m assis de ned by m =  $m_b=Z$ ; where  $m_b$  is the non-interacting band m ass. For U = 10 time nd for t < 0, m = 1:5m b whereas for t > 0, m = 3:4m b. For n = 1 we nd m = 4.0m b independent of the sign of t. This is an important point as it shows that for the same U = W the two di erent signs of t lead to di erent renormalizations of the quasiparticles can be understood from the fact that for electron doping the DOS close to the Fermi energy is larger for t > 0 than for t < 0 (c.f., the bare DOS shown in Fig. 6).

The di erent renorm alization of the electrons found for the dierent signs of t in the electron doped system is in contrast to the very sim ilar renorm alization found in the half-lled case (n = 1) for which Z decreases rapidly and in the same way for both t > 0 and t < 0, leading to a very similar critical value of  $U_c$ 1:65W at which the Mott transition occurs. This value is sim ilar to DMFT estimates obtained for the Bethe lattice<sup>21</sup>:  $(1:5 \quad 1:7)W$ . The value obtained U = 15 t should Uc 12 jjobtained from exact be compared with the U<sub>c</sub> diagonalization calculations for 12 site clusters.<sup>32</sup> The sim ilar critical values appearing at half-lling can be explained from the fact that as U ! W , the spectral densities at each site are strongly modi ed by the Coulomb interaction washing out the ne details of the bare DOS. In contrast, for the doped case, kinetic energy e ects are im portant.




FIG.10: (Color online.) The variation of the e ective mass, m =  $m_b = 1$ =Z with doping n for both signs of t for U = 10jtj. Notice in particular the non-monotonic variation of the e ective mass with n for t > 0.

In Fig. 10 we show the variation of the e ective mass

with n for U = 10 tj. Strikingly the elective mass increases when the system is doped o half-lling close to n = 1 and t > 0 displaying a maximum at about n = 1.07. This is in contrast to the t < 0 case, and what has been found previously for non-frustrated lattices such as the hypercubic lattice, for which the elective mass decreases as the system is doped away from half-lling, relecting reduced correlations. In fact for n > 1:07 the elective masses do decrease with increasing n, reaching the non-interacting limit (Z ! 1), as n ! 2. A non-monotonic behavior of the elective mass is then found close to half-lling and t > 0. This is in contrast with the simple behavior encountered for the hole doped (n < 1) M ott insulator with a at non-interacting DOS. In that case, the elective mass behaves as<sup>21</sup>

diverging at the M ott transition. This result can also be derived from slave-boson theory.  $^{69}$ 

The elective mass increase with initial doping is a result of the initial increase of the DOS for t > 0 as  $_F$  m oves closer to the van-H ove singularity. The subsequent decrease in the elective mass can be attributed to the decrease in the elective number of charge carriers which suppresses correlation elects. It would be interesting to see whether slave boson theory, with the DOS for the triangular lattice, could reproduce the non-monotonic dependence of the quasi-particle weight on doping. (This would involve solving equations (8) and (9) in Ref. 69).

## B. Som m erfeld-W ilson ratio

In order to explore the e ect of magnetic exchange in the m etallic correlated state we analyze the Som m erfeld-W ilson ratio,




FIG.11: (Color online.) The variation of the Sommerfeld-W ilson ratio,  $R_W = \lim_{T \to 0} ((T) = 0) = ((T) = 0)$  with doping n for both signs of t for U = 10 t and  $T = \frac{1}{2}$  = 200.

where  $F_0^a$  is the Ferm i liquid parameter which is a measure the proximity of the system to a ferror agnetic instability ( $F_0^a = 1$  at the instability) and  $=_0 = 1=Z$ . The dependence of  $R_W$  on the electron occupation factors are plotted in Fig. 11 for both t > 0 and t < 0. The ratio  $R_W$  is the same at n = 1 fort > 0 and t < 0 but they behave very dimensional states of  $R_W$  is strongly enhanced signalling the proximity to a magnetic instability at about n = 1.35 and n = 1.65 (see the phase diagram in Fig. 1 fort > 0). Fort < 0,  $R_W$  displays a maximum close to n = 1.5.

#### C. Spectral density

The di erent renorm alization of the electrons for different signs of t is translated onto a di erent redistribution of spectral weight induced by the C oulom b interaction as the spectral weight suppressed at the Ferm i energy m ust be transferred to higher energies. W e investigate this by computing local spectral densities, A (!) =




FIG.12: (Color online.) Spectral densities for U = 10 j and n = 1.5 for the triangular lattice with t < 0 and t > 0. The non-interacting DOS is also shown (red line) for comparison and energies are relative to the Ferm i energy. The majority (") and m inority (#) spectral densities for n = 1.5 and t > 0 are shown as the system is ferrom agnetic.

In Fig. 12 a comparison of the spectral density A (!) with the non-interacting DOS per spin, (), is made for the case n = 1.5 and U = 10 j. For these parameters ferrom agnetism occurs when t > 0. Notice that within the ferrom agnetic m etallic phase the spectral function ofm a prity spin subband (") is found to be renorm alized m ore strongly than that of them inority spin subband (#). The lower Hubbard band for spin up electrons contains more spectral weight than the lower Hubbard band for spin down electrons. One may think of this in term s of a photoem ission experiment, clearly there are many more spin up than spin down electrons which can be extracted from a ferrom agnet. A lternatively, one may view this e ect as originating from the preclusion of the hopping of a m inority spin hole to a neighboring site by the presence of a m inority spin hole.

#### D. Resistivity and K adowaki-W oods ratio

W ithin the DMFT approximation the conductivity is given by,  $^{21}$

In the above equations  $_{\rm F}$  = Re (0) =  $_{\rm F}$ , where  $_{\rm F}$  is the Ferm ienergy of the non-interacting system  $^{70}$  for a given electron occupation n. From the T $^2$  coe cient of the resistivity, A, and the speci c heat slope at low tem – peratures, = 2 $^2k_{\rm B}^2$  K( $_{\rm F}$ )=3 =  $^2k_{\rm B}^2$  ( $_{\rm F}$ )=Z, where A( $_{\rm F}$ ) and ( $_{\rm F}$ ) are the interacting and non-interacting quasiparticle density of states per spin. We can now obtain the K adow aki-W oods ratio,




FIG. 13: (Color online.) The doping dependence of the K adowakiW oods ratio  $A = {}^2$  for t < 0 and t > 0 for xed  $U = 10 \pm j$ . The lattice parameter, a = 2.84A relevant to N  $a_x$  C oO  $_2$  has been used. N ote the non-m onotonic doping dependence of the ratio and the fact that even at half-lling the ratios are di erent for the di erent signs of t.

The doping dependence of the K adow akiW oods ratio is plotted in Fig. 13 com paring the t > 0 and t < 0cases. The gure displays the non-m onotonic dependence of the ratio with electron occupation and also how di erent band structures can lead to di erent absolute values of the K adow akiW oods ratio.

## VI. FERROM AGNETISM

N agaoka rigorously proved<sup>18</sup> that the Hubbard m odel on a connected lattice<sup>71</sup> in the U ! 1 limit displays ferrom agnetism when one hole (electron) is added to the half-led system when t < 0 (t > 0). This is due to the fact that in this case, the kinetic energy is m inimized if all the spins are aligned in the sam e direction. This rigorous treatment has not been extended to doping by m ore than one hole and it remains an outstanding problem to further understand this interesting phenom enon.<sup>72</sup>

DMFT has proved to be an important tool to describe ferrom agnetism appearing due to local electronic correlations. The possibility of N agaoka or m etallic ferrom agnetism in a hole doped in nite dimensional foc lattice has been previously analyzed within DMFT.<sup>73</sup> M ore recently DFT (LDA)+DMFT calculations (where DFT is density functional theory and LDA is the local density approximation) have provided a realistic description of ferrom agnetism in Fe and Ni.<sup>74</sup> Our calculations show that for su ciently large U and t > 0 ferrom agnetism occurs while the system is still m etallic as the spectral density at the Ferm i energy is always nite for non-zero doping (c.f. Fig. 12). In Fig. 14 we show the sharp ferrom agnetic transition in the T ! 0 limit for t > 0 obtained from our DMFT calculations.




FIG. 14: (Color online.) Ferrom agnetism in the electron doped t > 0 triangular lattice from DMFT. The magnitude of the spontaneous magnetic m on ent is shown as a function of the electron occupation n. As U is increased above  $U_{\rm c}(n)$  the system magnetizes spontaneously stabilizing a ferrom agnetic metal in a broad doping region. Ferrom agnetism does not appear in the electron doped t < 0 triangular lattice.

Increasing U stabilizes the ferrom agnetic region in a broader electron occupation range. Ferrom agnetism is found to be more stable for 1 < n < 1.5 than for 1.5 < n < 2, indicating the importance of correlation e ects as the system is closer to the M ott insulating phase as n! 1 and su ciently large U. The ferrom agnetic transition is found to be sharp as shown in Fig. 14 even at the lowest U value forn = 1.5 where the van H ove singularity occurs in the bare DOS. In contrast for t < 0 where, for

electron doping, there is no van Hove singularity we do not observe ferrom agnetism. This is, of course, rather rem iniscent of a Stoner type instability.

In order to explore the possibility of having Stoner ferrom agnetism we can obtain the critical value  $U_c^S$  for ferrom agnetism from the Hartree-Fock (random phase approximation, RPA) Stoner condition

where  $(_{\rm F})$  is the bare DOS per spin. One would nd  $U_{c}^{s}$  (n = 1:5) = 0 and  $U_{c}^{s}$  (n = 1) = 5 for t > 0 which are much smaller values than the ones obtained from DMFT calculations (see Fig. 1). Furtherm ore, from the Stoner condition we would also expect a ferrom agnetic instability at  $U_c^S$  (n = 1:3) = 5:26 and  $U_c^S$  (n = 1:90) = 10 for t < 0. Clearly, simple Stoner ferrom agnetism is inconsistent with our DMFT results not only at the quantitative but also qualitative level as the Stoner criterion would predict ferrom agnetism for both signs oft for su ciently large, but nite, values of U . Stoner theory is known to overestim ate ferrom agnetic tendencies.<sup>76</sup> In the present case, it would predict ferrom agnetism for t < 0 in contrast to the more sophisticated DMFT treatment. This di erence can be attributed to the on-site dynam ical correlation e ects which strongly redistribute the spectral weight of the electrons and that are not taken into account in standard m ean-eld theories.

Vollhardt et al.<sup>76</sup> have given a nice review of the essential features of Hubbard models that are favourable towards to ferrom agnetism. (i) The energy dependence of the density of states near the Ferm i energy should be su ciently asymmetric, with the DOS being larger towards the top (bottom) of the band for electron (hole) doping. A at band system with a singular DOS at the upper (low er) edge the m ost favorable for ferrom agnetism . Then the increase in electronic kinetic energy associated with spin polarisation is smaller than for a constant  $D \circ S$ . (ii) Strong C oulom b interactions narrow the bands. Less narrow ing occurs for the polarised case because polarisation reduces the elect of correlations.

Our DOS is not of the at band type, however, the energy cost in completely polarizing the non-interacting electron doped system for t > 0 is found to be much smaller than for t < 0. Indeed, for an electron doped system this is given by

which should be negative if ferrom agnetism is stable. The chem ical potentials,  $_0$  and  $_p$ , correspond to the unpolarized and fully polarized system s, respectively and  $_{max}$  is the energy at the upper edge of the band. Inserting

() for t > 0 in expression (35) with n = 1.3 we obtain  $E = 0.603 \pm j$  to be compared with  $E = 1.34 \pm j$  for t < 0. Interestingly, for the square lattice,  $E = 0.8 \pm j$  which is between the values of E for the t < 0 and t > 0 triangular lattices. Hence, although unsurprisingly ferrom agnetism is not stable for the non-interacting system regardless of the sign of t, the ferrom agnetic tendencies are clearly stronger in the electron doped triangular lattice for t > 0 than they are for t < 0 in agreement with the conclusions derived from the three site cluster analysis (sect. IID and Fig. 2).

Finally, it is worth comparing previous studies of the J model on the triangular lattice with our DMFT t. results. A Curie-W eiss m etal as well as ferrom agnetism have been previously found from calculations using high tem perature series expansions, for the hole doped trian-J m odel.<sup>45</sup> O ur results for the electron doped qulart lattice are equivalent to the hole doped case discussed in Ref. 45 once the sign of t is reversed. M ore speci cally, ferrom agnetism and Curie-W eiss m etallic behavior appear in the high temperature expansion for the hole doped system with t < 0 while a weak tem perature dependent susceptibility appears when t > 0. Furtherm ore, a heavy ferm ion state, analogous to our strongly correlated m etallic state for t > 0, is predicted to exist in the hole doped system with t < 0. The qualitative agreem ent of the magnetic response obtained from DMFT compared with the high tem perature studies (which includes both local and non-local correlation e ects) of the t J m odel indicate the importance of the local aspects of electronic correlations. This has also been pointed out in the context of m etallic m agnetism for w hich a good a description of the electronic and m agnetic properties of Fe and N i is attained from a local theory such as DMFT.<sup>74</sup>

# V II. COMPARISON W ITH EXPERIMENTS ON N $a_{\rm x} C \mbox{ od }_2$

As this work has been largely motivated by experiments on N  $a_x C \circ O_2$  we now consider what the lessons learned from a DMFT study of the Hubbard model on a triangular lattice might have to say about N  $a_x C \circ O_2$ . First, our results show that the details of the electronic structure, and in particular the DOS, play a crucial role in determining the physics of strongly correlated frustrated systems such as N  $a_x C \circ O_2$ . This is something of a pyrnhic victory in that this very result tells us that there is little hope of quantitative agreement between experiments on N  $a_x C \circ O_2$  and calculations based on a simplied one band models with nearest neighbour hopping only, such as those presented above. Indeed our results do not show any such quantitative agreement.

In particular for the triangular lattice with t < 0 (which, of the two cases we considered, gives the band structure closest to those suggested by both ARPES and LDA-DFT) the DMFT of the electron doped Hubbard m odel closely resembles a weakly interacting m etal. This is clearly not what is observed in Na<sub>x</sub>CoO<sub>2</sub>, even at a qualitative level.

On the other hand m any of the results for t > 0 are qualitatively consistent with the picture drawn by experiments on Na<sub>x</sub>CoO<sub>2</sub>. In particular we propose that the experimental Curie-W eiss metal' is little more than the \bad metal" in the extreme situation of very strong electronic correlations and high frustration. Important experimental support for this hypothesis comes from the fact that a Fermi liquid like resistivity has only been observed<sup>19</sup> when T . 1 K which suggests that T 1 K. An obvious objection, that T predicted by DM FT will not be this small for any reasonable parameters, will be discussed below (Sec. V IIIA 1).

Our results for t > 0 show that magnetism is a genuinely quantum many-body e ect, in particular them agnetism has little resemblance to simple Stoner ferrom agnetism. We propose that the observed A-type antiferrom agnetism results from in plane N agaoka ferrom agnetism with a weak interlayer antiferrom agnetic coupling. The observation<sup>15,16</sup> that the strength of the e ective in-plane ferrom agnetic coupling in NaxCoO2 is the same order of m agnitude as the e ective interlayer antiferrom agnetic interaction despite of the highly two-dimensional crystaland band-structures of  $Na_xCoO_2$  is naturally explained in this scenario as the e ective ferrom agnetic interaction in the Nagaoka is much weaker than the intrinsic antiferrom agnetic interaction which gives rise to the phase. This can be seen from Fig. 10, here (n) becom es positive and ferrom aquetism is suppressed by reducing the doping tow ards the critical doping which is the lower bound for which ferrom agnetism is observed. The intrinsic antiferrom agnetic interactions due to superexchange are given by  $J = 4t^2 = U = 0.4 \text{ tj}$  for U = 10 tjwhich we take in the calculations above. Therefore even  $J_2 = 4t_2^2 = U$ , where  $J_2$  and  $t_2$ ? though  $J = 4t^2 = U$ 

are respectively the inter-plane exchange constant and hopping integral, near the phase transition to ferrom agnetism J (n) and thus the inter-plane antiferrom agnetic exchange m ay be the same order of m agnitude as the in-plane ferrom agnetic exchange, as is observed experimentally in Na<sub>x</sub>CoO<sub>2</sub>.

To qualitatively test these ideas calculations with a m ore realistic band structure are required. LDA calculations predict that the dispersion of the bands is rather different to the dispersion obtained from a nearest-neighbor isotropic triangular lattice. In particular the LDA band ismuch atter close to the -point. Indeed this is just the sort of change that is likely to have a signi cante ect on the results of the type of calculations we have presented above. In the current work we have also neglected the possibility of Ferm i surface pockets near the K -points arising from the  $e_{2\alpha}^0$  band.<sup>47,48</sup> Recall that, for example, we demonstrated that the magnetism and Curie-Weiss m etal behavior we observed in the triangular lattice depend crucially on the DOS near to the Ferm i level and not just on the DOS at the Ferm ienergy. Therefore, even if this band does not actually cross the Ferm i energy, as som e studies have indicated,  $\overline{f}^{46,51}$  it may play an important role in N  $a_x C \circ O_2$ . Interestingly, the  $e_{2\alpha}^0$  band can be tted to a t > 0 tight-binding m odel close to the Ferm i energy. Hence, the  $e_{2\alpha}^0$  bands m ay play an important role in producing the Curie-W eissm etallic state. A nyway, the generalization of these results to multiband system  $s^{52}$  is likely to be important for a complete understanding on the magnetic and transport properties of N  $a_x C \circ O_2$ .

To quantify these remarks we now present a comparison of the DMFT results for the triangular lattice with the experimentally measured properties of N  $a_x$  C oO  $_2$ .

#### 1. Electronic heat capacity

The experimental  $7^{7,78}$  value of the linear-T coe cient of the specic heat (C<sub>v</sub> T for T < T with T = 1 K) in N  $a_x$  C oO 2 and 0:7 < x < 0:82 is = 25 30 m J/ (m ol  $K^2$ ) in zero magnetic eld. This corresponds to an effective mass enhancement m = m b 3 4 where  $m_{\rm b}$  is the LDA band mass. On applying an external magnetic eld of H = 14 T, is suppressed leading to = 0.02J/(molK<sup>2</sup>) (Ref. 77) implying at 20-30% decrease in m . The observed temperature and magnetic eld dependence also has two unusual features. In zero eld, C<sub>v</sub>(T)=T is non-monotonic, but becomes monotonic in a eld of 14 T (see Fig. 3 in Ref. 77). The reduction of  $C_v$  (T)=T as the tem perature increases from 1 to 5 K is consistent with the destruction of quasi-particles in this tem perature range (com pare Fig. 37 in Ref. 21)

O urDMFT calculations for n = 1:7 and  $U = 10 \pm j$  predict a weak renormalization of the electrons,  $m = m_b$ 1:1, for t < 0 and m = m 1:5 for t > 0. However, in the discussion to follow it will be important to note that as the system is driven towards half-lling, n ! 1, we nd e ective m ass enhancements which are comparable to or larger than experim entalvalues (see Fig. 10). Note that e ective mass enhancem ent for t < 0 is rapidly suppressed (Fig. 10) as n is increased above n > 1.2 becom - ing e ectively a weakly correlated m etal for this doping region. But, for t > 0 we nd that the mass enhancem ent rem ains large to much higher dopings than for t < 0 (for t > 0 the mass enhancem ent is comparable or greater than that observed experim entally for x . 1:5).

#### 2. Low-tem perature resistivity

Experimentally,<sup>19</sup> the resistivity varies as, (T)  $_0$  + AT<sup>2</sup>, as is expected for Fermiliquid, below T 1K. The coe cient of the quadratic term is measured <sup>19</sup> to be A = 0:96 cm/K<sup>2</sup> for N a<sub>0:7</sub>C oO<sub>2</sub>. On applying an external magnetic eld up to H = 16 T, the quadratic coe cient of resistivity is decreased to A = 0:22 cm/K<sup>2</sup> and T is increased to 4 K.

DMFT predicts Ferm i liquid behavior below T, the low energy coherence scale. The resistivity coe cient cm /K  $^2$  fort < 0, predicted by DMFT is A = 0.0053n = 1:7 and U = 10 tj, which is more than two orders ofm agnitude sm aller than the experim ental value. How ever, at half-lling and U = 10; A = 0.81 $m/K^2$ , which is comparable to the experimental result. For t > 0, n = 1.7 and  $U = 10 \pm jwe nd A = 0.32$ om /K<sup>2</sup>, which is the sam e order of magnitude as in experin ents of N  $a_x$  C oO 2. Therefore, either the details of the DOS or driving the system towards the Mott transition could be responsible for the large value of A observed experimentally. However it is important to stress that in our calculations the coherence scale, T 100 K for U = 10 jjat half-lling, is two orders of m agnitude larger than the tem perature below which (T)  $_0$  + AT<sup>2</sup> in the experiments.<sup>19</sup> We will discuss the reasons for this below (see Sec. V IIIA 1).

#### 3. Kadowaki-W oods ratio

The K adowakiW oods ratio of N  $a_{0:7}CoO_x$  is experimentally found<sup>19</sup> to be A =  $^2$  = 60a<sub>0</sub>, with  $a_0$  = 10<sup>5</sup> cm m of K<sup>2</sup>/m J<sup>2</sup> being the constant value found in the heavy-fermion materials. The large values of the ratio have been recently discussed by H ussey,<sup>20</sup> who explained that when volumetric rather than molar quantities for the speci c heat, the values of A =  $^2$  are comparable to the ones in the heavy fermion system s. From the DM FT calculations with t < 0 we nd that A =  $^2$  = 64.2a<sub>0</sub> for n = 1:7 whereas at half-lling A =  $^2$  = 75a<sub>0</sub>, im plying a weak dependence with the electron doping. A stronger dependence is found from DM FT for t > 0 for which the ratios vary between A =  $^2$  = 100a<sub>0</sub> for n = 1:7 and 170a<sub>0</sub> at half-lling (see Fig. 13). Thus, the absolute values depend strongly on the DOS.

#### 4. Uniform magnetic susceptibility

Experimentally, the magnetic susceptibility is found to have a Curie-W eiss form, (T) = (T + ), and a m agnitude much larger than the Pauli susceptibility expected for weakly interacting metal across a large range of dopings that have metallic ground states.<sup>8,11</sup> Our DMFT calculations for t < 0 display Pauli param agnetism, which is typical of weakly correlated metals, in qualitative disagreem entwith experiments. However, fort > 0 a Curie-W eiss m etal is observed across a wide range of dopings. In the discussion that follows it will be important to recall that the DMFT prediction of the susceptibility of a metal close to the M ott transition is that it has the C urie-W eiss = T + J > 0. Thus, a behaviour similar form with to the experim entally observed Curie-W eiss m etal is predicted by DMFT fort > 0 [i.e., when  $(_{\rm F})$  is large] and near to the M ott transition.

## 5. Som m erfeld-W ilson ratio

experim entally The m easured Som m erfeld-W ilson ratio<sup>79</sup> of  $Na_{0:7}CoO_2$  is  $R_W$  $\lim_{T \to 0} ((T) = 0) = (0) = 7.8$ . For the hypercubic lattice, the W ilson ratio predicted by DMFT goes to zero close to the M ott transition, i.e. at half-lling, but becomes nite as soon as the system is doped away from half-lling.<sup>21</sup> On the triangular lattice with t < 0we nd that the W ilson ratio attains its largest values at n = 1:6 at which  $R_W = 1$ :7 and decreases to 1.3 as  $n ! 2 w ith U = 10 t_j$ . In the lim it n ! 1, the calculated  $R_{W} = 0.8$ . On the other hand for t > 0,  $R_{W}$  becomes extremely large at dopings close to the ferrom agnetic instability. For example, for n 1:65,  $R_W$  is already about 6. One should note that experimentally, x = 0.7is extremely close to the critical doping at which the A-type antiferrom agnetism appears. Therefore the large Sommerfeld {W ilson ratio observed is probably a direct consequence of the proximity of Na<sub>0:7</sub>CoO<sub>2</sub> to the magnetic transition. This analysis would also suggest that as the doping is decreased from x = 0.7 then  $R_W$ will also decrease, although calculations with a more realistic band structure are required to con m that DMFT makes this prediction.

## E ect of a small external magnetic eld on the low-T resistivity, A, and speci c heat, , coe cients

A rapid suppression of the low-T resistivity coe cient A and speci cheat slope and an increase in T are observed when an external small magnetic eld is applied to  $Na_x CoO_2$ . [The details of the experimental observations of the behaviour of (Ref. 77] and A (Ref. 19) are summarised in sections V II 1 and V II 2 respectively.)

For the single in purity K ondo m odel the tem perature dependence of the heat capacity has a m axim um near the

K ondo tem perature. In a magnetic eld, once the Zeeman energy, g  $_{\rm B}$  B, is comparable to the K ondo energy,  $k_{\rm B}$  T<sub>K</sub>, this maximum shifts to higher tem peratures.<sup>80,81</sup> B ased on this we would expect that the coherence tem – perature becomes larger with increasing eld.

DMFT for the Hubbard model in a magnetic eld shows that in the metallic phase of a weakly interacting metal the quasi-particle weight Z increases with eld, consistent with the predictions of Stoner theory. (See Fig. 5 of Ref. 58) C onsequently, the speci c heat coe cent will decrease with eld. Sim ilarily, the resistivity coe cient A will also decrease. In contrast, a strongly correlated metal close to the M ott transition displays a weak suppression with magnetic eld (see inset of Fig. 9 in Ref. 58).

## 7. Failure of one band models with nearest neighbour hopping

The disagreem ents highlighted above between the one band model with nearest neighbour hopping and experin ents on  $Na_xCoO_2$ , particularly for t < 0 which is the appropriate sign of t for  $Na_x CoO_2$ , does not appear to be a result of the DFMT approximation. Our results are entirely consistent with the series expansions<sup>45</sup> and RVB<sup>12</sup> results for the t J m odel on a triangular lattice in this regard. Therefore we believe that simple one band models with nearest neighbour hopping only cannot account for the observed behaviour of  $Na_x CoO_2$ . This is an extrem ely important result given the number of theoretical papers on both  $Na_xCoO_2$  and  $Na_xCoO_2$ уӇО that are based on this type of model. In the next section we exam ine what kind of models or approxim ations are required to give an account of the strong correlation e ects in Na<sub>x</sub>CoO<sub>2</sub>.

#### VIII. MORE REALISTIC MODELS OF Na<sub>x</sub>CoO<sub>2</sub>

## A. Beyond DMFT

A lthough DM FT calculations on the triangular lattice suggest the proxim ity of the m etal to a M ott insulating phase several aspects of the observed low tem perature behavior of N  $a_x$  C oO  $_2$  are still di cult to understand. Forem ost am ongst these is why is the value of T estimated from resistivity so m uch sm aller than the obtained from the susceptibility and DM FT?

The experimental value for the coherence temperature, T = 1 K, as determined from the temperature below which  $(T) = _0 + \text{AT}^2$ , is two orders of magnitude smaller than the DMFT result, T = 0.1 j 100 K for U = 10 j j at half-lling. For t > 0 there is only a weak increase in T with doping (see Fig. 5). Driving the system closer to the M ott transition by increasing U would lead to a strong suppression of T, e.g. T = 0as  $U = U_c$  at half-lling. On the other hand, the values of T predicted by DMFT are comparable with values of 150 K found experimentally from the Curie-W eiss t of the spin susceptibility, (T) 1=(T + ), at large temperatures.

Spin susceptibility experiments on Na<sub>x</sub>CoO<sub>2</sub> show a clear departure from the simple high temperature Curie-W eiss susceptibility at temperatures of order the coherence temperature predicted by DMFT (but orders of magnitude above the temperature where the resistivity is observed to vary quadratically with temperature). Below this temperature the spin susceptibility is strongly enhanced in contrast to the DMFT prediction of a Pauli susceptibility below T . Although on this front one should bew are of them a pridi erences<sup>13</sup> between the susceptibilities measured by Foo et al.<sup>8</sup> and those measured by P rabhakaran et al.<sup>11</sup>

#### 1. Spin uctuations

All of the results presented in this paper were obtained from a purely local theory, DMFT. Therefore these results neglect short range ferrom agnetic uctuations which are likely to become increasingly important as one dopes towards the ferrom agnetic phase. Indeed such ferrom agnetic uctuations have already been observed by neutron scattering in N  $a_{0.7}$ COO<sub>2</sub>.<sup>14,15,16</sup>

The importance of these uctuations can be addressed within Moriya's<sup>82</sup> spin uctuation theory of the electronic and magnetic properties of nearly ferrom agnetic metals. The theory assumes that the dynamic spin susceptibility has the form

in two dimensions. is the ferrom agnetic correlation length and is a phenom enological parameter. This has the same frequency and wavevector dependence as one obtains from an RPA treatment of a Fermi liquid metal.

W ithin this fram ework, the electronic properties can be sensitive to an applied magnetic eld as, at low tem – peratures, it suppresses the ferrom agnetic uctuations, driving the system into an unrenormalized Fermi liquid state. The low temperature scale  $T_0$  is de ned by<sup>82</sup>

where  $q_{\rm g}^2$  is a measure of the area of the rst B rillouin zone.

The spin susceptibility is enhanced as the tem perature is low ered departing from the Curie-W eiss law as a result of the enhancement of ferrom agnetic uctuations at low tem peratures. Also a small magnetic eld is expected to rapidly suppress A and as experimentally observed in Na<sub>x</sub>CoO<sub>2</sub>. The above arguments are consistent with evidence of strong ferrom agnetic uctuations acting in

the Co-planes for x 0:75 from recent neutron scattering experiments.<sup>14</sup> In order to determ ine the in portance of these spatial correlations it is desirable to compare the measurements of (q; !) in Ref. 14 with the form (36). If at a frequency ! one observes a peak of width 1= in wavevector space then  $T_0$  !  $(q; )^3$ . One sees from Figures 1 and 4 in Ref. 14 that for ! ' 10 m eV that  $q_B$  0.4. Hence, T 1 10 K and so the ferrom agnetic uctuations could be the origin of the low energy scale in Na<sub>x</sub>CoO<sub>2</sub>.

## B. Beyond the single band H ubbard m odel

#### 1. Role of ordering of the sodium ions

We believe that the A-type antiferrom agnetic phase observed experimentally corresponds to the ferrom agnetic phase predicted by DM FT and many of the metallic state properties can be interpreted in terms of their proximity to a ferrom agnetic transition and strong C oulom b repulsion e ects. However, a number of experiments suggest that N  $a_x$  C OO 2 behaves like it is more strongly correlated as the doping, x, is increased. These results are difcult to understand from a simple model which only contains the C o planes as such models become more weakly correlated as the electronic doping is increased due to the small number of holes left in the C o-planes. Below we propose that the ordering of the N a atom s observed at many dopings provides a natural explanation of these e ects as it can e ectively drive the system towards half

lling by introducing a spatial modulation of the site energy of the Co atoms. The suggestion that Na ordering plays a crucial role that has not been appreciated until now is made more plausible by the very sensitive dependence of the magnetic and transport properties on the exact details of the DOS that we have demonstrated above.

It seems likely that the charge ordering of the electrons in the  $C \circ O_2$  layers observed at x = 0.5 is induced by N a ordering.<sup>8</sup> Recently, experimental studies by Zandbergen et al.<sup>83</sup> and Roger et al.<sup>84</sup>, rst principles calculations by Zhang et al.<sup>85</sup> and classical electrostatic calculations by Zhang et al. and Roger et al. have shown that as x is varied not only is the doping of the  $CoO_2$  planes varied, but so is the Na ordering. However, there remains debate over the exact nature of the Na order at specic values of x.<sup>83,84,85</sup> There is additional evidence from NMR experiments of the presence of inequivalently charged Co ions with  $Co^{3+}$  (S=0) and  $Co^{4+}$  (S=1/2) induced by the charged Na layer of ions.<sup>79</sup> This e ect. implies that a large fraction of the electrons in the Co planes behave as S = 1=2 localized m om ents. This is precisely the behavior expected close to the M ott insulating phase in a Hubbard model close to half-lling as described by DMFT.

To make this proposal more concrete we analyse four special cases, x = 0.33, 0.5, 0.71 and 0.75. For each of


these we take the orderings proposed by Zhang et al.85 and Zandbergen et al.<sup>83</sup> although we note that in two of these cases (x = 0.71 and 0.75) Roger et al. have proposed di erent Na ordering patterns which involve the form ation of 'vacancy droplets'. W e stress that this work has nothing to contribute to the debate over which patterns are, in fact, realised and we take these patterns at x = 0.71 and 0.75 m erely to exem plify our point. In the cases of x = 0.33 and 0.5 we nd that the Na ordering introduces two Co sublattices while for x = 0.71 we nd three Cosublattices and for x = 0:75 we nd four Cosublattices. For this analysis one needs to consider the two possible locations of N a in N  $a_x C \circ O_2$ , referred to as N a (1) and N a (2).<sup>83</sup> T he C oO <sub>2</sub> planes are at z = 0.25c, where c is the lattice constant perpendicular to the cobaltate layers. The Na(1) sites lie directly above (at z = 0.5c) and below (z = 0) the Co atom s, while the Na(2) sites are above or below the centres of the triangles in the triangular lattice form ed by the Co atom s. The sim plest m odel which can include the e ects N a ordering is a Hubbard model which includes the Co site energy modulated by the num ber of nearest N a sites that are occupied. C learly, one expects that occupied N a (1) and N a (2) willm odulate the Co site energy by di erent am ounts which we denote  $"_1$  and  $"_2$  respectively. If is the chemical potential for x = 0 the H am iltonian is then given by


where N<sub>1i</sub> and N<sub>2i</sub> give the number of occupied nearest neighbour N a (1) and N a (2) sites respectively. Thism odel assumes that the electronic degrees of freedom relax on much shorter time scales than the N a ions move, which is reasonable because of the relative masses, even though the electronic degrees is an order of magnitude larger than the bare electronic mass.


To simplify our notation we now introduce the following nom enclature,




FIG.15: (Color online.) Dierent sublattices of cobalt ions due to commensurate ordering of sodium ions. Pictorial representation of the H am iltonians given by eqn. (38) are shown for x = 0:33, 0.5, 0.71 and 0.75. The dierent letters denote the dierent site energies de ned by eqn. (39), so that, for example a P represents a site with site energy "<sub>P</sub>. These dierent site energies result from the dierent N a order patterns, which have been observed experimentally<sup>83</sup> and predicted from rst principles calculations.<sup>85</sup> The N a ordering for the quoted lling factors are taken to be those shown in Fig. 2 of R ef. 85. Note that R oger et al.<sup>84</sup> proposed dierent ordering patterns for x = 0:71 and 0.75, which involved vacancy clustering'.

This allows us to sketch the relevant lattices in Fig. 15. It can be seen that for x = 0.33 we have a honeycomb lattice of sites with site energy "A with the central sites in the lattice having site energy "P. For x = 0.5 the lattice contains alternating chains of sites with site energy "B and "P. W ith x = 0.71 we nd the lattice contains sites with site energies "D, "P and "Q with all three sublattices

form ing stripes. For x = 0.75 a com plicated arrangem ent of interlaced stripes of sites with site energies  $"_{\rm C}$  ,  $"_{\rm P}$  ,  $"_{\rm O}$ and  $"_R$  is formed. This model (38) will clearly make very di erent predictions from the Hubbard model if the variations in the site energies caused by Na ordering are su ciently large. For example for x = 0.5 and "<sub>P</sub> "B W a charge ordered in-(as one m ight expect) and U sulator is likely to be the ground state of H am iltonian (38), this is the state observed in  $Na_{0.5}CoO_2$ . Roger et al. have estimated from classical electrostatics that "B ' 100 m eV which is consistent with this " scenario. Further this kind of e ect will drive the system closer to M ott insulating phase if the occupation of one or m ore of the sublattices is strongly suppressed. Thus we expect that the DMFT treatment of (38) will have signi cantly better qualitative agreem ent with the experim entally observed properties of N  $a_x C \circ O_2$  than the DMFT treatment of the Hubbard model on a triangular lattice does. Finally we note that, if one of the sublattices of x = 0.5 can be 'integrated out' of the e ective low energy theory due to a large disparity in the site energies we are left with a M ott insulator on a rectangular lattice. A long one side (the horizontal direction in Fig. 15) of the rectangle it can be seen that the antiferrom agnetic exchange constant is  $J = 4t^2 = U$ . In a similar manner superexchange leads to an exchange constant

In particular note that for U "we may have J  $^{0}$  J. Neutron scattering experiments suggest that the charge ordered phase of N a<sub>0:5</sub>C cO<sub>2</sub> has long range N eel order<sup>89</sup> which suggests J J<sup>0</sup> > J<sup>0</sup> and is therefore consistent with this model when U "t, which is precisely the regime that the separate estimates of these three param eters suggest we are in.

Before moving on from the e ects of N a ordering it is interesting to note that this type of problem is actually rather general in doped systems. For example, in most models of the cuprates it is assumed that the only e ect of varying the doping is to vary the electronic density in the  $CoO_2$  layers. However, if it is con med that N a ordering plays the role we have proposed in  $Na_xCoO_2$ 

then this may be an important step towards a general understanding of the role of dopant impurities in strongly correlated system s.

W e stress that the above proposal relies on N a ordering and not disorder. It is well known that disorder only plays a signi cant role in DMFT when there are rather extrem e levels of disorder.<sup>86</sup> Therefore one would not expect our results to be signi cantly a ected by the low levels of disorder typically found in N  $a_x C OO_2$ . How ever, recently the role of disorder on the band structure of N  $a_x C OO_2$  has received some attention.<sup>87</sup> If disorder does induce signi cant changes in the D O S this would be an important factor for the results reported in this paper. M ore generally, the role of disorder in N  $a_x C OO_2$  will no doubt prove an important probe of whether the superconducting state is conventional or not.<sup>88</sup>

#### 2. Multiple bands

Them odel, as written in eqn. (38), only contains a single band. A s discussed in the above band structure calculations suggest a simple one band m odel is not su cient to describe the band structure of N  $a_x C OO_2$ . A lthough the  $a_{1g}$  band can be roughly tted to a tight-binding m odel with t < 0 which is consistent with the large hole pocket around the point, additional sm all hole pockets may be present in the Ferm i surface associated with the  $e_{2g}^0$  bands crossing the Ferm i energy. These bands can be tted to a t > 0 tight-binding band which is likely to favour ferrom agnetism. Such a multi-band m odel is a straightforw ard generalisation of (38) giving

where the labels and  $^{0}$  refer the di erent orbitals. A multiband DMFT treatment is likely to describe both of the following e ects: (i) the proximity of the metal to a M ott insulating phase leading to renorm alized quasiparticles and Curie-W eiss behavior for T > T and (ii) the strong ferrom agnetic uctuations appearing at very low tem peratures. Several models have been recently proposed to describe  $Na_x CoO_2$ . In comparison to single band<sup>12,36</sup> and multiband Hubbard models<sup>48,49,52</sup>, our proposed model explicitly contains the periodic potential of the Na layers acting on the Co planes in combination with the Coulomb interaction. This is an important ingredient to understand the unexpected Curie-W eiss susceptibility and large e ective m ass at  $x \neq 0.7$ . At these large dopings the system is expected to behave as a weakly correlated m etal. W e believe that our m odel is su cient to fully understand the interplay between these two essential ingredients of the problem .

The problem of applying DMFT to a Hubbard model with two inequivalent sublattices has been considered before. Chitra and Kotliar<sup>90</sup> considered the Hubbard model at half lling in the presence of antiferrom agnetic order. This leads to a di erent chem ical potential on the two sublattices. Bulla and collaborators<sup>91</sup> considered charge ordering in the extended Hubbard model at one-quarter

lling. For the case of the Bethe lattice the model was mapped to a pair of Anderson in purity models, one for each of the two sublattices. For V (the Coulomb repulsion between electrons on neighbouring lattice sites) larger than about t and U = 2t the quasi-particle weight (and presum ably the coherence temperature also) is orders of magnitude sm aller than the non-interacting value and there is a pseudogap in the density of states. Based on the above we would expect that for x = 0.5 the ground state will be insulator if  $J'_{\rm P}$  "B j U > jtjdue to the two di erent sublattices.

## IX. CONCLUSIONS

W e have presented a DMFT analysis of the electronic and magnetic properties of the doped isotropic triangular Hubbard model. An important result of our work is the large e ect of the bare DOS on its magnetic and electronic properties. In particular, a Curie-W eiss m etal is found fort > 0 and U & W . In contrast, Pauliparamagnetism is found for t < 0 regardless of the magnitude of U. We nd a larger degree of localization and a larger renorm alization of the electrons for t > 0 than for t < 0 due to the di erent DOS at the Ferm i energy. The spin susceptibility crosses over from Curie-W eiss behavior, at large tem peratures, to a renorm alized Ferm i liquid as T ! 0. At low tem peratures, the uniform spin susceptibility is strongly enhanced for t > 0 due to the proximity to the ferrom agnetic transition. This is in contrast to the behavior for t < 0, for which only a small enhancement of (T ! 0) = 0 is found. The stronger renorm alization of the quasiparticles found for t > 0 than fort < 0 when the system is doped away from half-lling is a consequence of a larger DOS near the Ferm i energy in the t > 0 case.

For t > 0 we nd a metallic ferrom agnetic state when U is su ciently large. The ferrom agnetism is signi – cantly di erent from Stoner ferrom agnetism in that it has a strong local moment character and the criterion for ferrom agnetism is not simply related to the DOS at the Ferm i level, but depends on the features of the DOS over a signi cant energy range around the Ferm i level. No ferrom agnetism has been found for any band lling or any value of U when t < 0, which is qualitatively different from the prediction of Stoner theory. We conclude that the ferrom agnetism we have observed is much more closely related to N agaoka ferrom agnetism. The di erent behaviour of the two lattices is due to kinetic energy fustration which dram atically reduces the energy cost of polarizing the system for t > 0. We have therefore proposed that the A -type antiferrom agnetic phase observed in N  $a_x C \circ O_2$  for x > 0.75 is the result of in plane N agaoka type ferrom agnetism .

The di erent behaviors encountered away from halflling for the di erent signs of t contrasts with the system su ciently close to the M ott insulating phase (n ! 1 and  $U > U_c$  or  $U ! U_c$  and n = 1). In this case, the model displays very similar properties including Curie-W eiss susceptibility with > 0 (due to antiferrom agnetic superexchange interaction close to half-lling), a large e ective m assenhancem ent, (m =m<sub>b</sub> = 5 for U = 10 fc), large low-T resistivity coe cient, and enhanced K adowaki-W oods ratio.

Thus our results show that the details of the band structure are extrem ely in portant for understanding the m etallic and spin ordered phases of N  $a_x C \circ O_2$ . In particular, a simple one-band Hubbard model on a triangular lattice is not enough to understand the unconventional properties of N  $a_x C \circ O_2$ . Our results how ever do suggest that the Curie-W eiss susceptibility observed in the m etallic phase of N  $a_x C \circ O_2$  results from incoherent quasi-localized electrons. Remarkably, the DM FT estimate of T = 0.1 j 100 200 K is in good agreement with the Curie-W eiss constant 150 K experimentally m easured.

M any of the therm odynam ic and transport properties observed in N  $a_x$  C oO  $_2$ , for large x, are consistent with the D M FT prediction of the transport and m agnetic properties of the m etal very close to the M ott transition. We have proposed that M ott physics is relevant to N  $a_x$  C oO  $_2$  even when x is large and the system is far away from the M ott insulating phase because of experimental observation of charge ordering in the C o planes.

The T dependence of several transport and m agnetic properties is consistent with the DM FT description of a m etal close to the M ott transition for T > T. How - ever, at very low temperatures, experimental observations on Na<sub>x</sub>CoO<sub>2</sub>, depart from our DM FT results. For instance, the susceptibility deviates signi cantly from the Curie-W eiss behavior being strongly enhanced below T 80 K. A loo transport and therm odynamic quantities are very sensitive to a small applied m agnetic eld. O ne is tempted to associate the very low temperature scale of about 1 K experimentally determined to the DM FT coherence scale, T, which goes to 0 as the system approaches the M ott insulating state. How ever, such a small value of T im plies an extrem ely large e ective

m assenhancem ent in clear disagreem ent with experim ental values, m =m  $_{\rm b}$  3 4. We conclude that this very small energy scale is due to low energy ferrom agnetic uctuations in the Co-planes which are neglected within the DMFT. These uctuations would scatter the strongly renorm alized quasiparticles which are properly described by DMFT.

We have then used this analysis to help identify the simplest relevant model that captures the essential physics in Na<sub>x</sub>CoO<sub>2</sub>. We have proposed a model which contains the charge ordering phenom ena observed in the system that we have proposed drive the system close to the M ott insulating phase for the large dopings. B and structure calculations nd that the a<sub>1g</sub> band can be roughly tted to a tight-binding model with t < 0 which roughly describes the large hole pocket around the

point. A dditional sm allhole pockets m ay be present in the Ferm i surface associated with the  $e_{2g}^0$  bands crossing the Ferm i energy. These bands can be tted to a t > 0 tight-binding band for which ferrom agnetic uctuations are likely to exist. Hence, a multiband DM FT treatment containing the  $a_{1g}$  and  $e_{2g}^0$  bands as well as charge ordering phenom ena should describe both the follow ing aspects: (i) the proximity of the metal to a M ott insulating phase leading to renormalized quasiparticles and Curie-W eiss behavior for T > T and (ii) the strong ferrom agnetic uctuations appearing at low temperatures. We believe that a model including both of these ingredients is needed to fully understand the physics of N  $a_x C \operatorname{oO}_2$ .
