The phase transition of triplet reaction-di usion models

The phase transitions classes of reaction-di usion systems with multi-particle reactions is an open challenging problem. Large scale simulations are applied for the 3A ! 4A, 3A ! 2A and the 3A ! 4A, 3A ! ; triplet reaction models with site occupation restriction in one dimension. Static and dynamic mean-eld scaling is observed with signs of logarithm ic corrections suggesting $d_c = 1$ upper critical dimension for this family of models.

I. IN TRODUCTION

The exploration of the universal behavior of nonequilibrium phase transitions is still an open problem of statistical physics [1, 2, 3]. In equilibrium critical phenom ena sym m etries, dim ensions and boundary condition are the relevant factors determ ining a universality class. During the study of non-equilibrium models other circum stances, like initial conditions or topological e ects in low dimensions have been proven to be decisive [4]. Unfortunately solid eld theoretical background exists for only a few reaction-di usion (RD) system s exhibiting continuous phase transition to absorbing states [5]. These are mainly branching and annihilating random walk models A ! (n + 1)A, 2A !; built up from unary particle creation reactions [6, 7, 8] RD m odels are interesting since m any other types of system s like surface grow th, spin system s or stochastic cellular autom ata can be mapped on them [3].

Recently RD systems with multi-particle creation has became in the focus of research. Num erical studies resulted in debated critical phenom ena and generated a long series of publications. An interesting example was being investigated during the past decade that em erges at phase transitions of binary production systems [9] (PCPD). In these systems particle production competes with pair annihilation and single particle di usion. If the production wins steady states with nite particle density appear in (site restricted) models with hard-core repulsion, while in unrestricted (bosonic) models the density diverges. If the annihilation is stronger an absorbing phase em erges, which is either com pletely em pty or contains a solitary di using particle. In between the two phases a continuous phase transition can be observed in site restricted m odels.

In triplet reaction models at least three particle is needed to contact for a reaction. They have been investigated by simulations [10, 11, 12] and numerical Langevin equation solution [15]. The rst simulation results [10, 11] for 3A ! 4A, 3A ! 2A models in one dimension claimed a distinct universal behavior from the known ones. Simple power-counting analysis of an effective Langevin equation corresponding to the coarse grained microscopic model results in $d_c = 4=3$ [12]. How-

ever the num erical estim ates for the critical exponent describing the density decay from hom ogeneous random initial state (t) / t di ered signi cantly = 0.32(1)[10] vs = 0.27(1) [11]. In the former case a site restricted m odel was investigated and scaling was reported in the 10⁴ < t < 10⁶ region. In [11] di erent suppressed bosonic triplet models { where the multiple site occupancy is suppressed by an exponential probability factor { exhibited scaling for $10^4 < t < 10^7$ M onte C arlo steps (MCS) (throughout the paper the time is measured by MCS). Renorm alization group analysis pointed out [16] that a single eld theory does not exhibit a nontrivial stable xed point and suggested $d_c = 1$ for such models. This study raised the possibility that a proper eld theory should be a coupled one, with positively correlated clustered particles and solitary random walkers. An other simulation study [12] on site restricted models reported scaling agreeing with m ean-eld exponents = 0.95(5)and = 1:07 (10), where is the order parameter exponent in the active phase $/\dot{p}$ p_cj.

Very recently a coupled eld theoretical description of such systems is suggested [15]. An elective Langevin equation between a DP like and an annihilating random walk (ARW) system is analyzed by numerical integration technique. Note however the ARW like system is described by a positive noise term saying that at the critical point the anti-correlations do not play a role and serve merely as a luctuating source to the primary eld. As the consequence this eld theory leads to the same elitical scaling behavior as that of the PCPD albeit with a di erent upper critical dimension $d_c = 4=3$ (vs $d_c = 2$ for PCPD). So according to this study in one dimension one should see PCPD class exponents: = 0.20(1) and = 0.40(1) [11, 17].

In the present study I extend the simulation time of the 3A ! 4A, 3A ! 2A model investigated in [12] by two orders of magnitude and follow the static and dynamic scaling behavior of particles and triplets (AAA) at dierent di usion probabilities. In Section (III) I apply this the same kind of analysis for the 3A ! 4A, 3A ! ; model.




FIG.1: (Color online) Density decay of the 3A ! 4A, 3A ! 2A model at D = 0:1. Dierent curves correspond to p = 0:301, 0:302, 0:3027;0:3031, 0:3032, 0:3033, 0:30335, 0:3034, and 0:3035 (from top to bottom). The insert shows the decay of triplets: $_{3}t^{1=3}$, for p = 0:30337

The simulations were carried out on 2 $L = 10^5$ sized system s with periodic boundary conditions. The initial states were random ly half lled lattices, and the density of particles, singlets and triplets is followed up to 2 10^9 MCS by random sequential dynamics. An elementary MCS consists of the following steps. A particle A is chosen random ly and the following processes are done:

(a) A; \$; A with probability D,

(b) 3A ! 2A with probability p(1 D),

(c) 3A ! 4A with probability (1 p) (1 D),

such that the reactions were allowed on the left or right side of the selected particle strings random ly. The time is updated by (t). The time { measured by MCS | is updated by $1=n_P$, where n_P is the total particle number at time t. In order to get precise (t), critical point and exponent estimates the number of independent realizations varied between 20 and 350 per p and D throughout this study.

First I extended the simulations at D = 0:1 published in [12] from $t_{m ax} = 10^7$ MCS by a factor of 200 in time. Figure 1 shows the density decay multiplied by $t^{1=3}$. Following an long initial transient, where the decay is slow an excellent agreement with the mean-eld scaling can be observed for $10^6 < t < 10^9$ MCS for $p_c = 0.30337$ (2). The triplet density decays in the same way ($_3$ / $t^{1=3}$) as the total density suggesting $d_c = 1$.

I repeated the simulations for a higher di usion rate D = 0.8. In this case due to the dynam ics of this model the reaction rates are sm aller and one can observe a faster than m ean-eld decay for $10^4 < t < 5$ 10⁸ M C S.A greement with m ean-eld scaling sets in for 5 10⁸ < t <




FIG.2: (Color online) Density decay of the 3A ! 4A, 3A ! 2A model at D = 0.8. Dierent curves correspond to p = 0.406, 0.407, 0.4074, 0.4075 0.408, 0.409 (from top to bottom). The insert shows the triplet density decay at p = 0.4075.

2 10^9 M C S steps for p = 0:4075 (1). Fast transient decay for interm ediate tim es has already been explained in case of the AA ! A coagulation model with nite reaction rates [13, 14]. One may expect sim ilar behavior for the triplet annihilation case where the low reaction rates at D = 0:8 can explain the fast transient seen here. A gain the triplet density decays by the mean-eld law for t > 5 10^8 M C S as expected at the upper critical dim ension d_c = 1. U sing the critical point estim ates obtained by the dynam ical simulations I investigated the singular behavior of the order parameter in the supercritical region as well. The order parameter is expected to scale as

To get the steady state densities I followed the decay in several samples until saturation occurs and averaged it in a long time window exceeding a level-o seen on log-lin. scale. The data are analyzed by the local slopes method. A coording to this




FIG.3: (Color online) E ective static order parameter exponent results in the active phase. Bullets correspond to D = 0.3, boxes to D = 0.1 of the 3A ! 4A, 3A ! 2A model. Stars denote the results of the 3A ! 4A, 3A ! ; model.

and as $p_i ! p_c$ the e ective exponent tends to the true critical value $_{eff} !$. As Figure 3 shows the $_{eff}$ converges to the mean-eld value = 1 for both di usion rates I investigated. For D = 0.8 on can see an overshooting, while for D = 0.1 local slopes approach the asymptotic value from below following an upward curvature. This kind of e ective exponent behavior usually corresponds to logarithm ic correction to scaling. In case of the general form

where $= \dot{p} p_c j$ the elective exponent behaves as

Applying this form for the data of Fig.3 one obtains: = 1.05(5), x = 1.2(1) for D = 0.1 and = 0.93(10), x = 1.1(1) for D = 0.8. A lthough the assumed scaling correction form may look somewhat ad hoc it indicates $d_c = 1$.

I also considered the scenario suggested by [15] according to which PCPD scaling (= 0.19(1) [15, 17]) should be observed at the transition point. By assuming that such density decay appears for very long times (t > 10^9 MCS) one can read-o the corresponding slightly di erent critical point estimates: $p_c = 0.30325$ (5) for d = 0.1 and $p_c = 0.4071$ (1) for D = 0.8. U sing these values in the local slopes analysis one can obtain: = 0.85 (5) for D = 0.1 and = 0.80 (5), neither of them is near to the exponent = 0.40(1) of the PCPD class [17]. Therefore these simulations can't support the PCPD class scenario.

III. SIM ULATIONS OF THE 3A ! 4A, 3A ! ; M ODEL

Considering the mean-eld type of scaling behavior of the 3A ! 4A, 3A ! 2A model one may speculate that in this model the spatial uctuations are som ew hat suppressed: it's hard to create nearly arbitrarily large regions void of particles from a place where "annihilation" reactions have taken place due to the 3A ! 2A rule. In the low-di usion regim e, when a particle was created from the con guration :::0AAA0::: it is most likely that this o spring would recombine with the remaining




FIG.4: (Coloronline) Density decay in the 3A ! 4A, 3A ! ; model at D = 0.8. Dierent curves correspond to p = 0.1185, 0.1187, 0.11875;0.1188, 0.11886, 0.1189, 0.119 (from top to bottom). The insert shows the decay of triplets for p = 0.11886.

2A particles and undergo another local sequence of reactions. And if in the meantime the 3A in a row have eitherbranched or undergone a 3A ! 2A reaction, the remaining particles would not have the time to go very far. Since everything takes place essentially locally, the meaneld rate equation should be valid [18] yielding therefore

= 1=3.

To check this scenario I run simulations for the 3A ! 4A, 3A !; model, in which no such local sequence of reactions occur, since following the triplet annihilation the remaining single A can di use away at most.

The dynam ical nules are very similar to those of the 3A ! 4A, 3A ! ; model. An elementary MCS consists of the following processes:

- (a) A; \$; A with probability D,
- (b) 3A ! ; with probability p(1 D),
- (c) 3A ! 4A with probability (1 p) (1 D),

such that the reactions were allowed on the left or right side of the selected particle strings. Now the system size was 4 L = 10^5 with periodic boundary conditions and the density of particles, singlets and triplets is followed up to 2 10^9 MCS from random initial state. As Figure 4 shows the time evolution of (t) can be split into three parts (a) an initial slow regime (t < 3 10^3 MCS), (b) an interm adiate faster then m ean-eld regime (3 $10^3 < t < 3 10^6$ MCS), (c) am ean-eld regime for t > 3 10^6 MCS. One can see a level-o in the time evolution of $t^{1=3}$ for p = $p_c = 0.11887$ (2). For this critical p value the density of triplets behaves in the same way in the long time limit (t > ' 3 10^6 MCS) corroboting the d_c = 1 result of the previous section.

Finally the static exponent was determined in the active phase in the neighbourhood of the critical point

($p_c = 0.11887$). As Figure 3 shows the local slopes (2) converge to the mean-eld value again. By tting with the form (4) one gets the following estimates: = 0.99(5), x = 0.6(1).

IV. CONCLUSIONS

Large scale simulations for two di erent triplet models: 3A ! 4A, 3A ! 2A and 3A ! 4A, 3A !; result in m ean-eld type of static and dynam ic scaling behavior in one dimension. The simulations up to $t = 2 \quad 10^9$ MCS do not support the scenario according to which uctuations are supressed and reactions take place locally hindering to see PCPD type of critical behavior. Since the triplet density dacays in the same way as the total density, which is typical at the upper critical dimension the $d_c = 1$ is concluded. Furtherm ore logarithm ic correction to scaling is shown in case of the static order parameter exponent. On the other hand one can't see log.

The contradiction with the results of the Langevin equation analysis of a bosonic triplet system is unresolved. This may also mean that the two-species coupled model and the one-species model behave di erently.
